DESCRIPTION

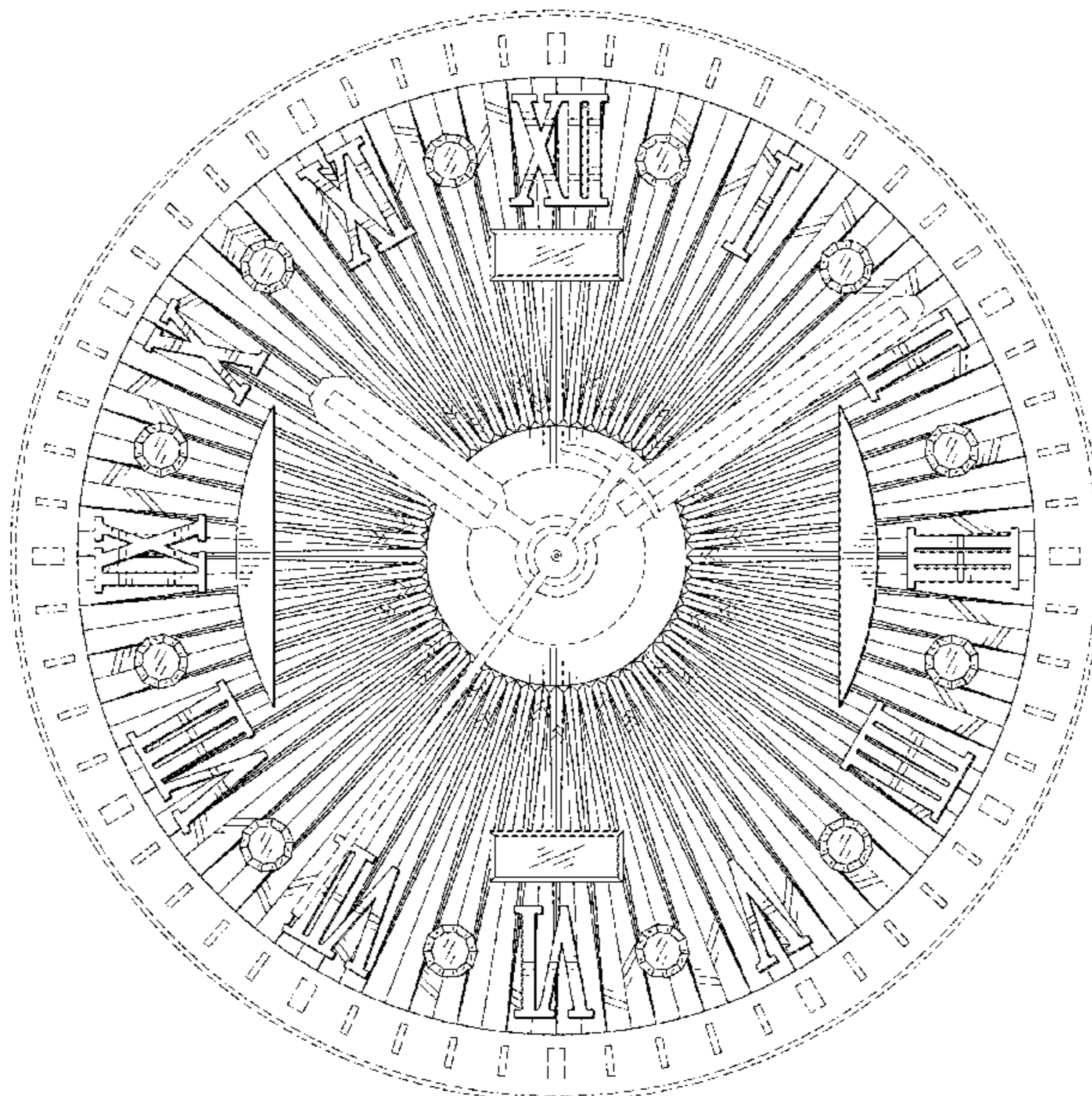
FIG. 1 is a left front perspective view of a first embodiment of a watch dial, showing my new design;

 FIG. 10 is a left front perspective view of a second embodiment of a watch dial, showing my new design;

 FIG. 12 is a rear elevation view thereof;
 FIG. 13 is a right side elevation view thereof;
 FIG. 14 is a left side elevation view thereof;
 FIG. 15 is a top plan view thereof;

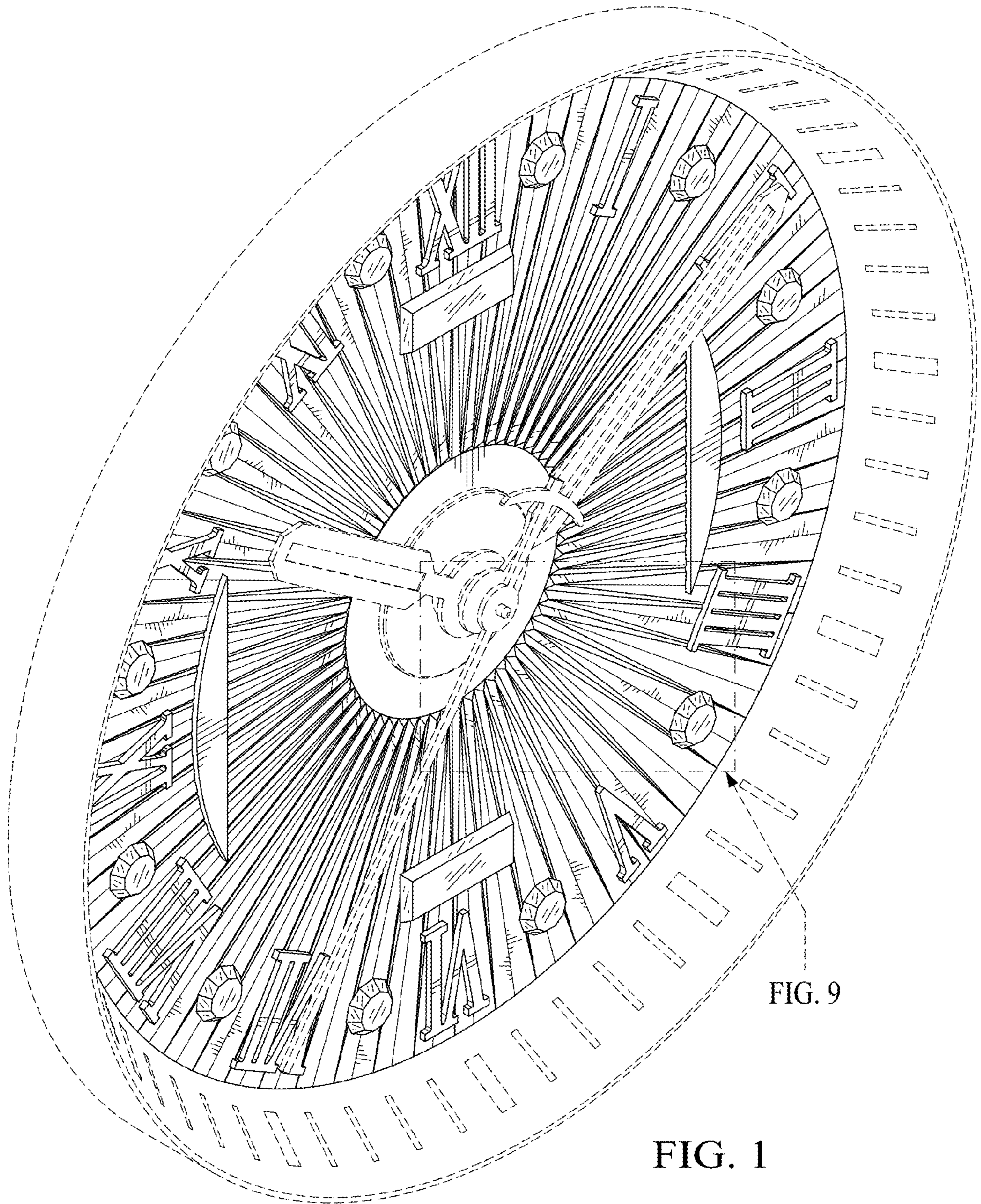

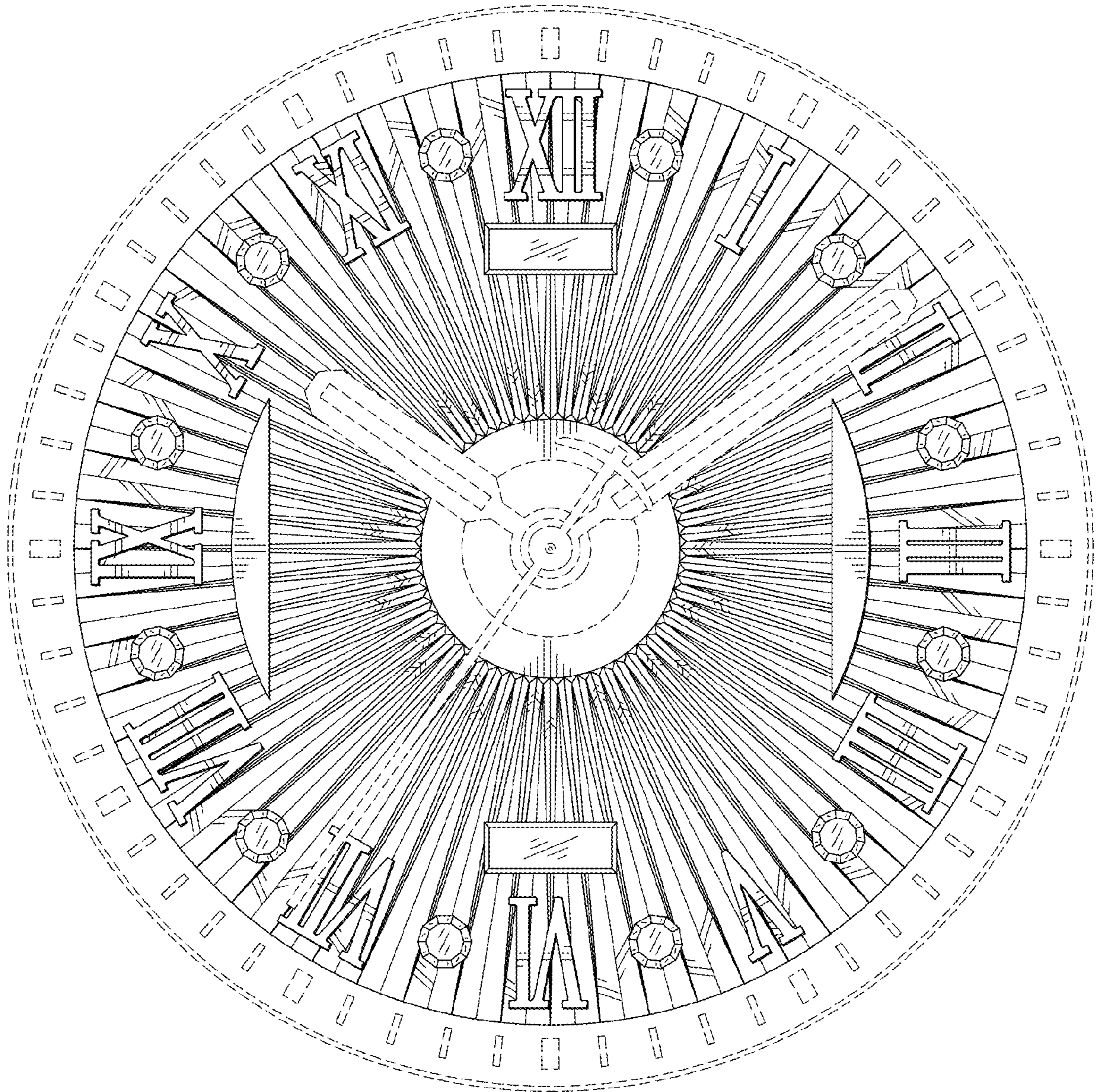

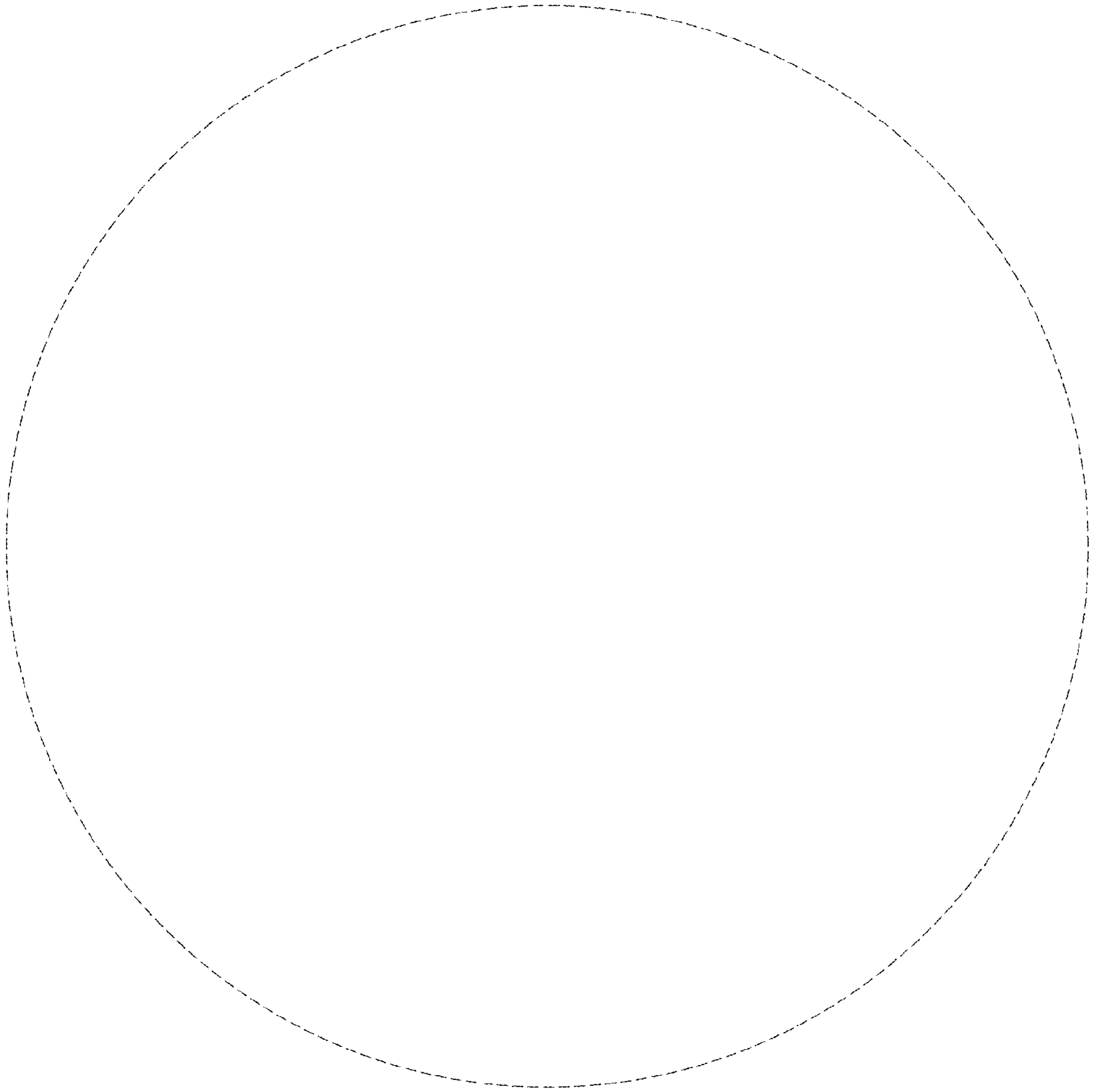

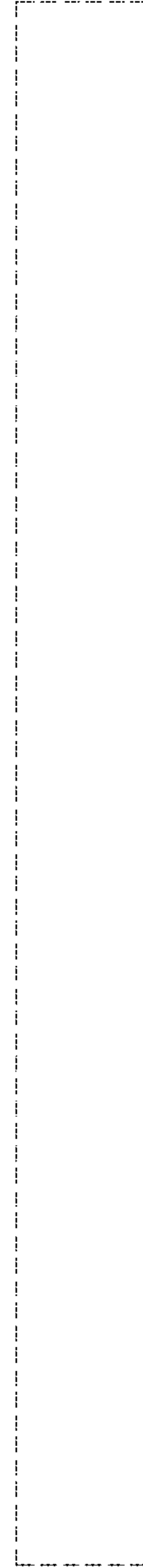

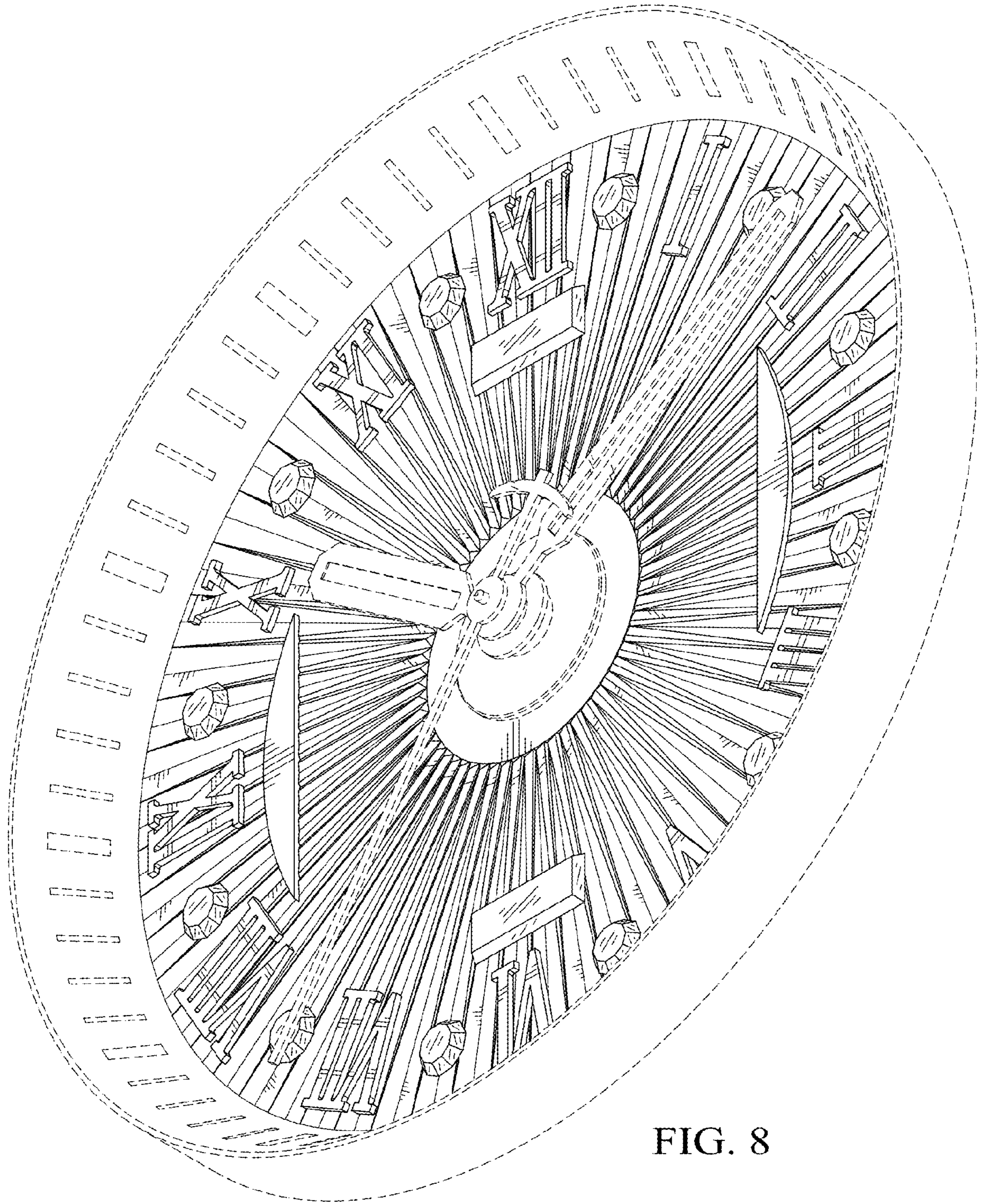

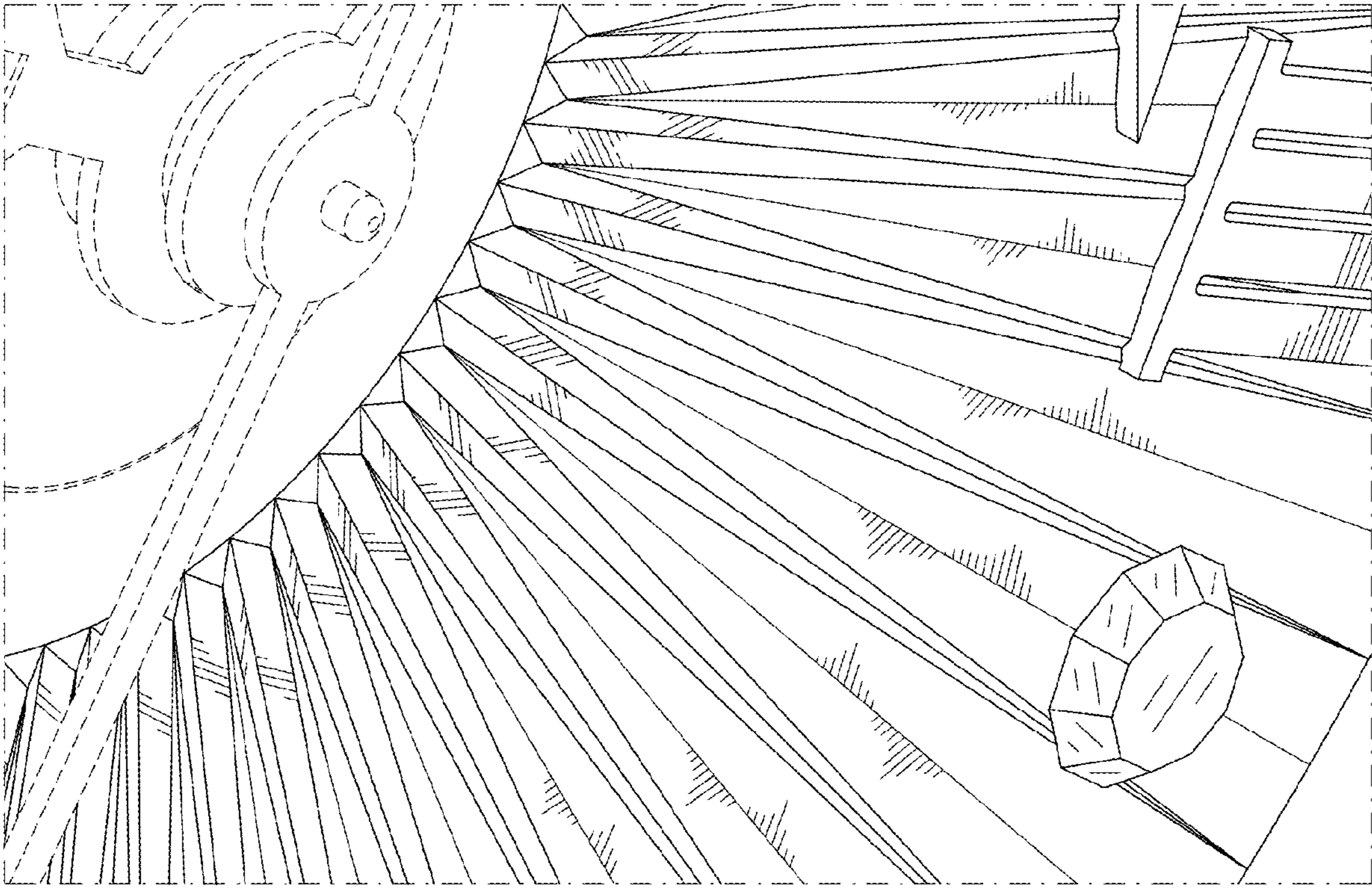

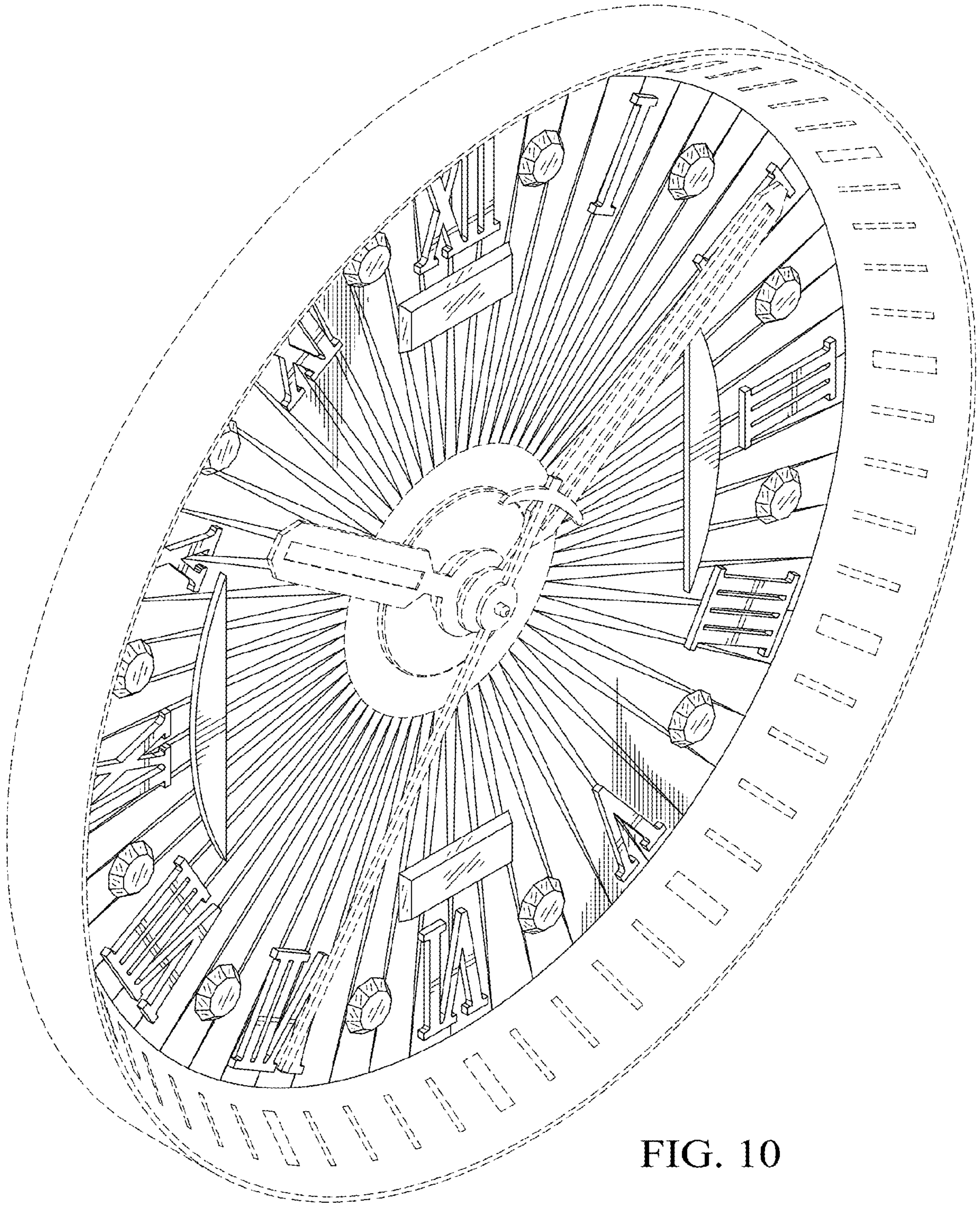

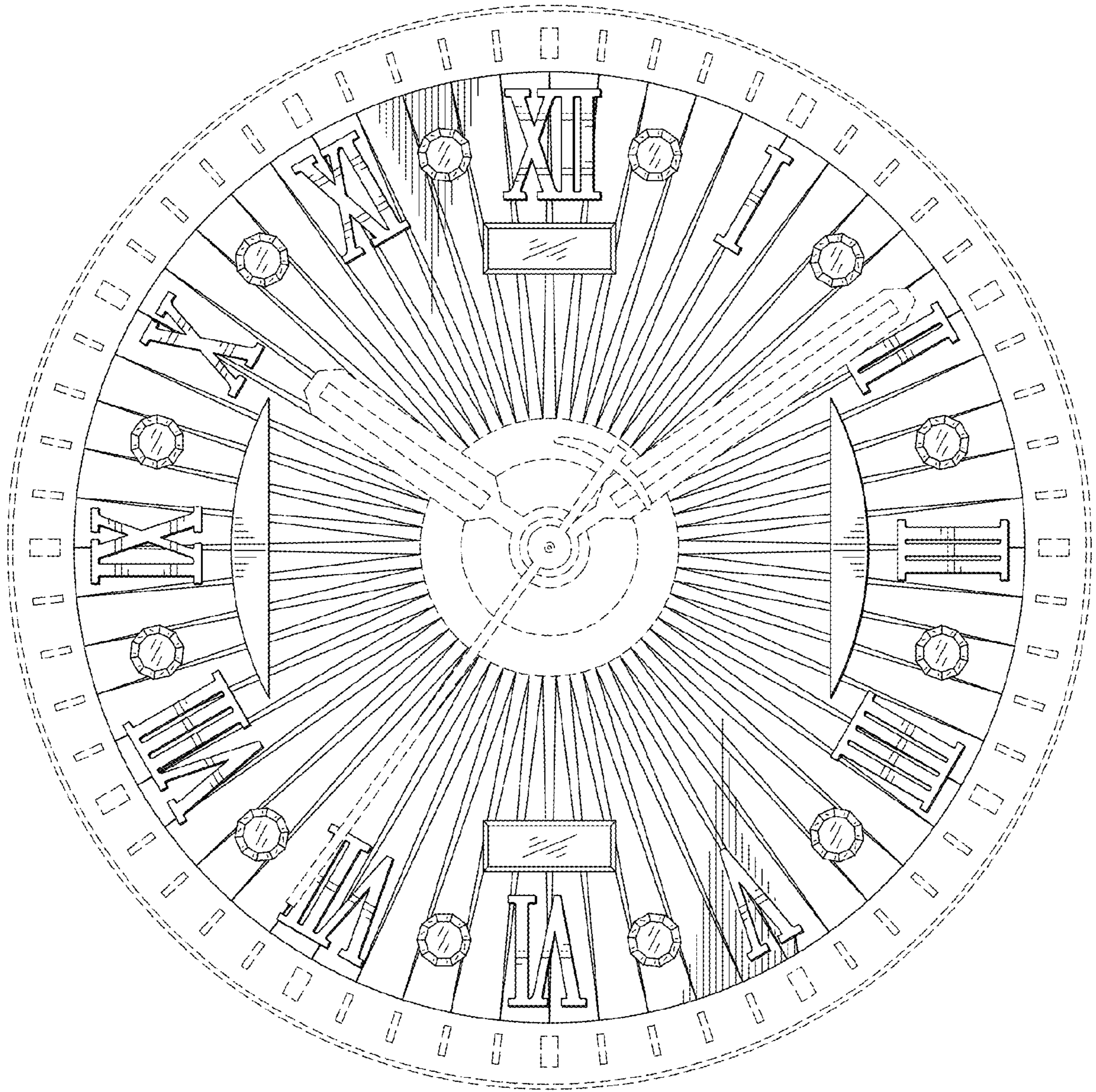

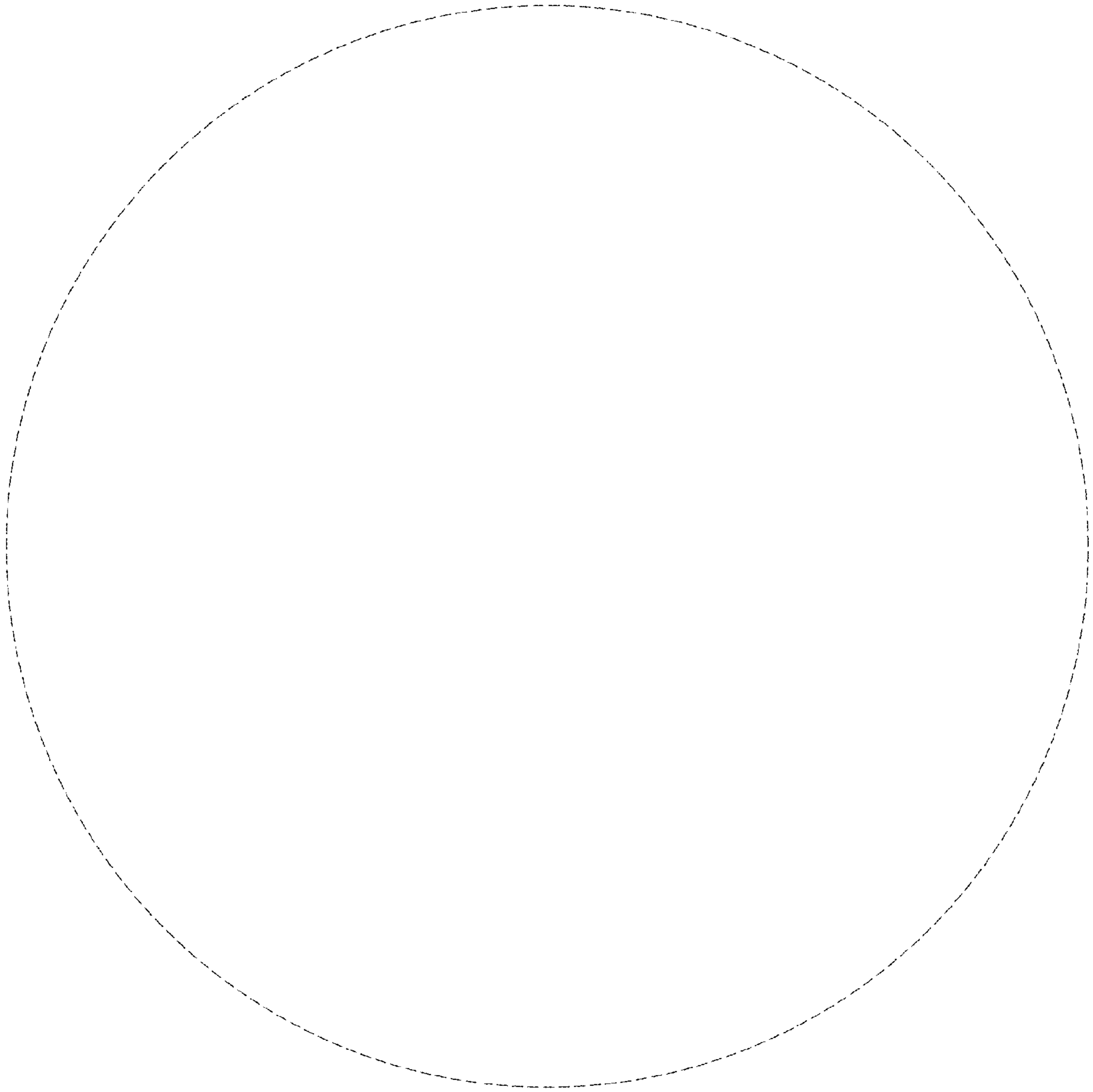

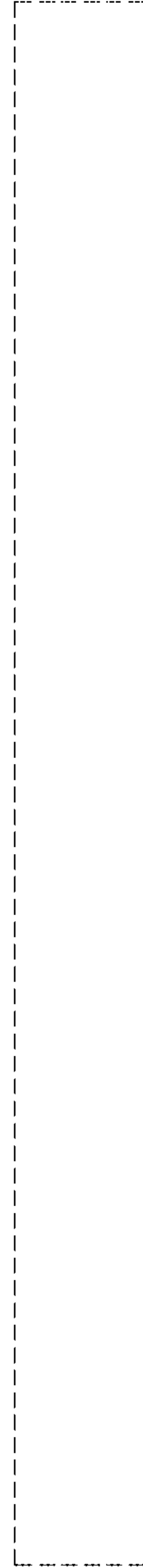

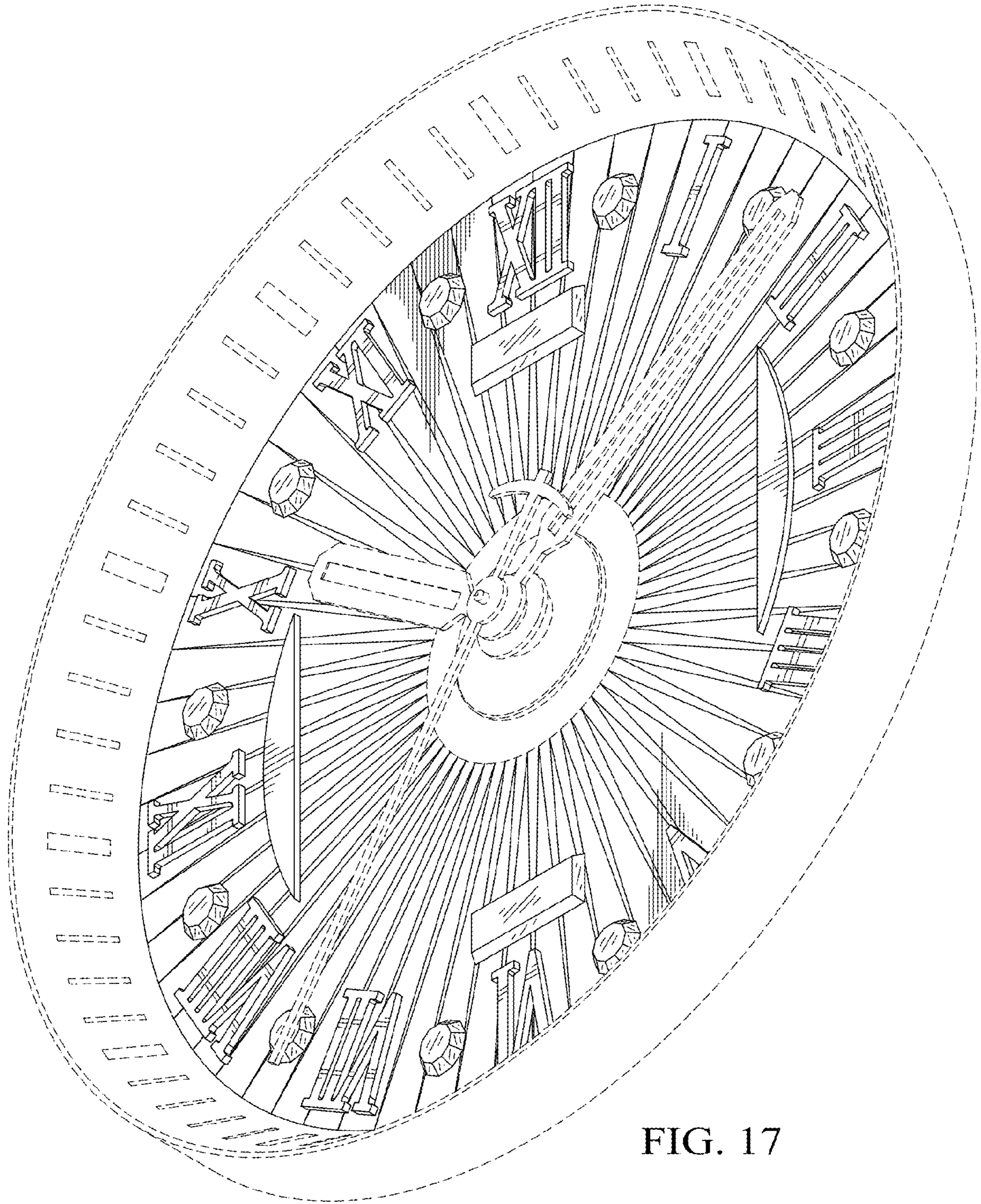
