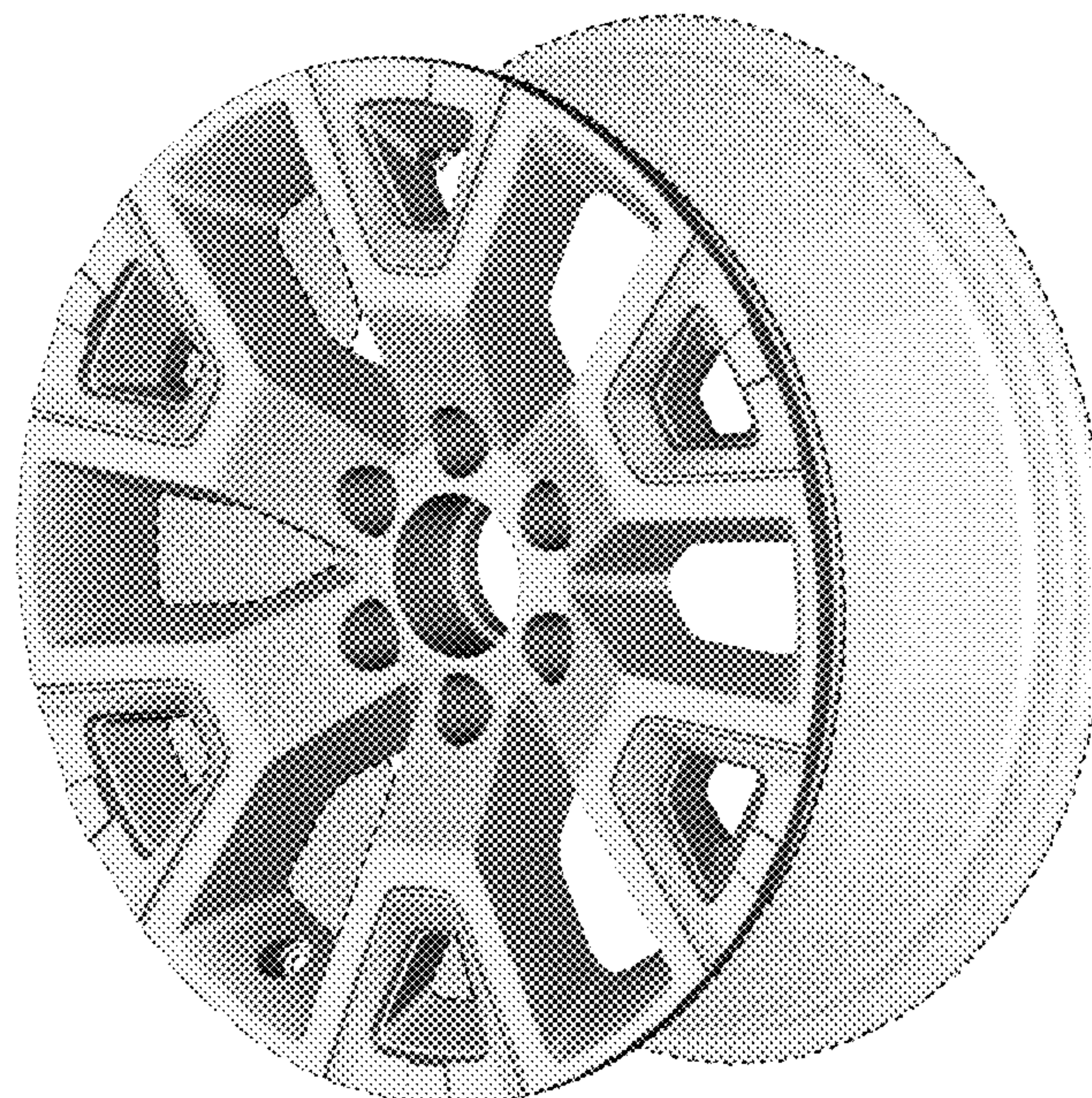
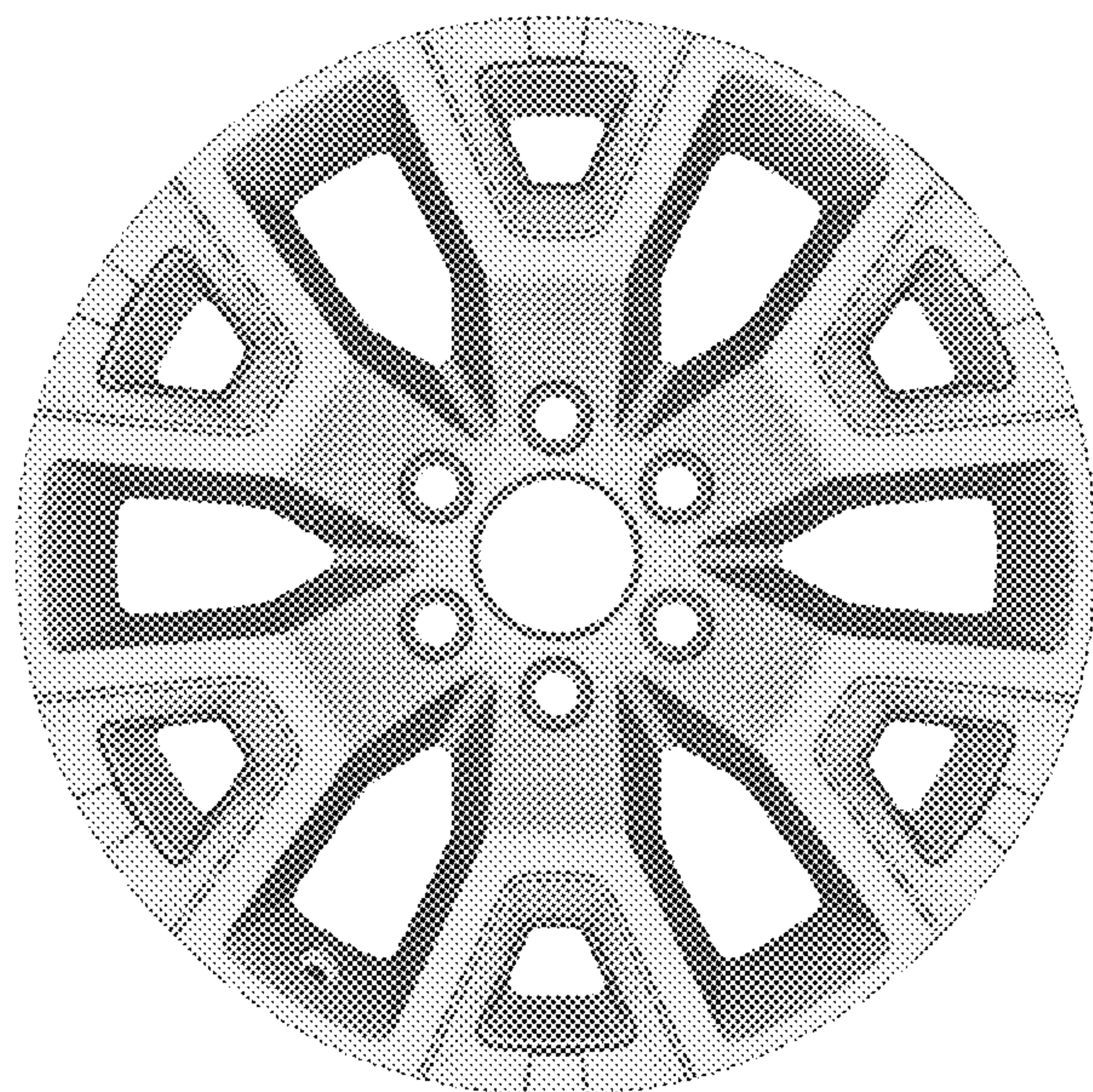
The ornamental design for an automobile wheel, as shown and described.

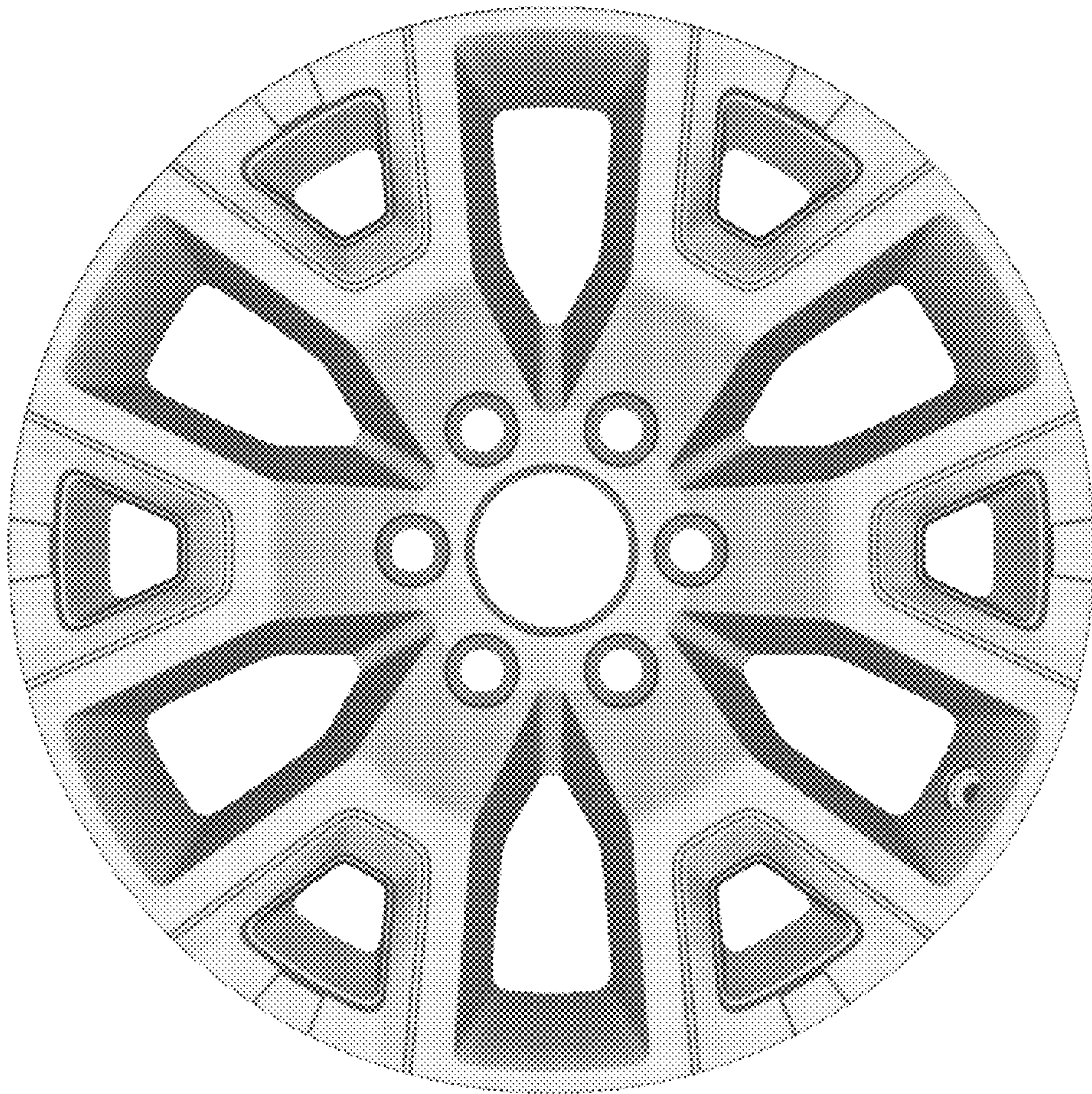

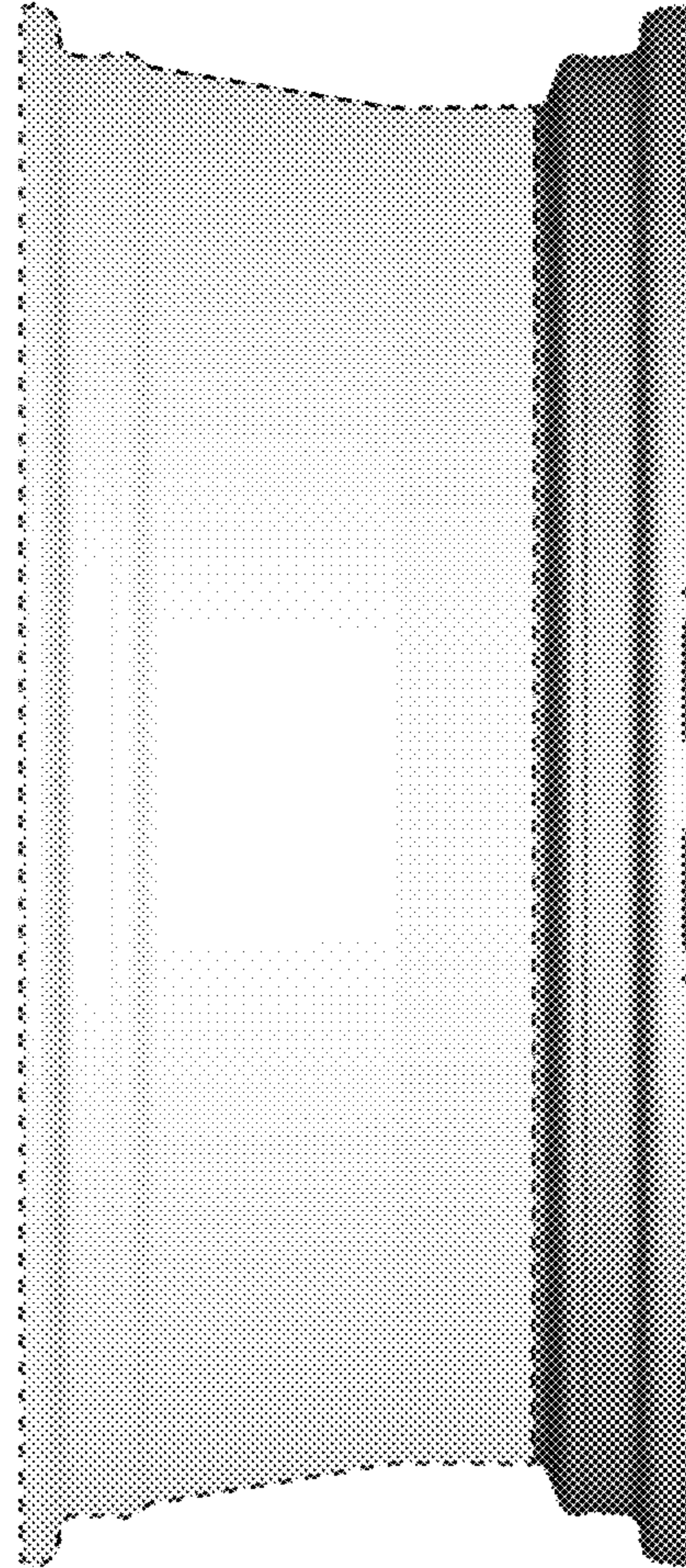

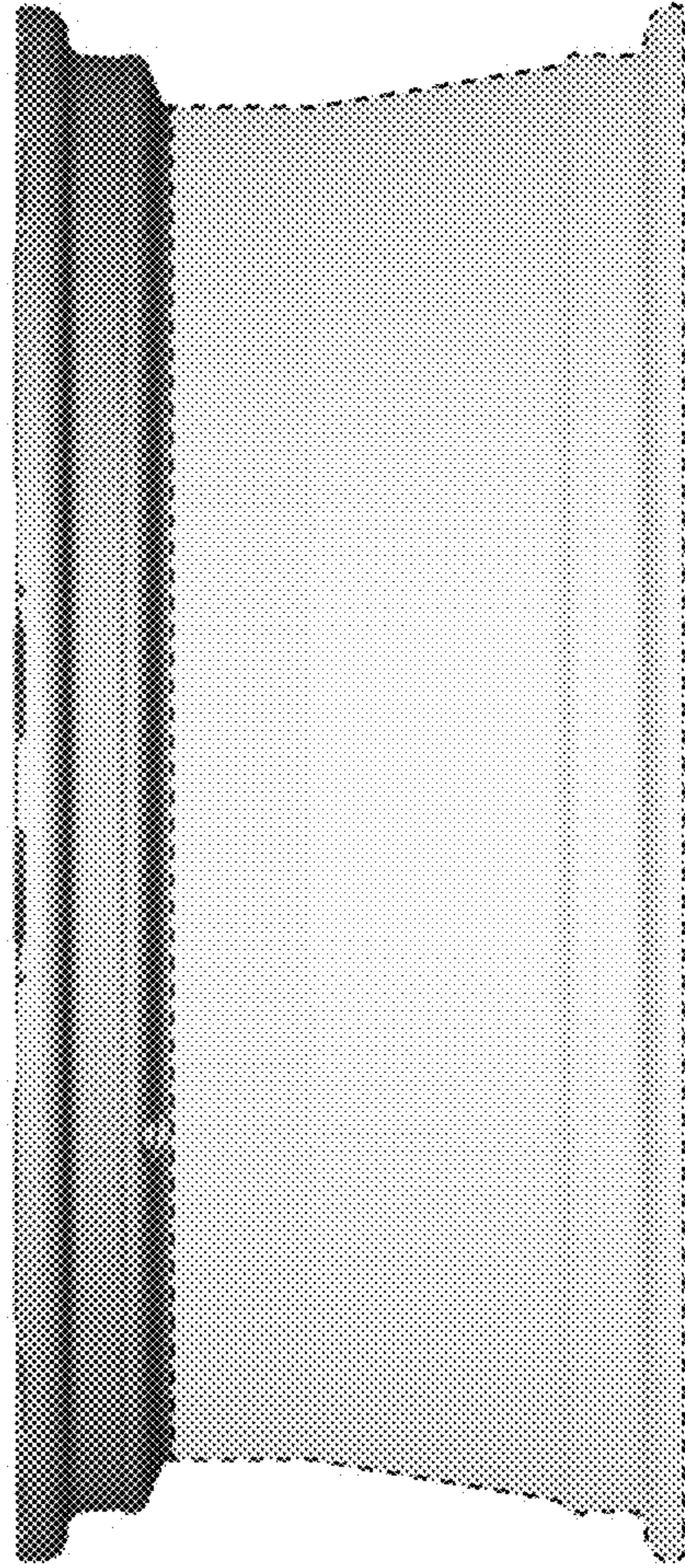

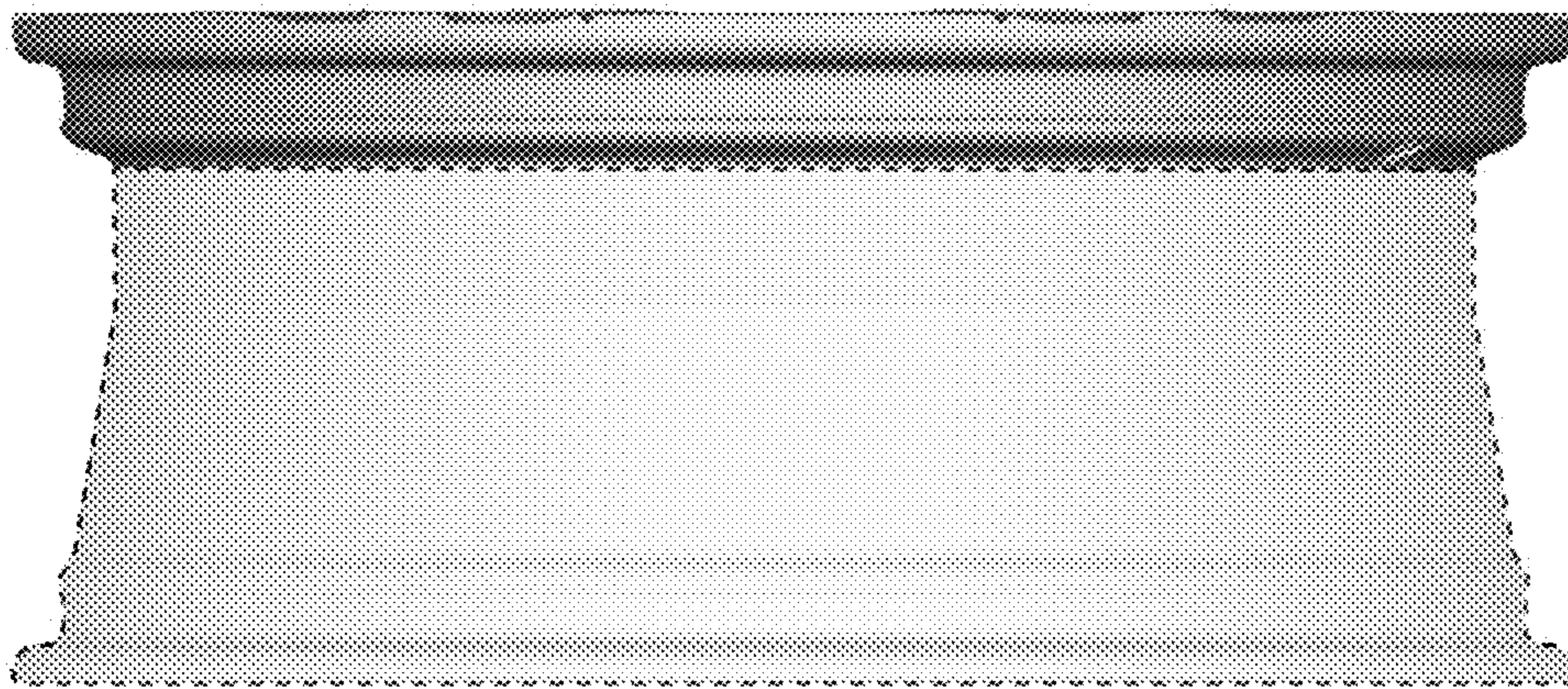

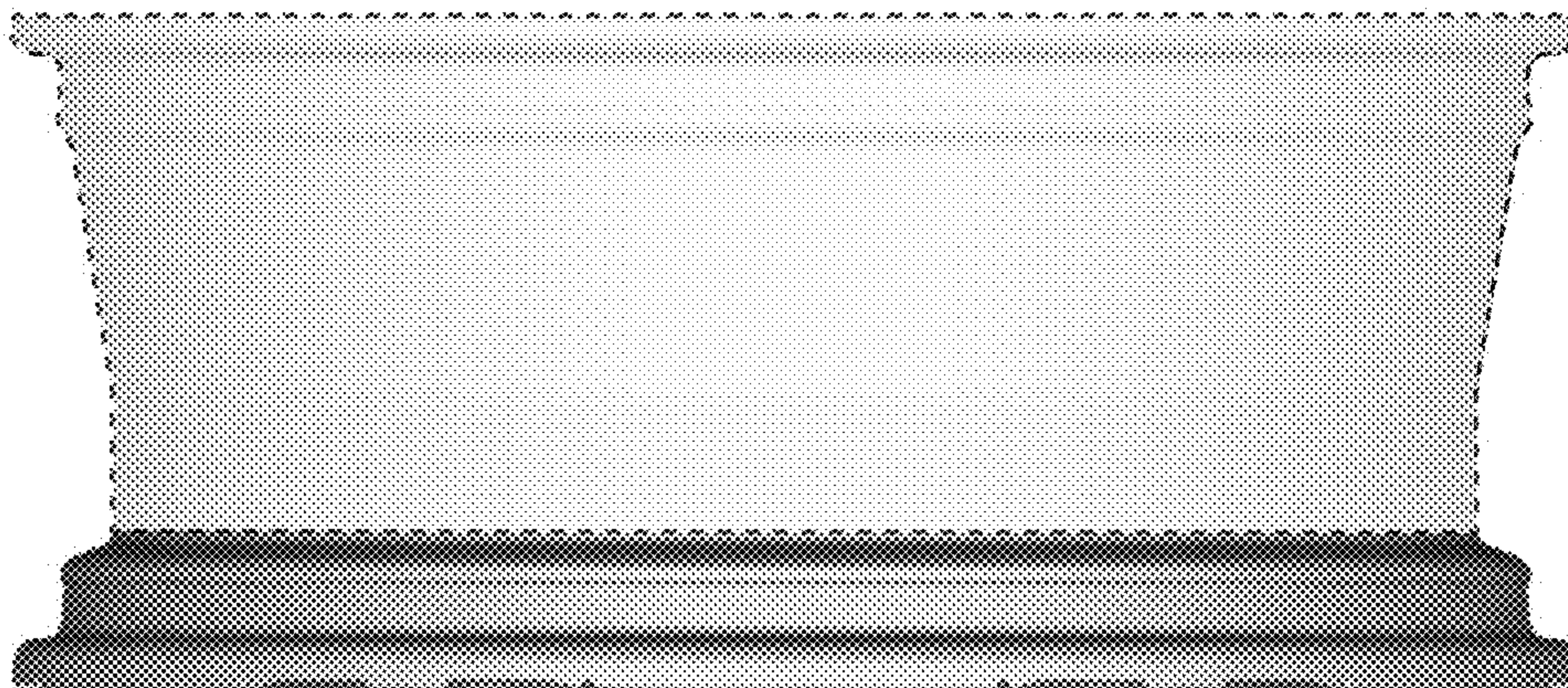
