DESCRIPTION

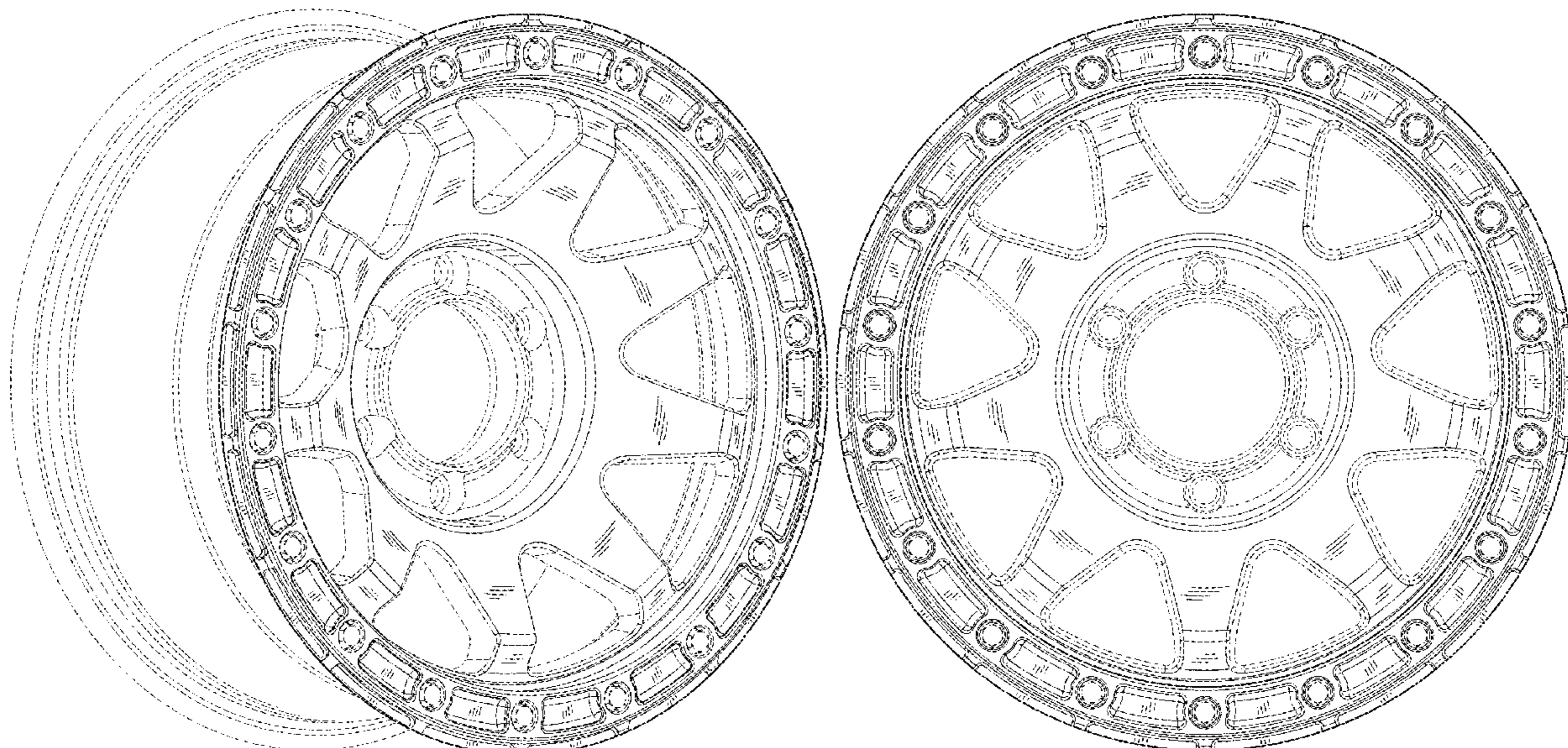
FIG. 1 is a front perspective view of the vehicle wheel front face;

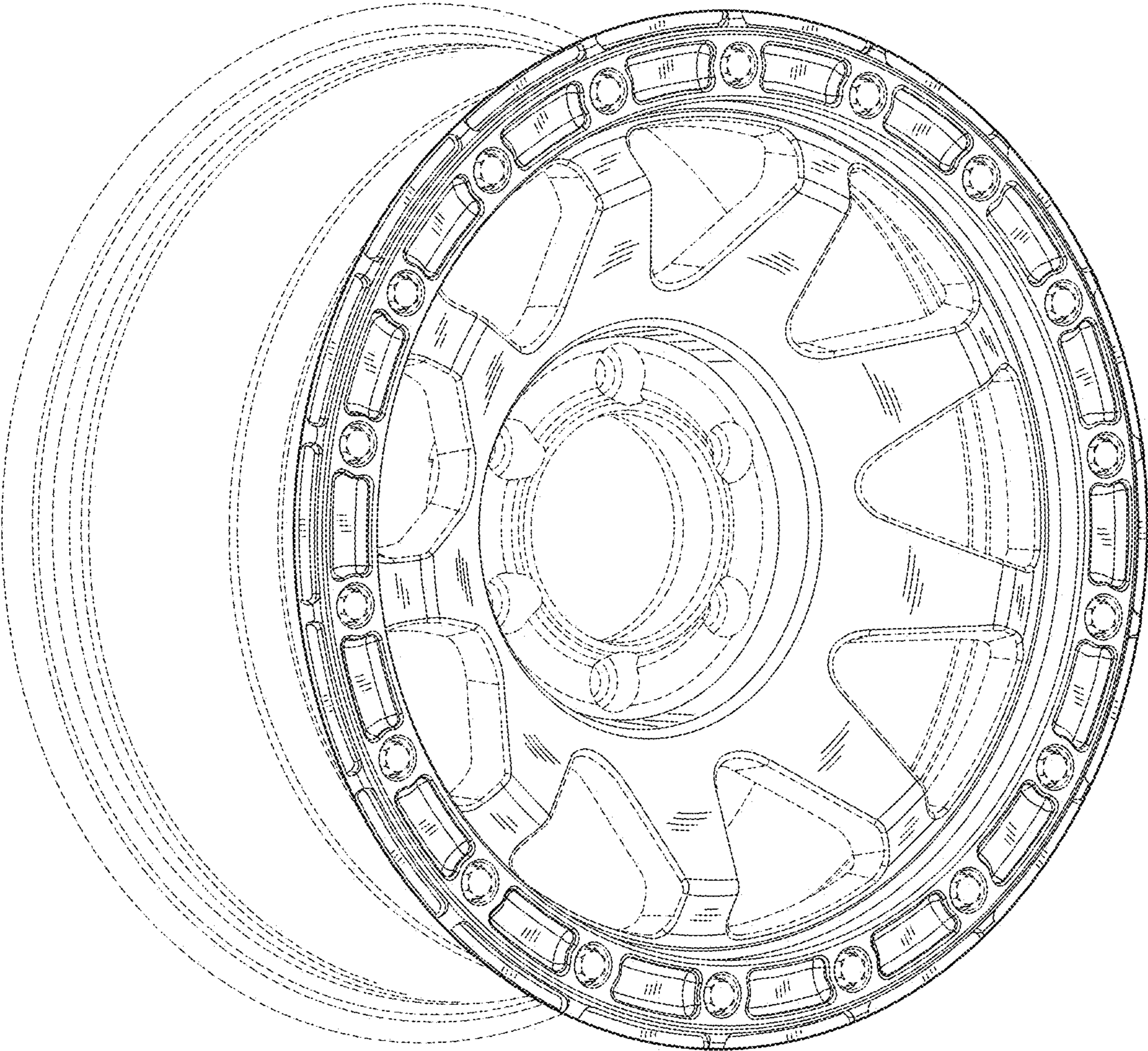

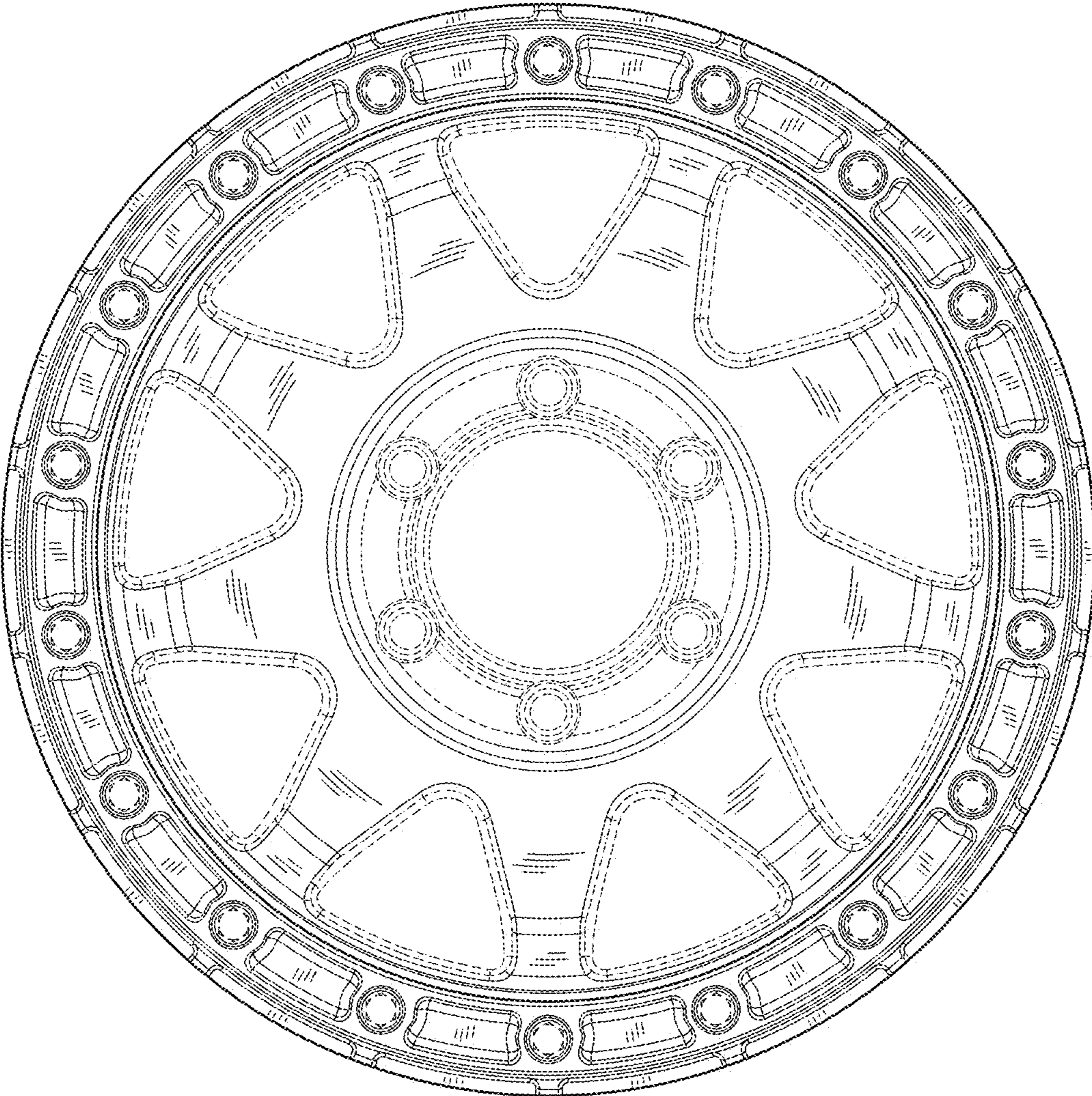

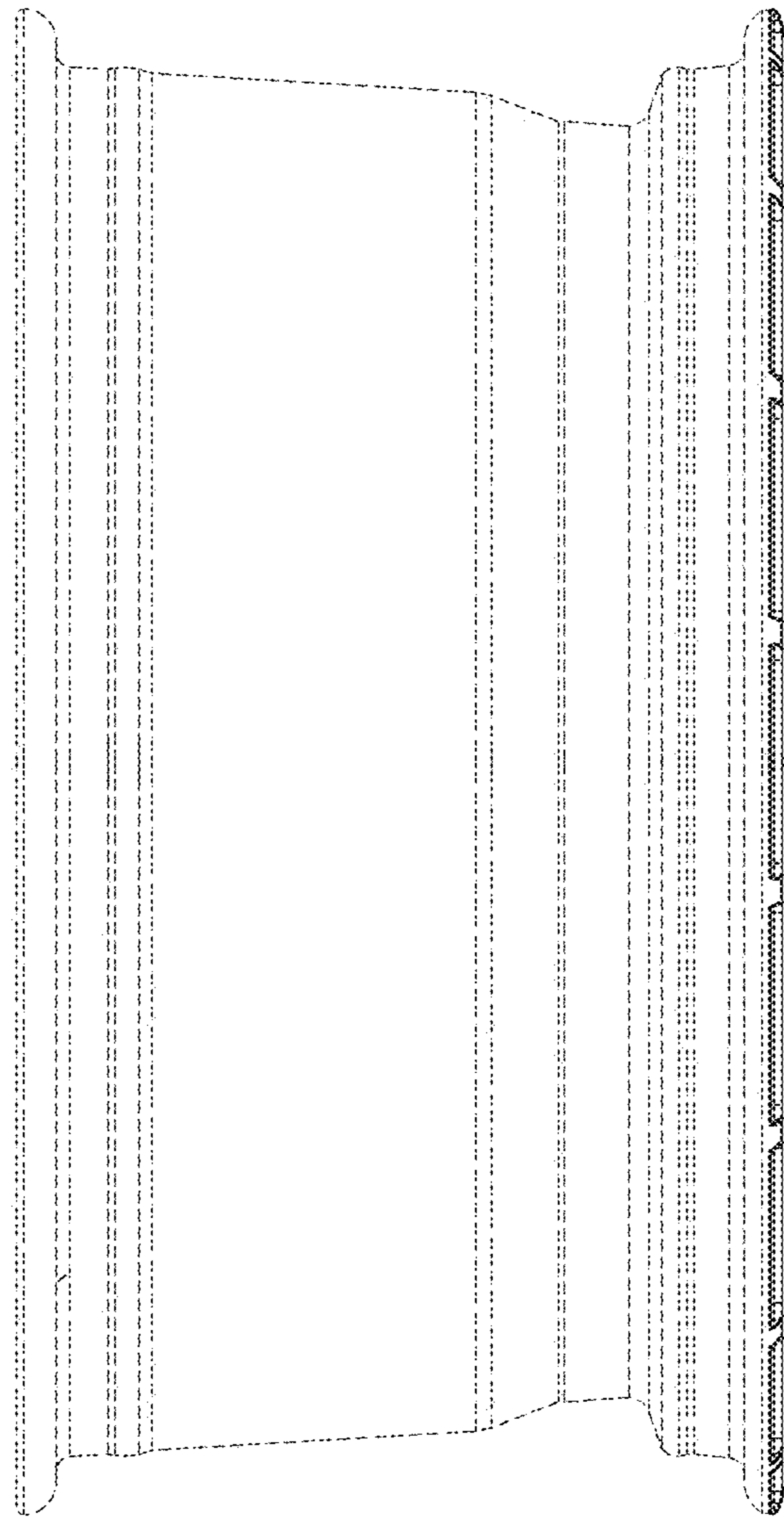
