The ornamental design for a wheel front face, as shown and described.

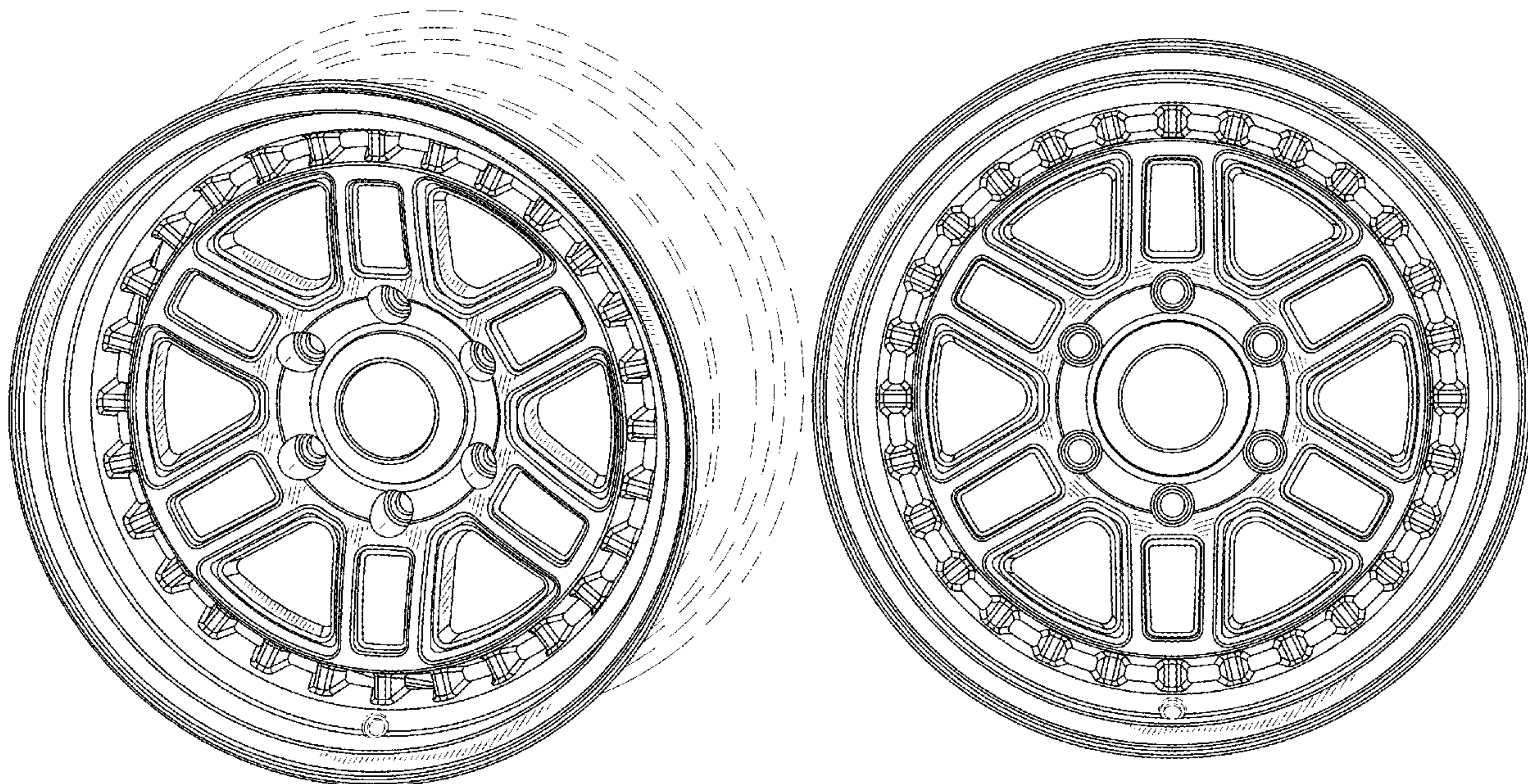
DESCRIPTION

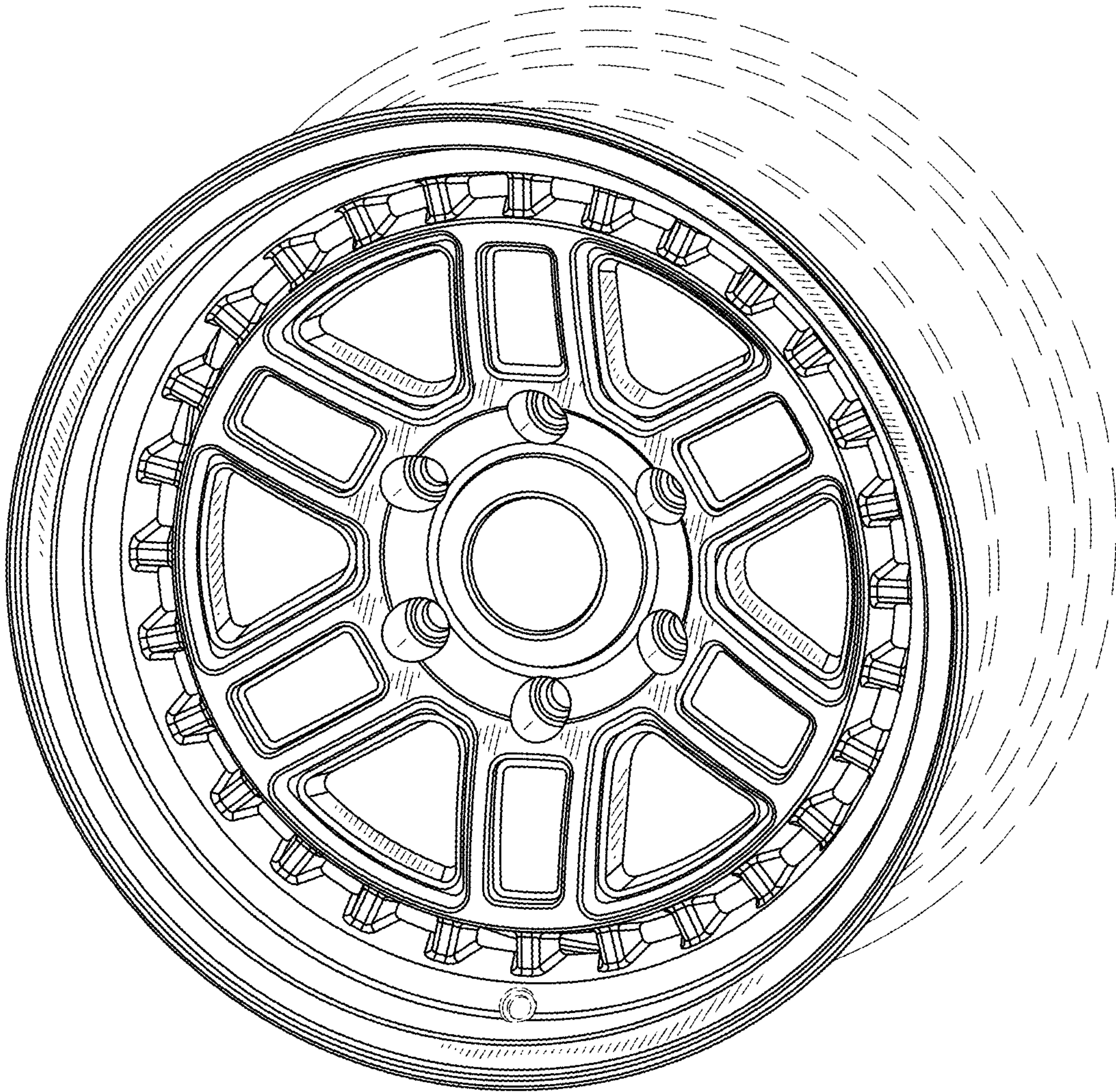

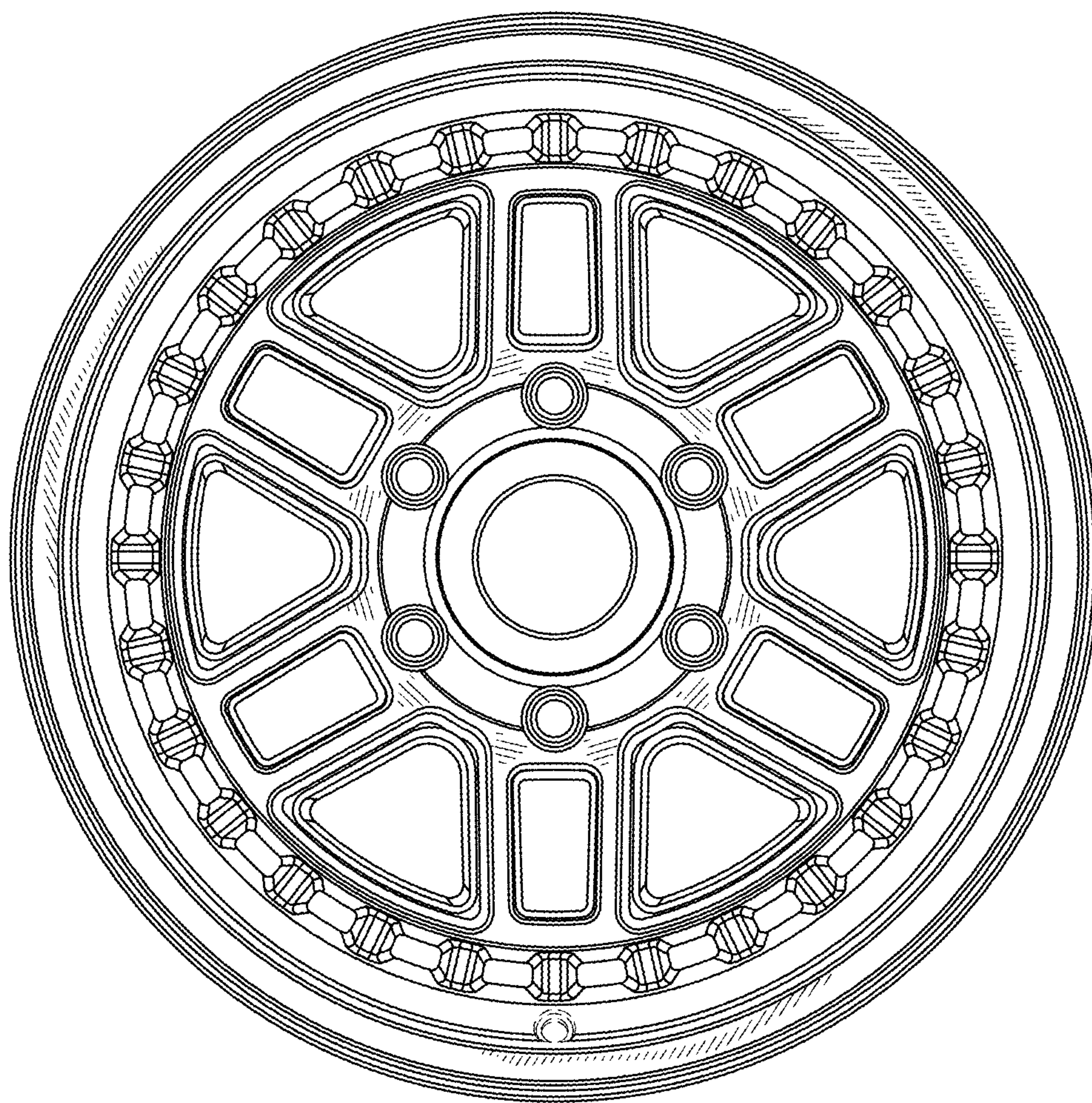

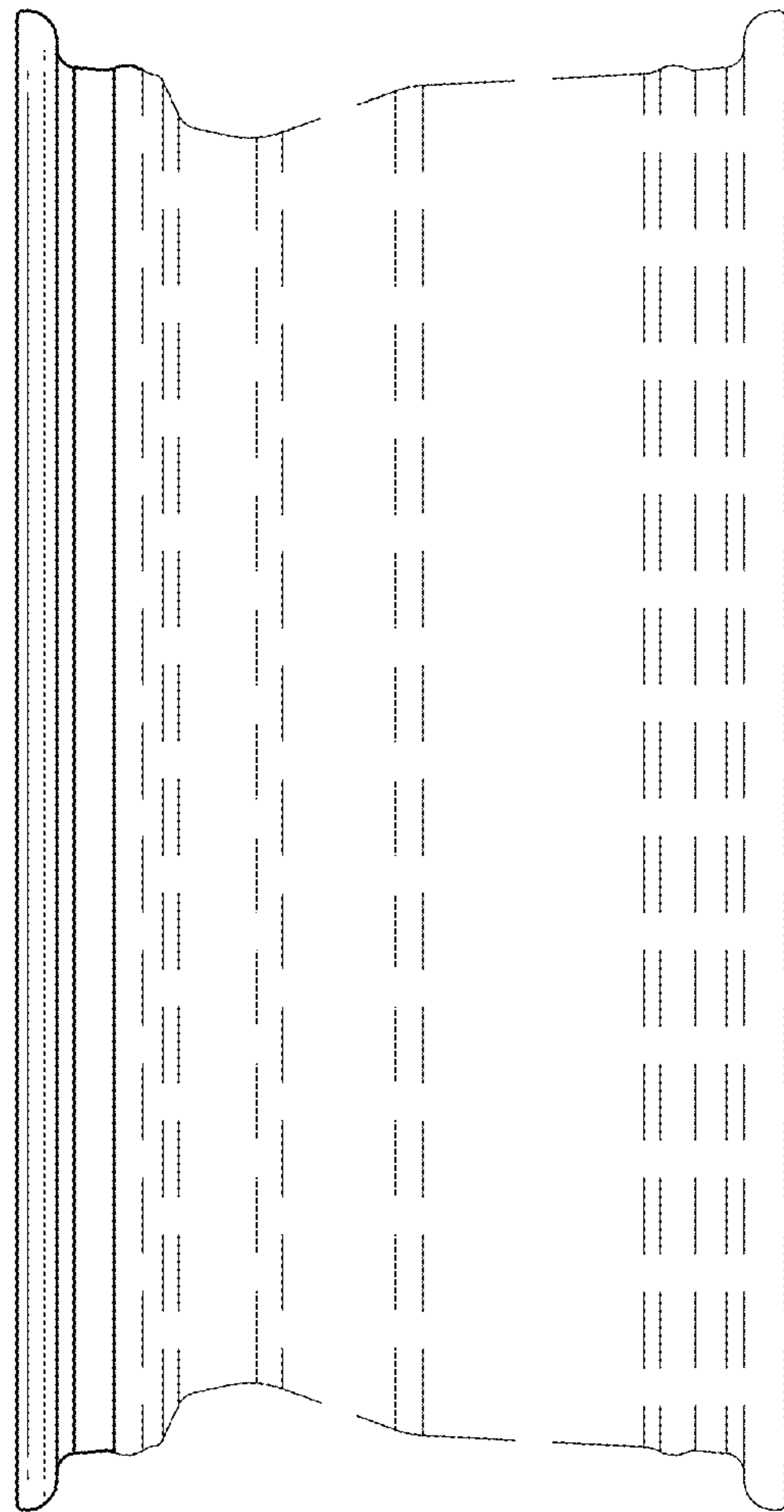
