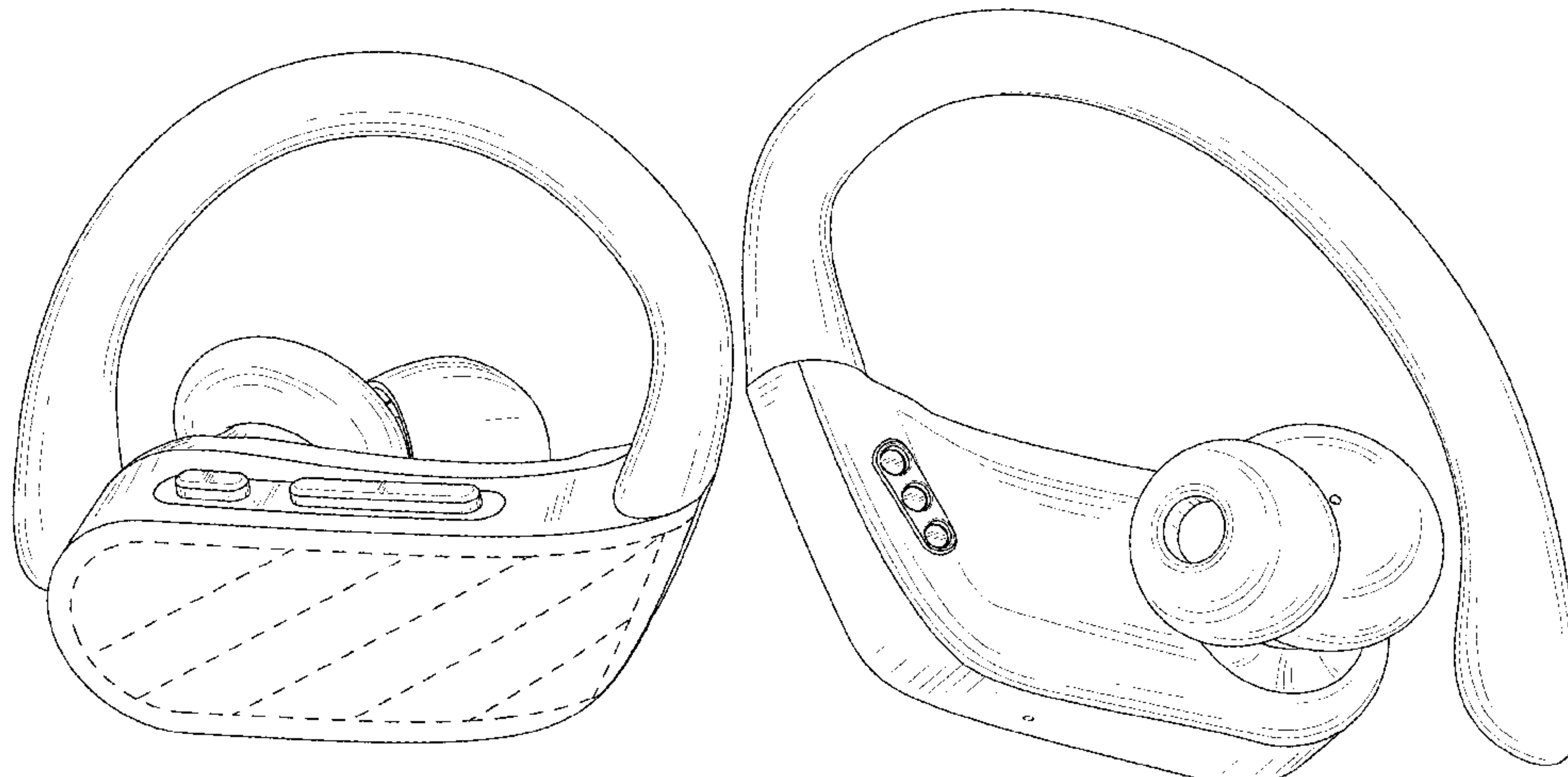
The ornamental design for earphone, as shown and described.

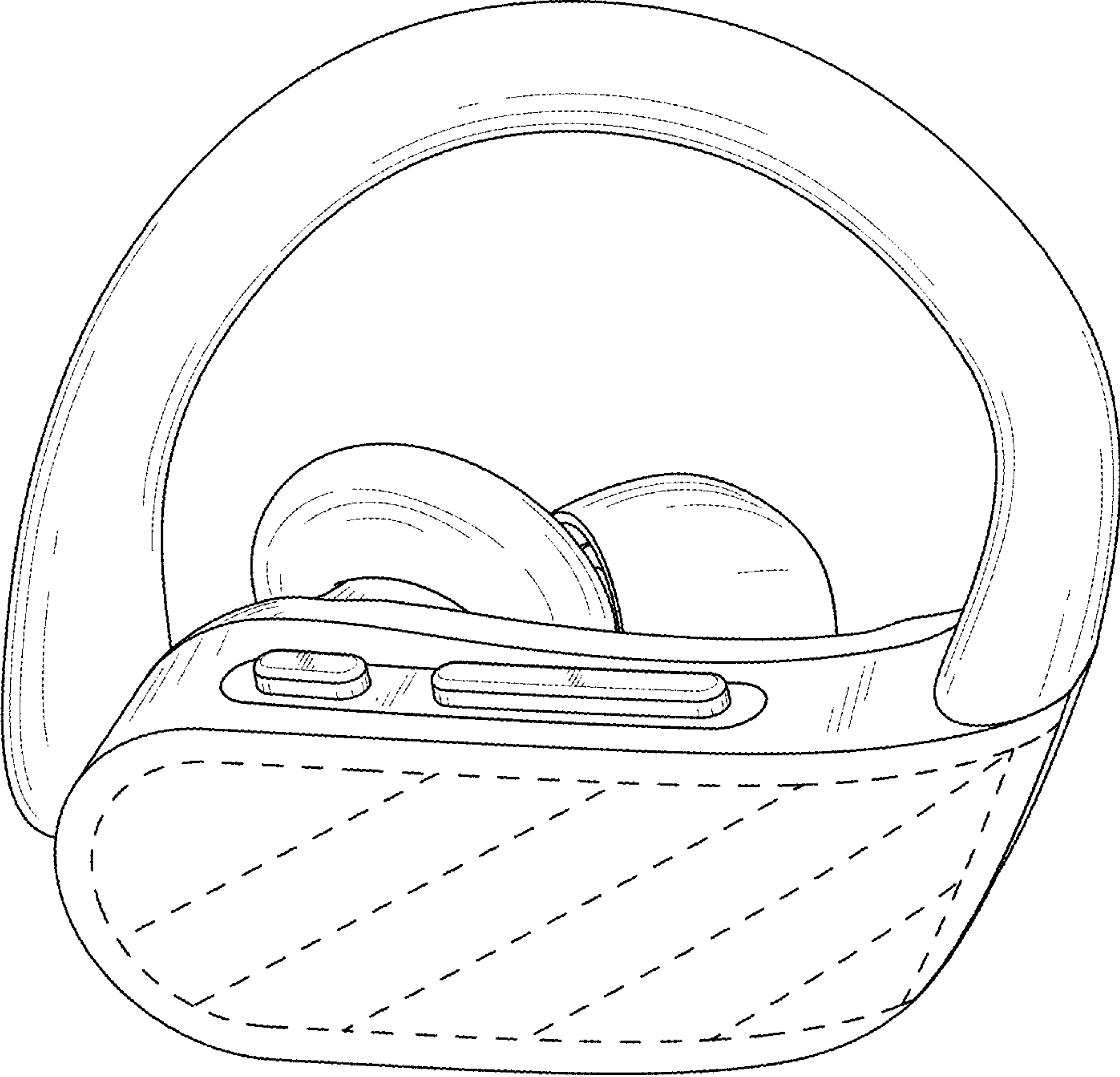

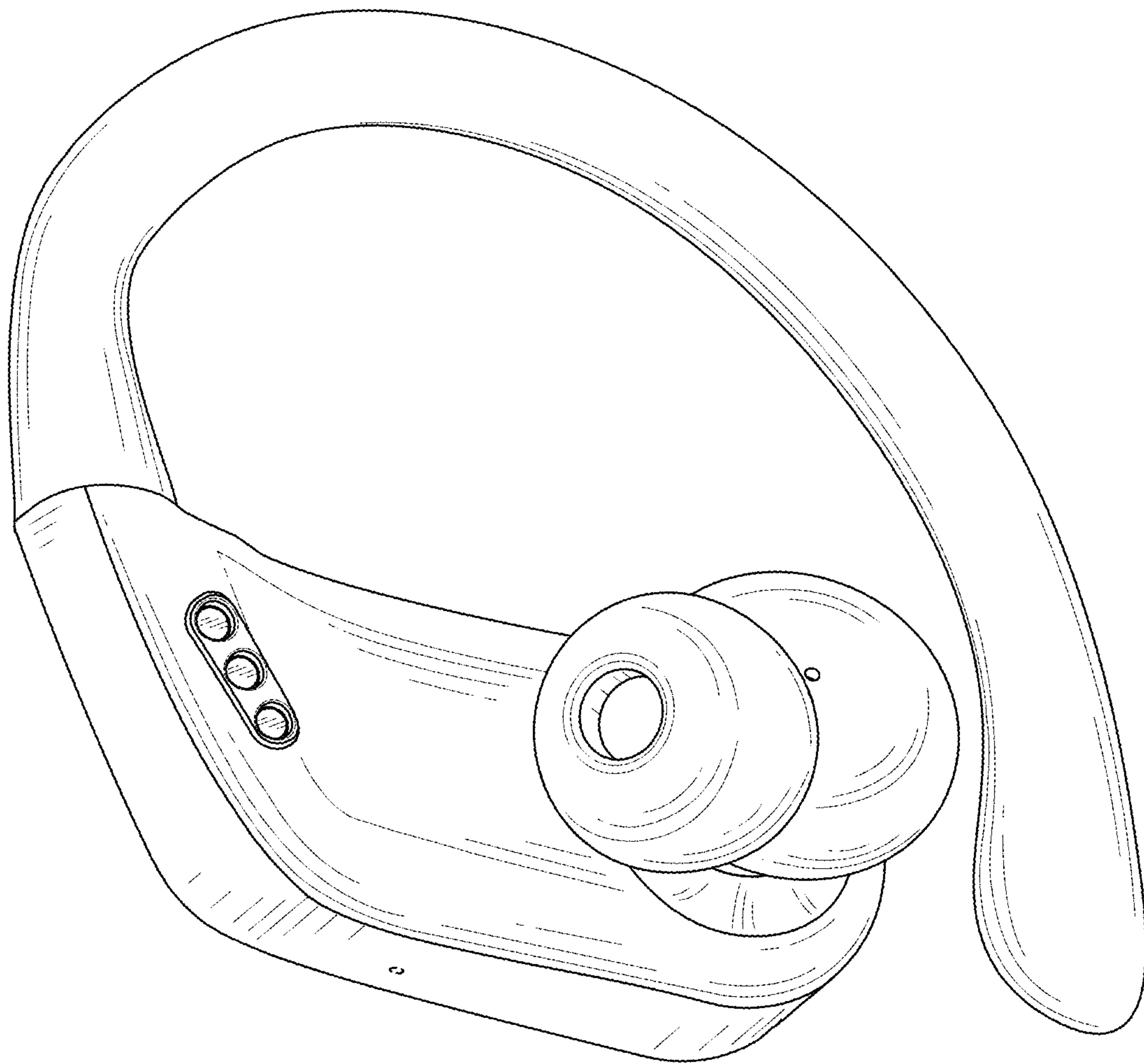

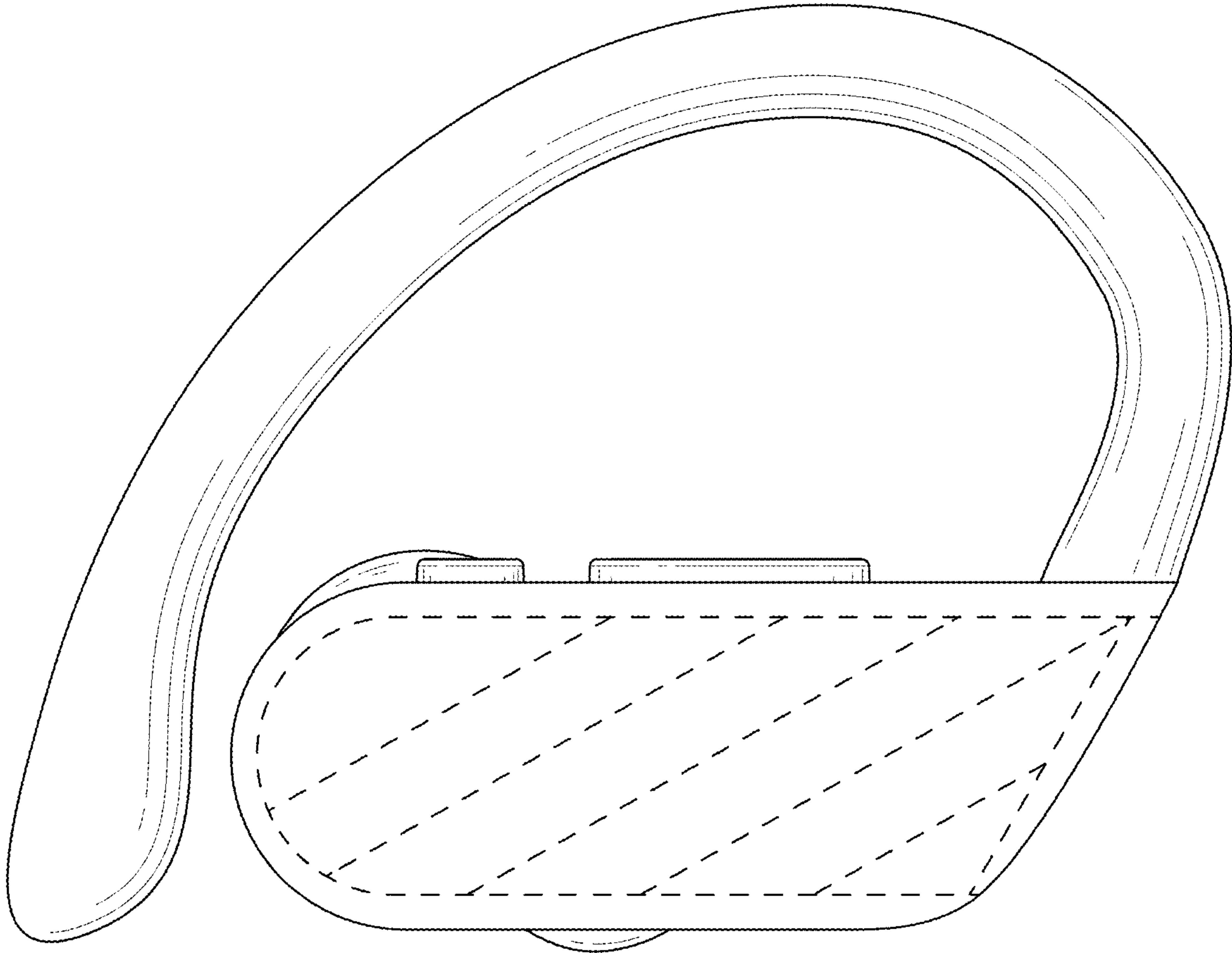

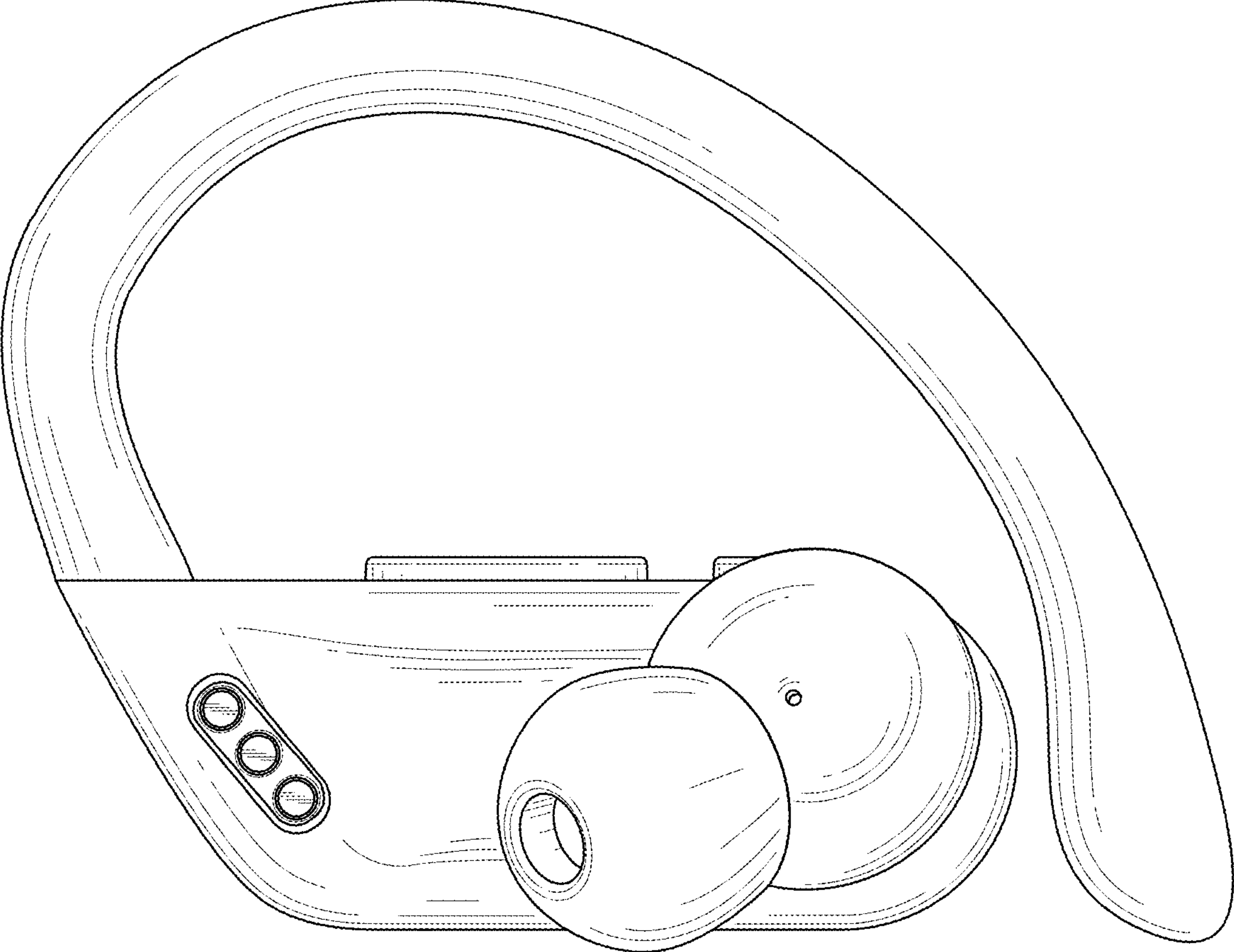

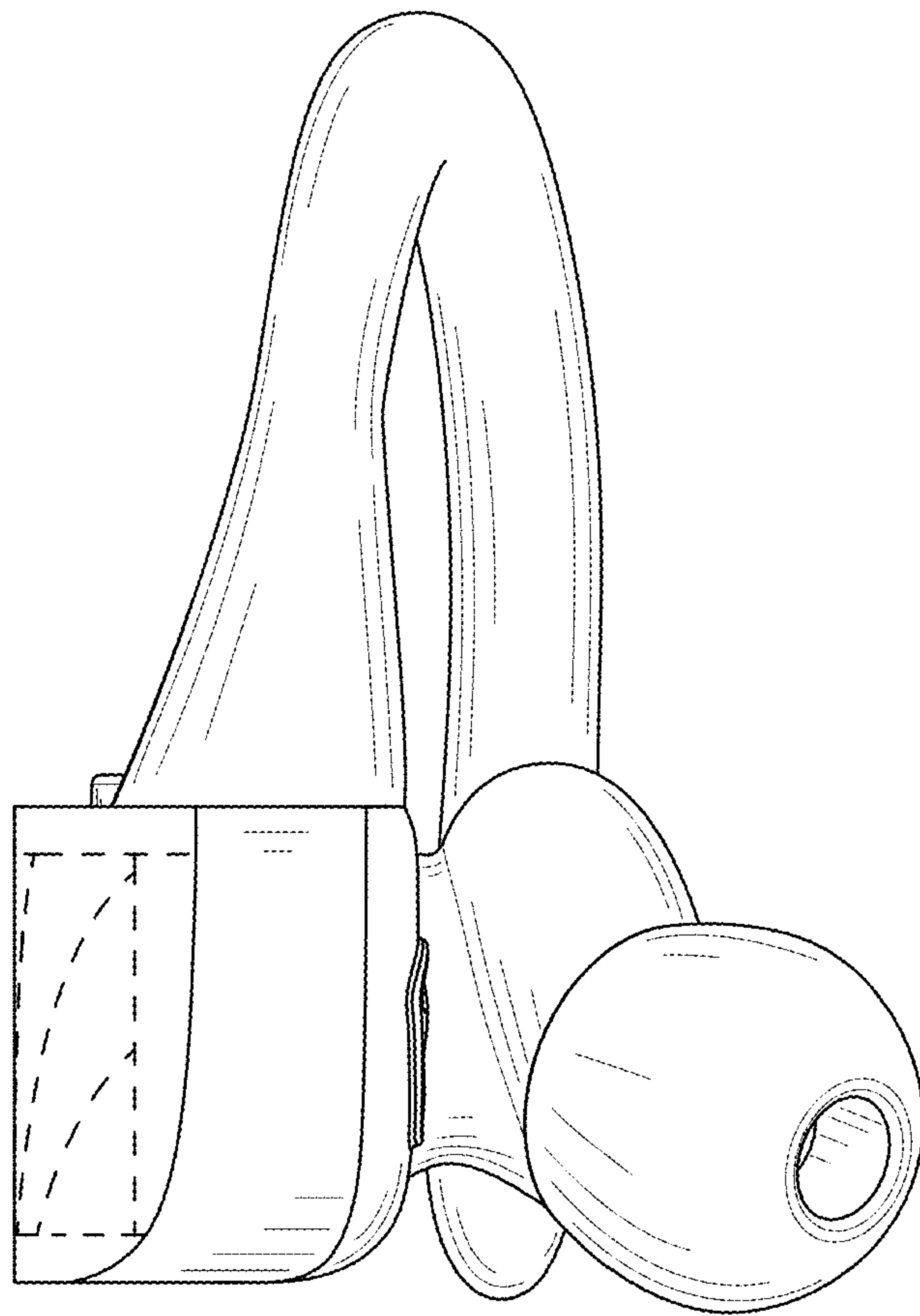

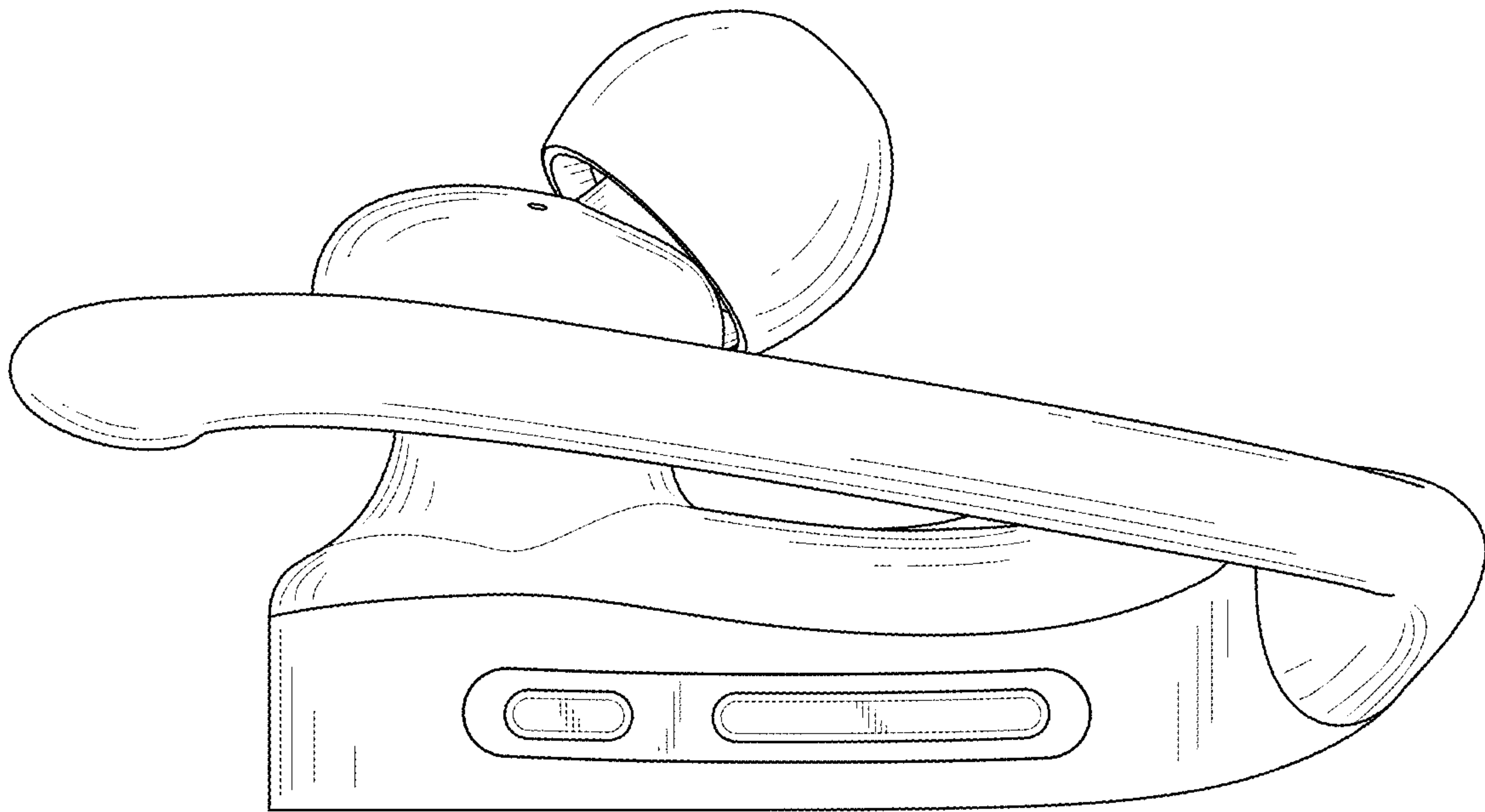

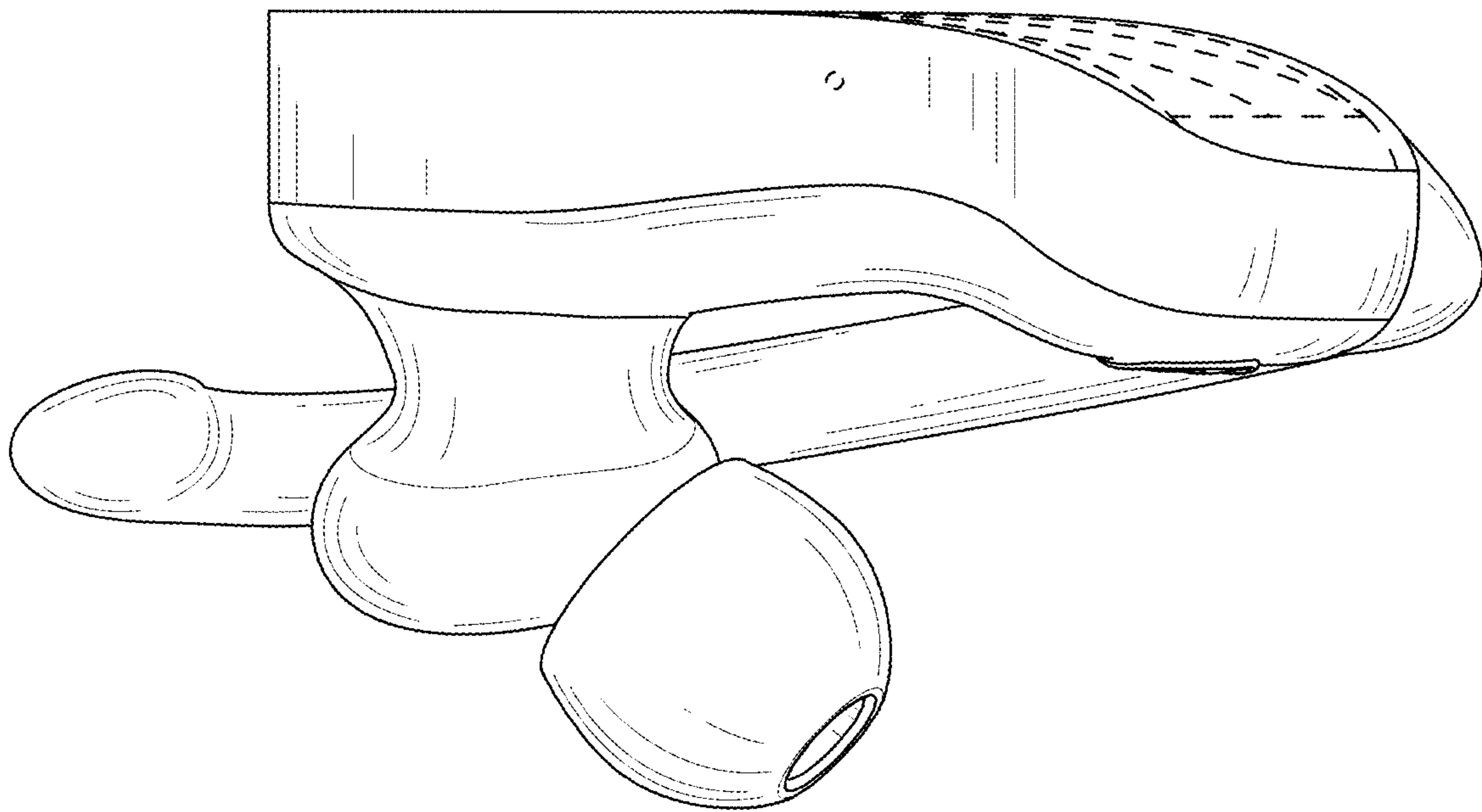

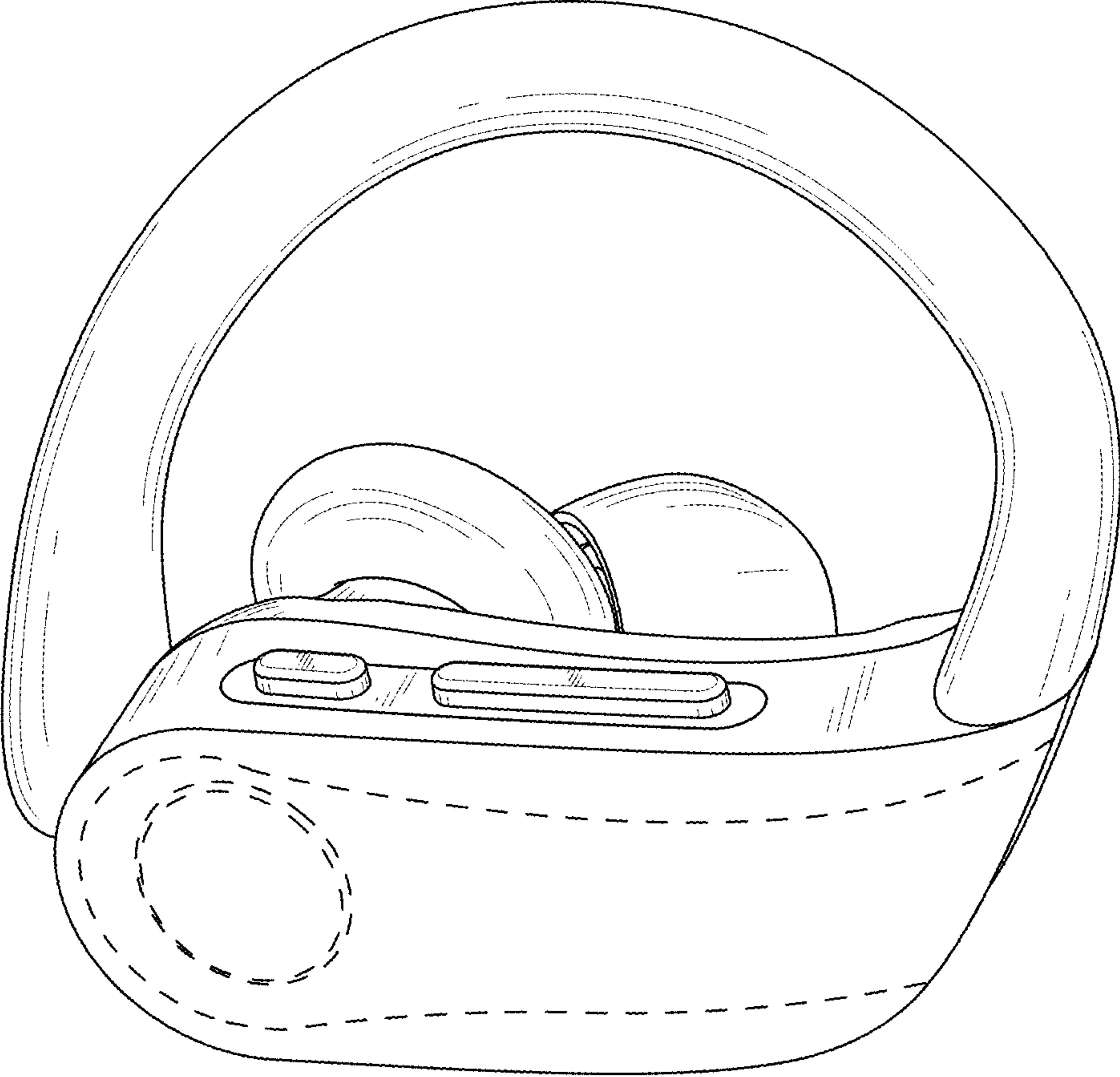

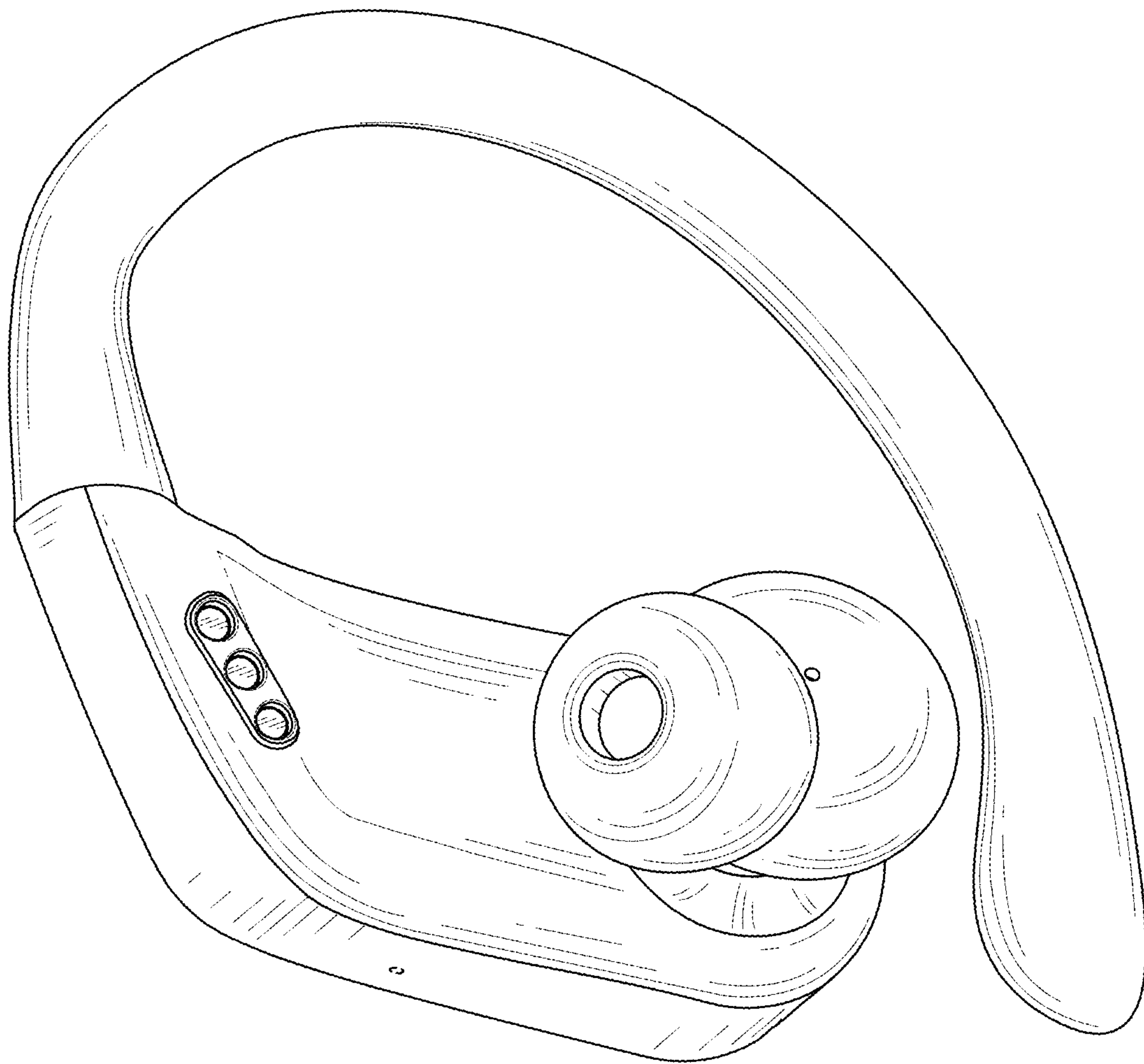

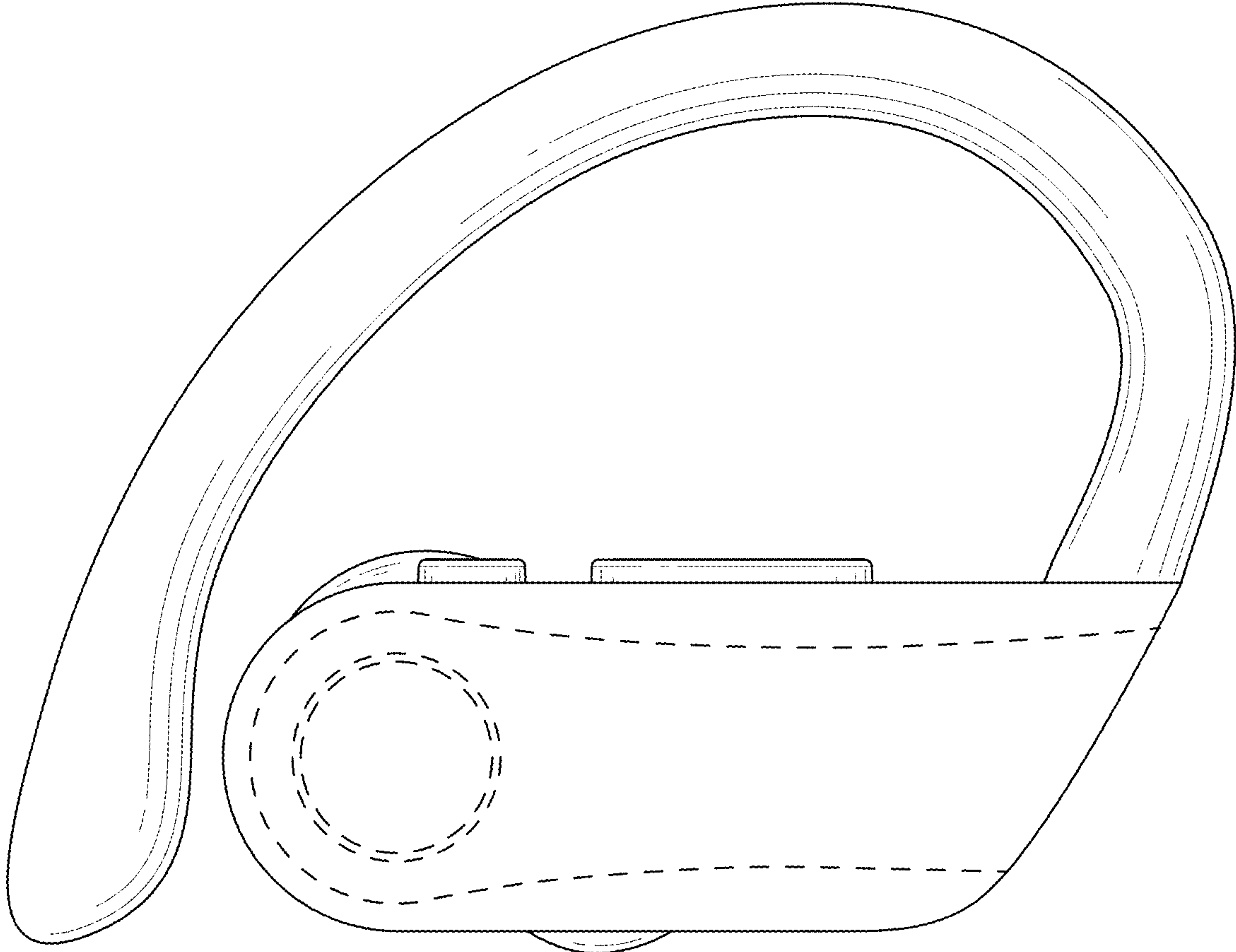

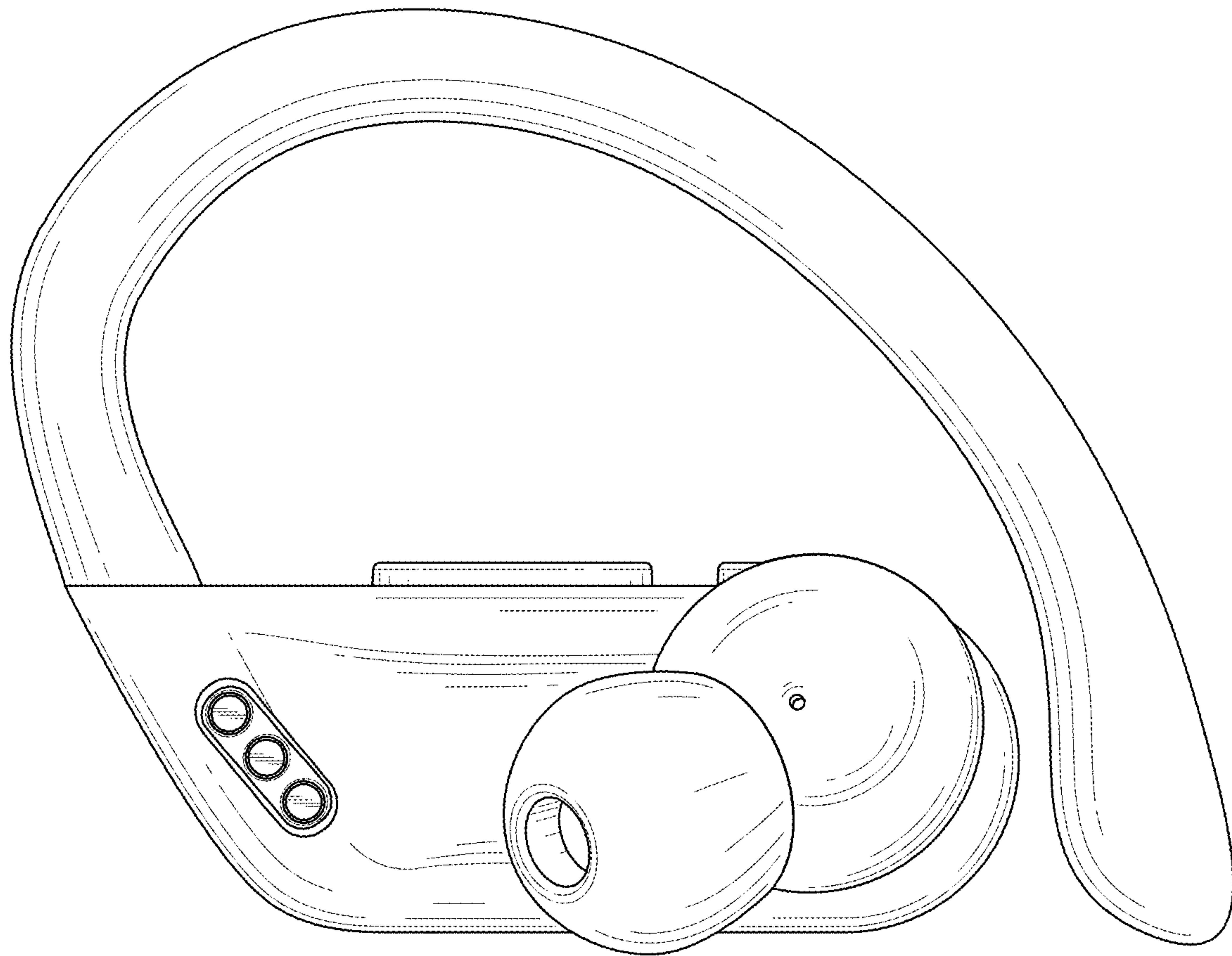

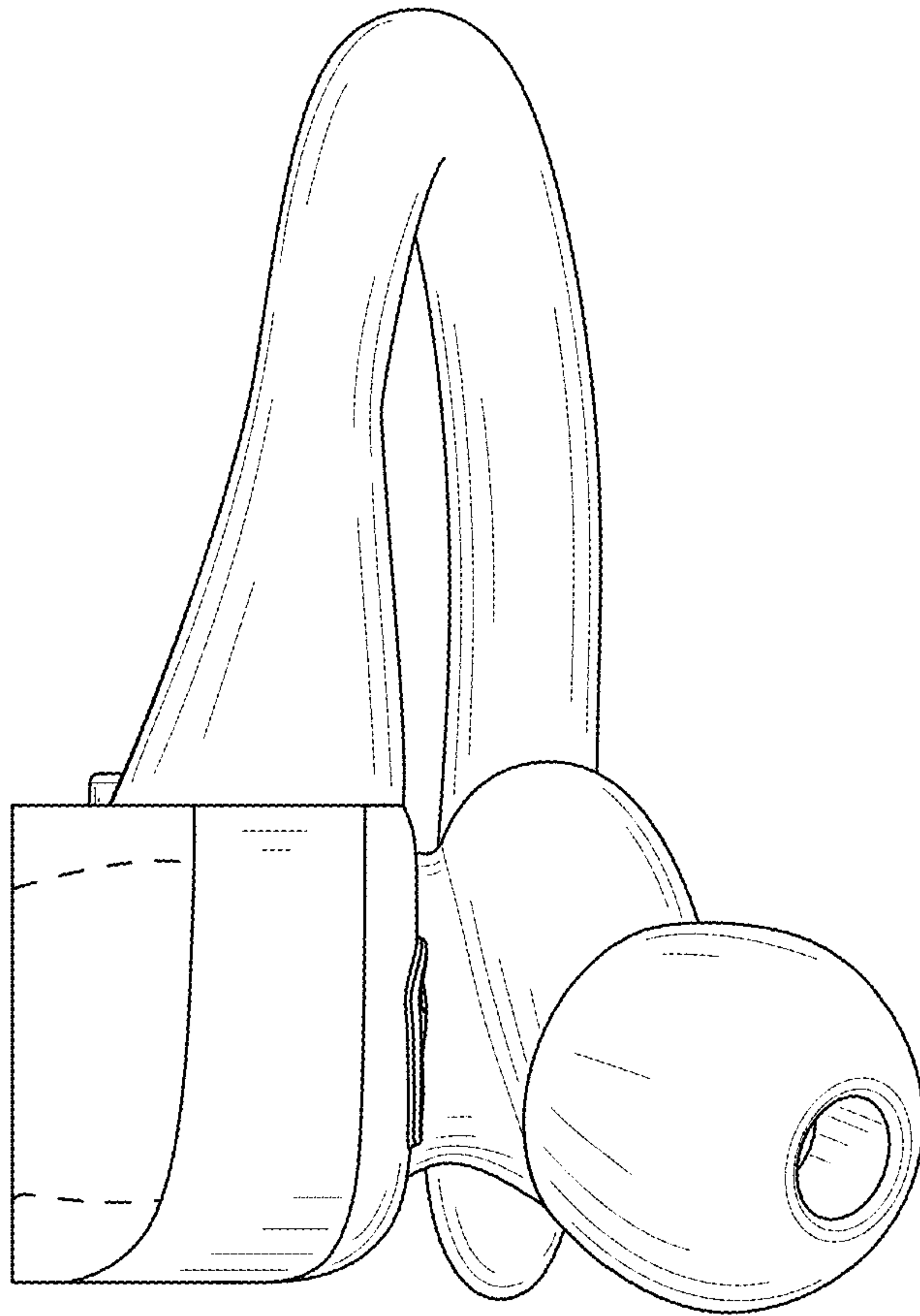

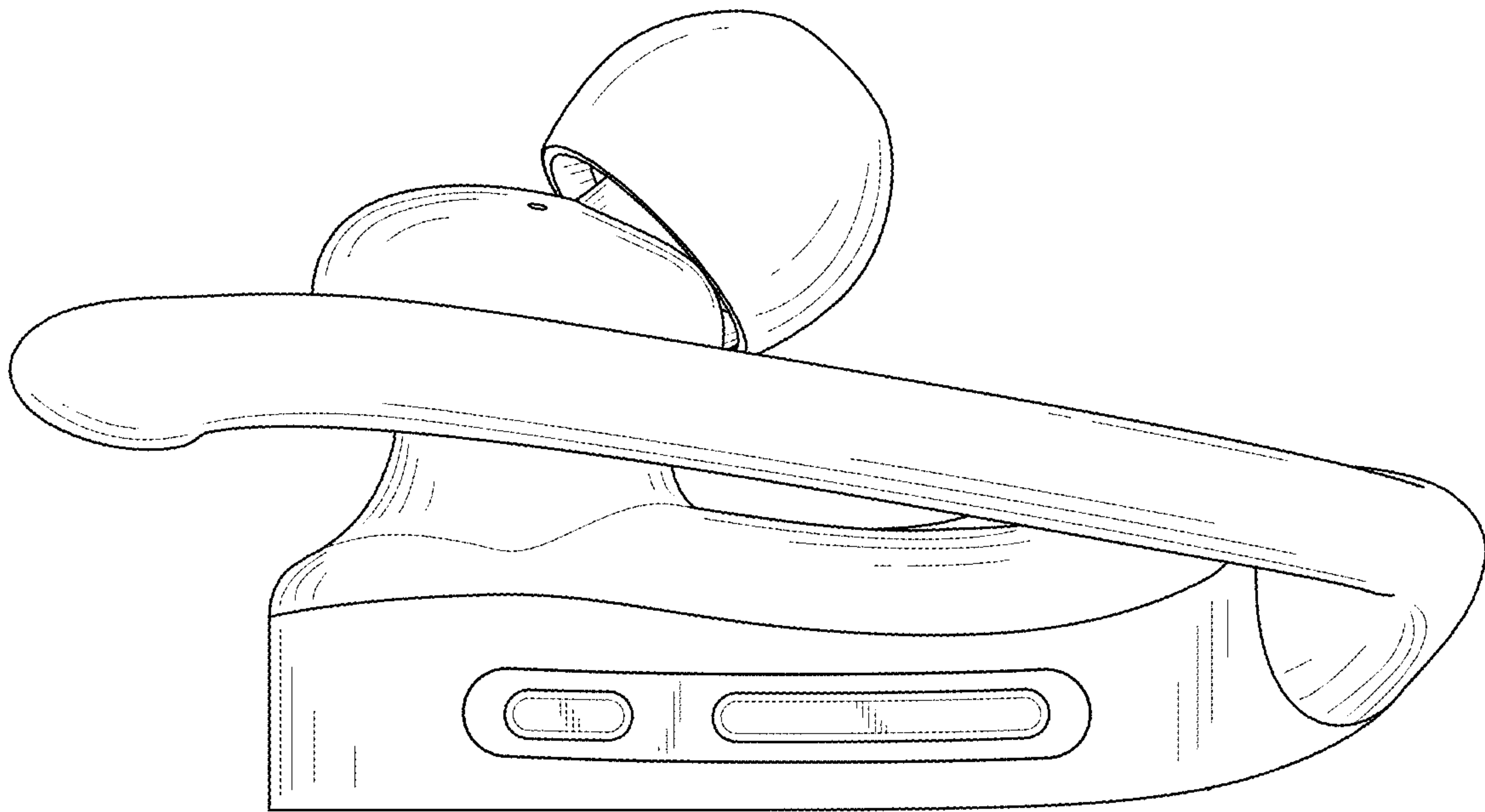

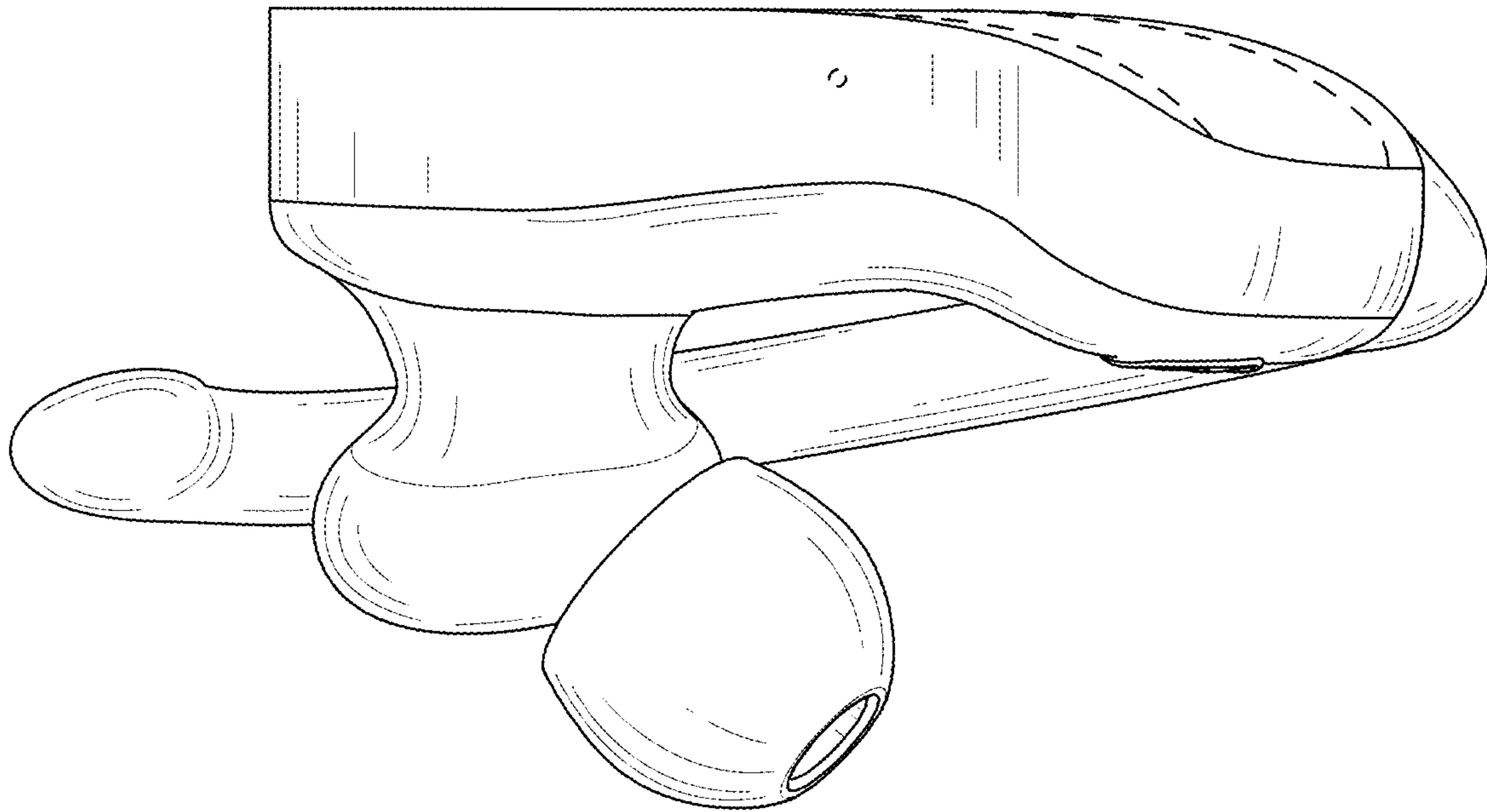

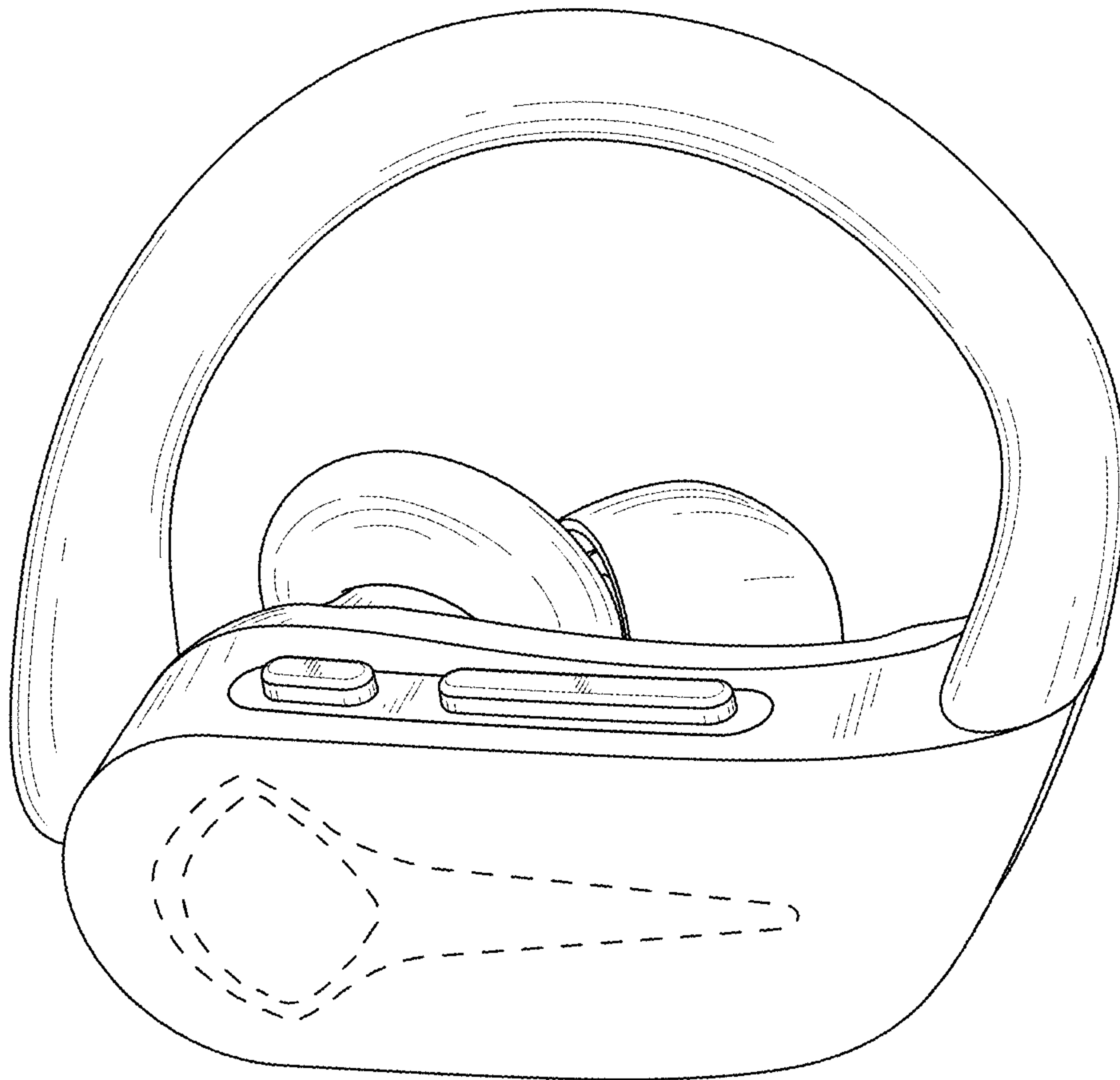

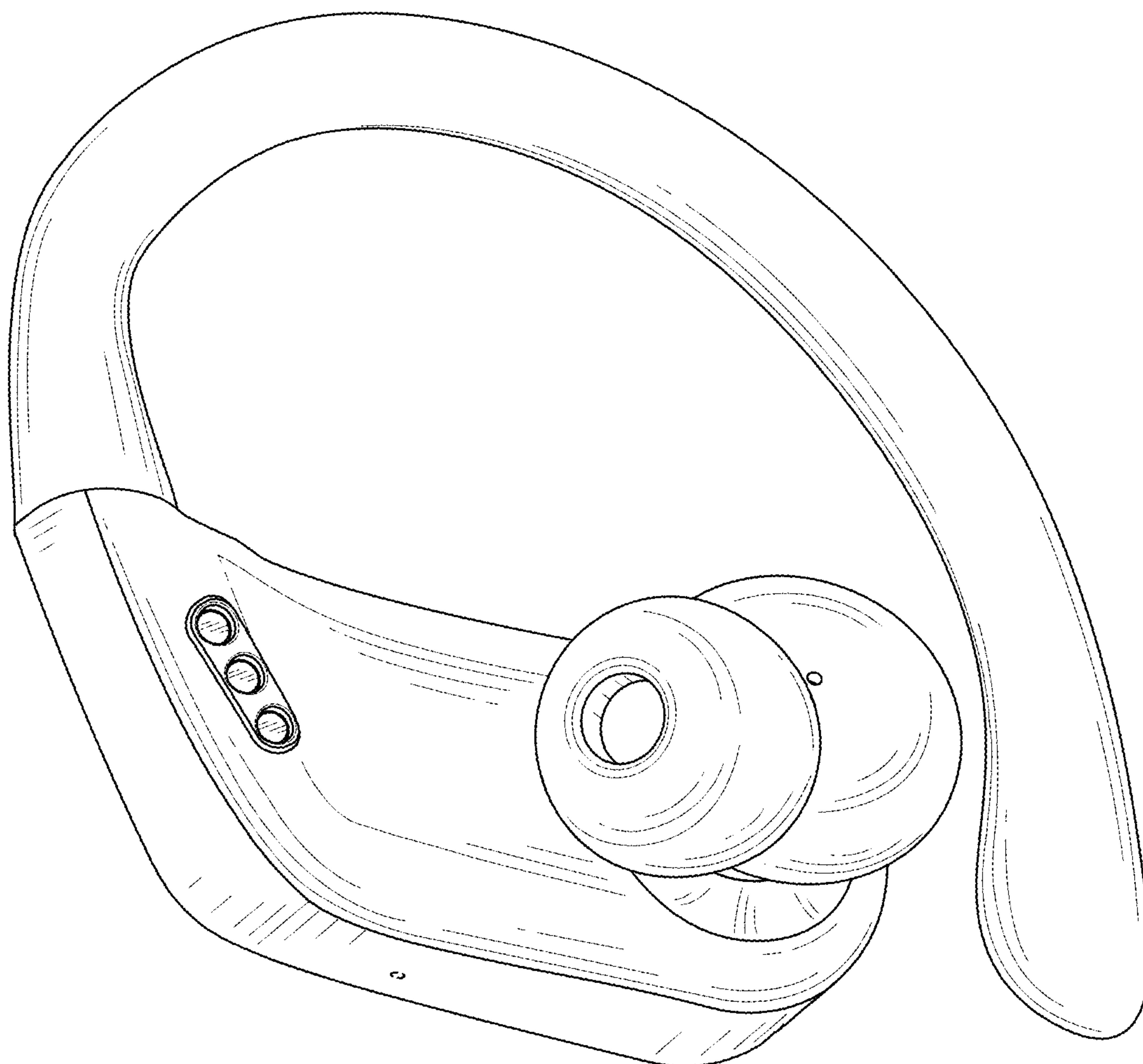

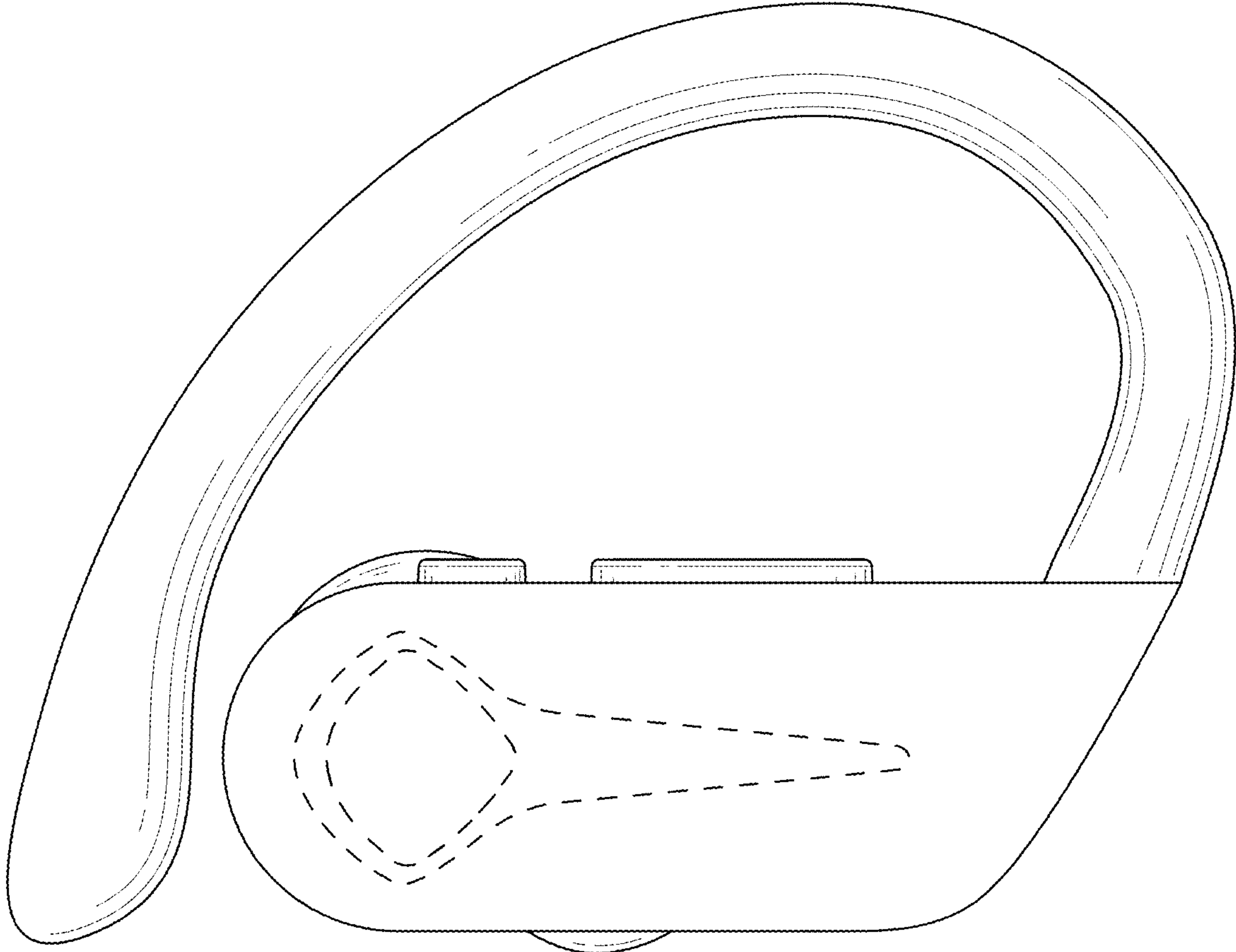

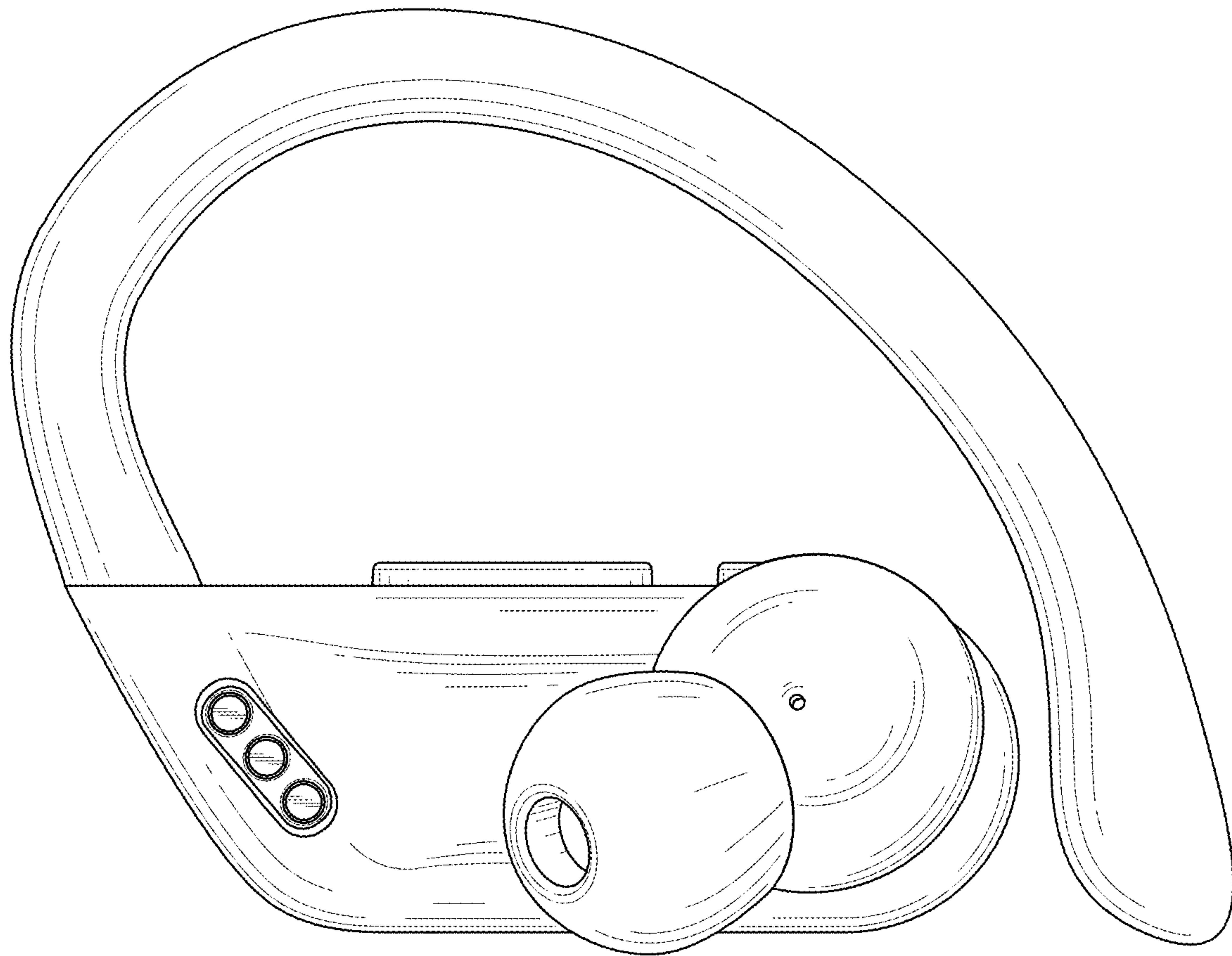

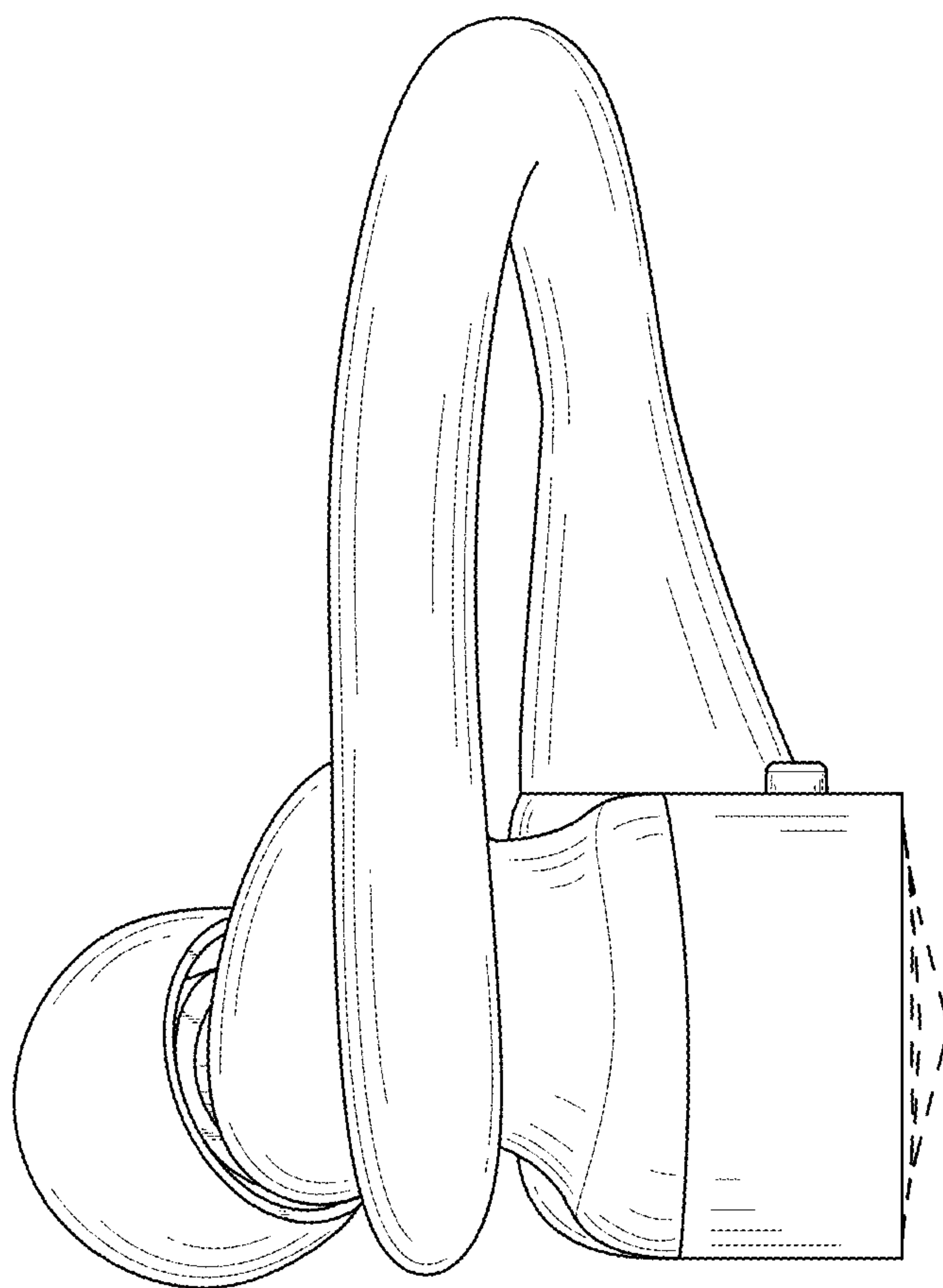

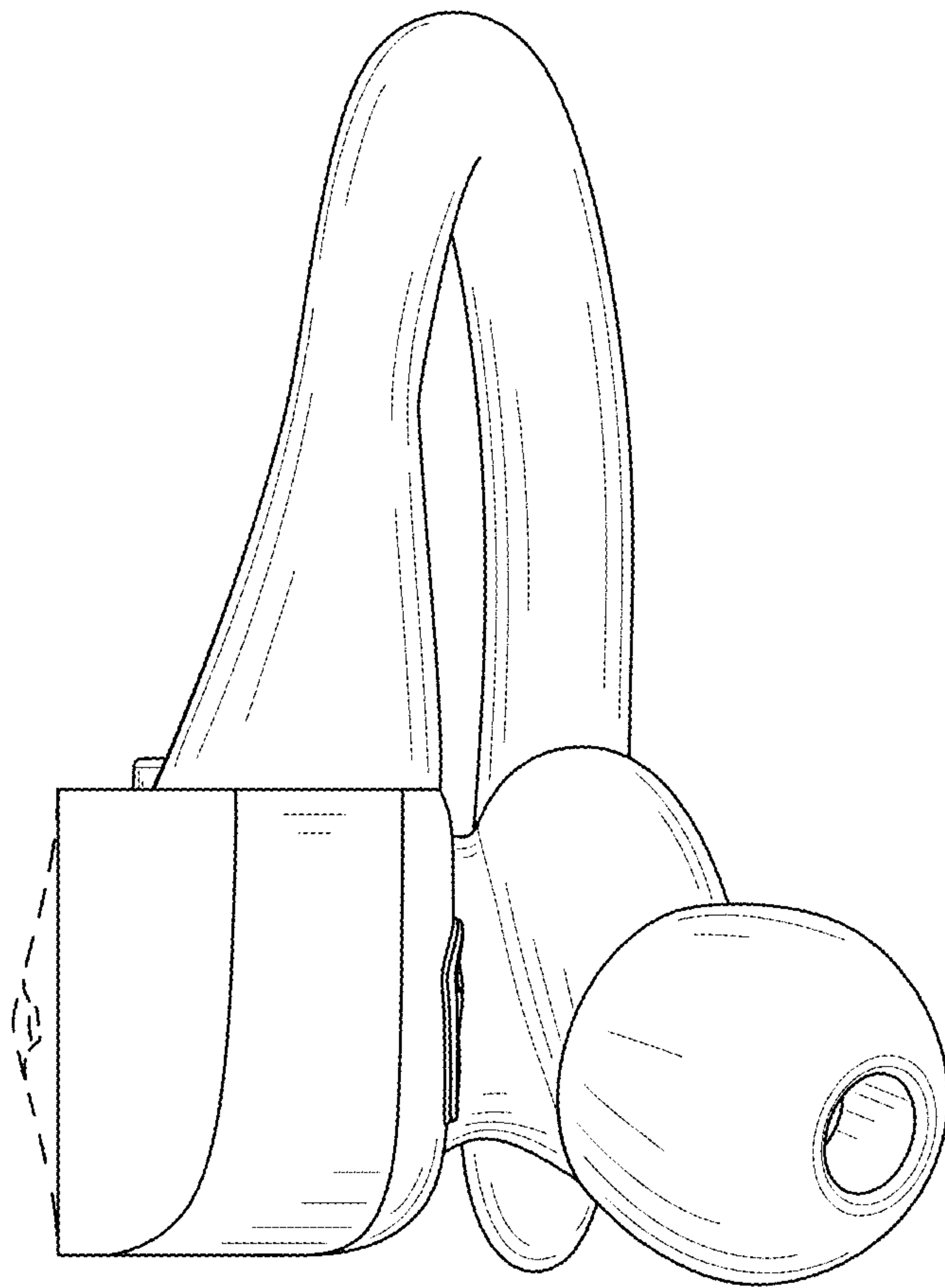

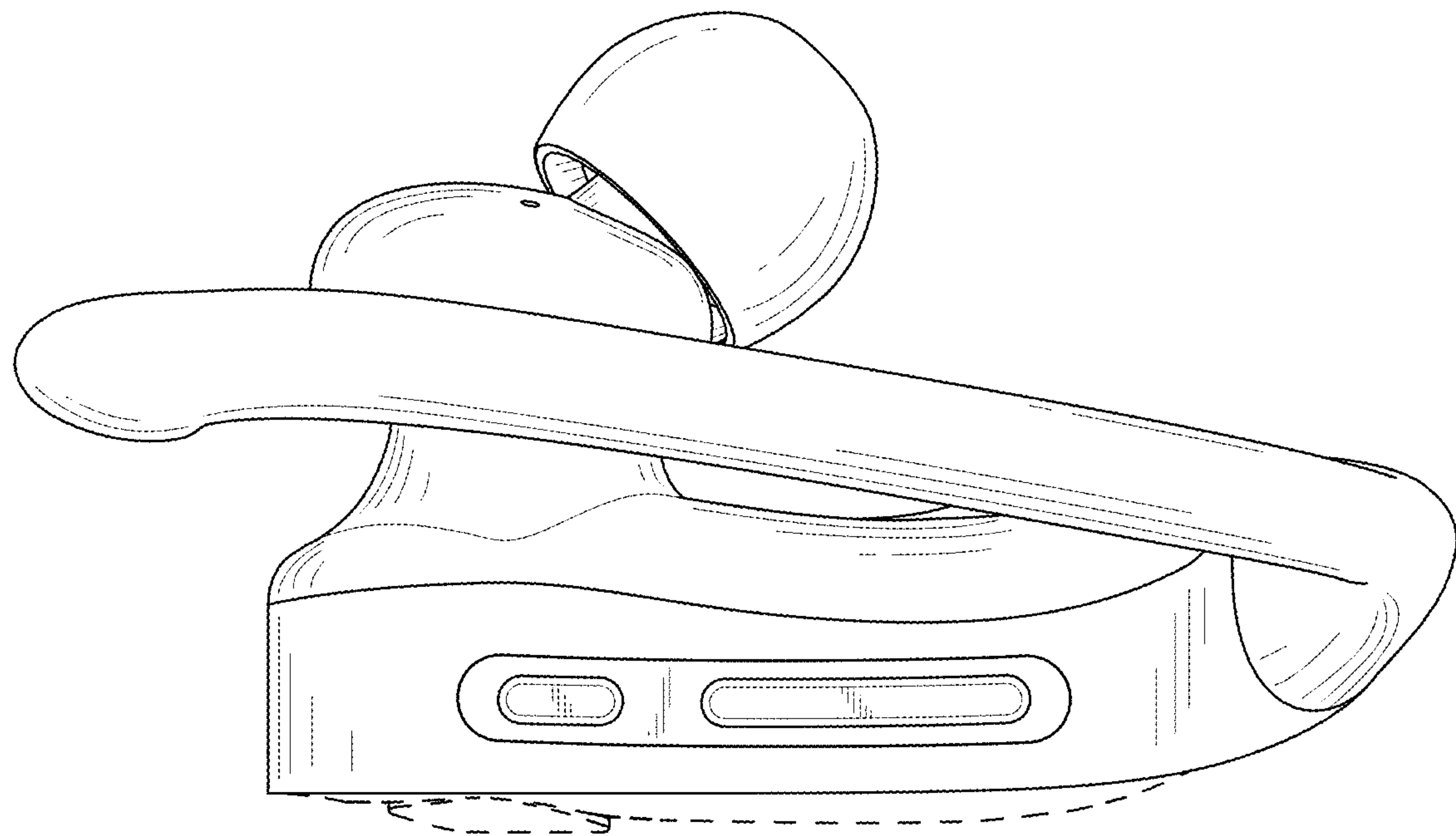

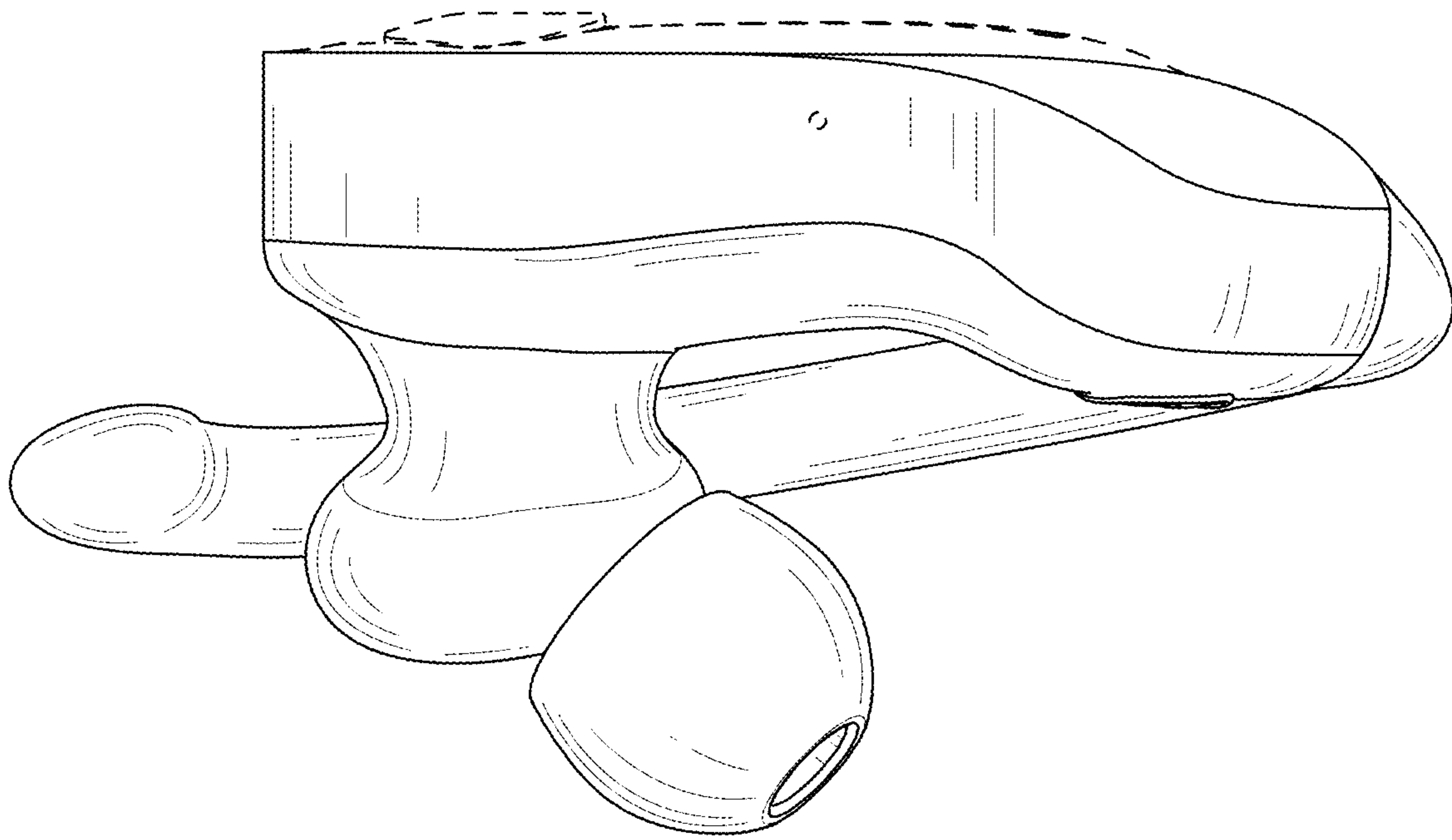

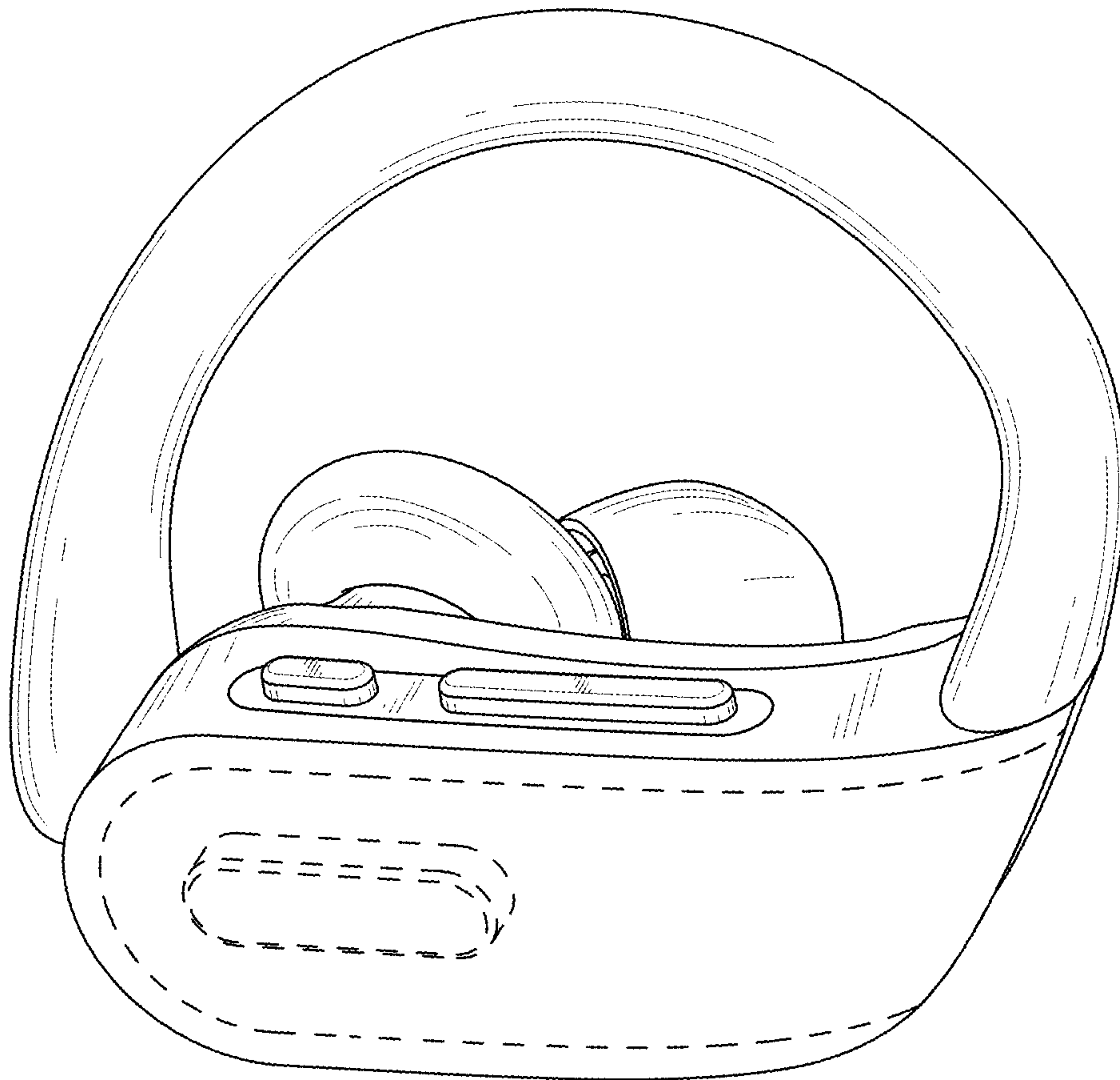

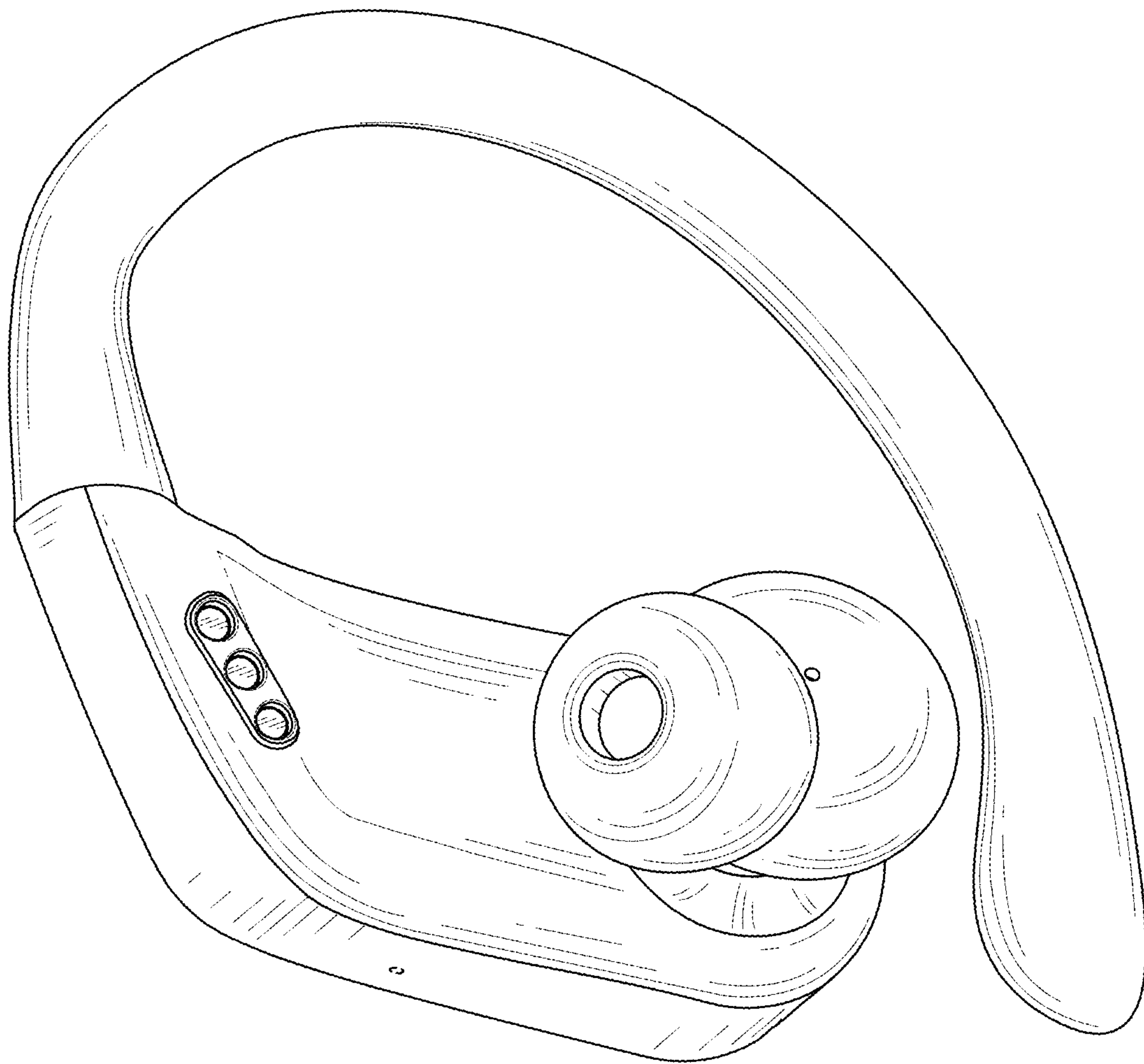

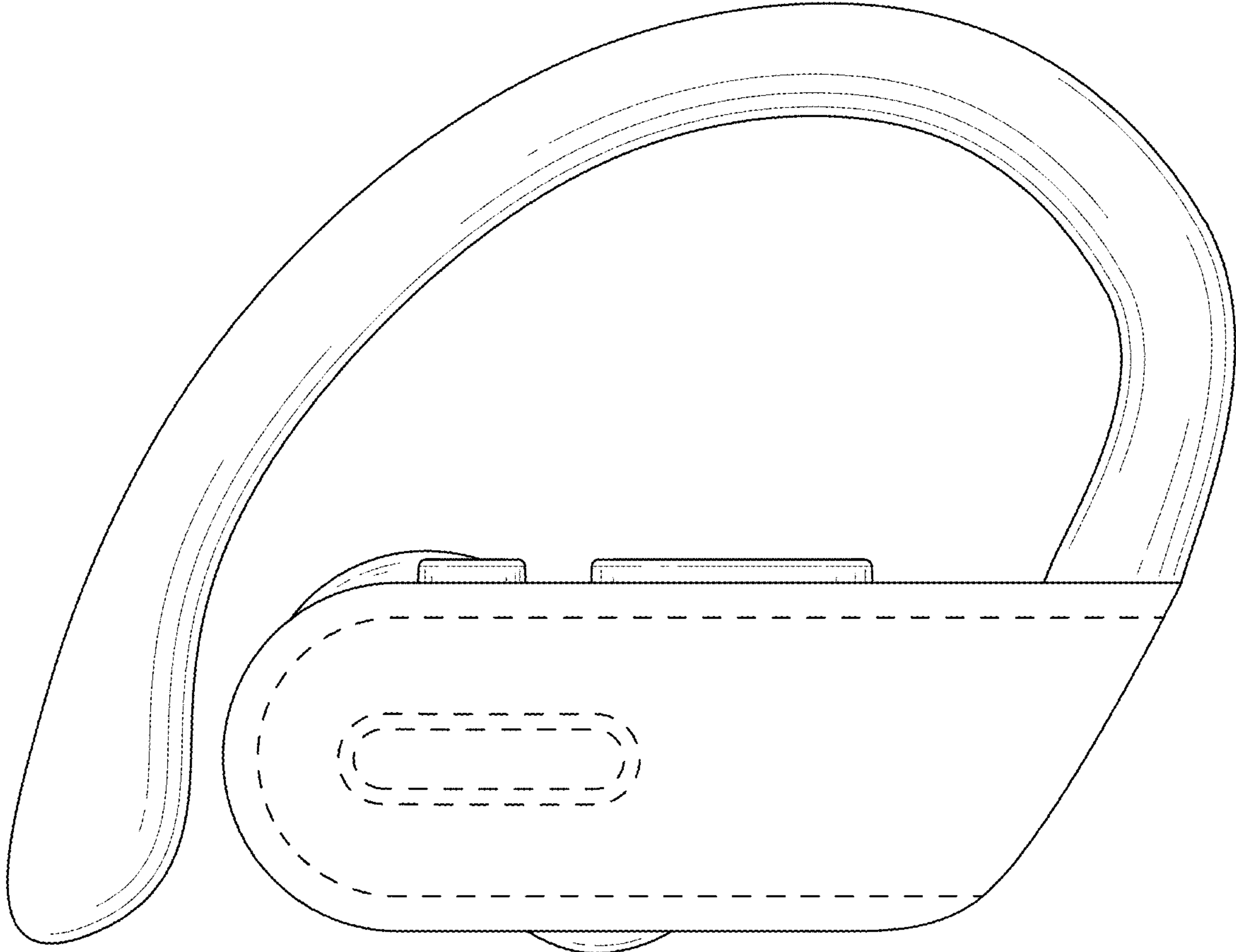

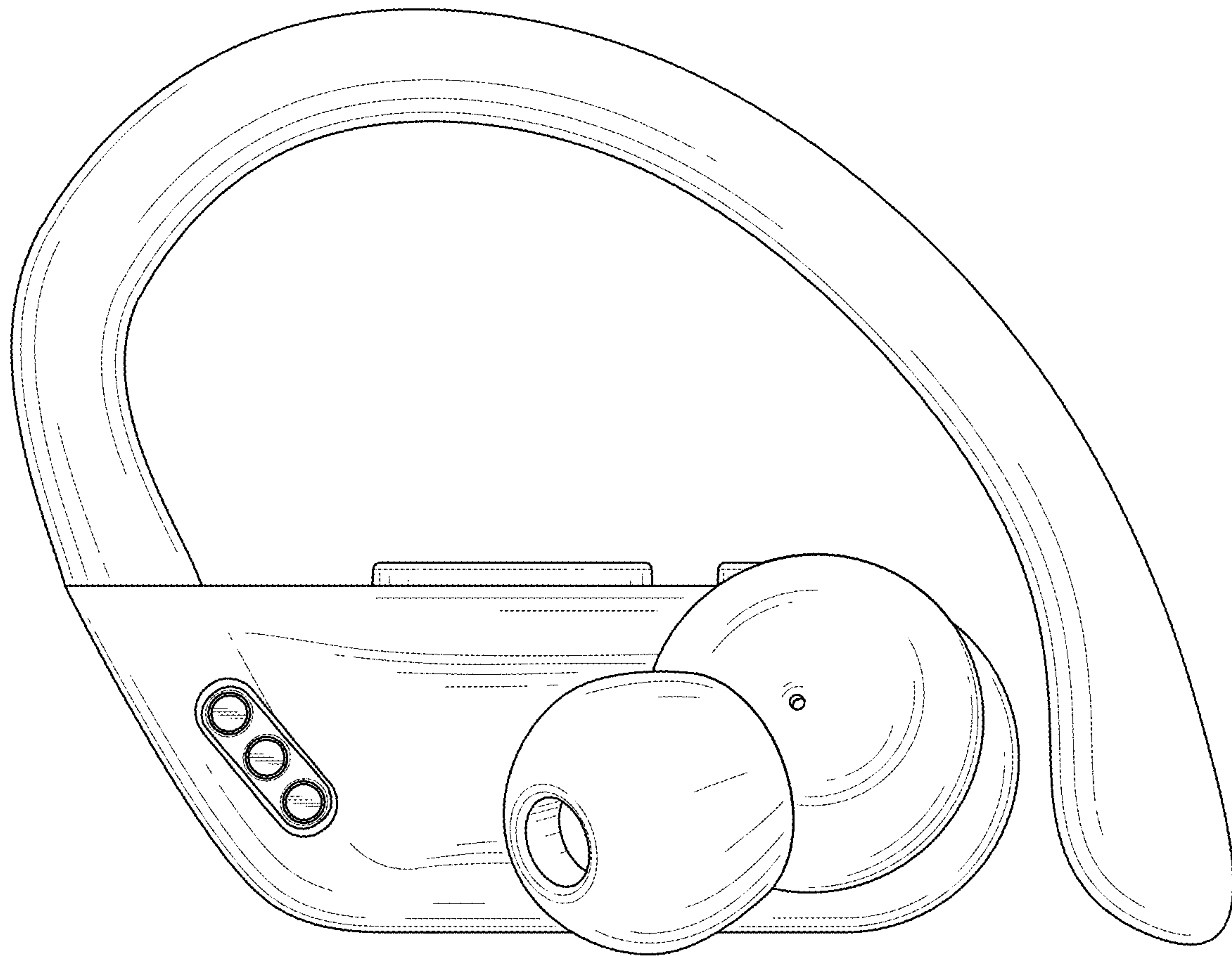

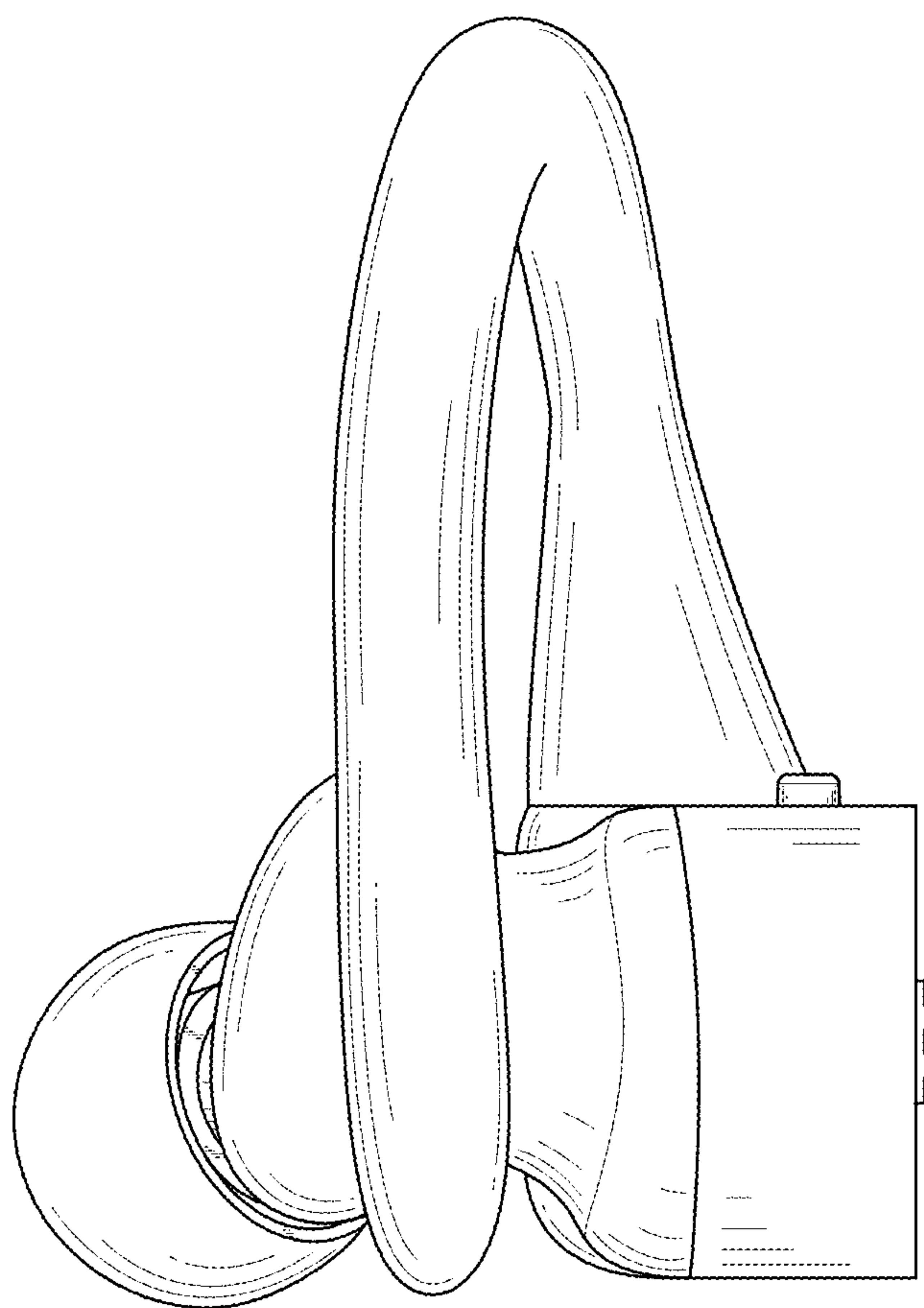

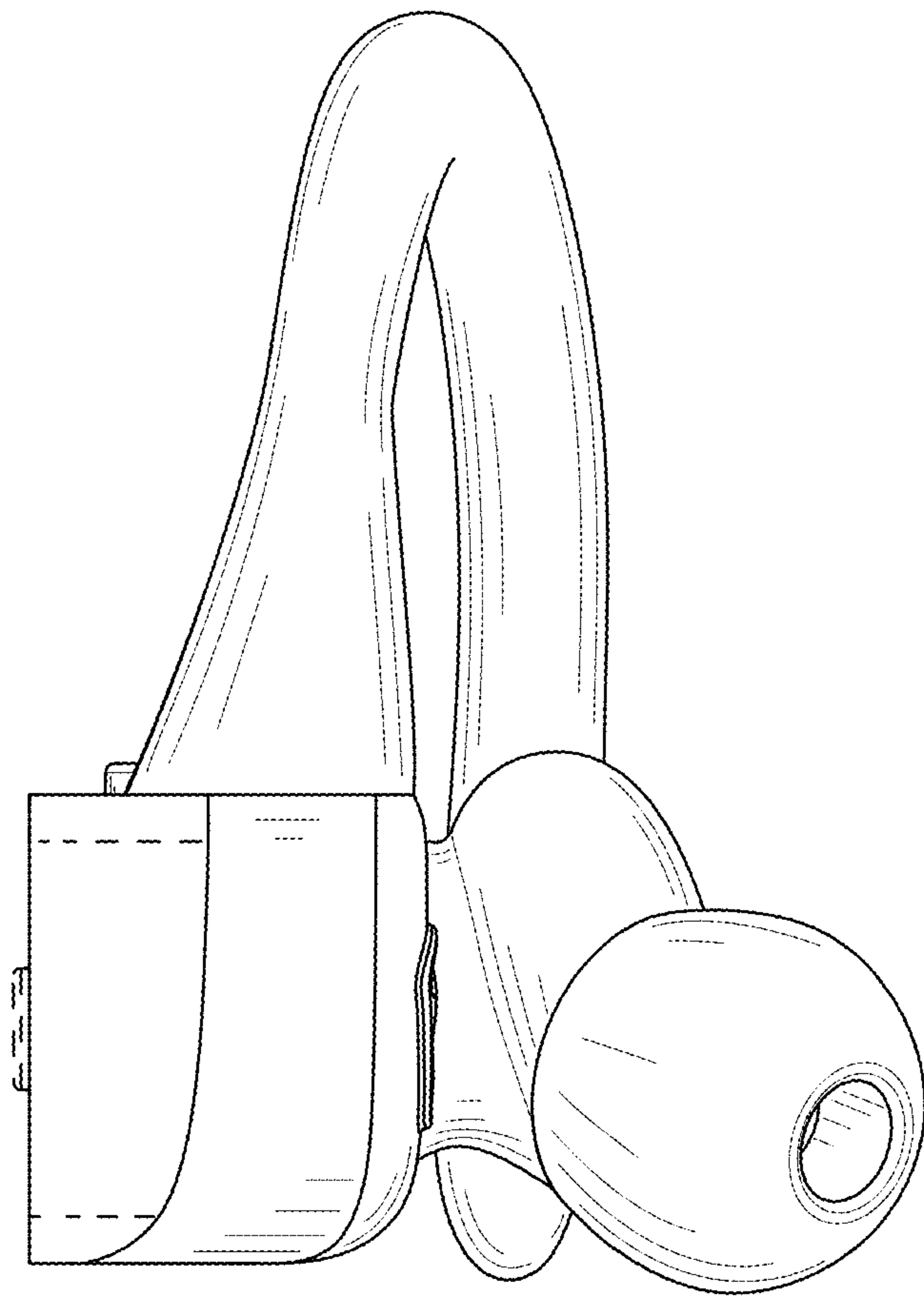

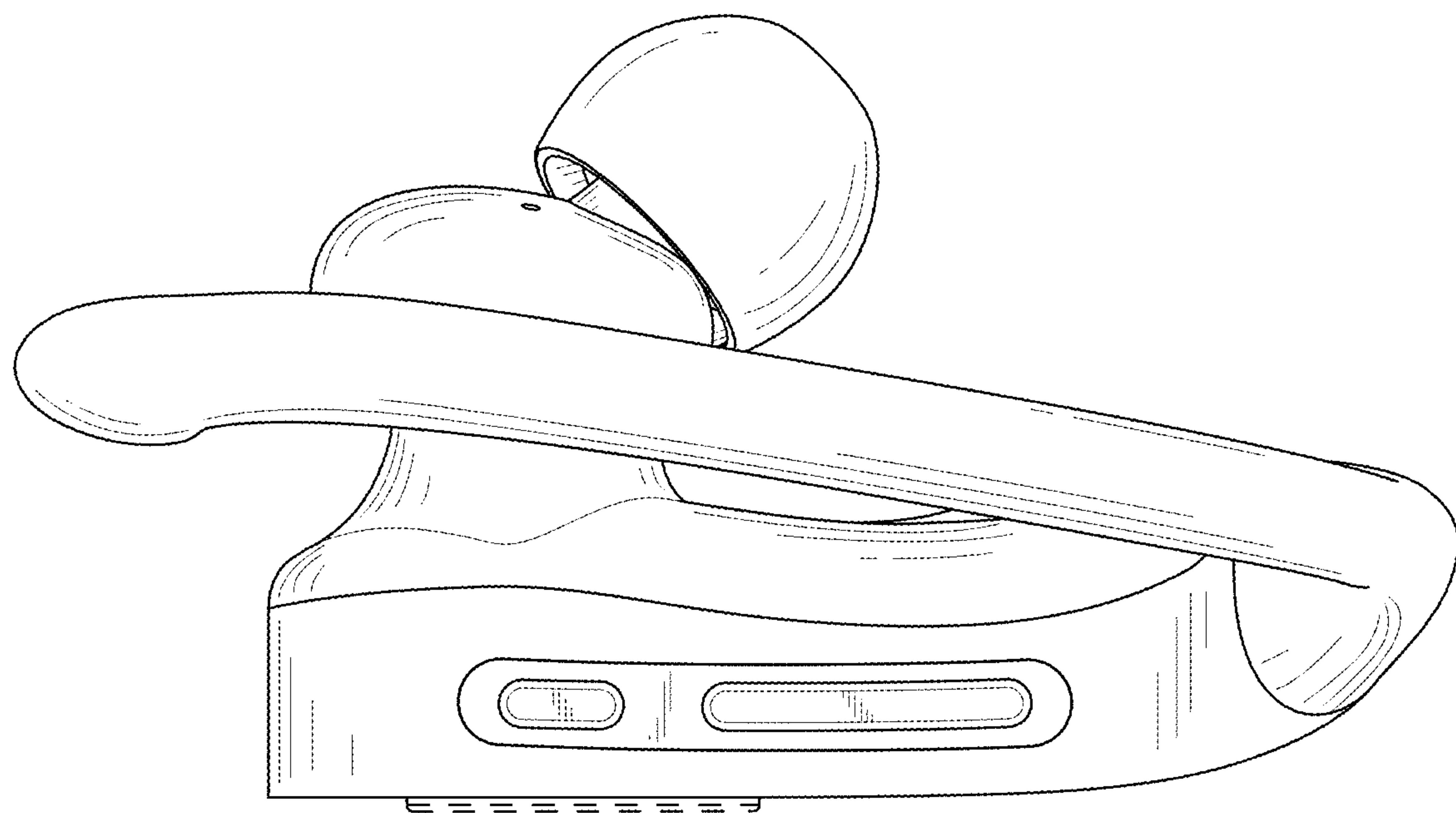

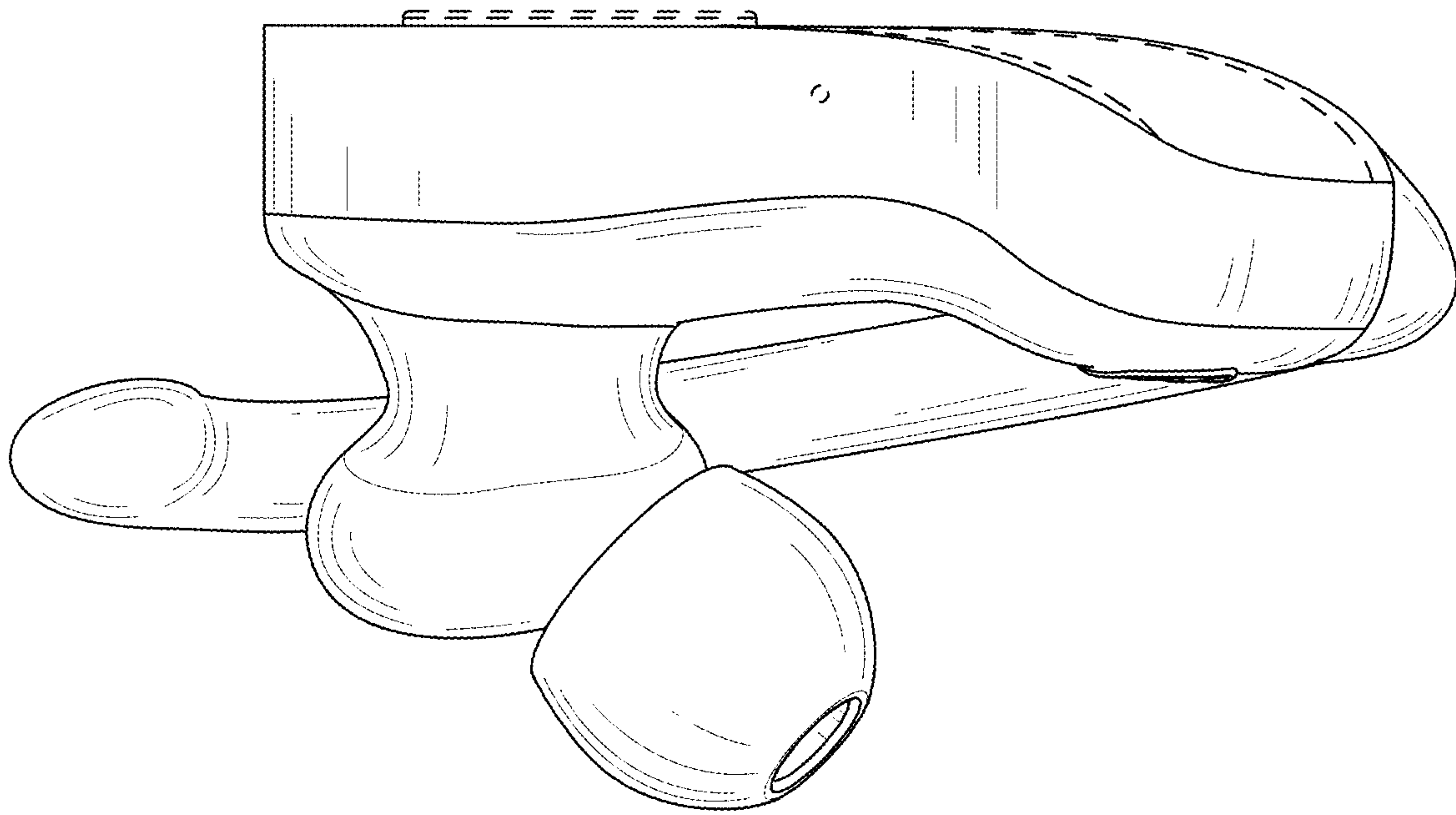

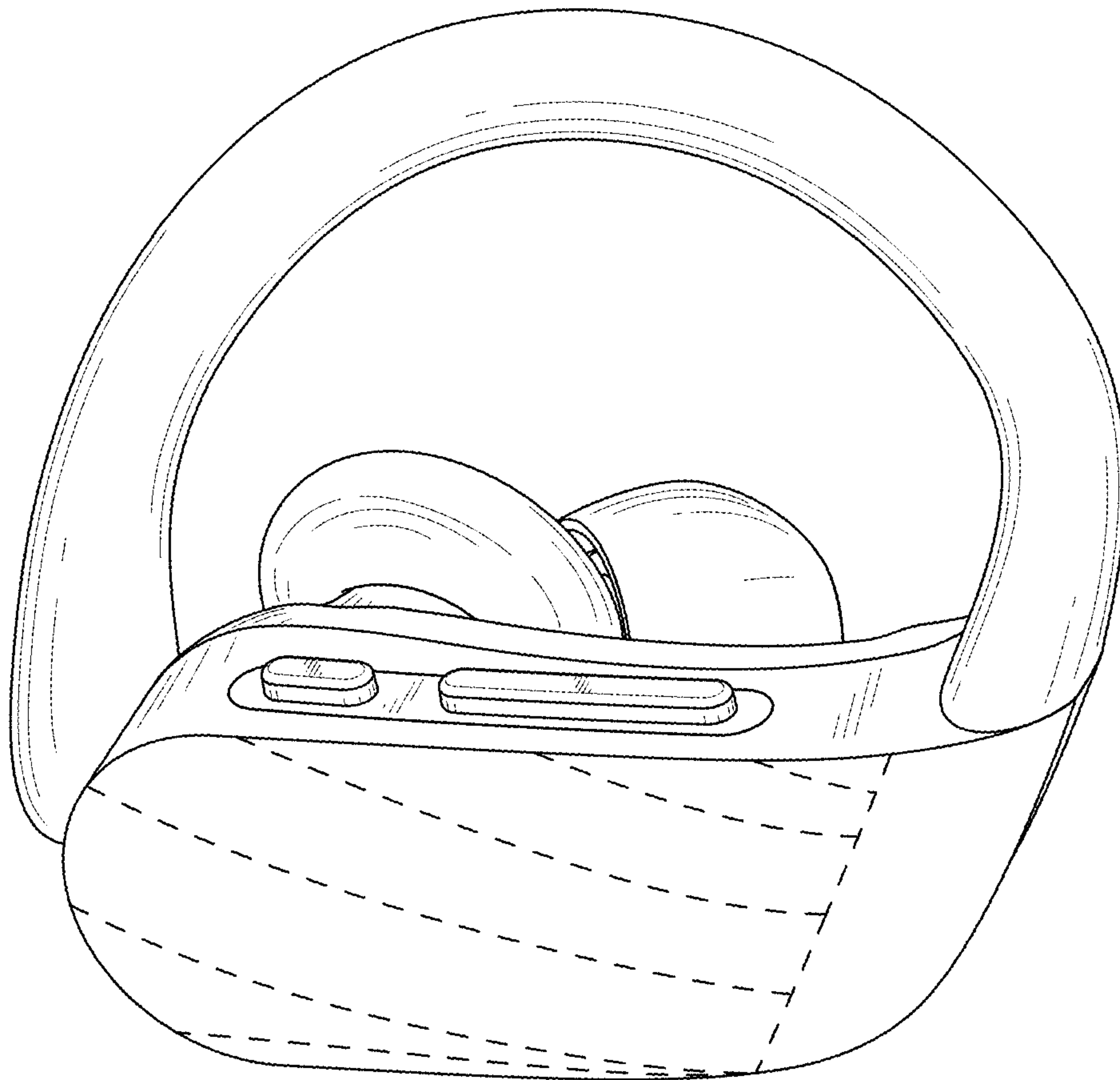

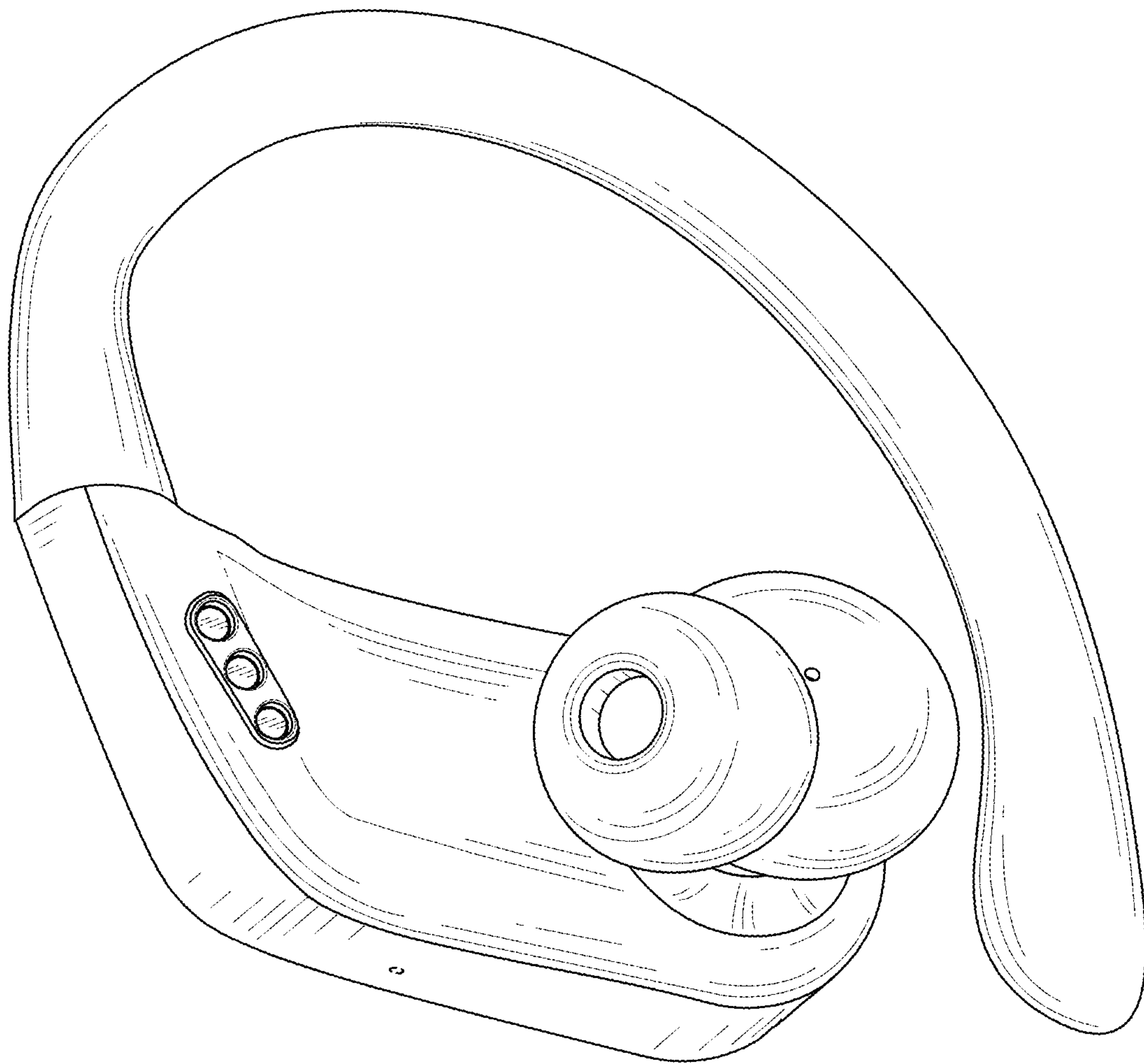

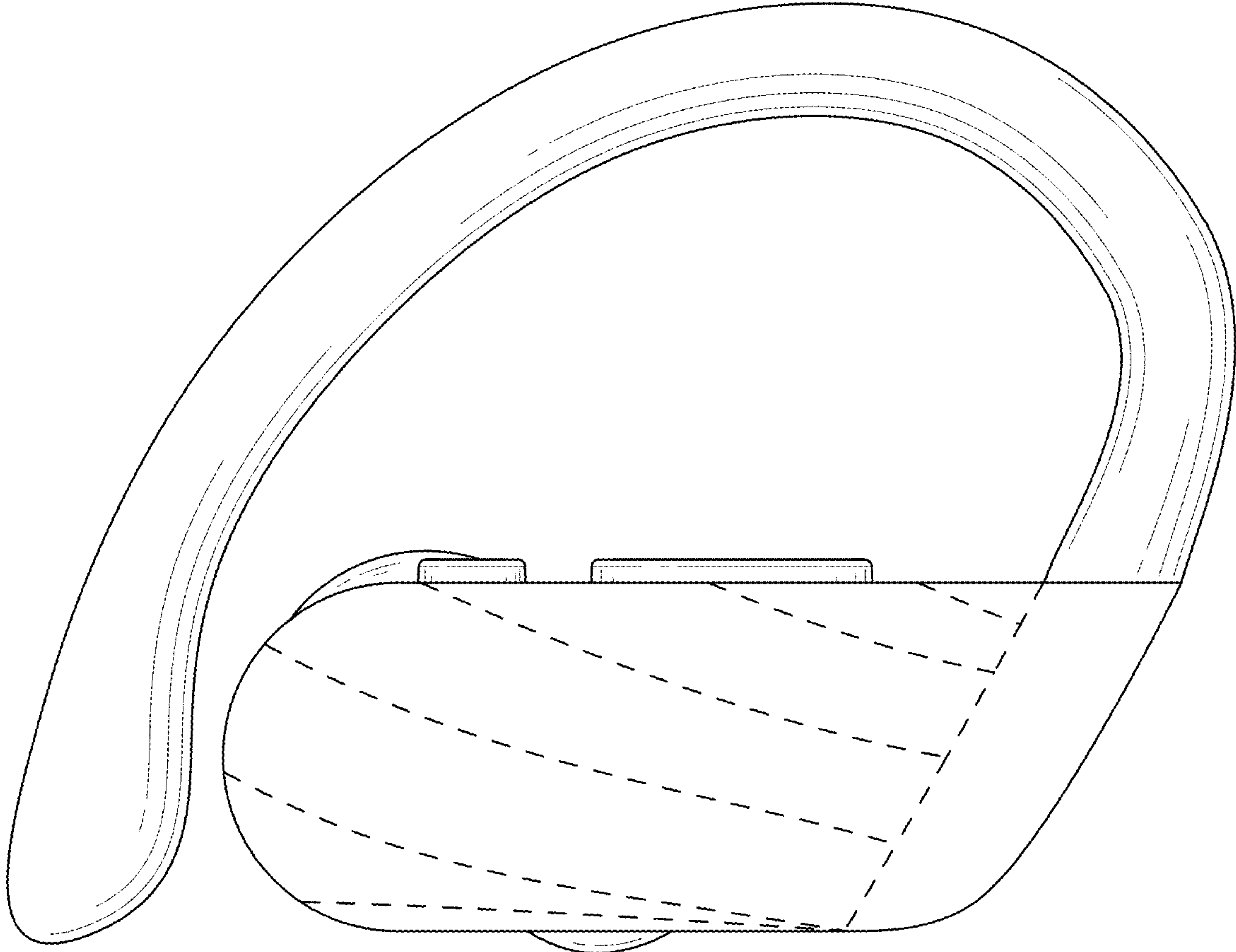

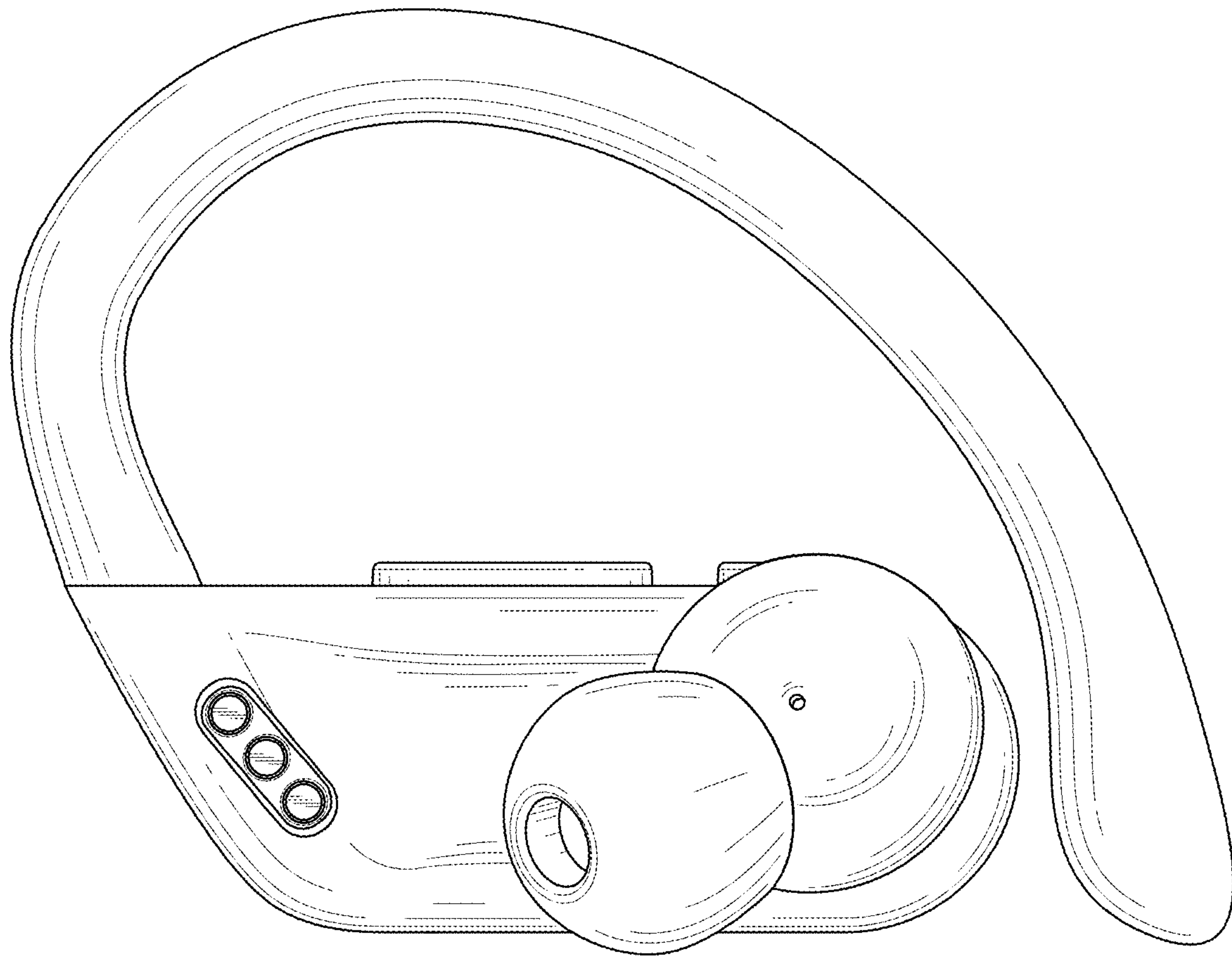

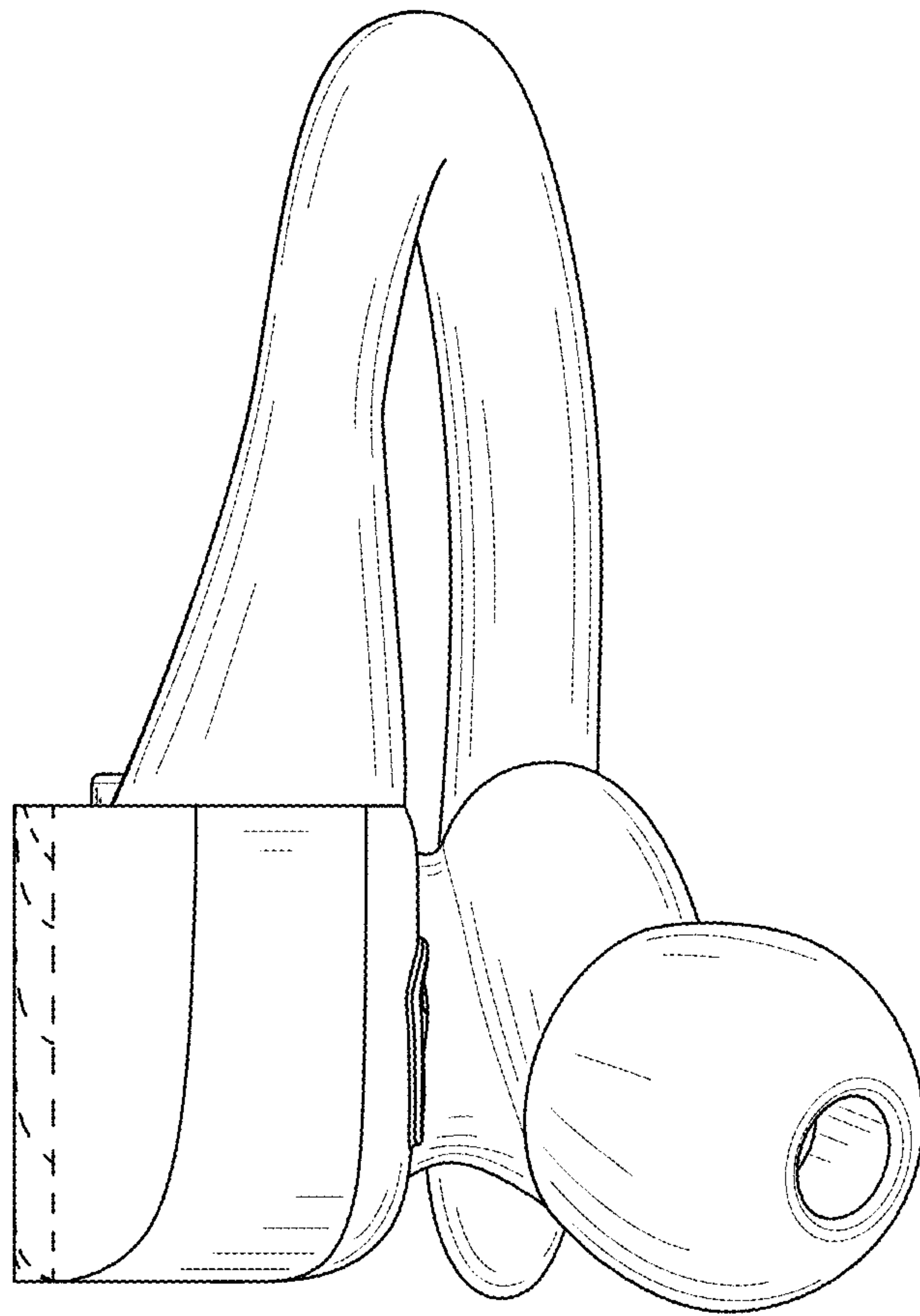

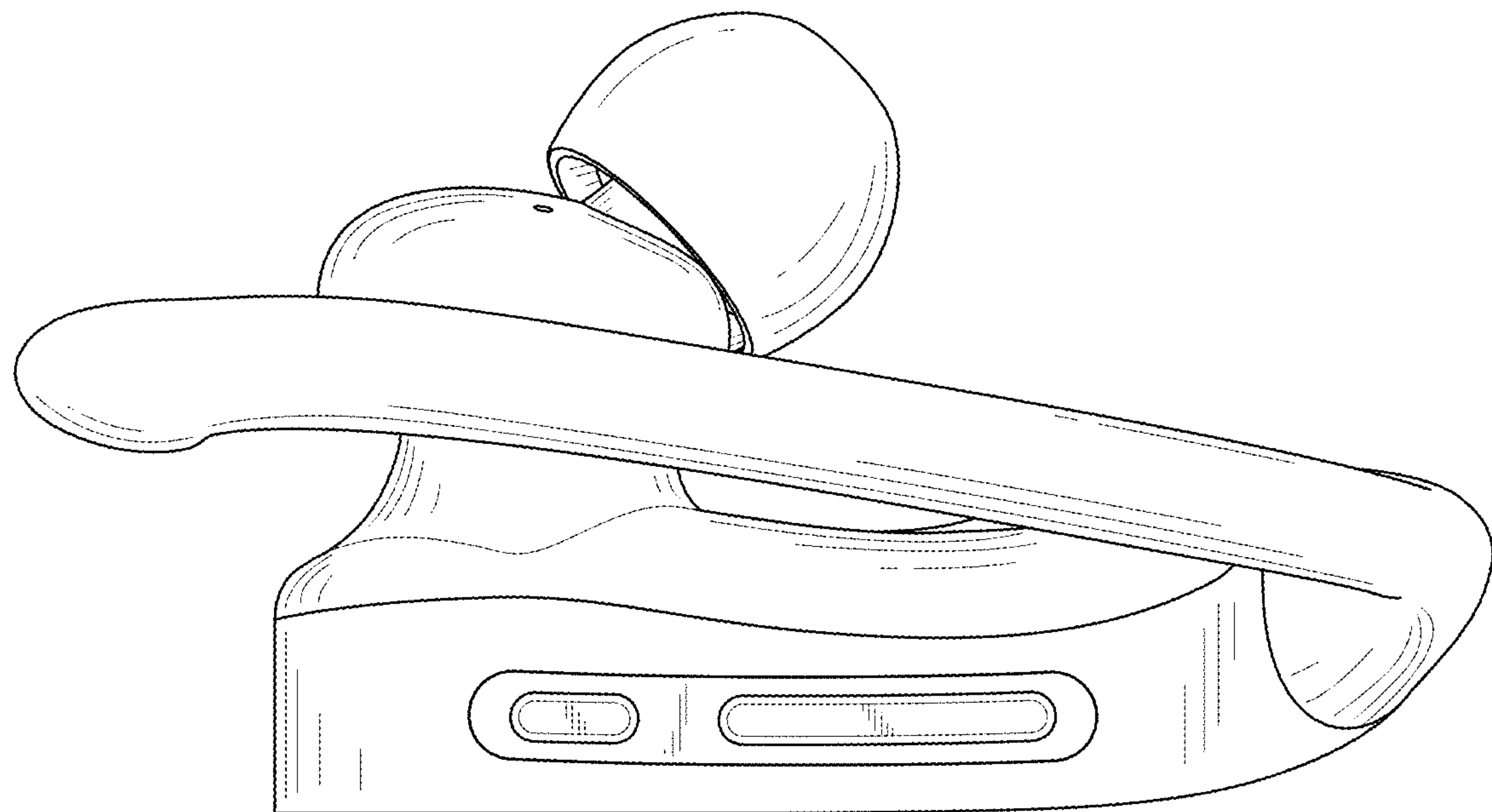

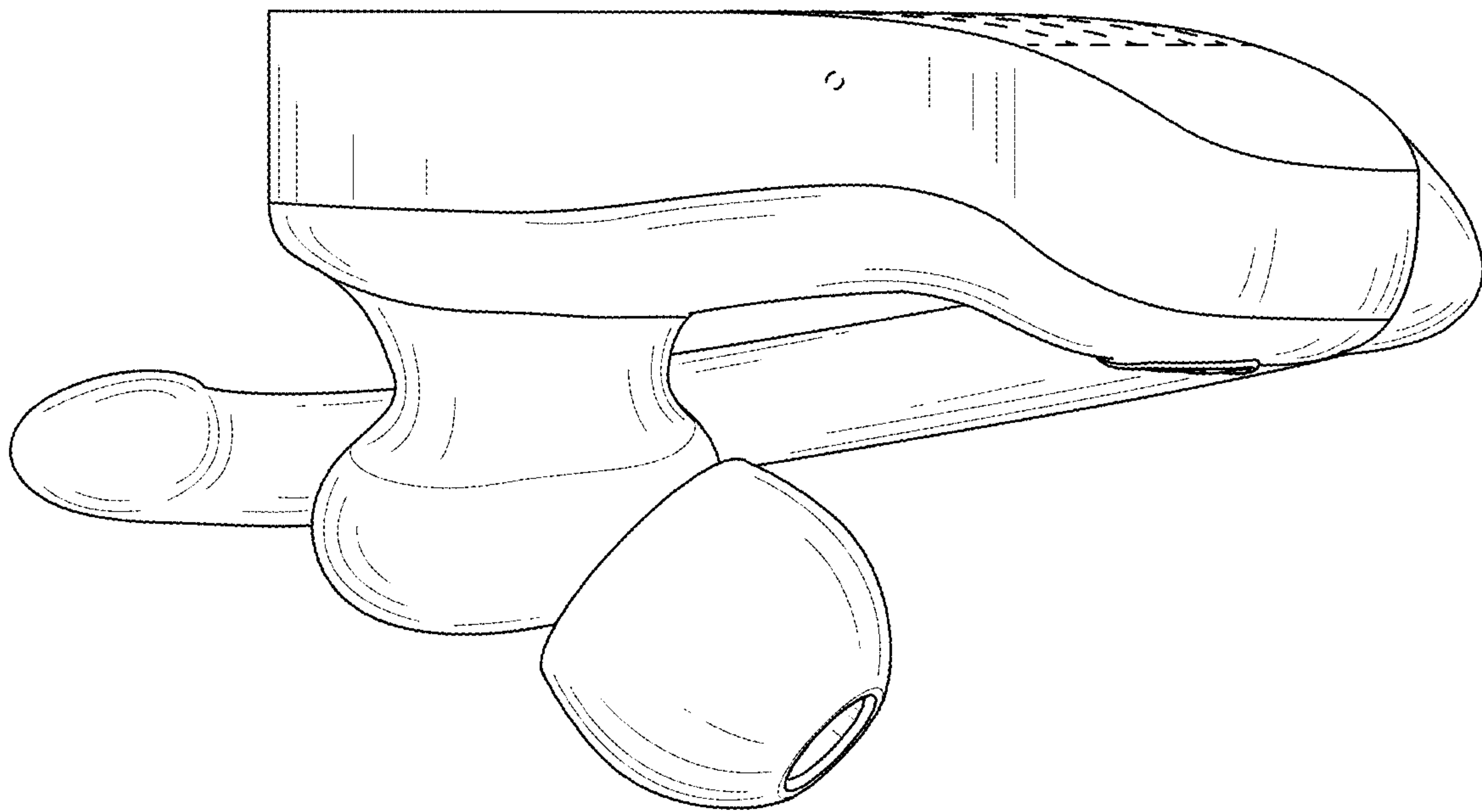
