FIG. 1 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image of the claimed design; and,

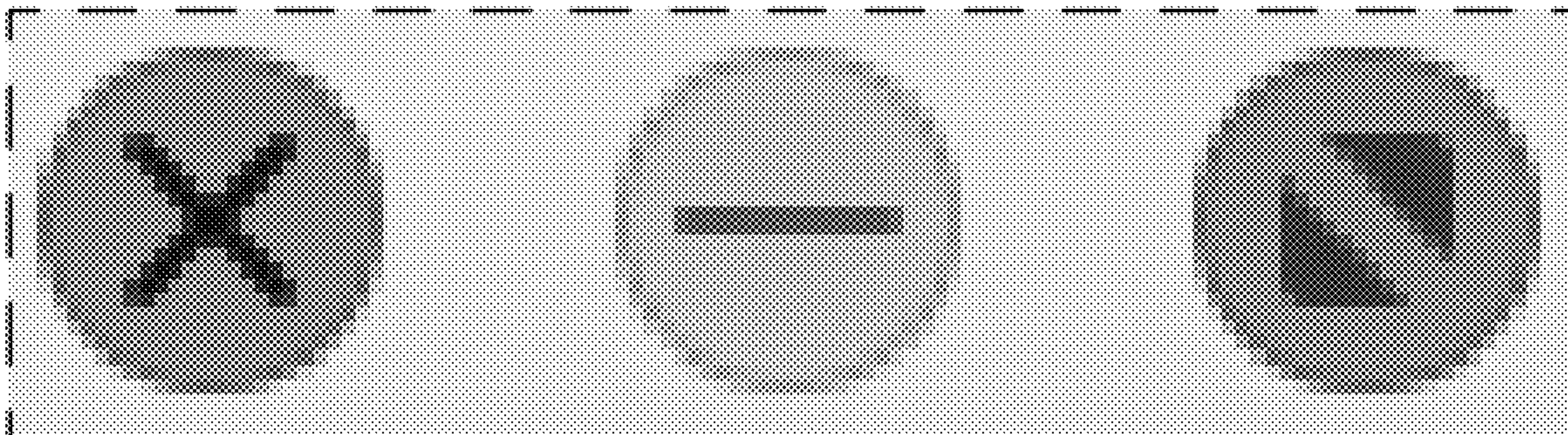
FIG. 2 is a second image thereof.

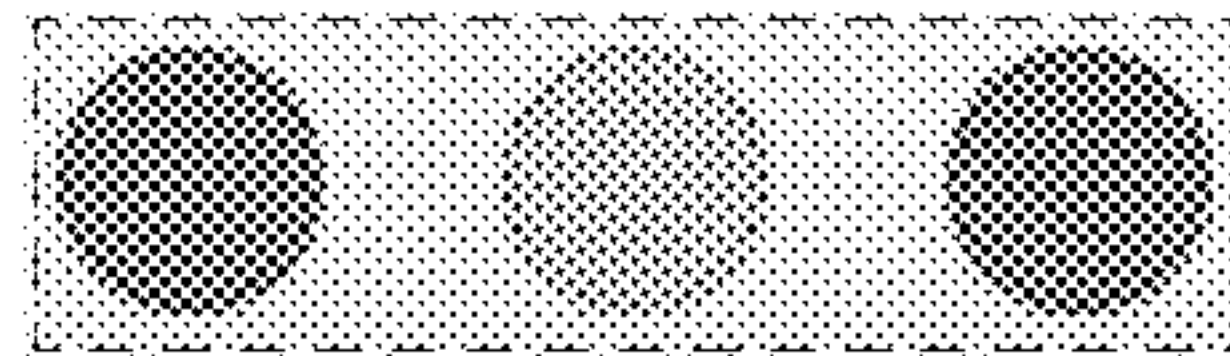

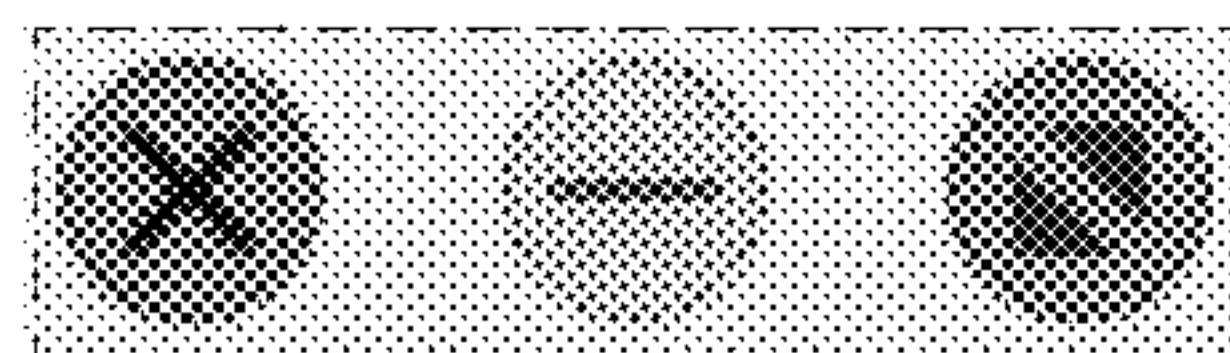
