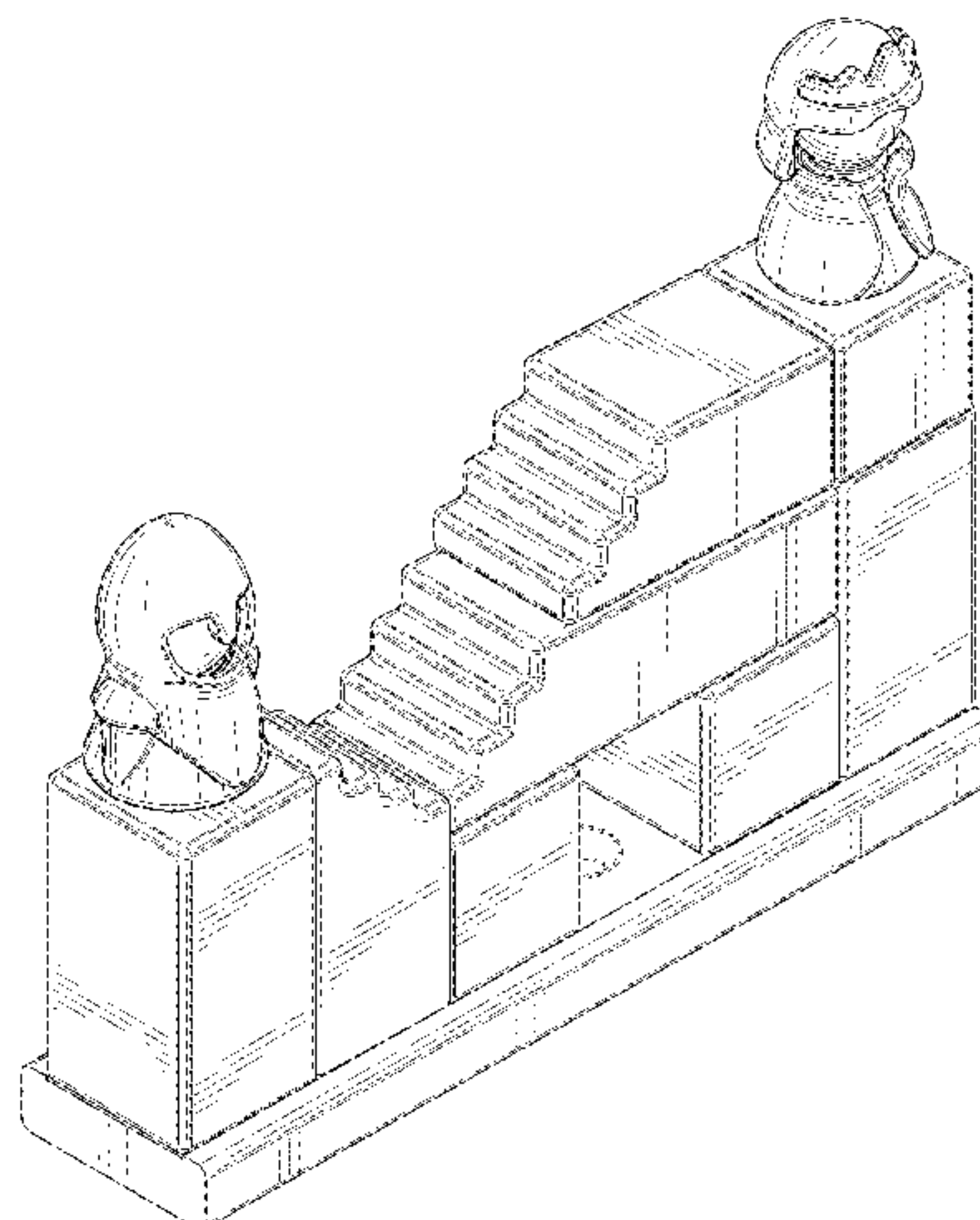

(57) **CLAIM**

The ornamental design for a game board and game pieces, as shown and described.

DESCRIPTION

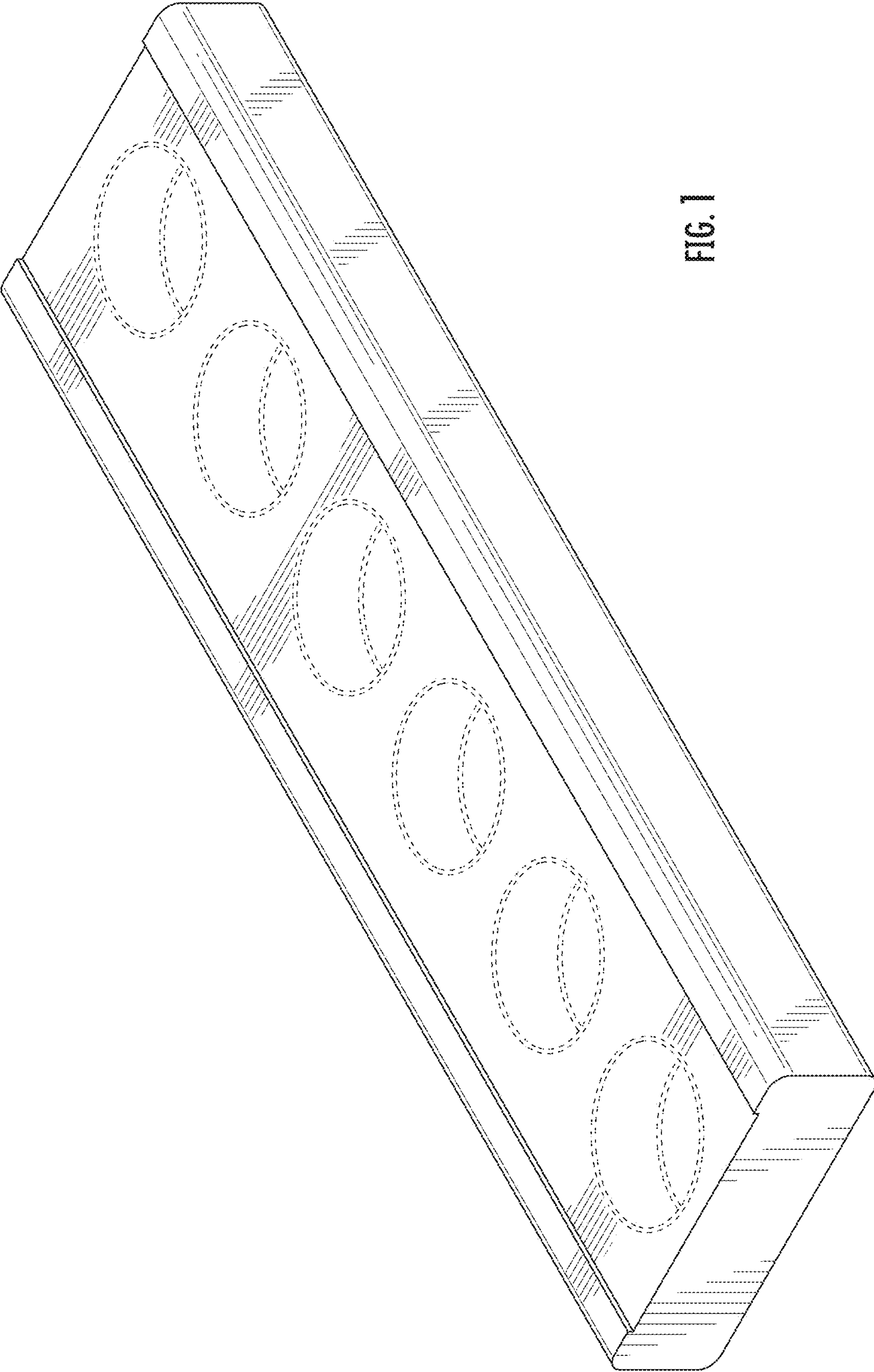

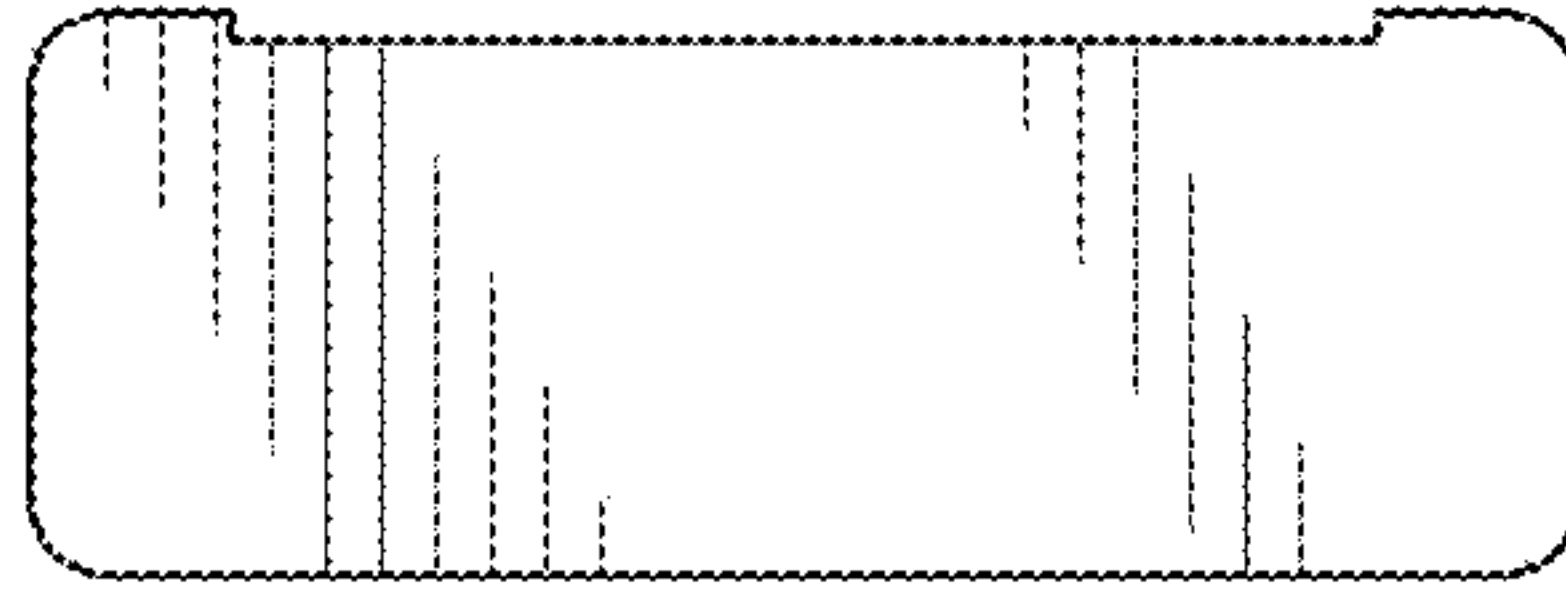

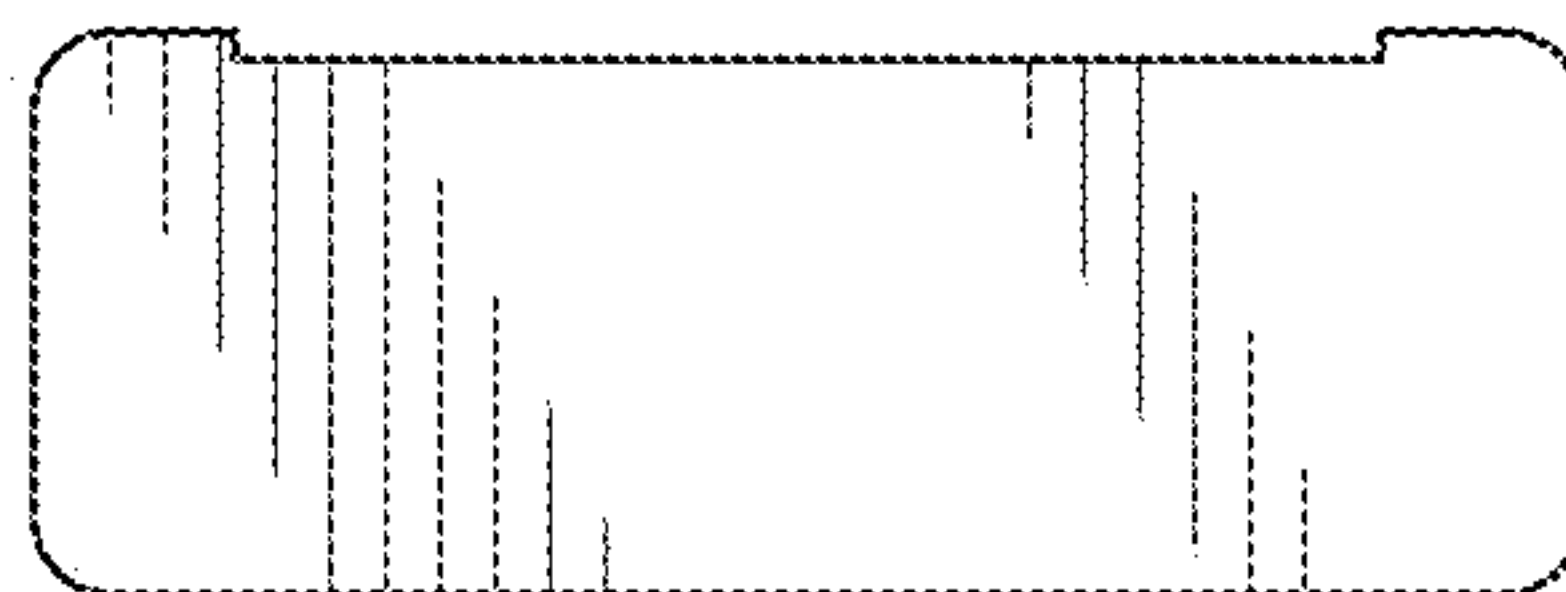

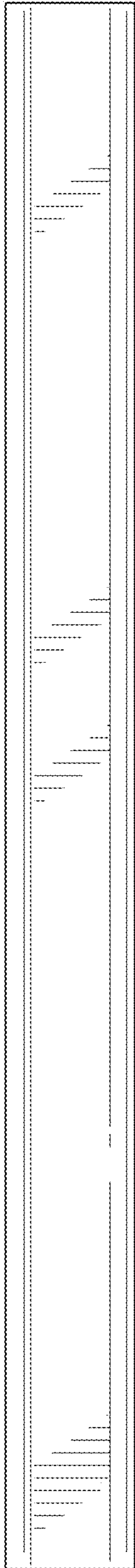

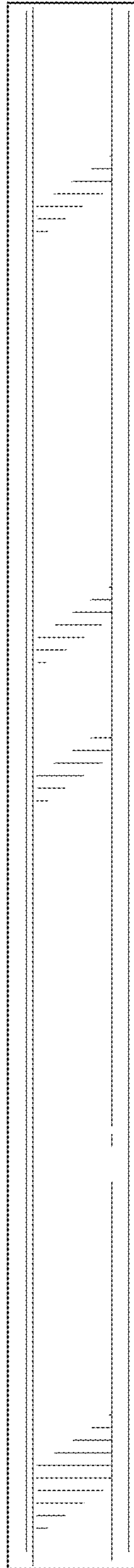

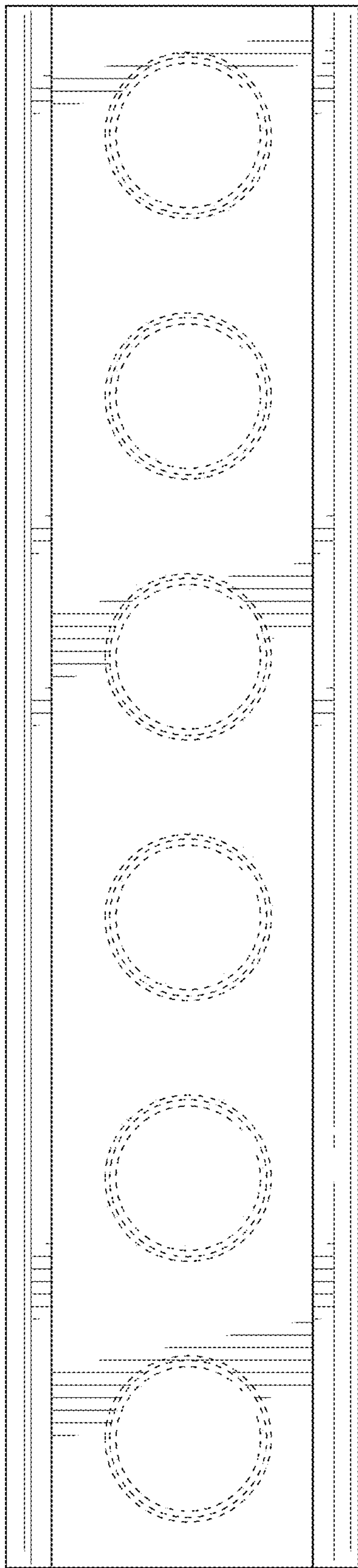

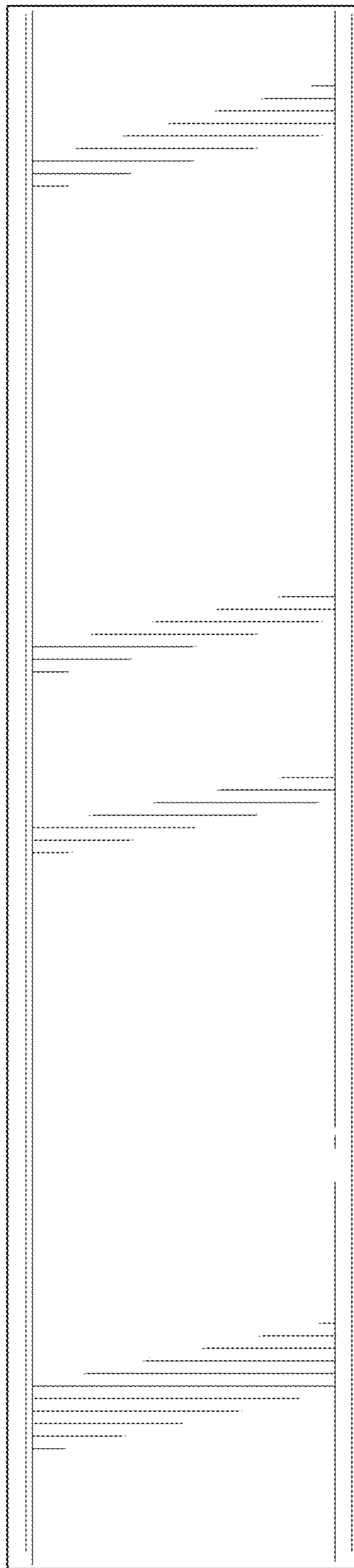

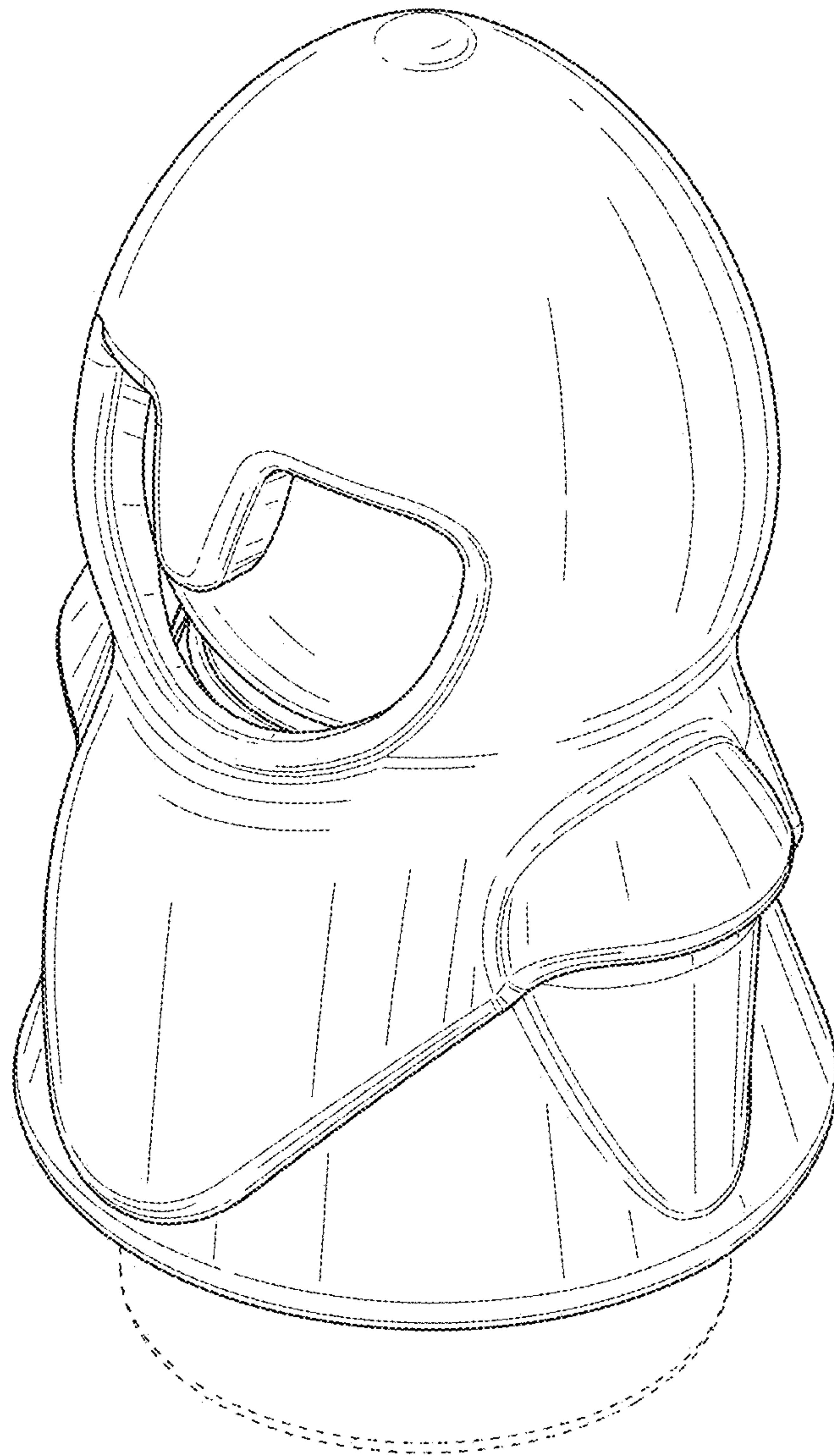

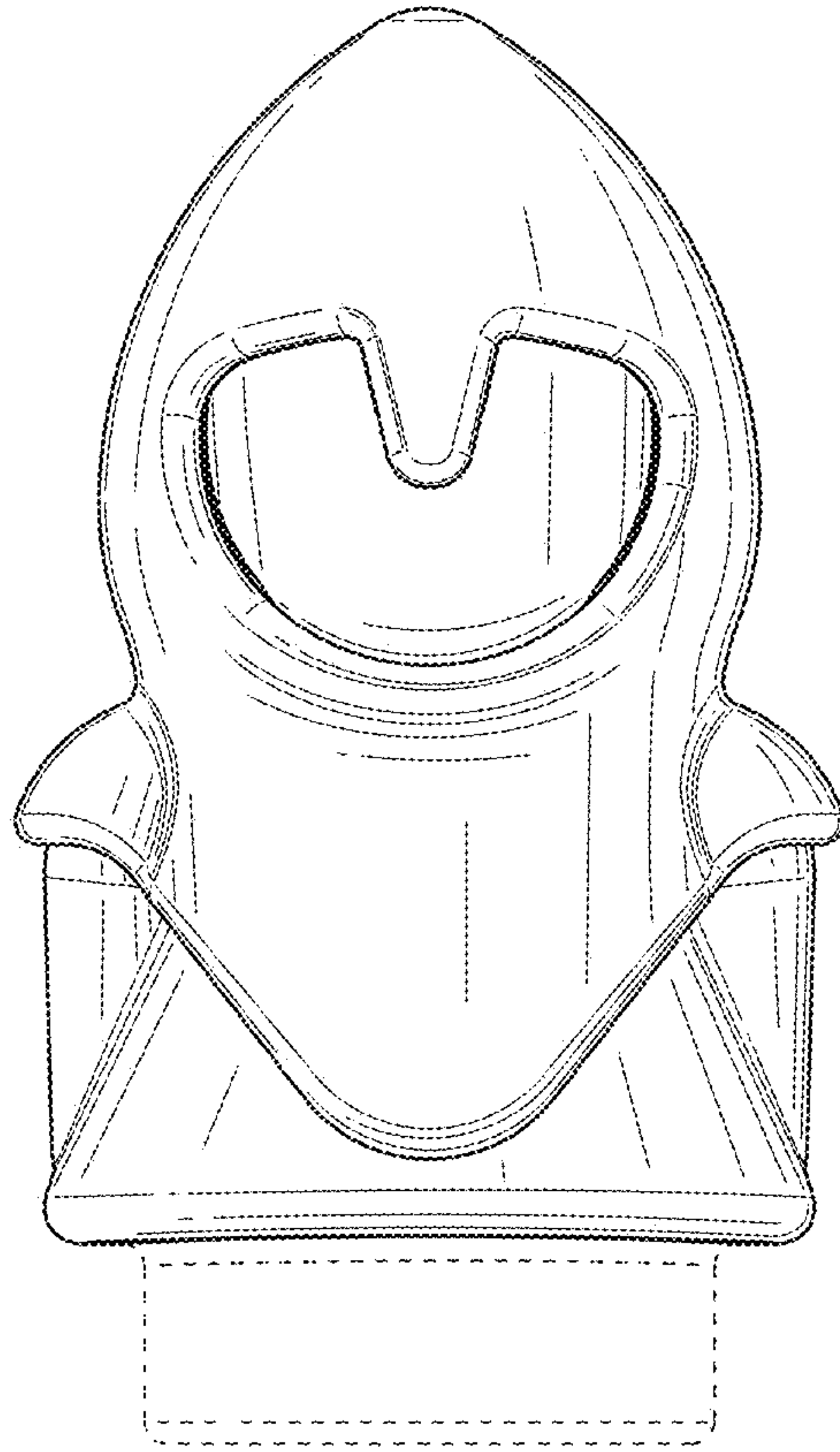

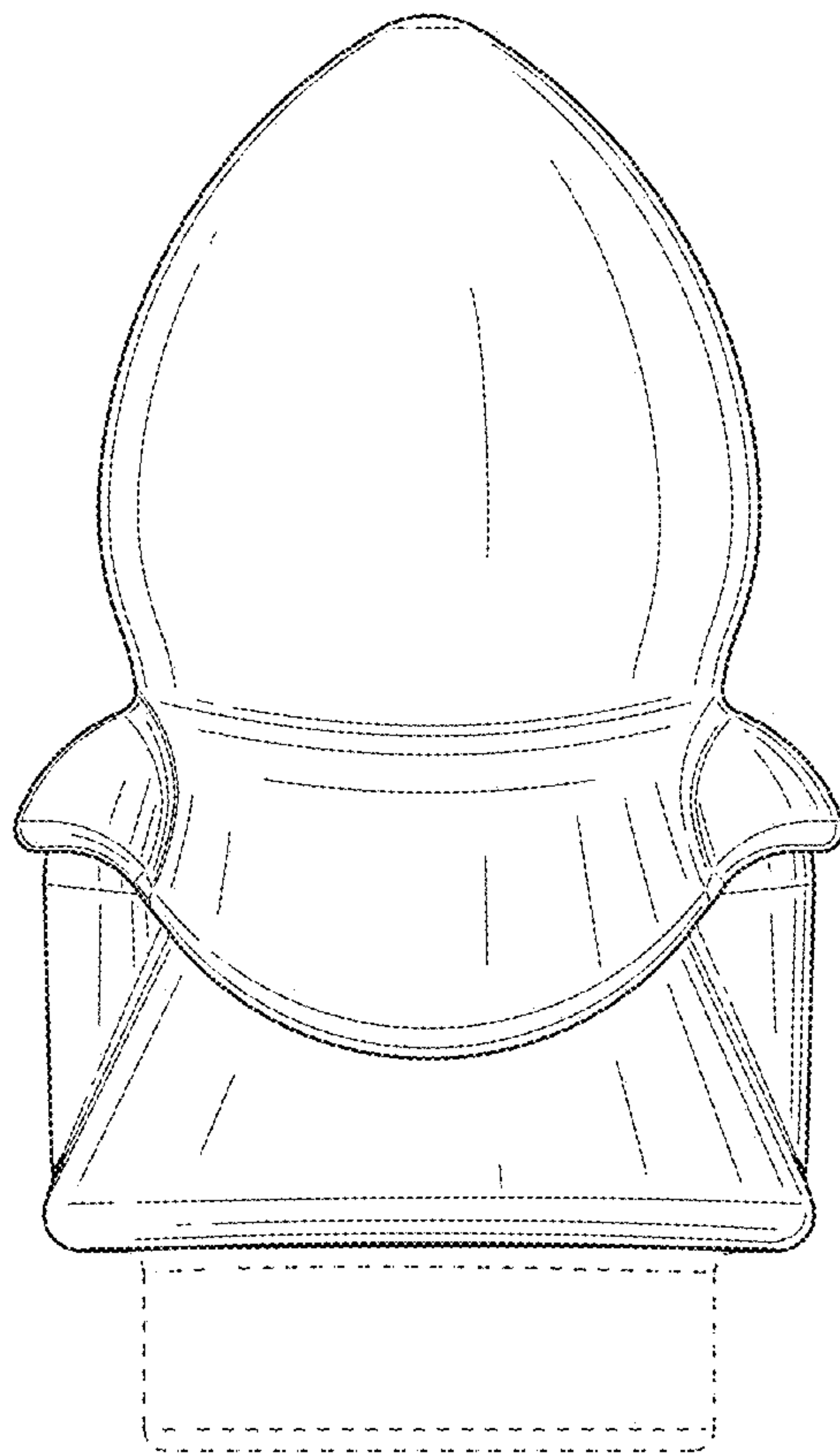

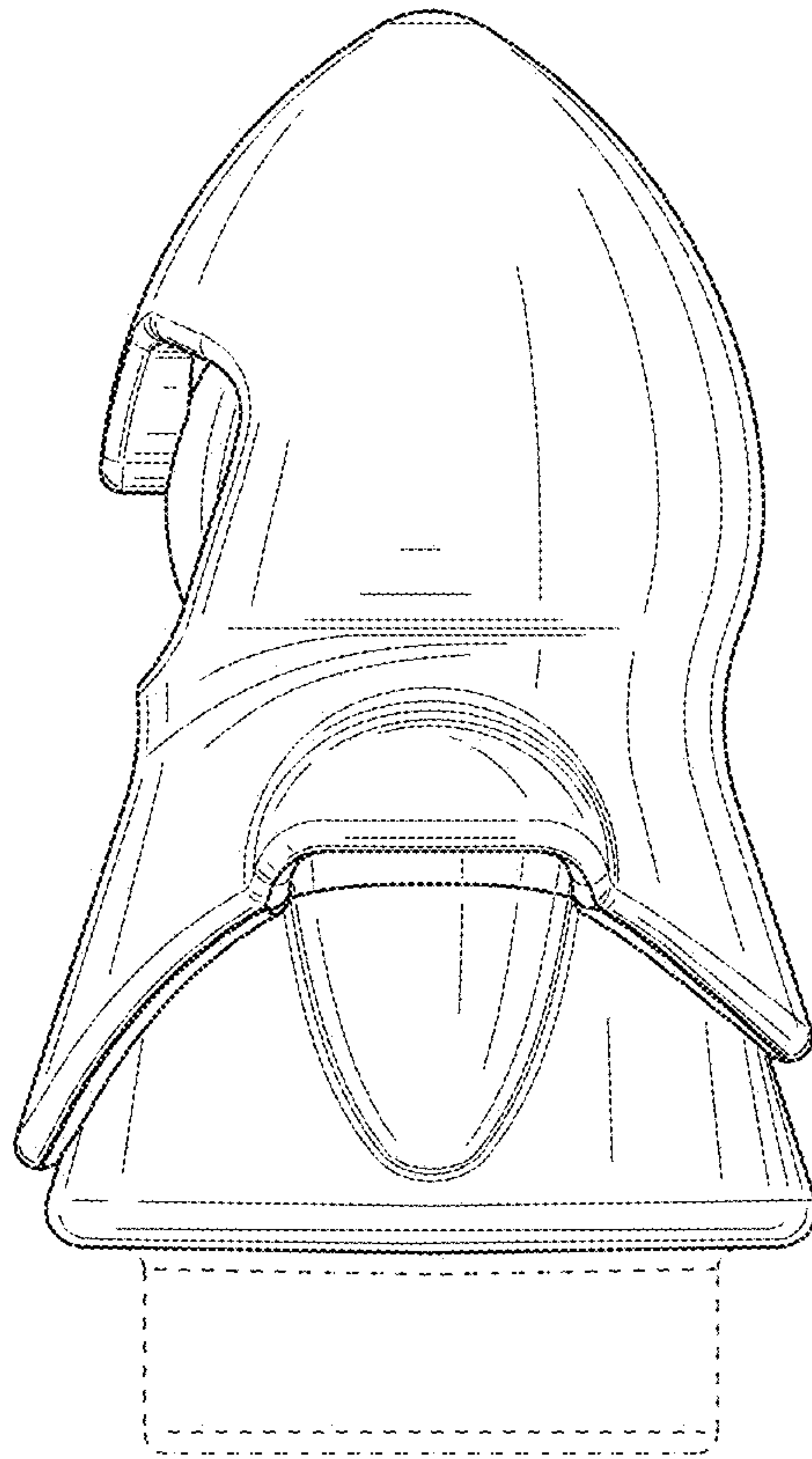

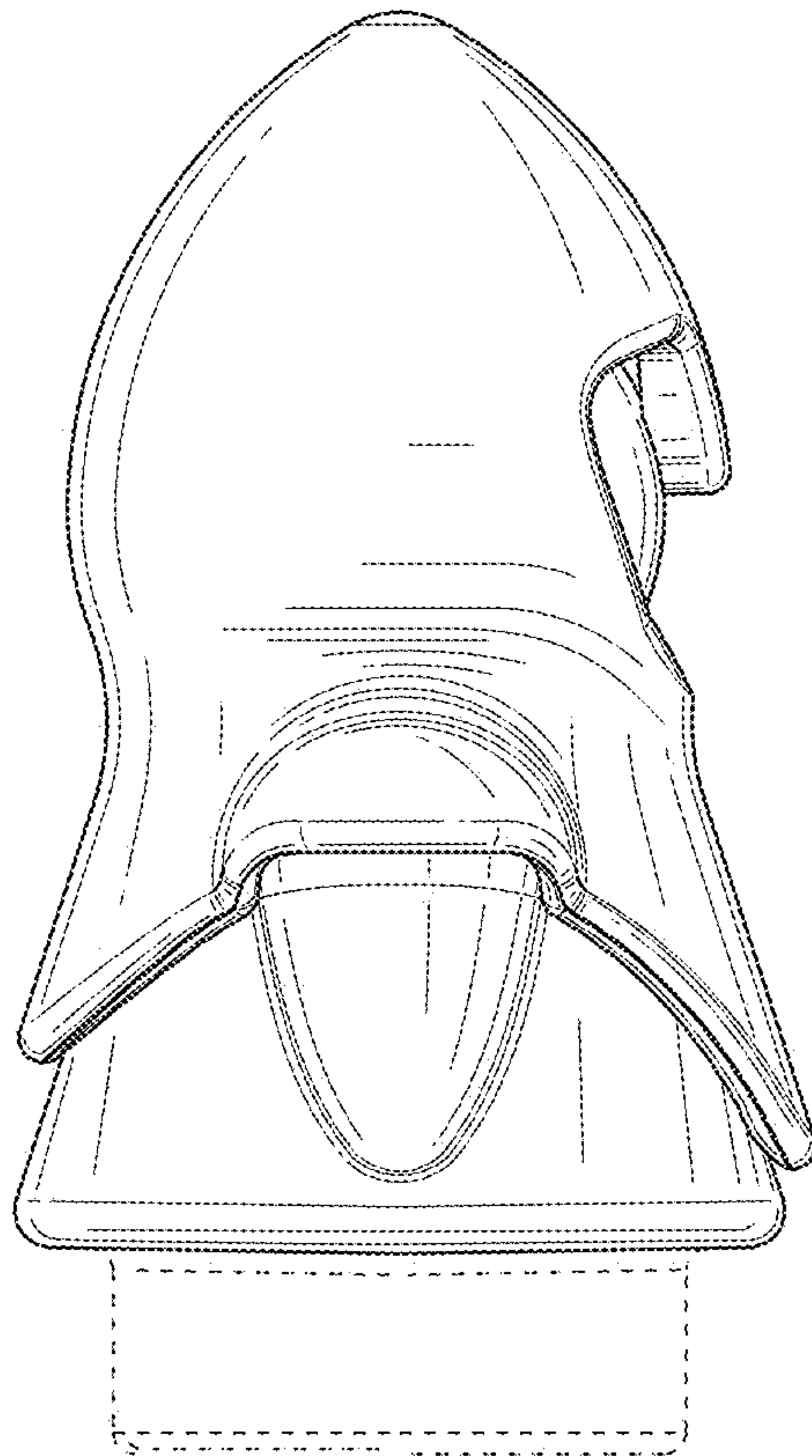

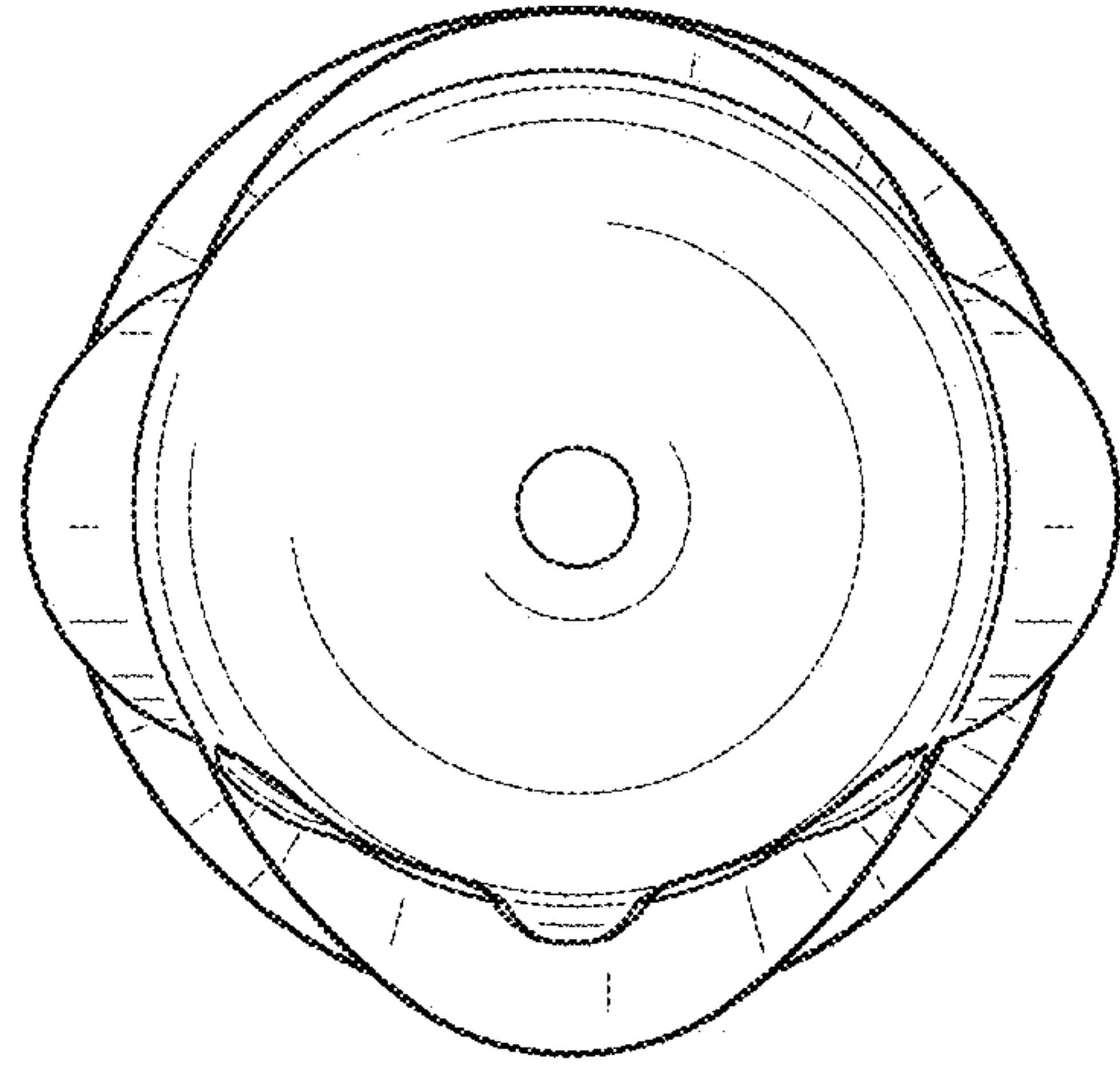

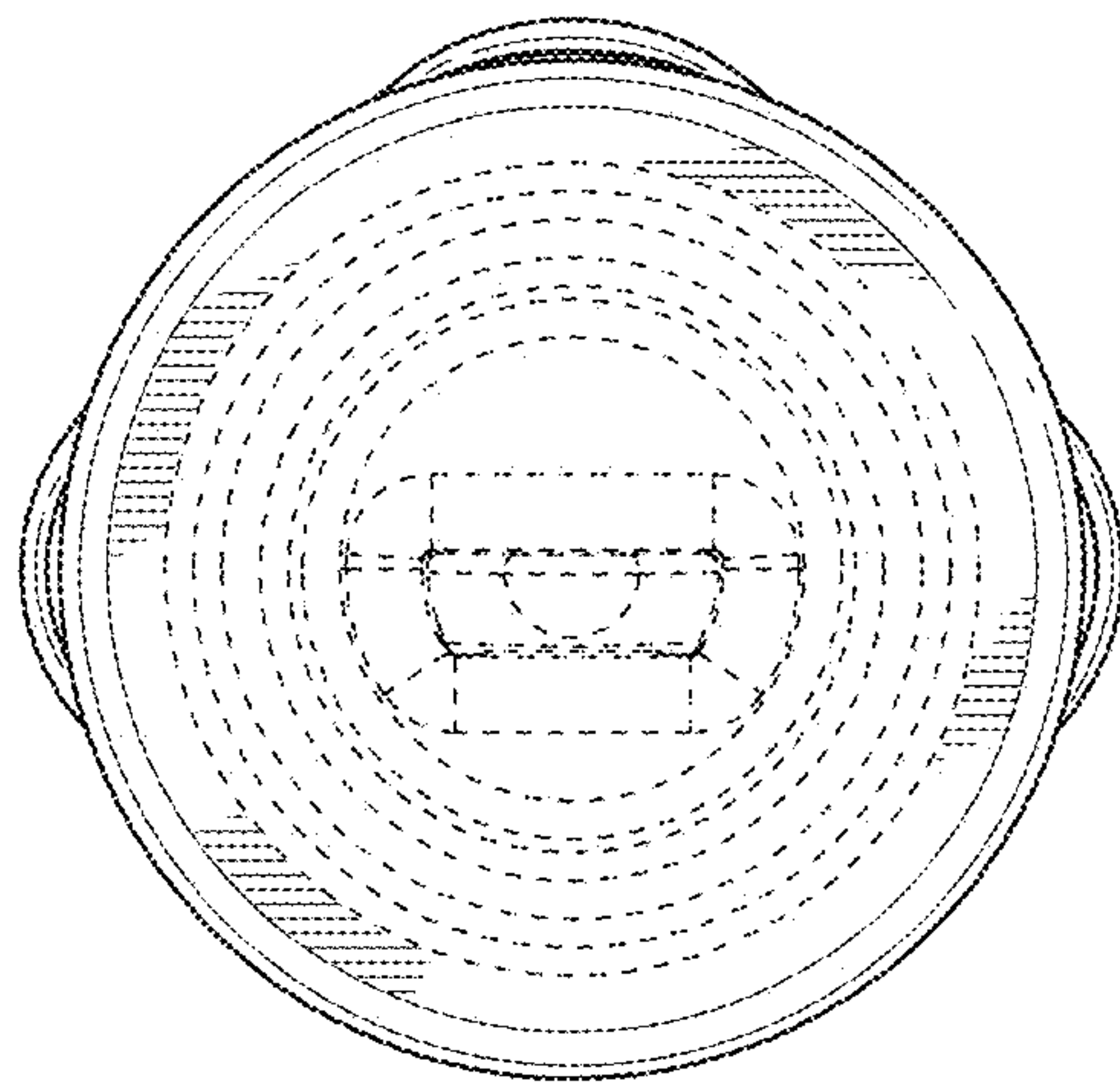

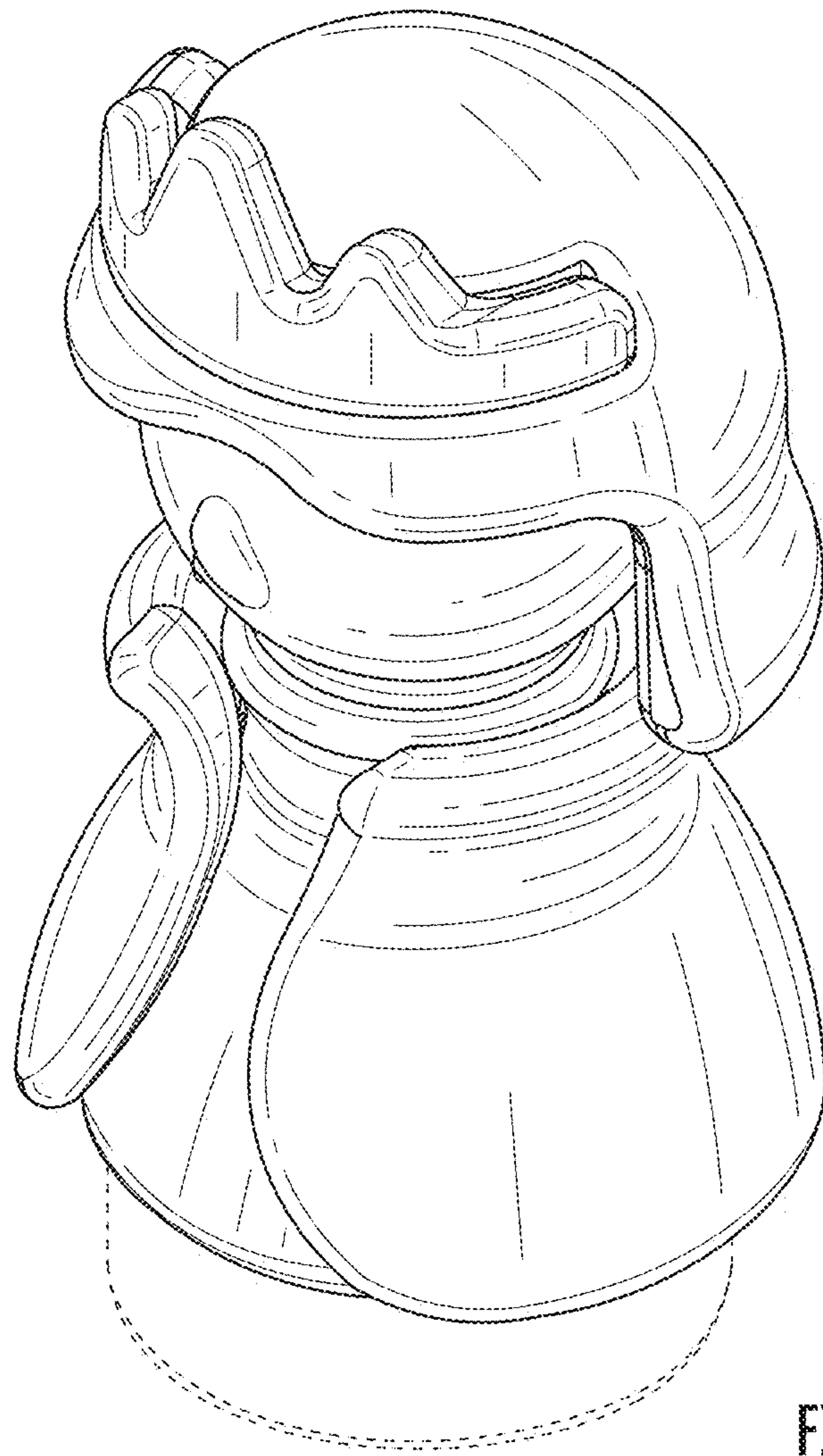

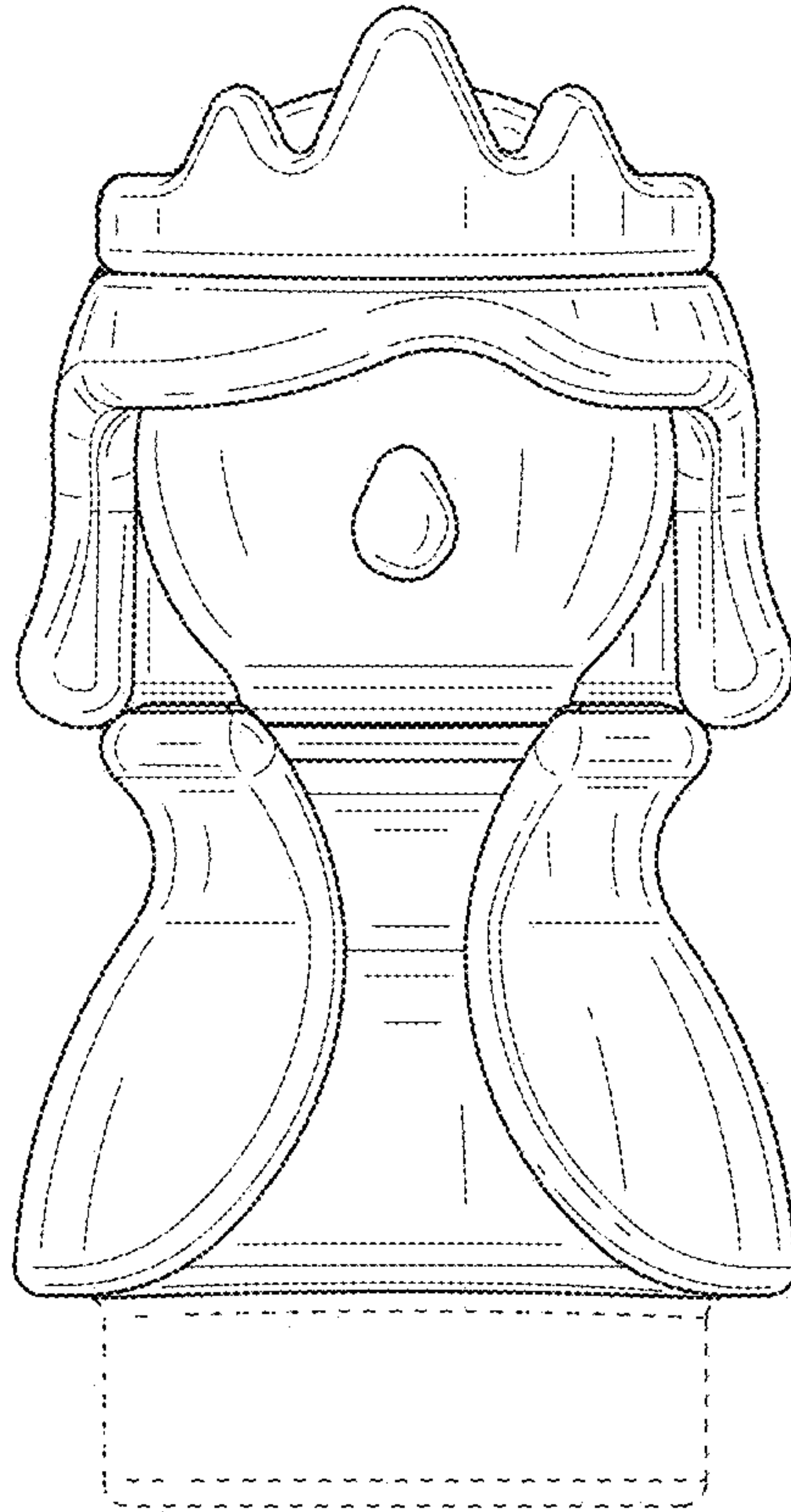

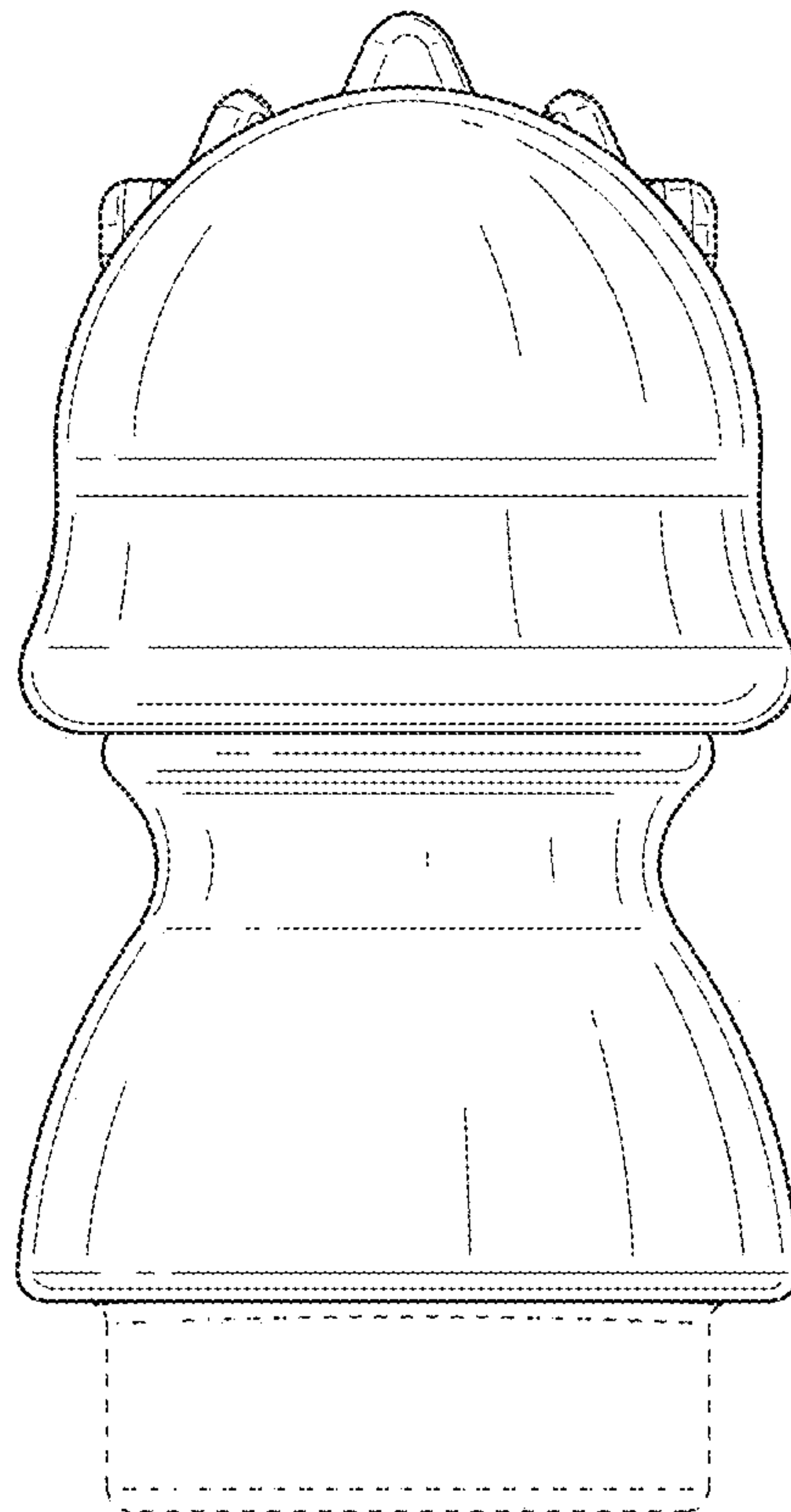

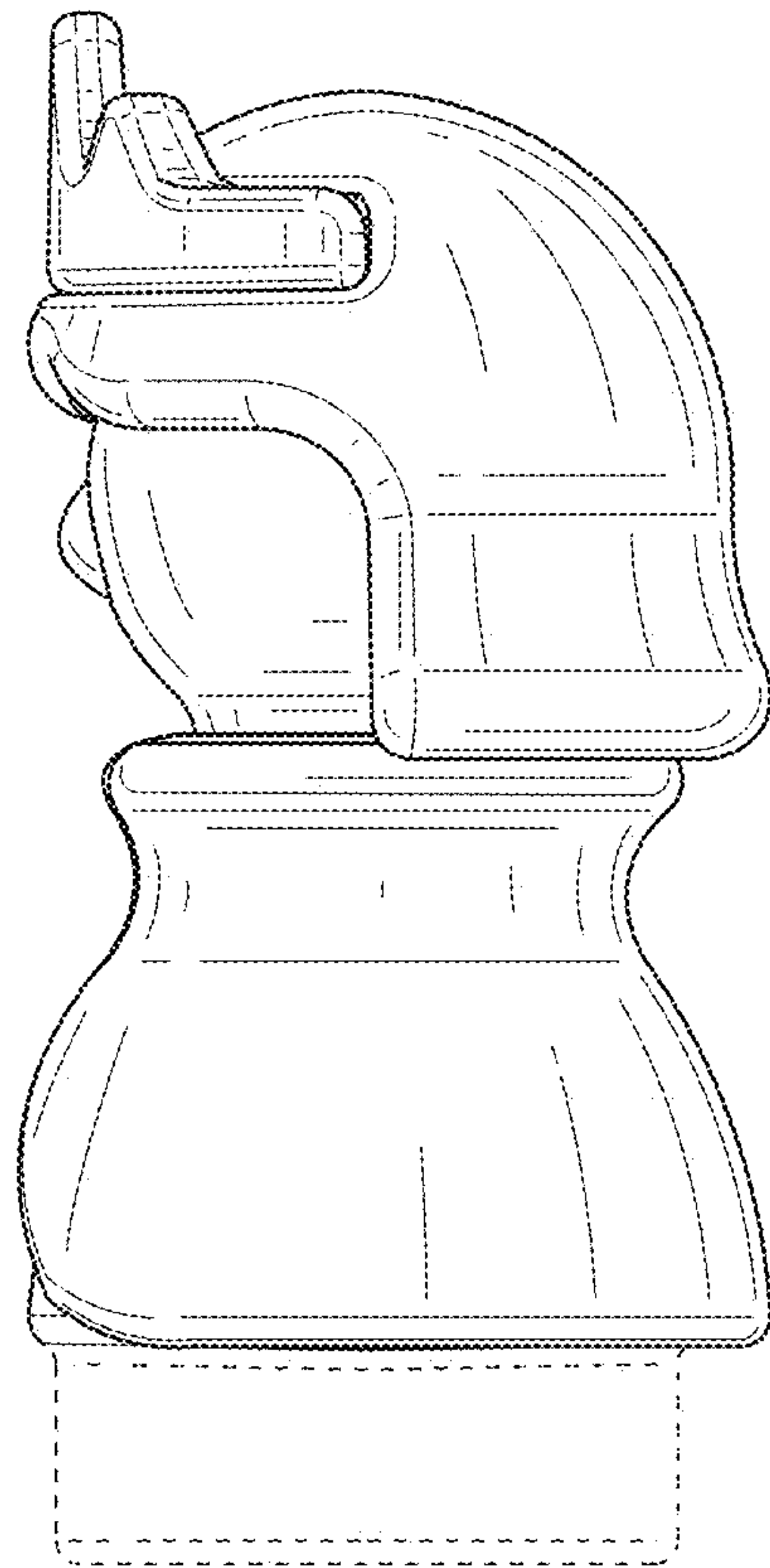

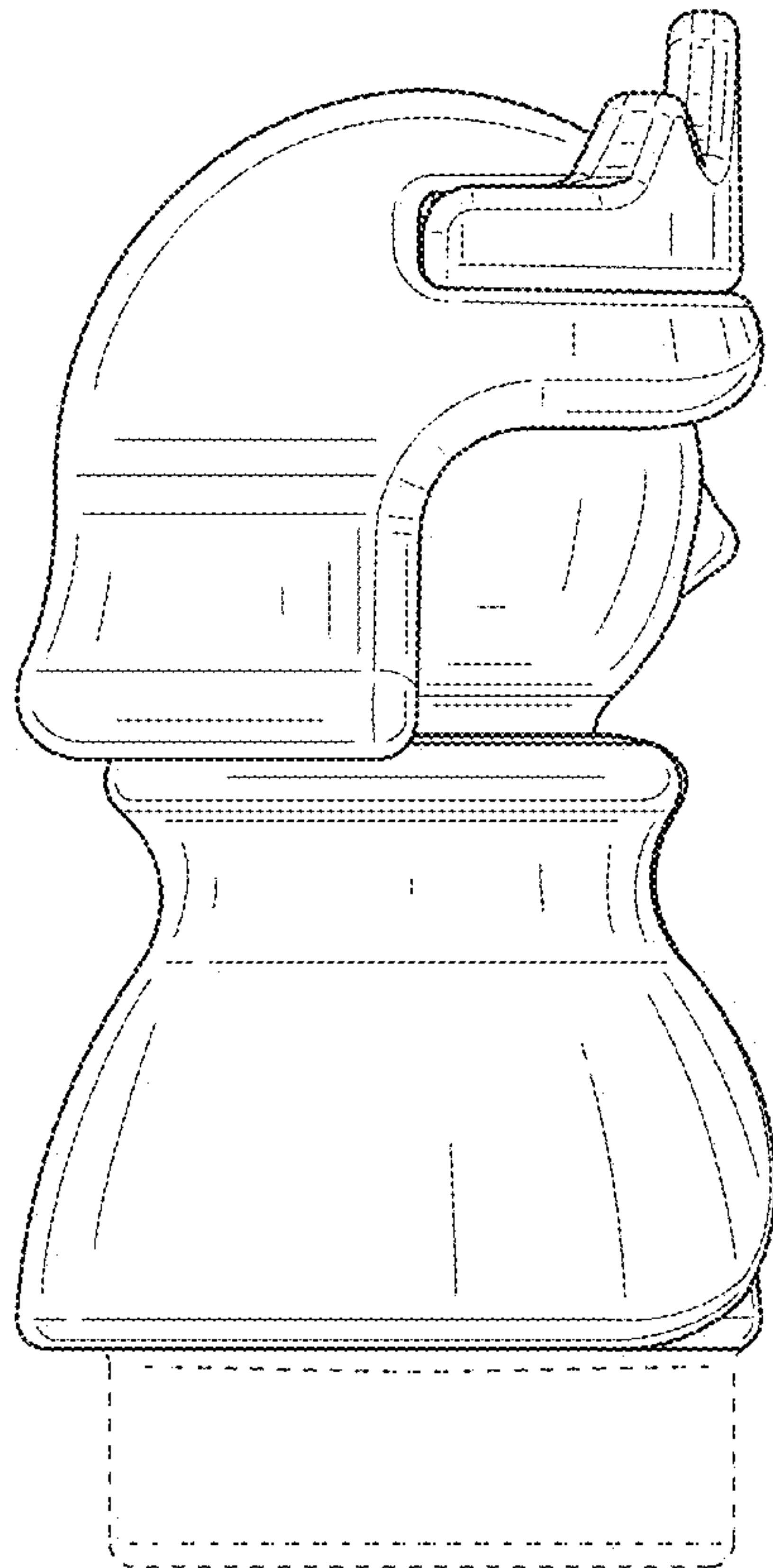

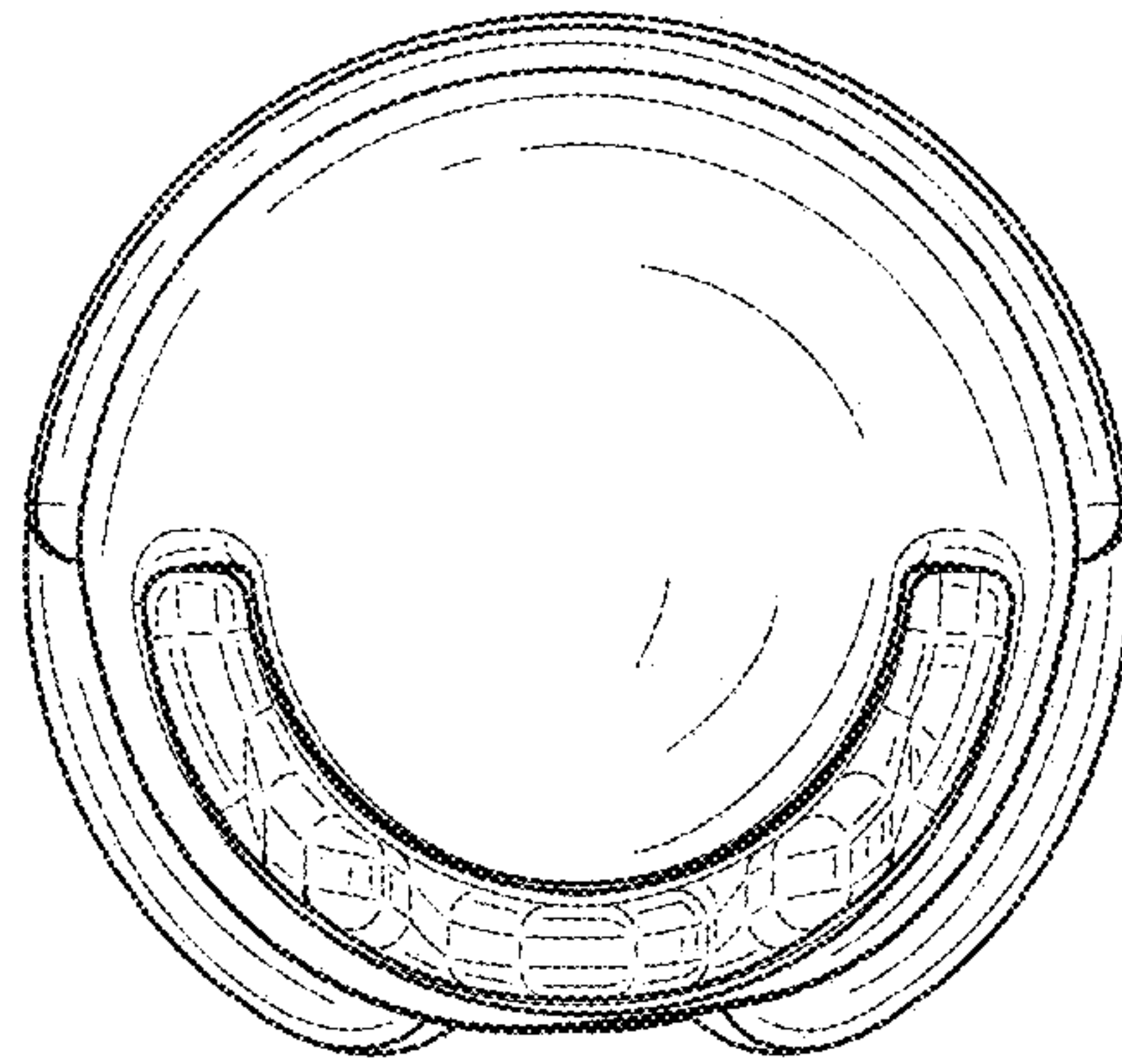

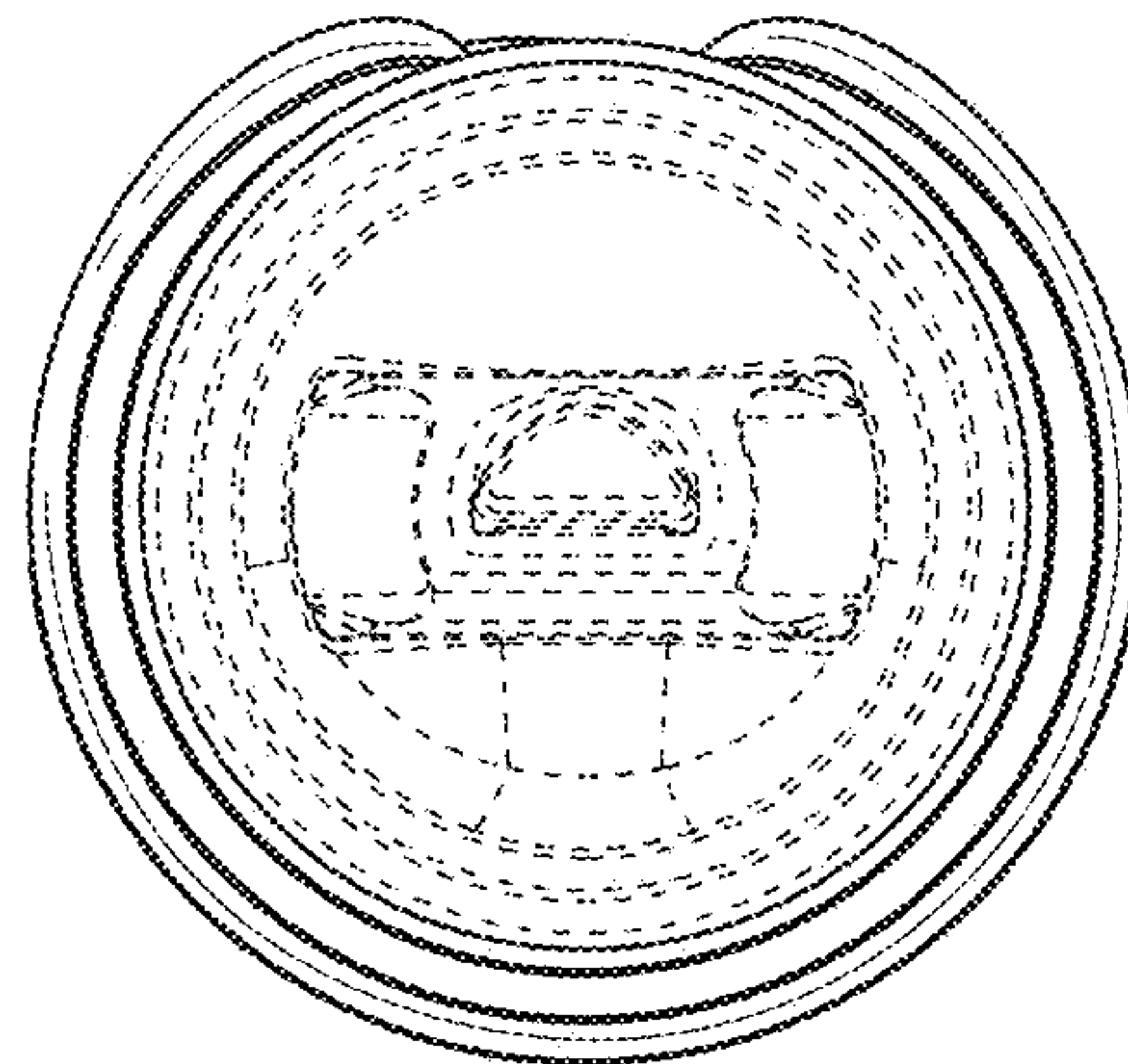

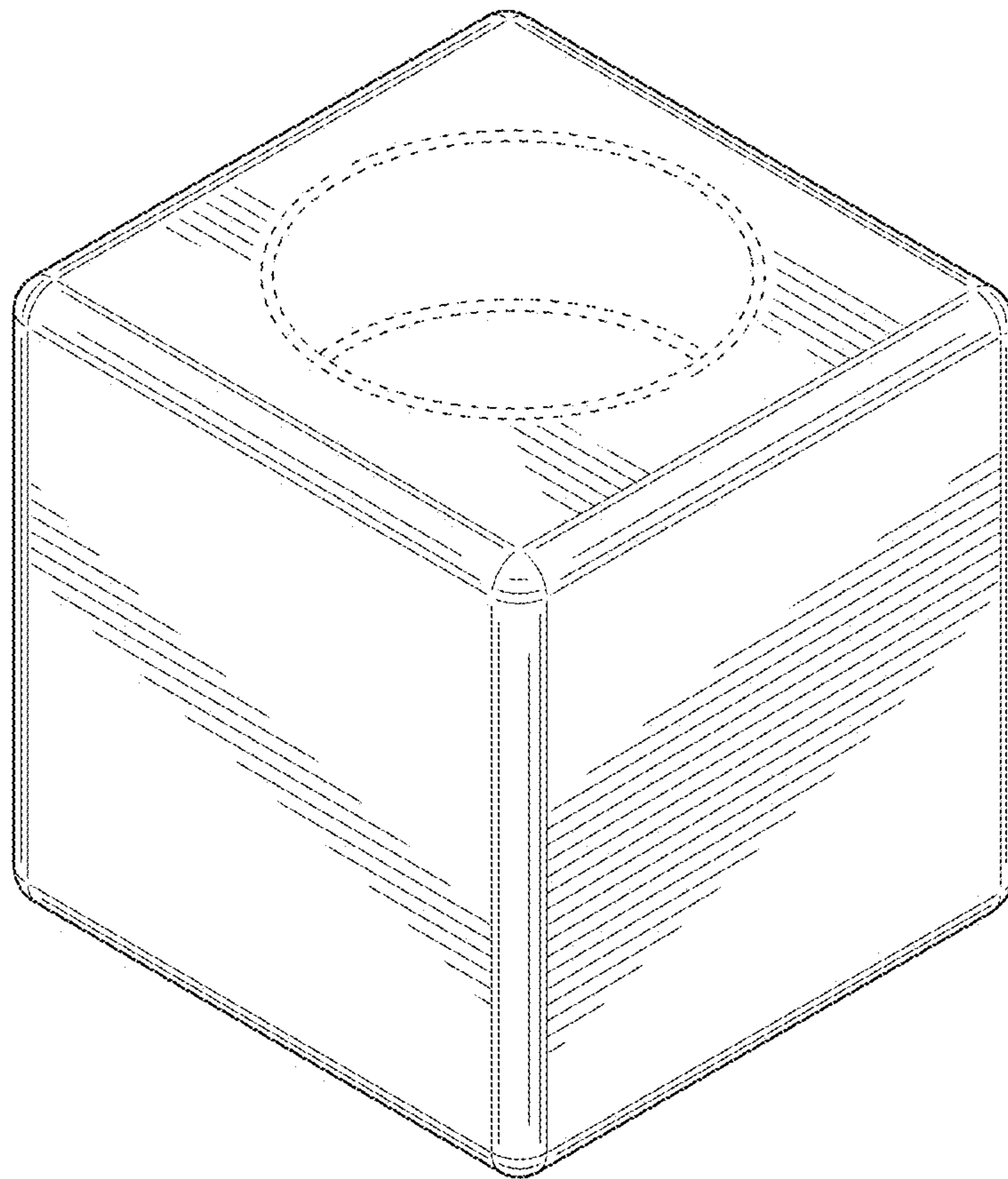

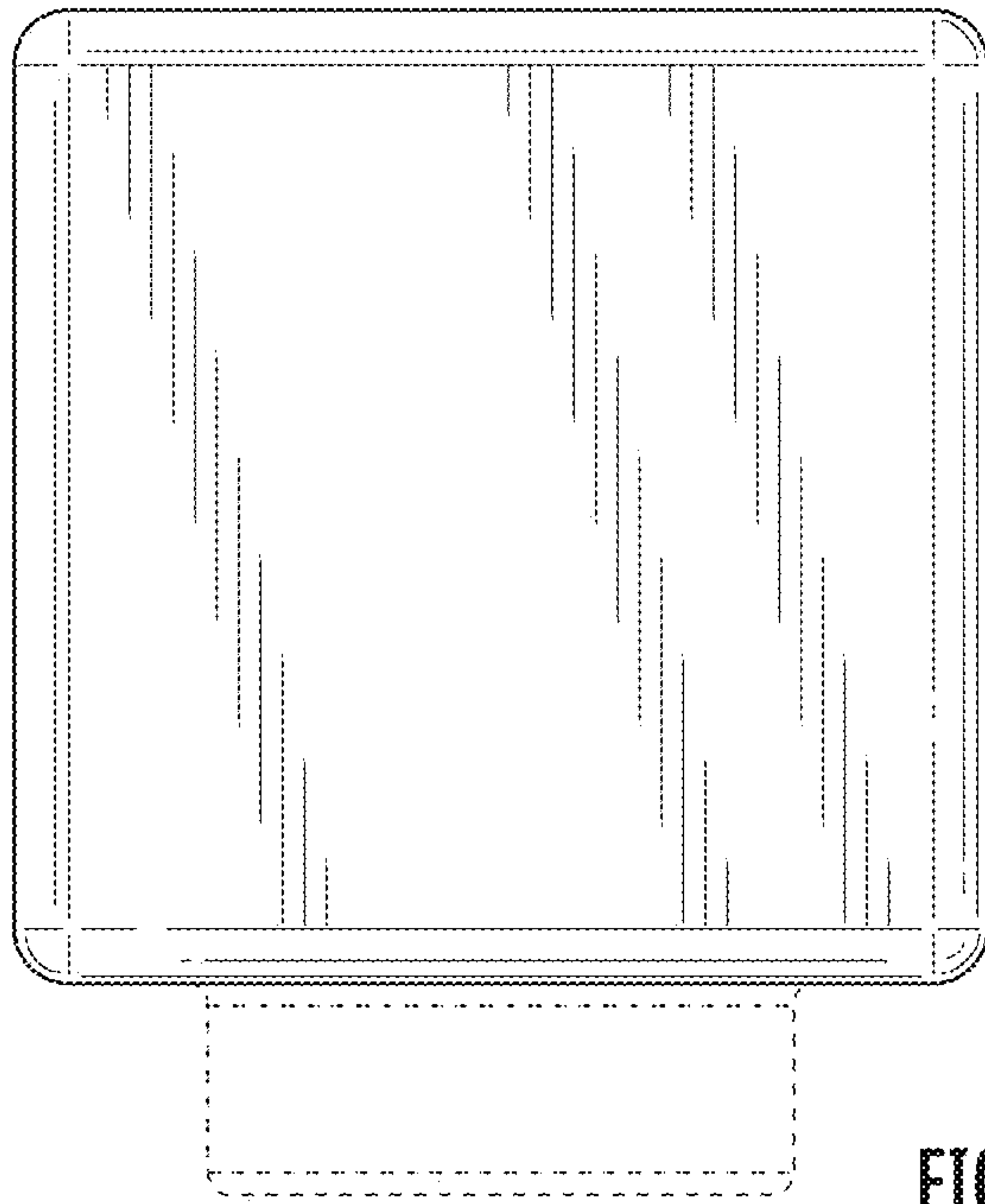

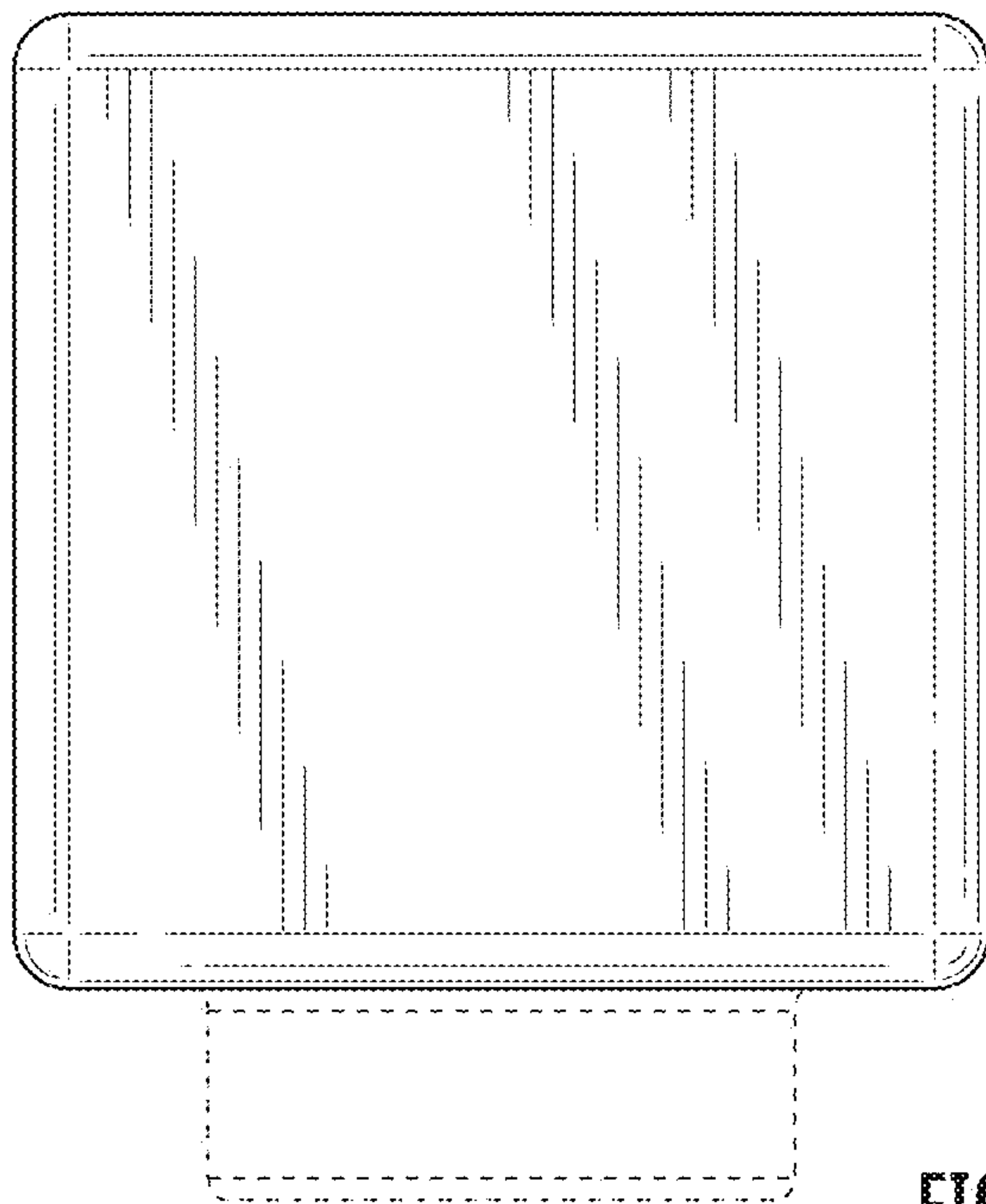

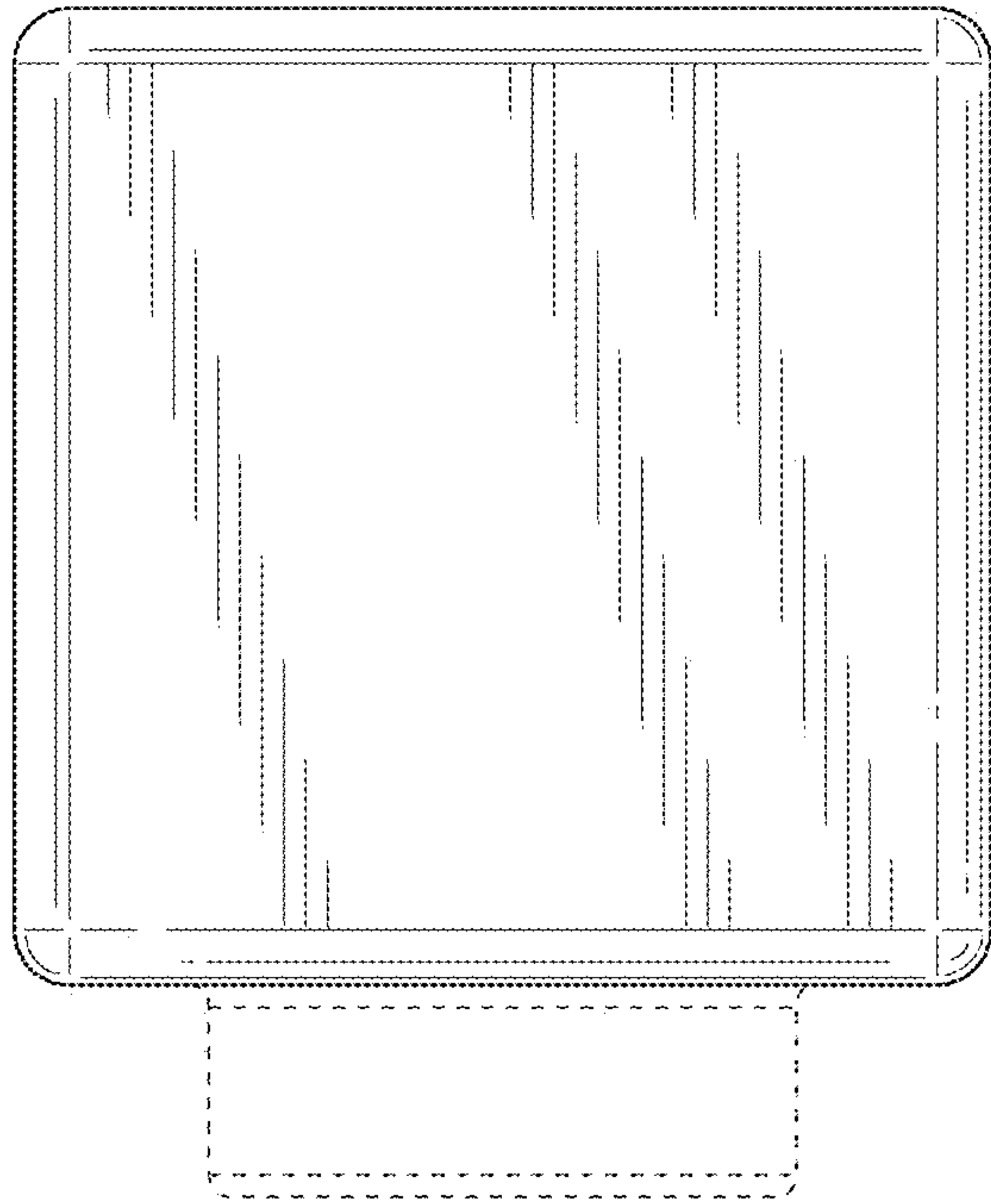

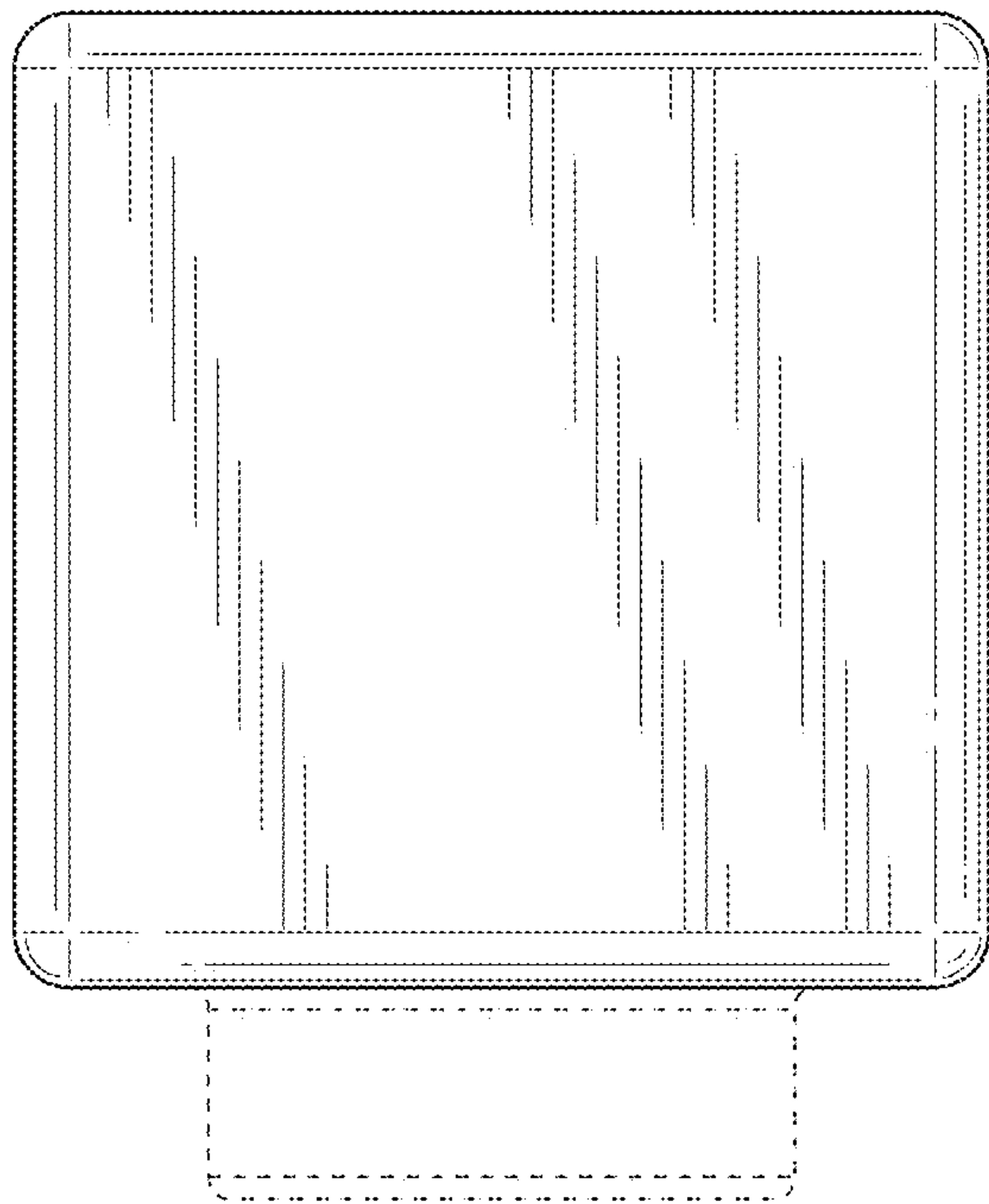

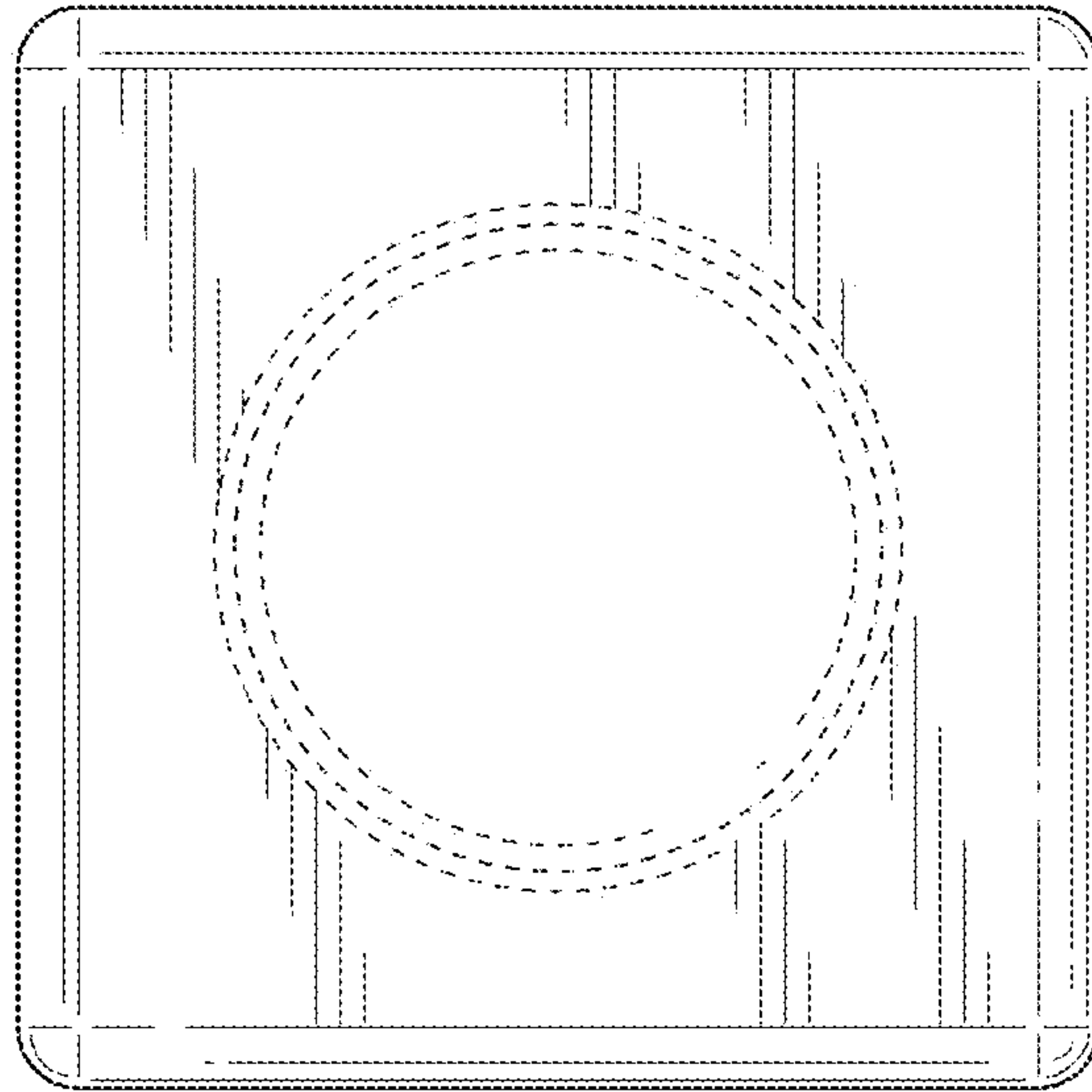

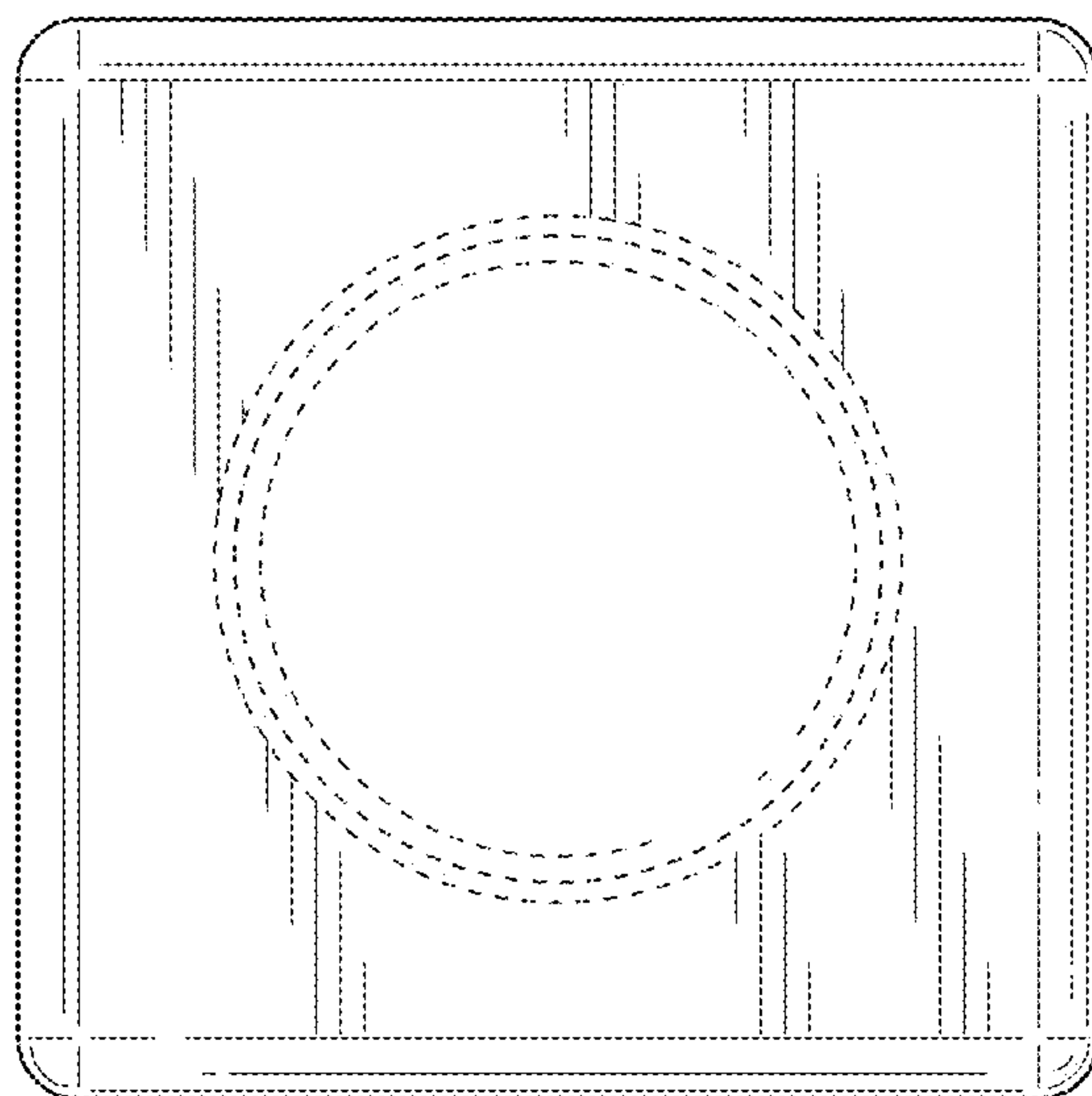

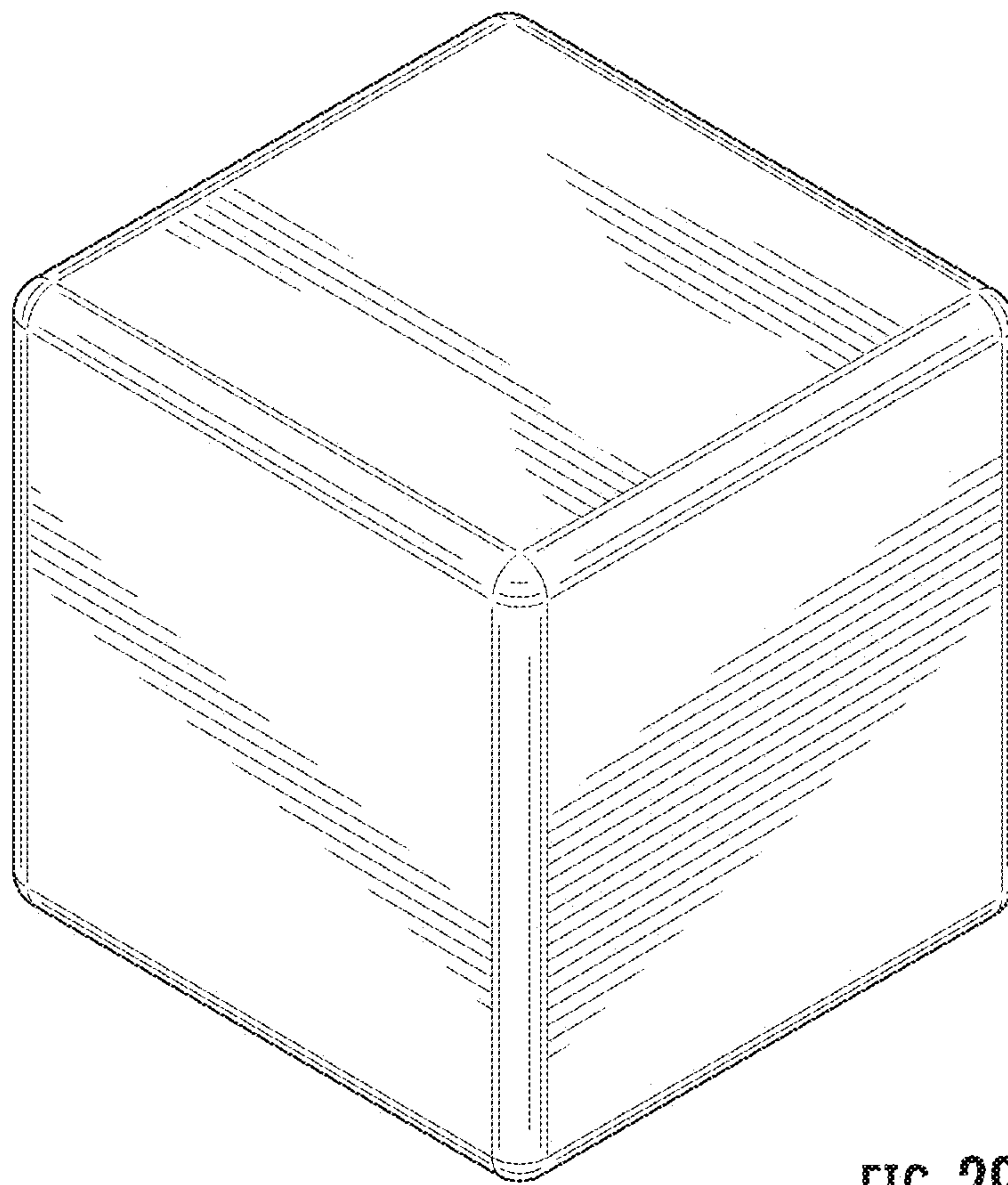

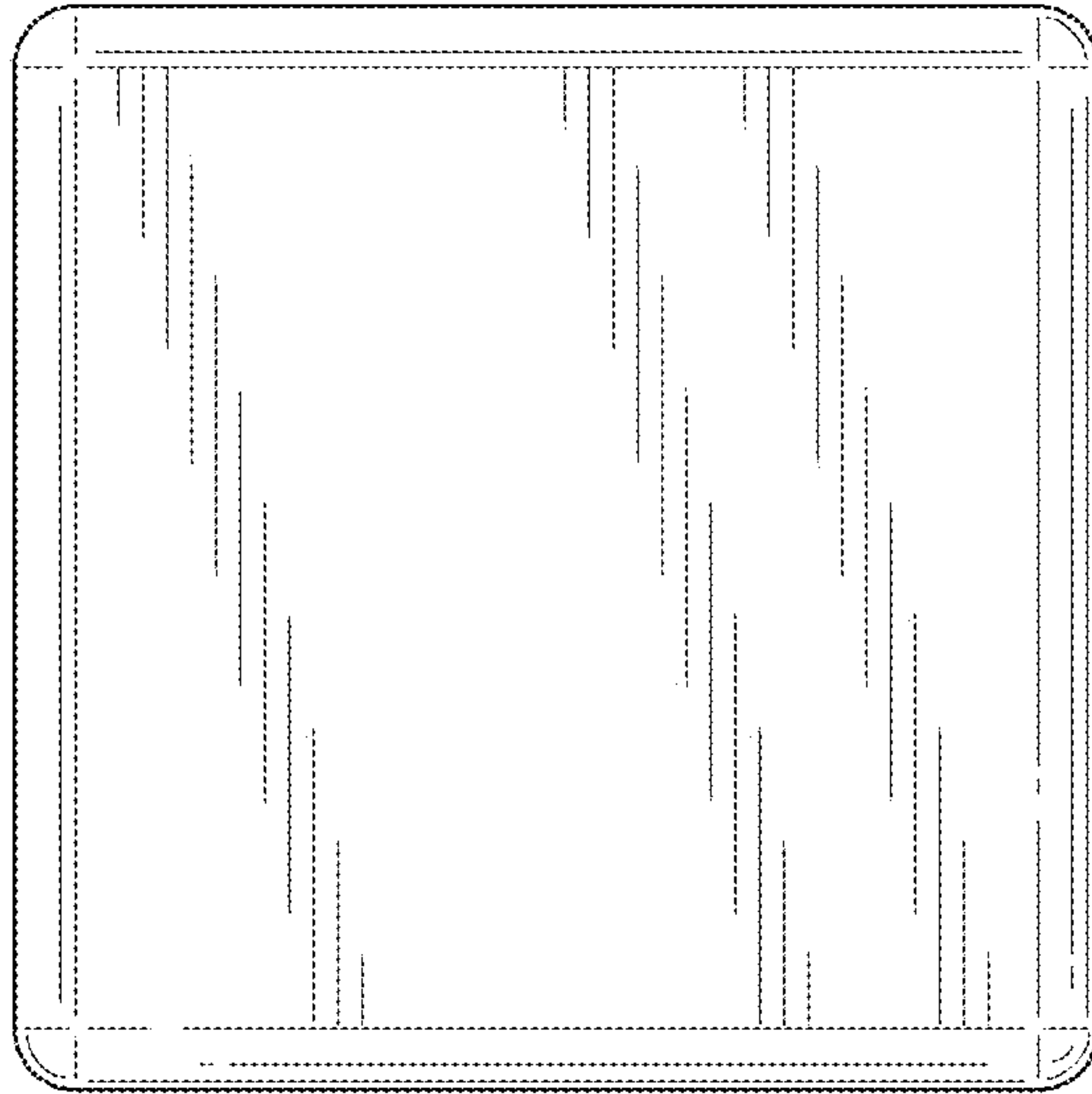

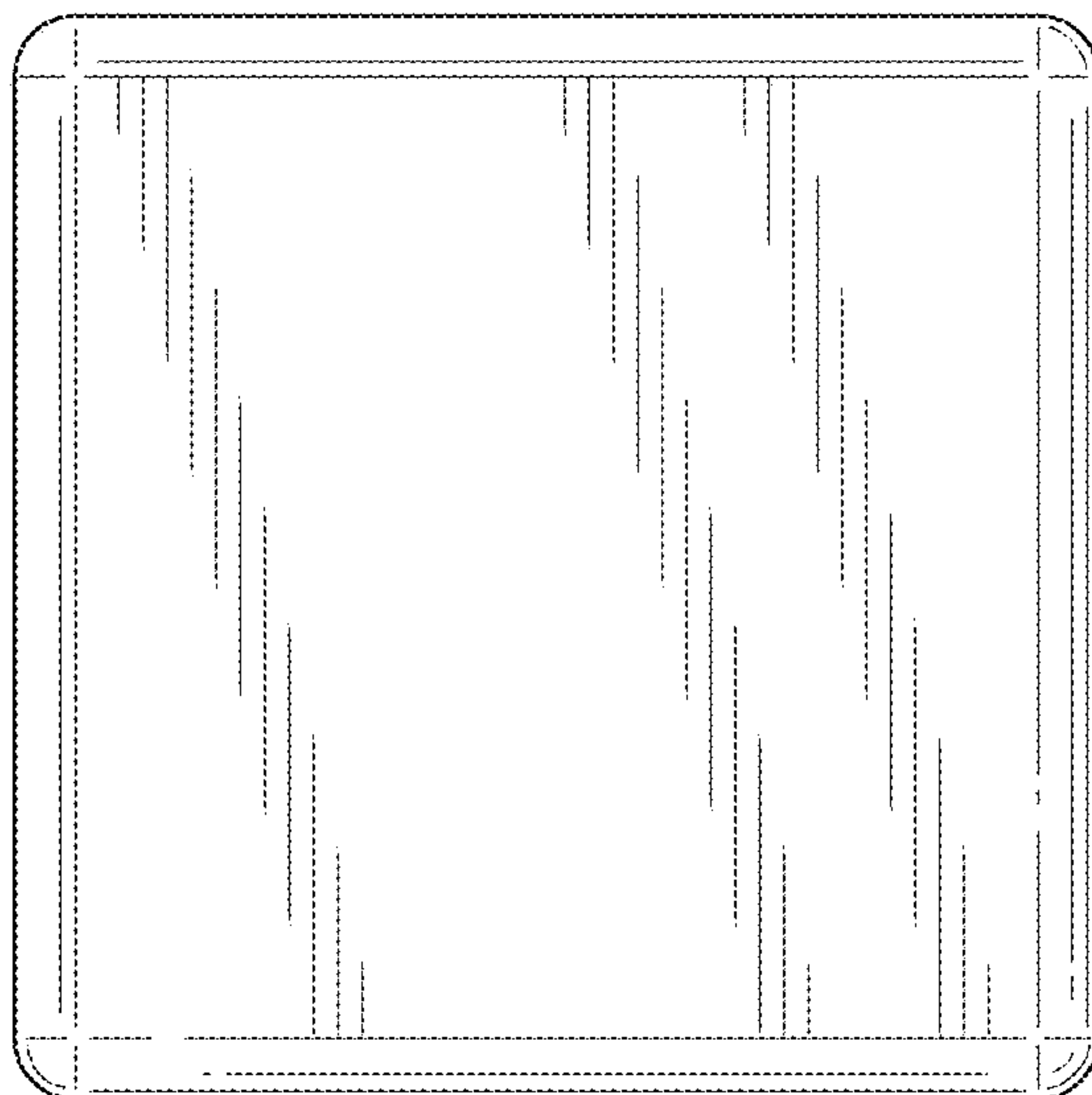

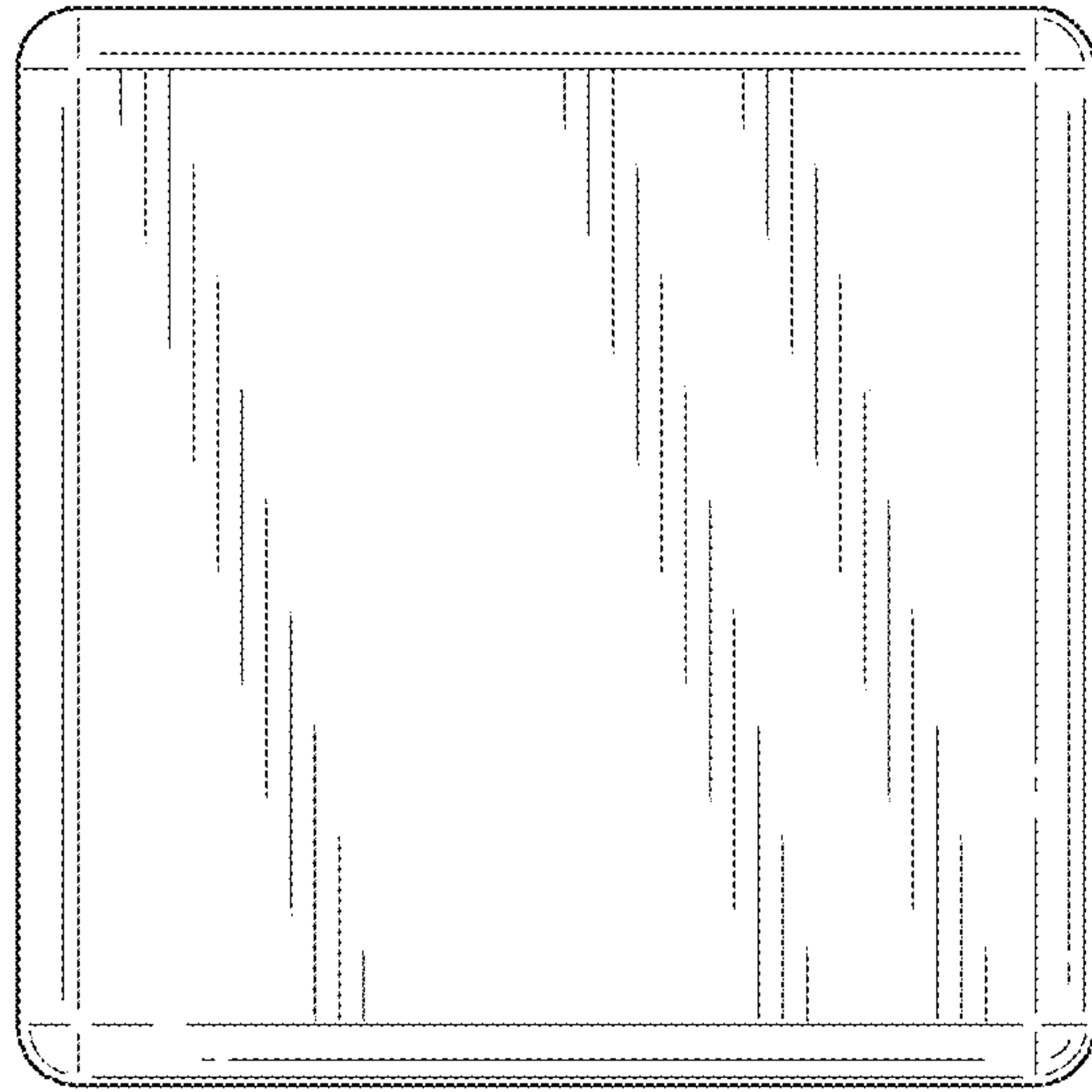

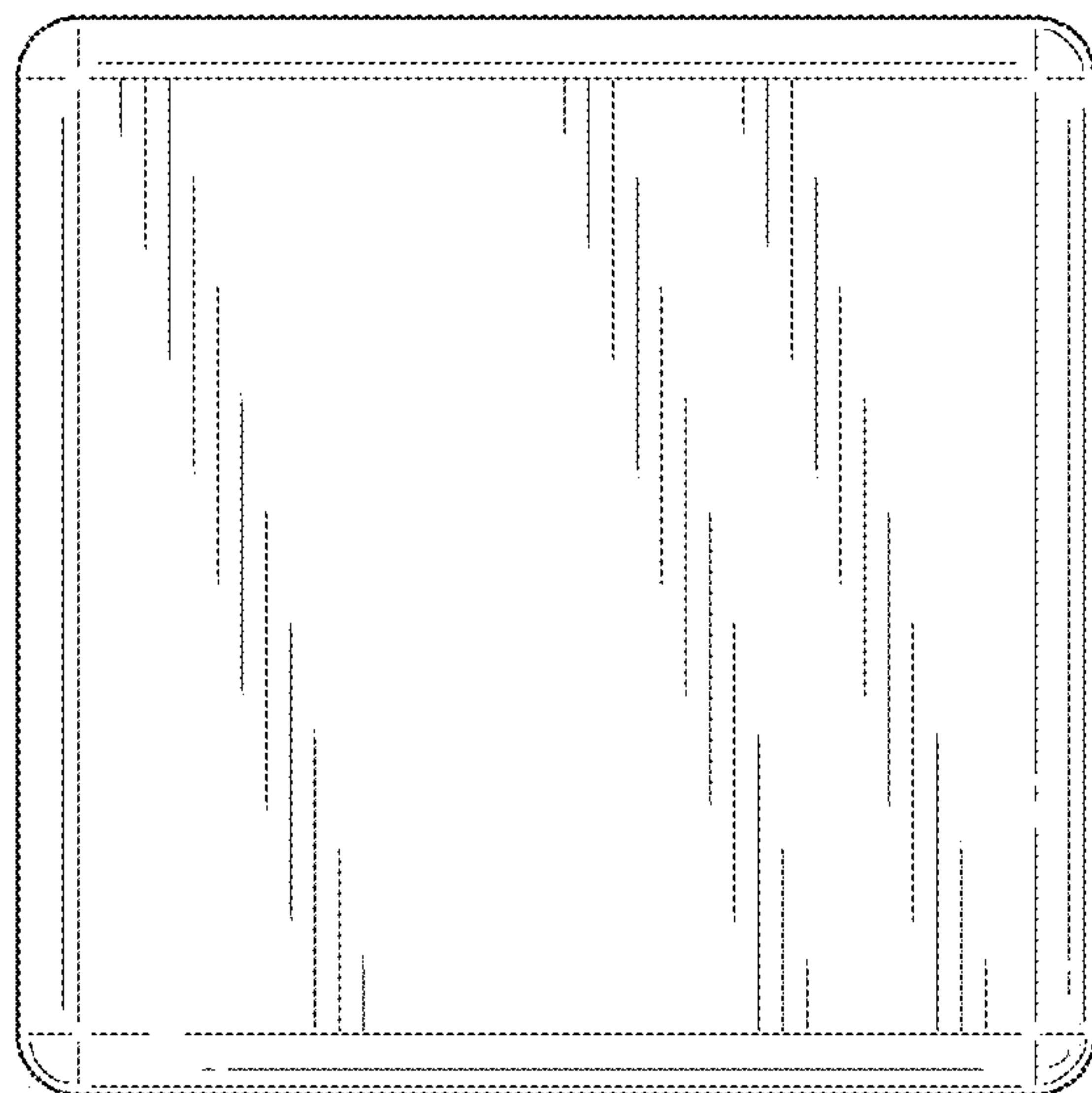

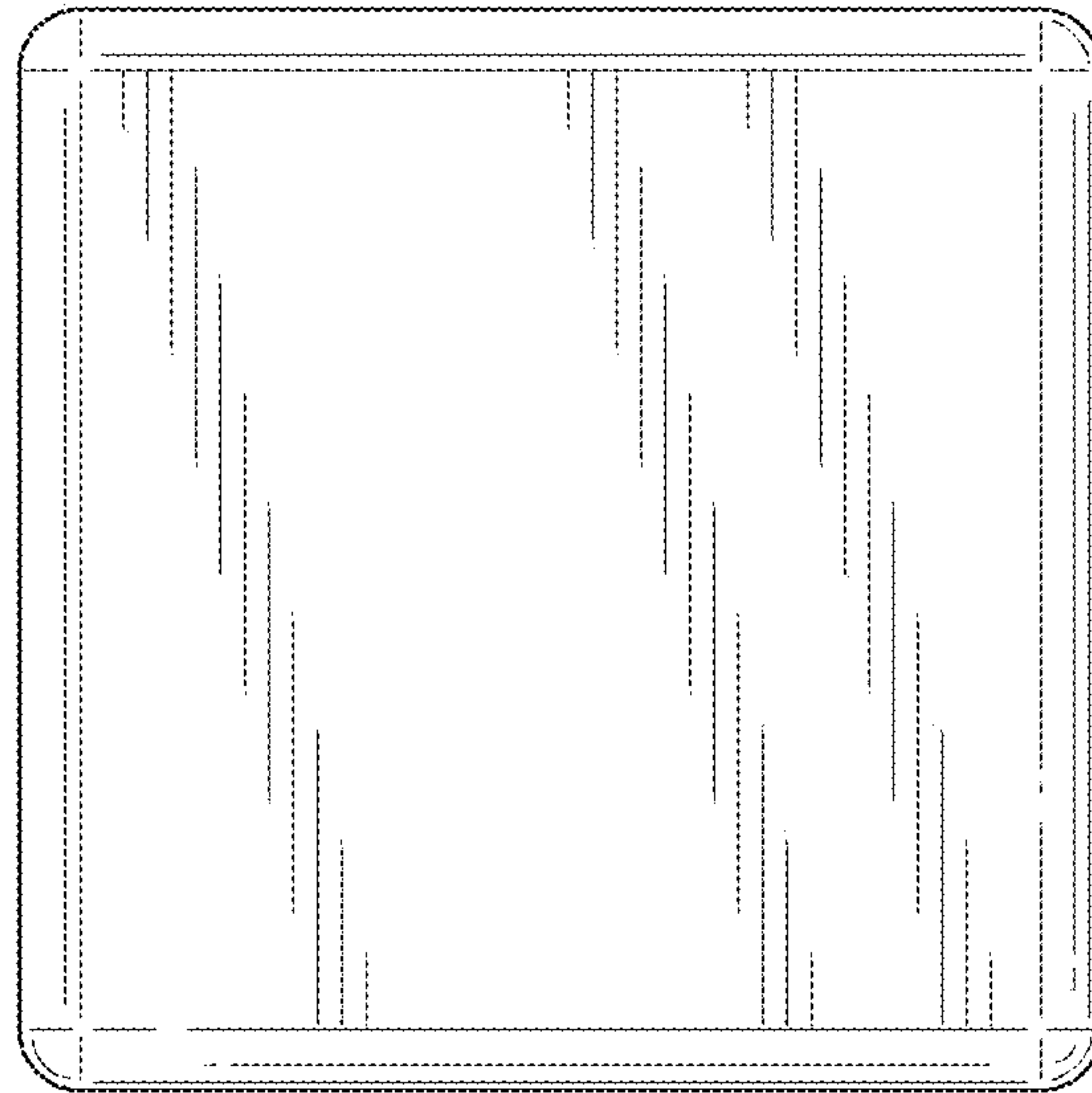

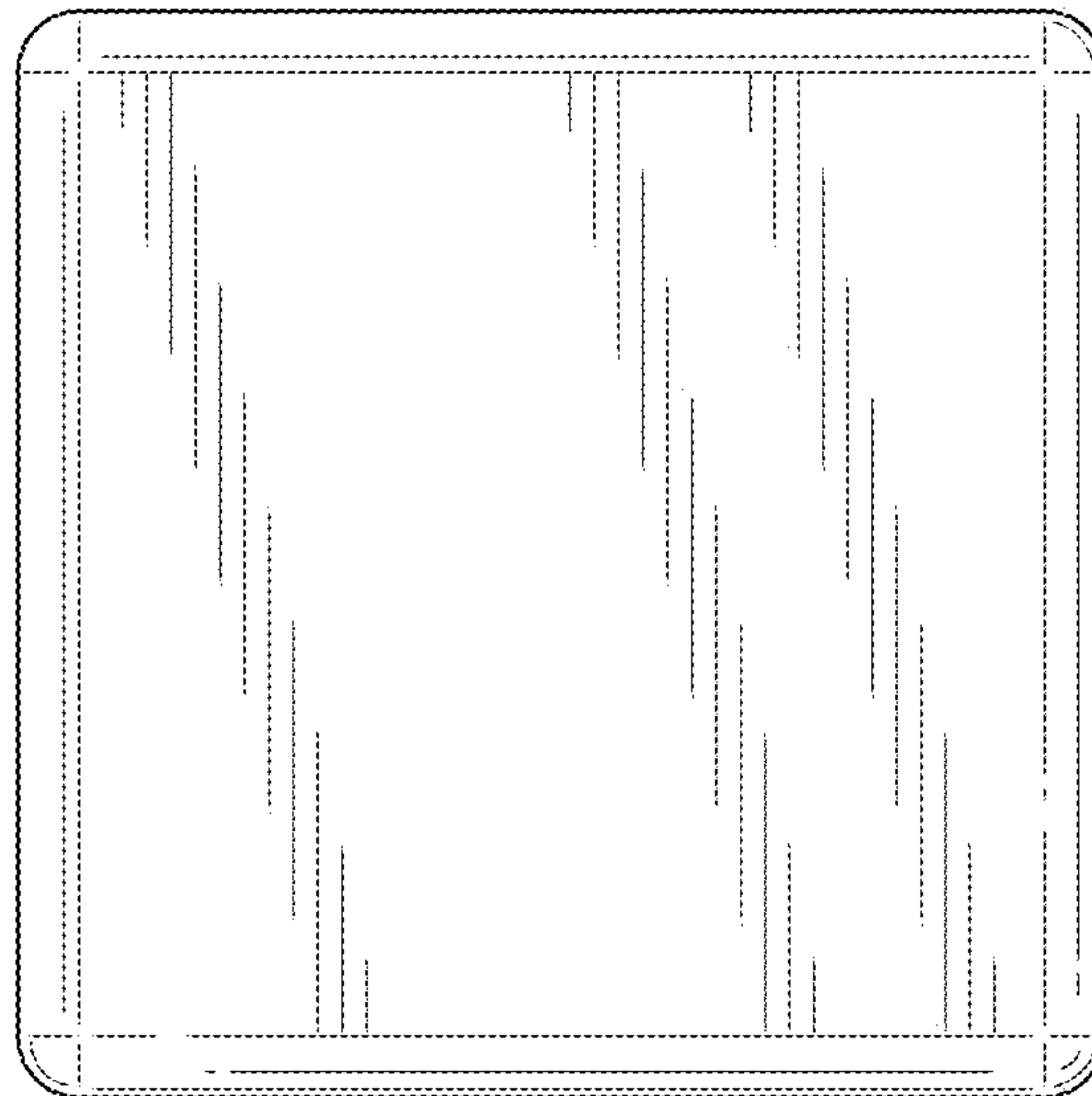

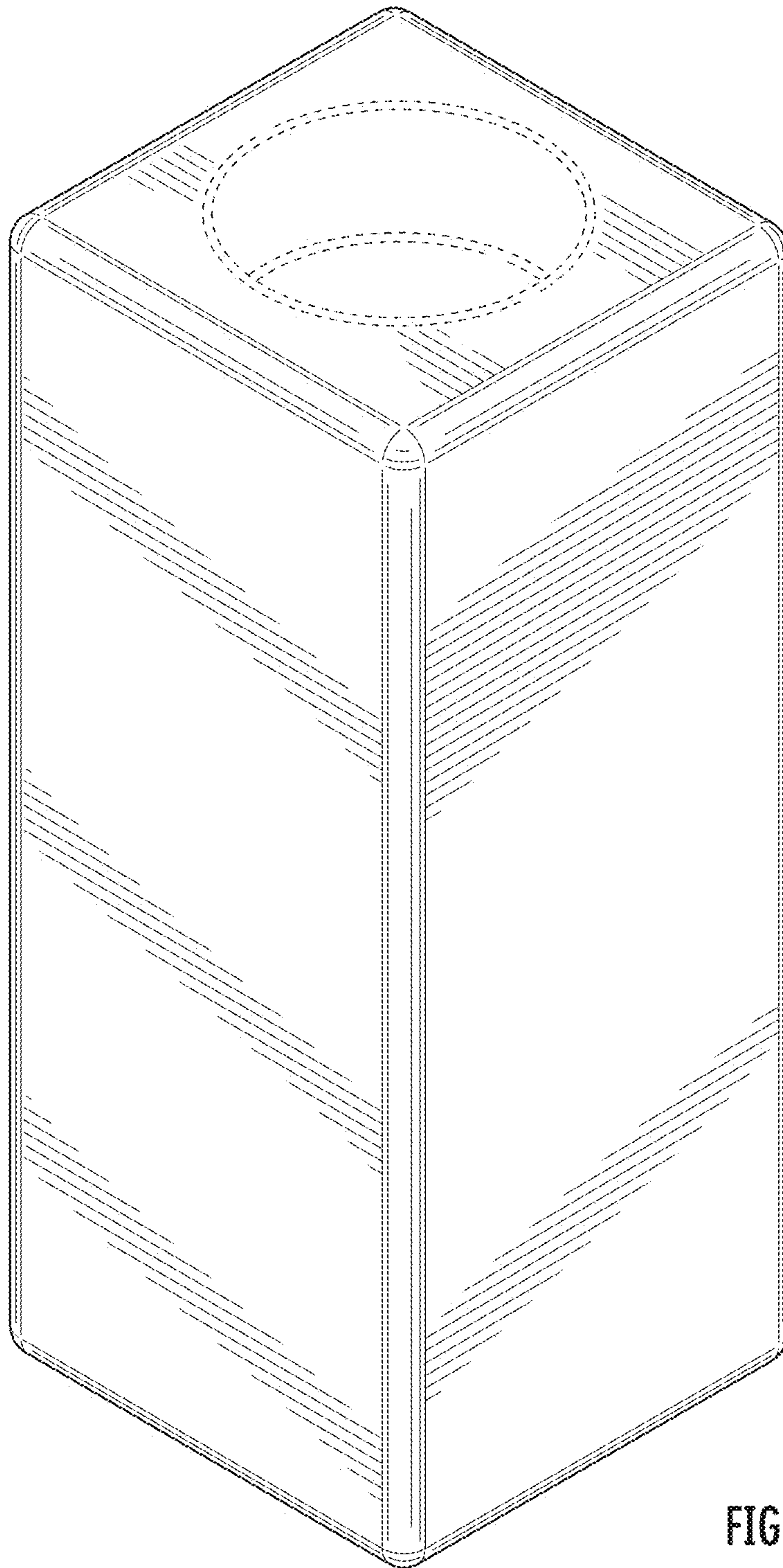

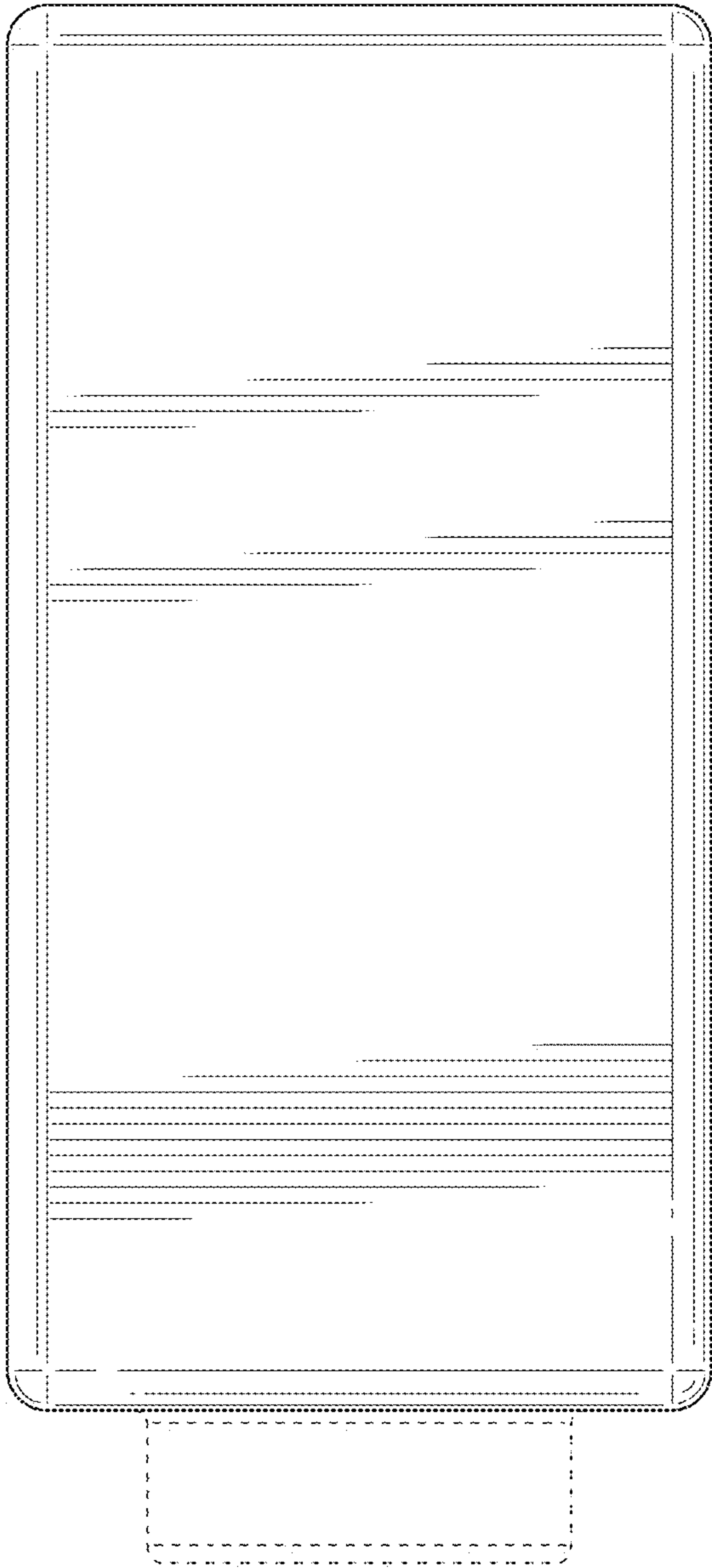

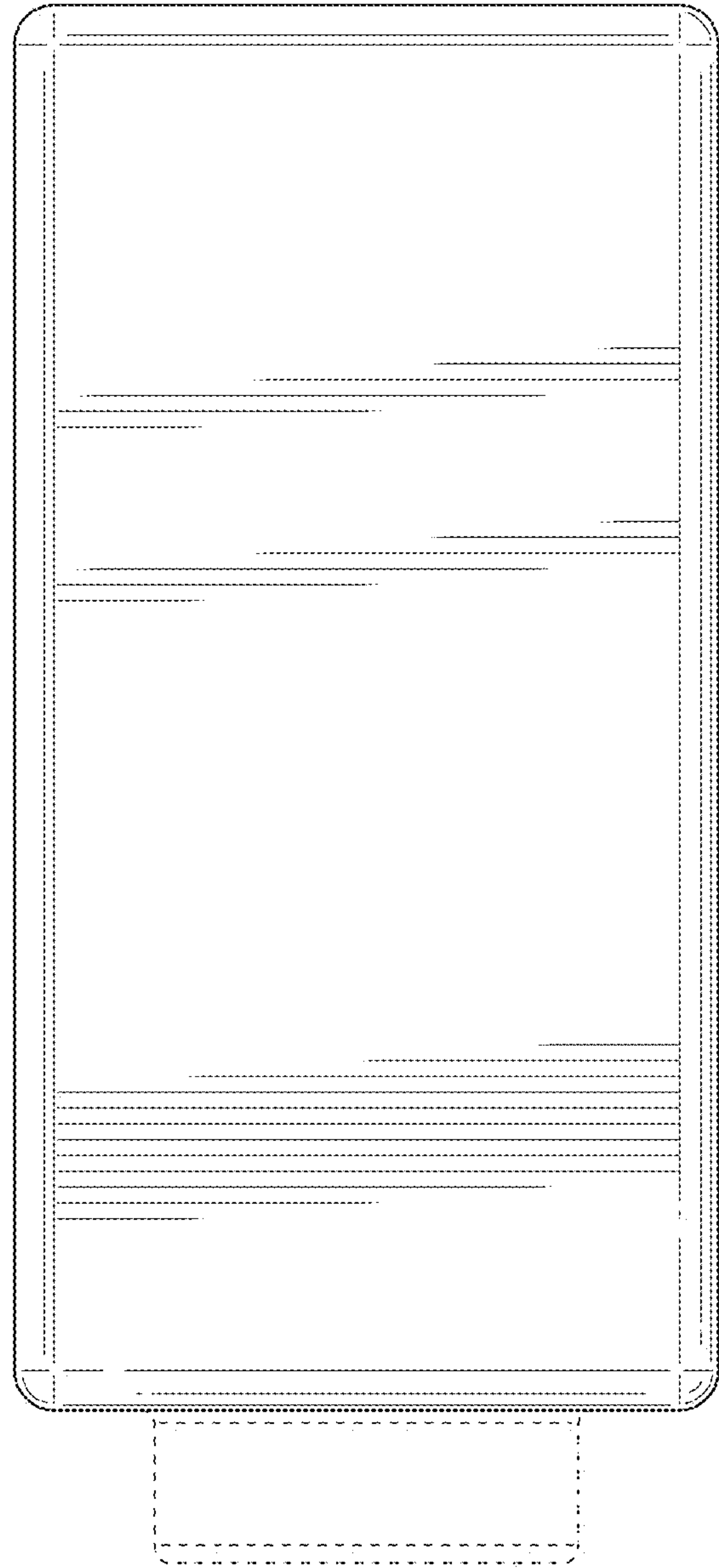

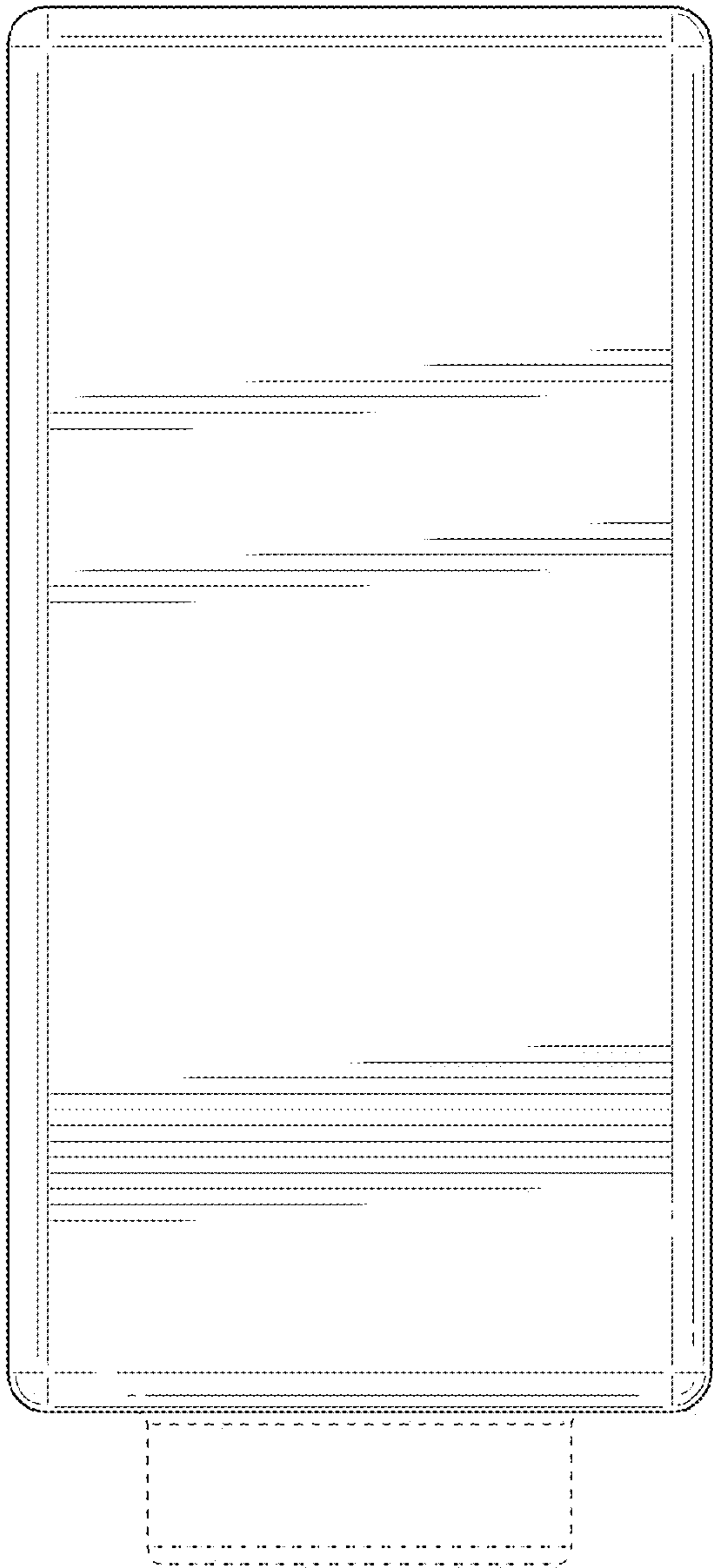

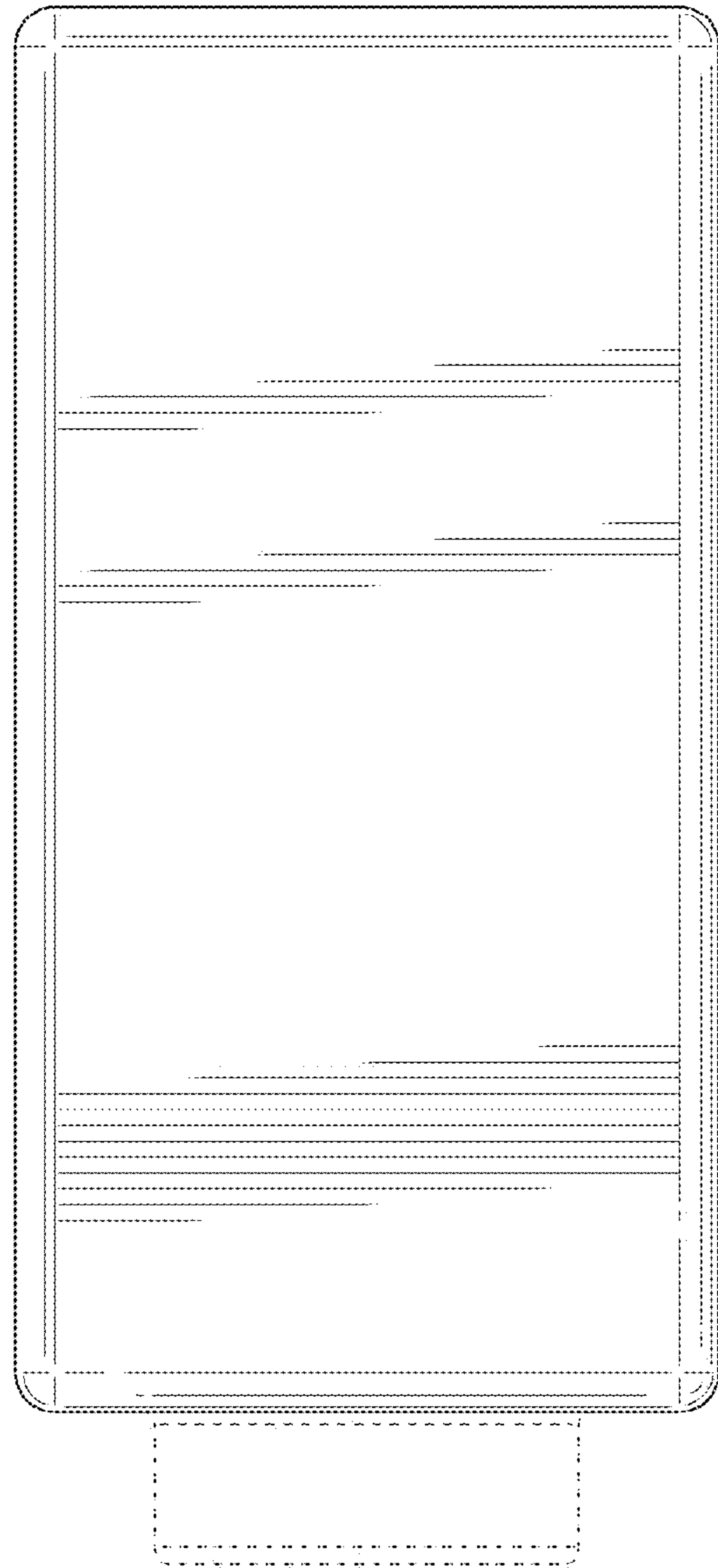

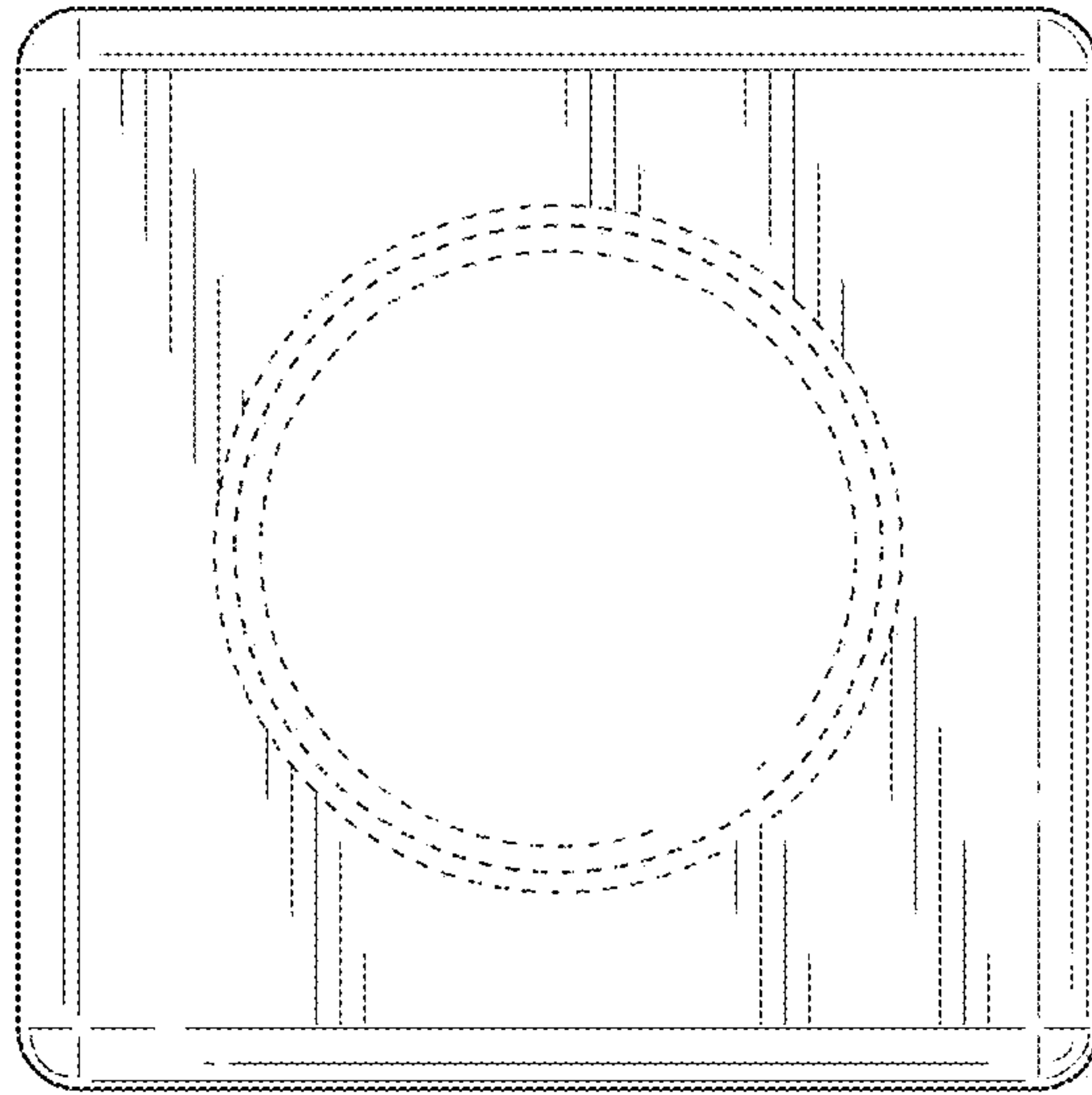

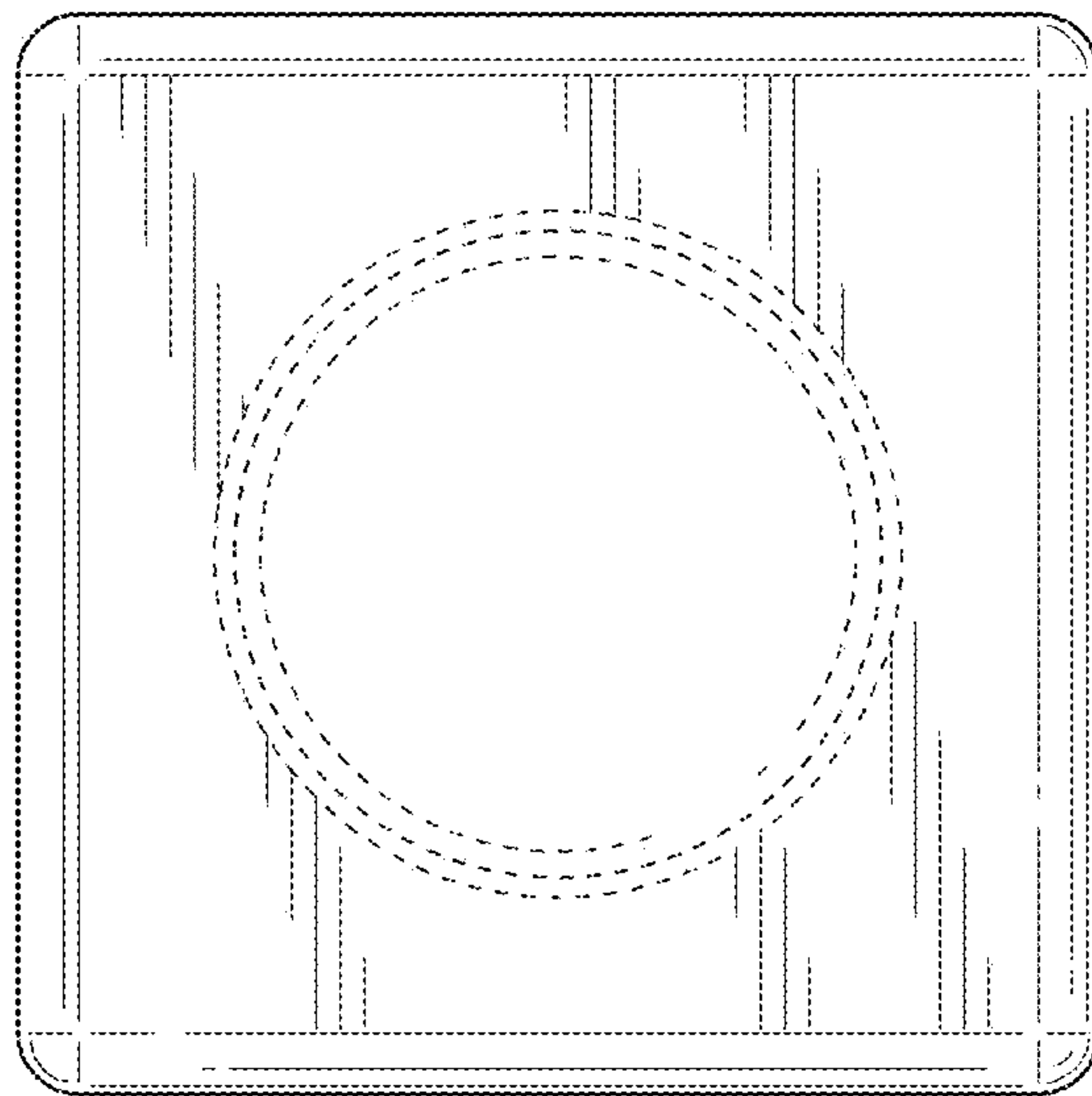

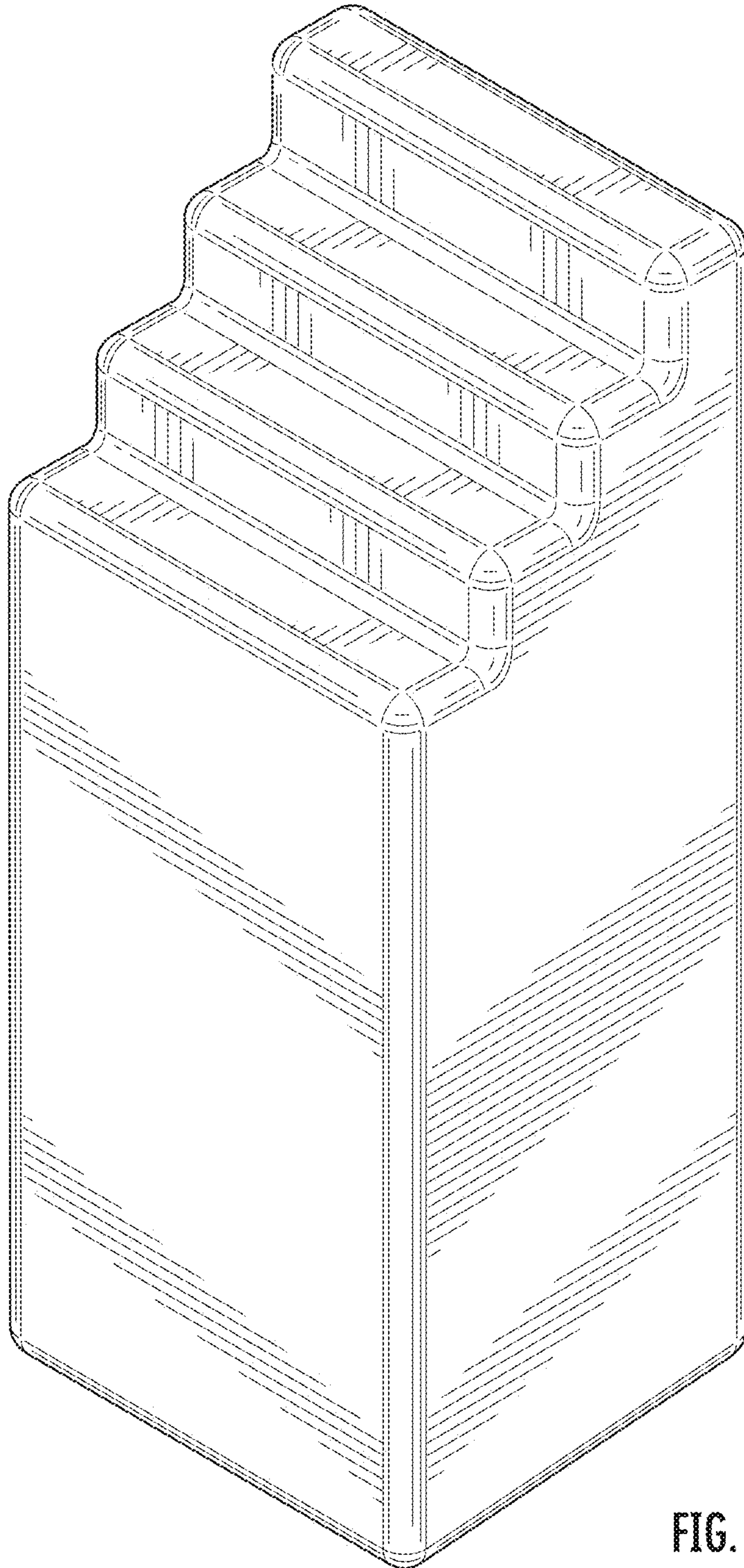

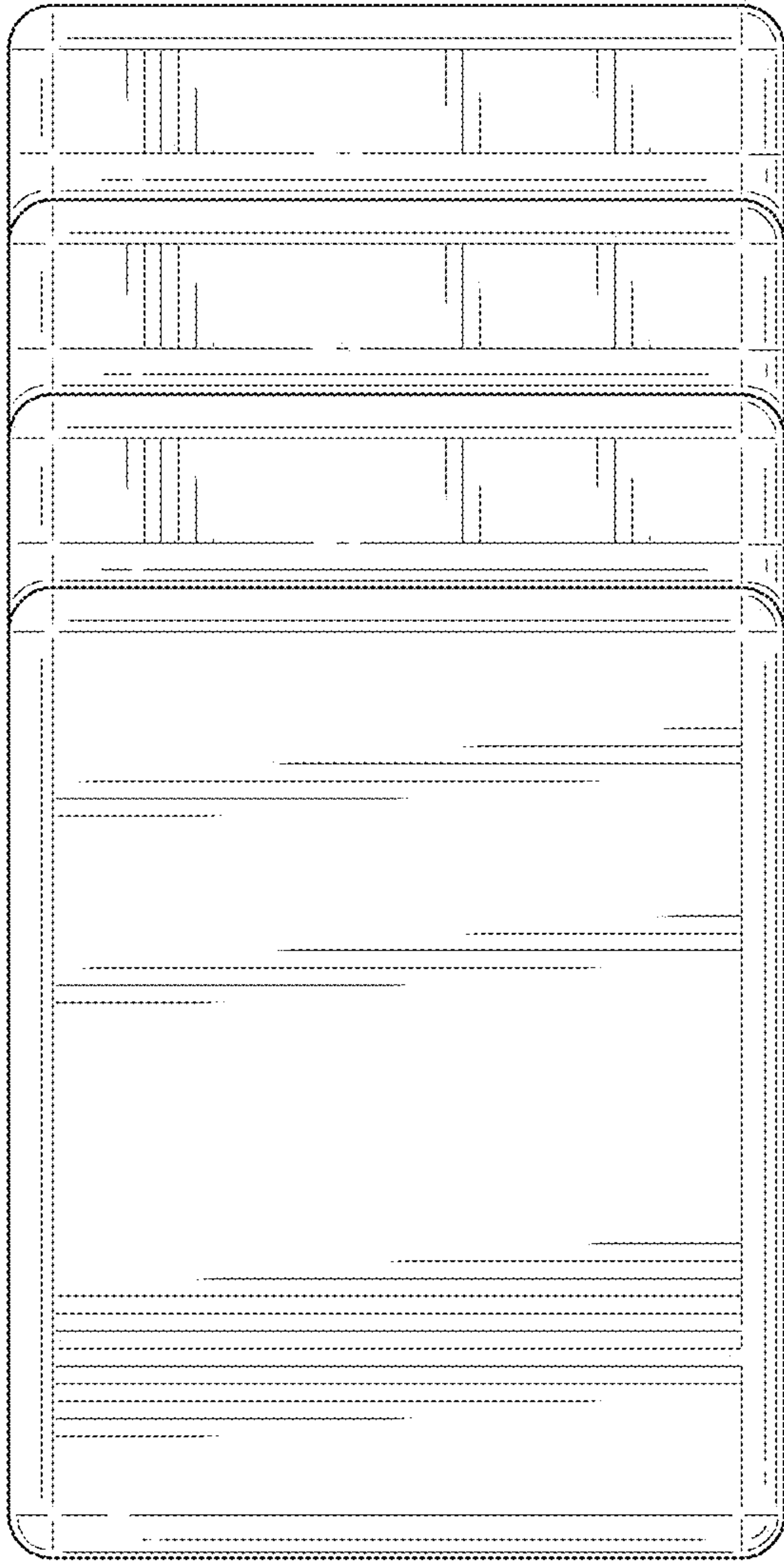

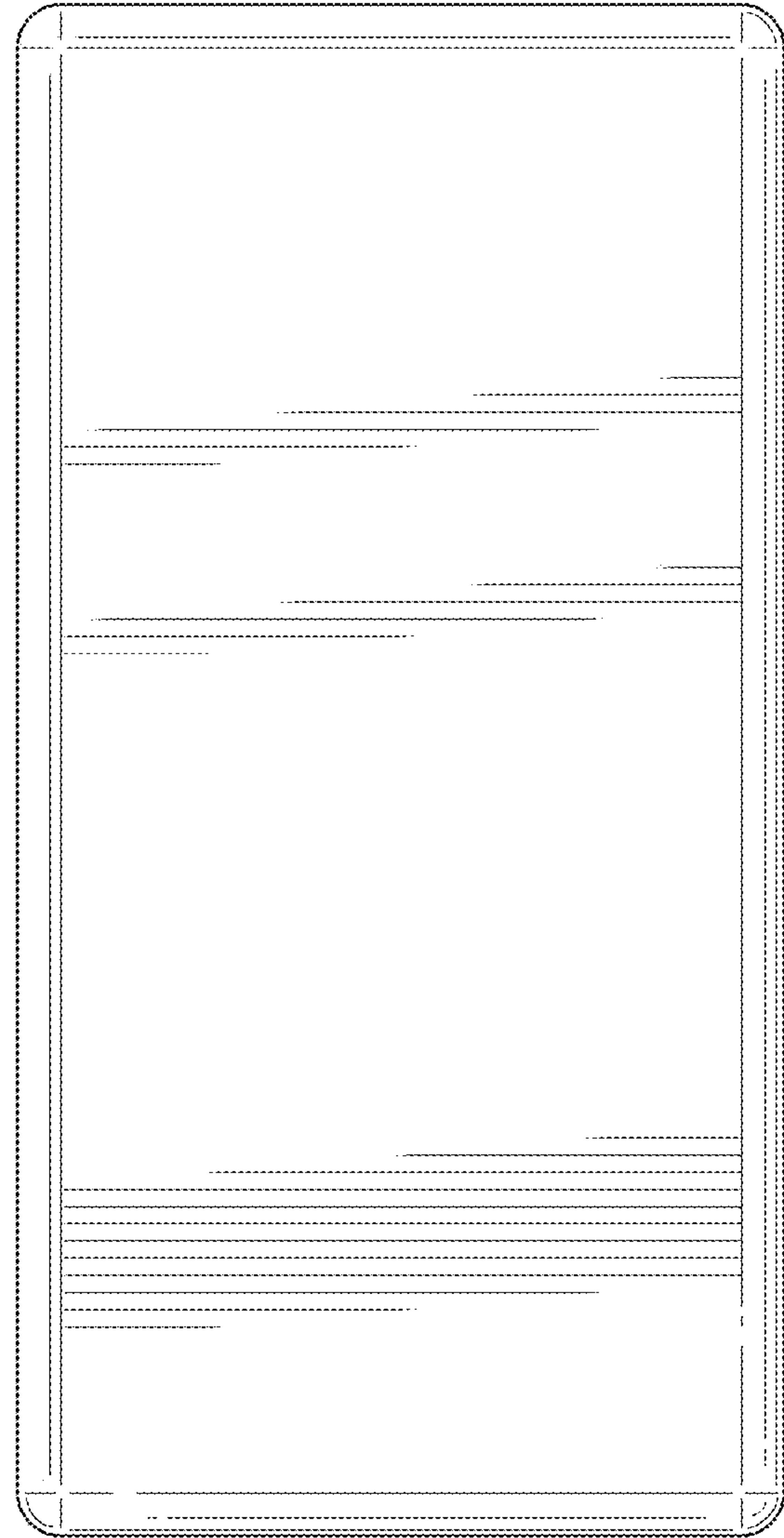

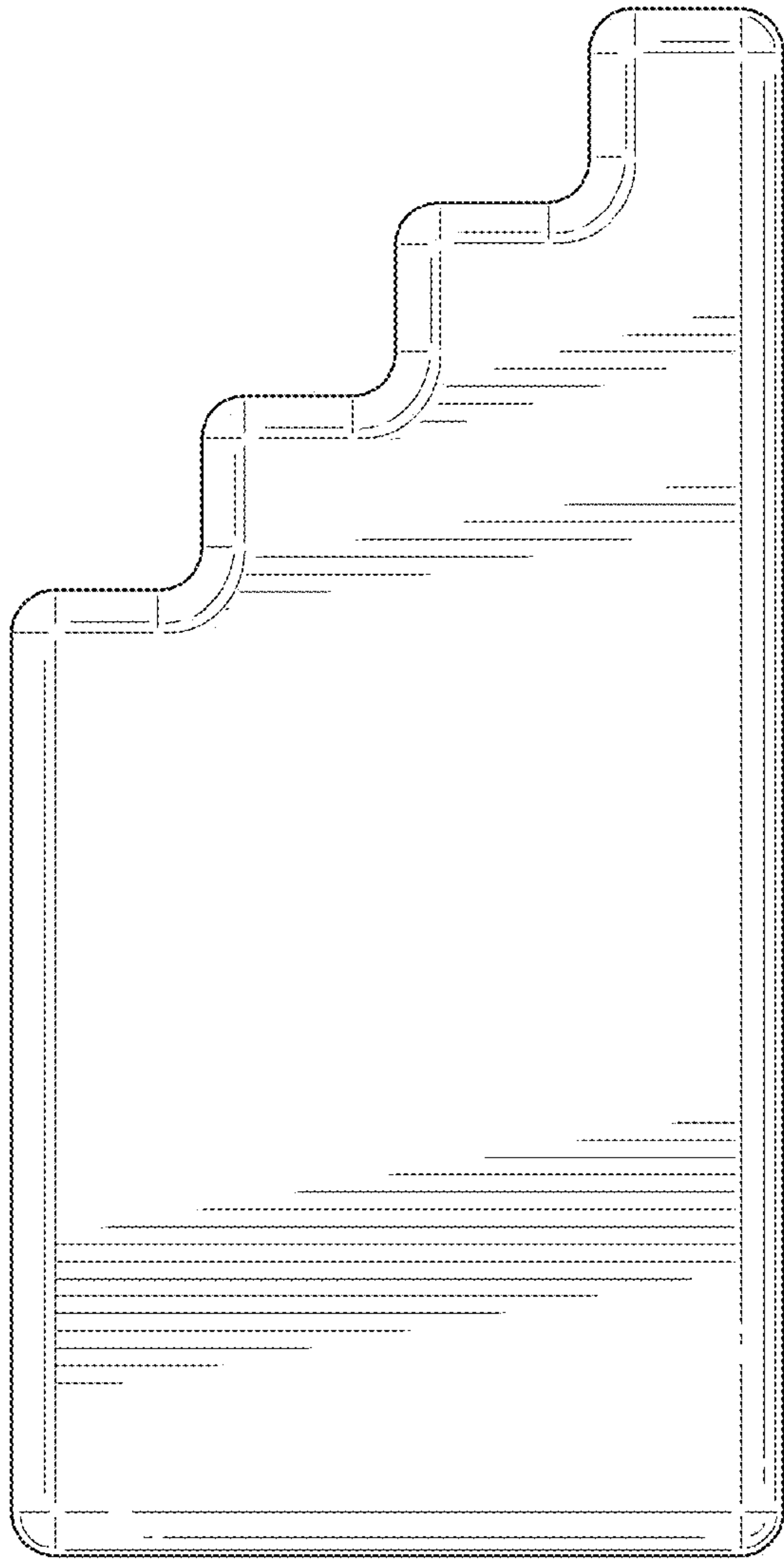

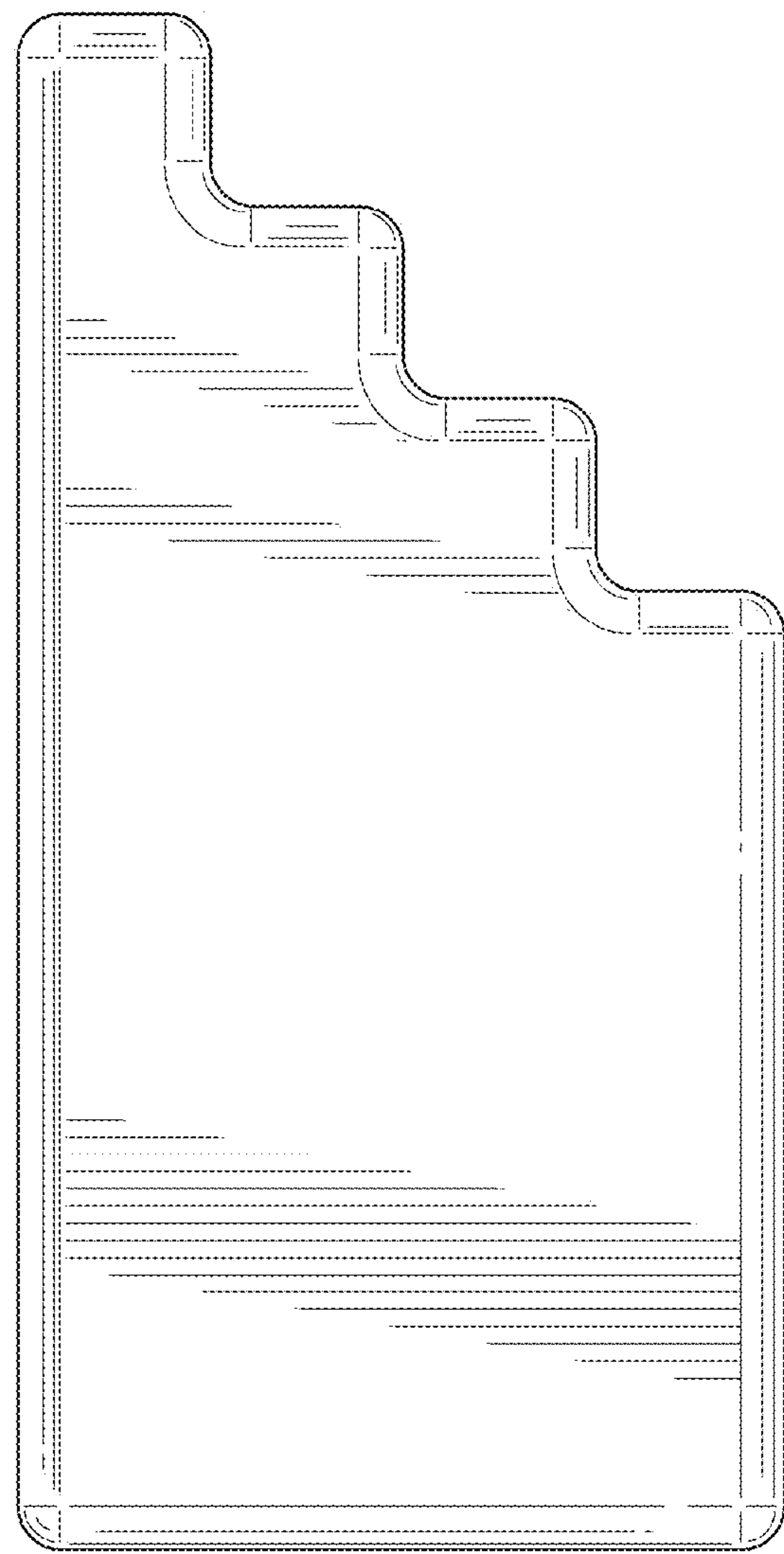

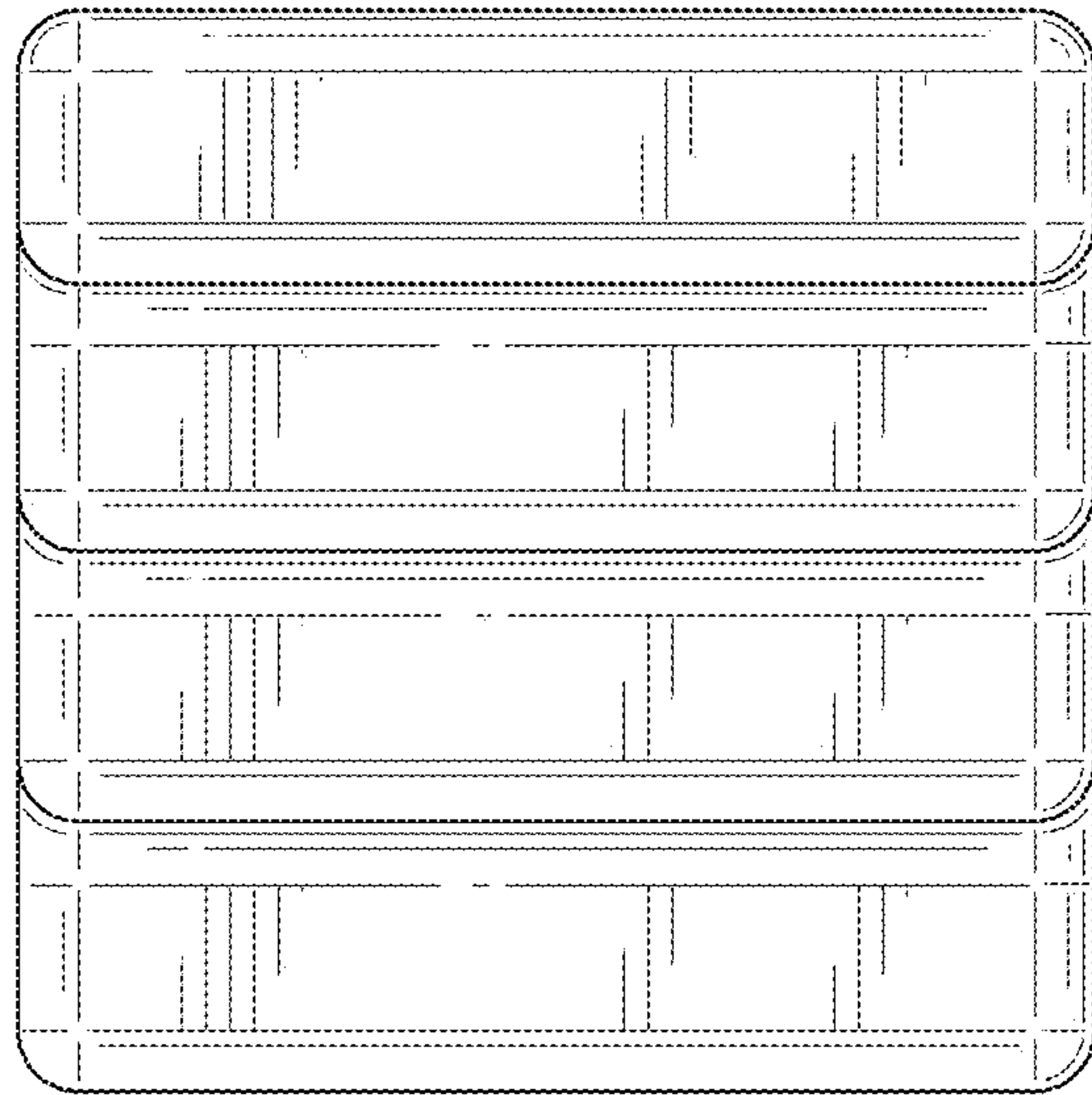

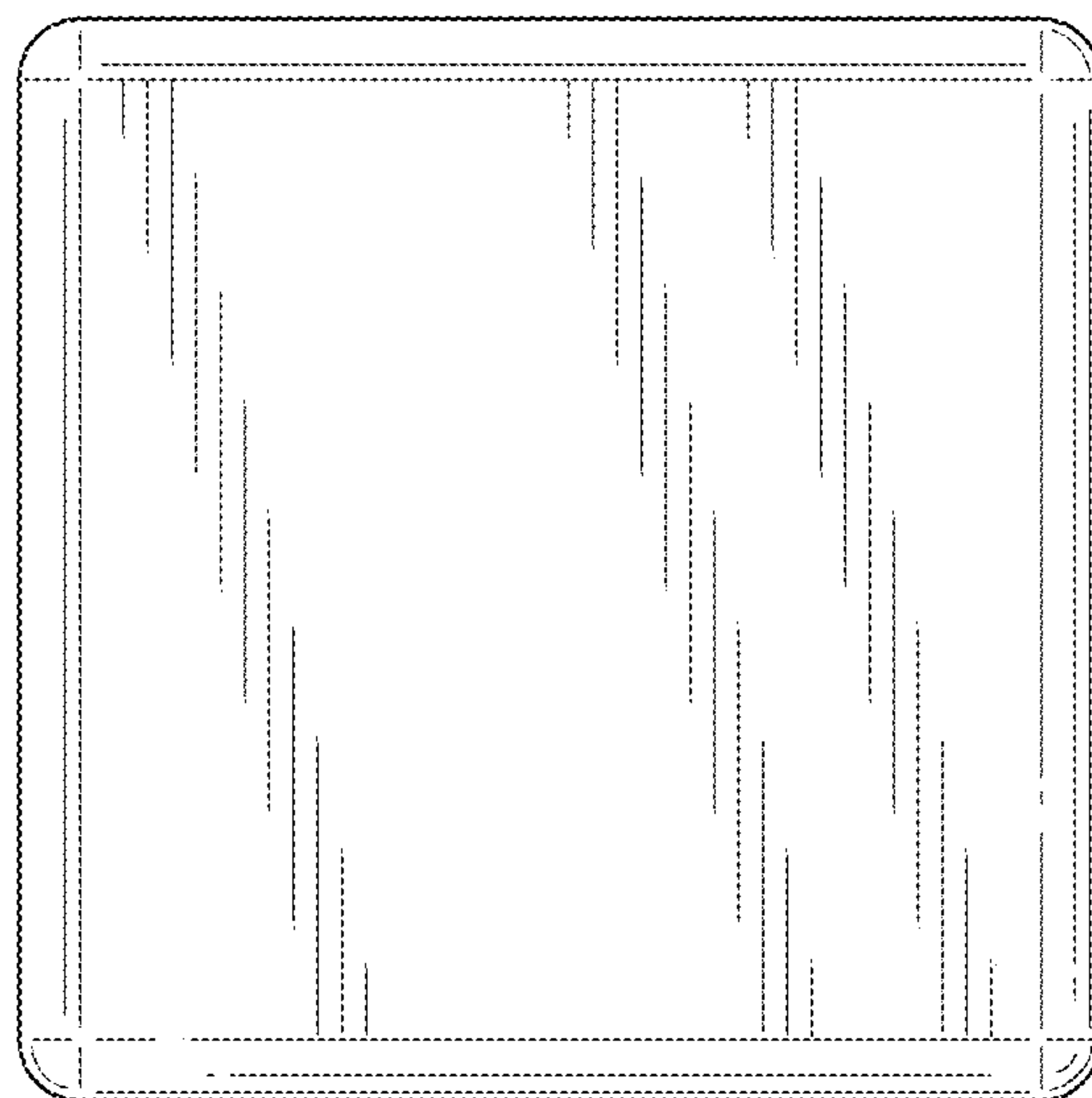

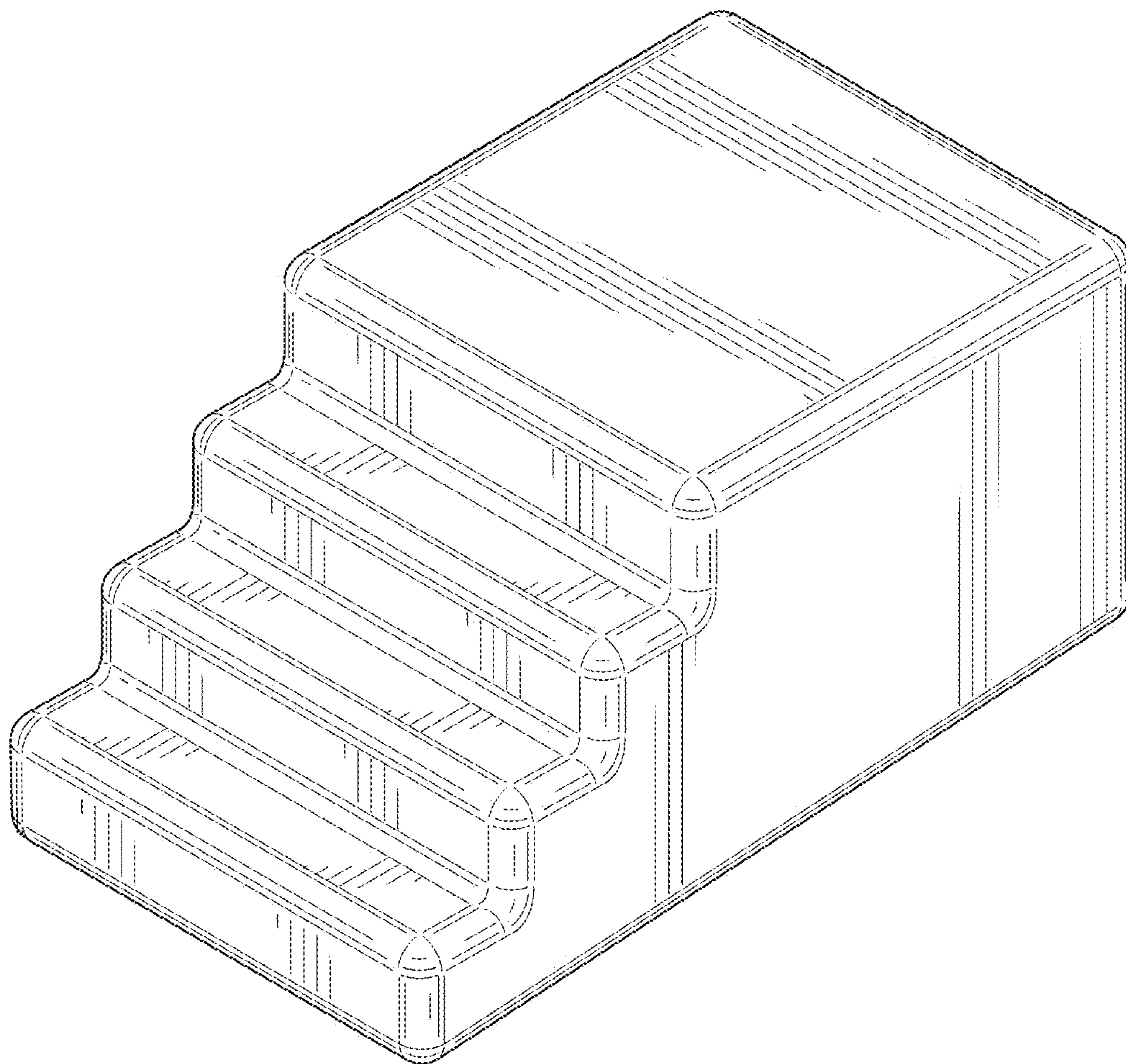

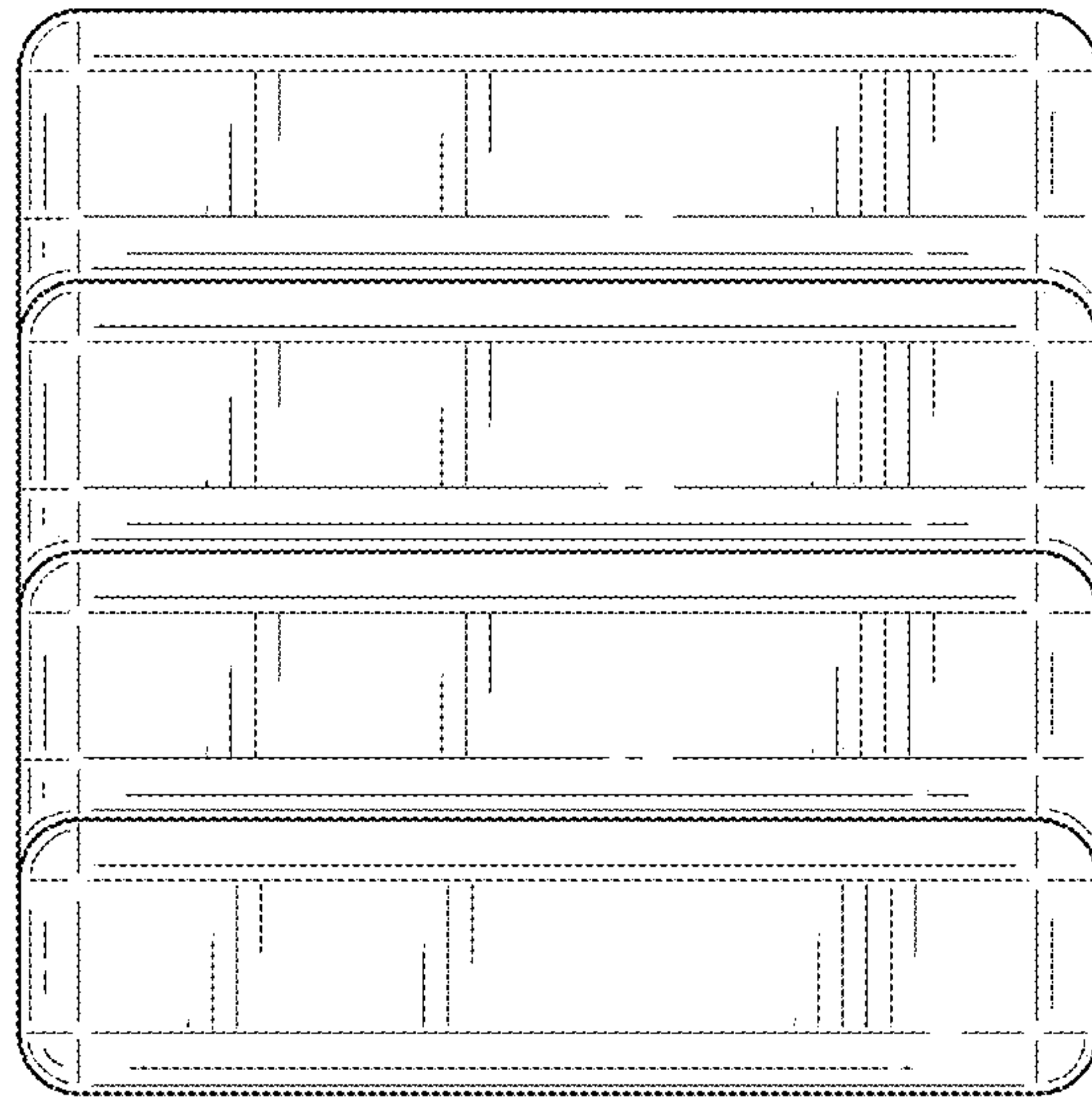

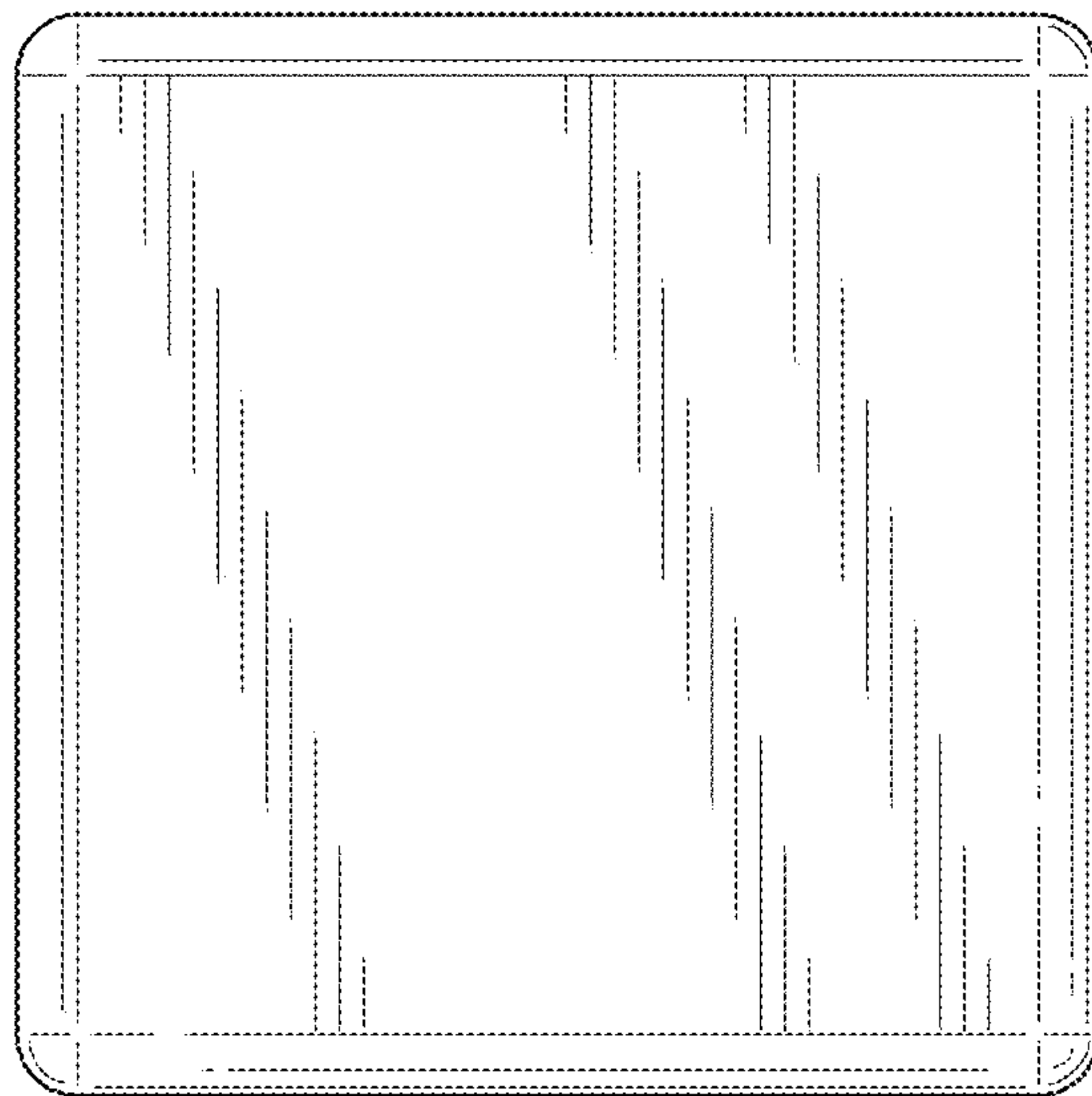

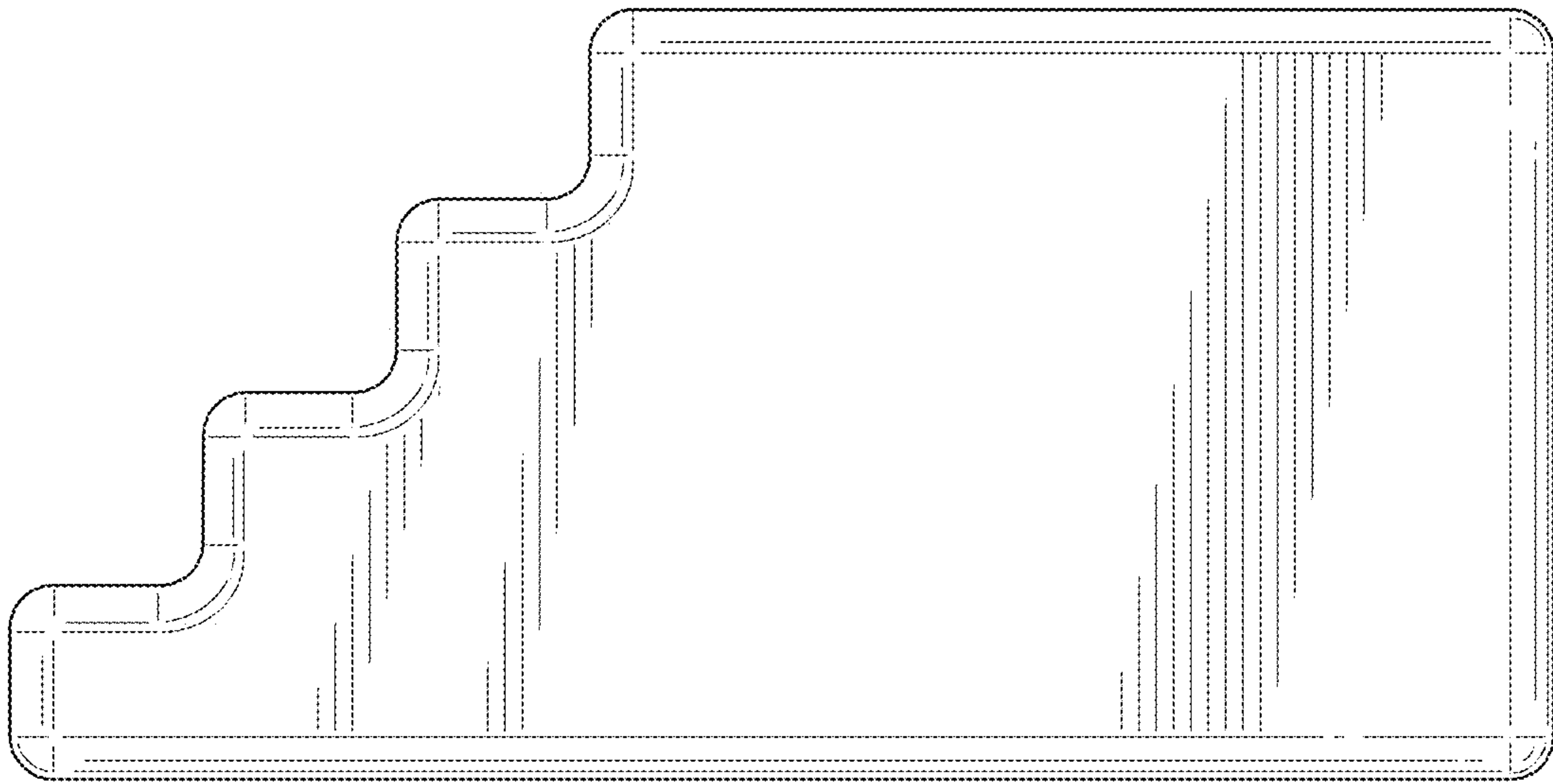

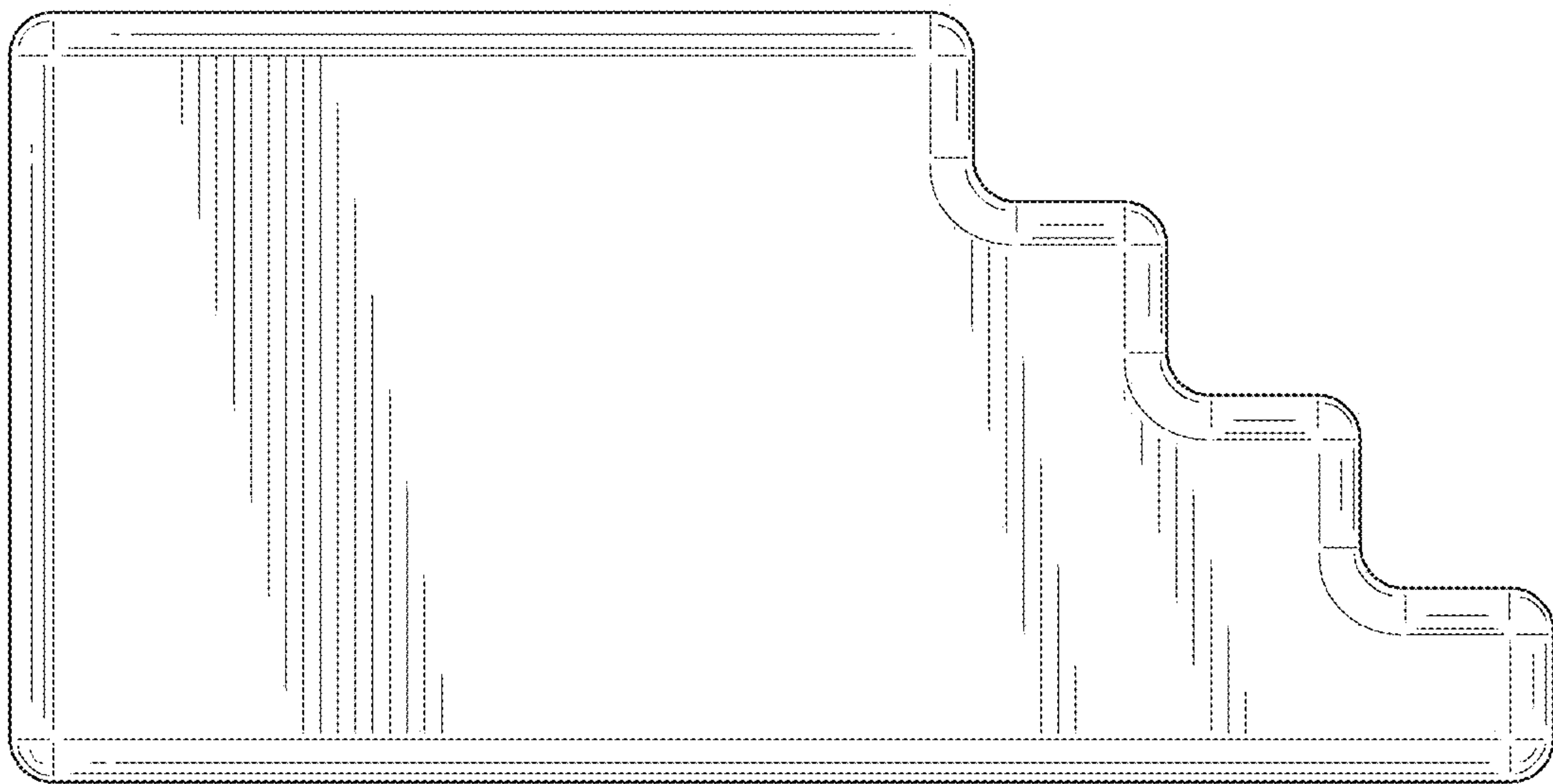

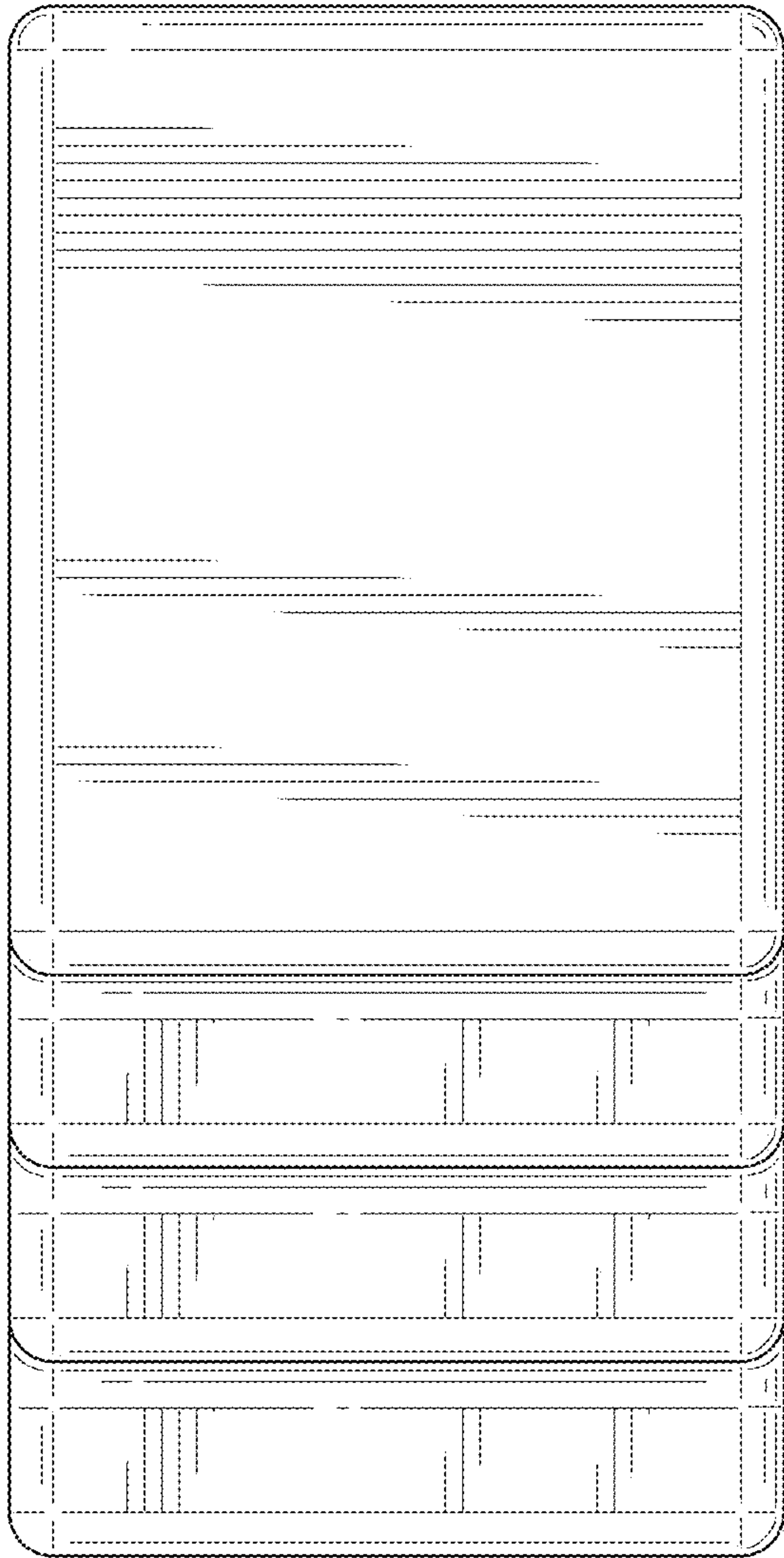

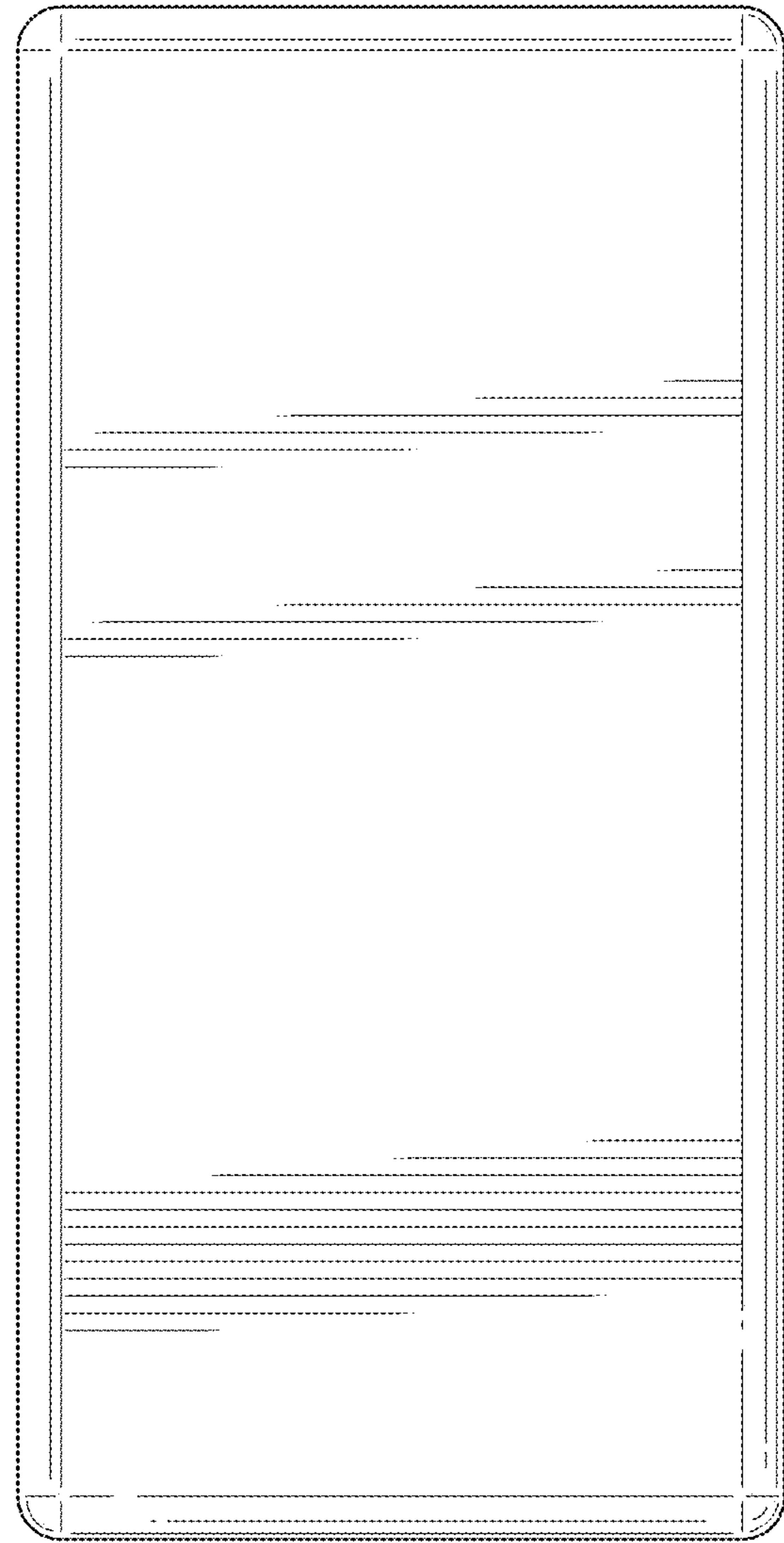

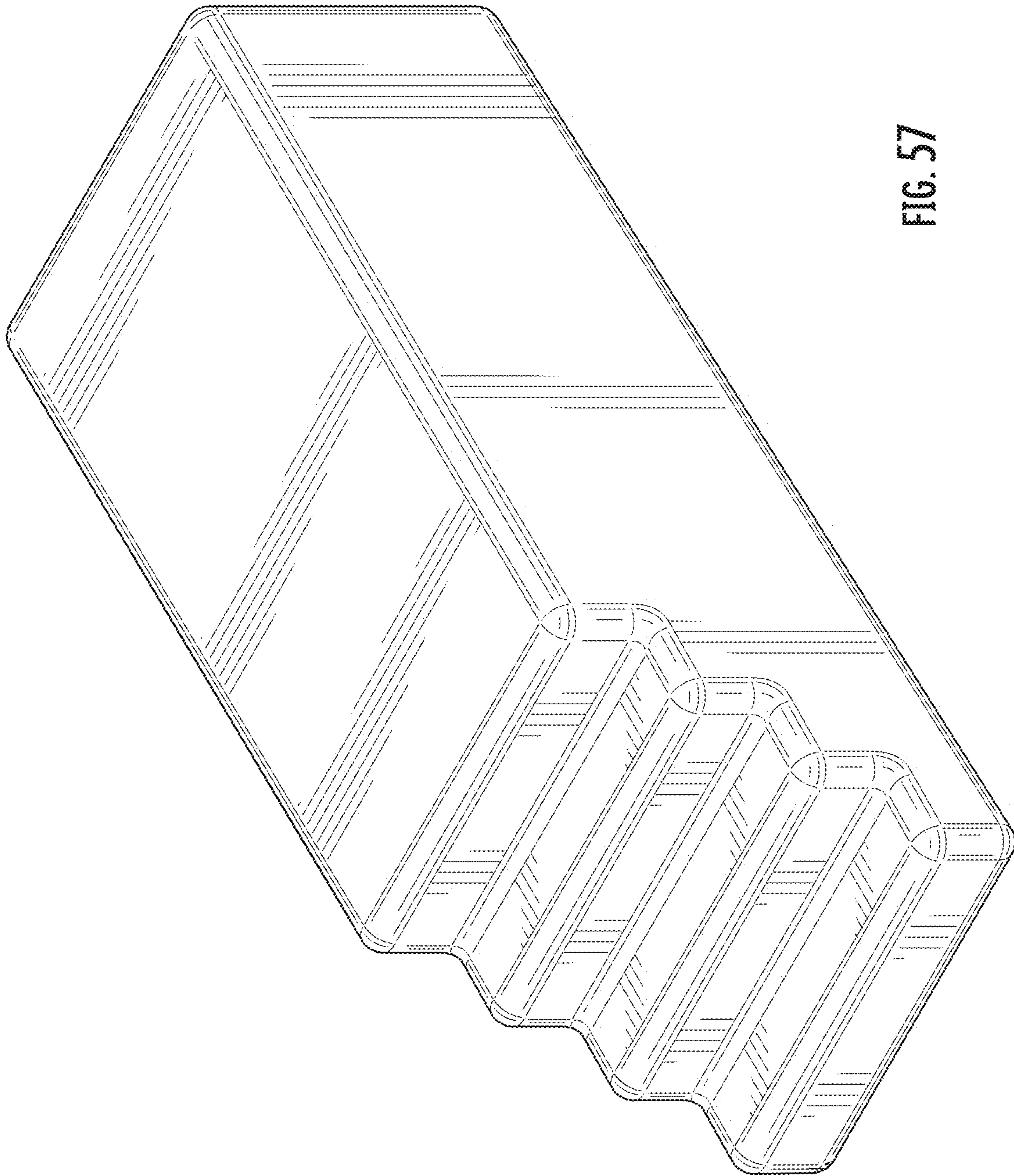

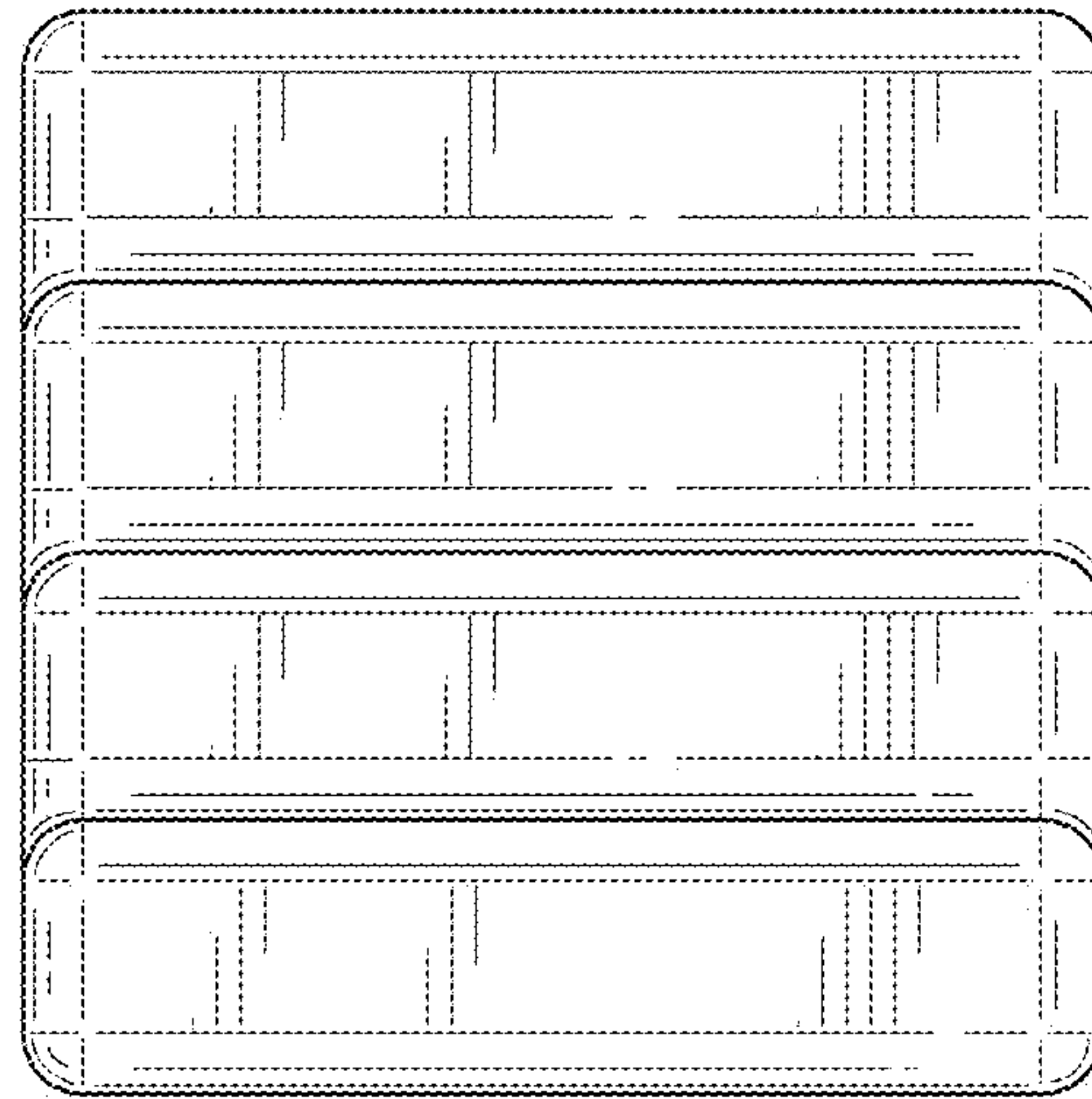

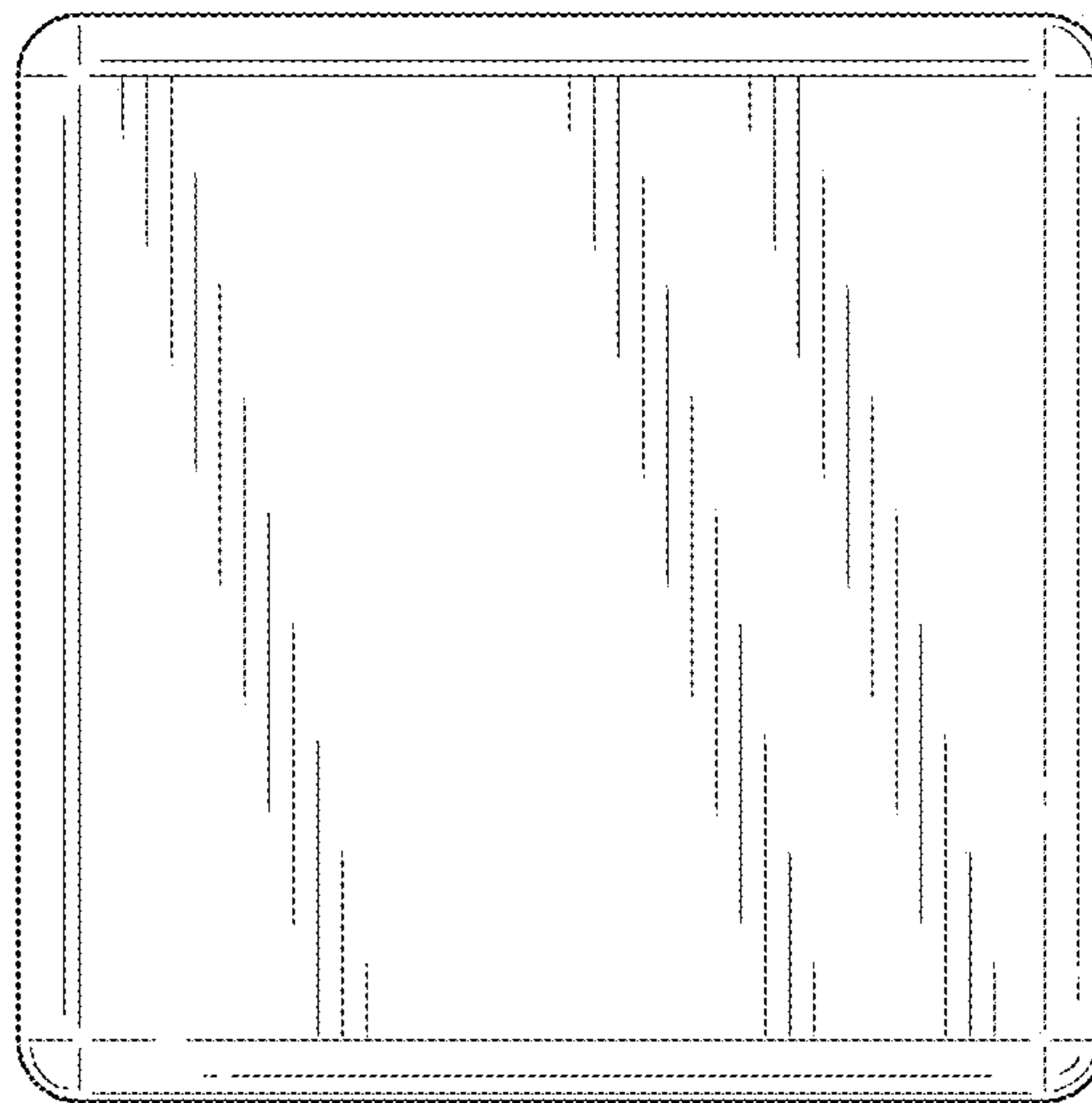

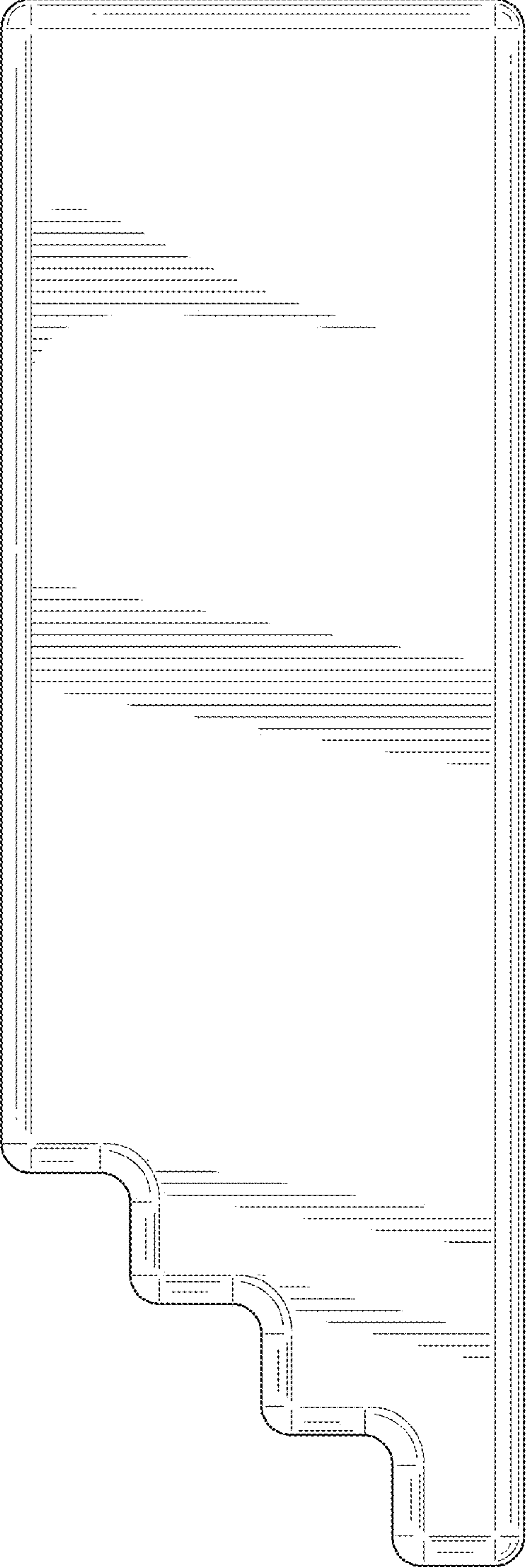

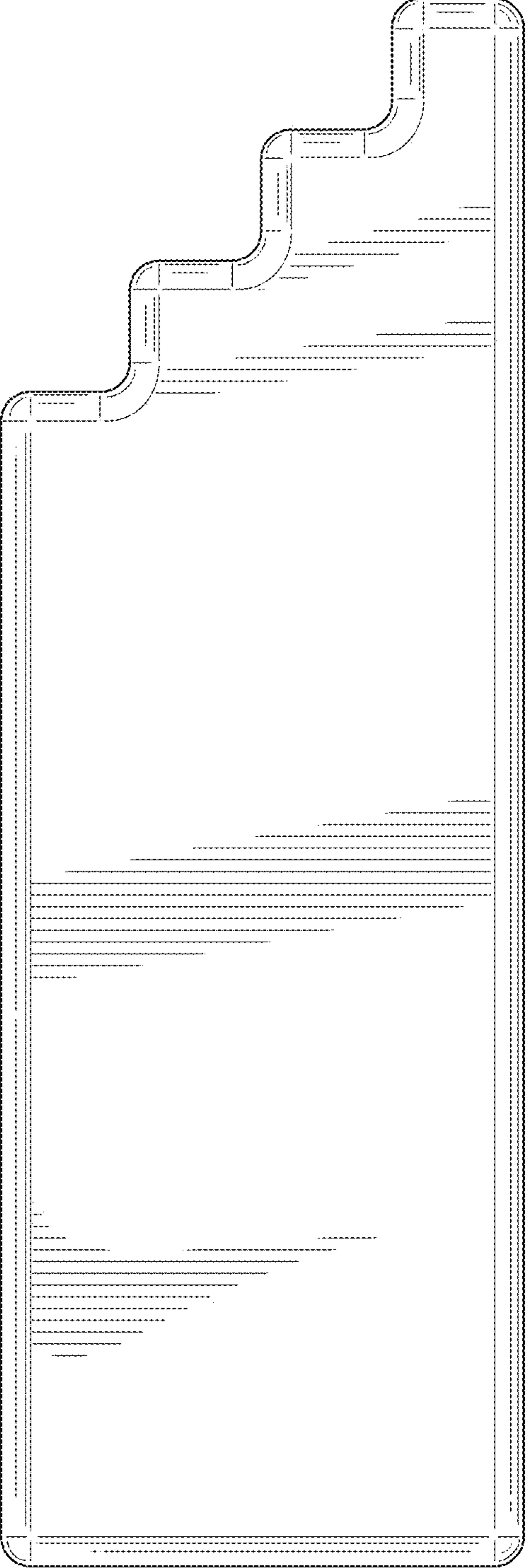

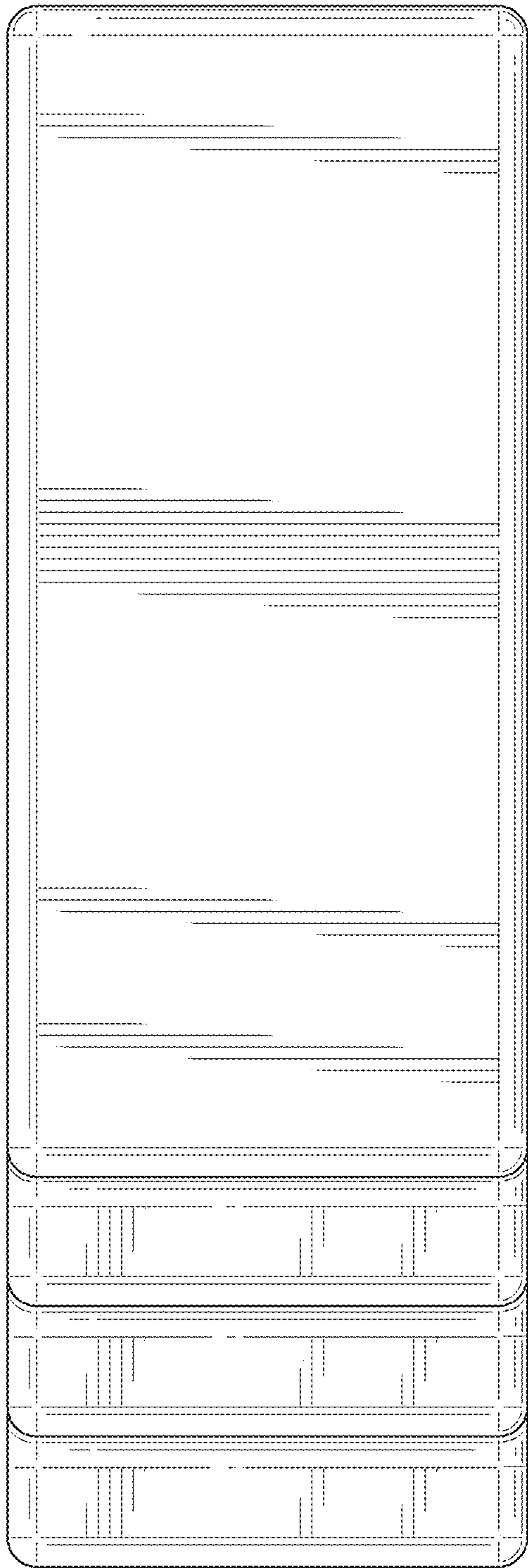

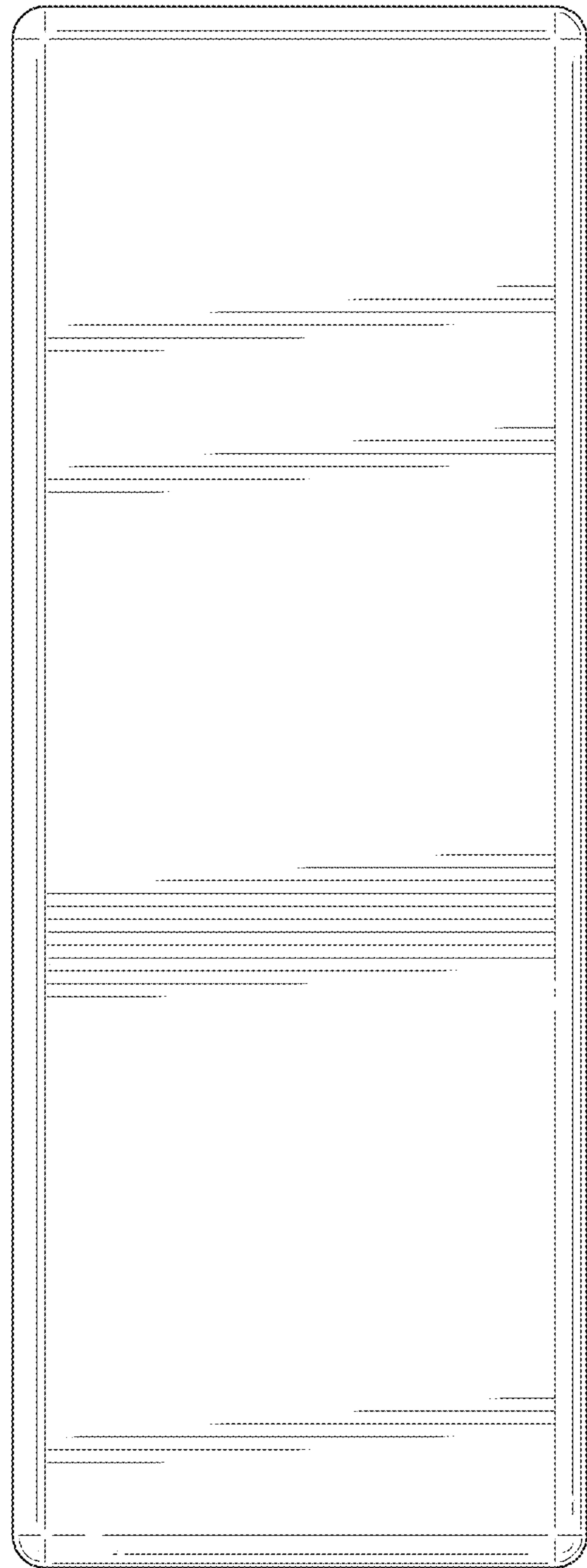

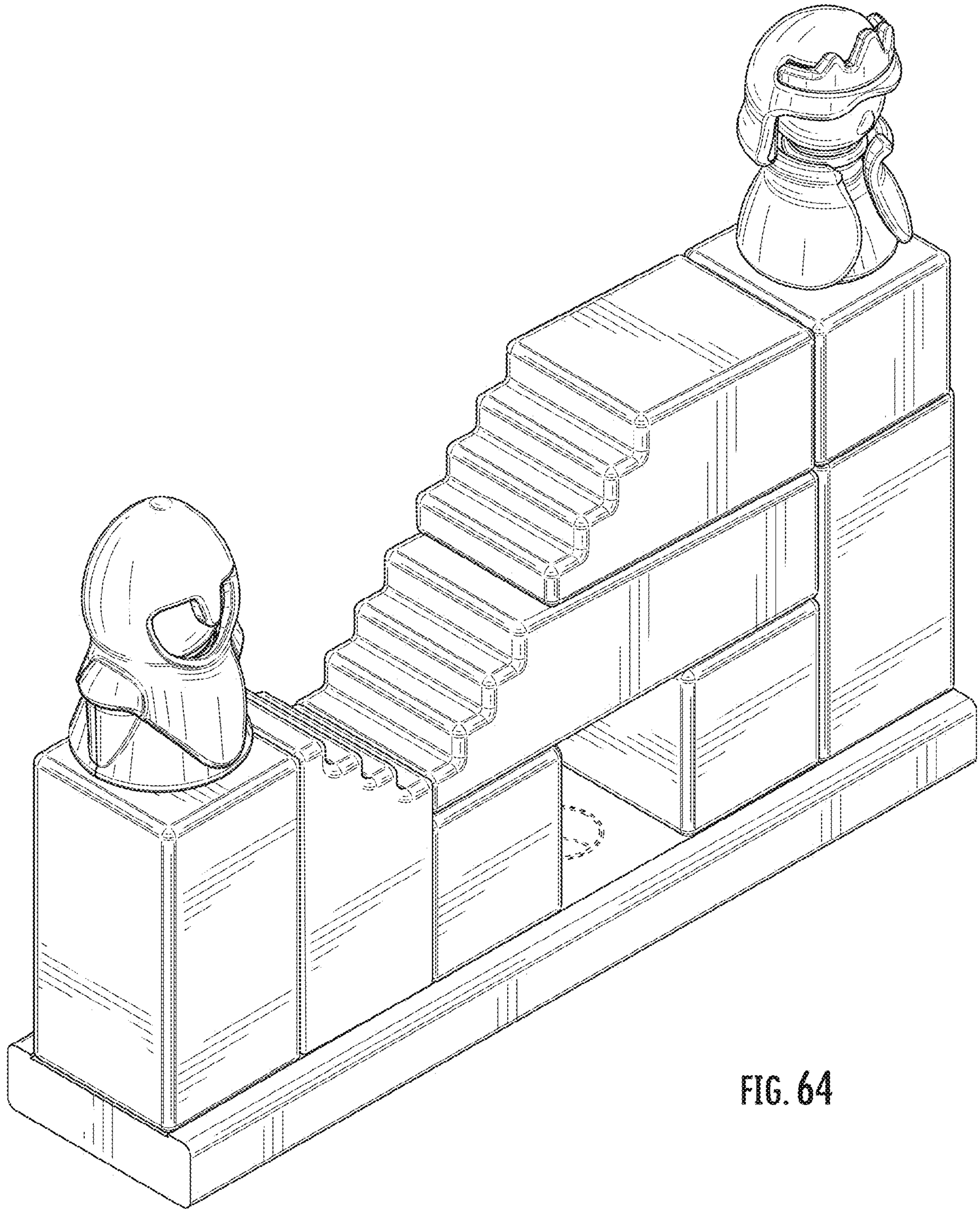
