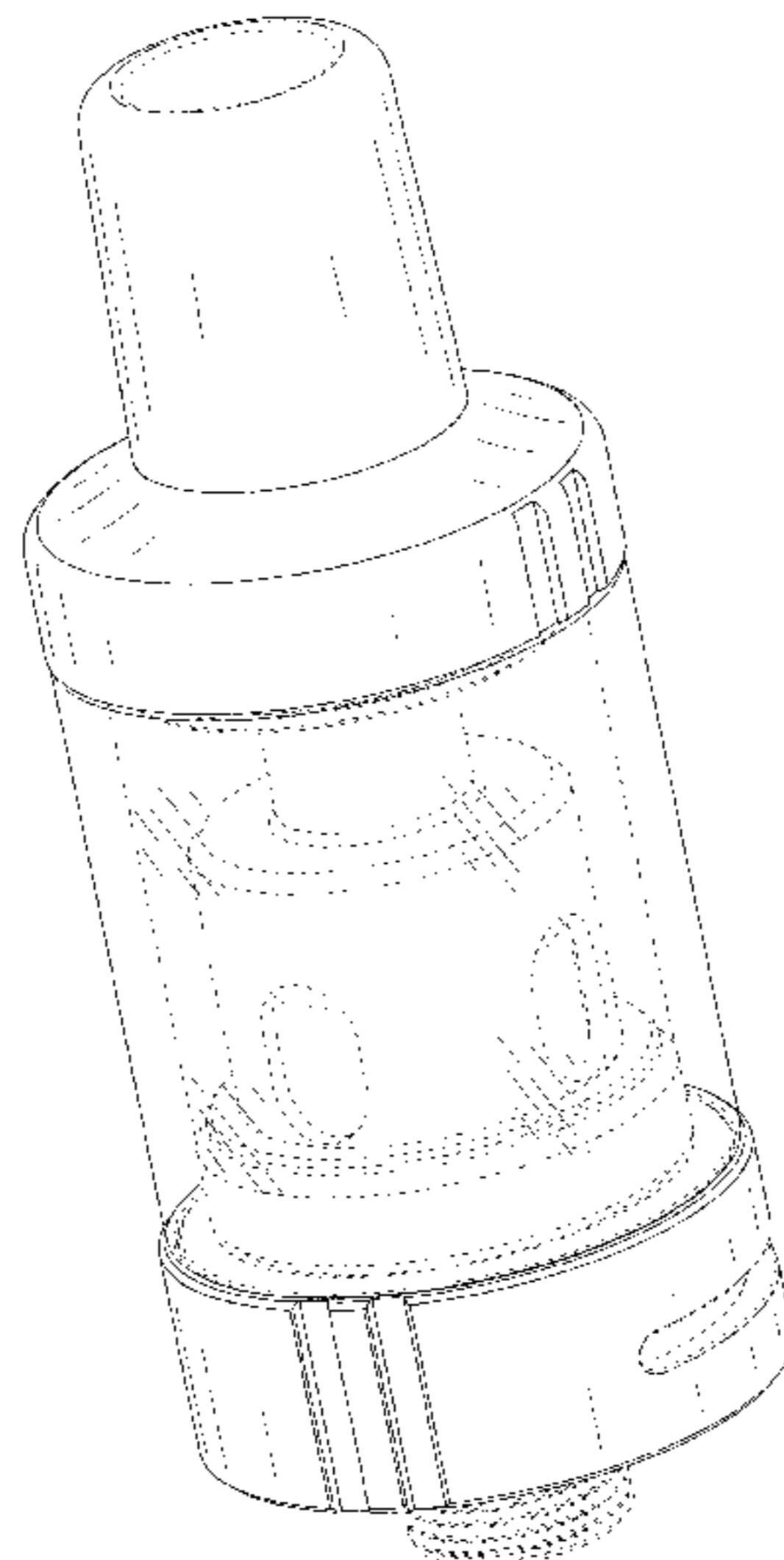
(57) **CLAIM**

The ornamental design for an atomizer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an atomizer; FIG. 2 is another perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is an enlarged top plan view thereof; and, FIG. 8 is an enlarged bottom plan view thereof. The broken lines in the drawings depict portions of the atomizer that form no part of the claimed design. The dot-dash-dot broken lines are for the purpose of illustrating the boundaries of the claim, and form no part of the claimed design. The oblique shade lines in the figures show transparency.

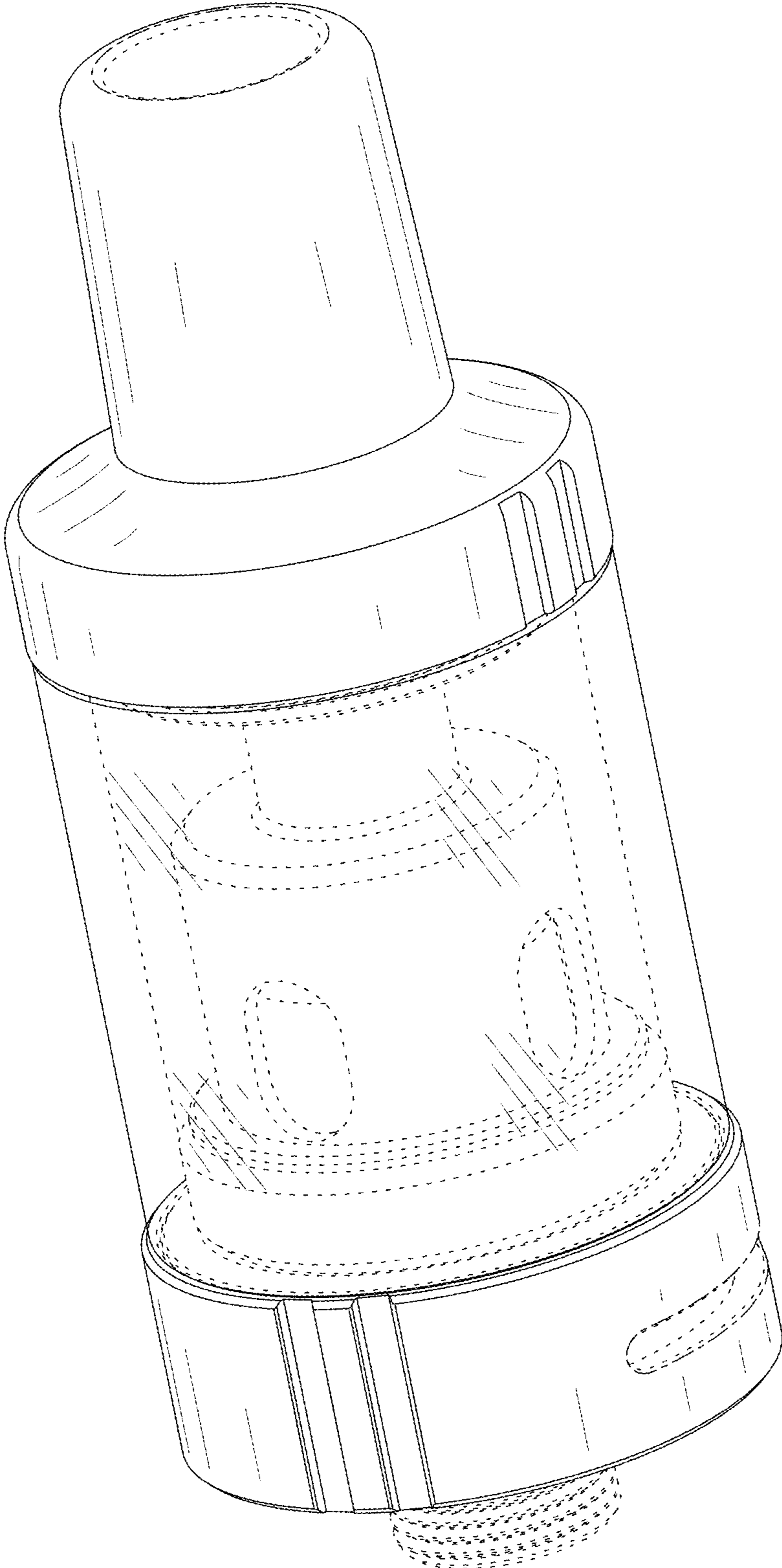

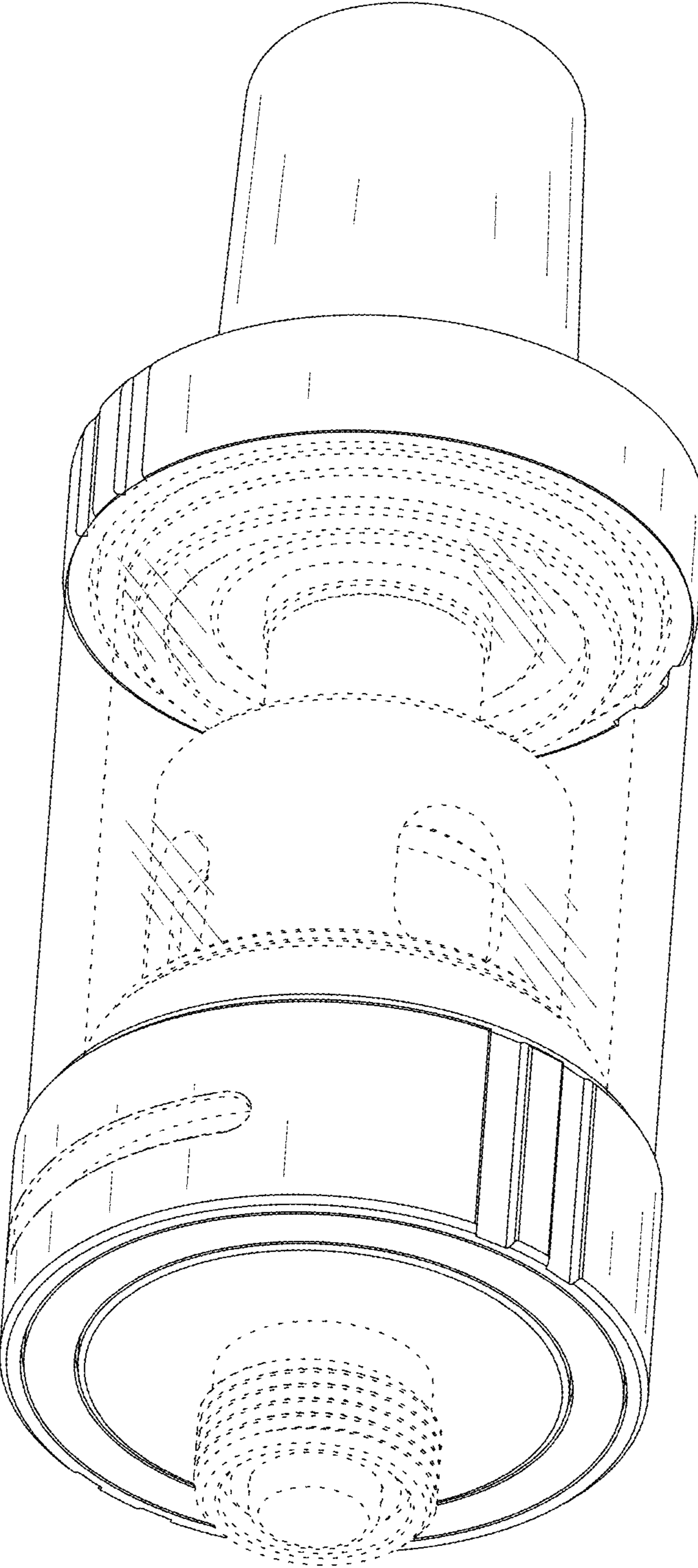

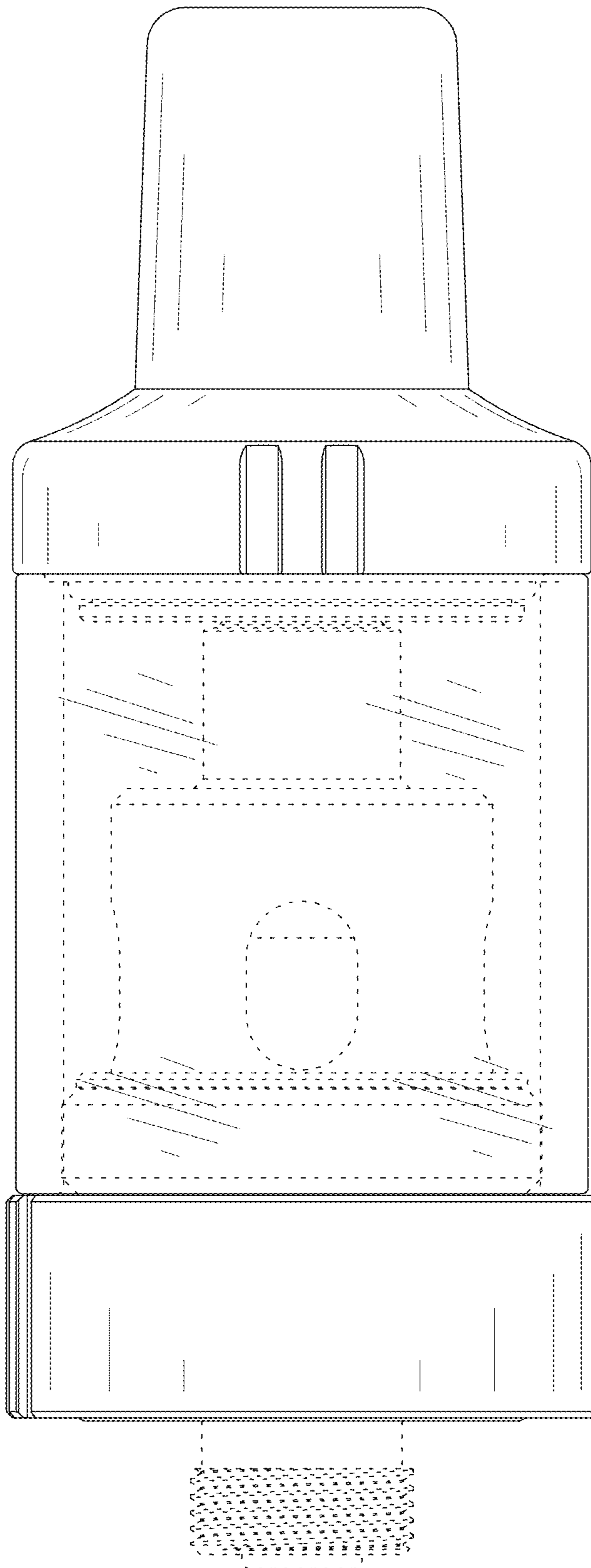

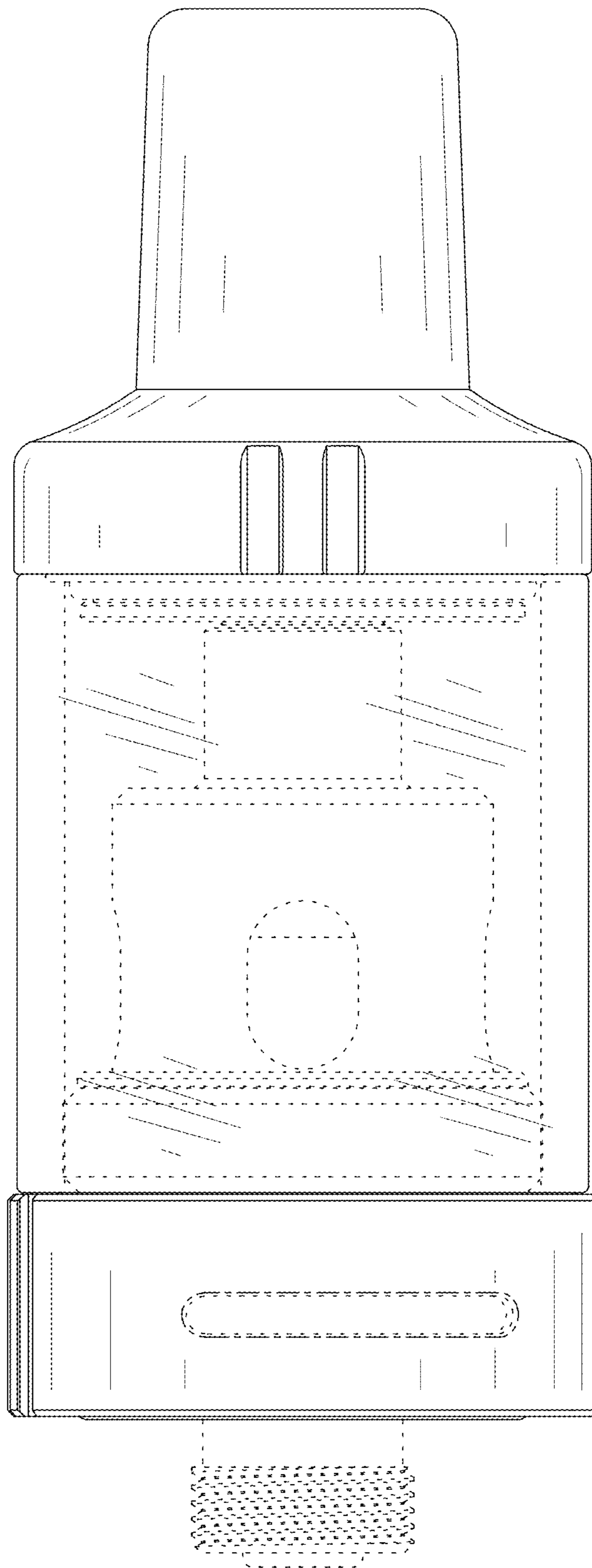

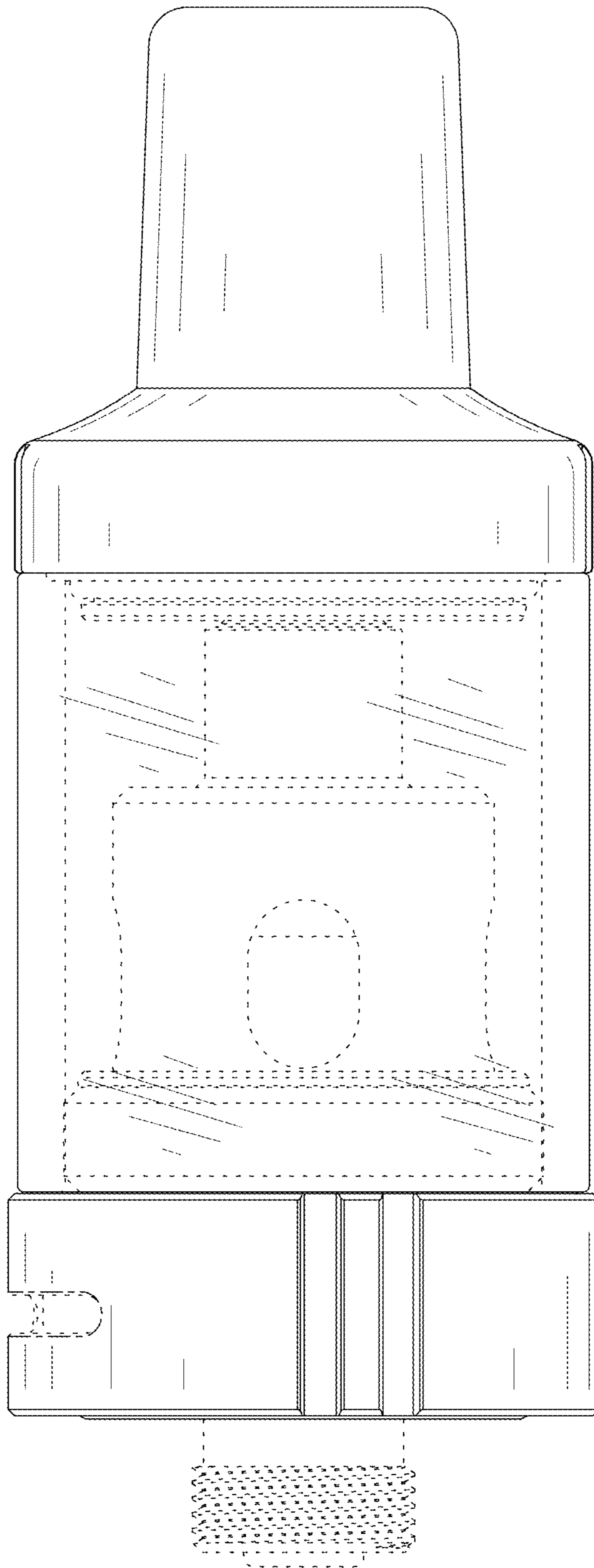

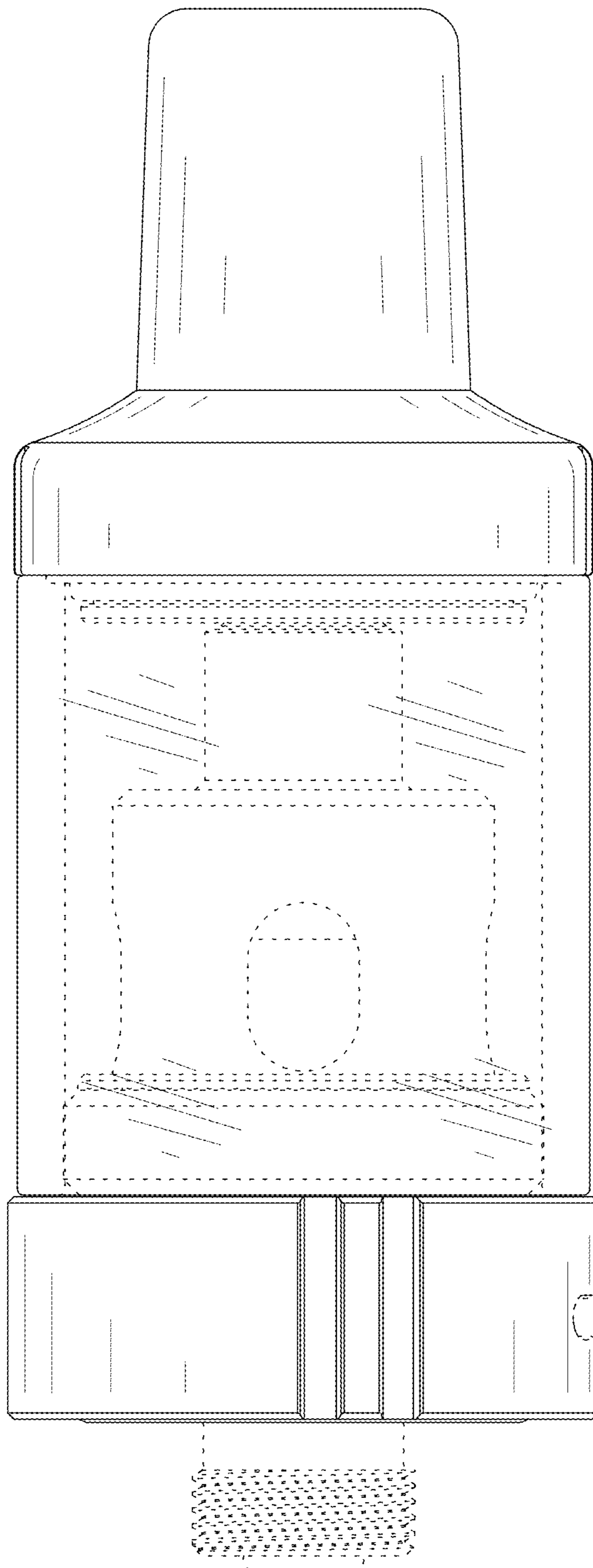

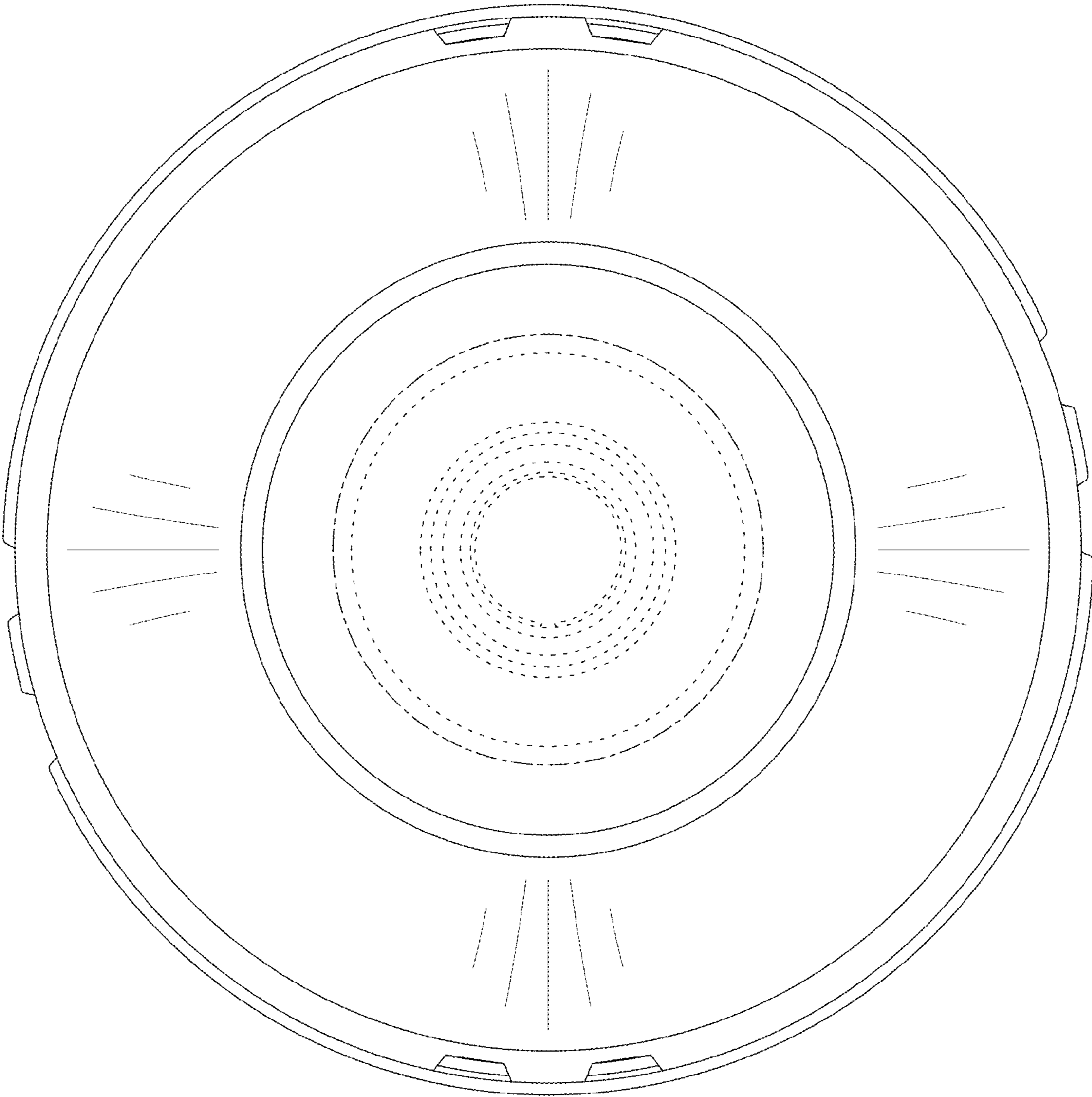

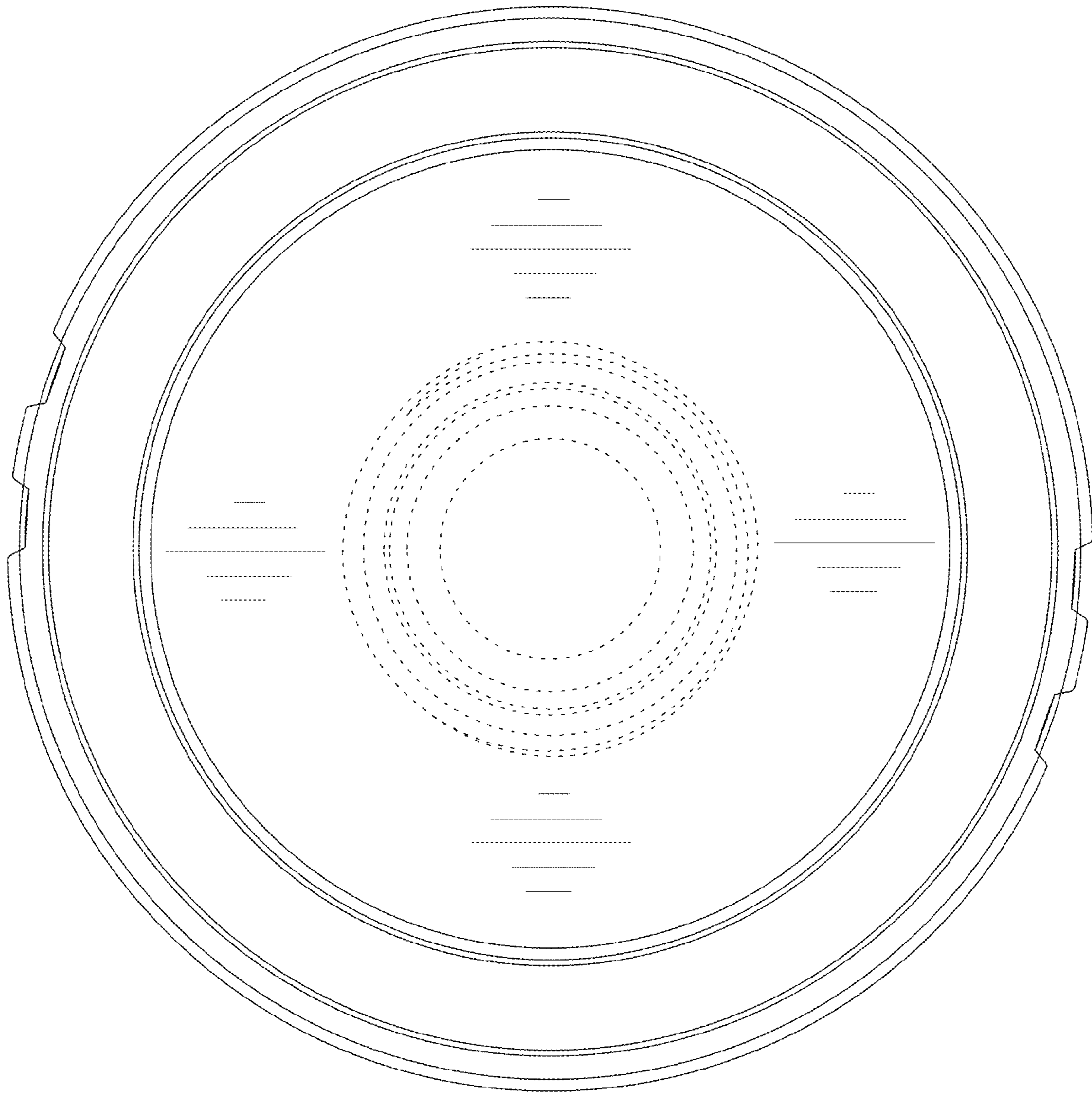
