(57) **CLAIM**

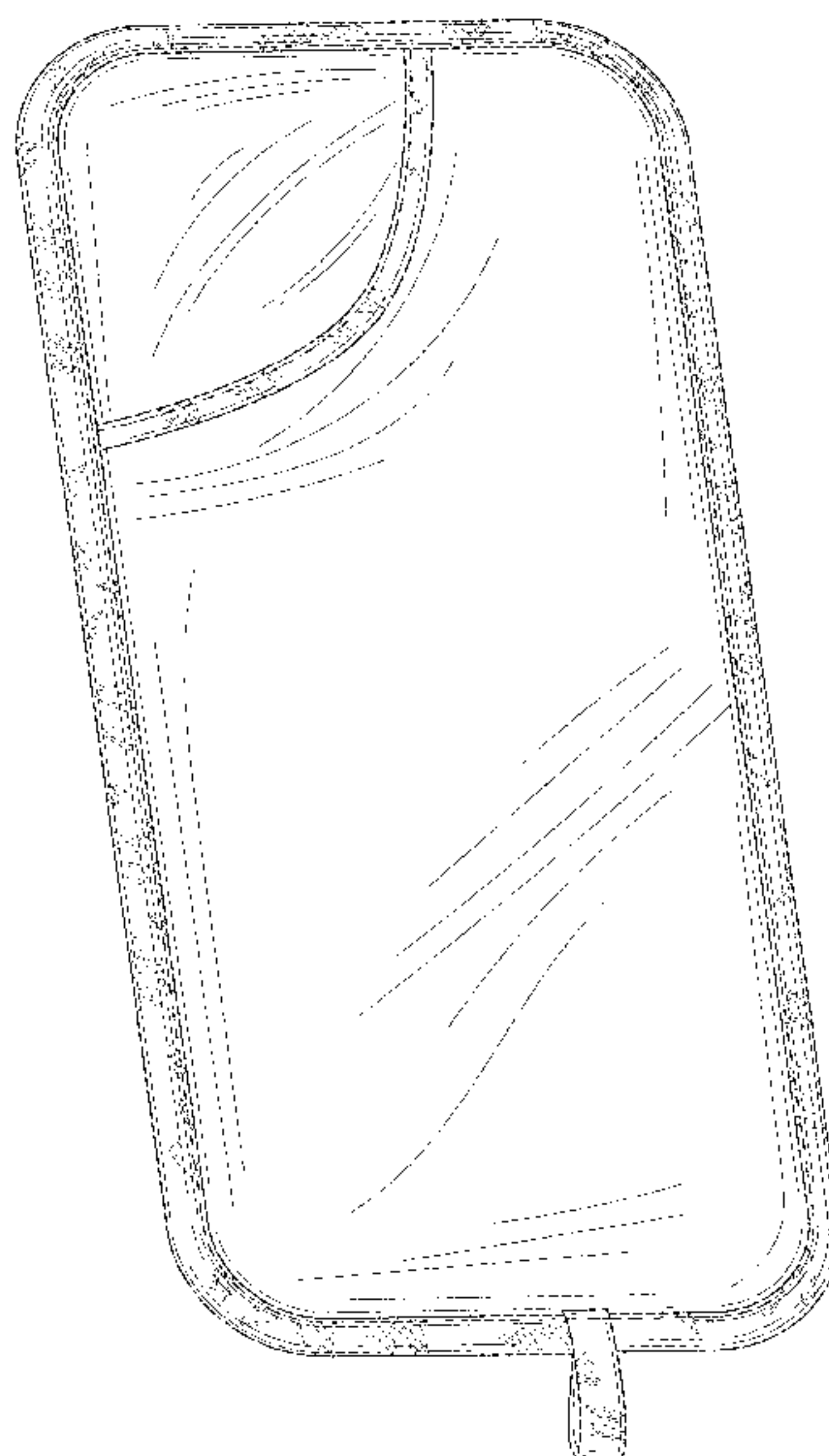
The ornamental design for a make-up removal towel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a make-up removal towel in accordance with my design;
FIG. 2 is a front elevational view of the make-up removal towel of FIG. 1;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a side elevational view thereof taken from the left side of FIG. 1; and
FIG. 5 is a side elevational view thereof taken from the right side of FIG. 1;
FIG. 6 is a top plan view thereof; and,

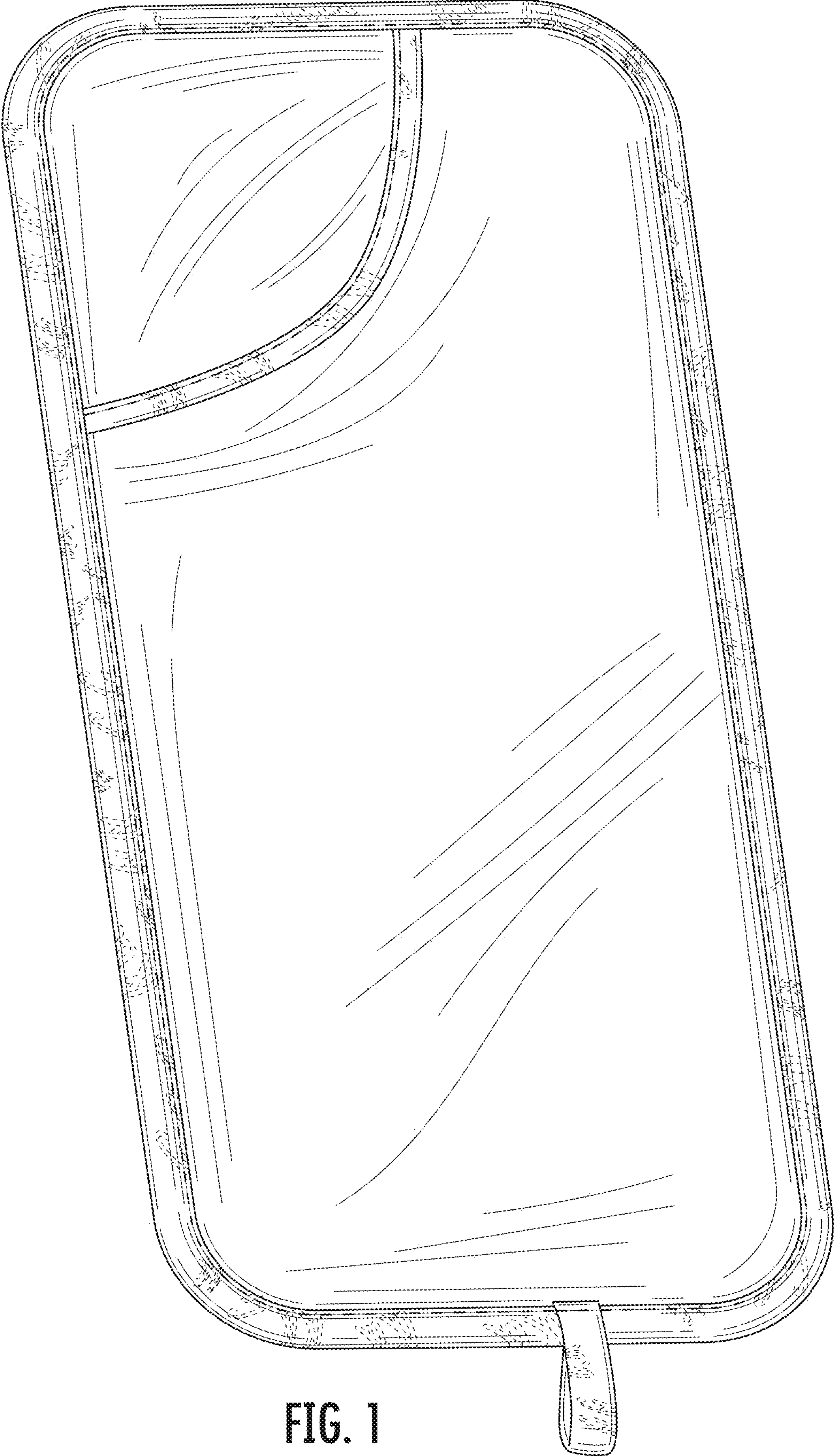

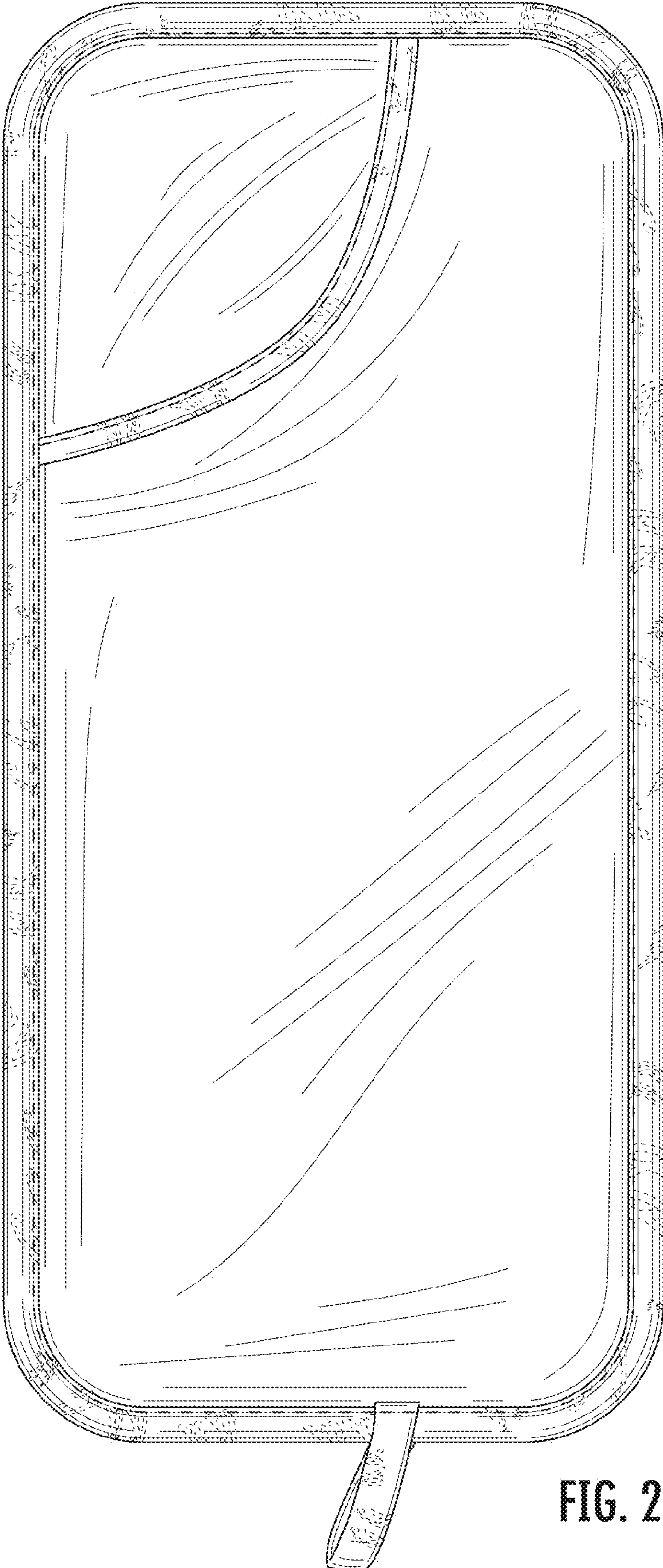

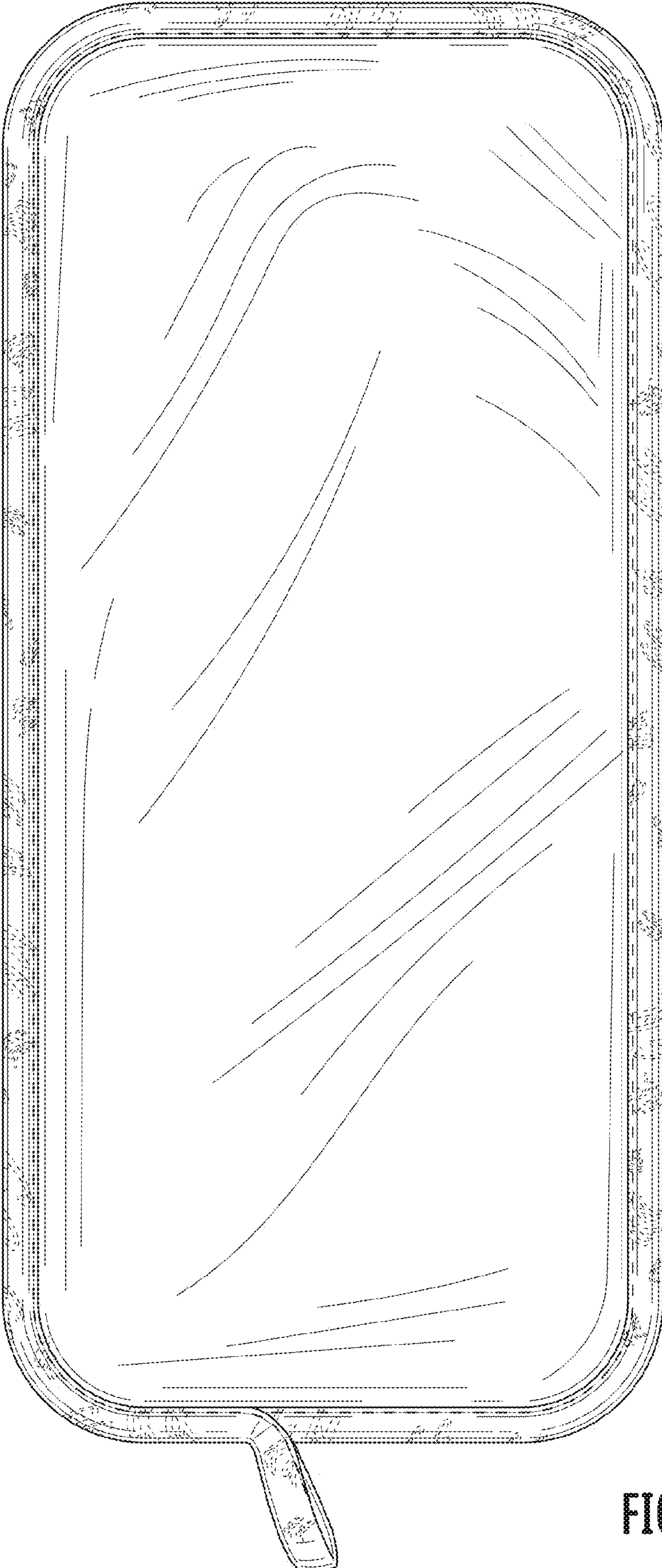

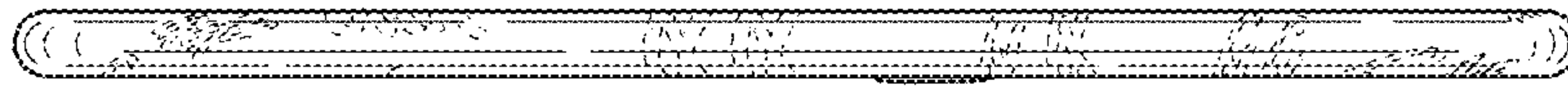
