The ornamental design for a litter box, as shown and described.

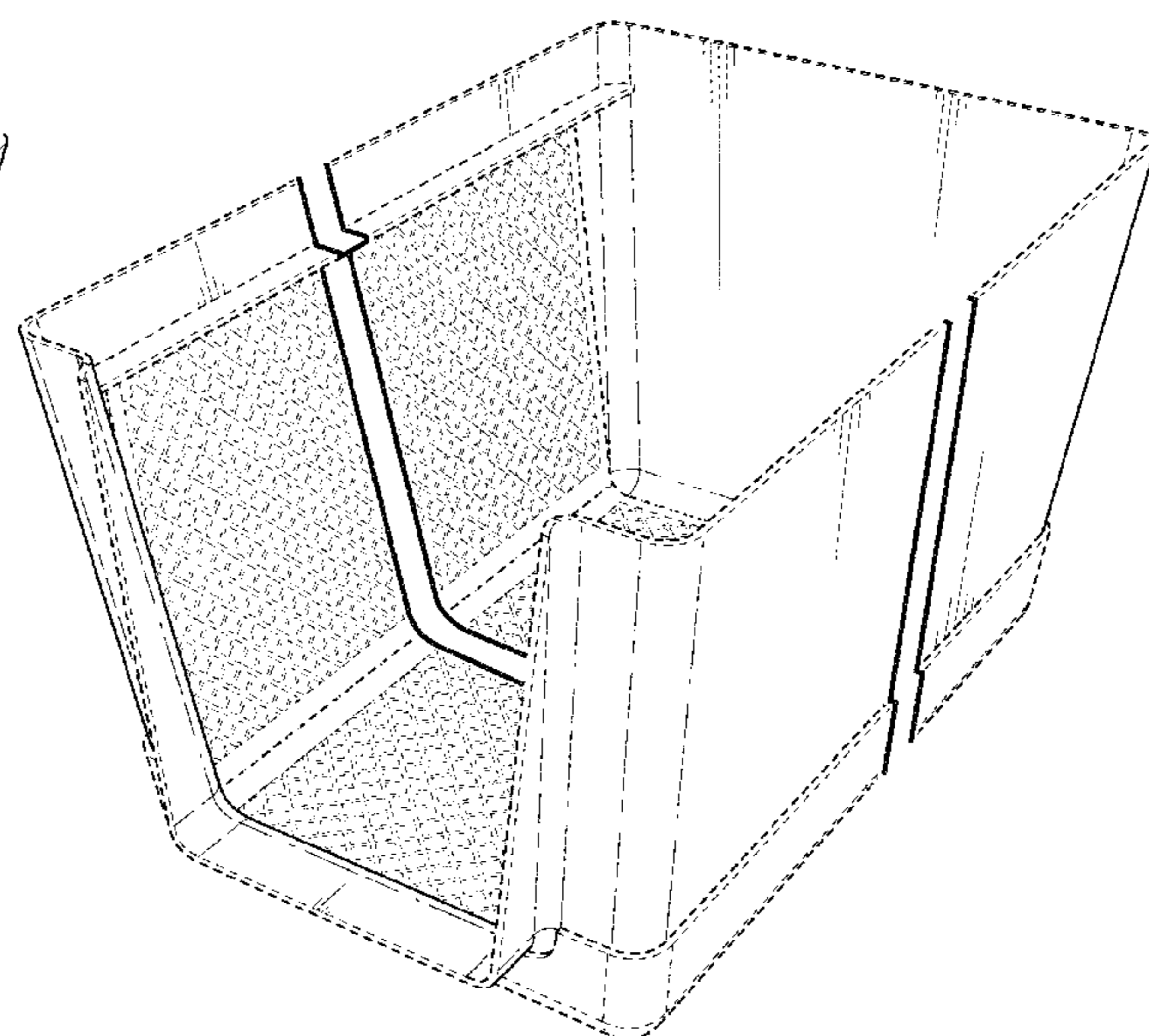
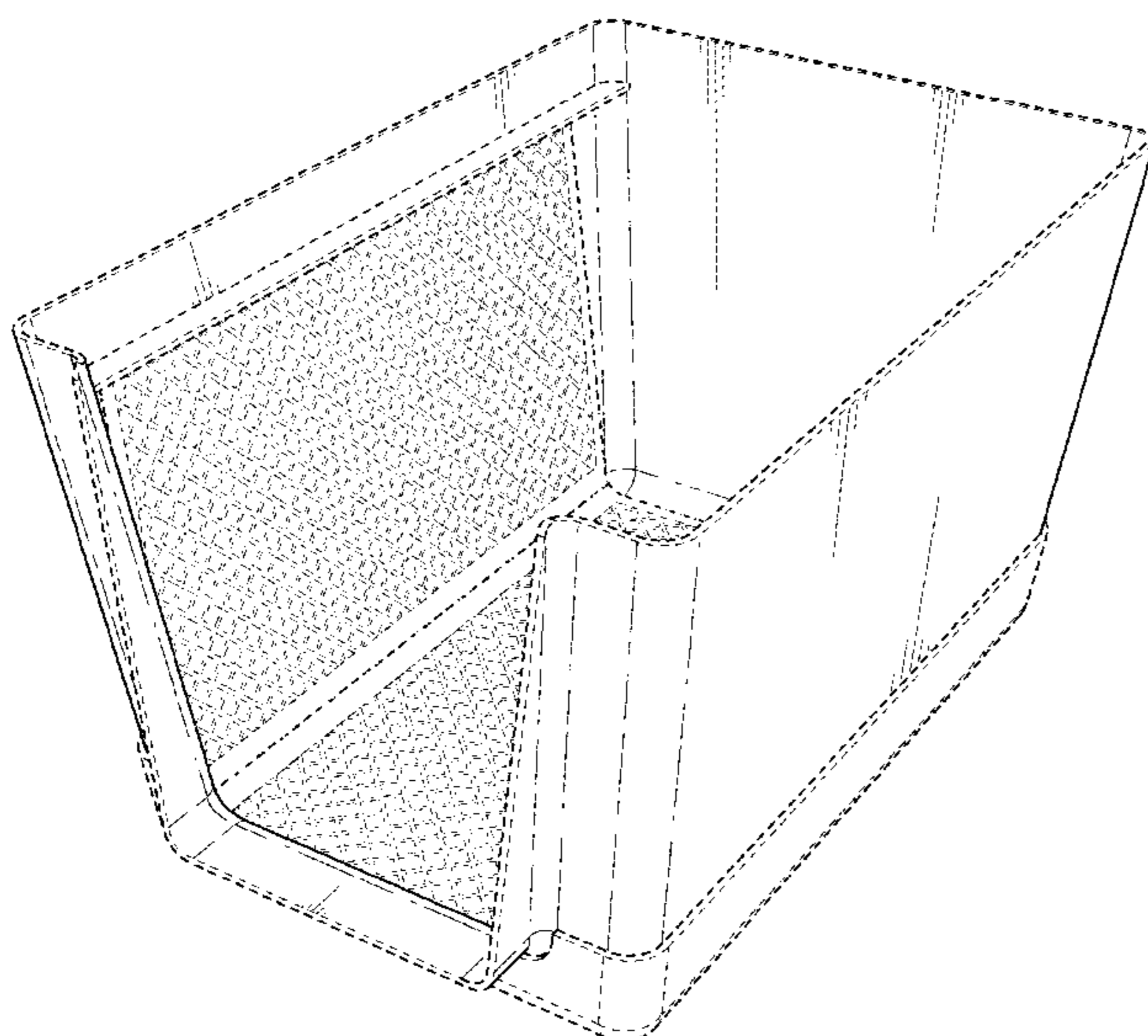
DESCRIPTION

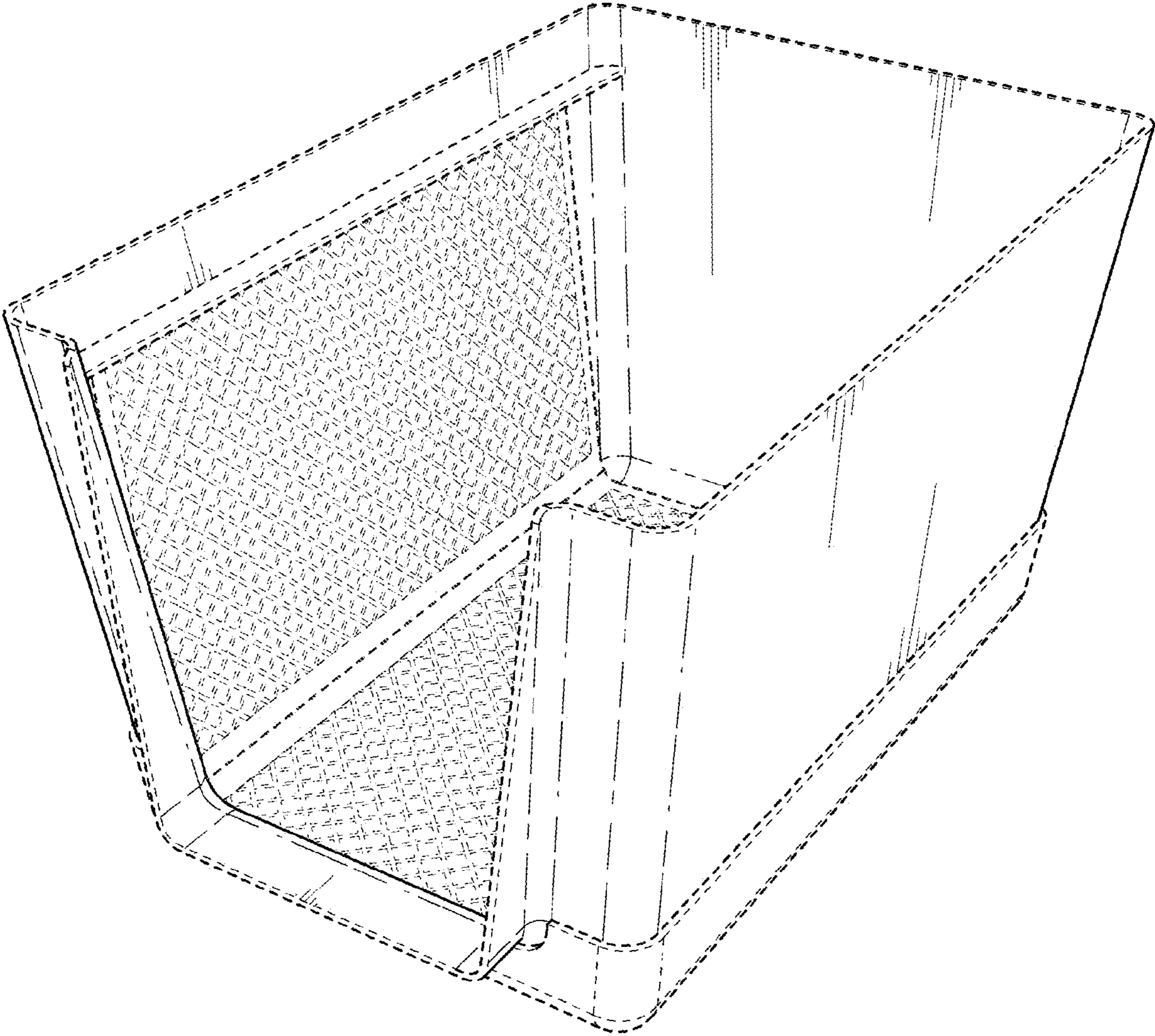

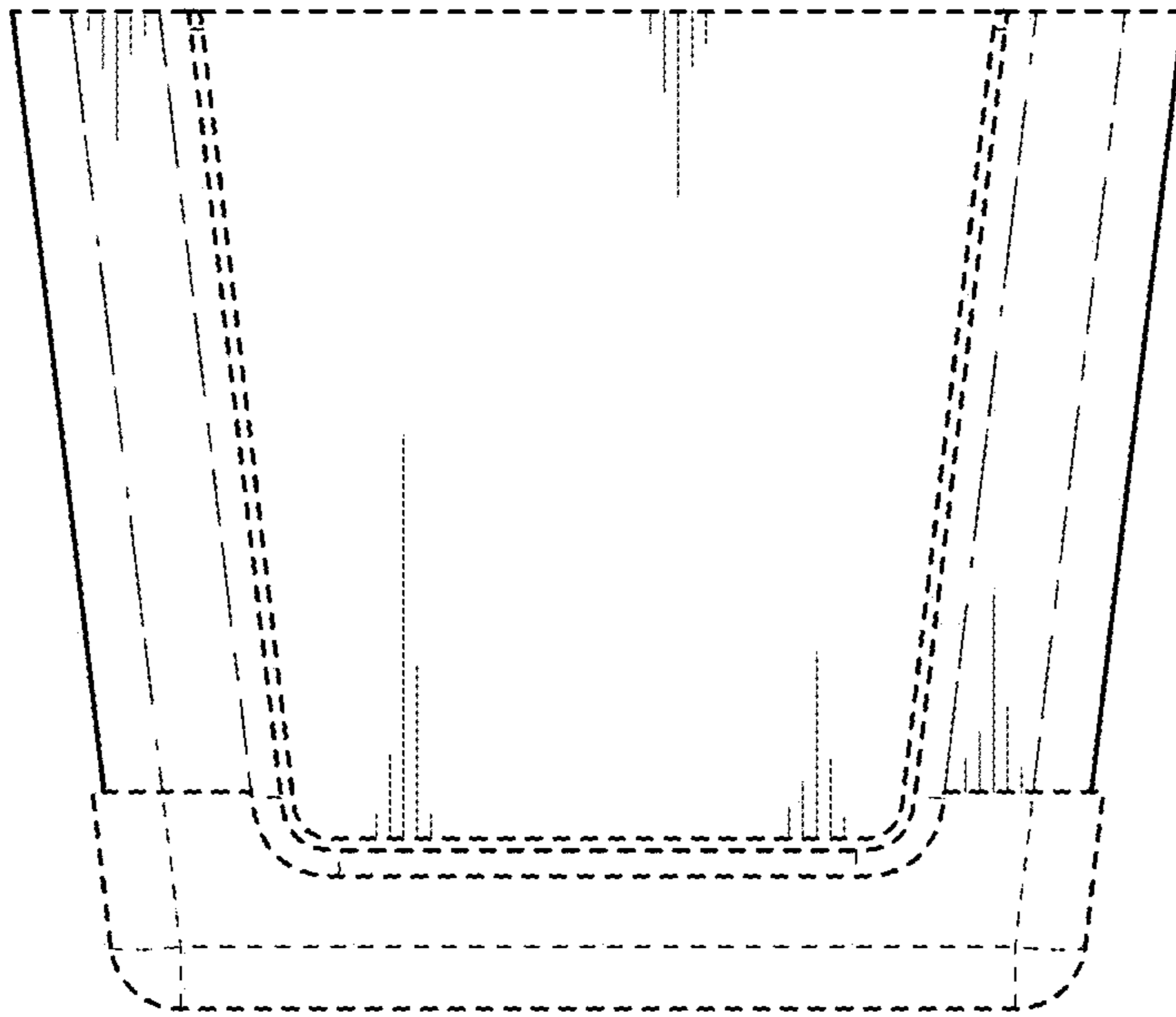

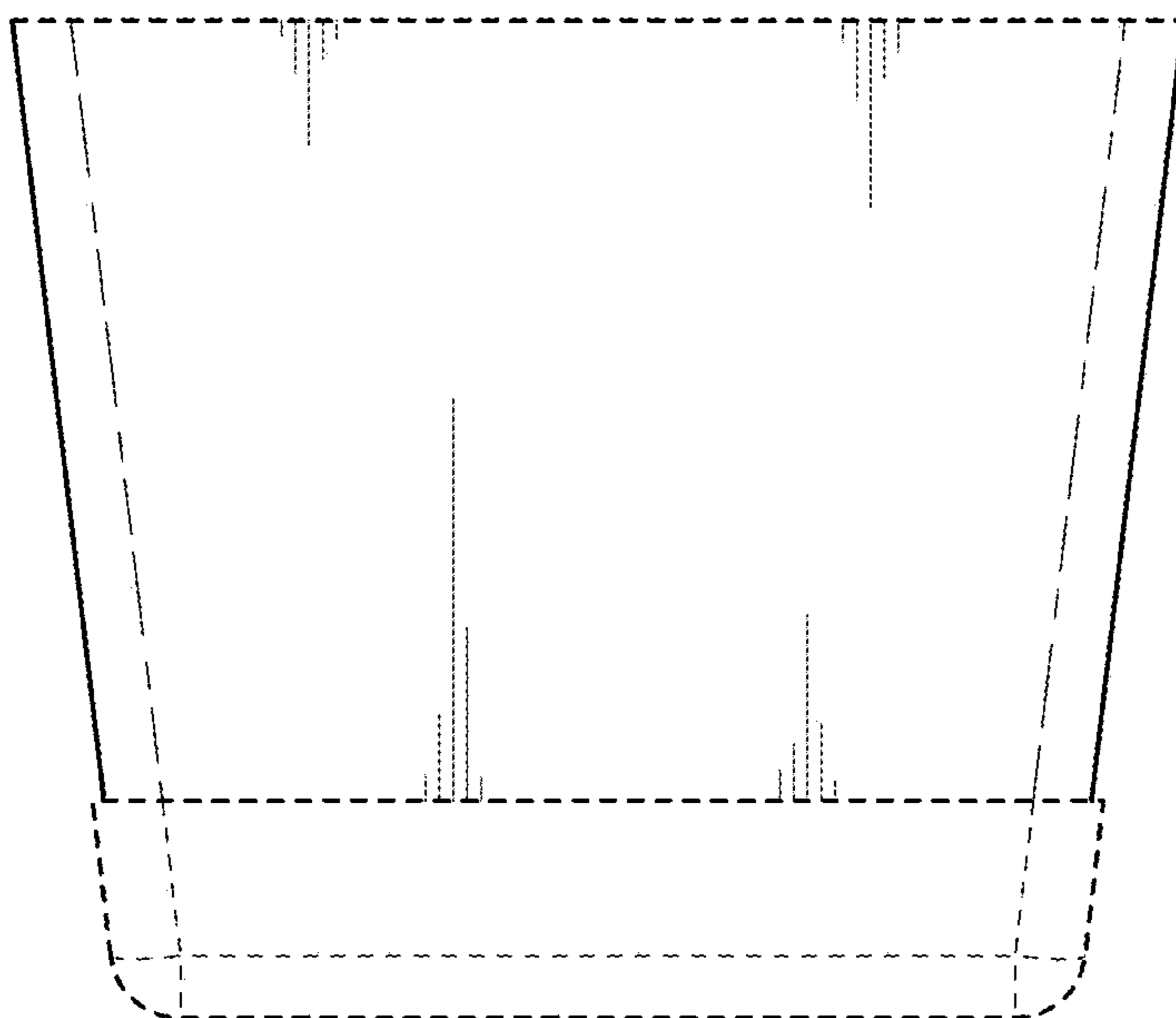

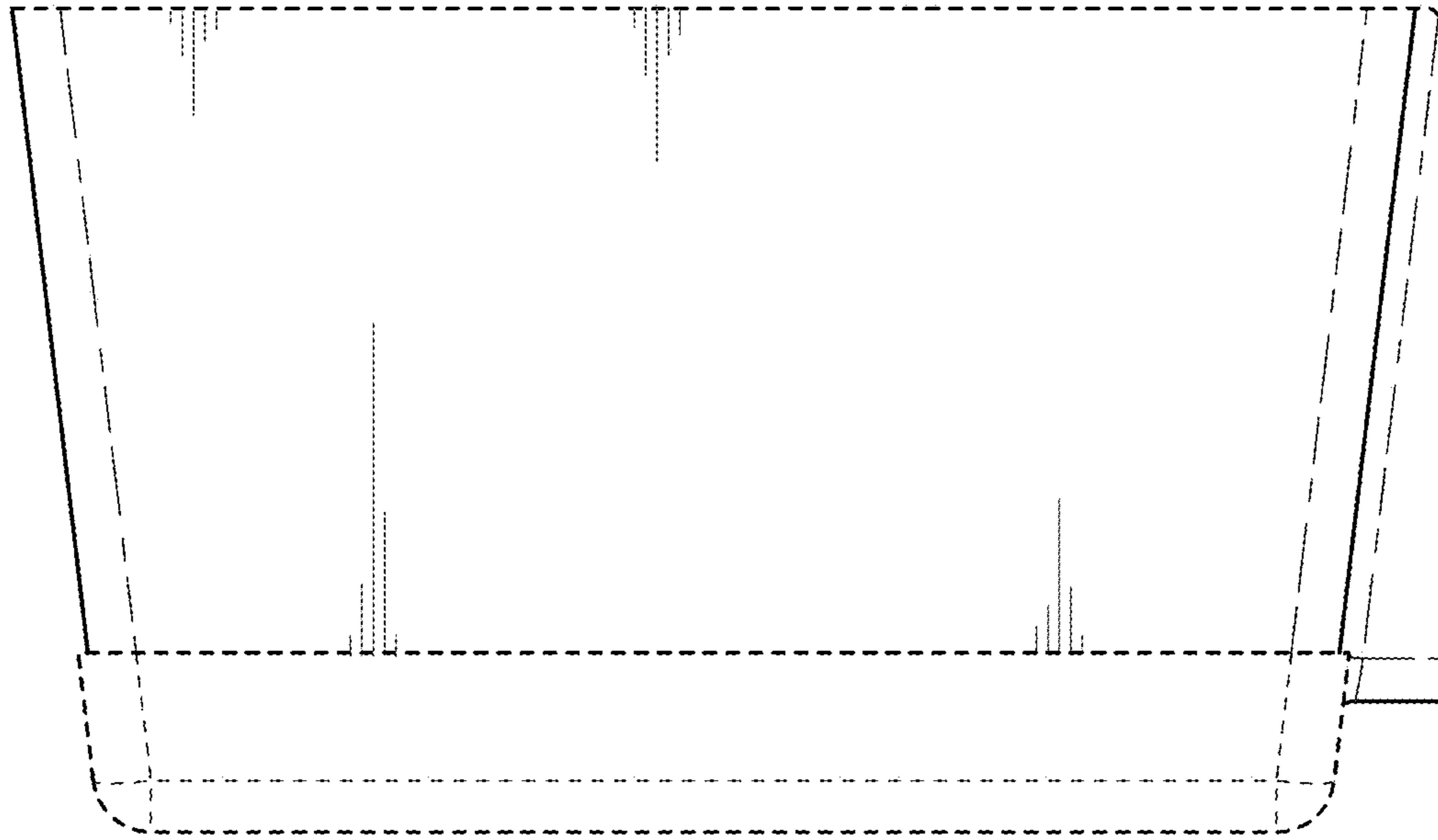

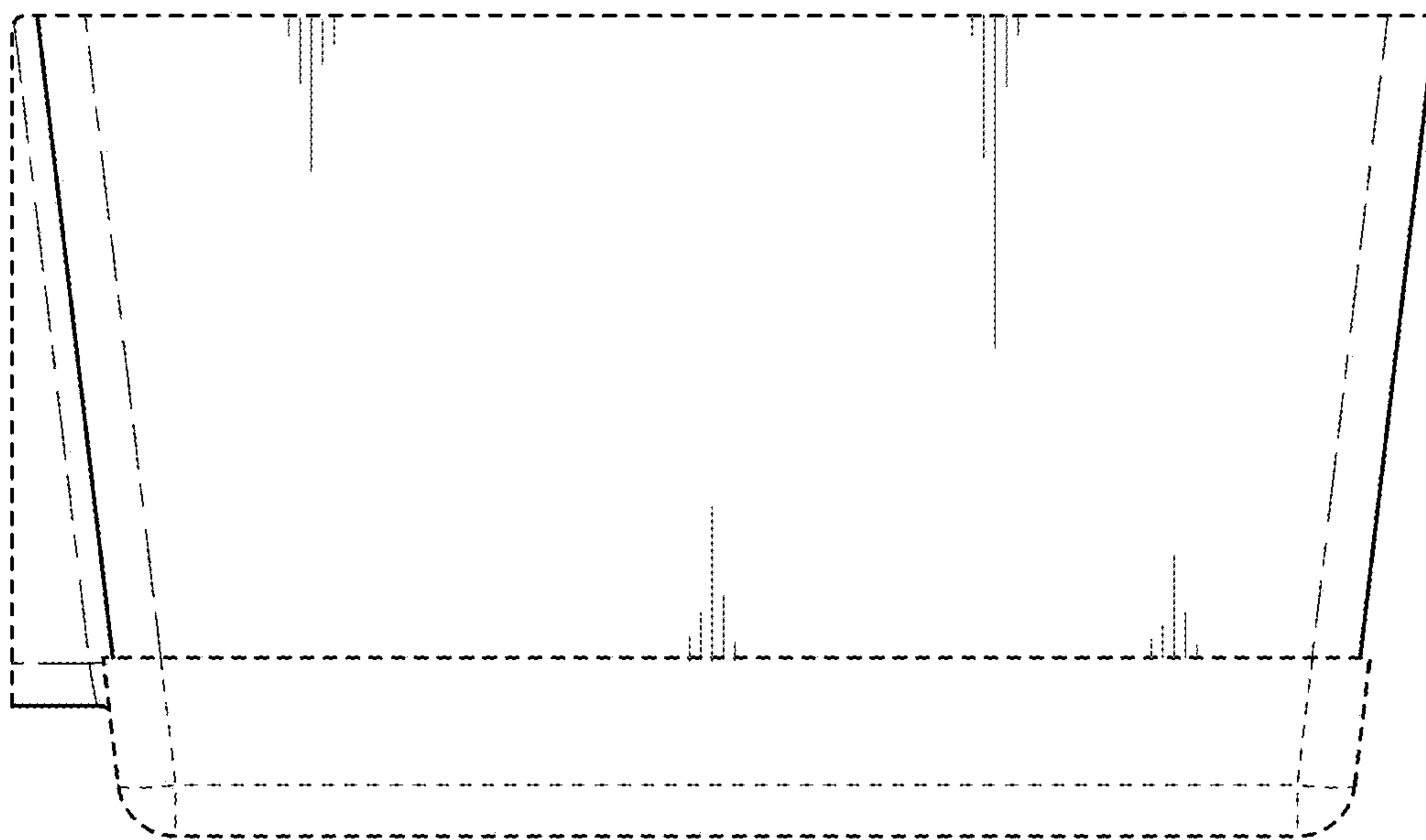

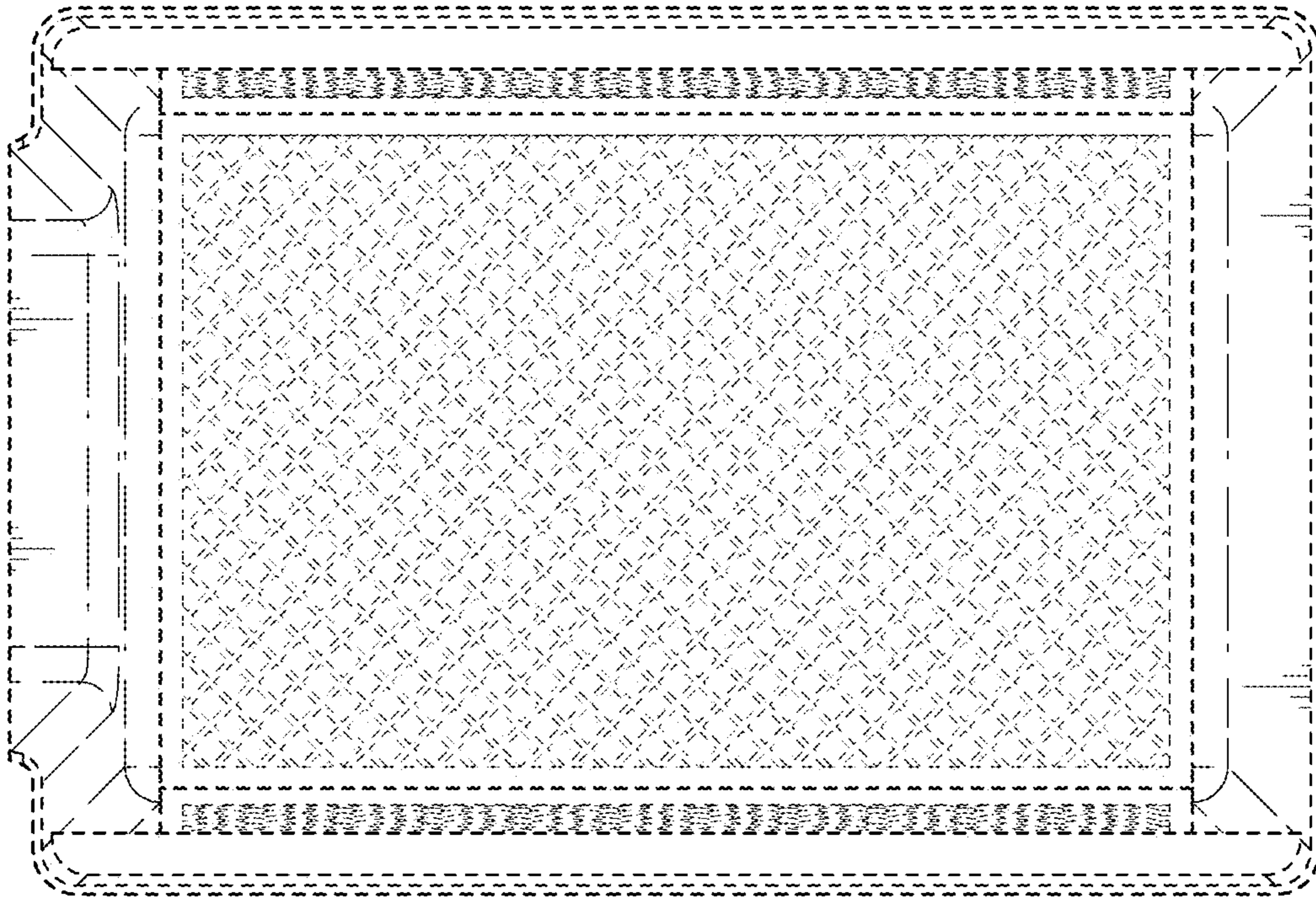

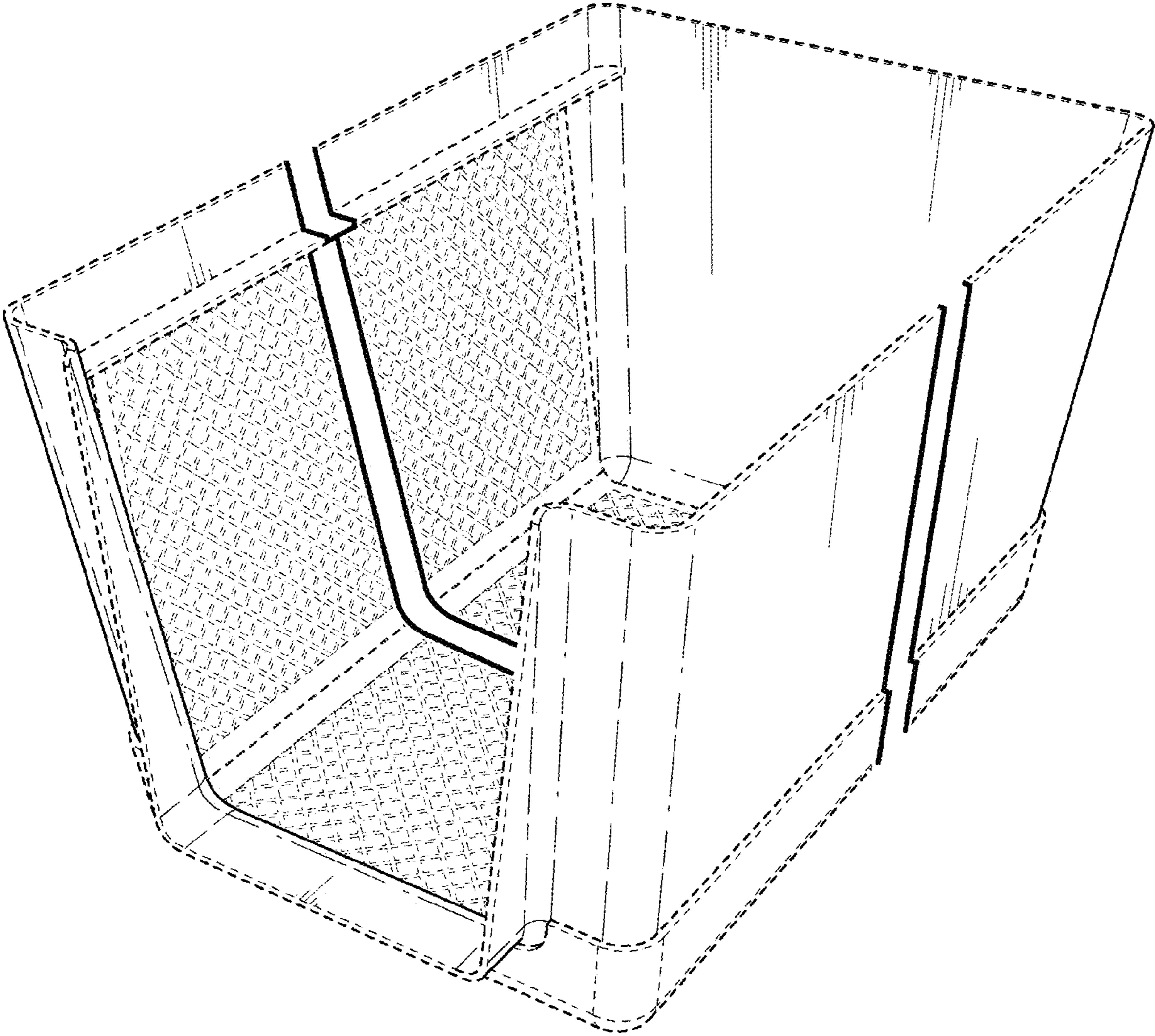

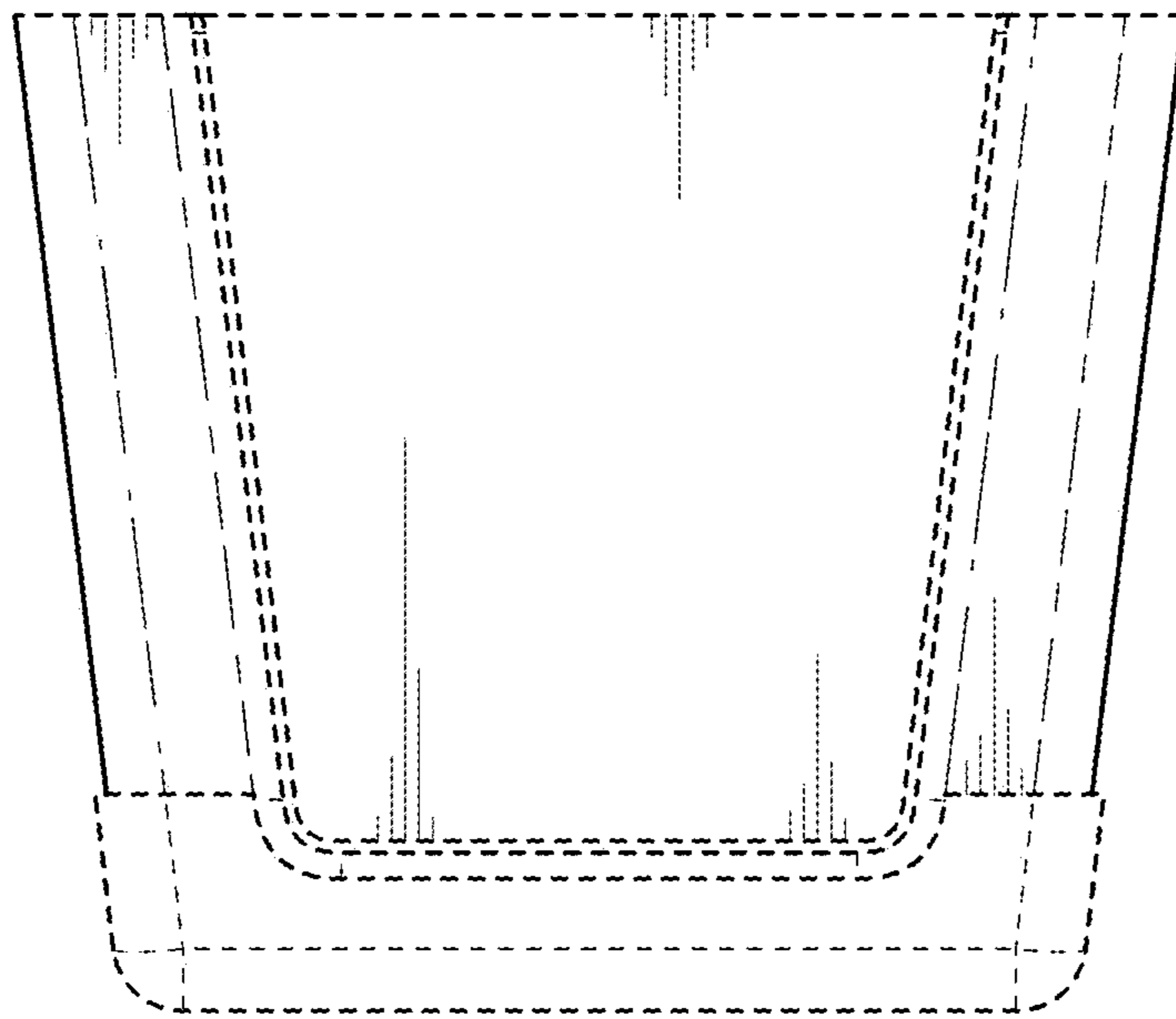

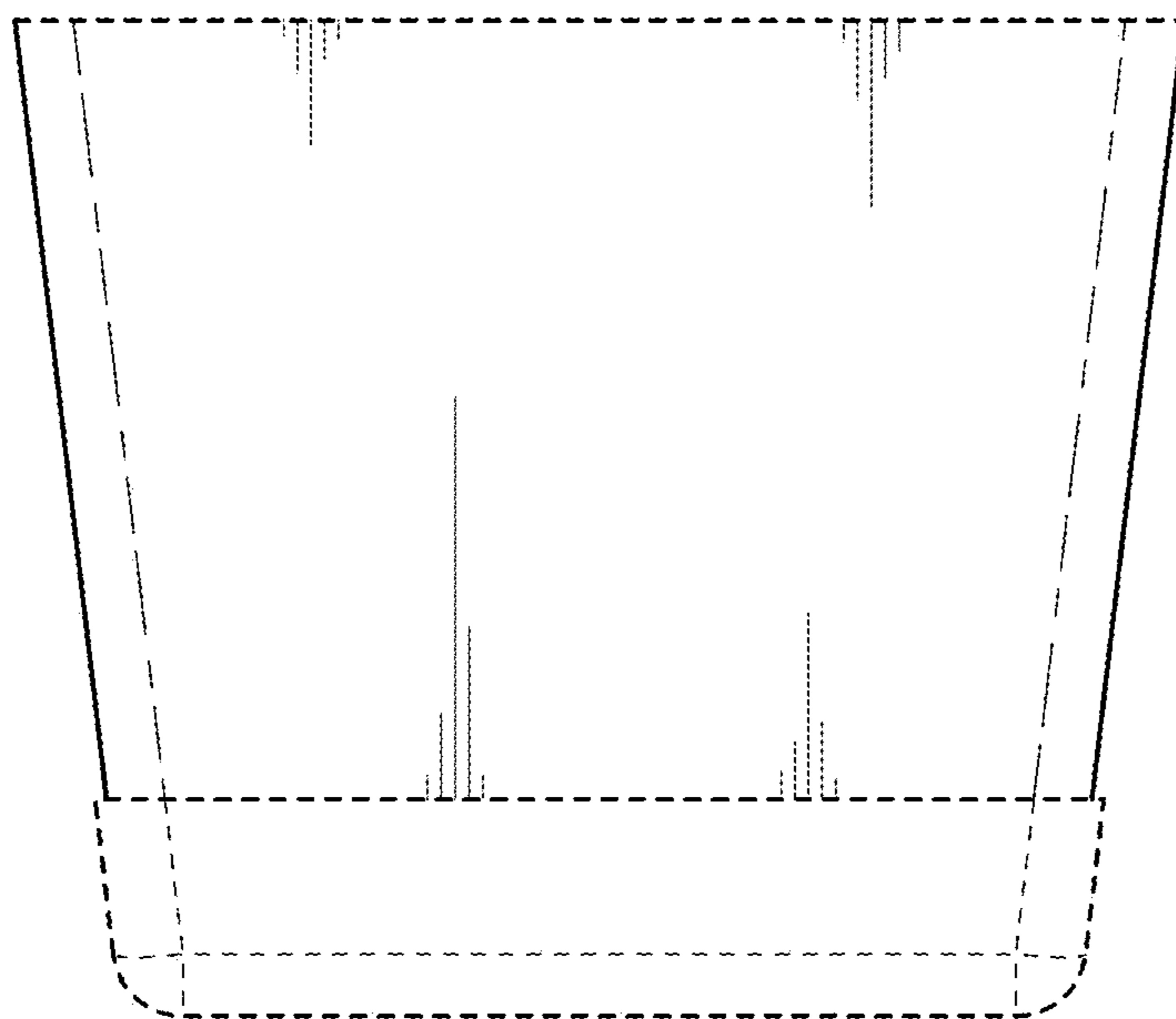

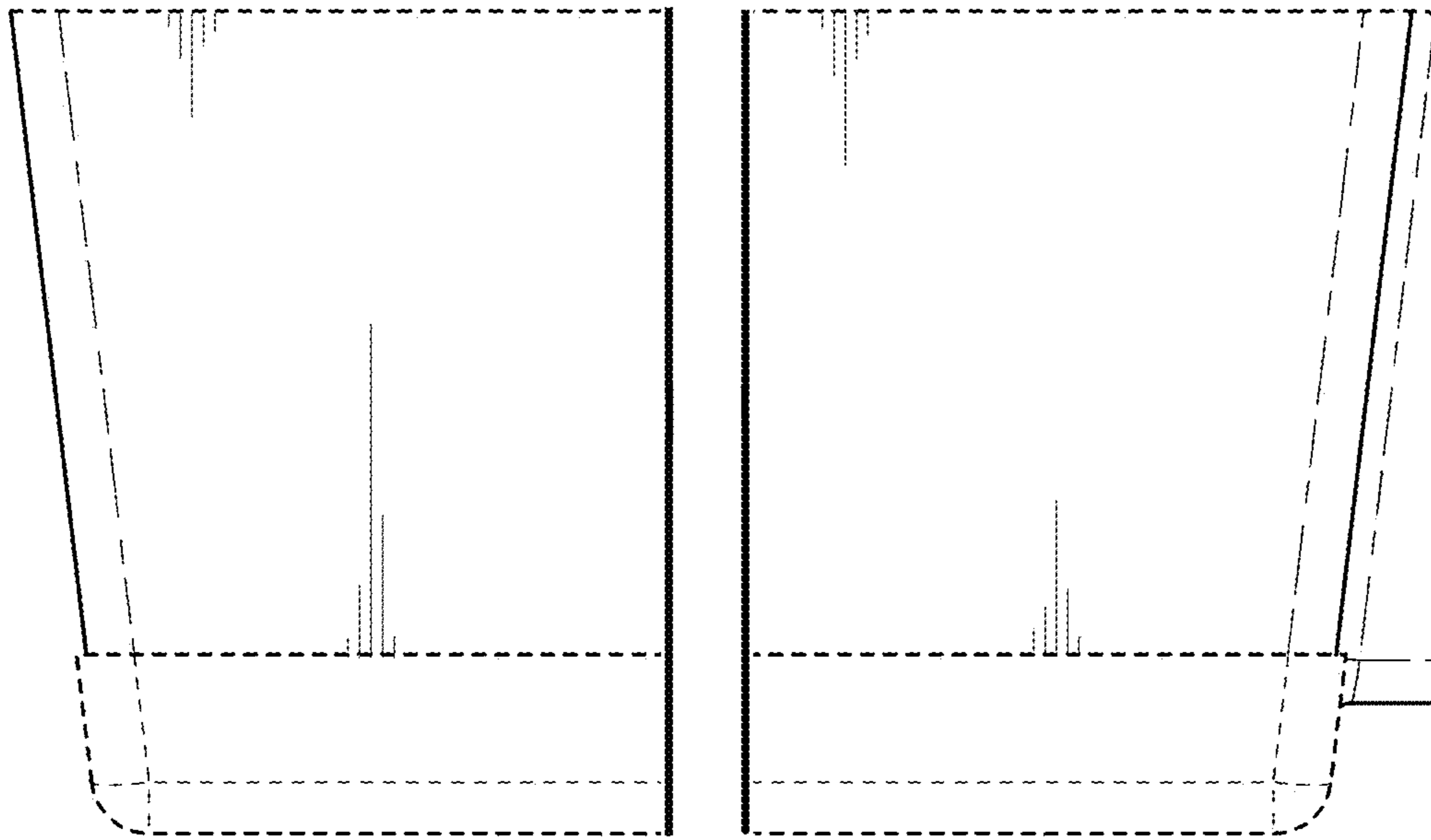

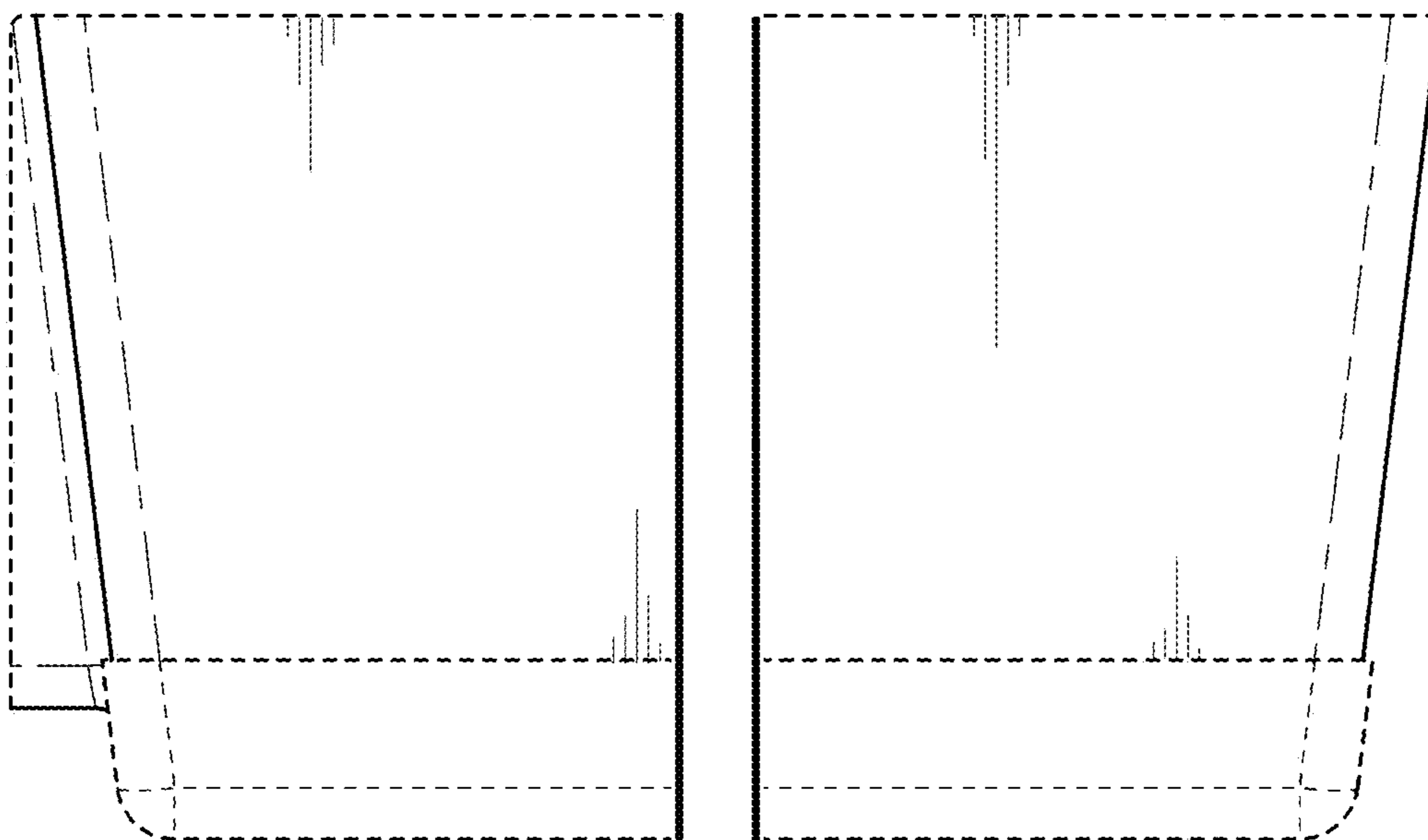

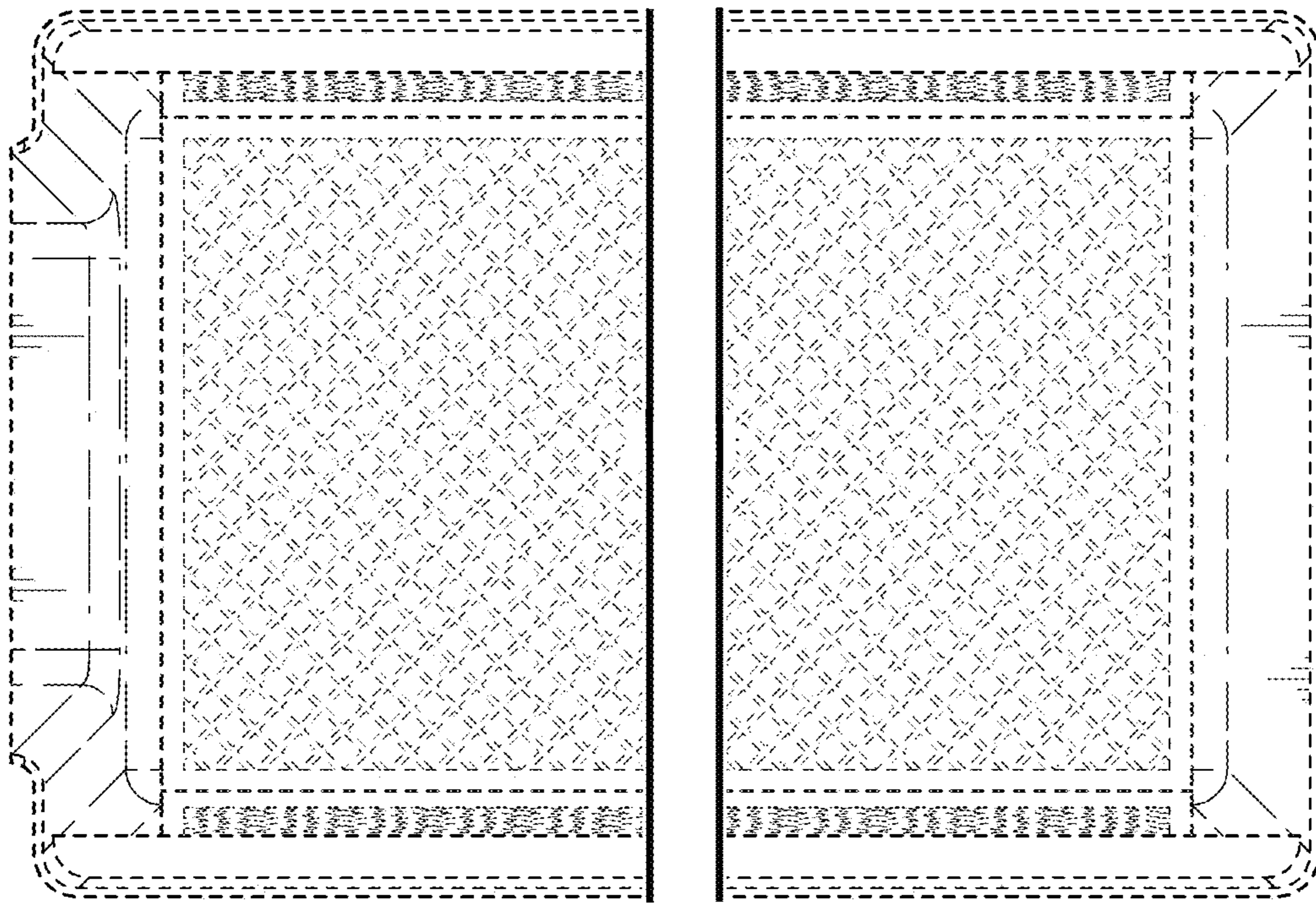

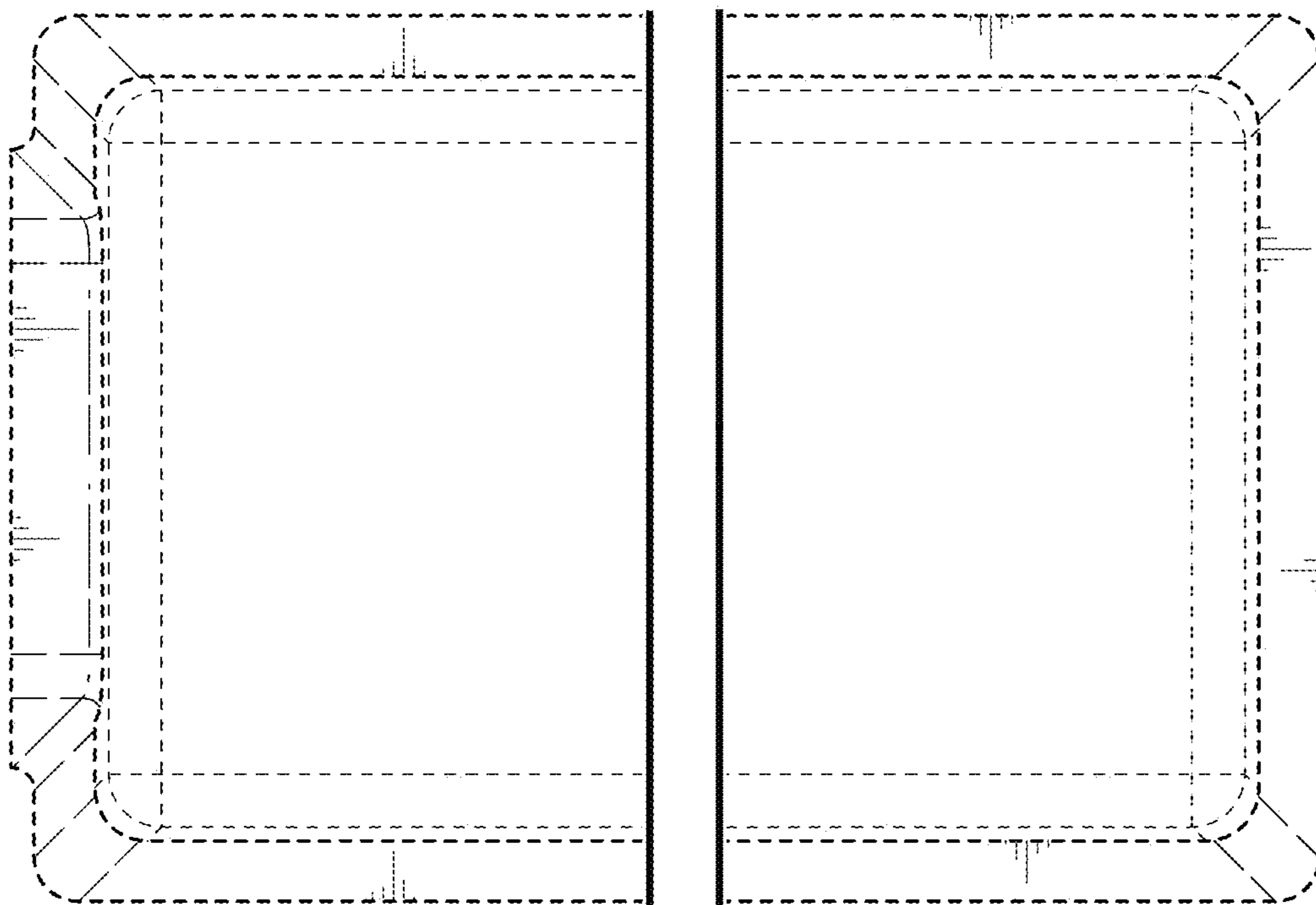

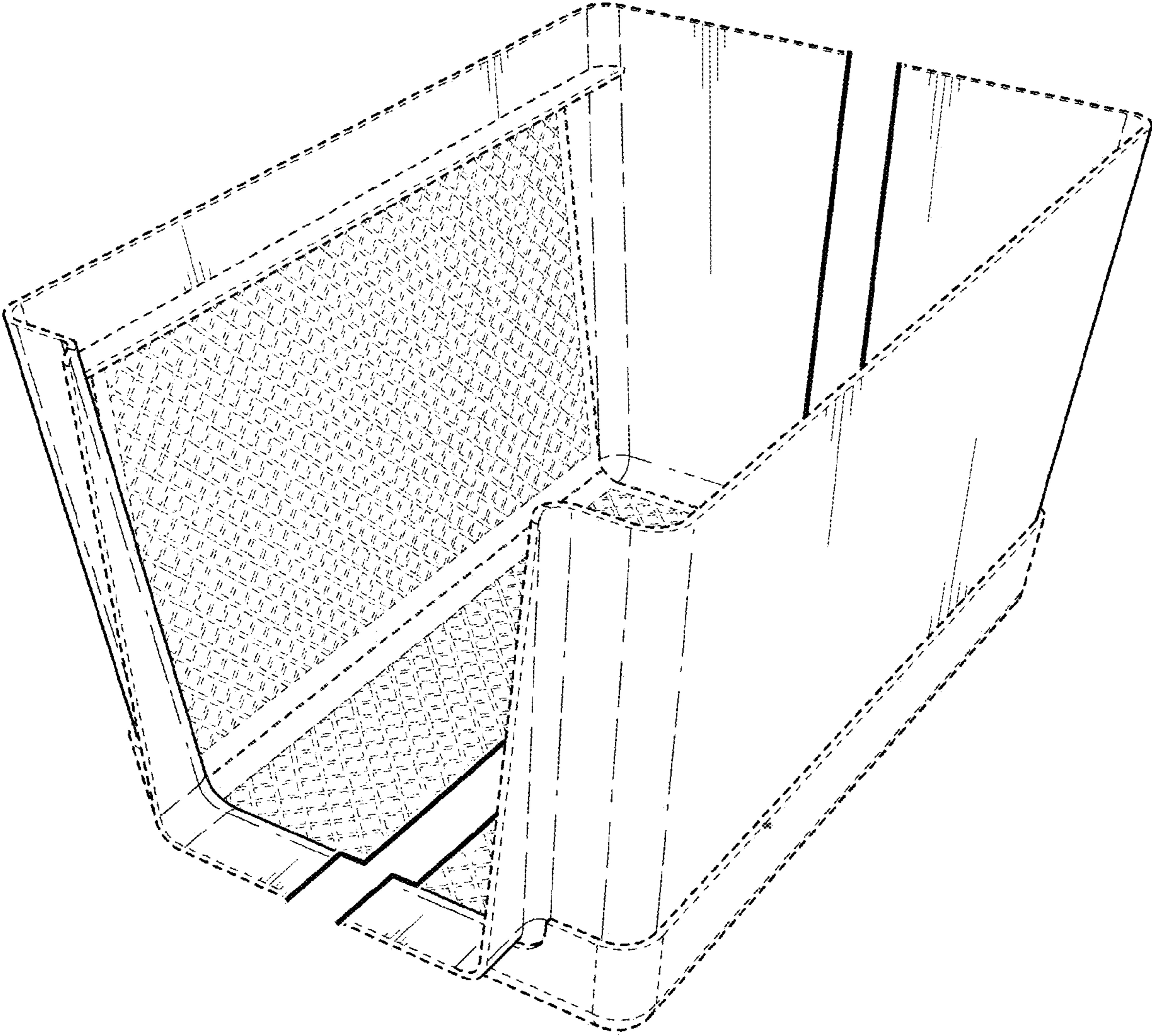

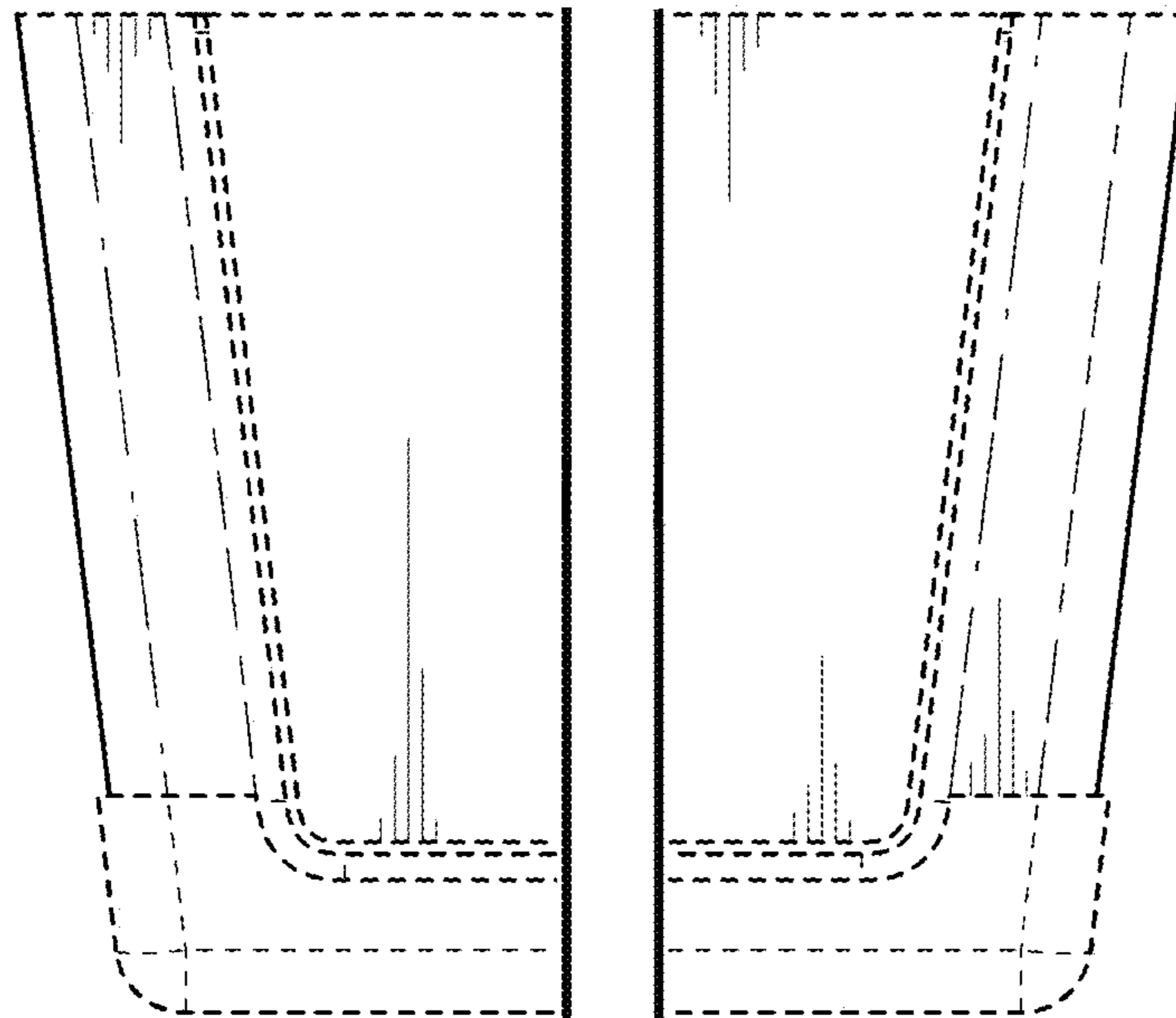

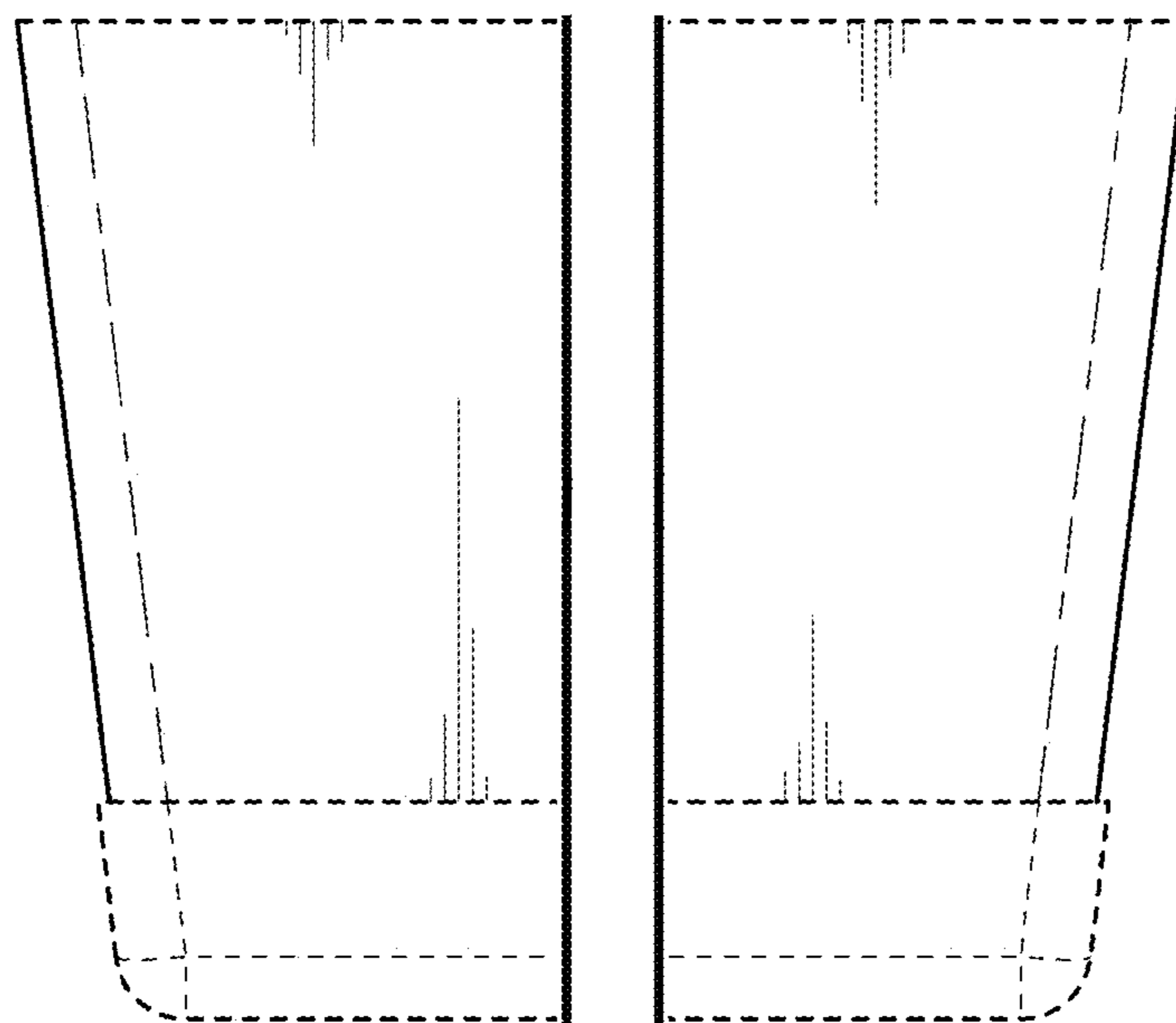

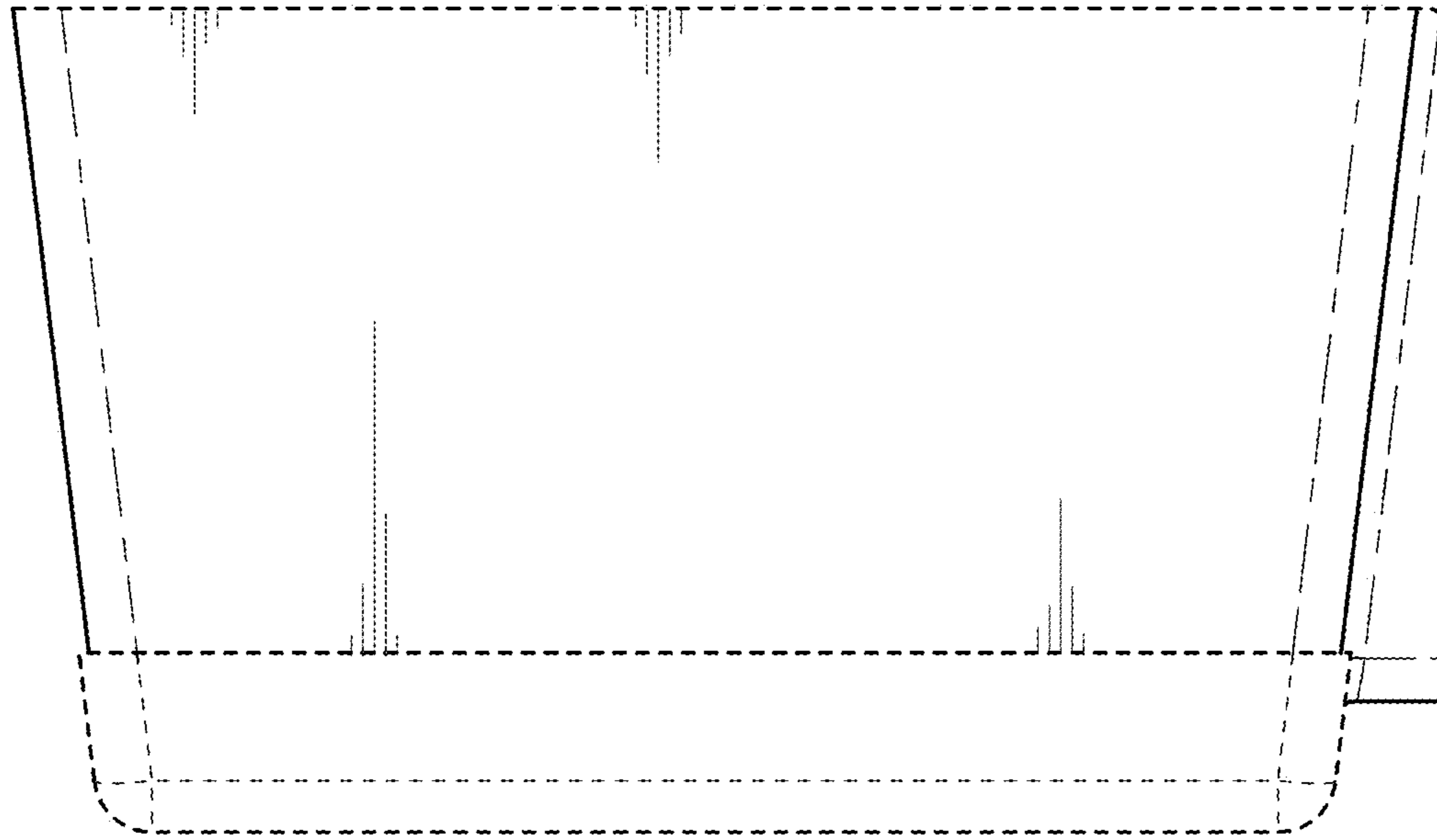

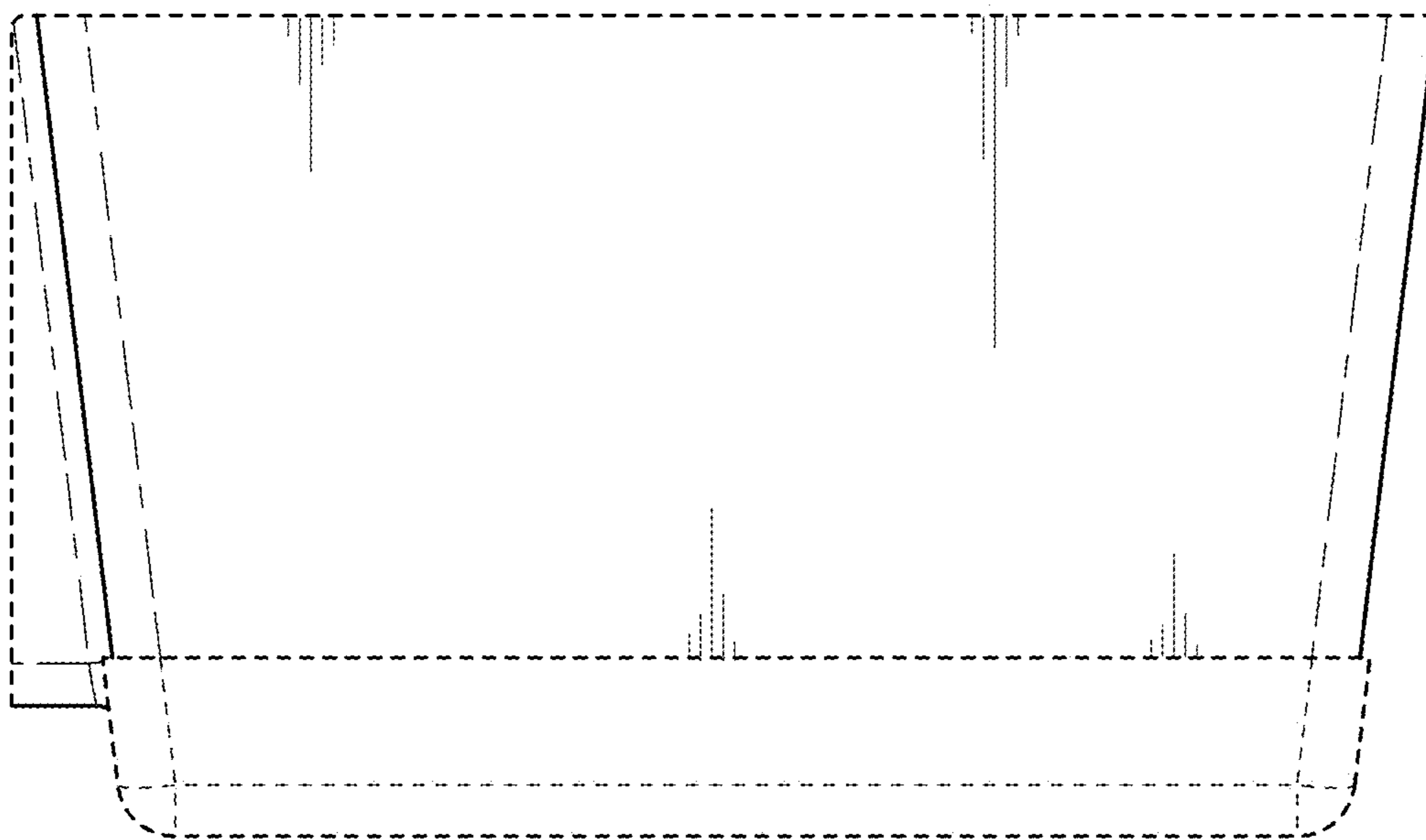

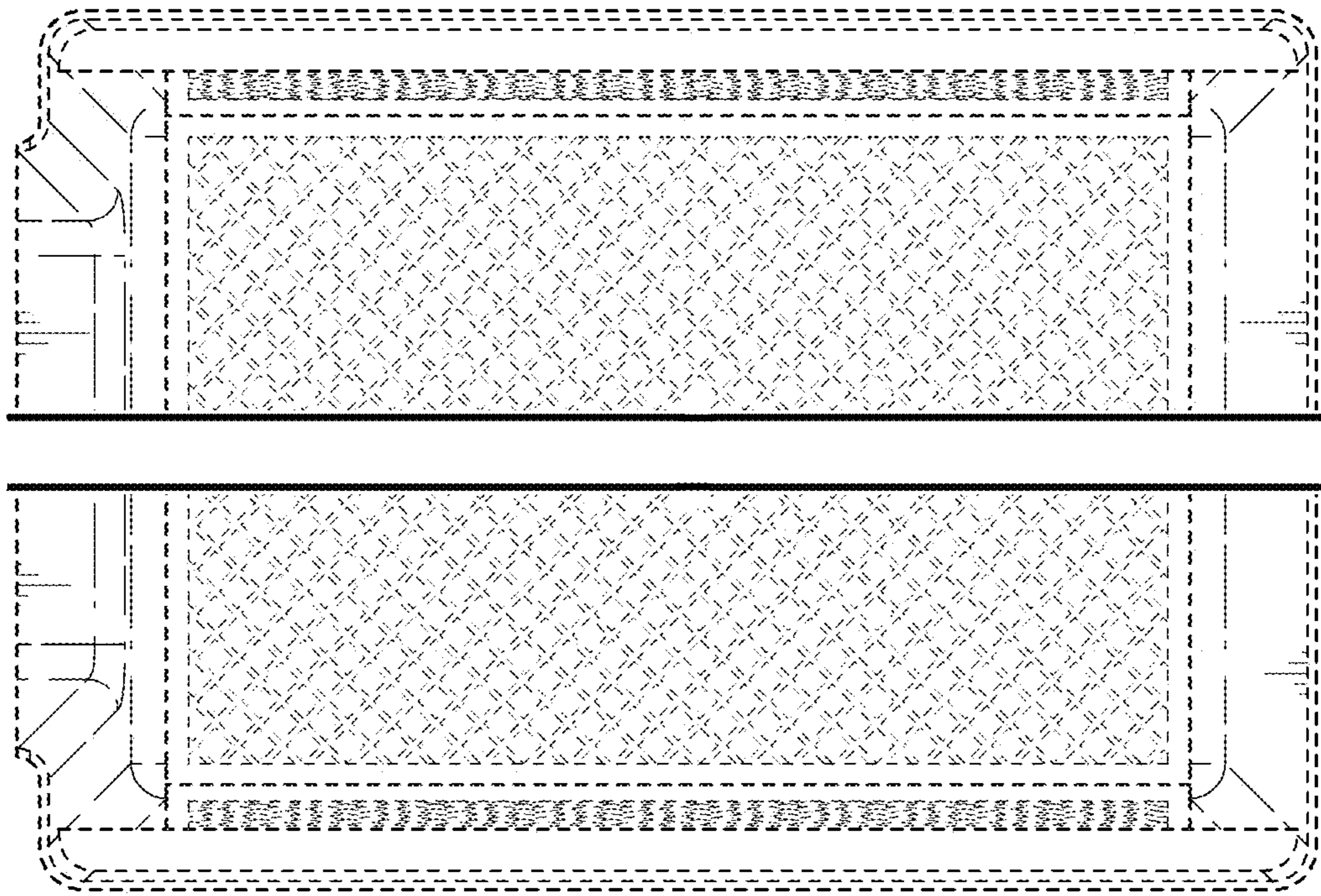

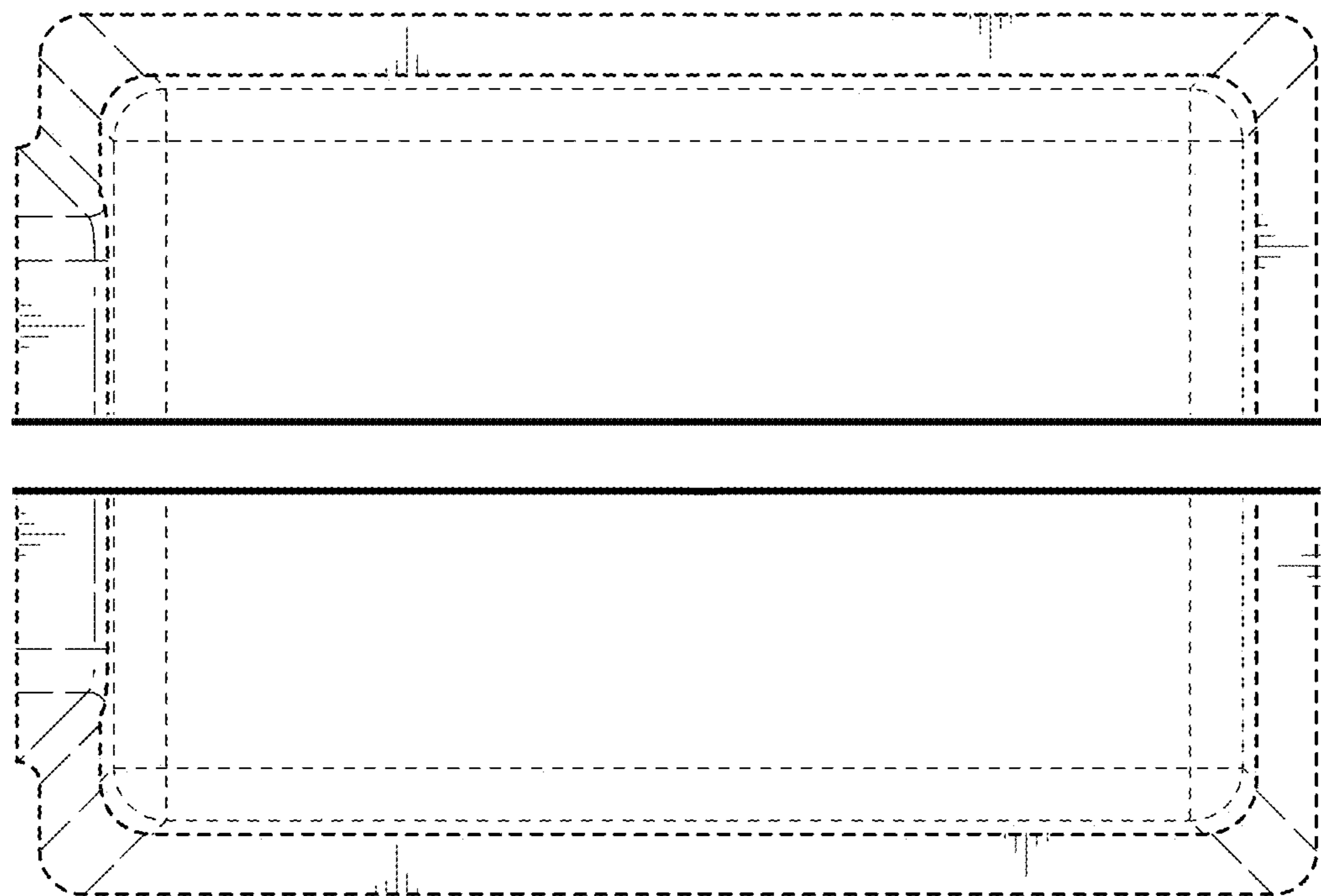

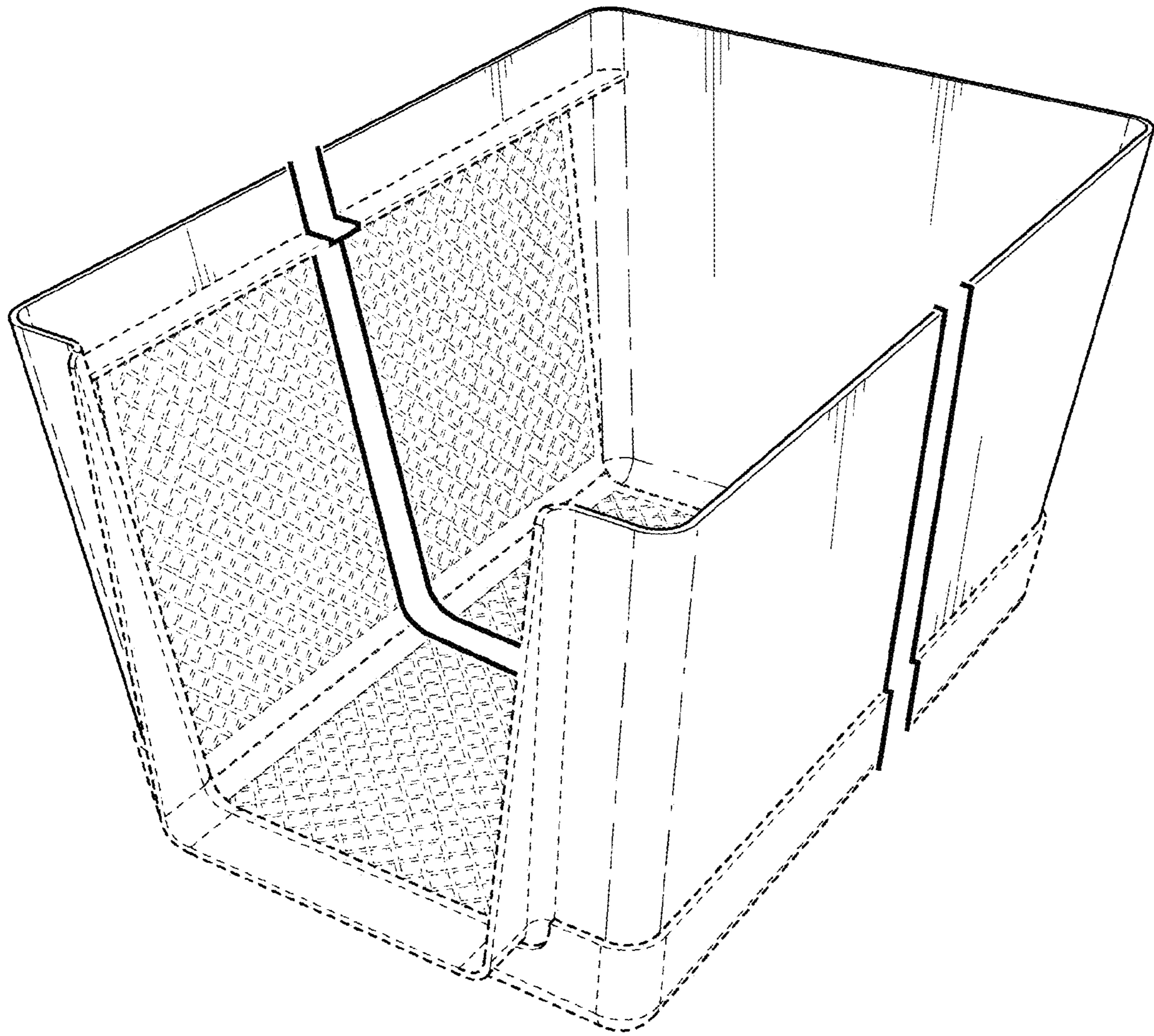

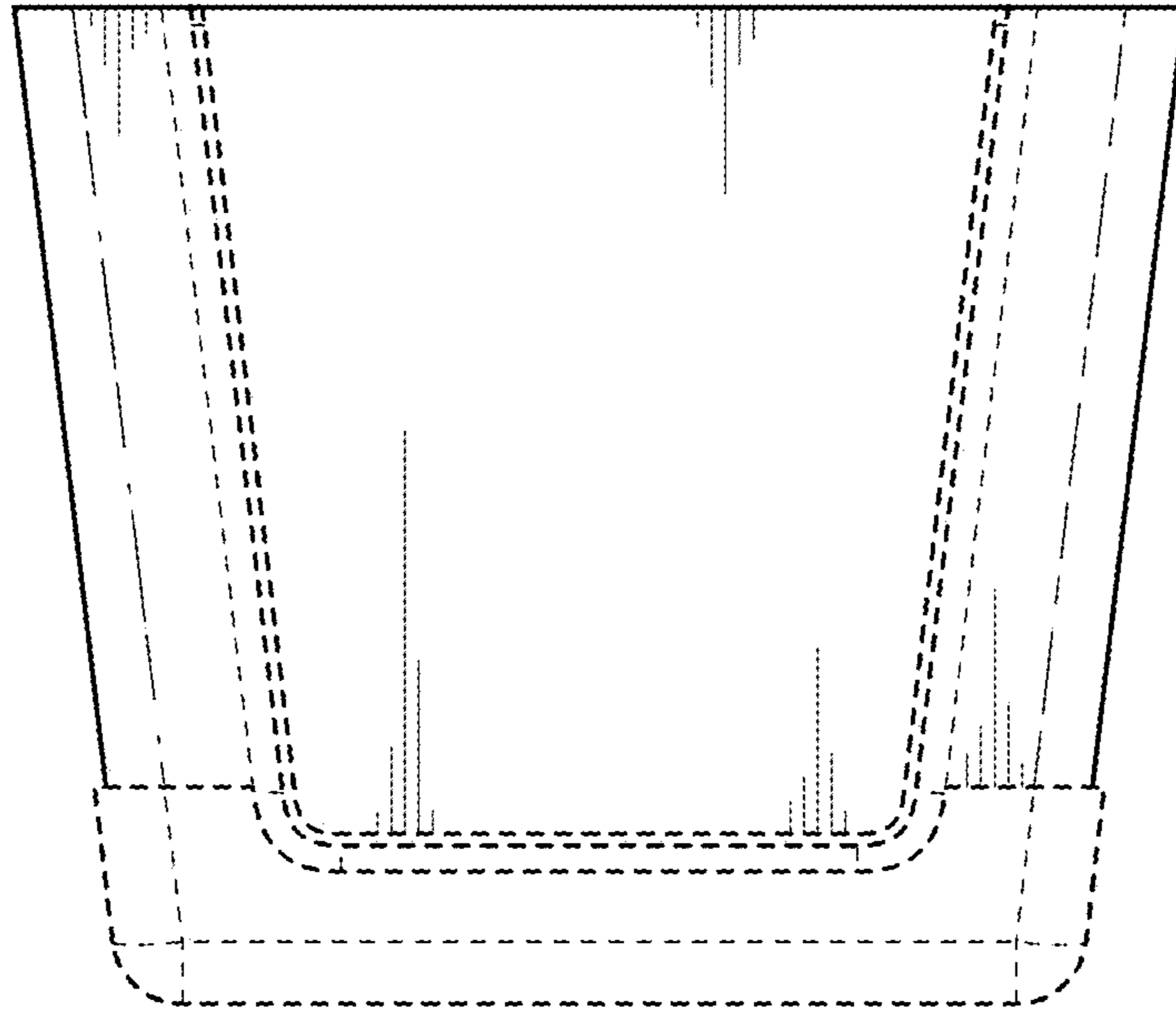

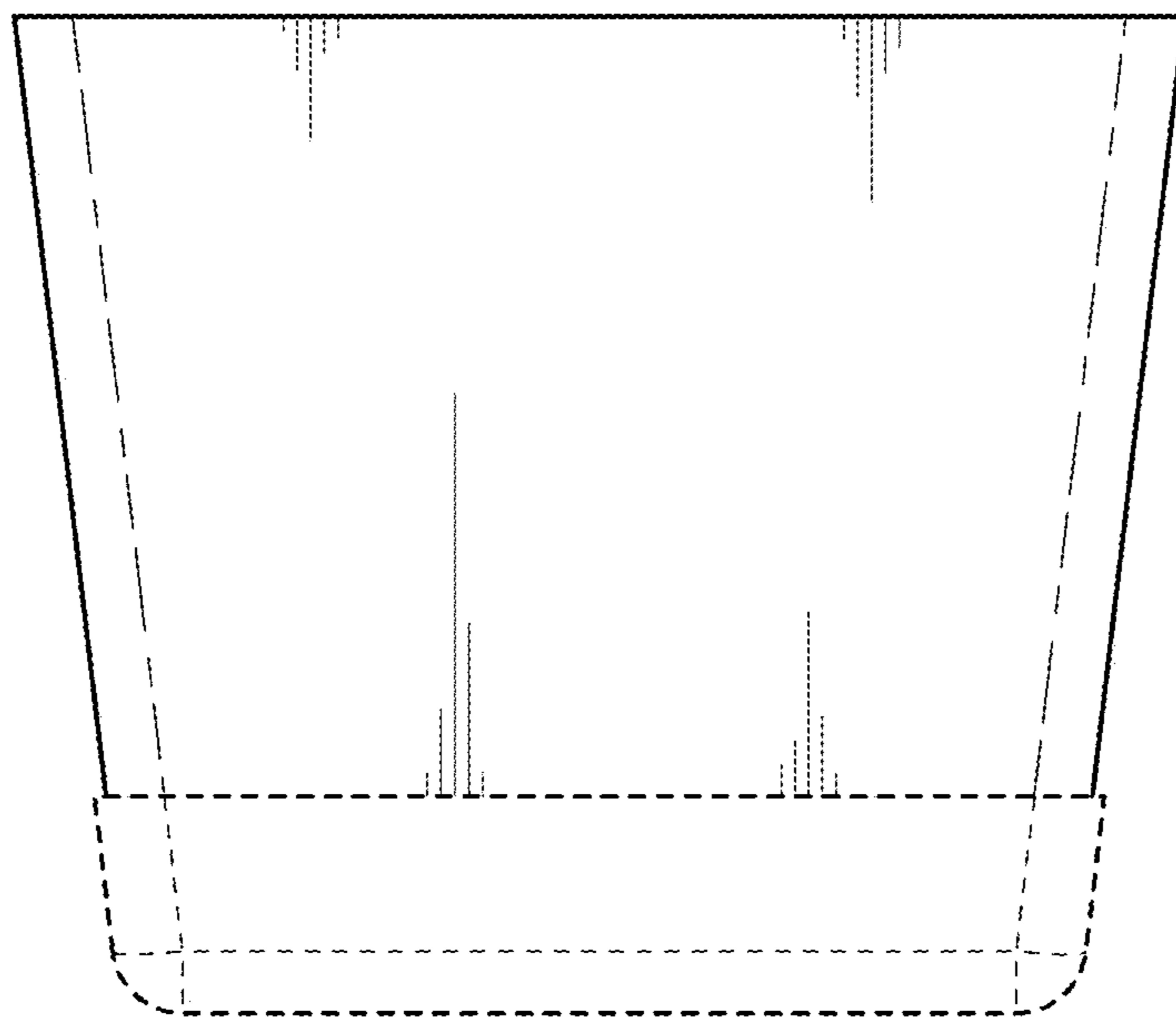

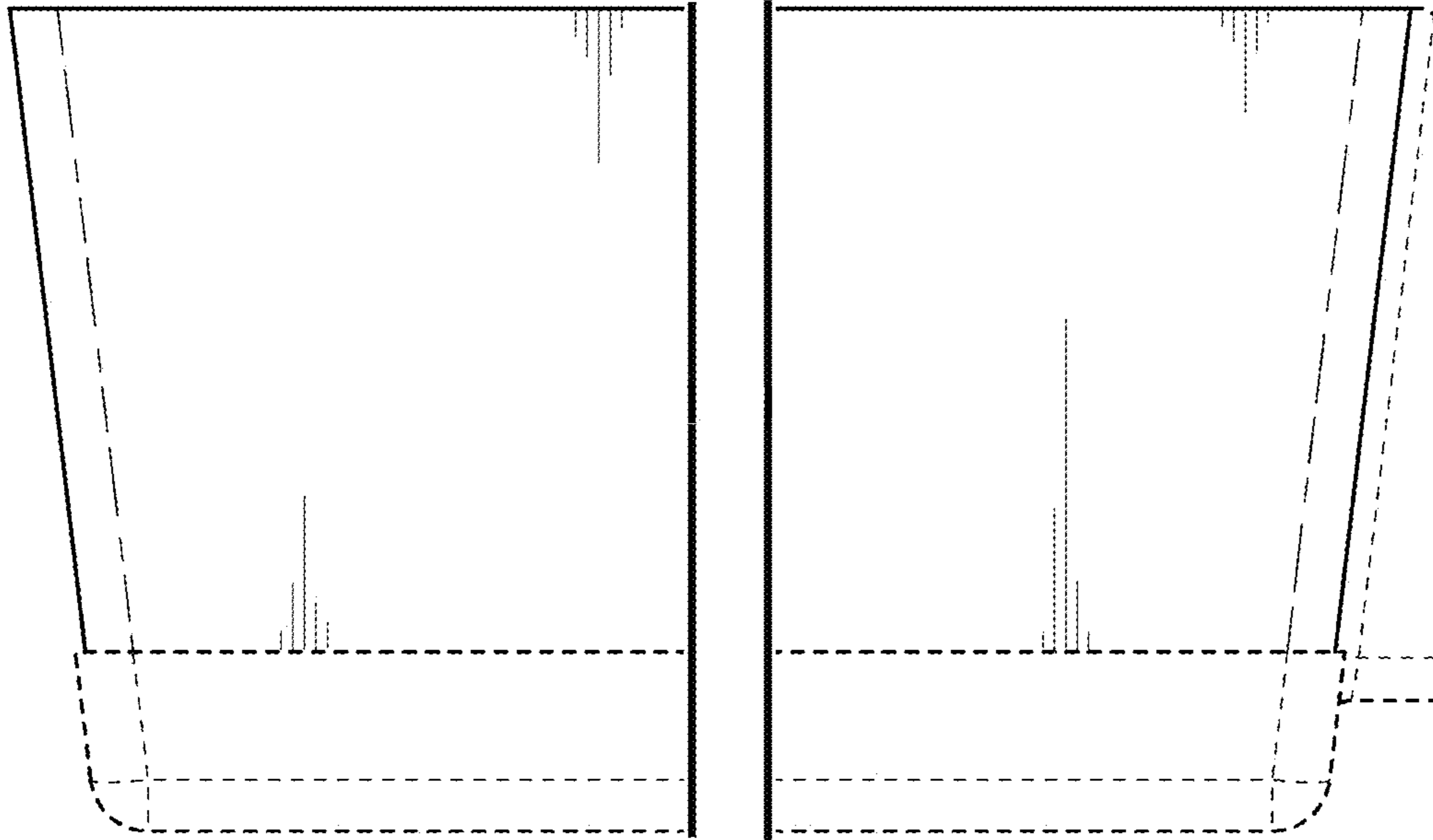

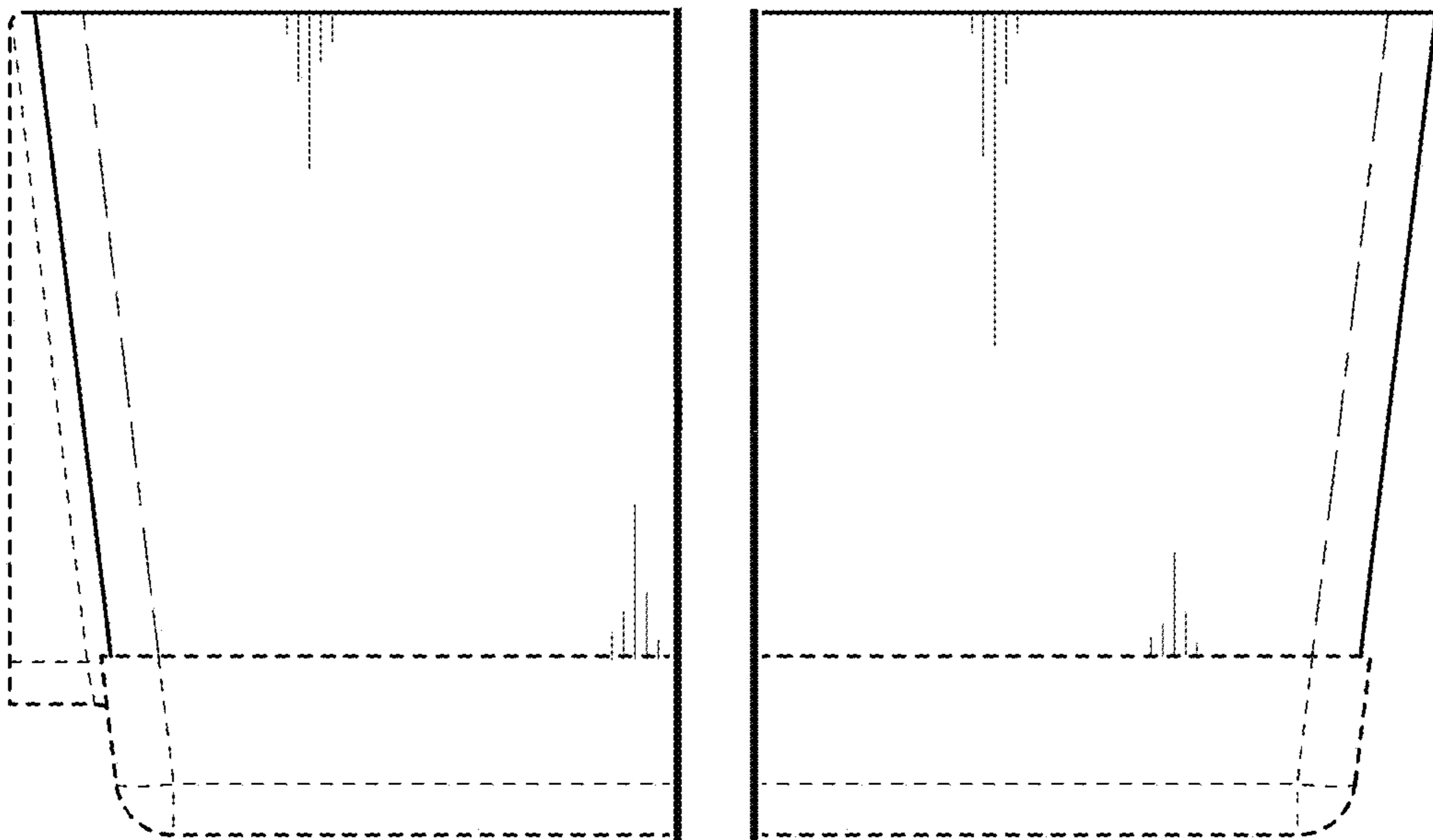

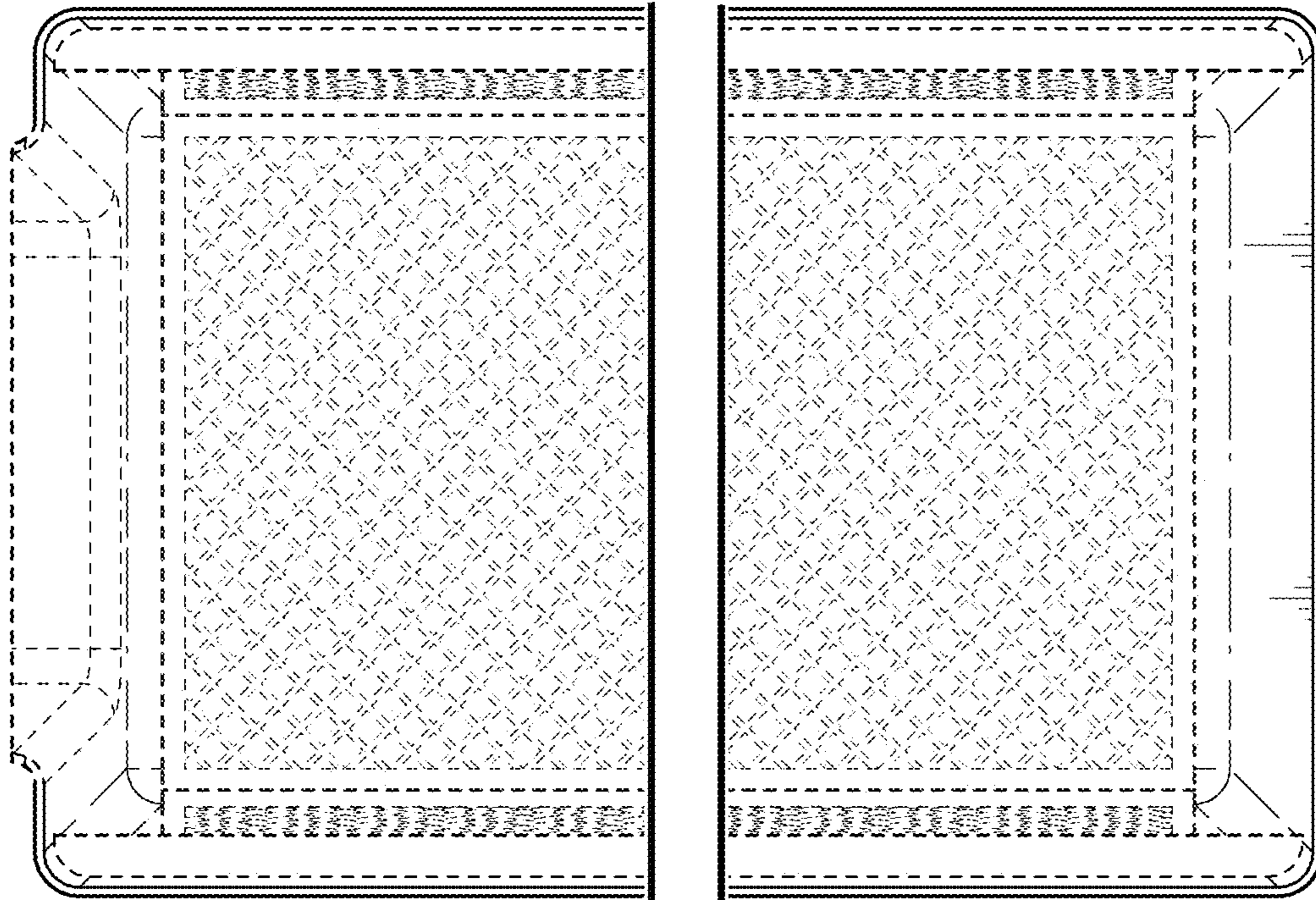

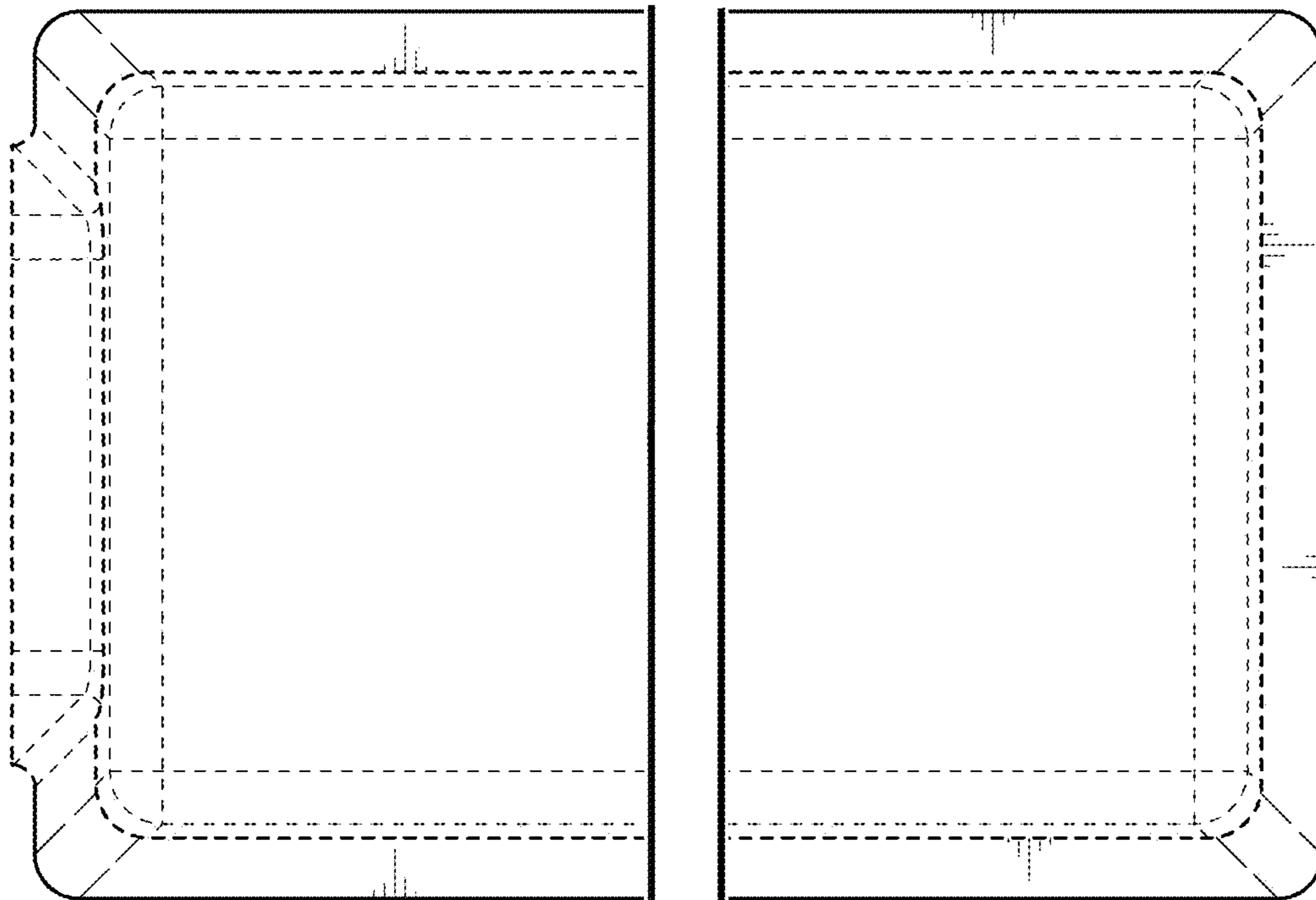

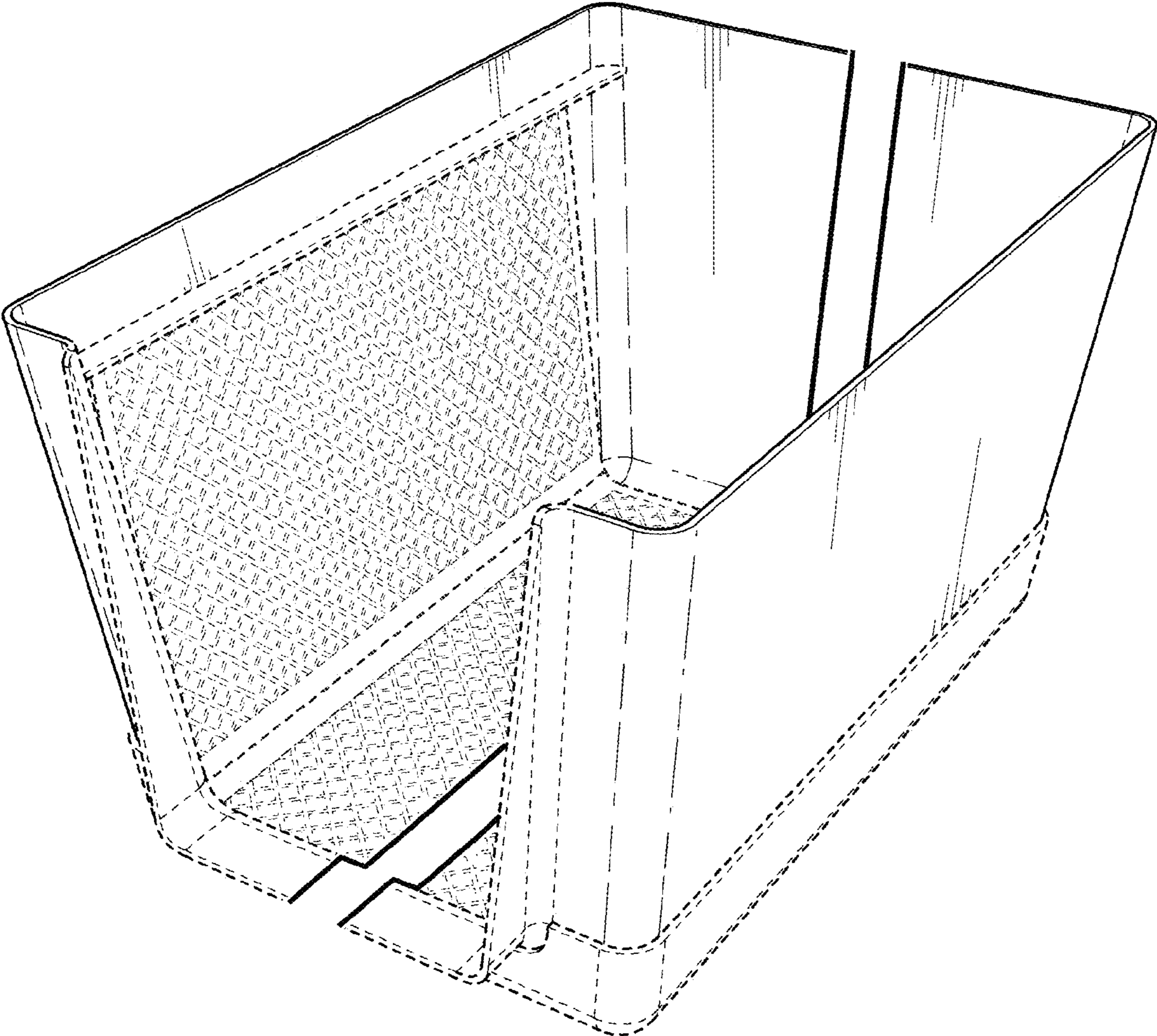

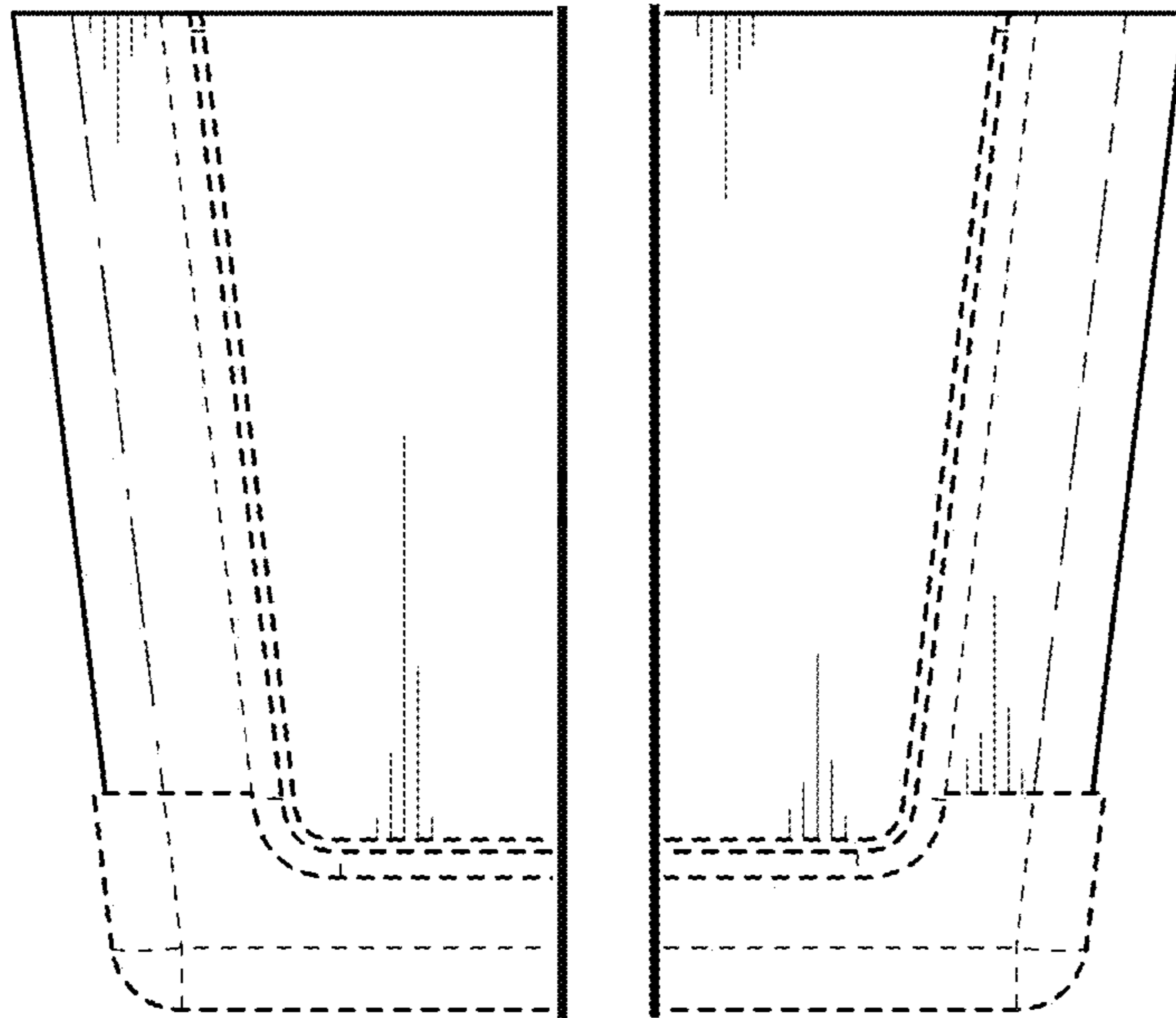

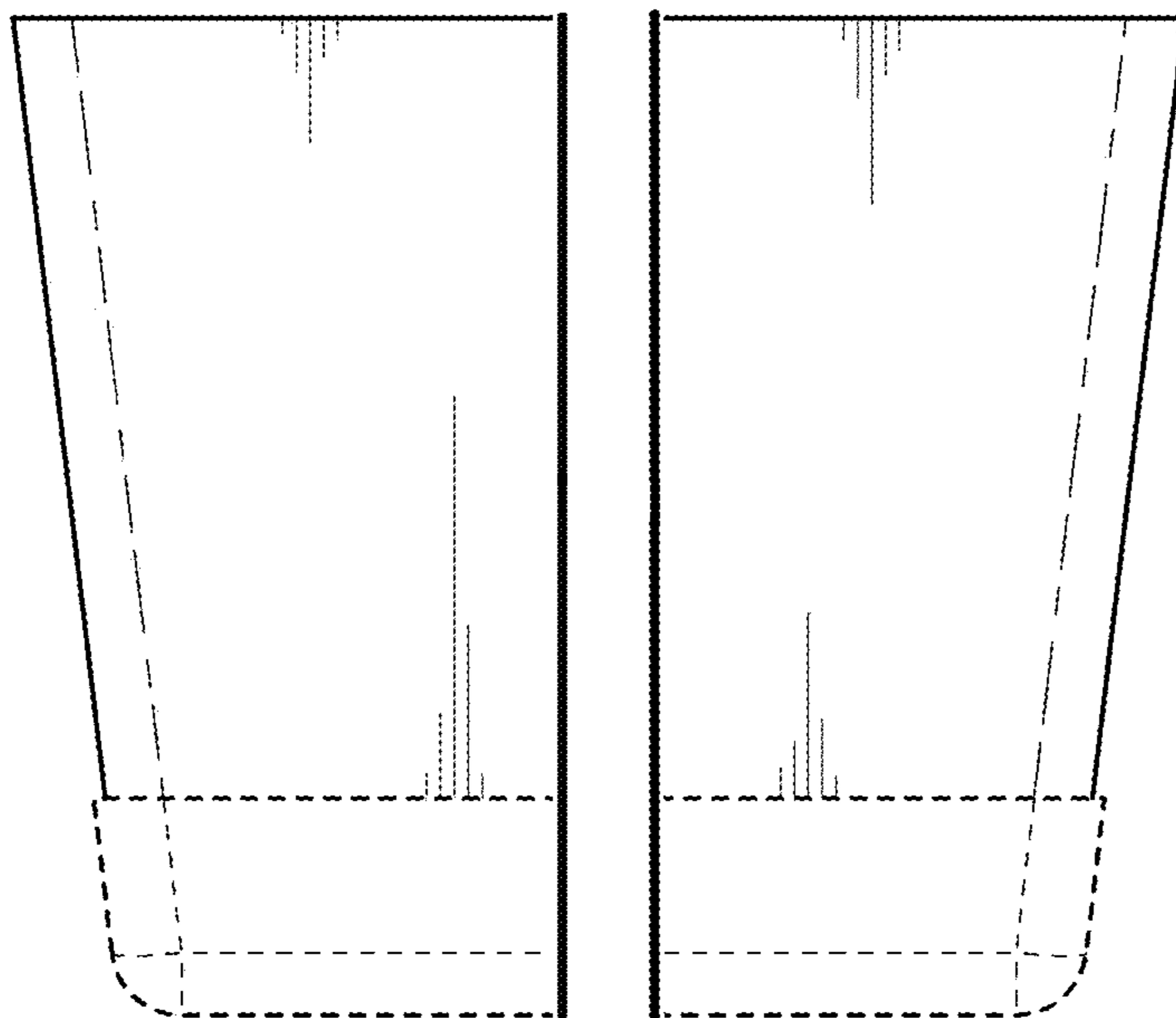

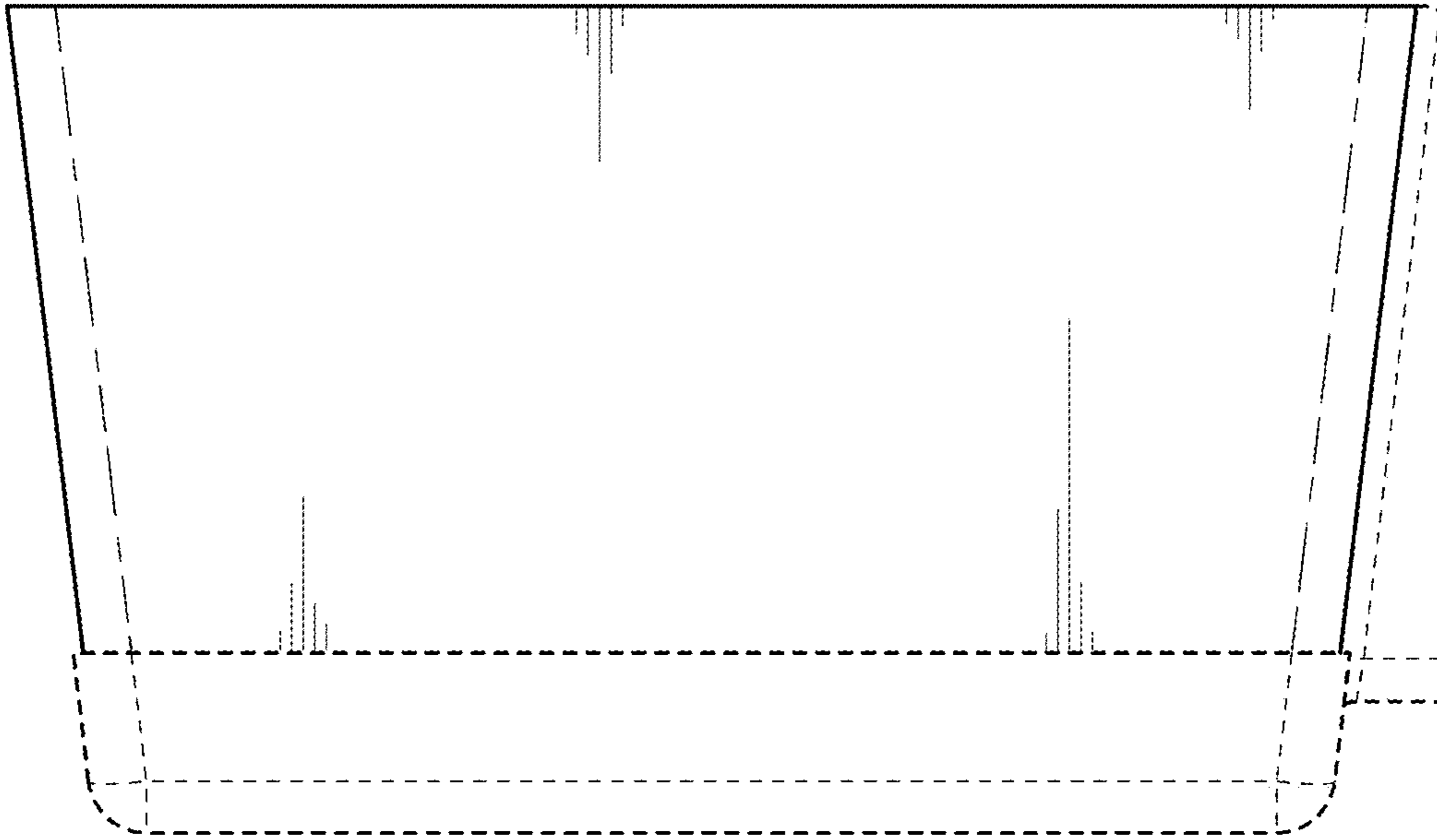

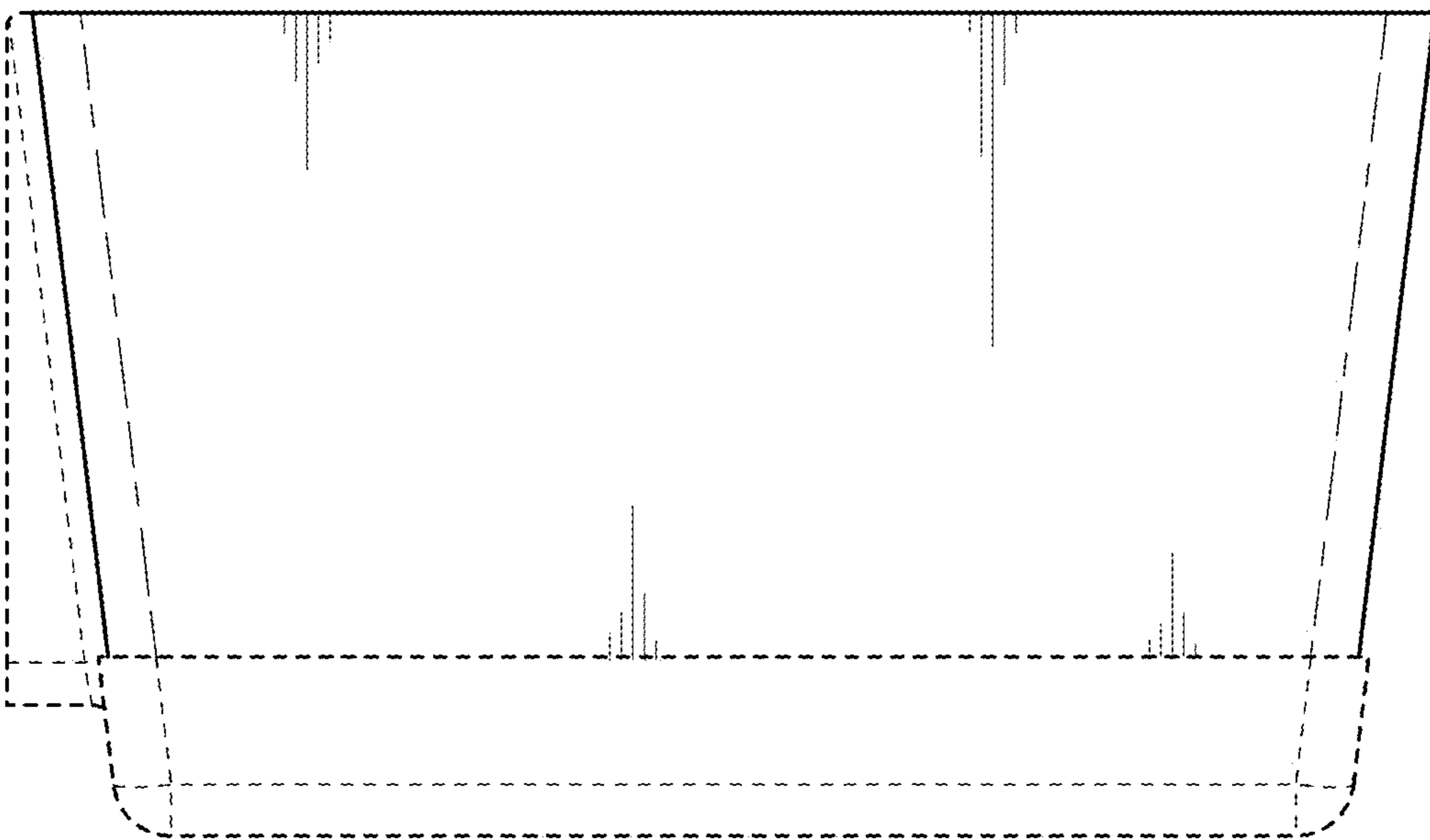

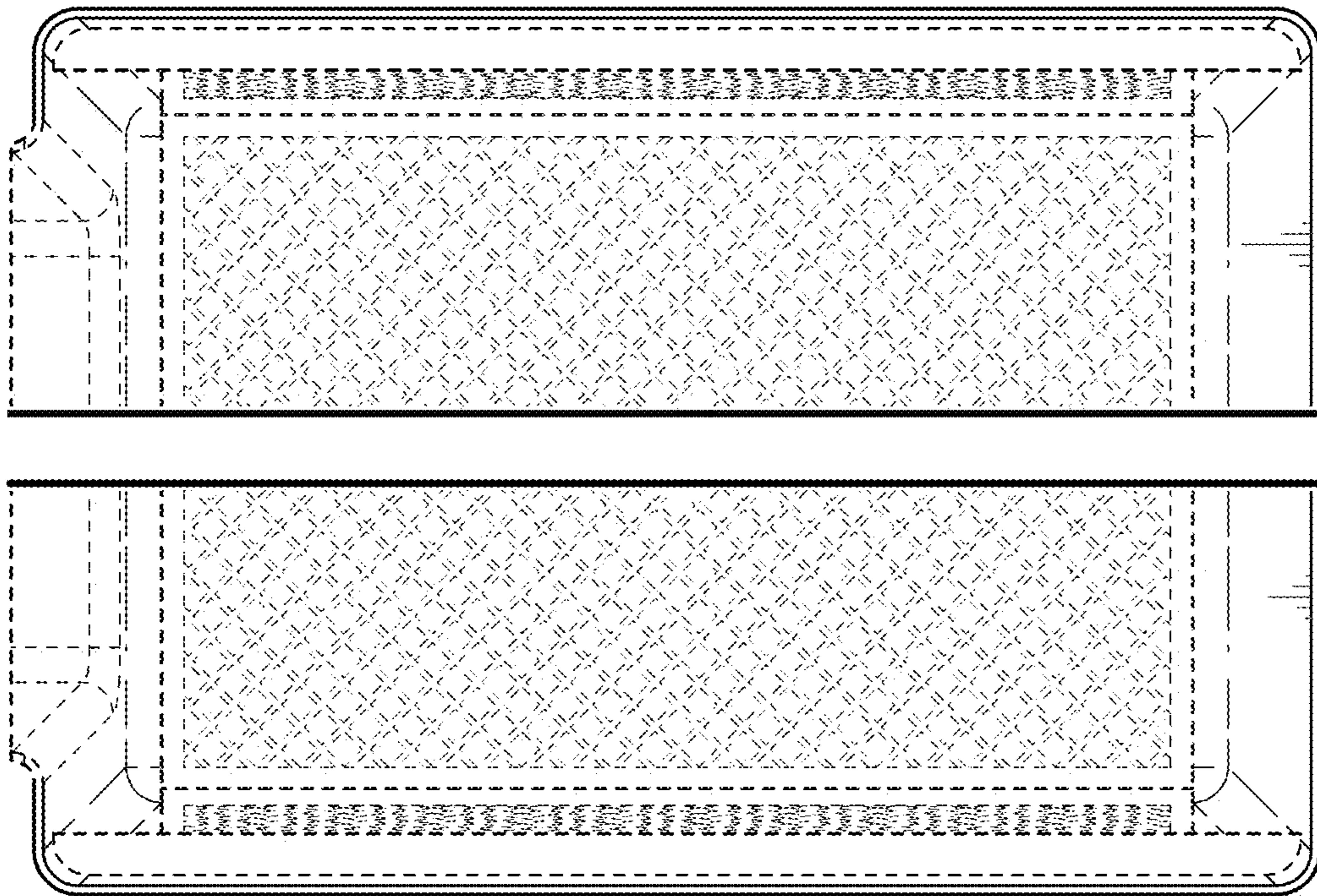

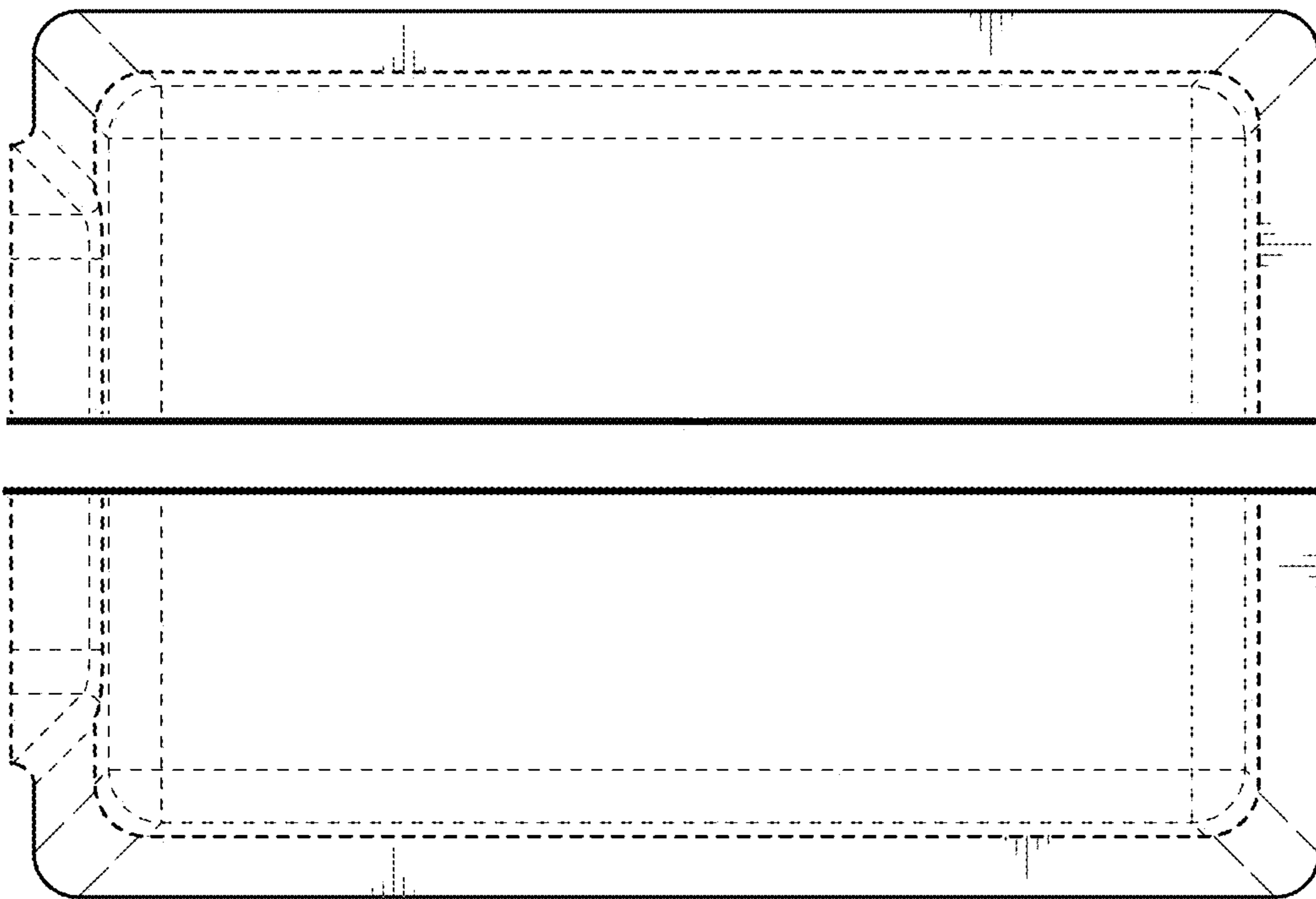
