DESCRIPTION

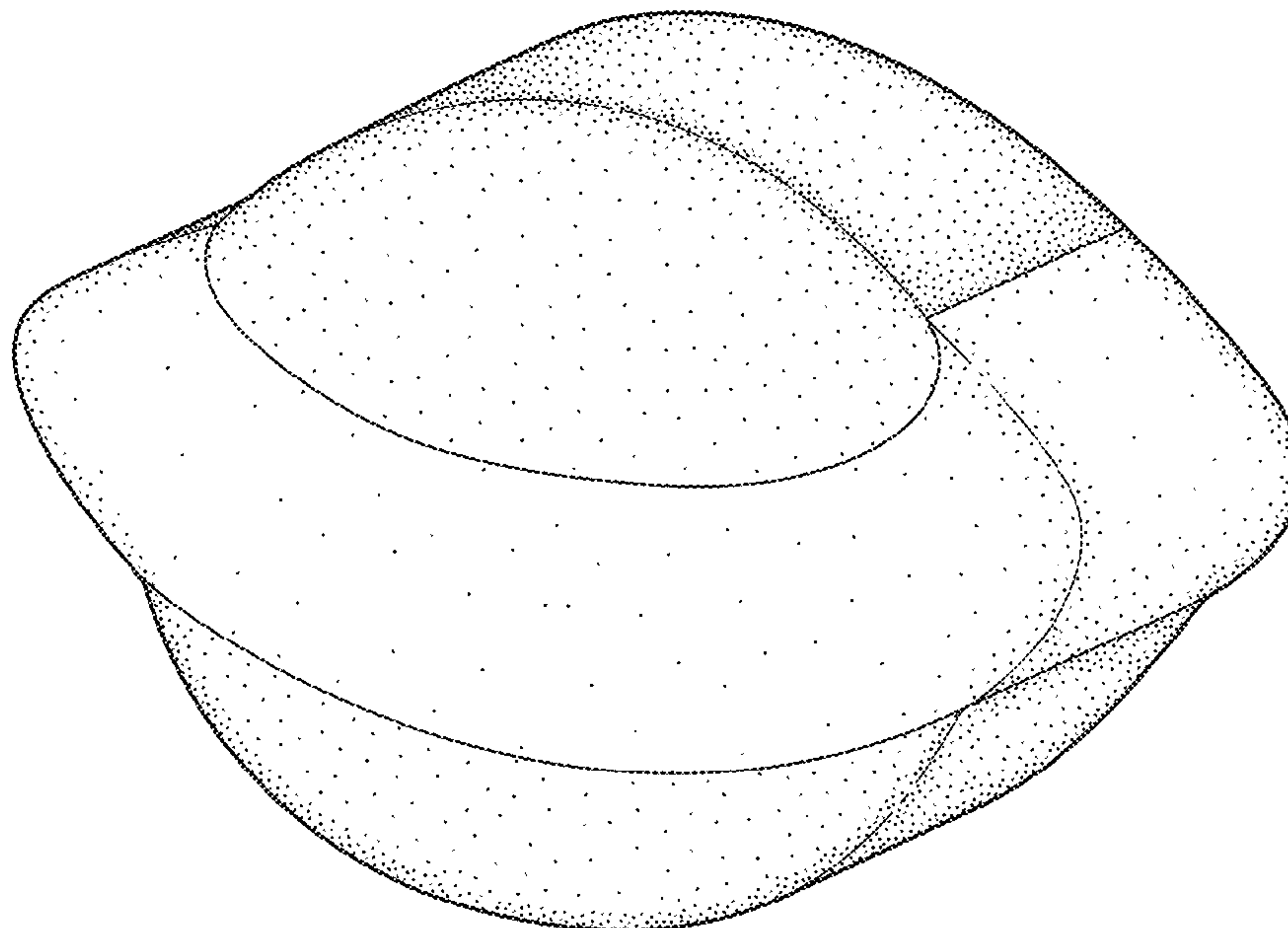
FIG. 1 is a front, top, right side perspective view of a cereal food piece according to our design shown in an environment of use;

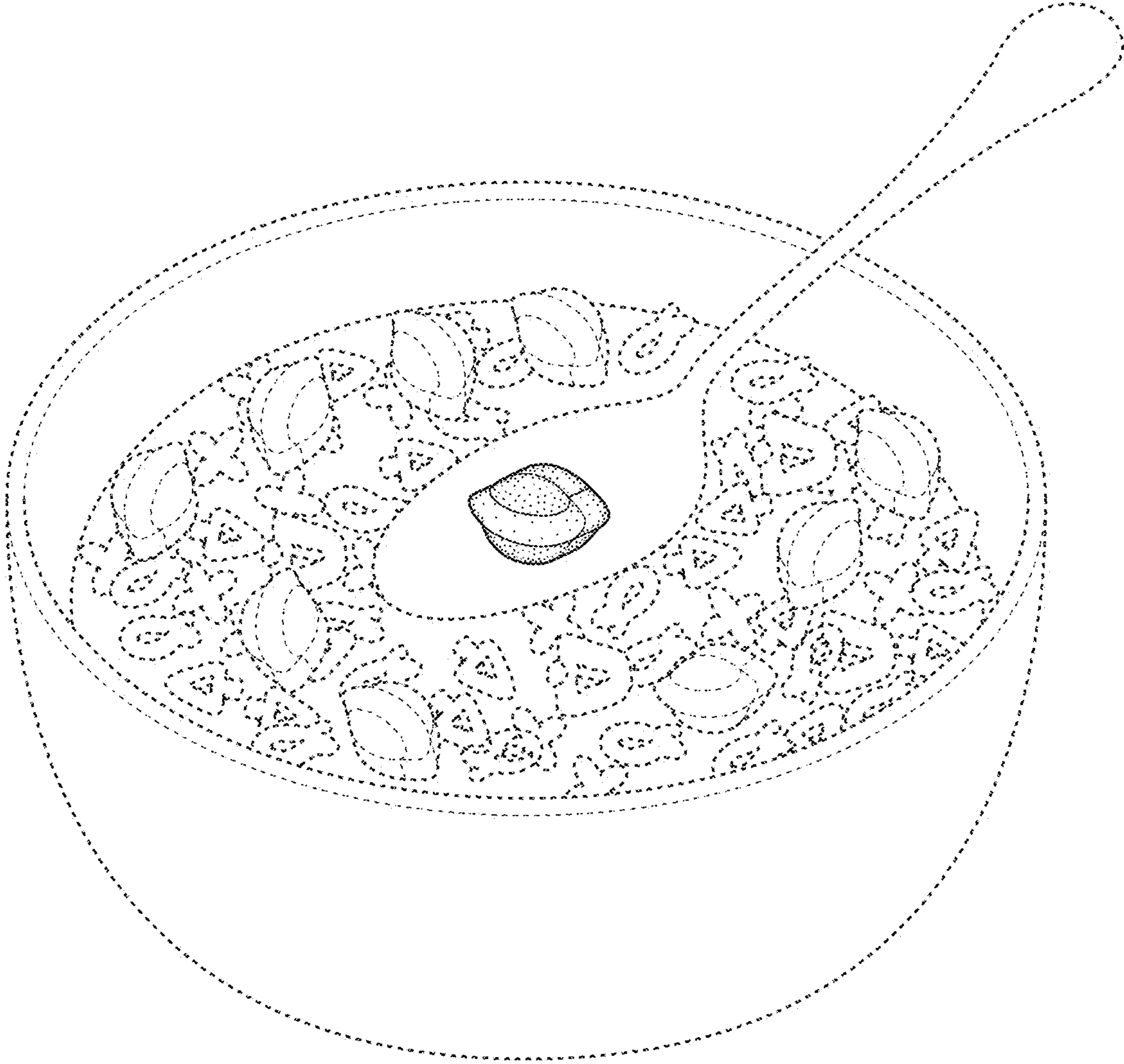

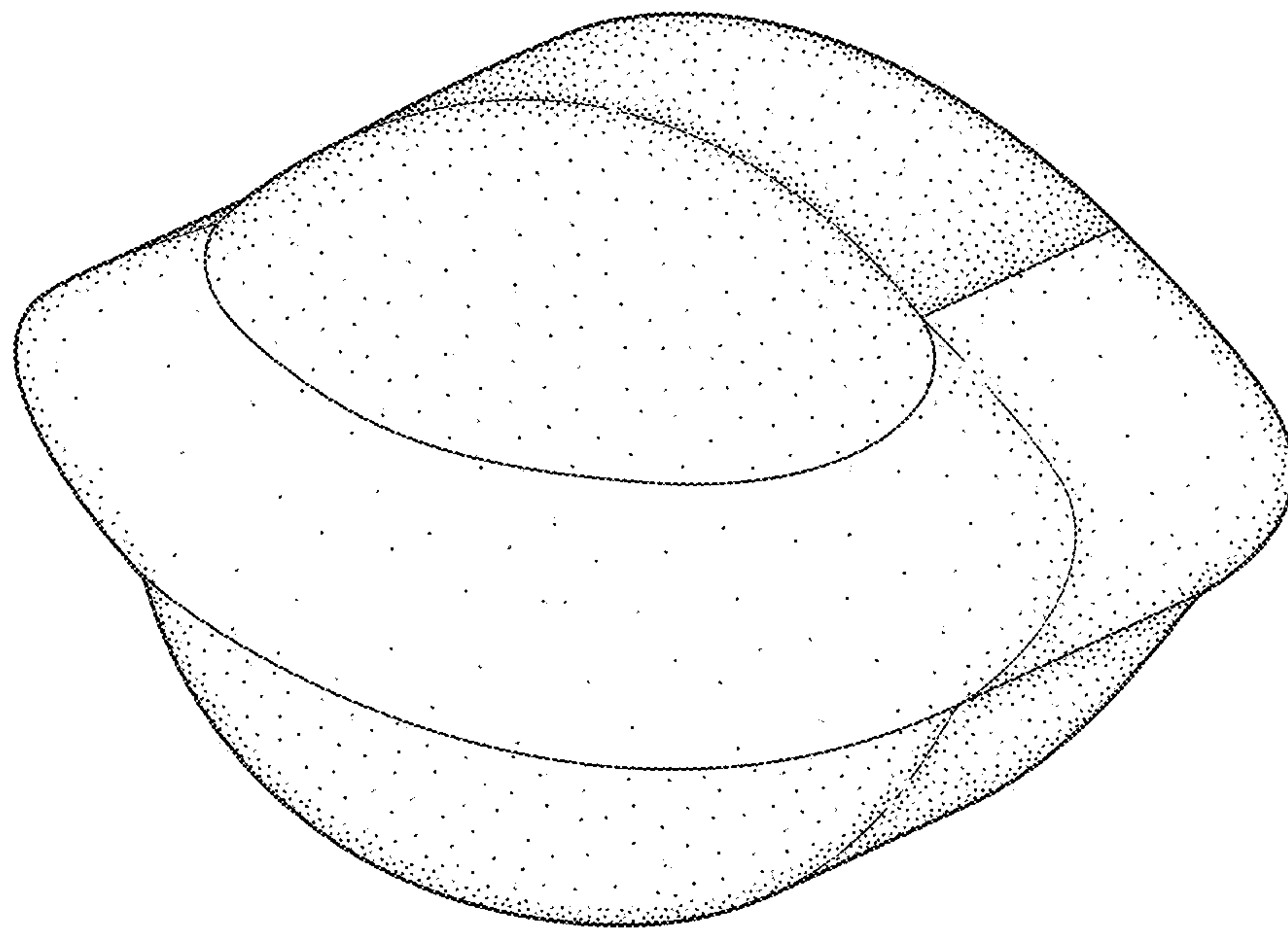

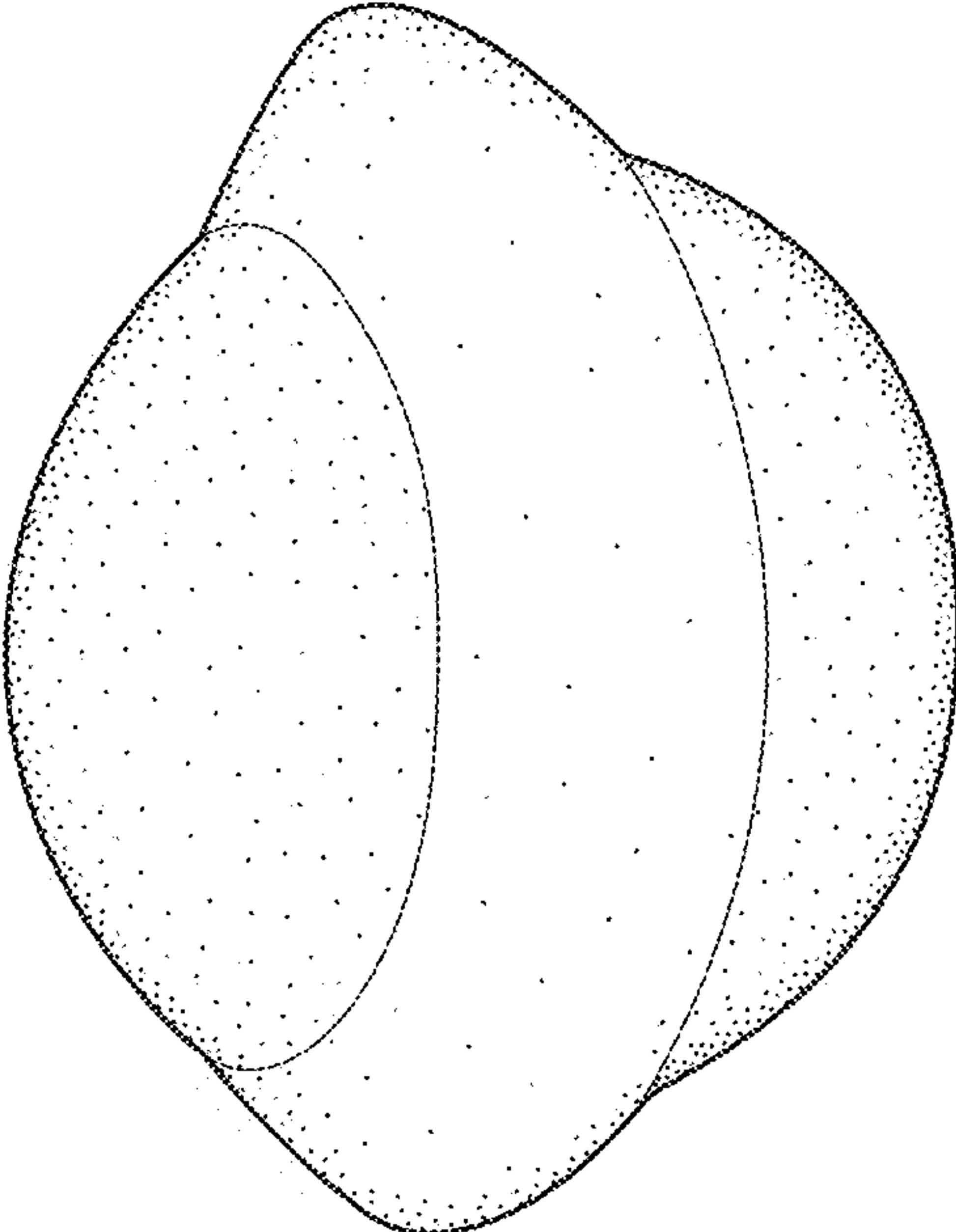

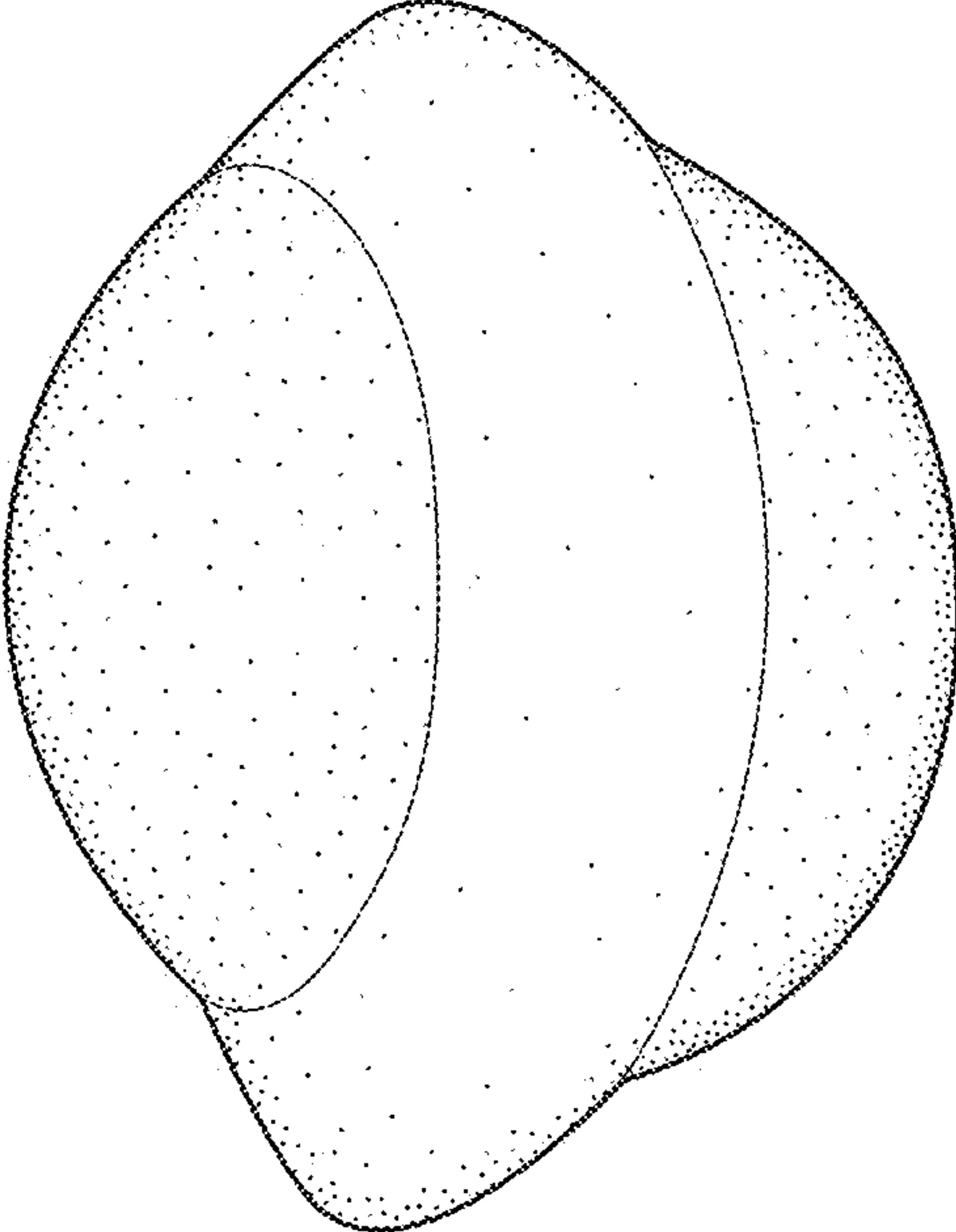

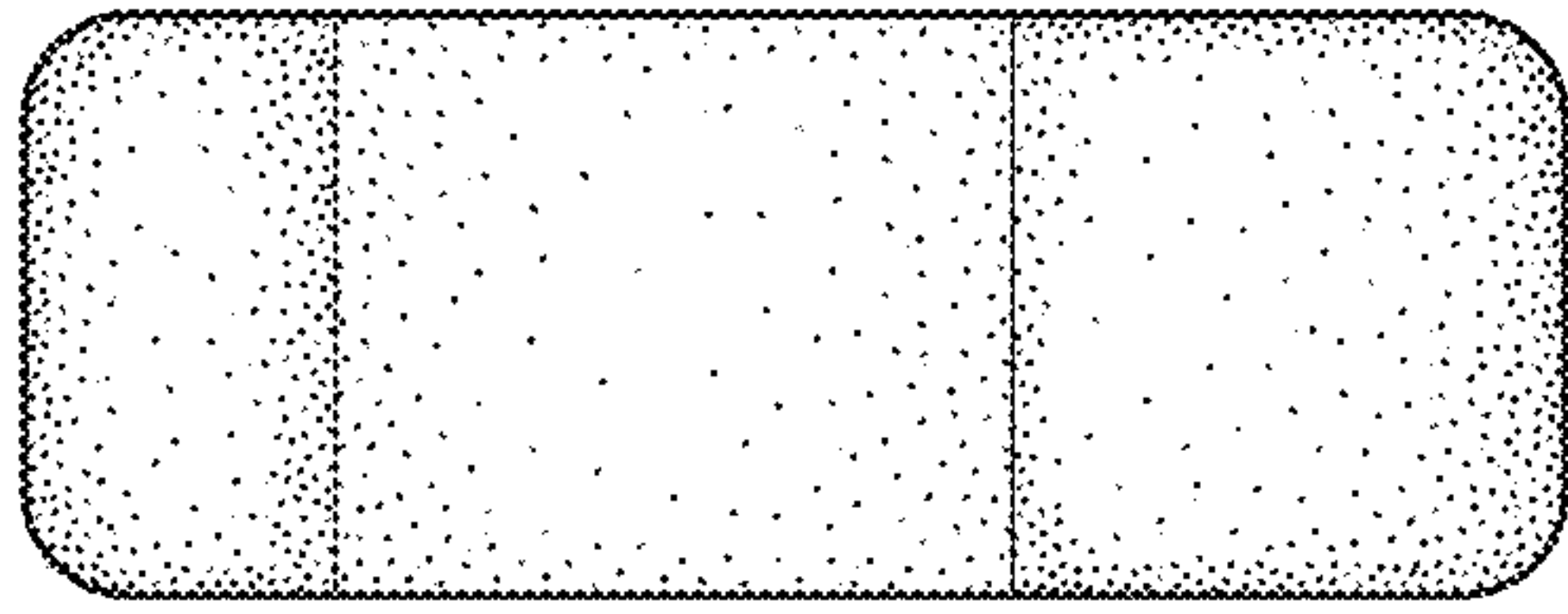

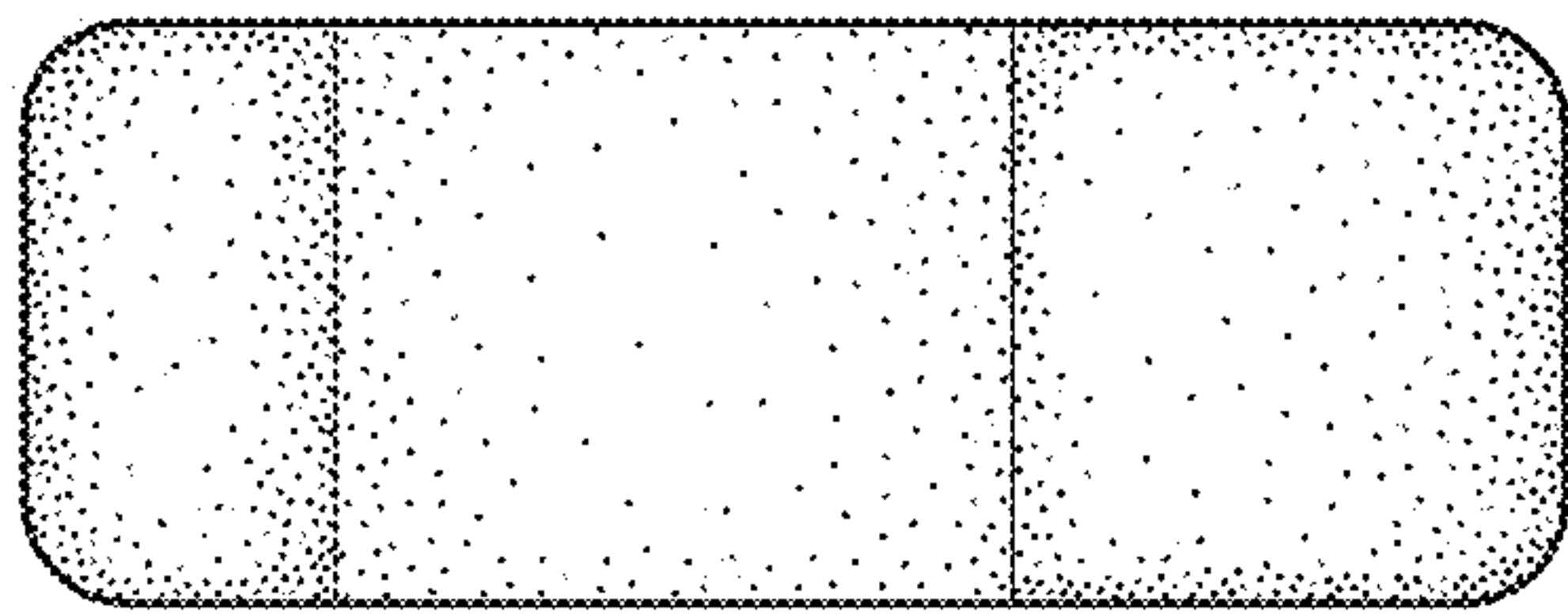

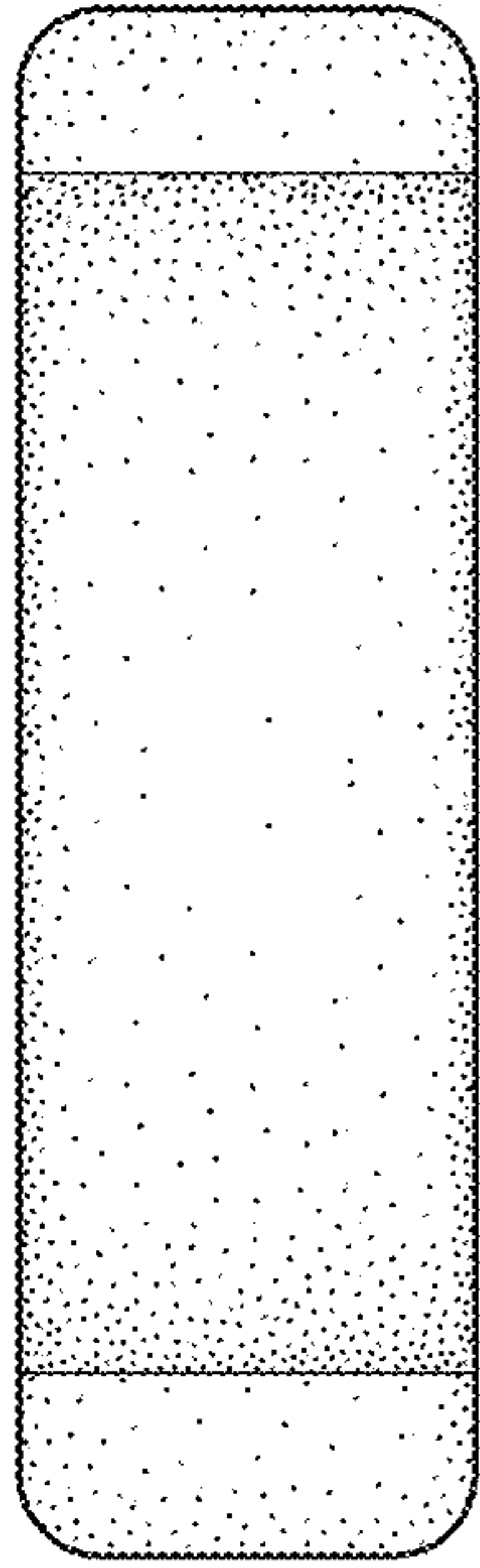

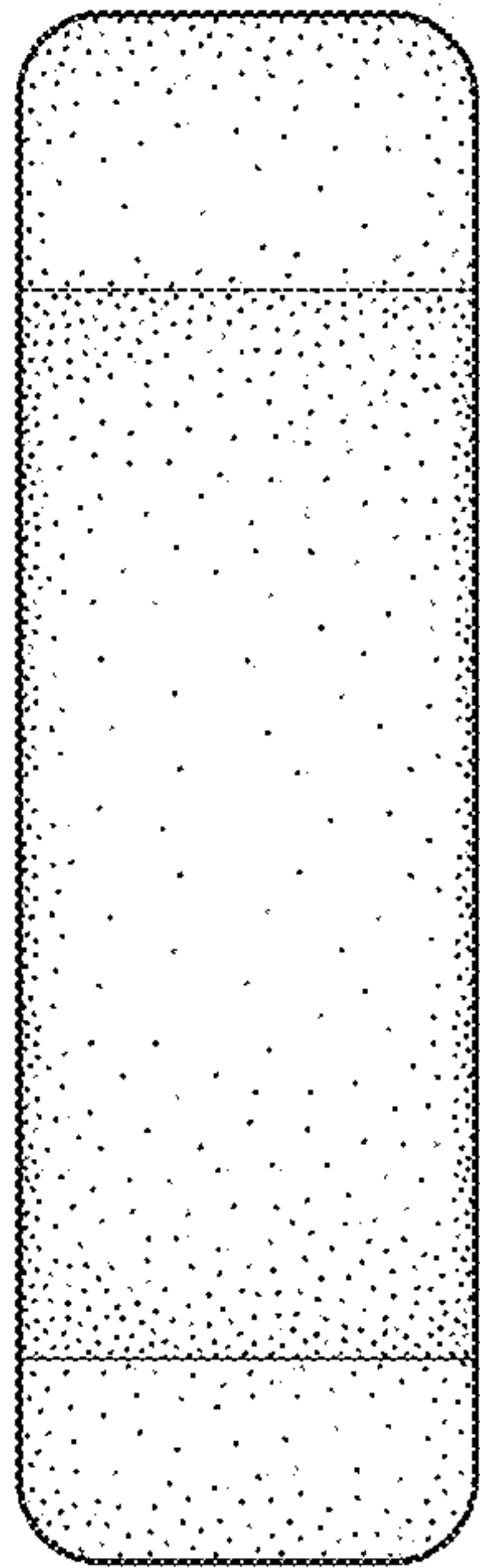
