The ornamental design for a sports shoe, as shown and described.

**DESCRIPTION**

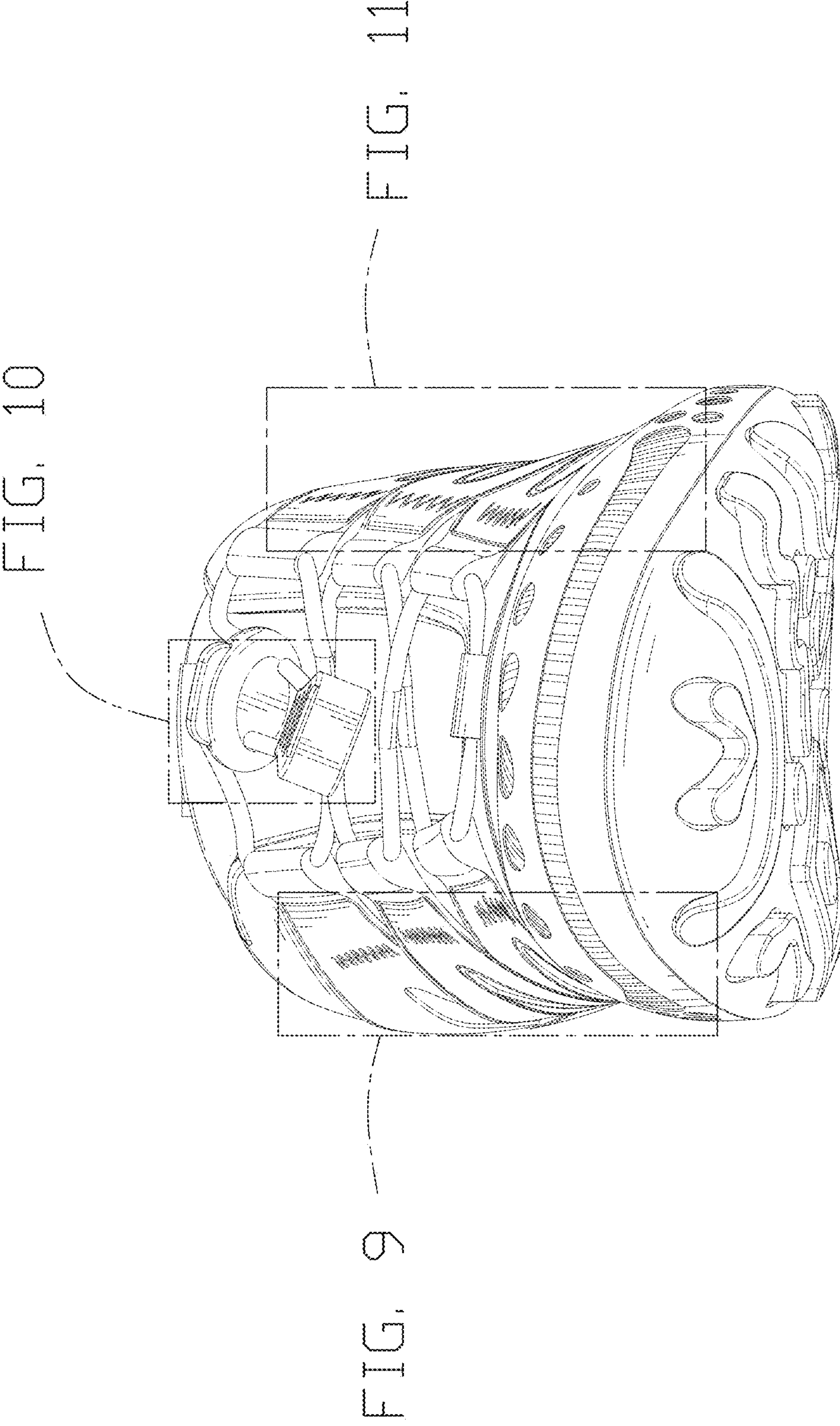

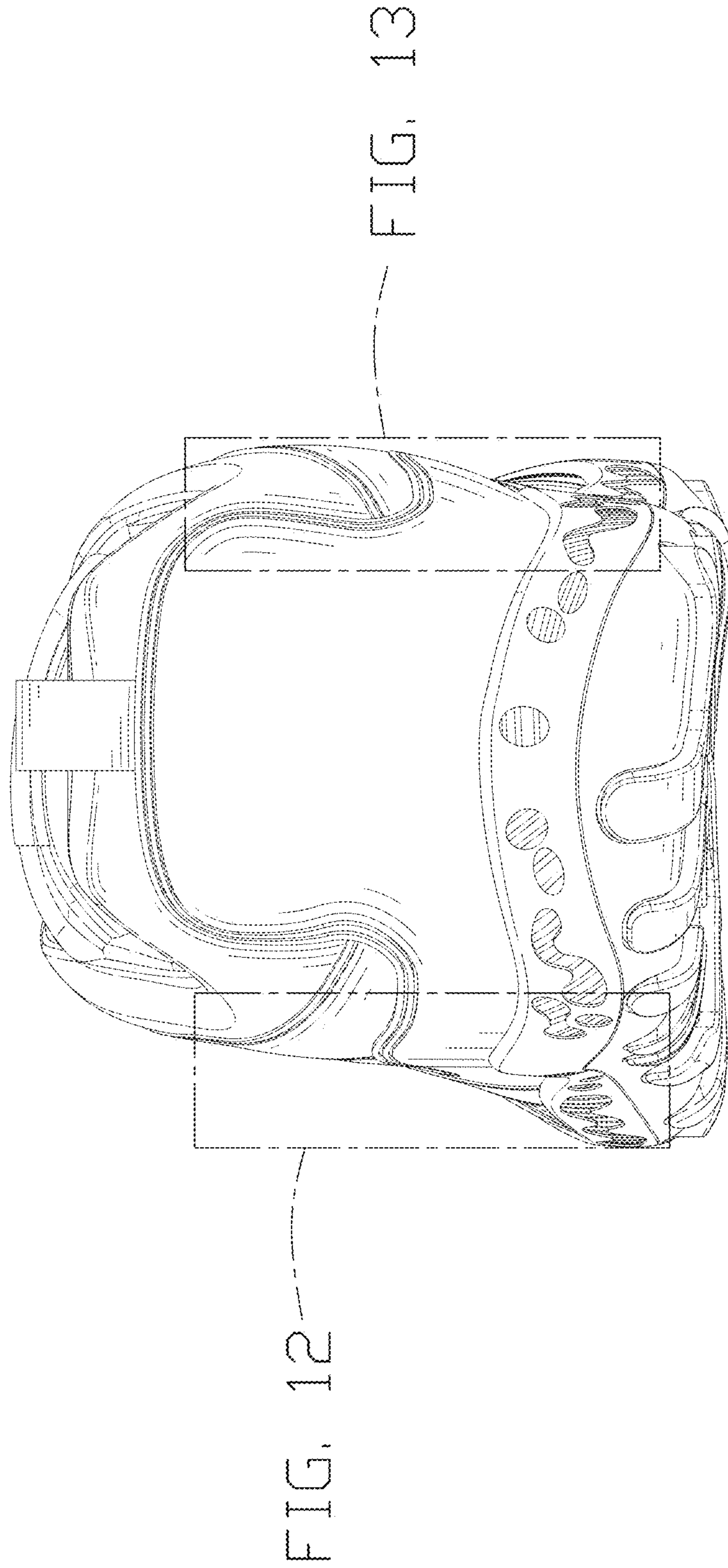

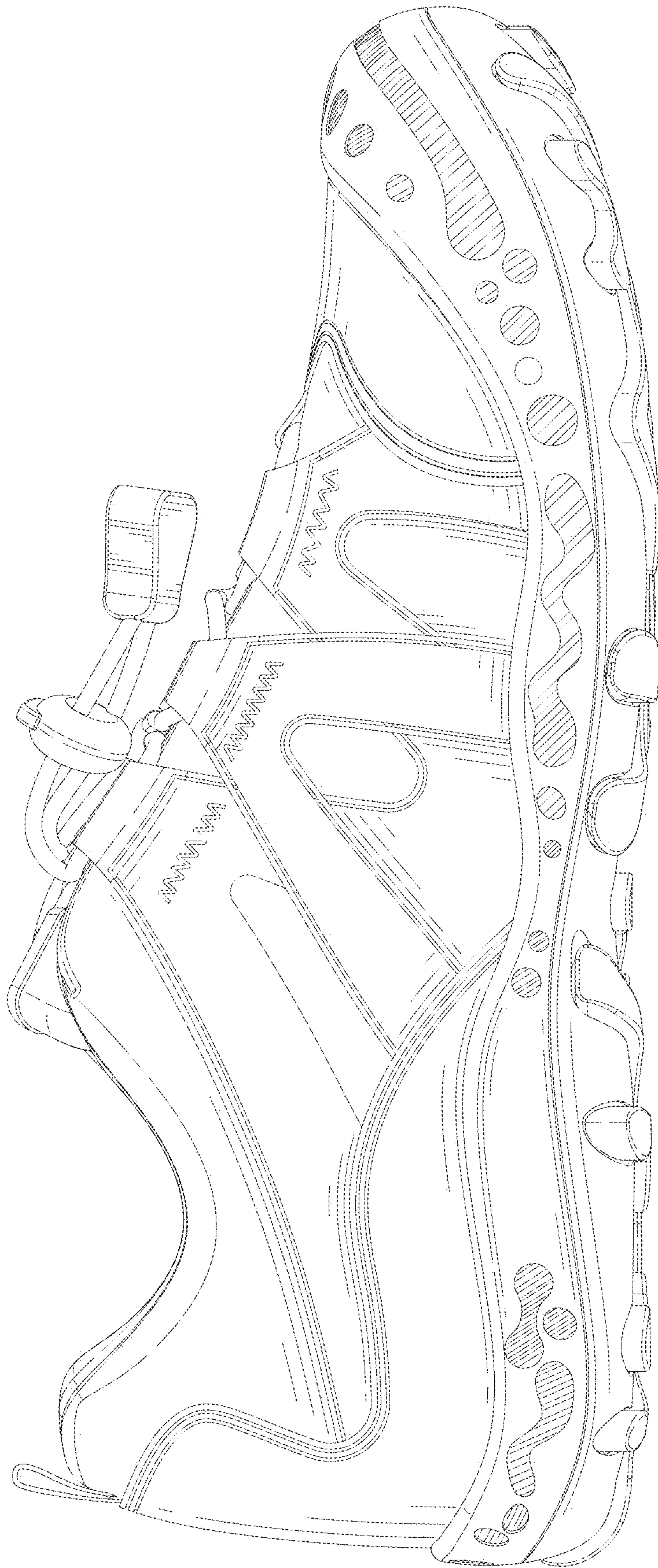

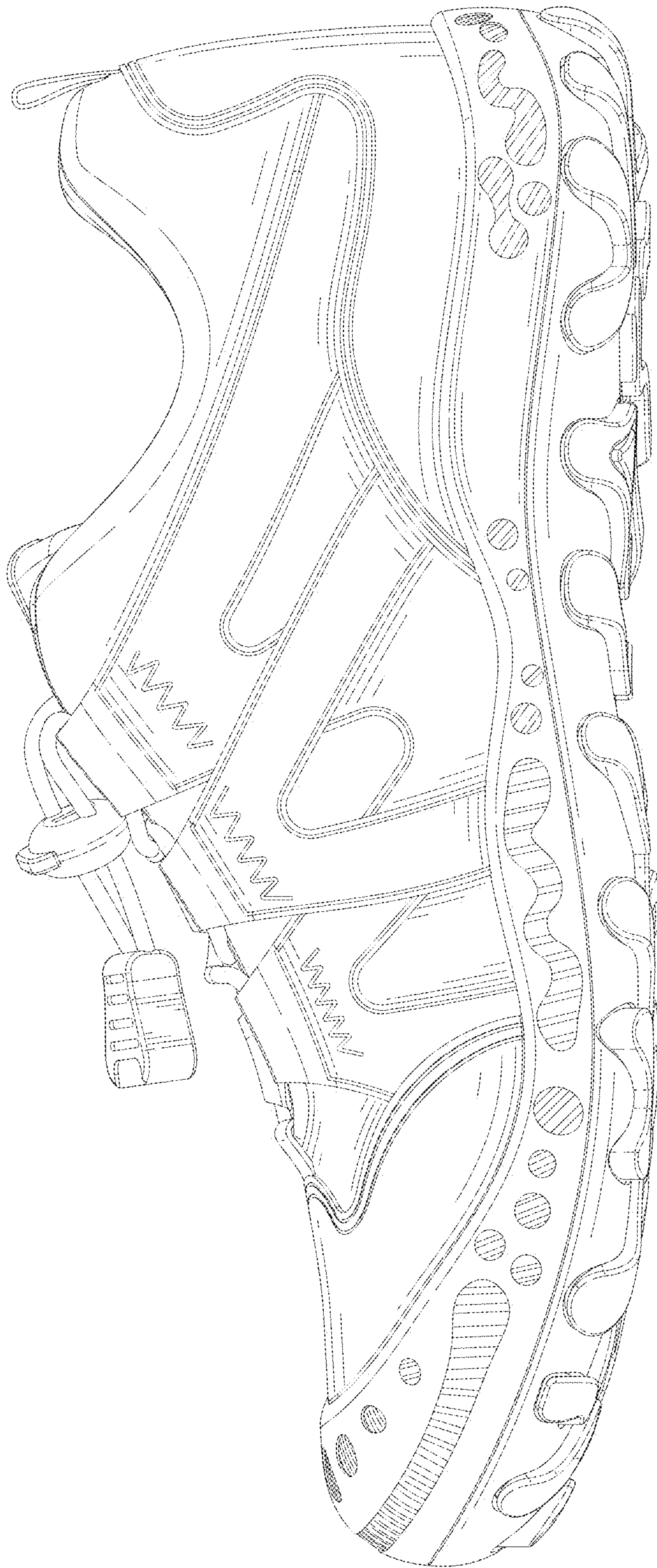

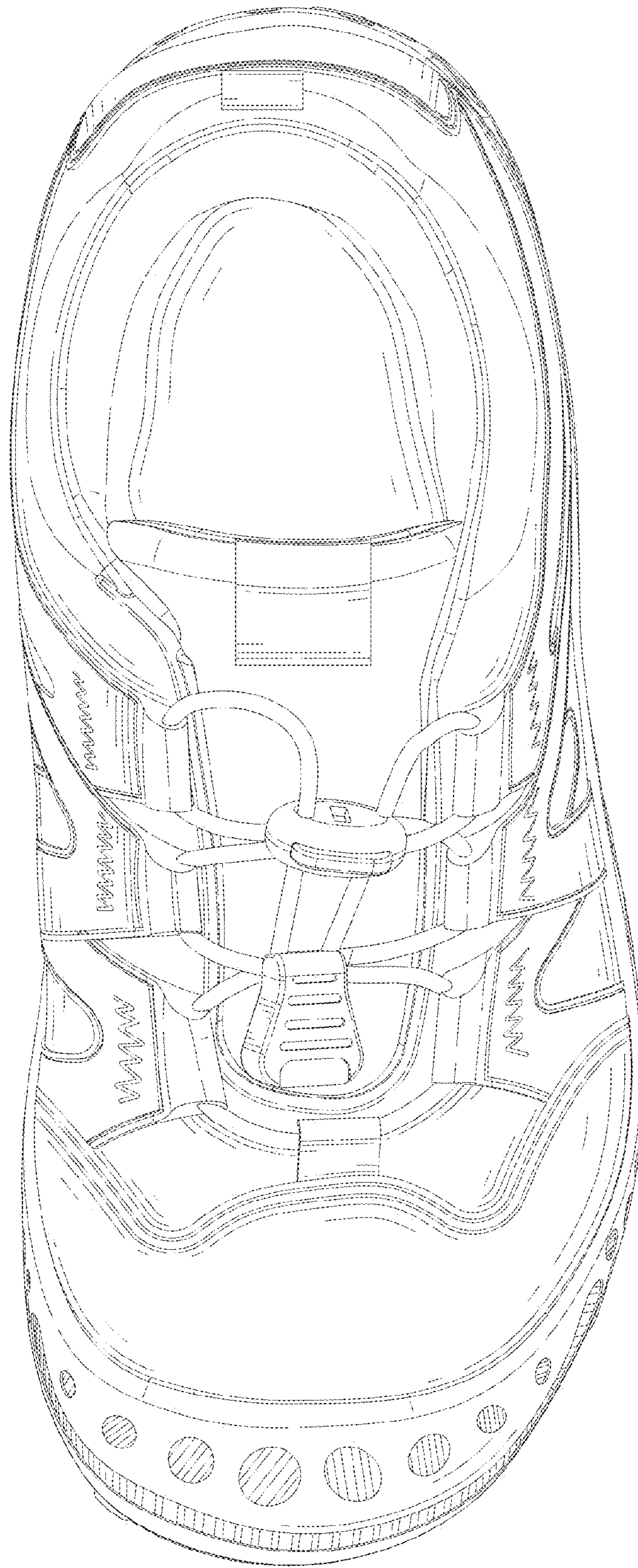

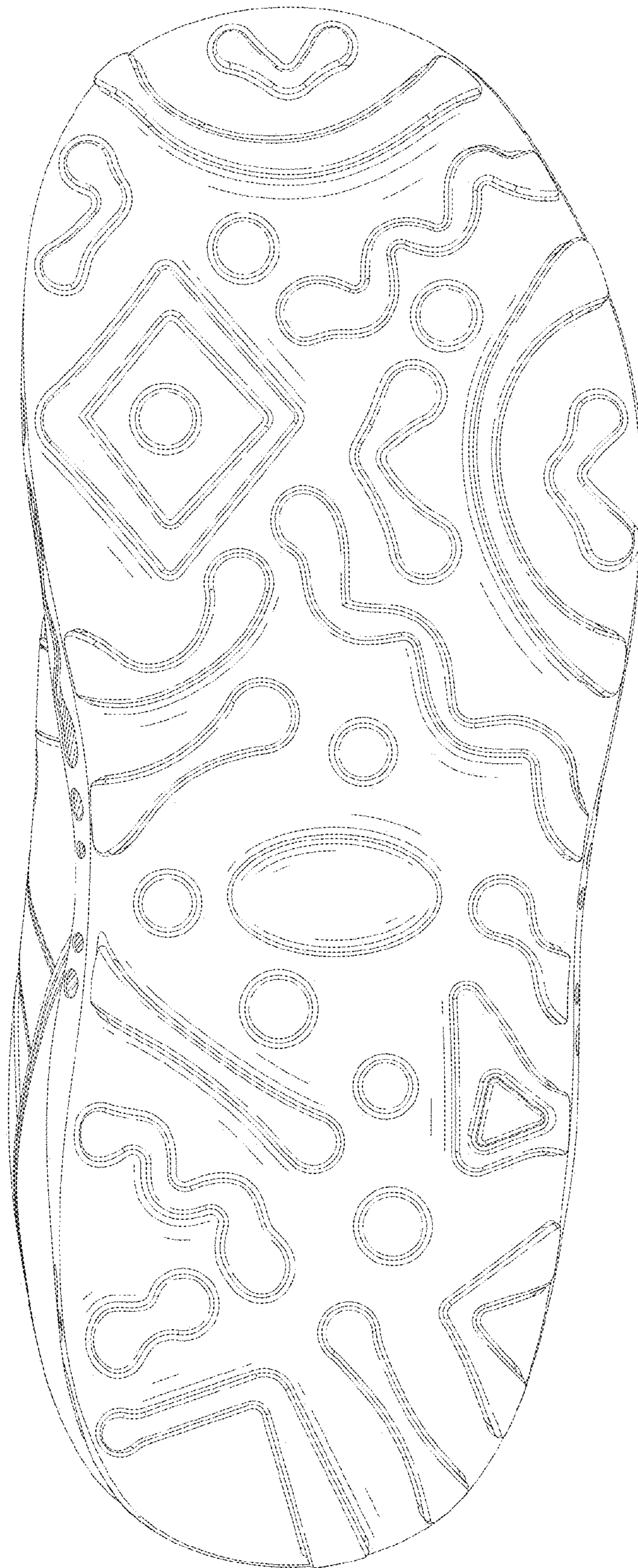

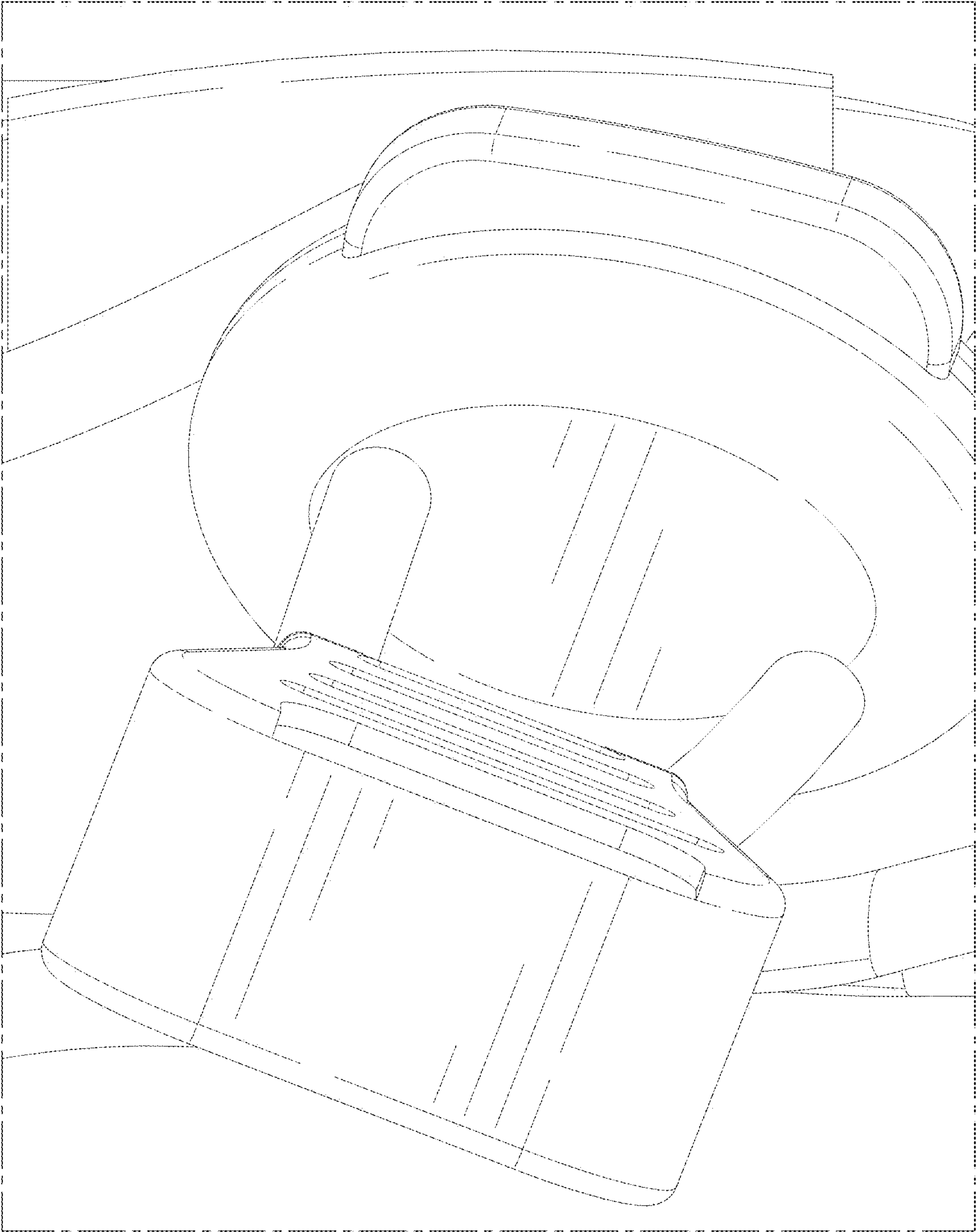

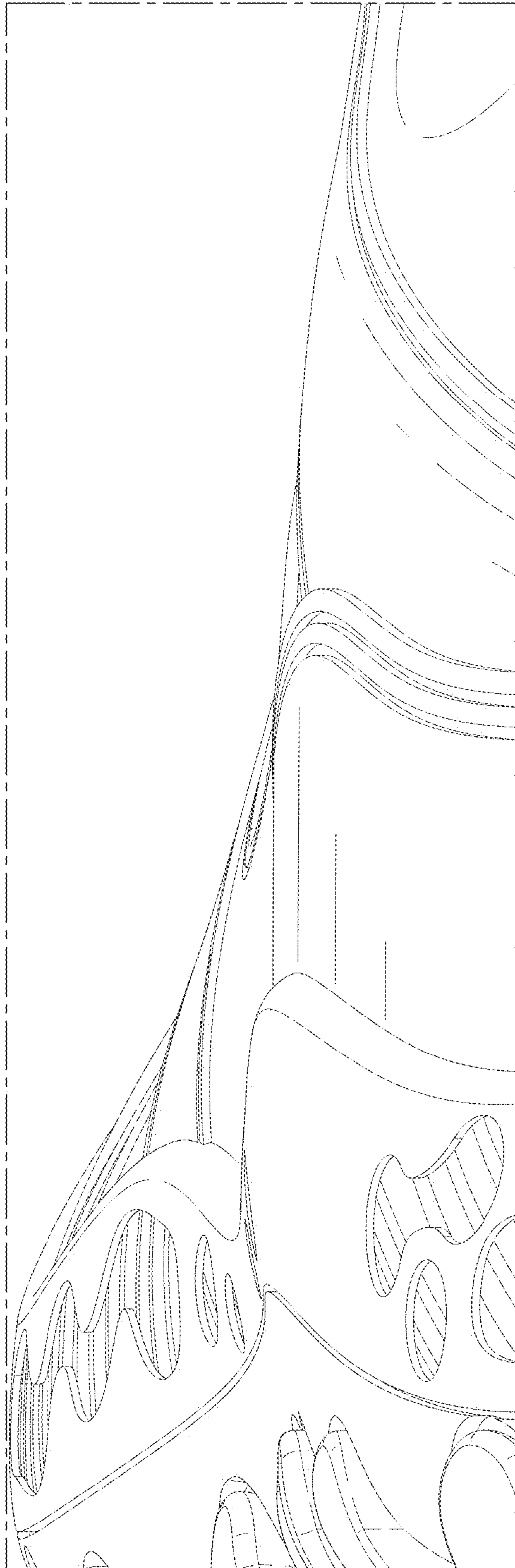

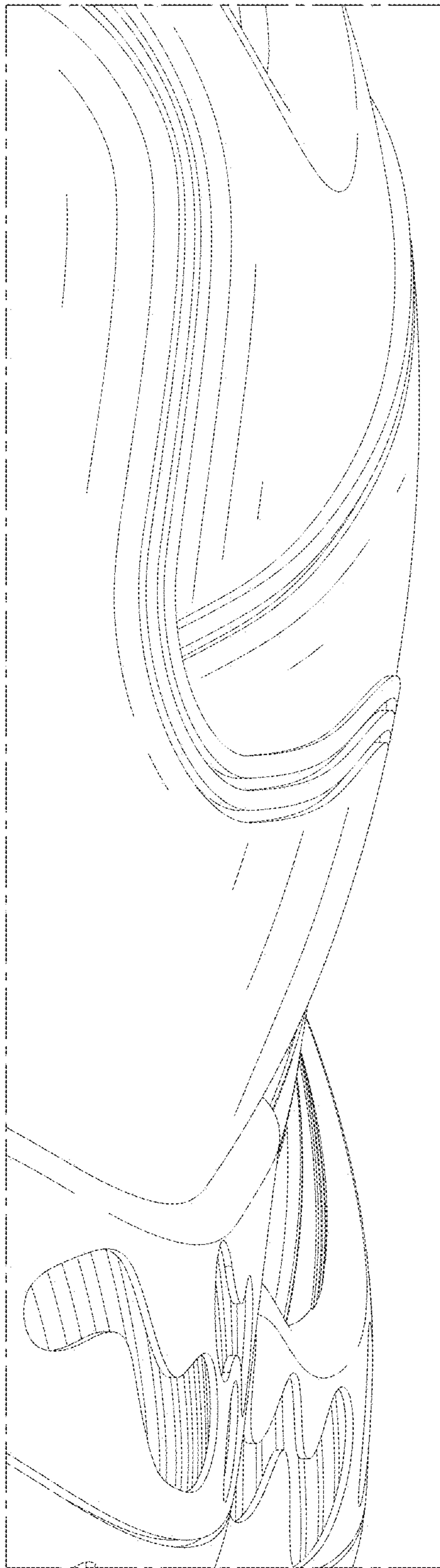
