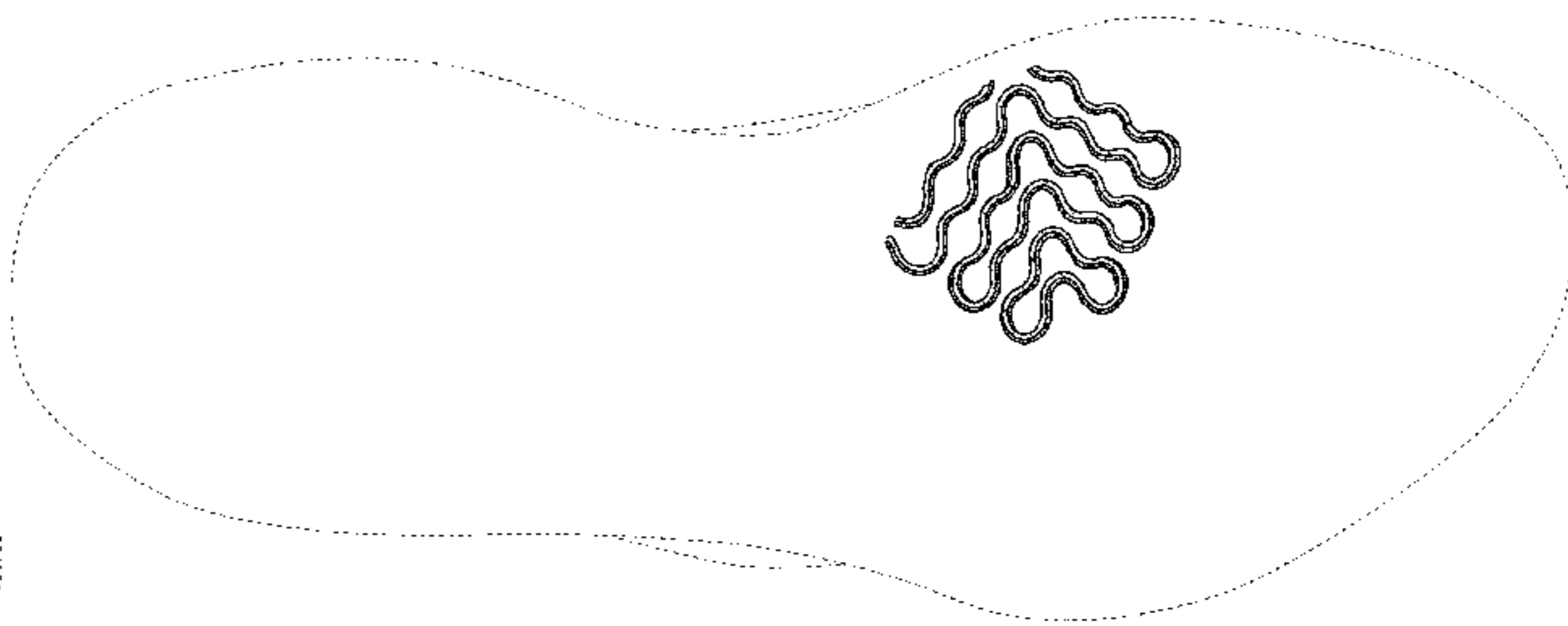
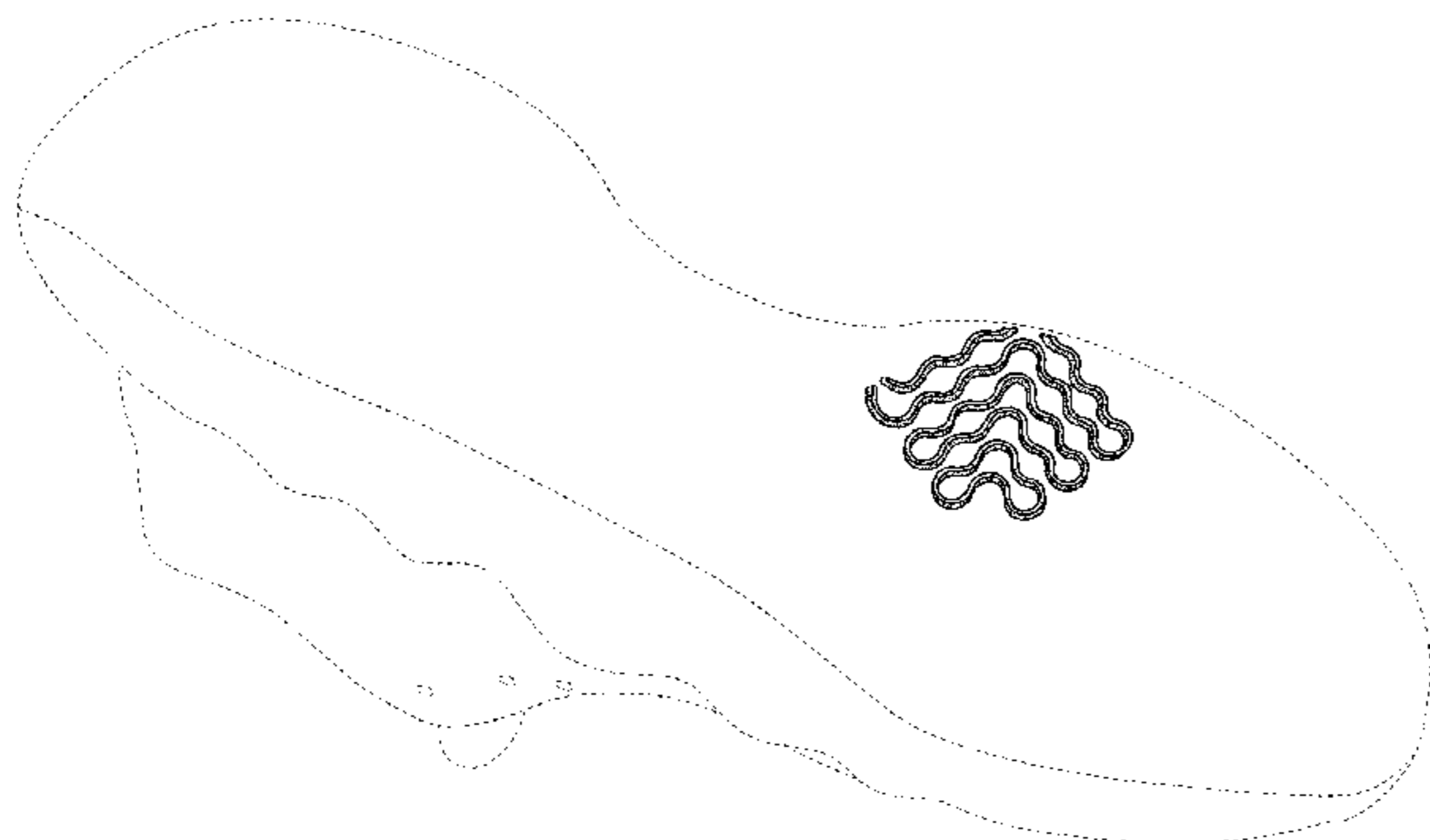

(57) **CLAIM**  
I claim the ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe, showing my new design; FIG. 2 is a bottom view thereof; and, FIG. 3 is a rear perspective view thereof. The claim is directed only to the solid line elements and the shaded surfaces upon them. The broken lines immediately adjacent to the shaded areas represent unclaimed boundaries of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

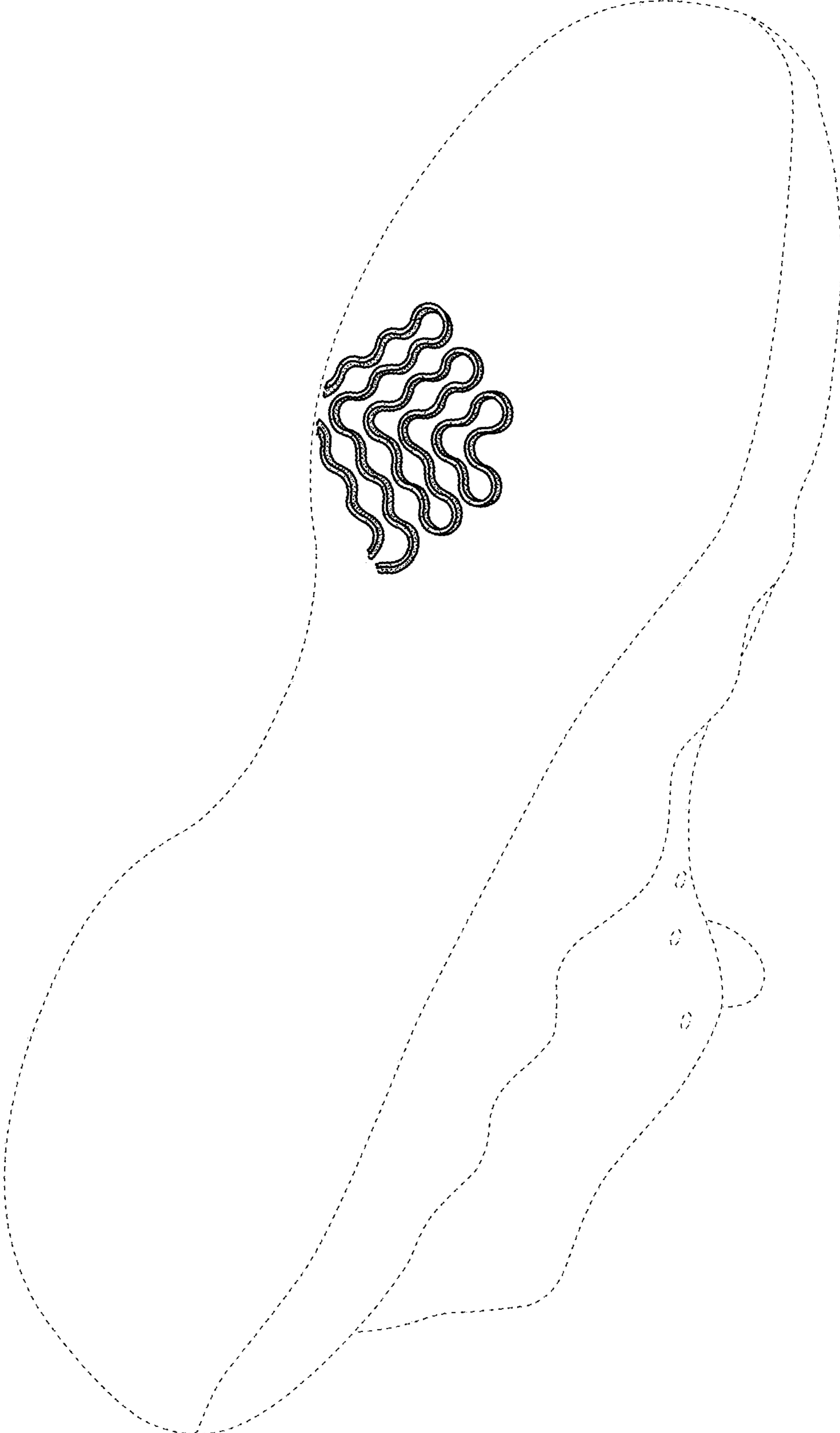

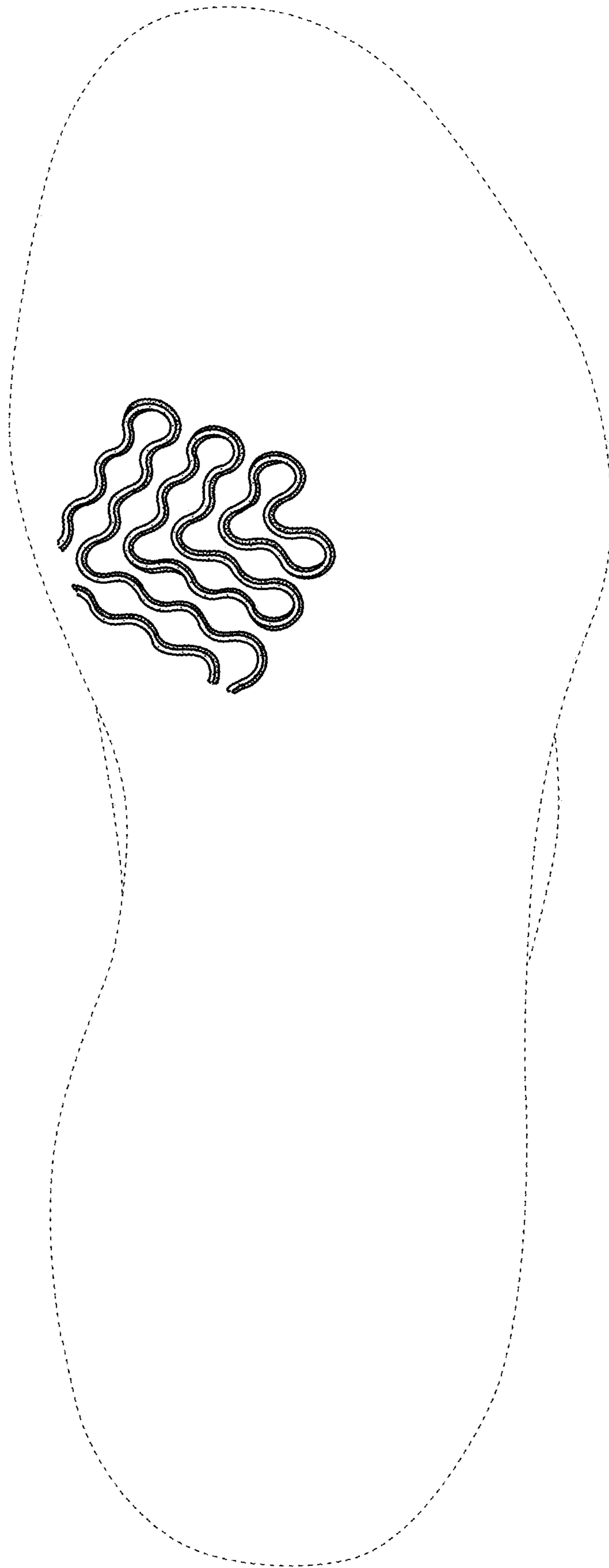
