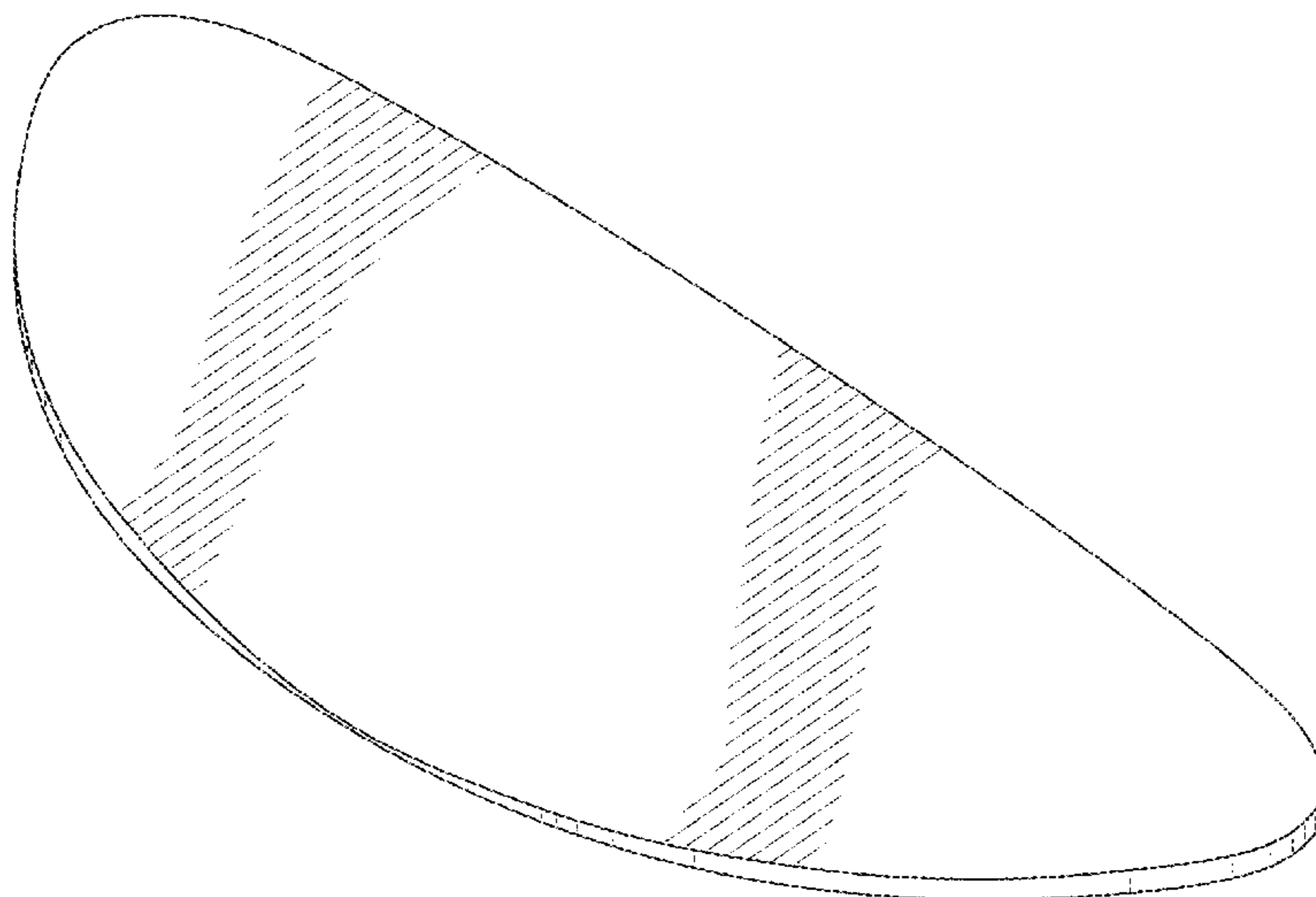
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front top perspective view of an arch support showing my new design;

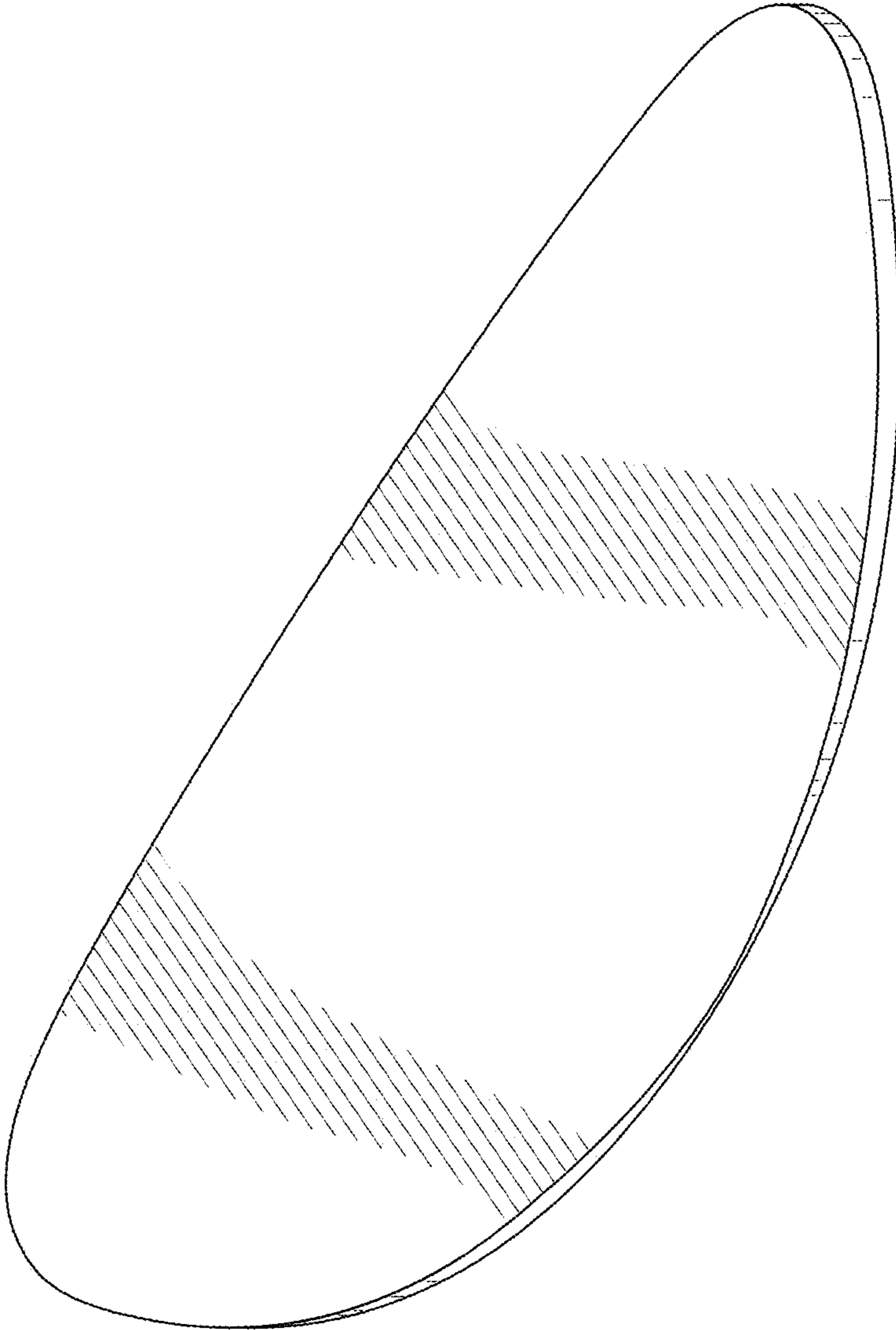

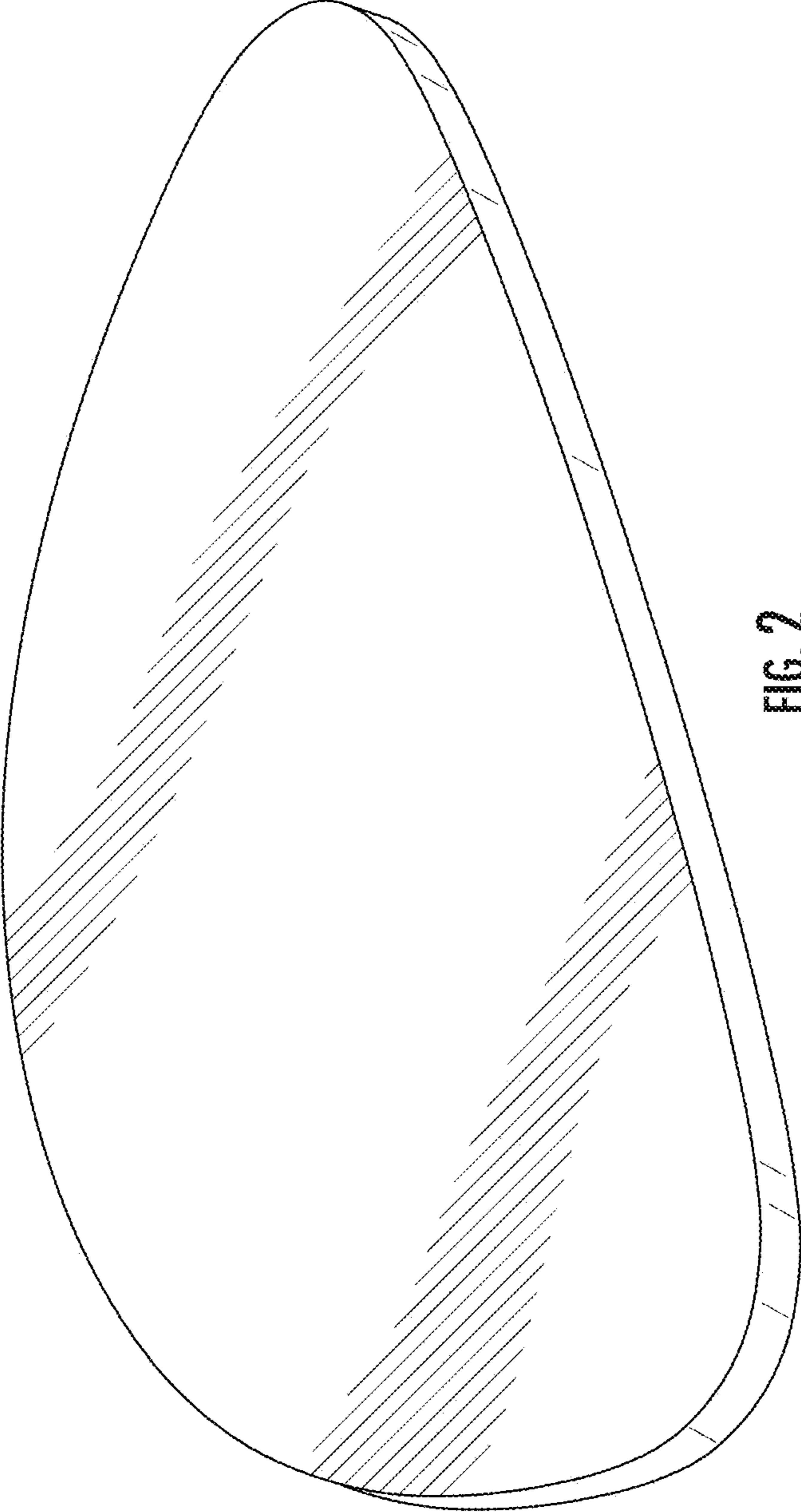

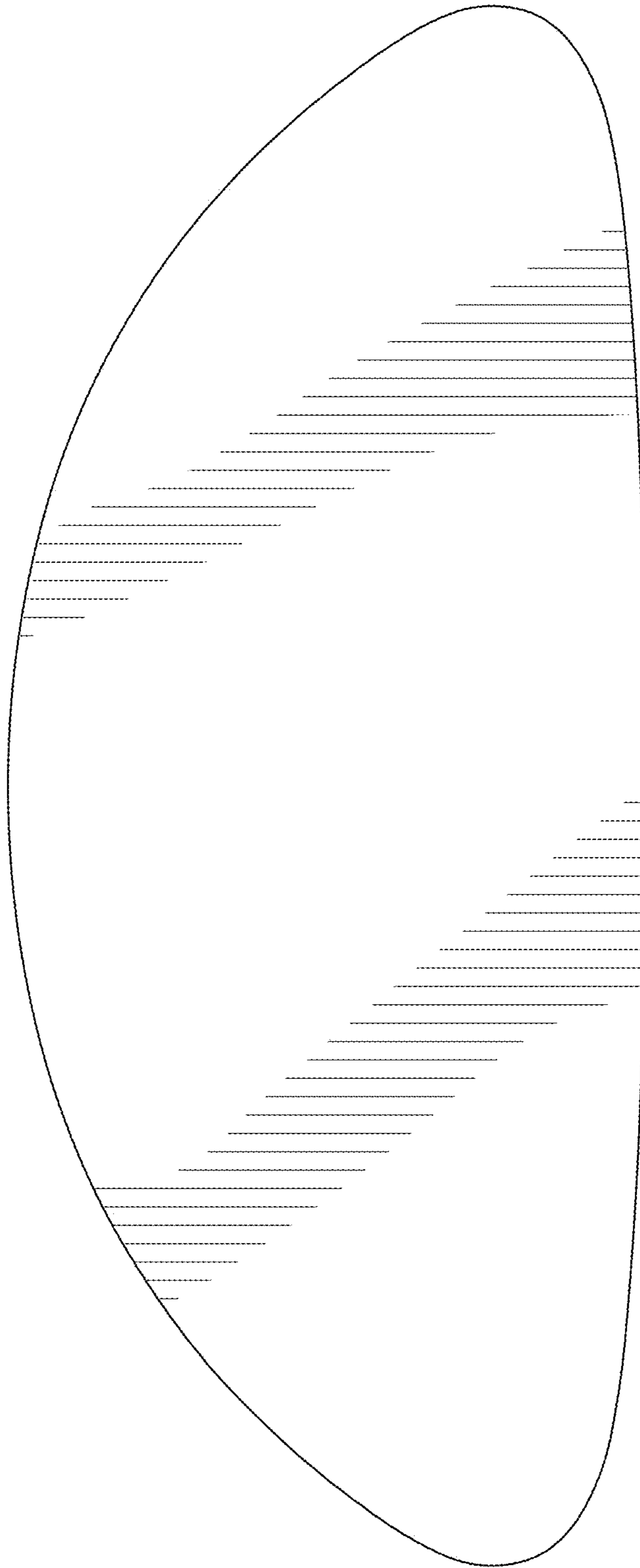

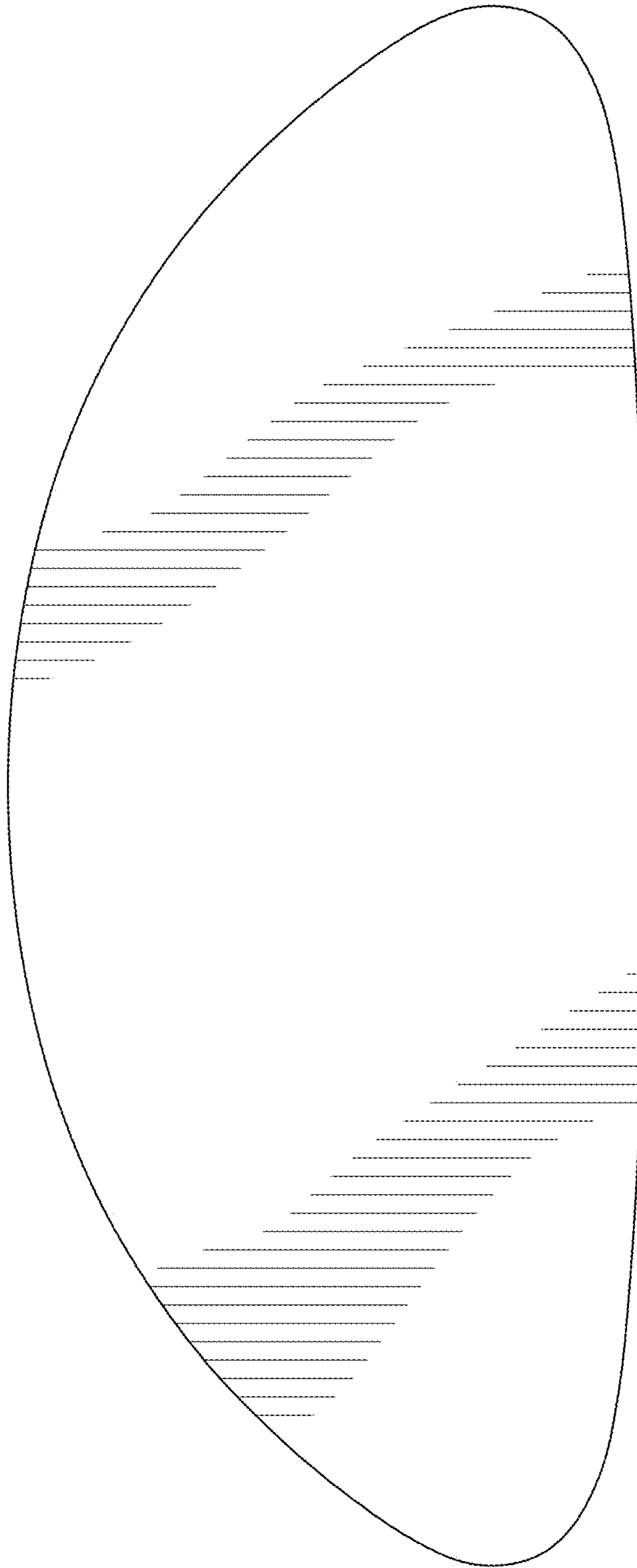

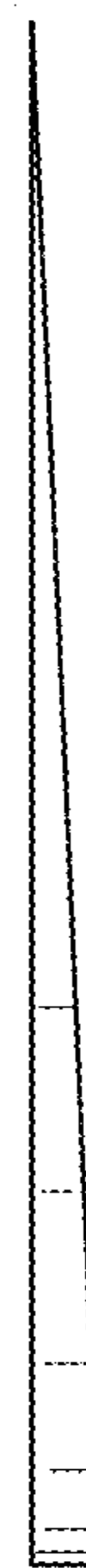

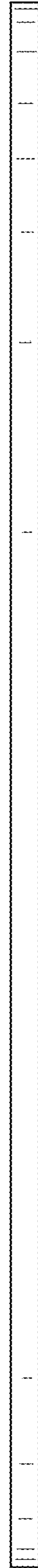
