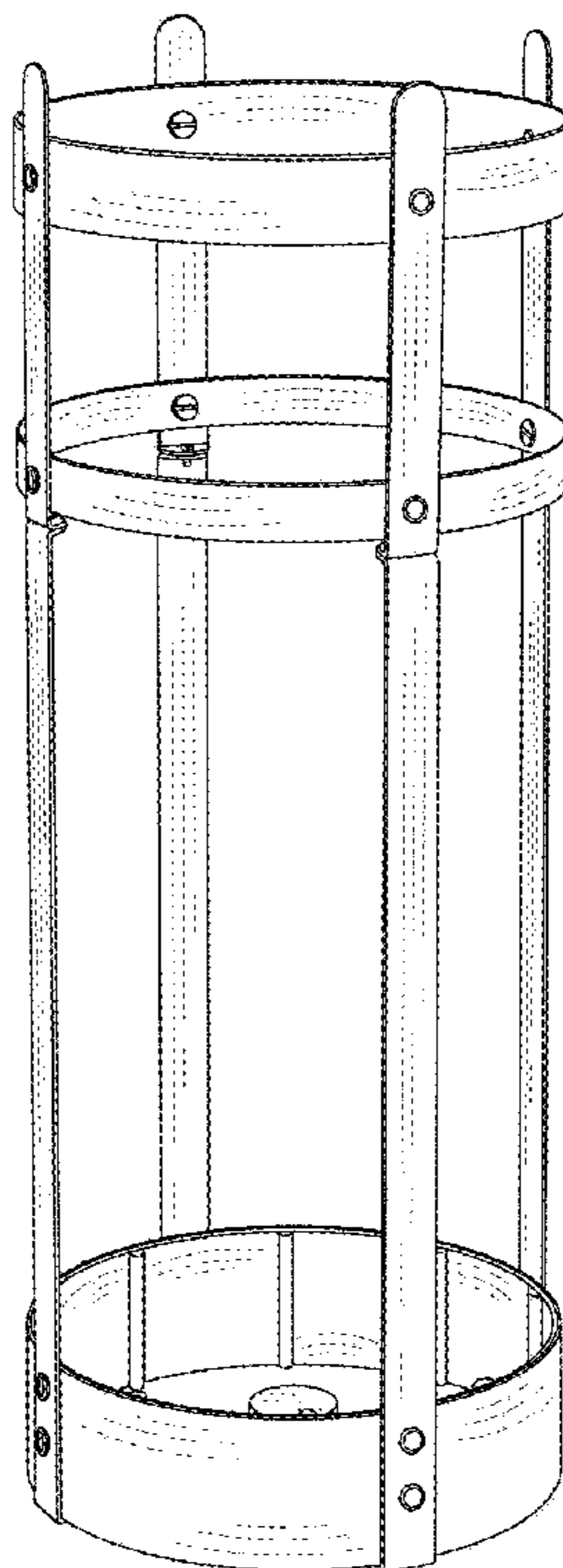
The ornamental design for an umbrella holder, as shown and described.

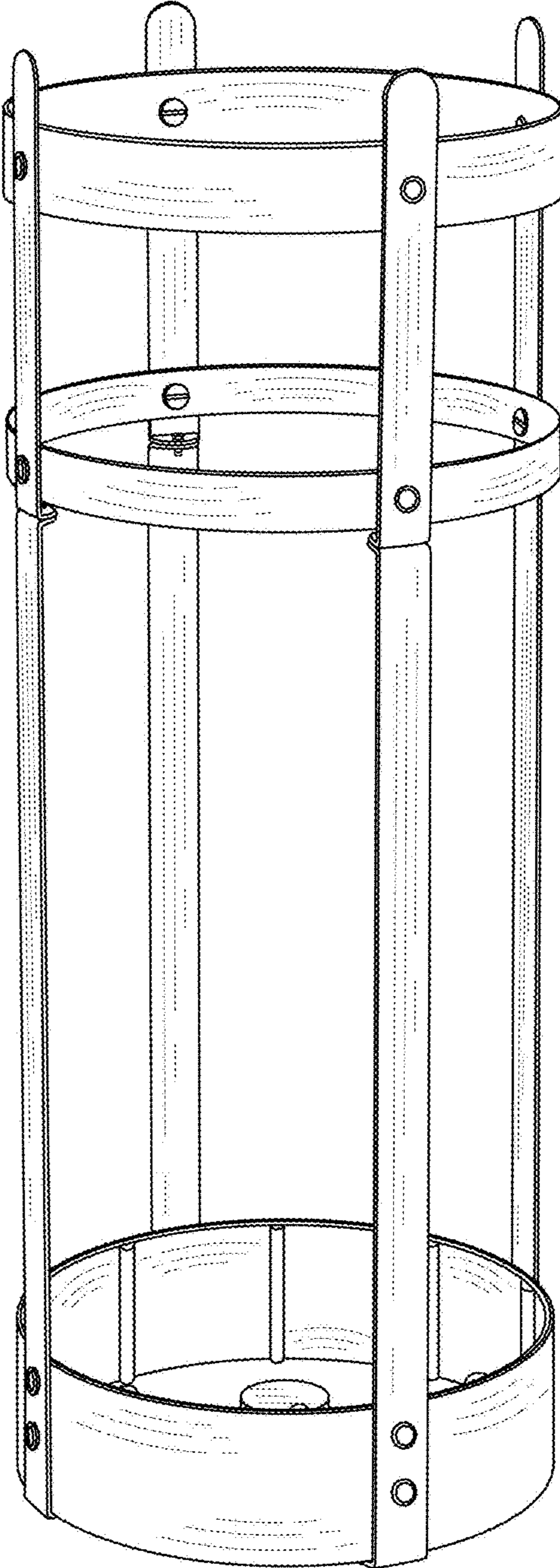

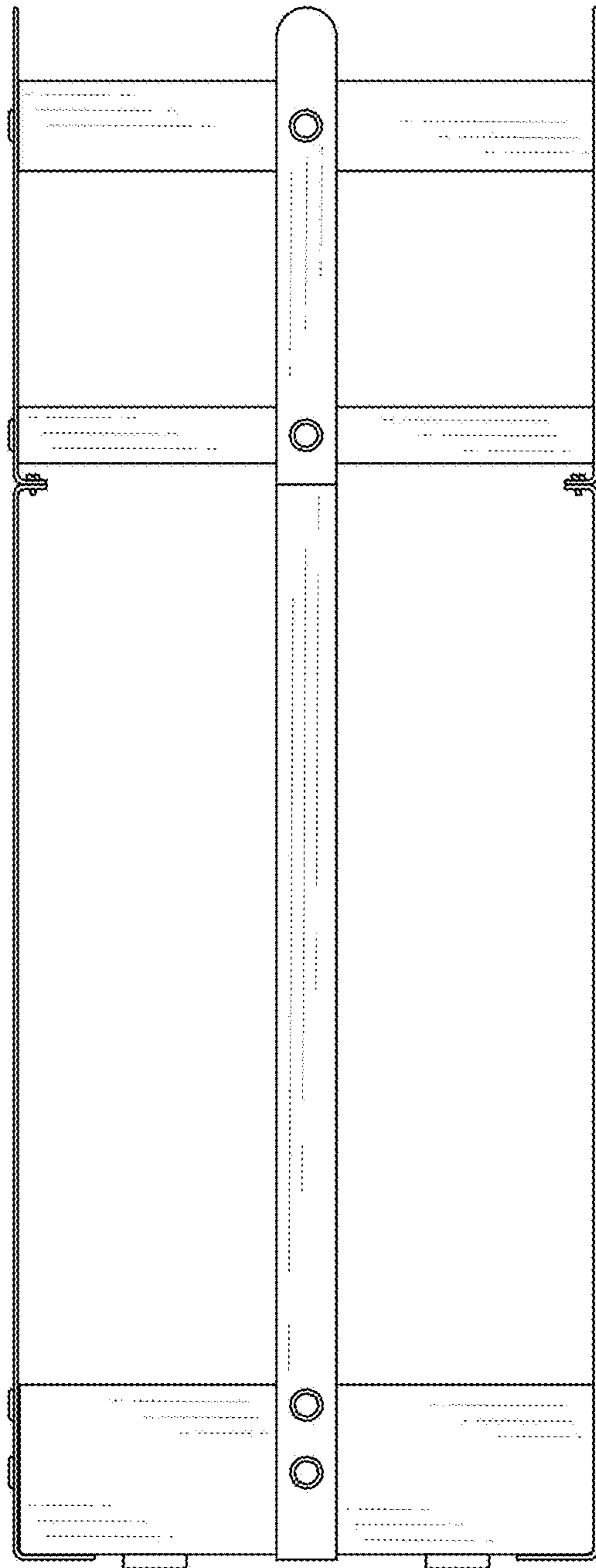

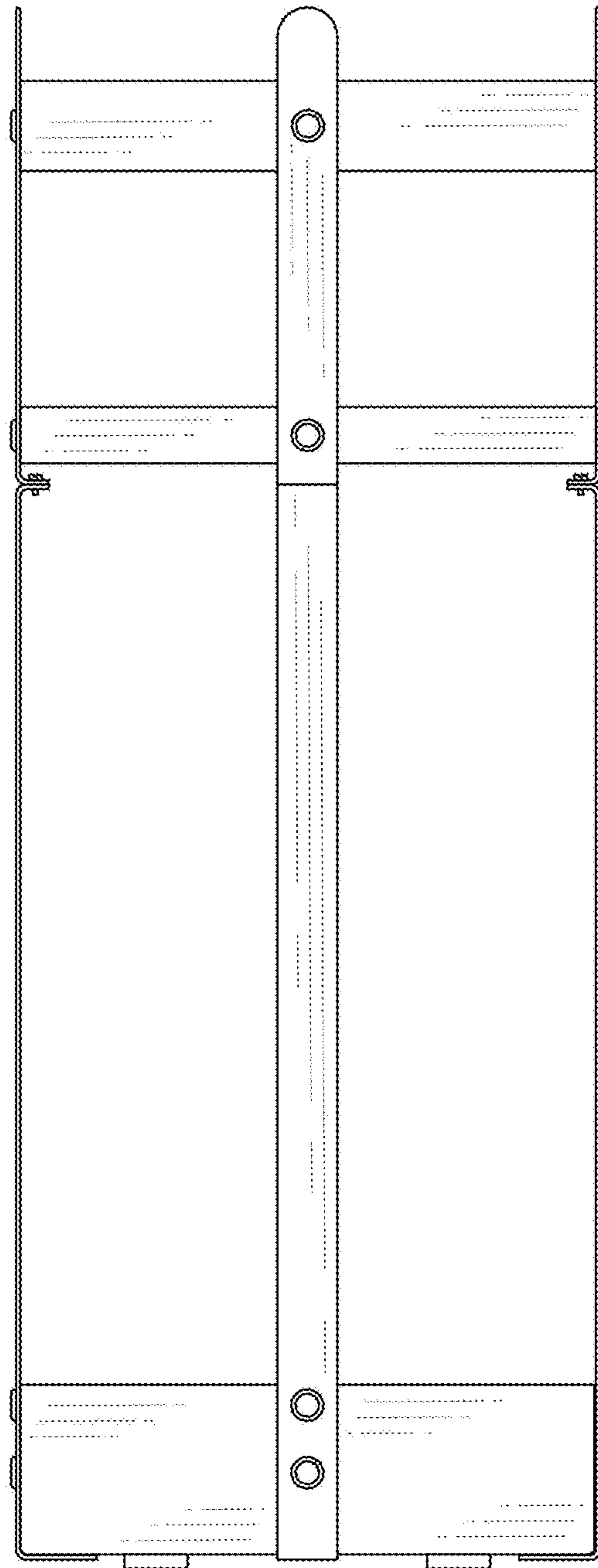

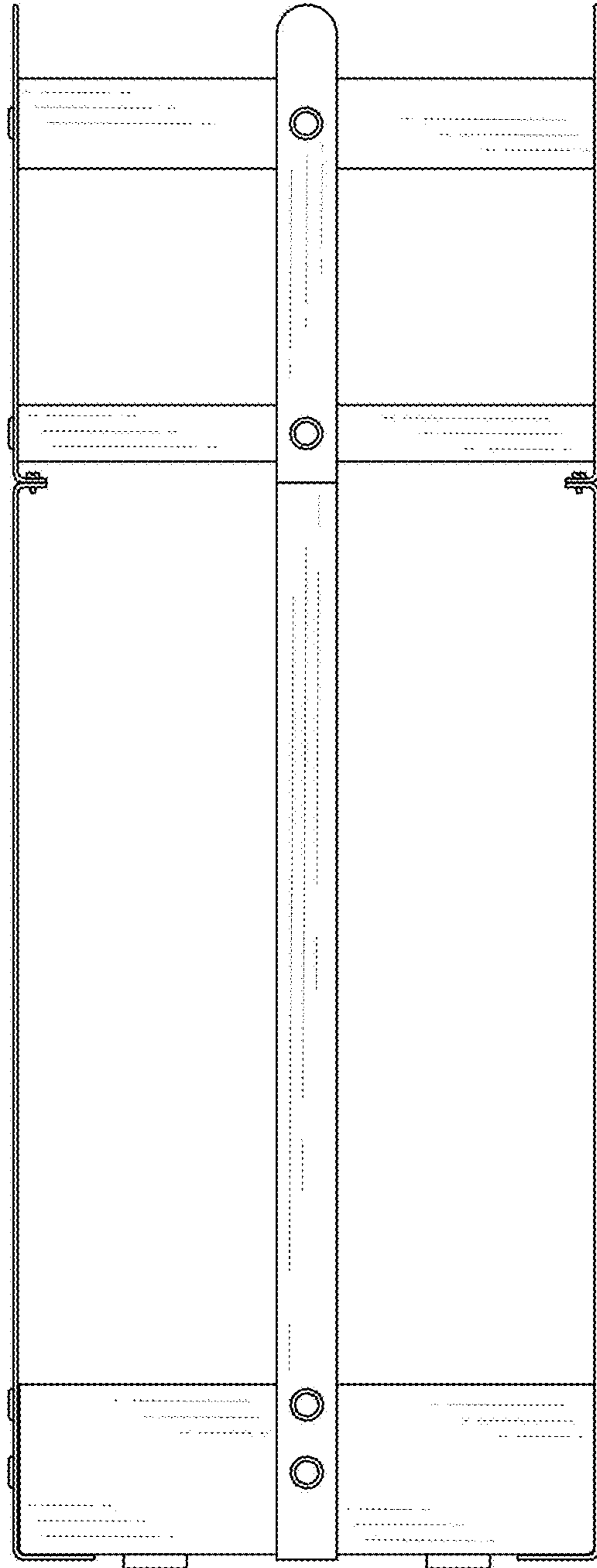

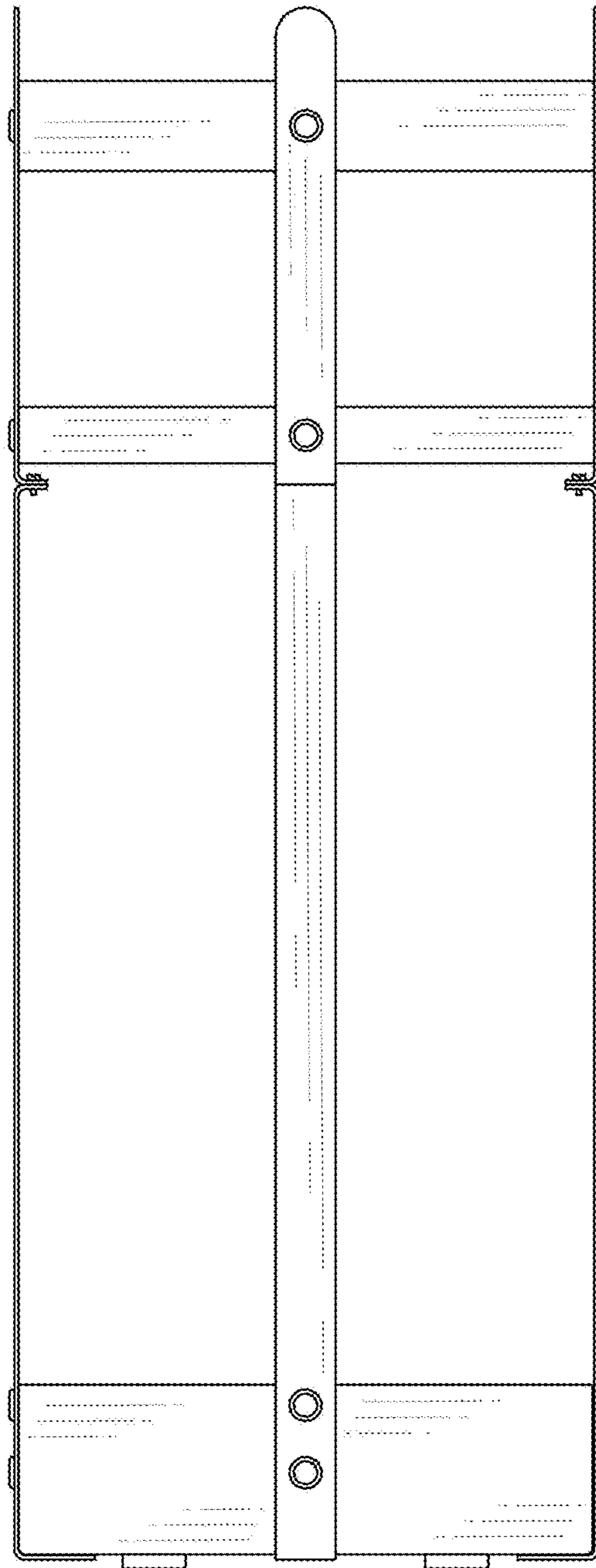

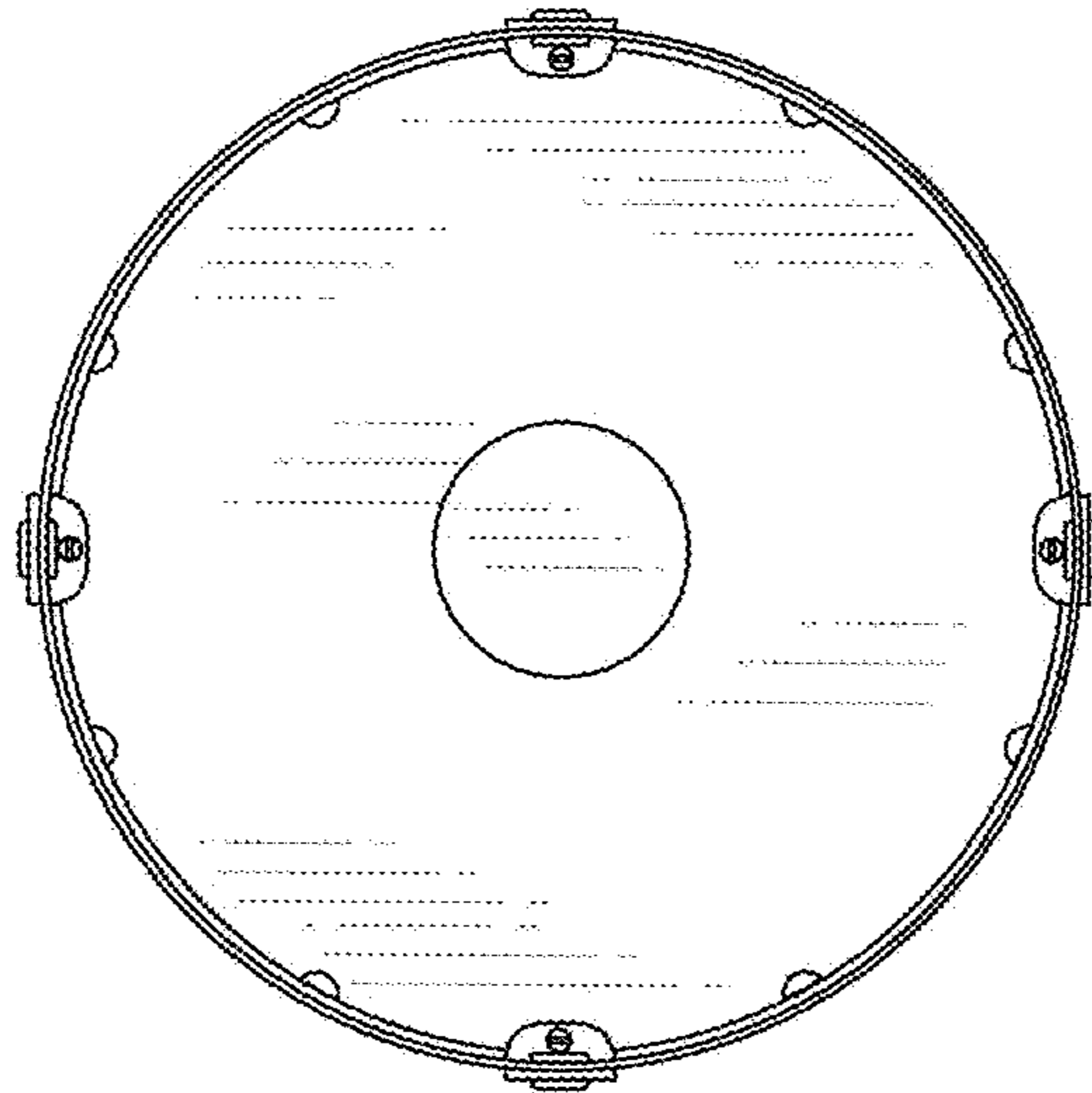

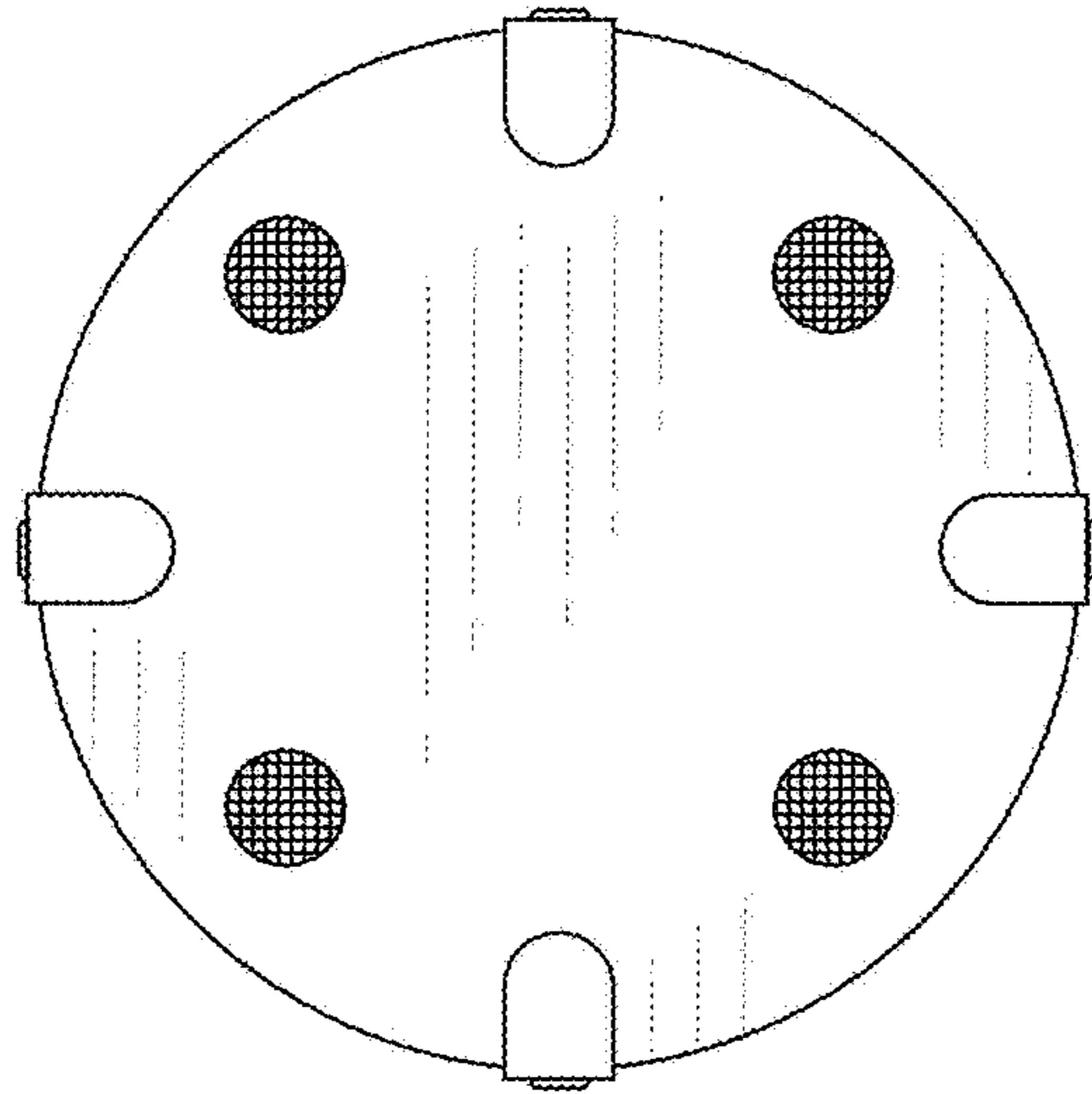
