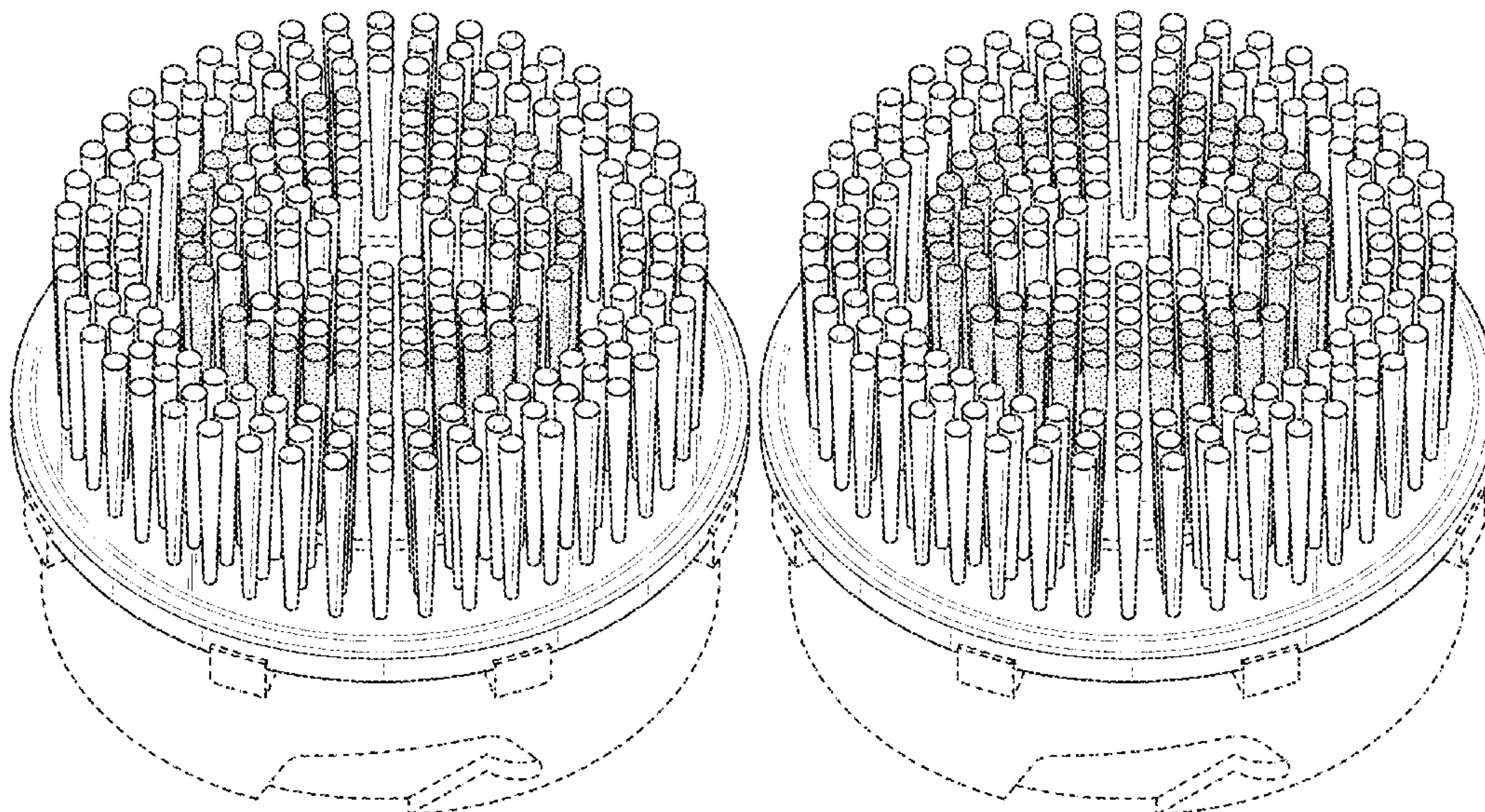
(57) **CLAIM**

The ornamental design of a detachable bristle head for electric face brush, as shown and described.

**DESCRIPTION**

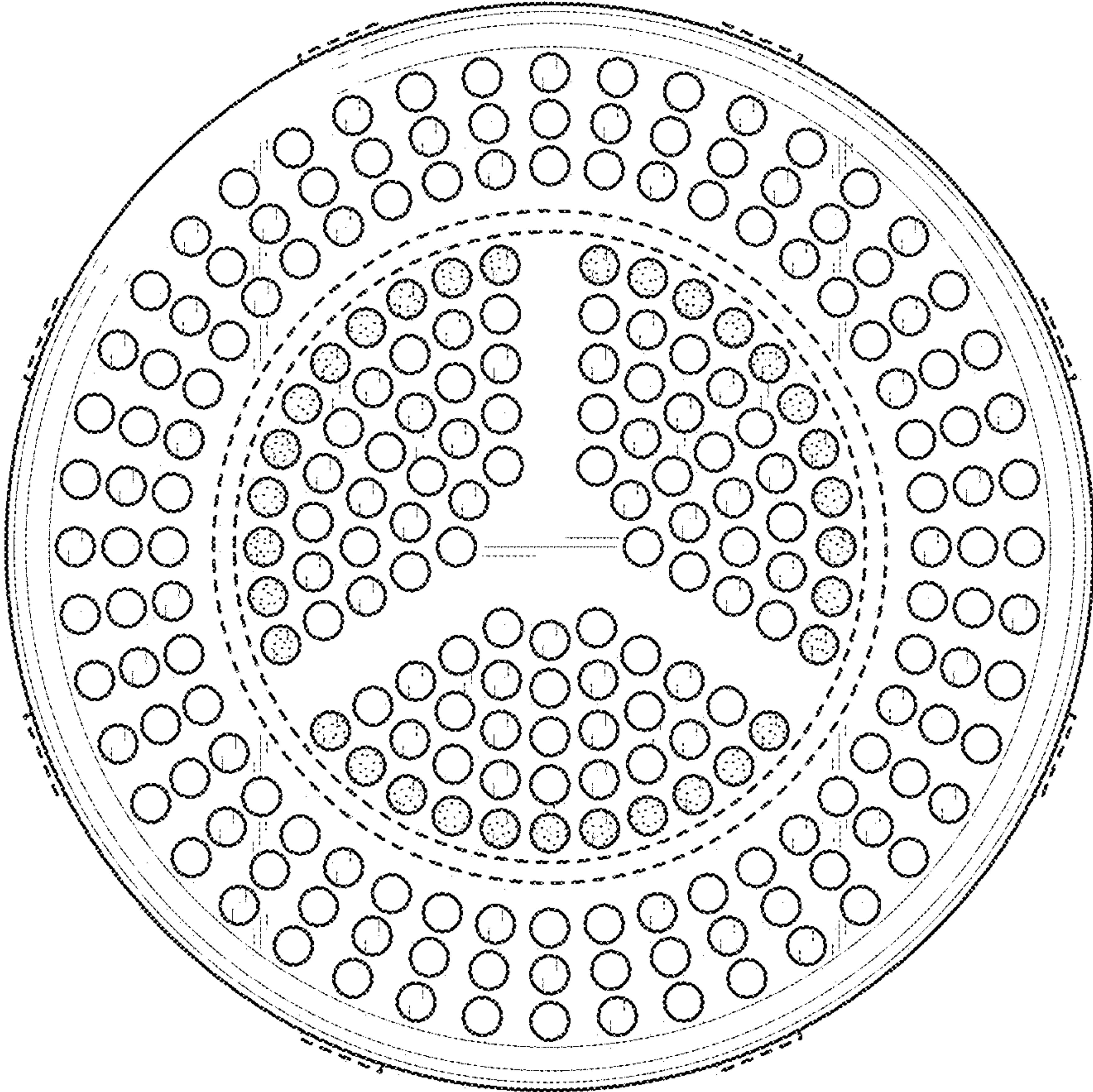

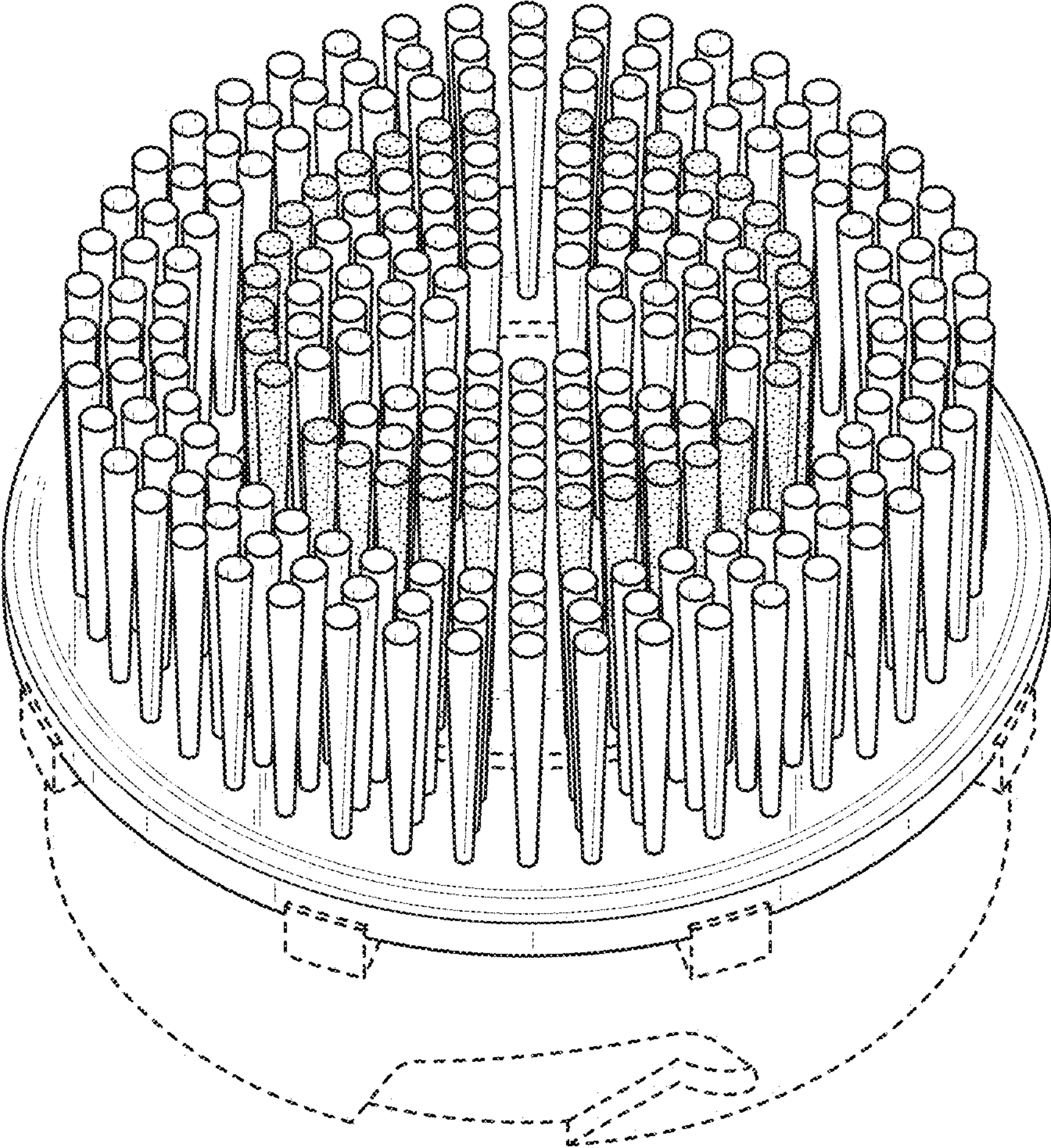

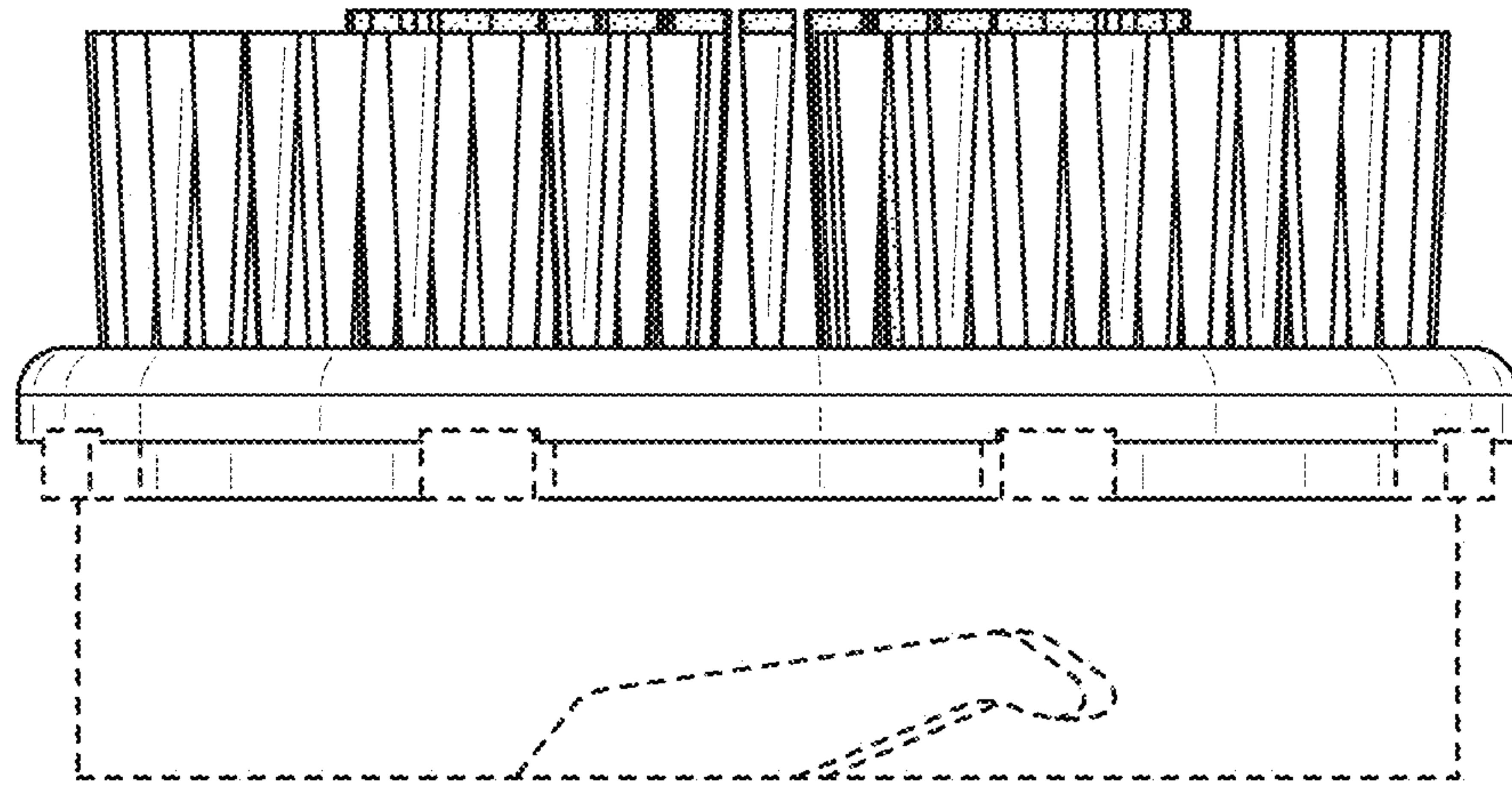

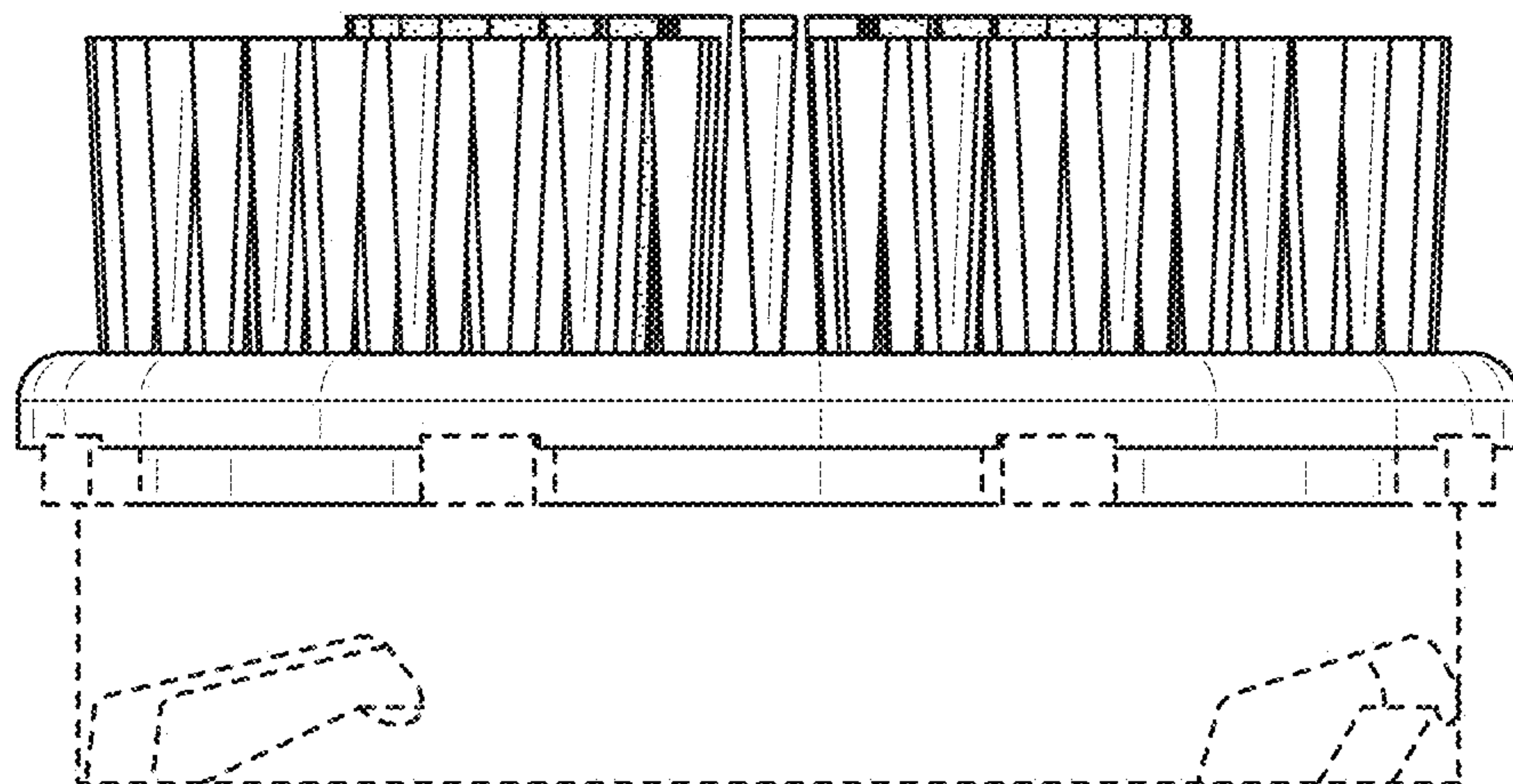

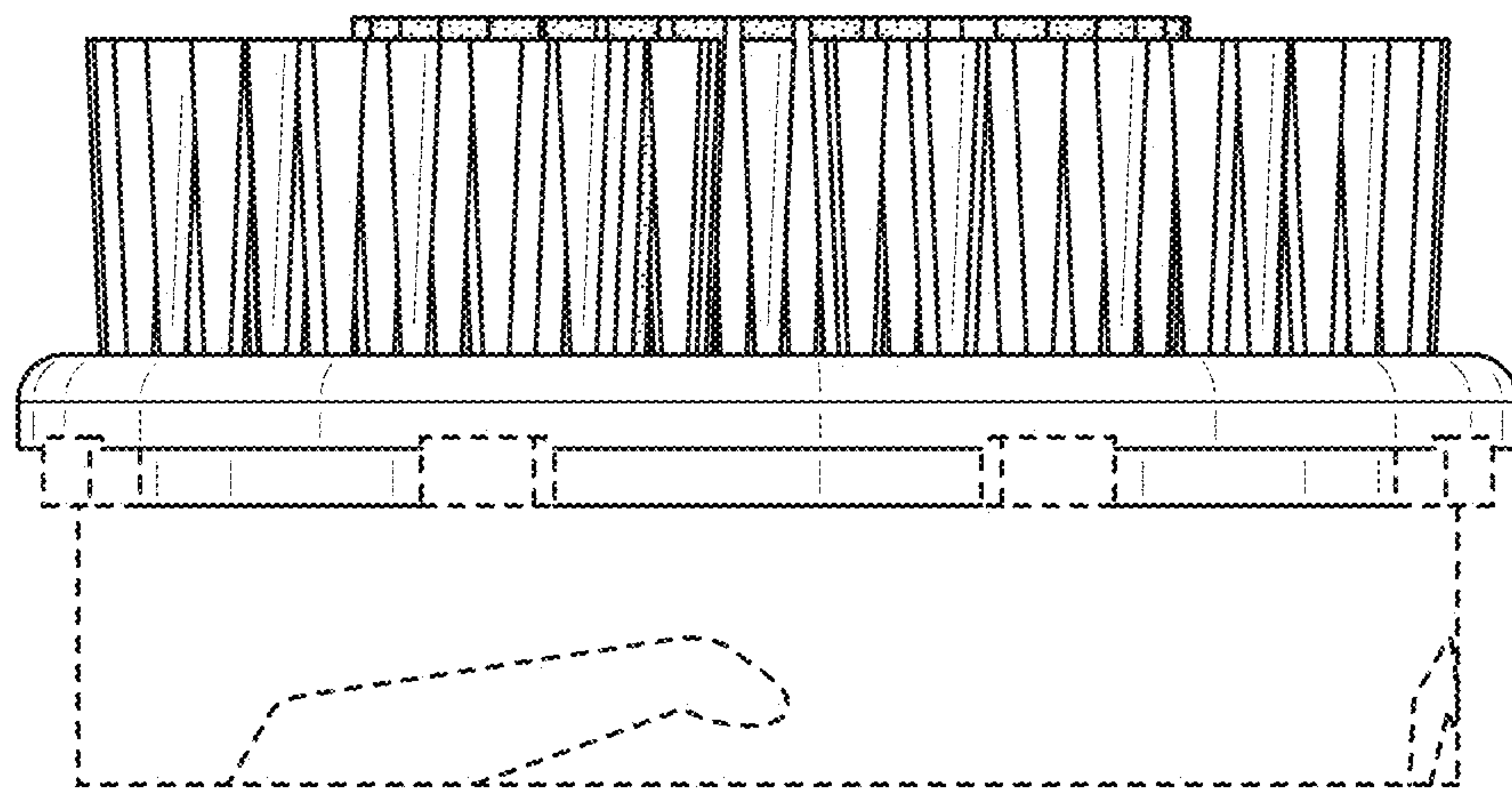

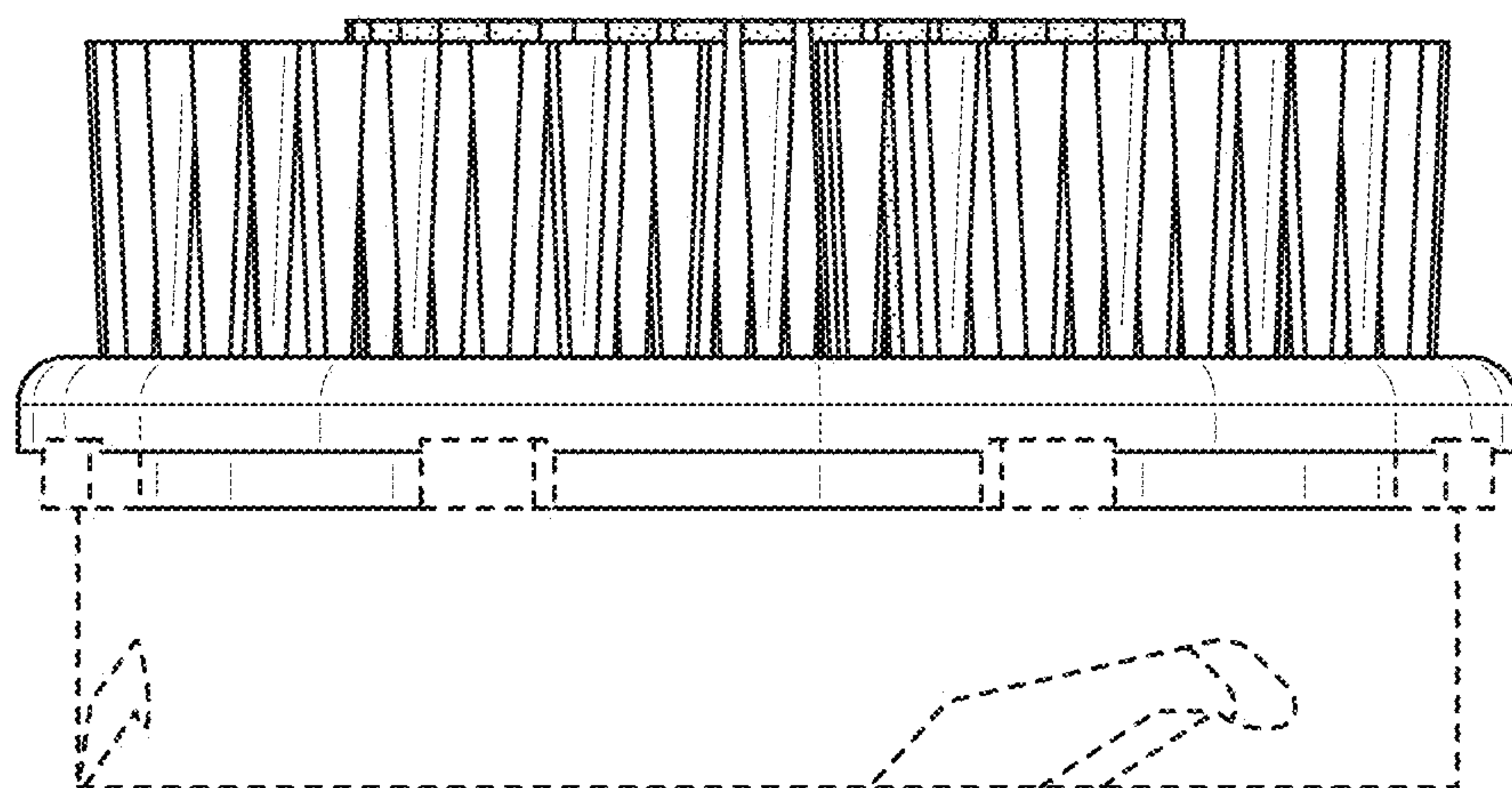

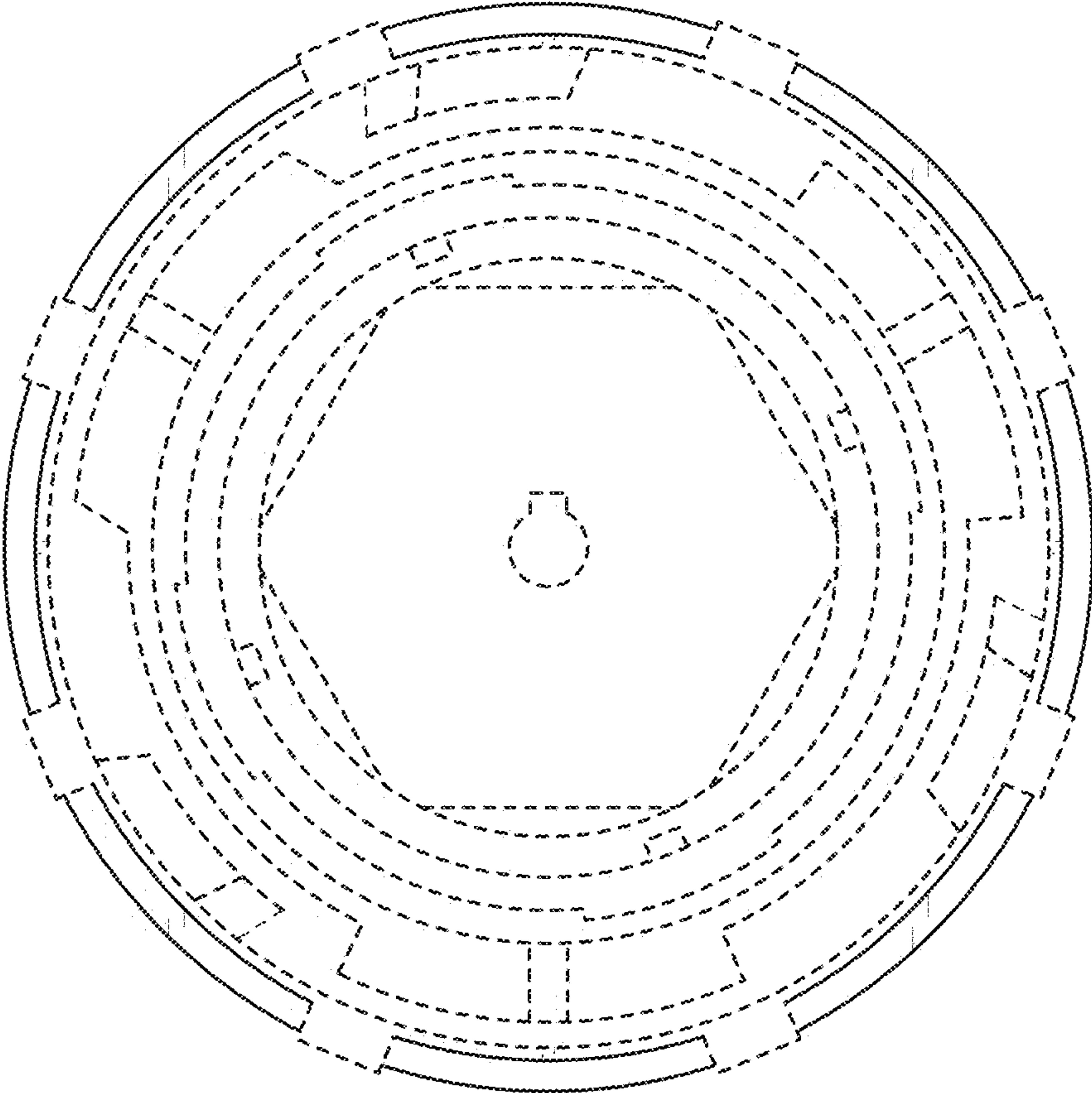

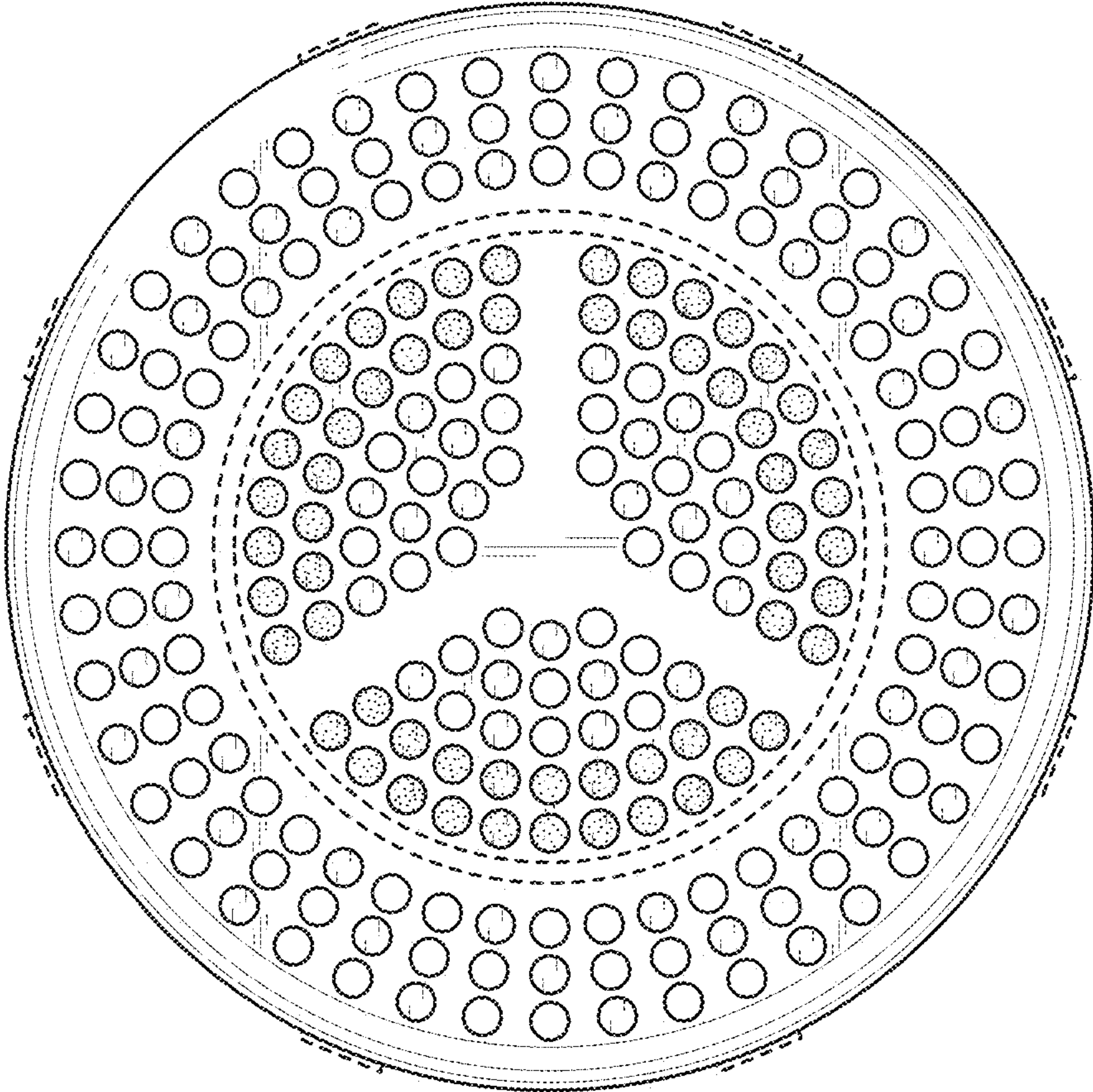

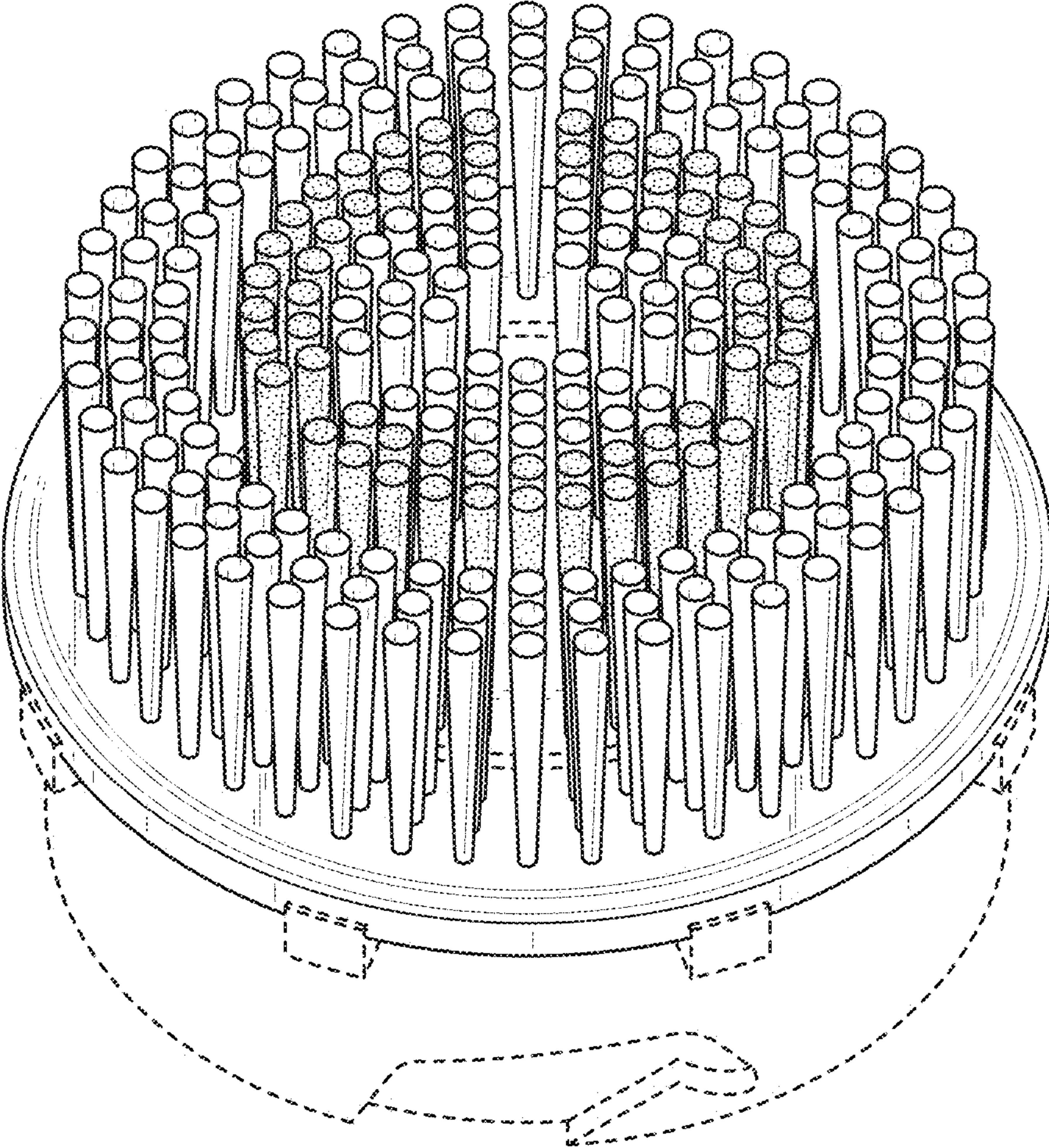

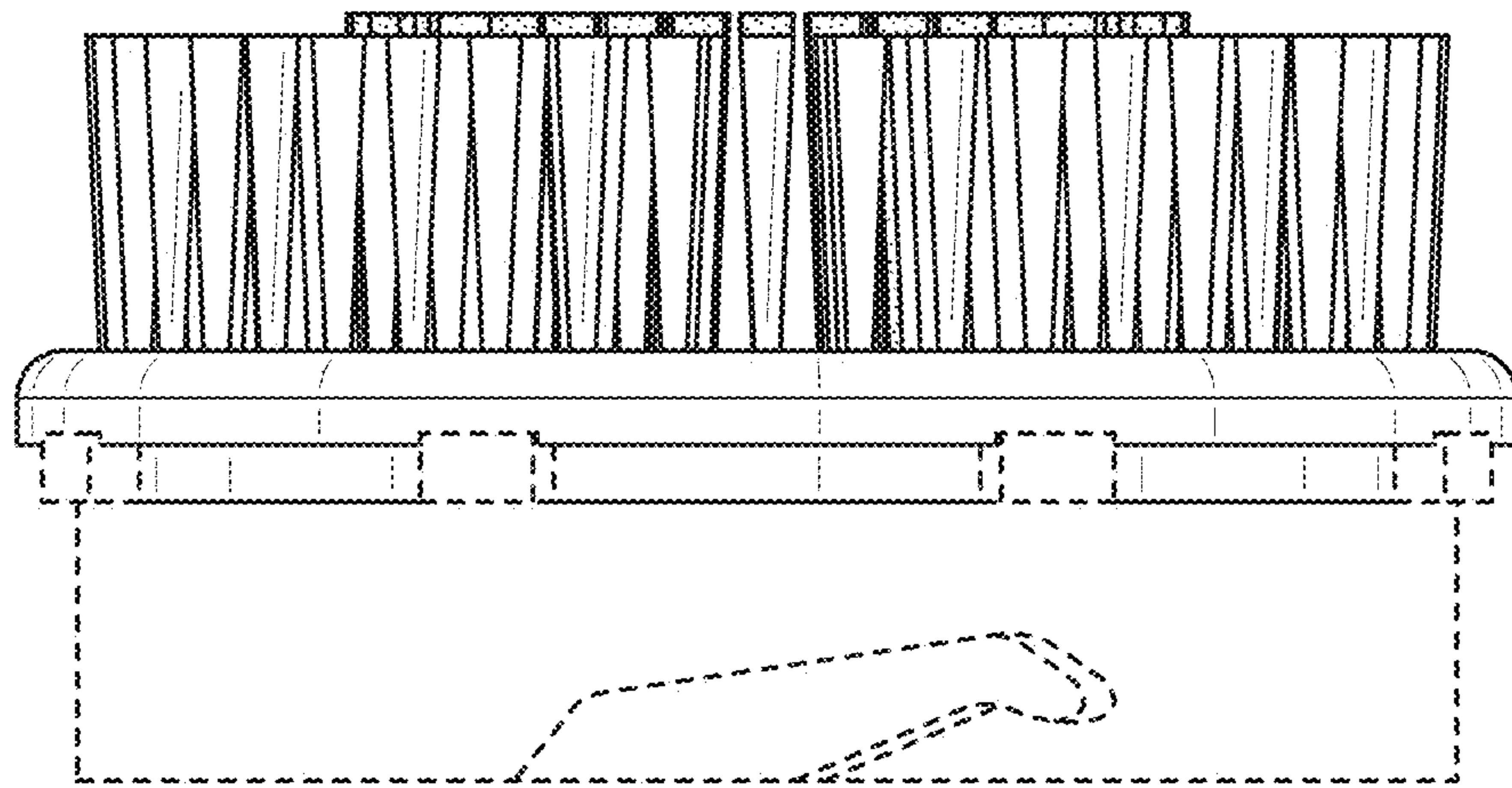

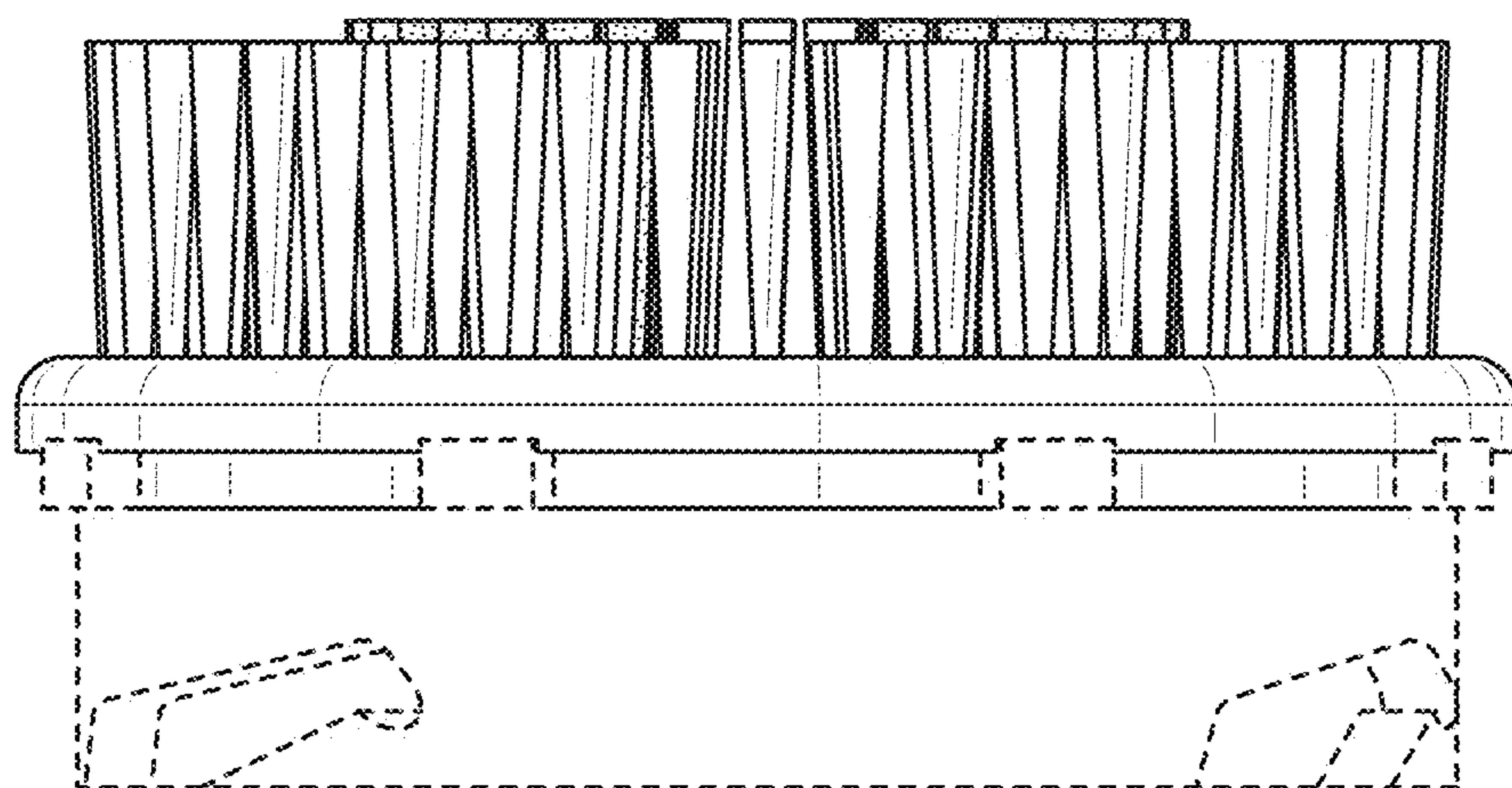

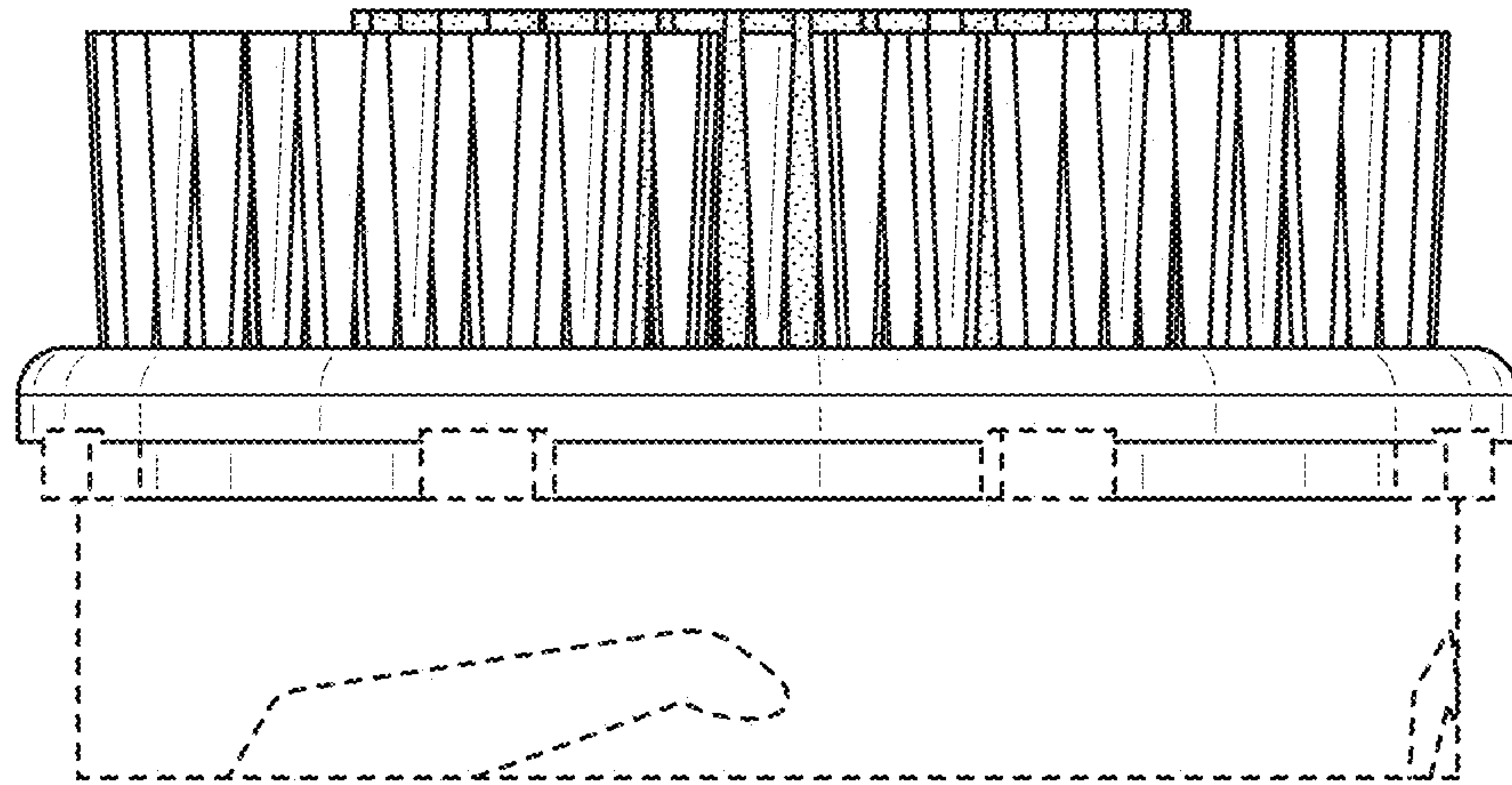

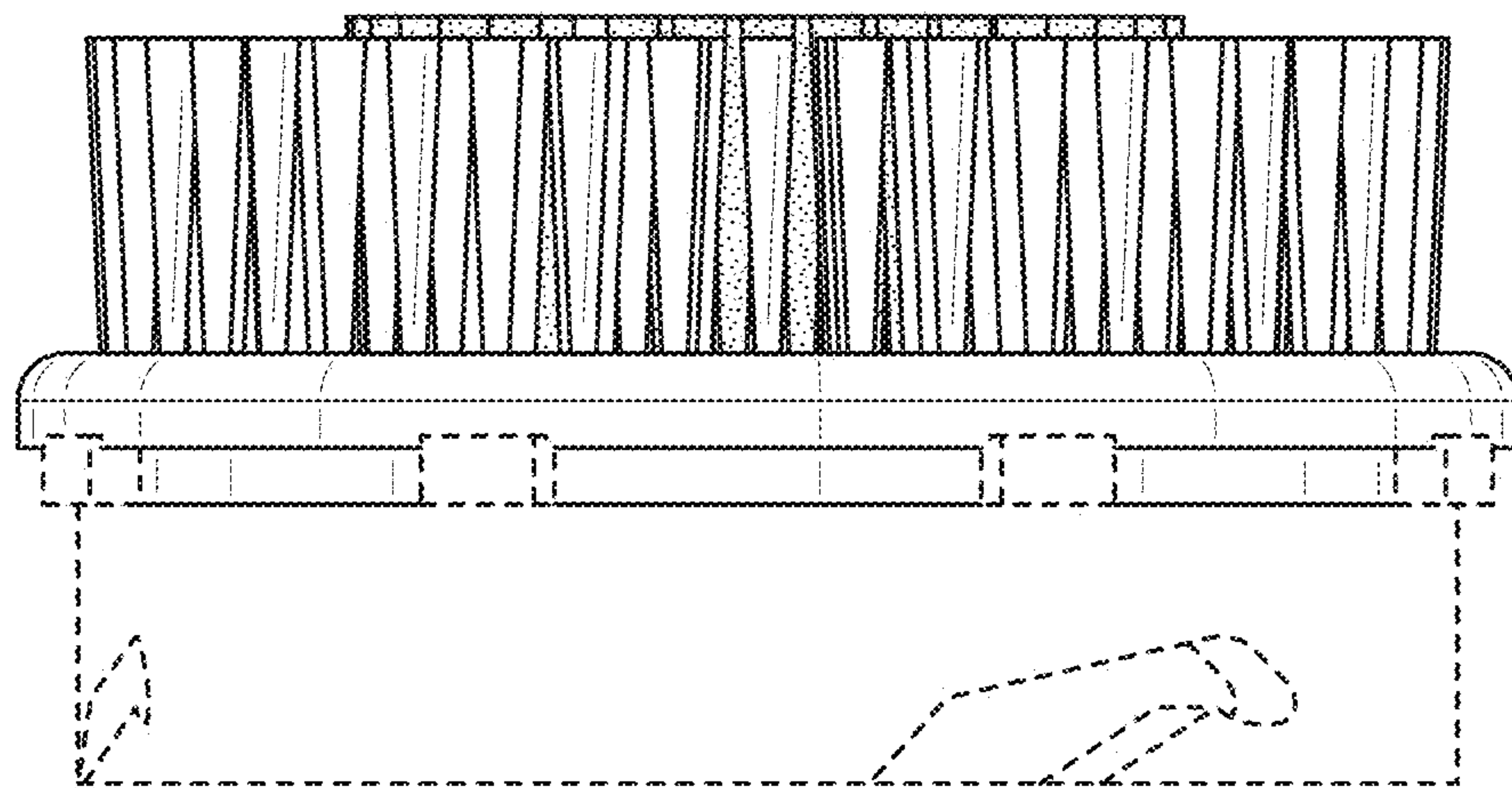

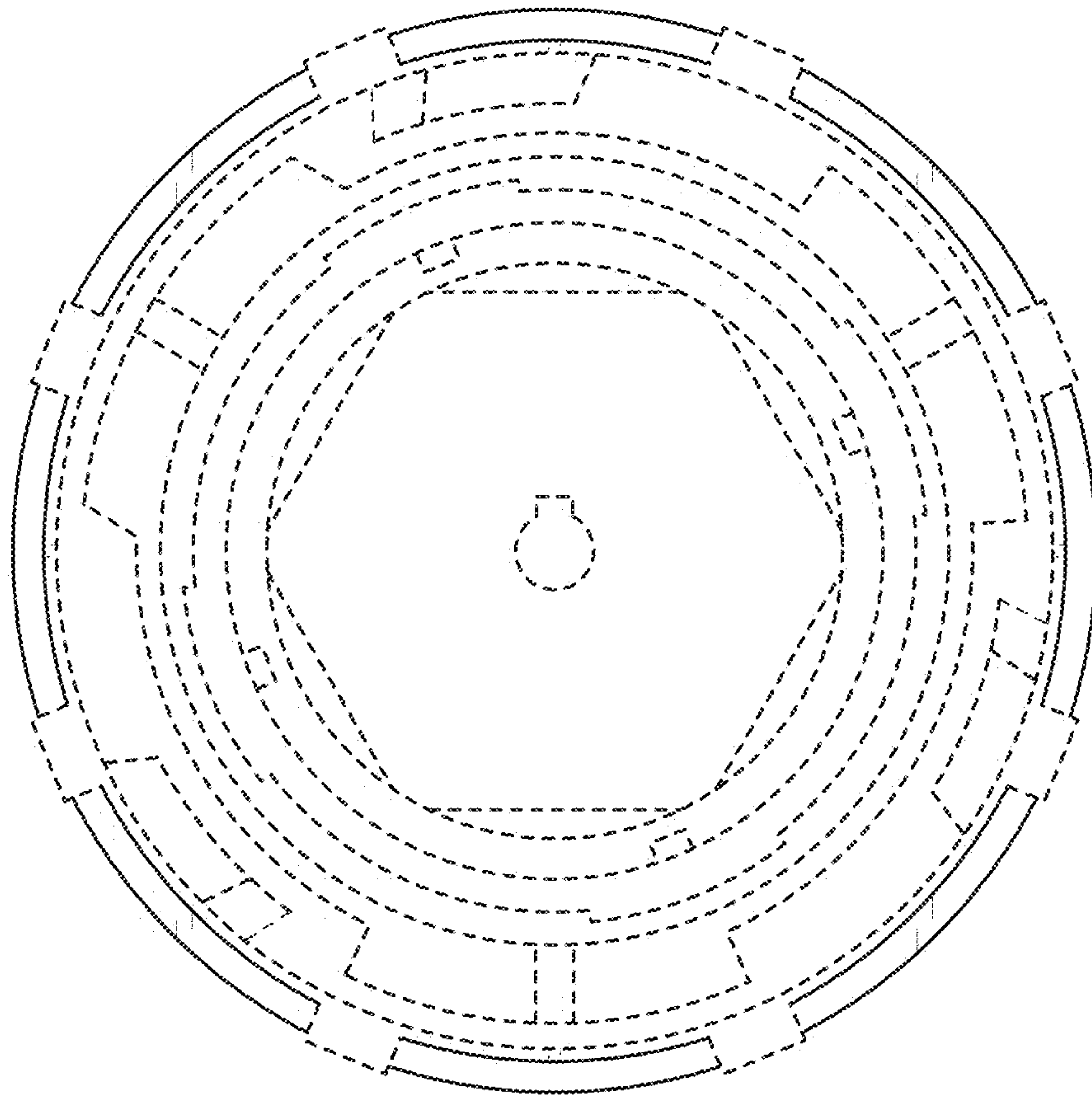
