(57) **CLAIM**

The ornamental design for a modular spa chair, as shown and described.

DESCRIPTION

This application is related to application Ser. No. 29/722,624, application Ser. No. 29/722,632, and application Ser. No. 29/722,639, all of which are concurrently filed herewith and entitled Modular Spa Chair, and the disclosures all of which are incorporated herein by reference.

FIG. 1 is a front perspective view of a modular spa chair according to a first embodiment of our new design with the arms in a closed position;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 8 is a front perspective view of the modular spa chair with the arms in an open position according to the first embodiment;

FIG. 9 is a side perspective view of FIG. 8;

FIG. 10 is a front perspective view of a modular spa chair according to a second embodiment of our new design in a reclined position;

FIG. 11 is a front elevation view thereof;

FIG. 12 is a rear elevation view thereof;

FIG. 13 is a right side elevation view thereof;

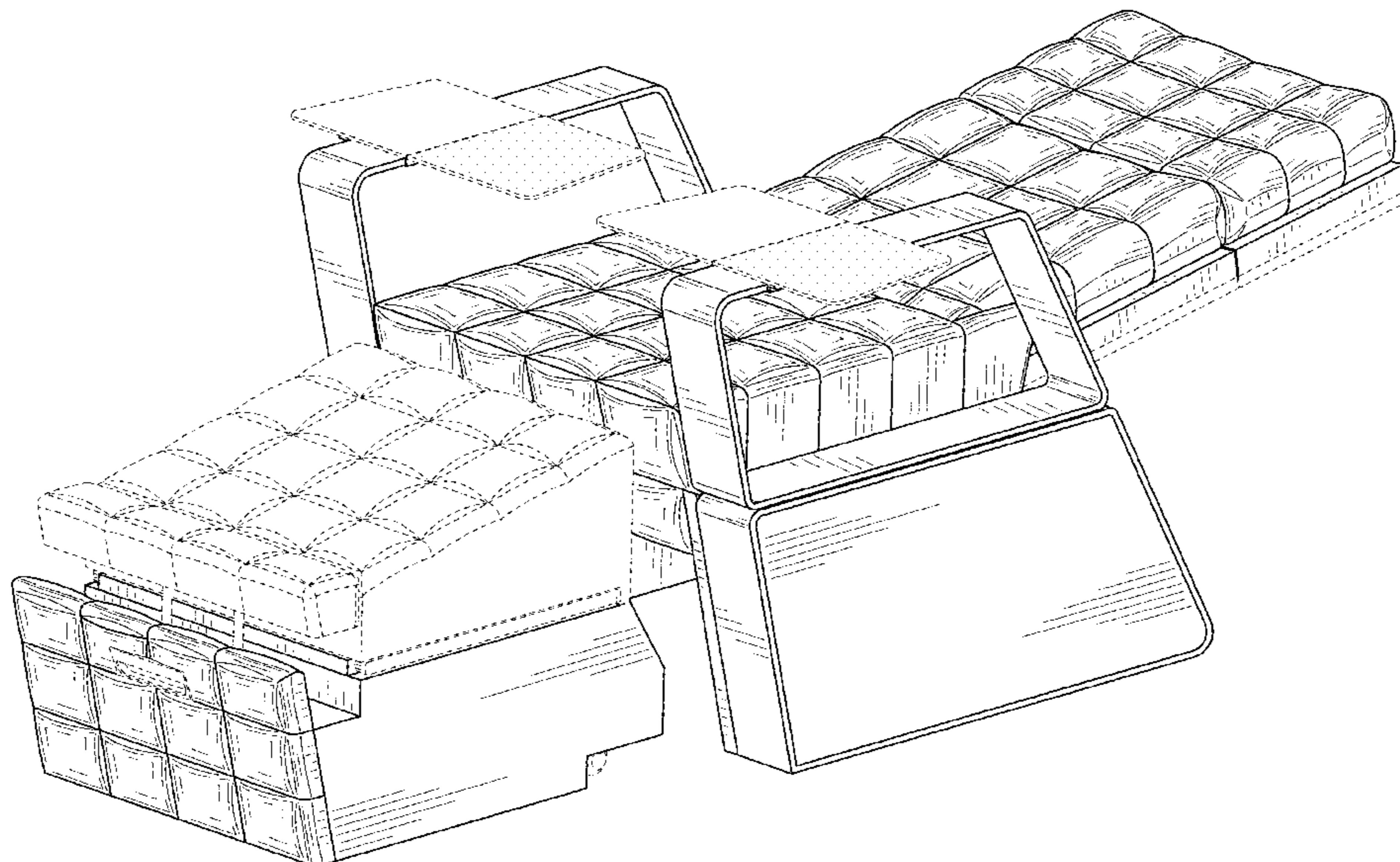
FIG. 14 is a left side elevation view thereof;

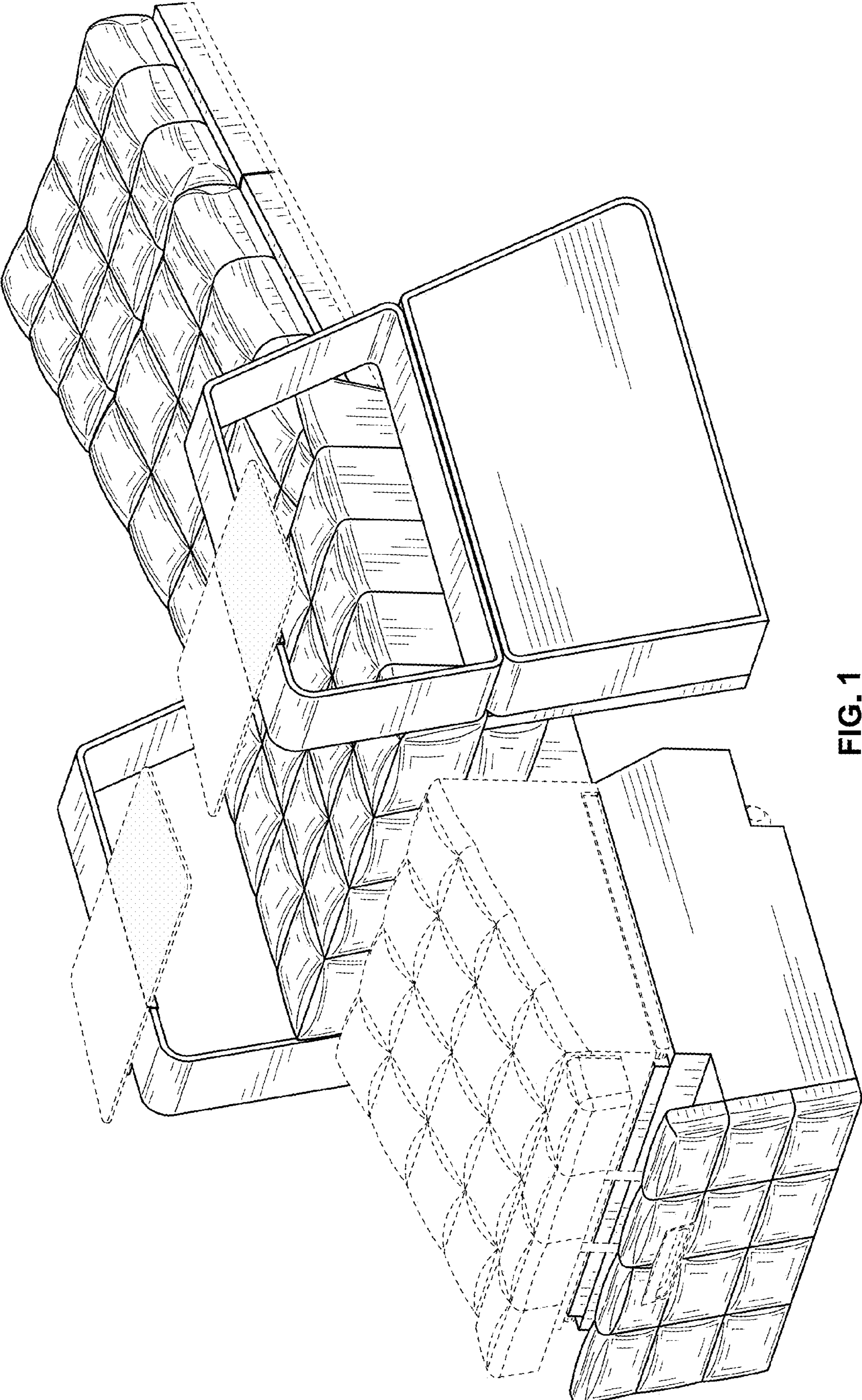

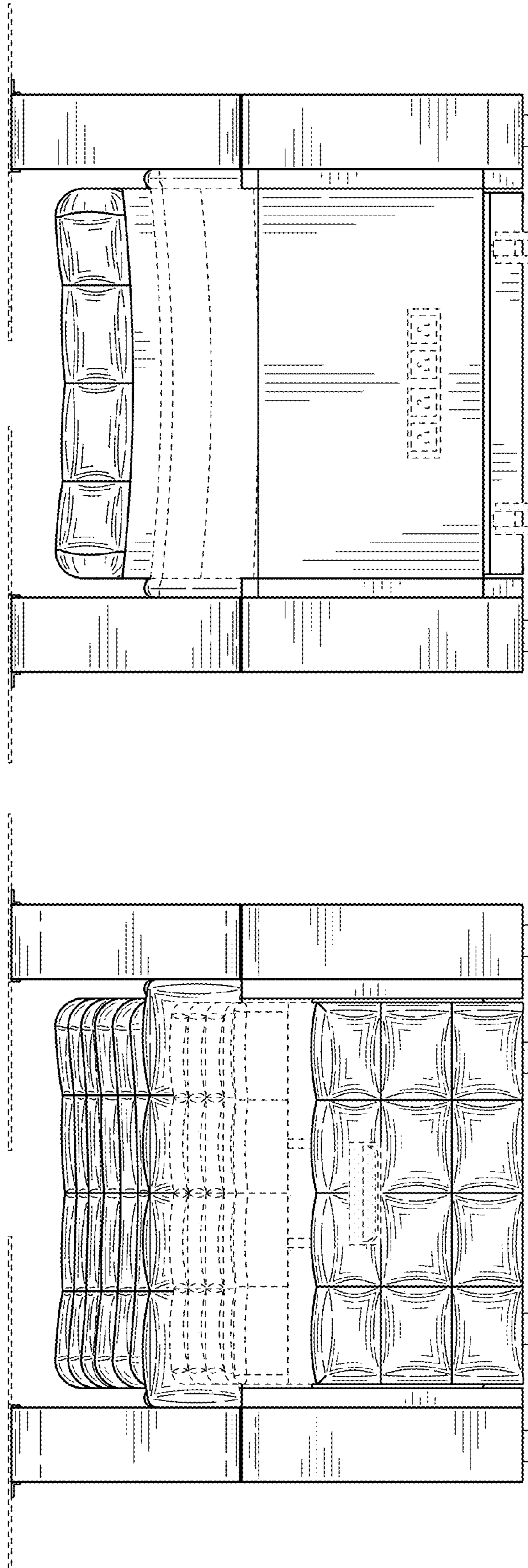

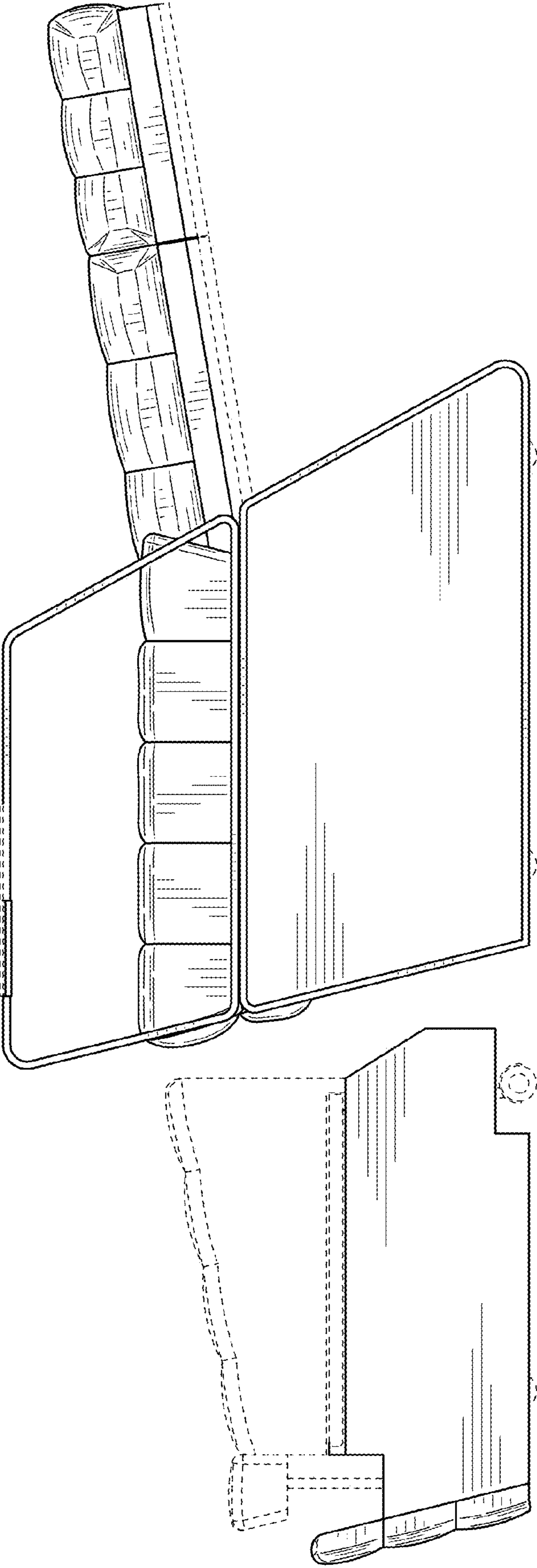

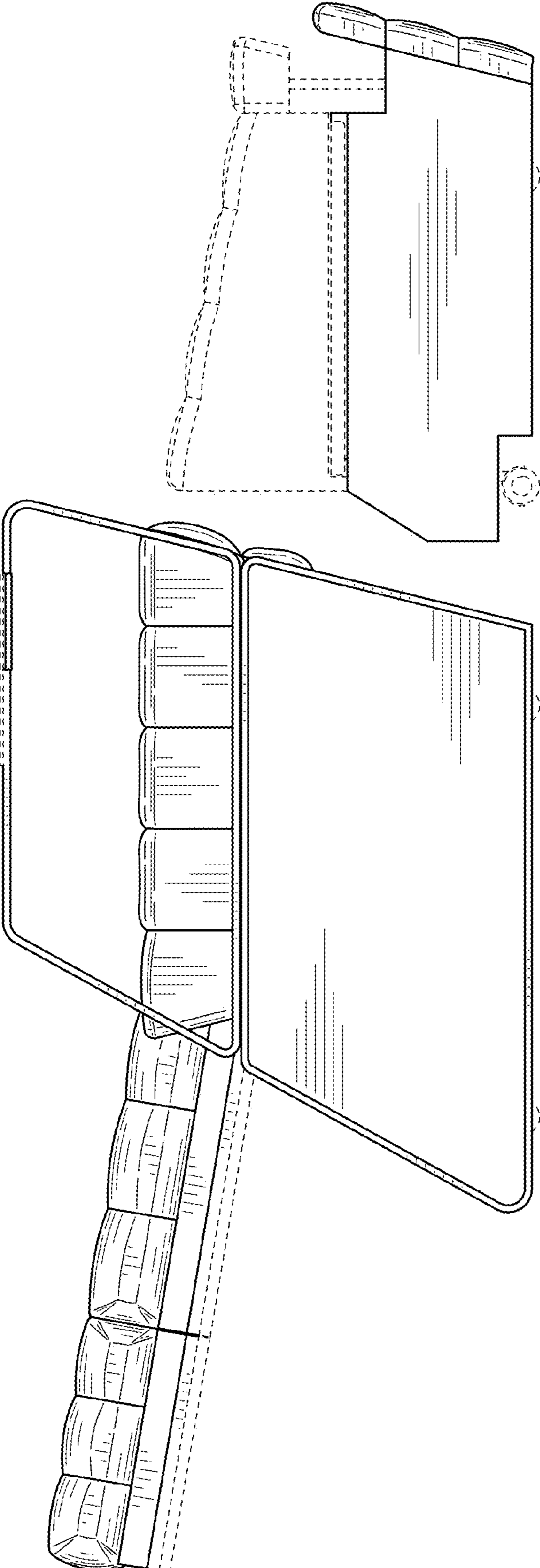

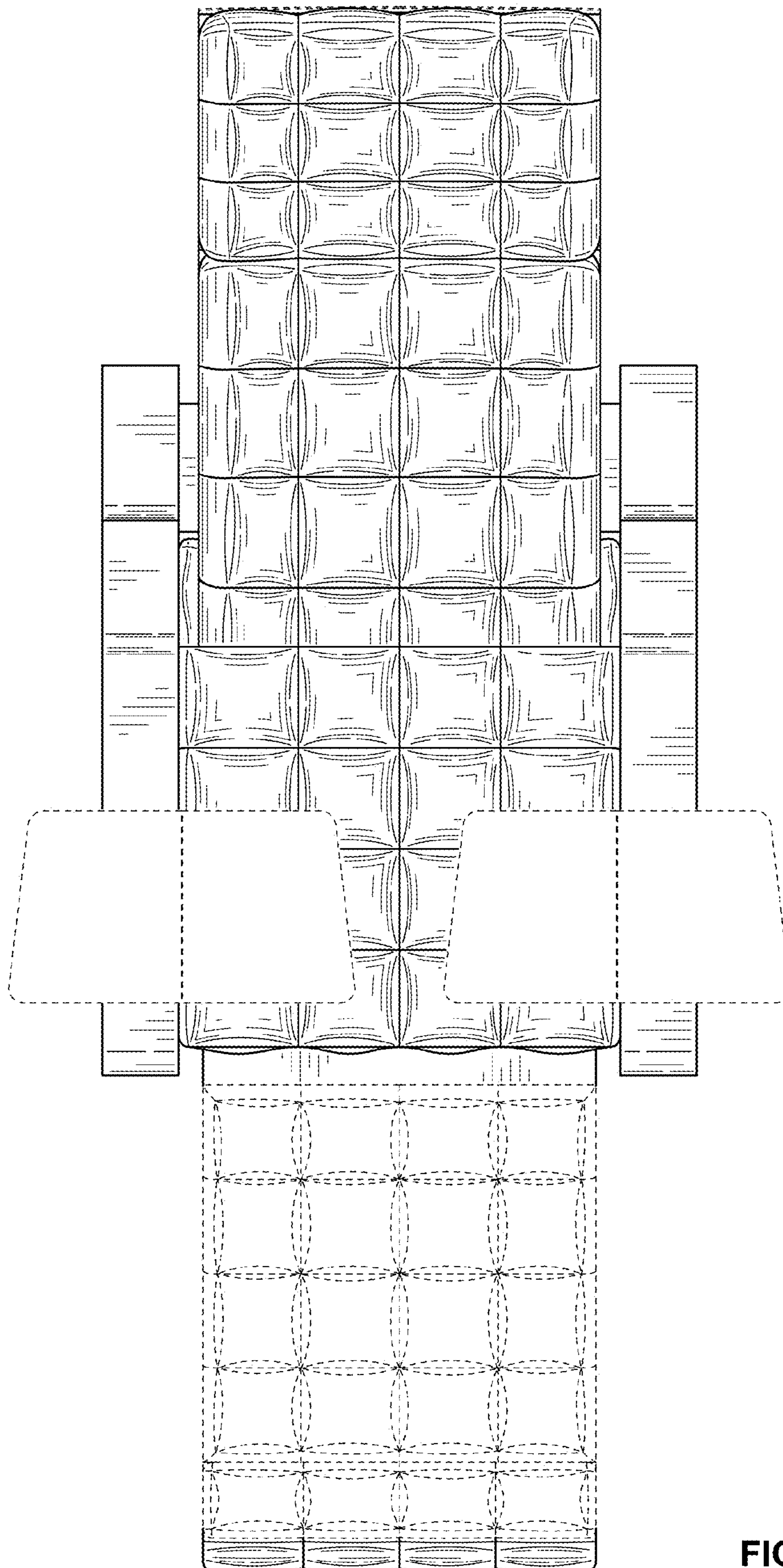

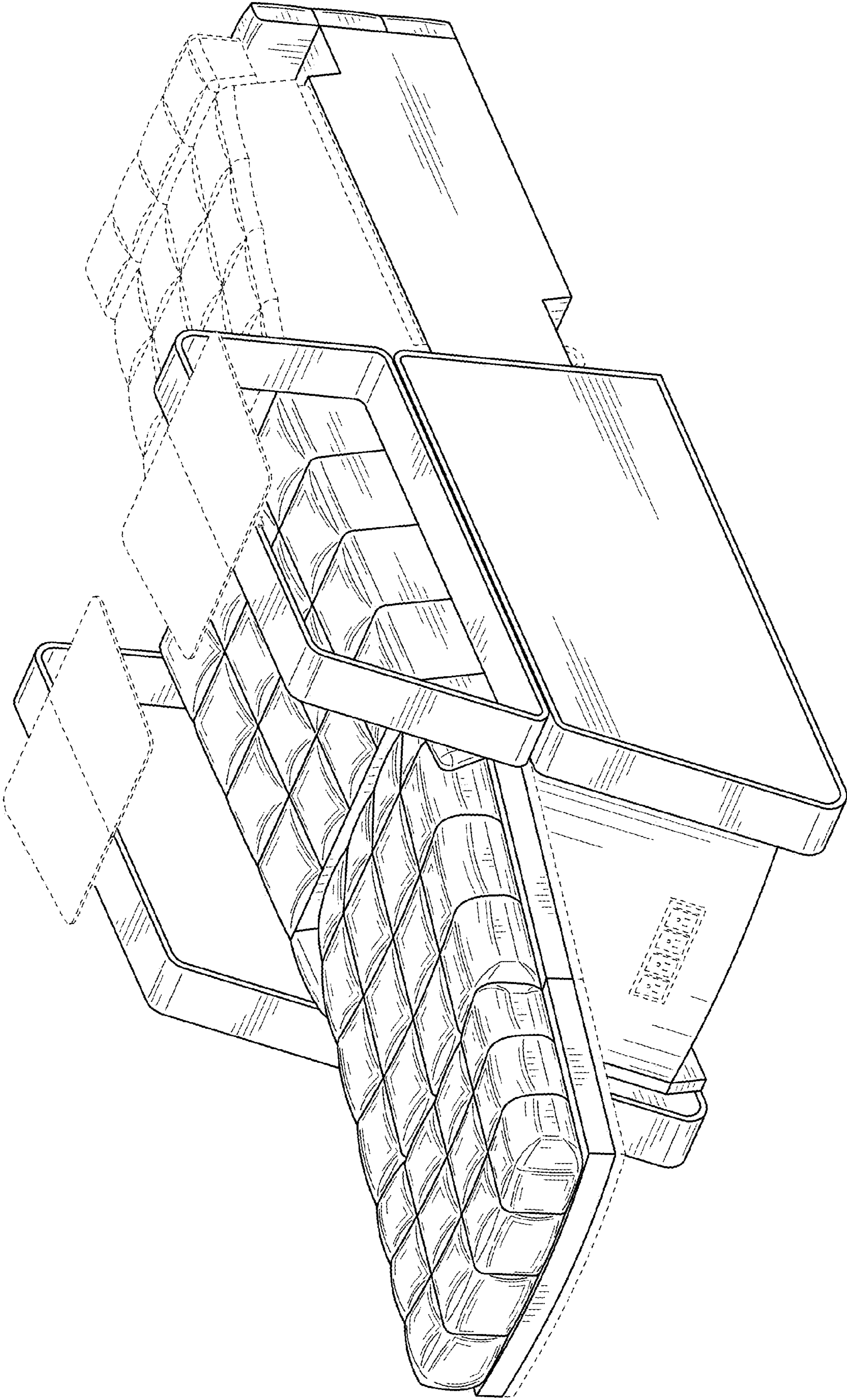

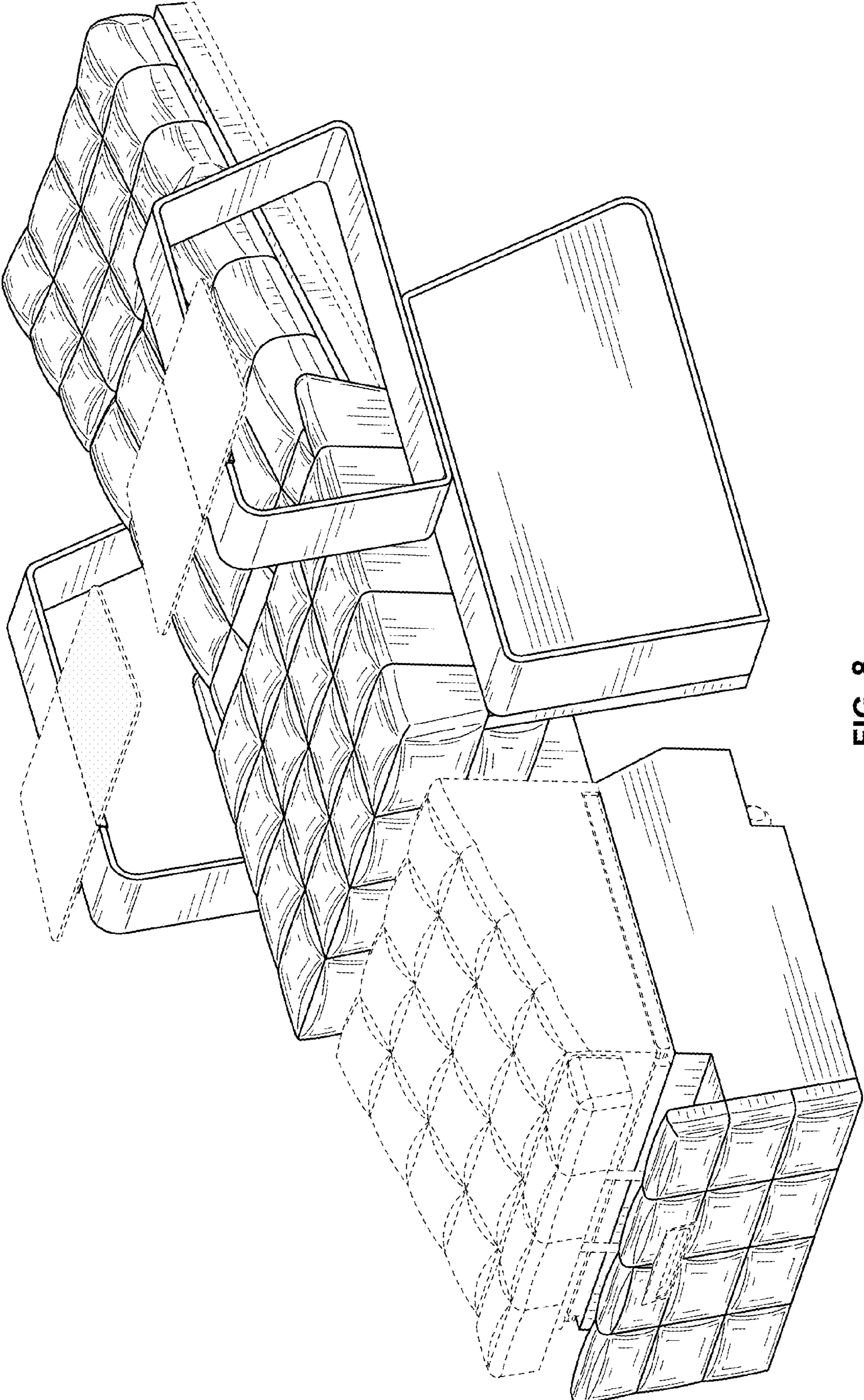

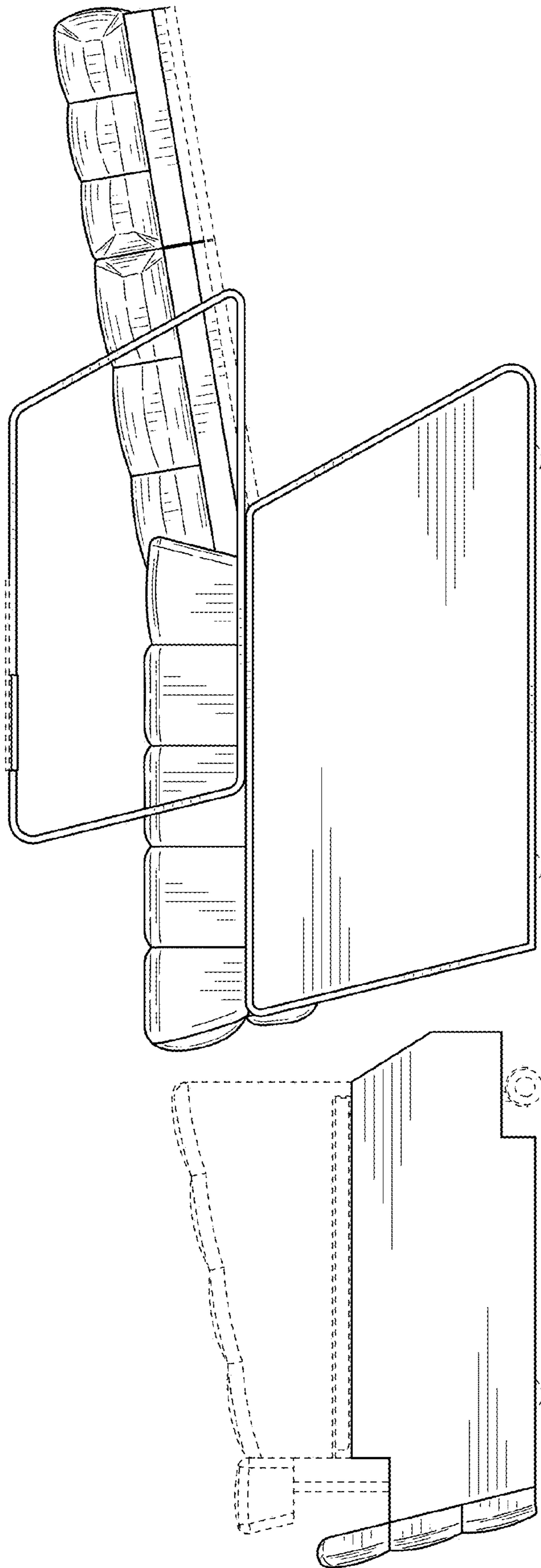

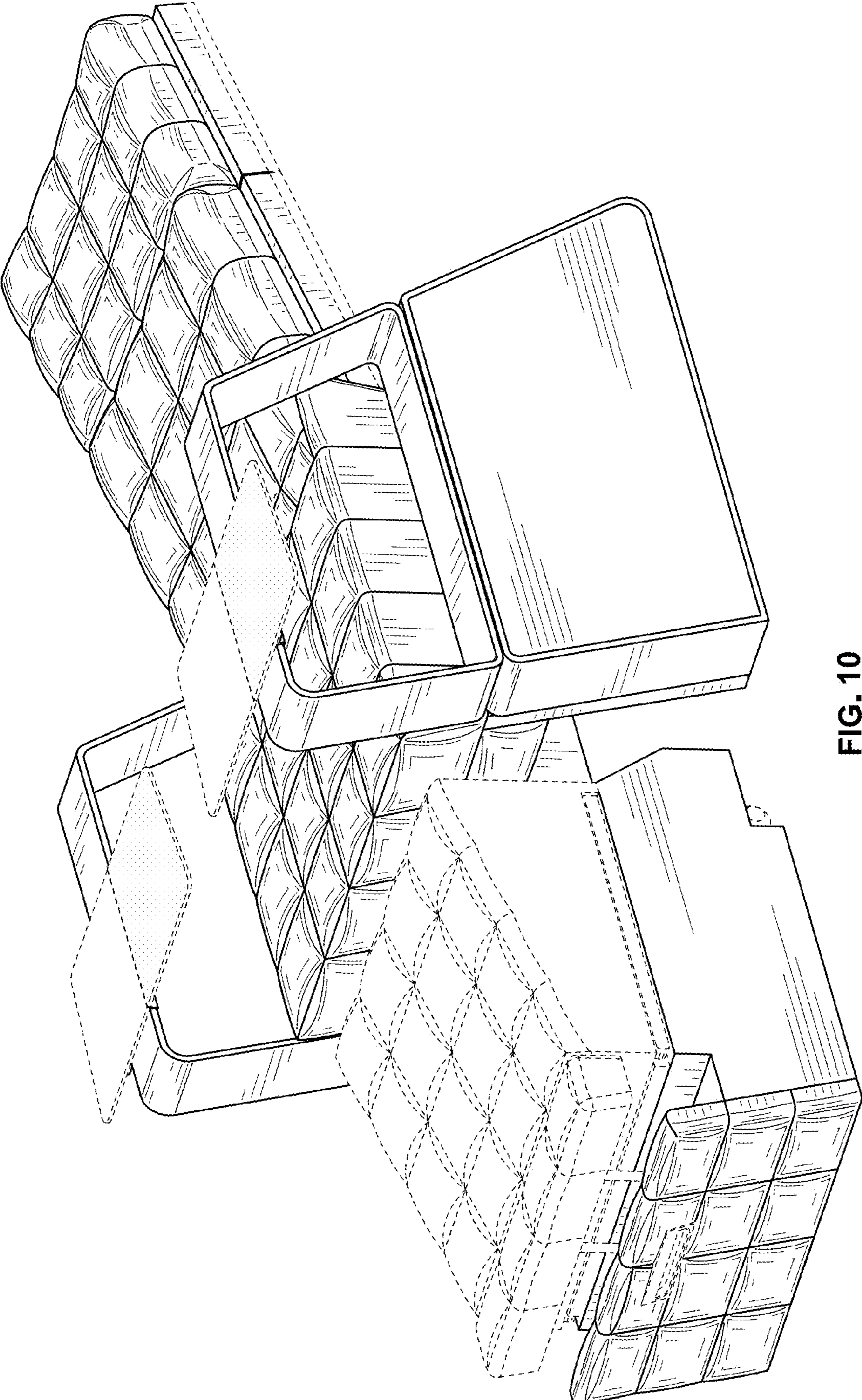

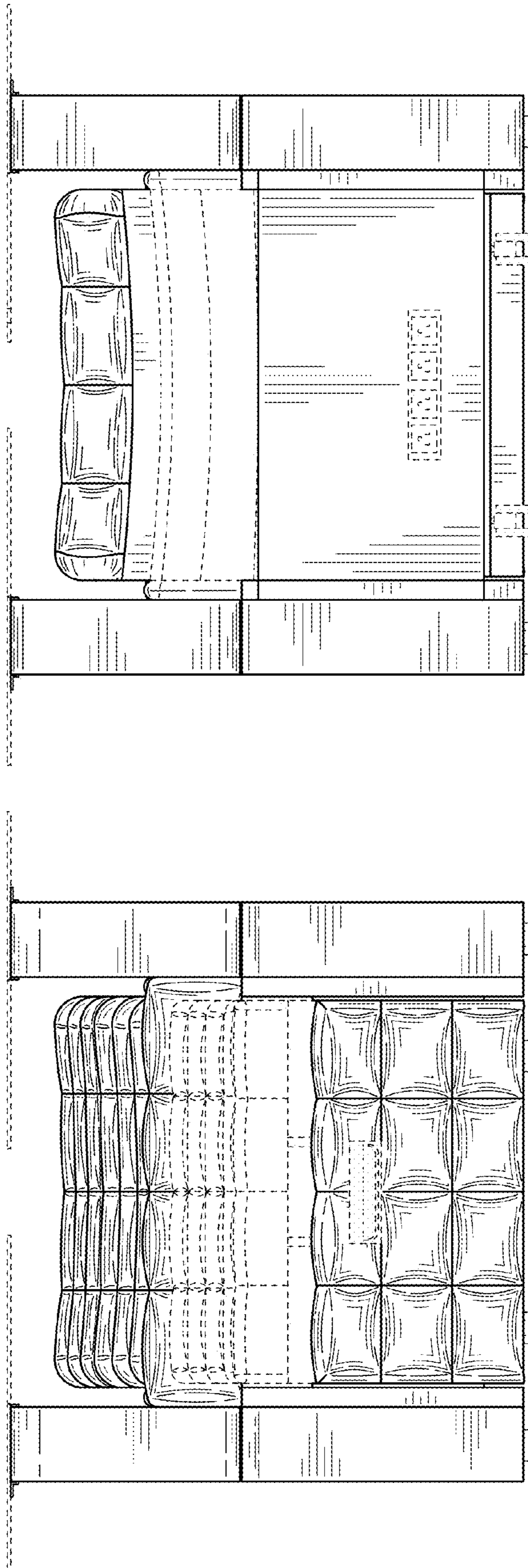

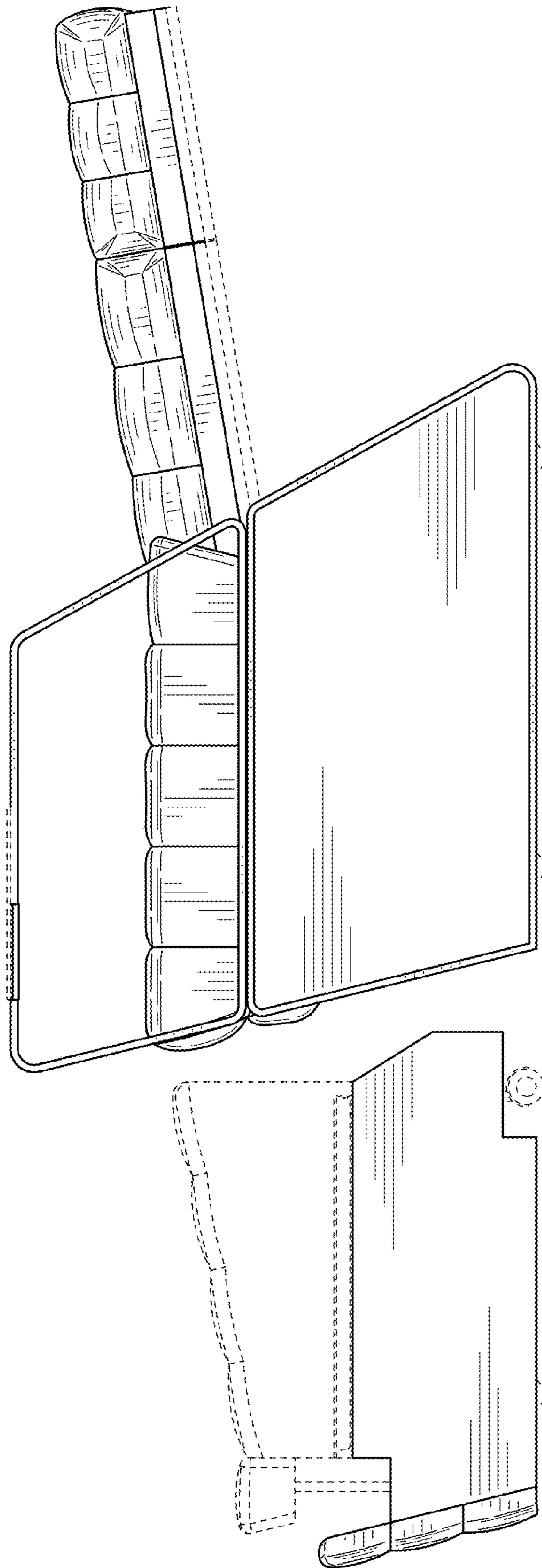

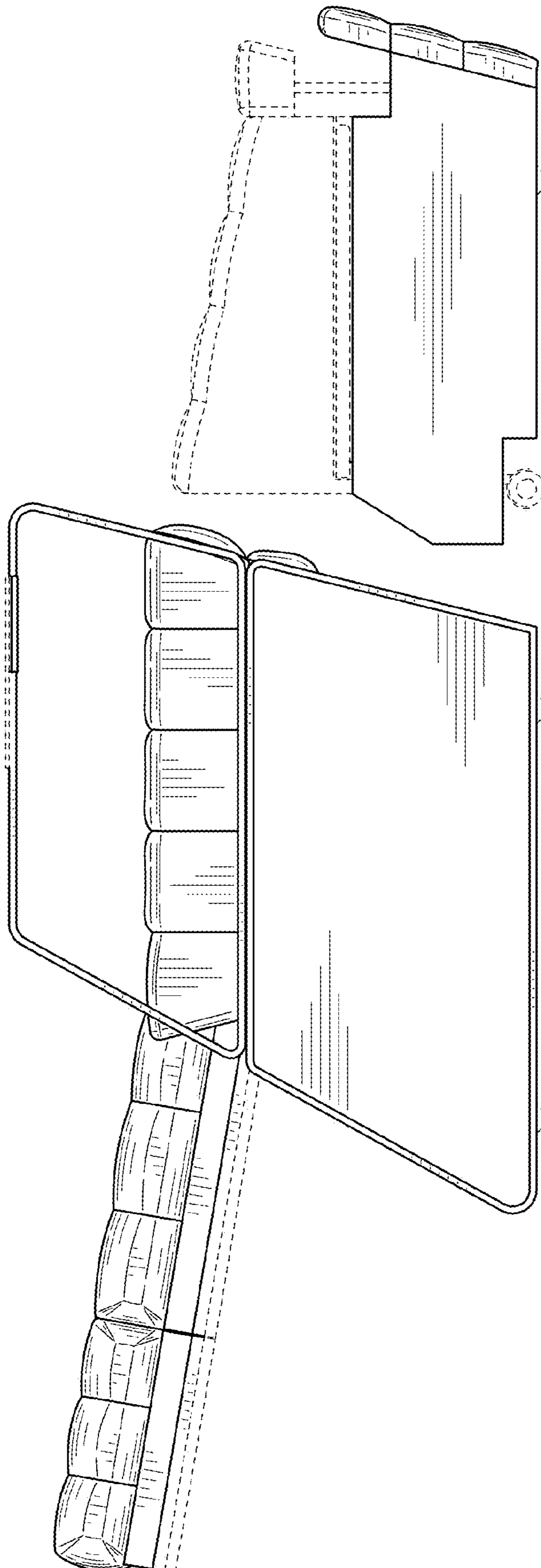

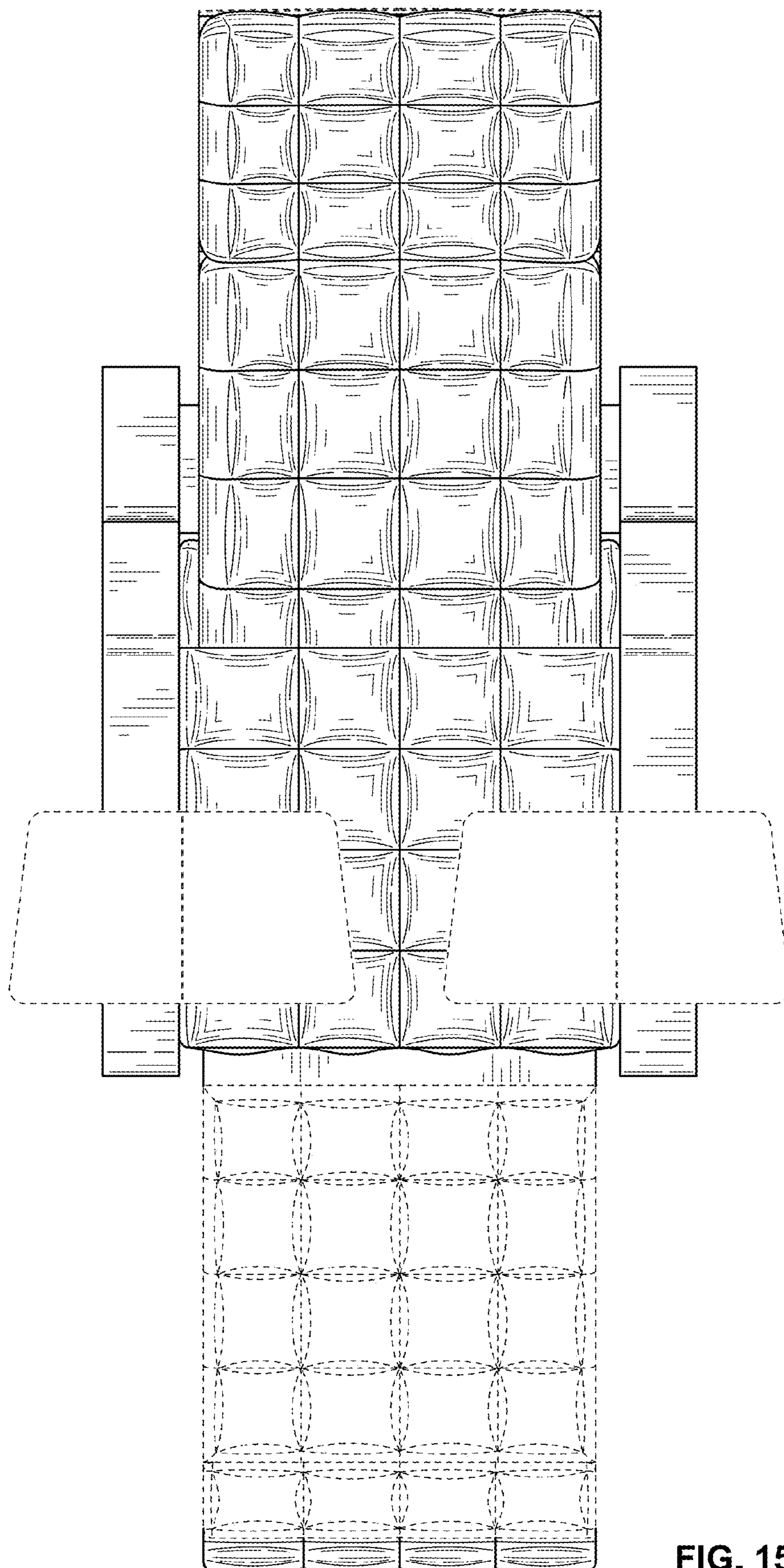

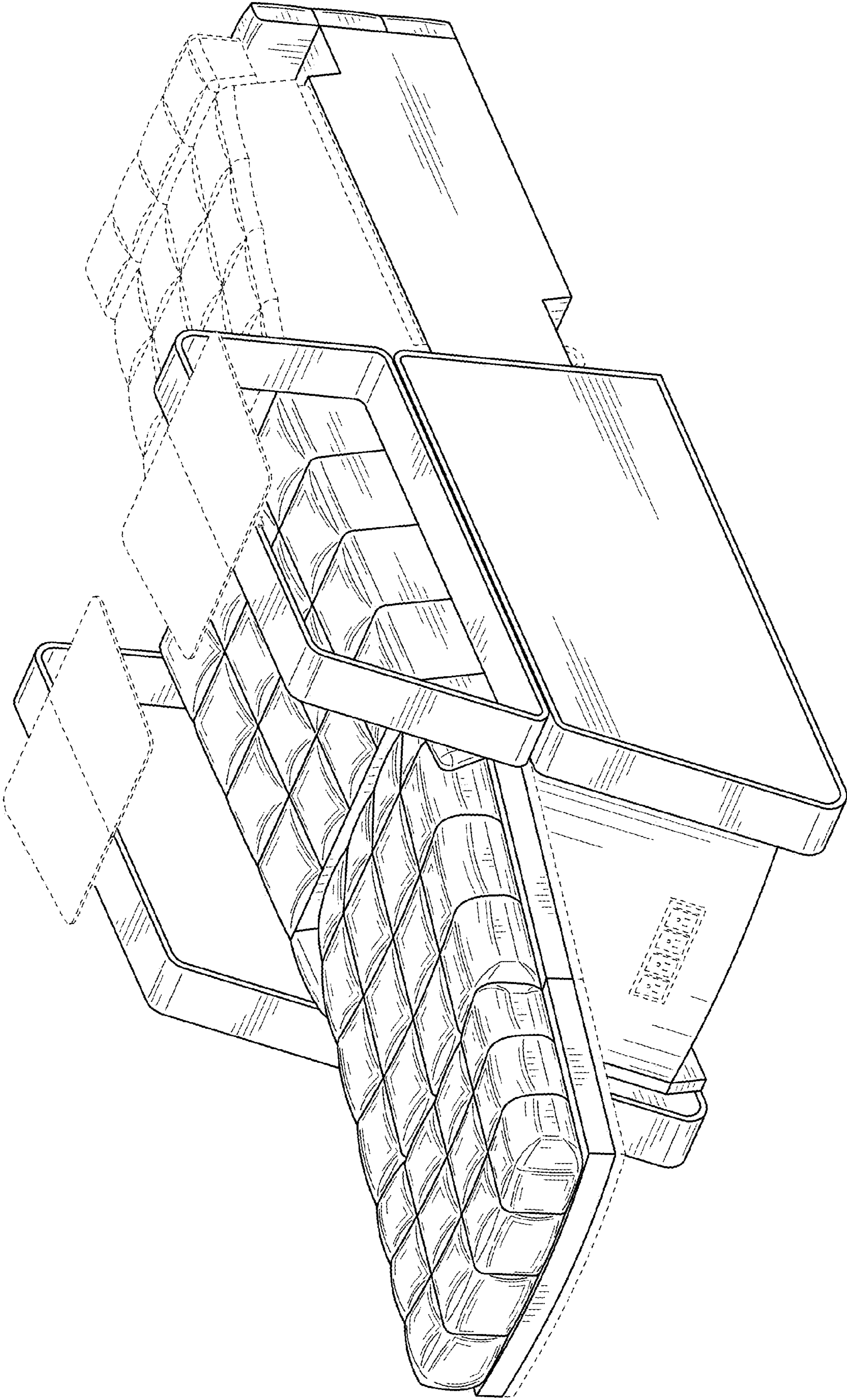
