(57) **CLAIM**

The ornamental design for a grill pan lid, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the grill pan lid, showing my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a right side view thereof, with the left side view being a mirror image of the right side view;

FIG. 4 is a perspective view showing the bottom and front thereof;

FIG. 5 is a perspective view showing the top and rear thereof;

FIG. 6 is a front view thereof;

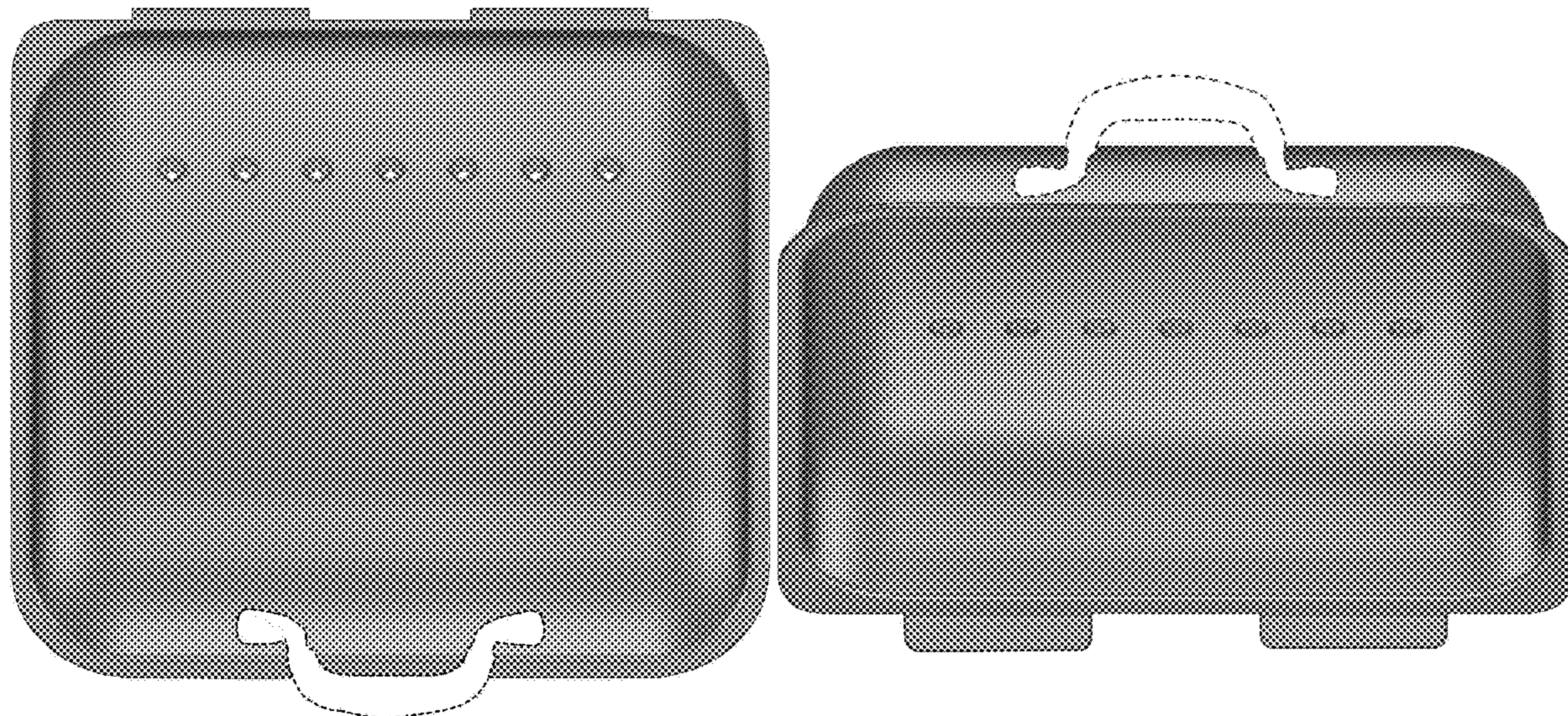
FIG. 7 is a rear view thereof;

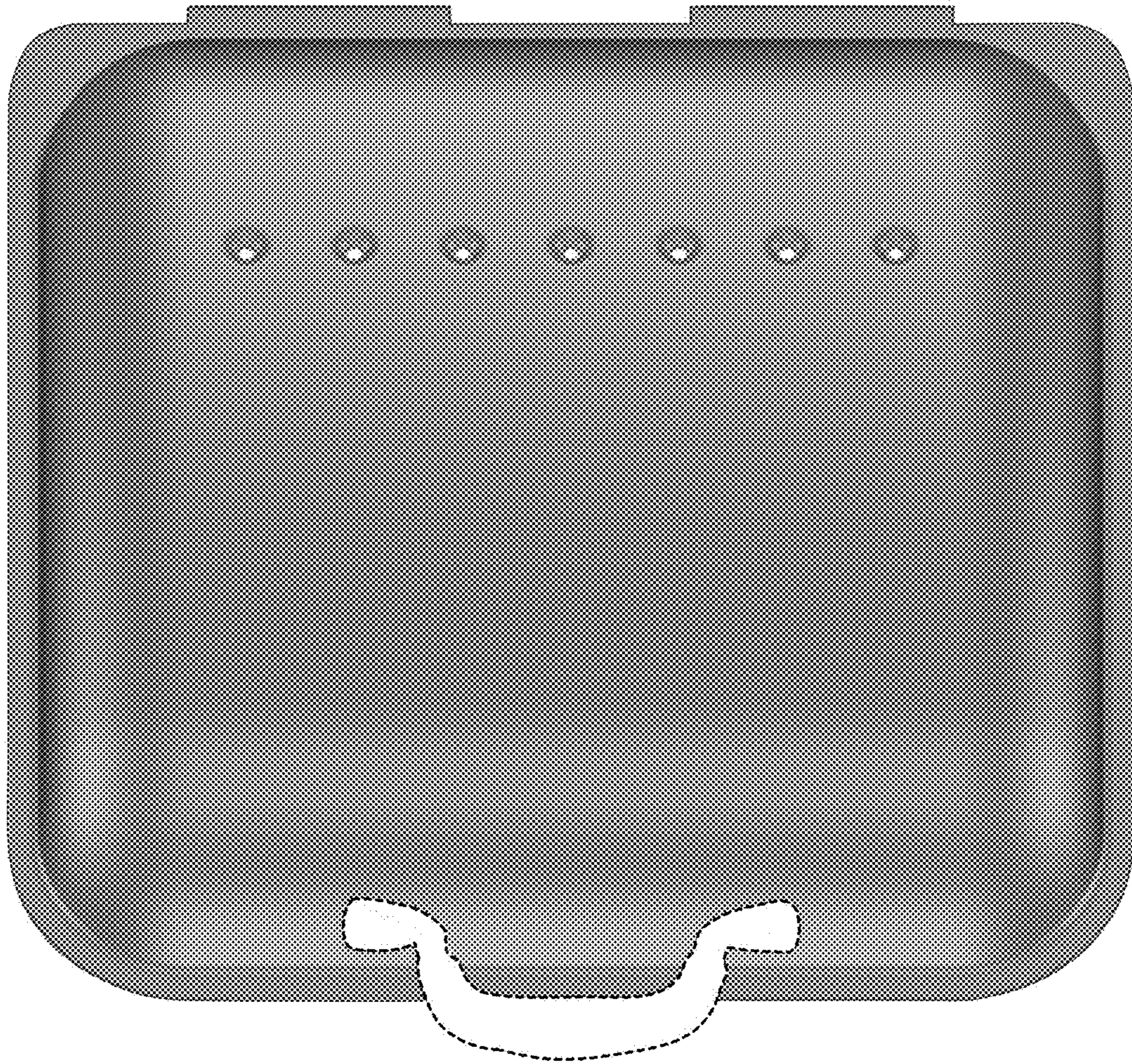

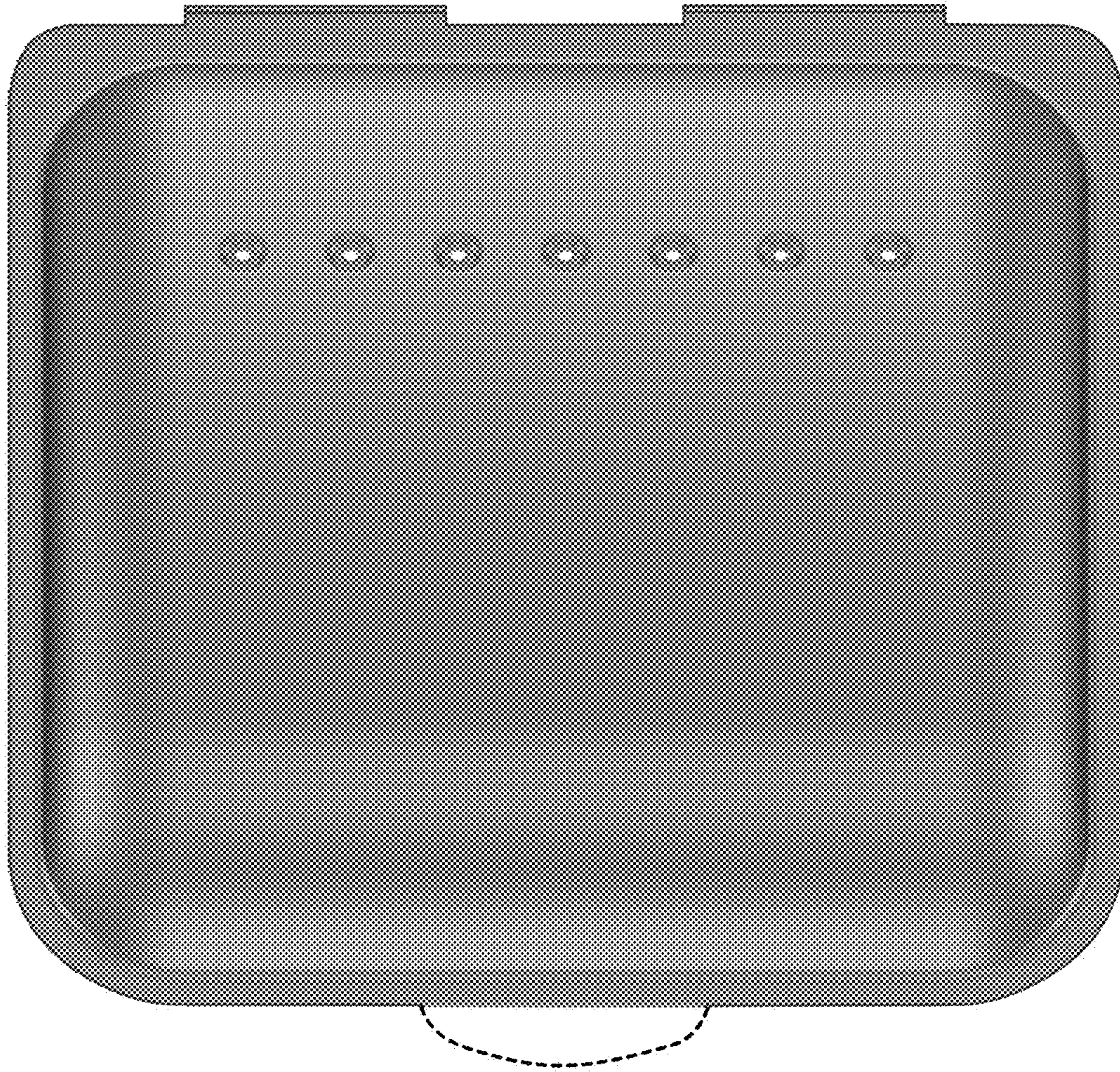

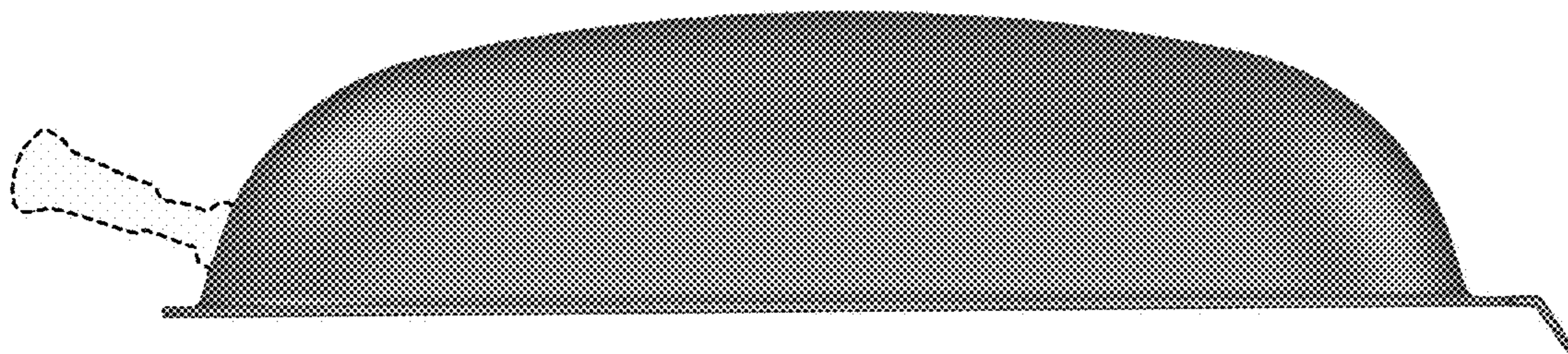

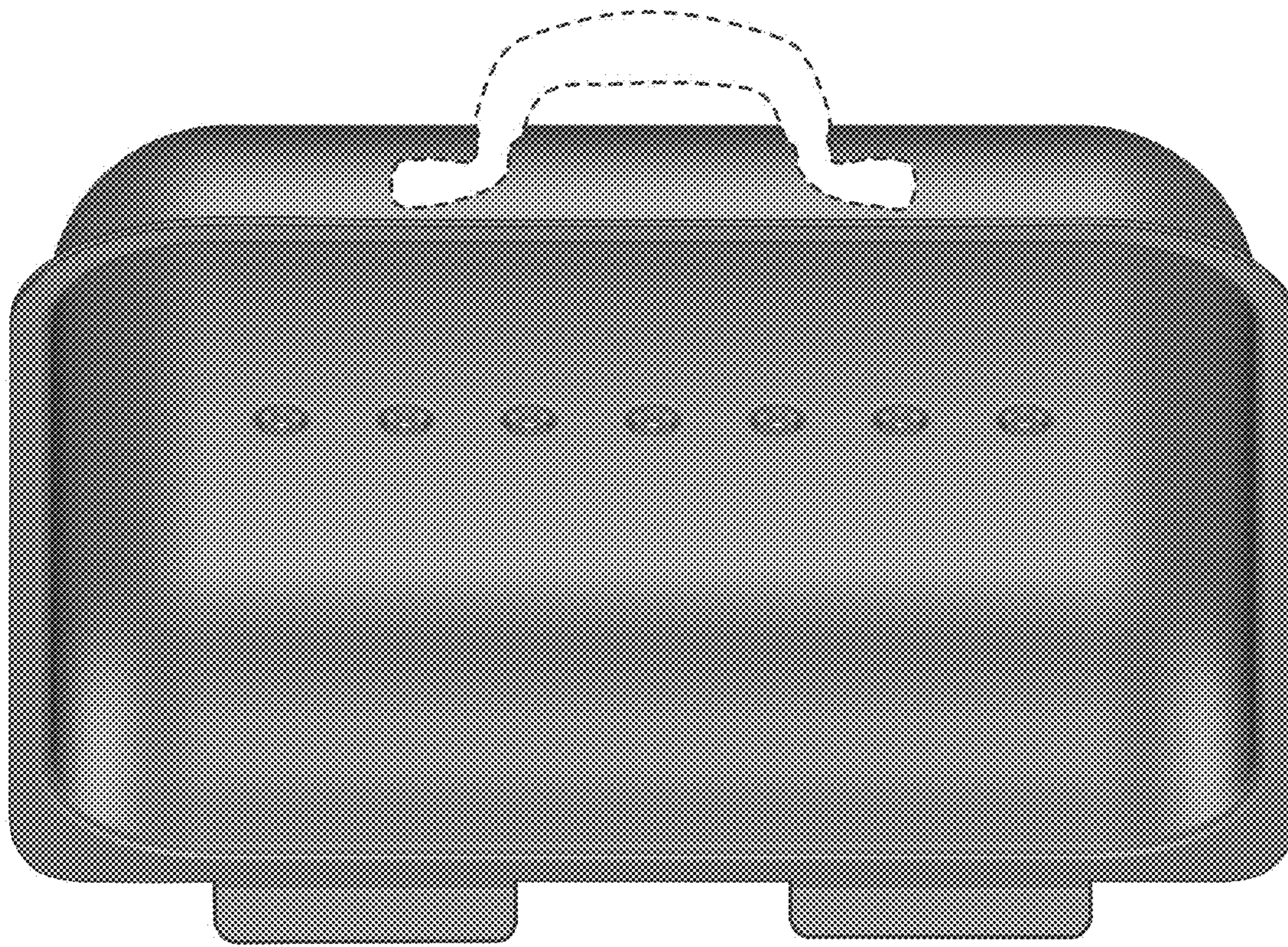

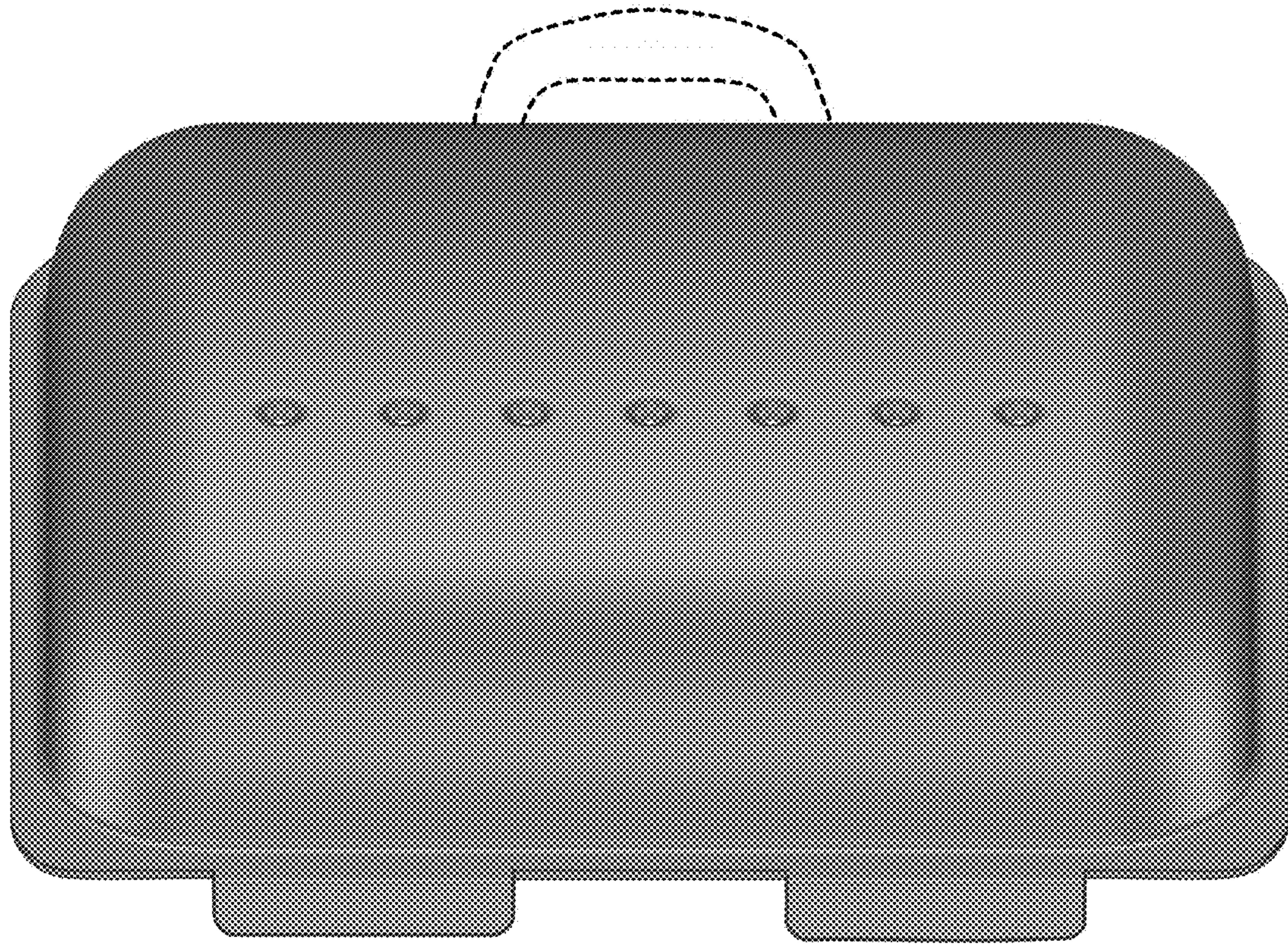

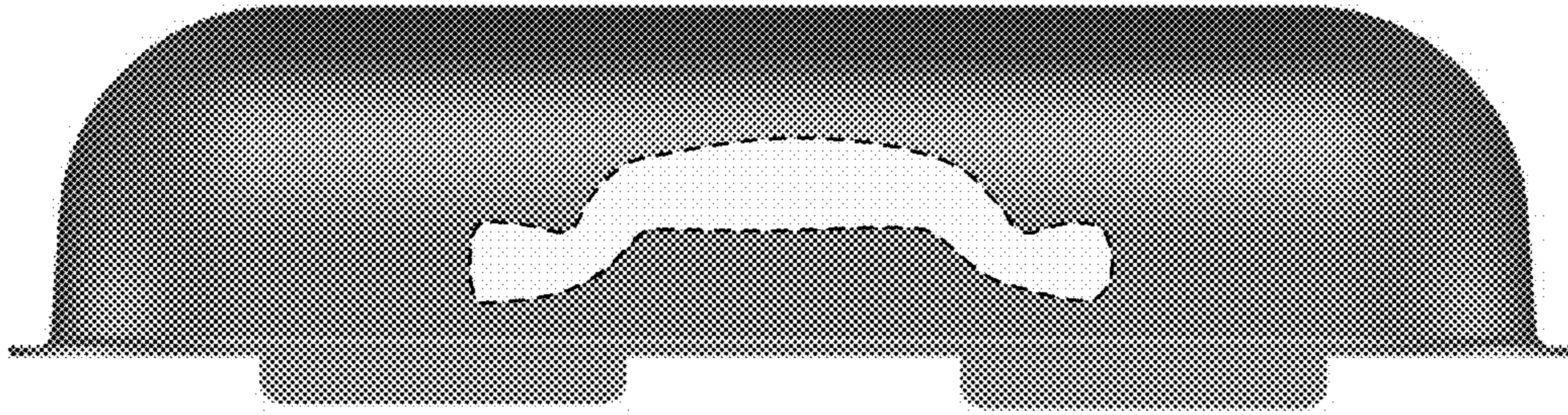

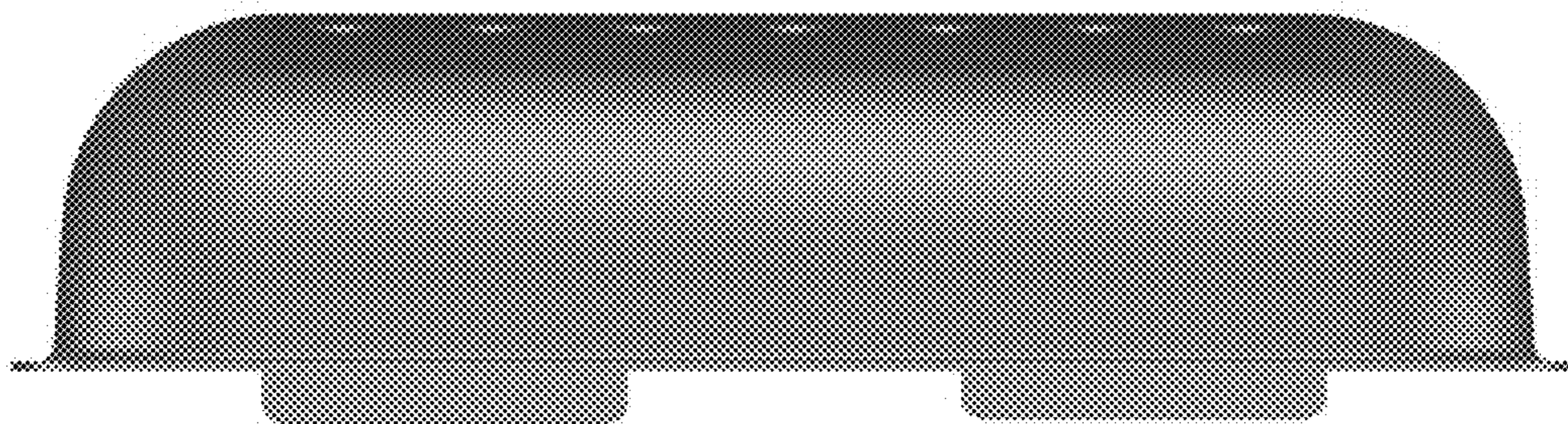

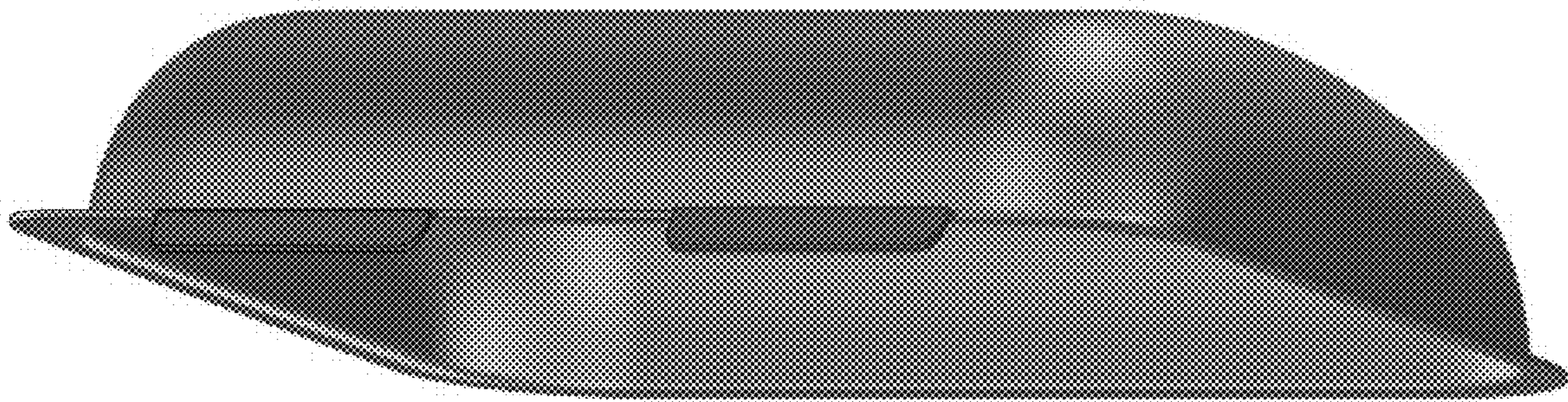

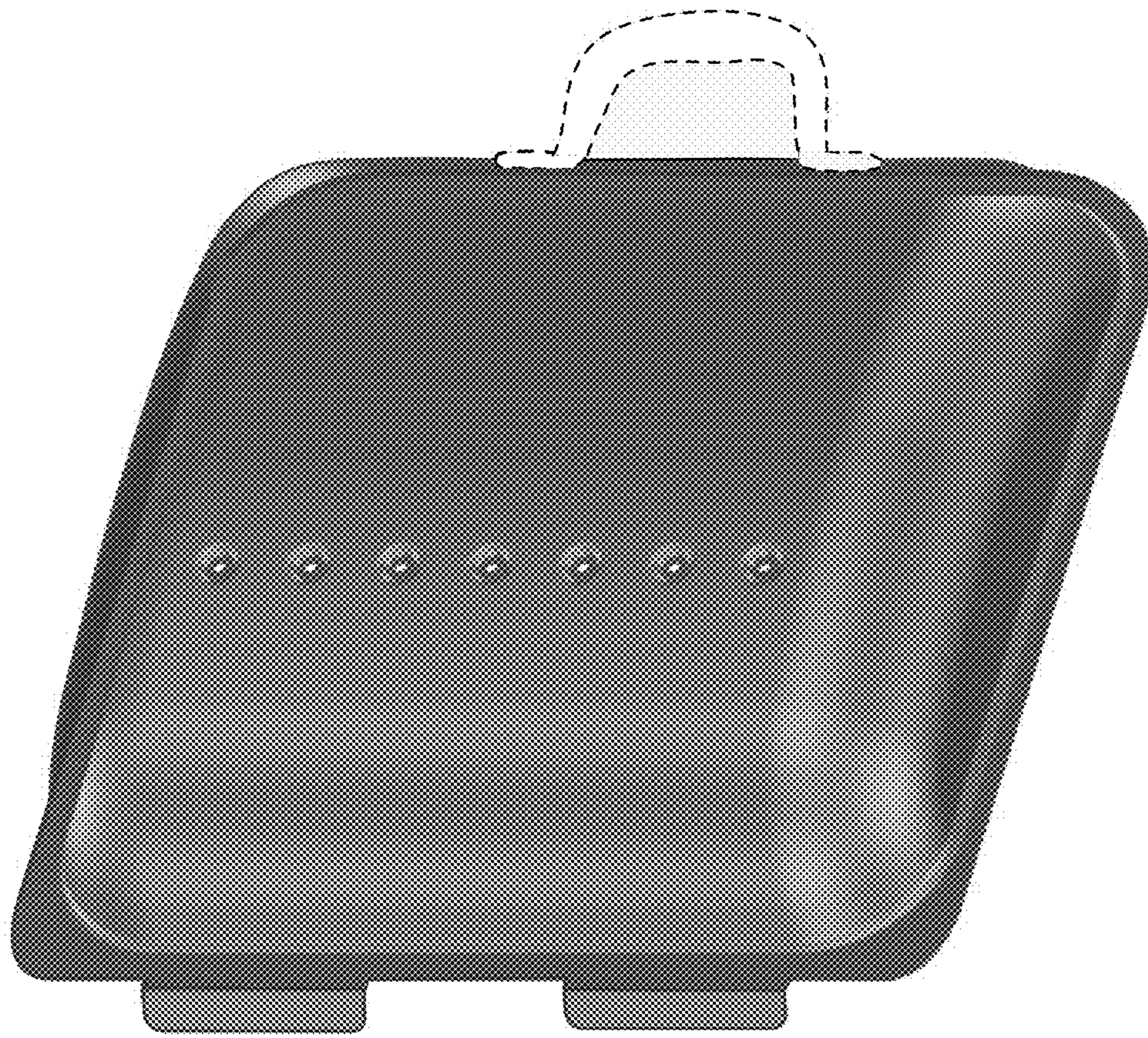
