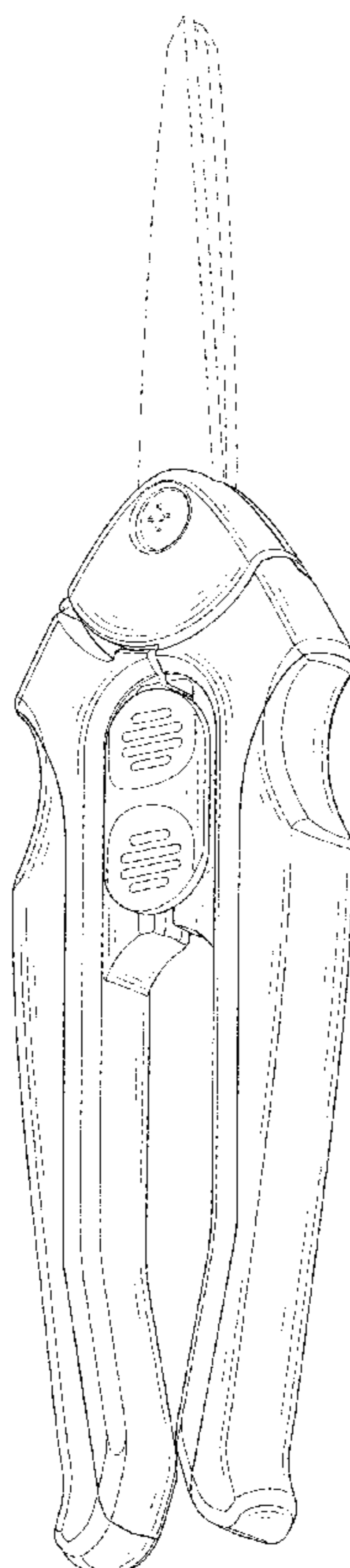
FIG. 1 is a perspective view of a pair of scissors showing my new design;

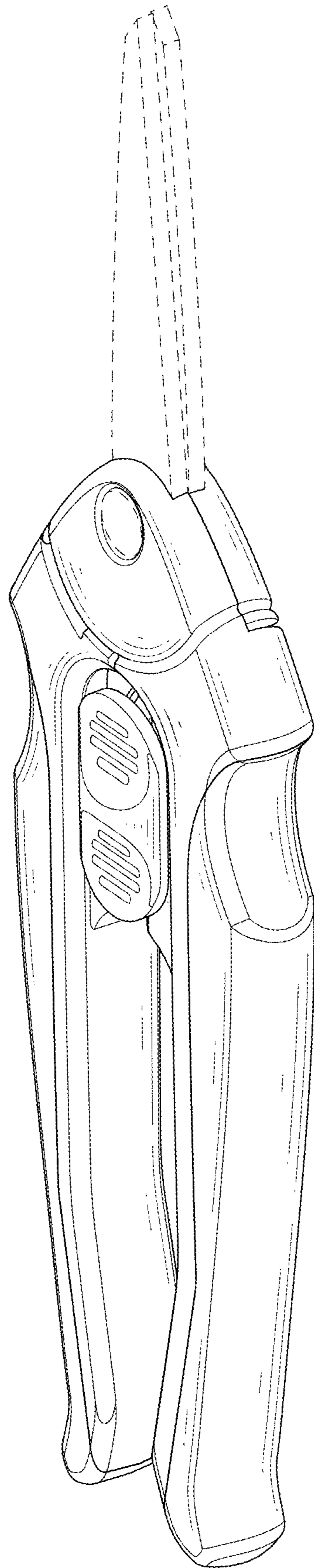

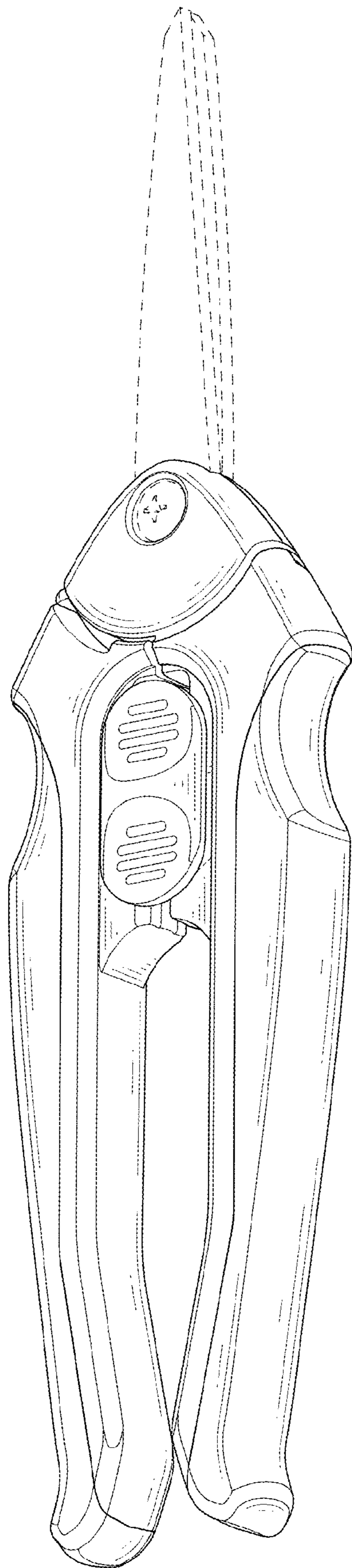

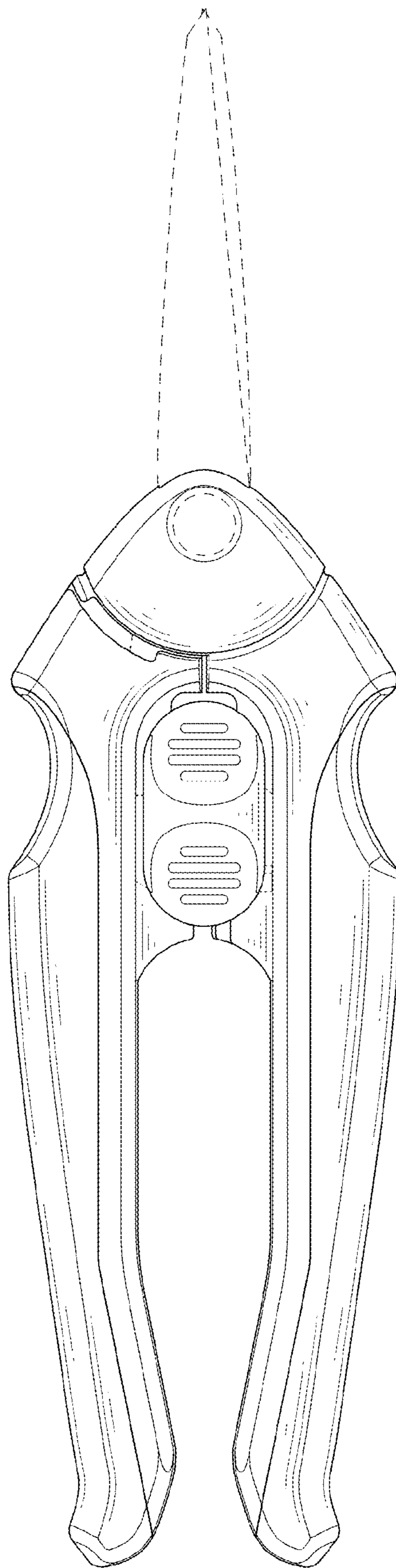

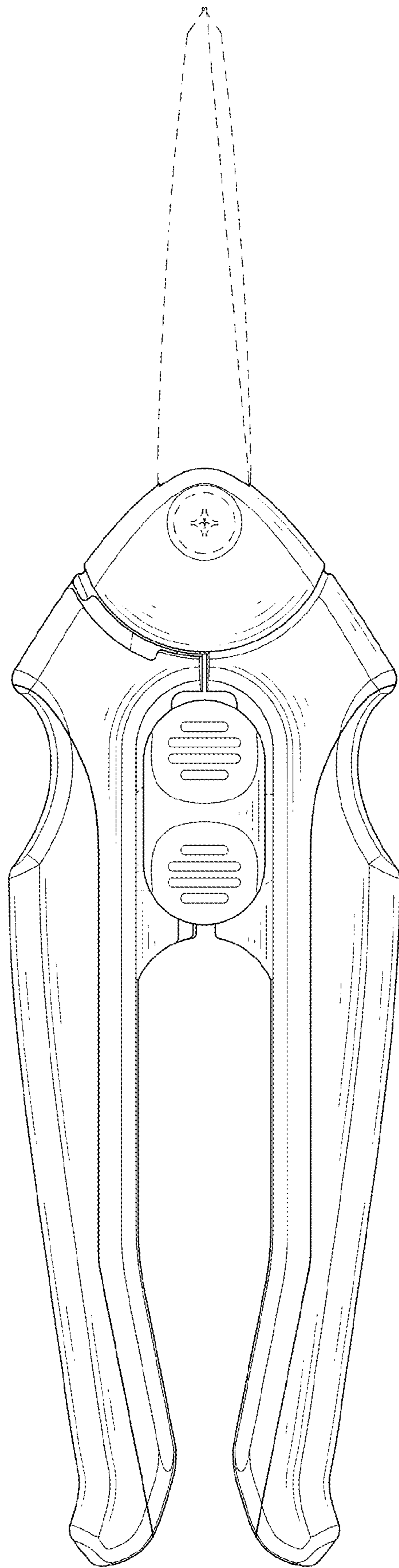

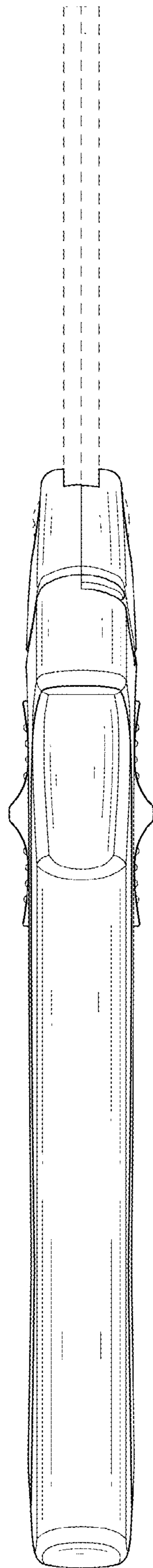

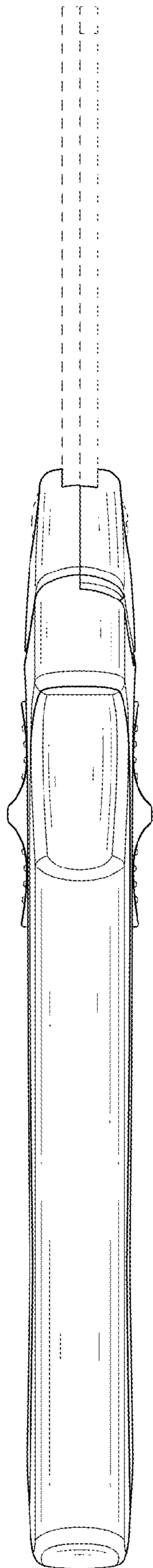

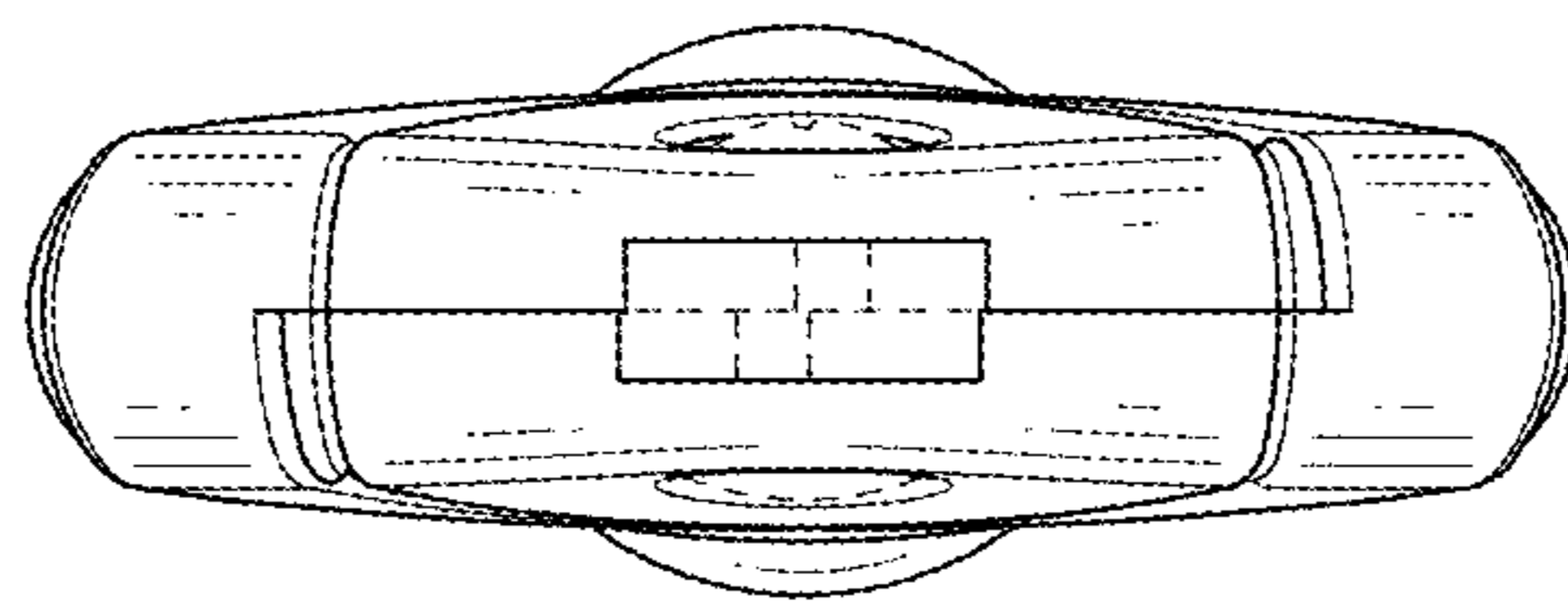

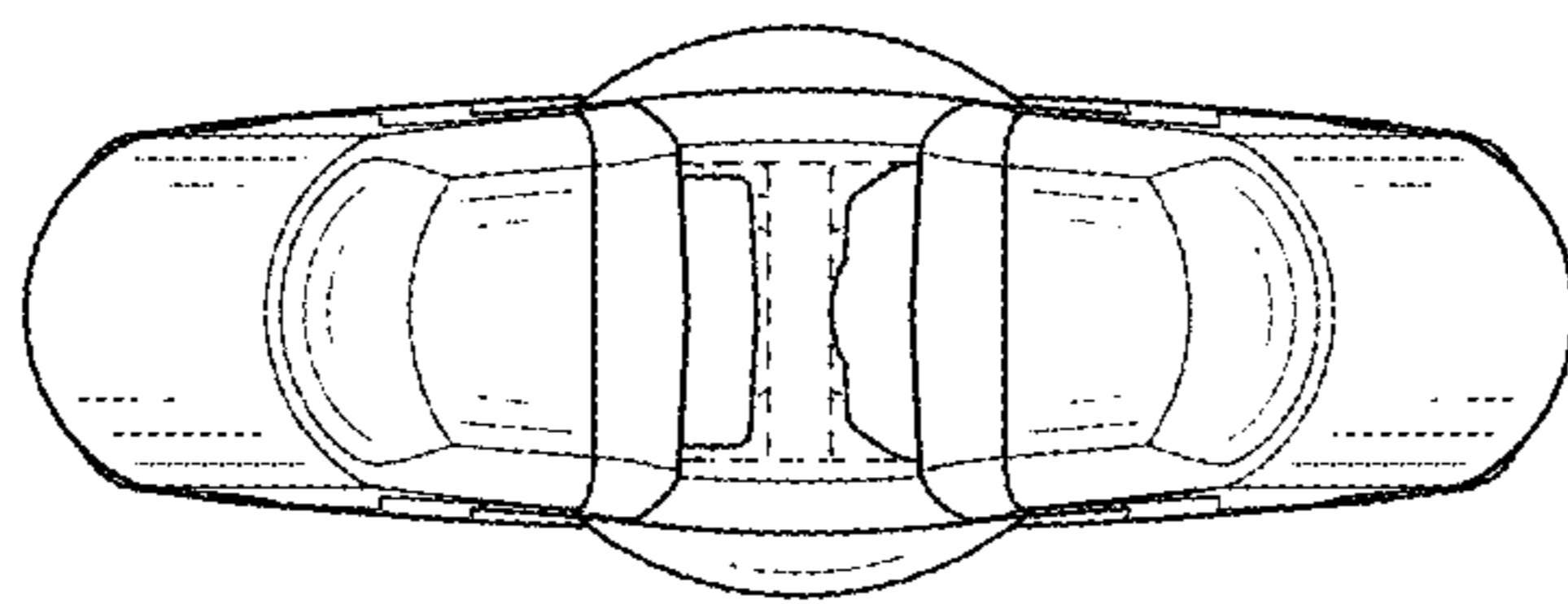
