(57) **CLAIM**

We claim the ornamental design for an electronic device, as shown and described.

DESCRIPTION

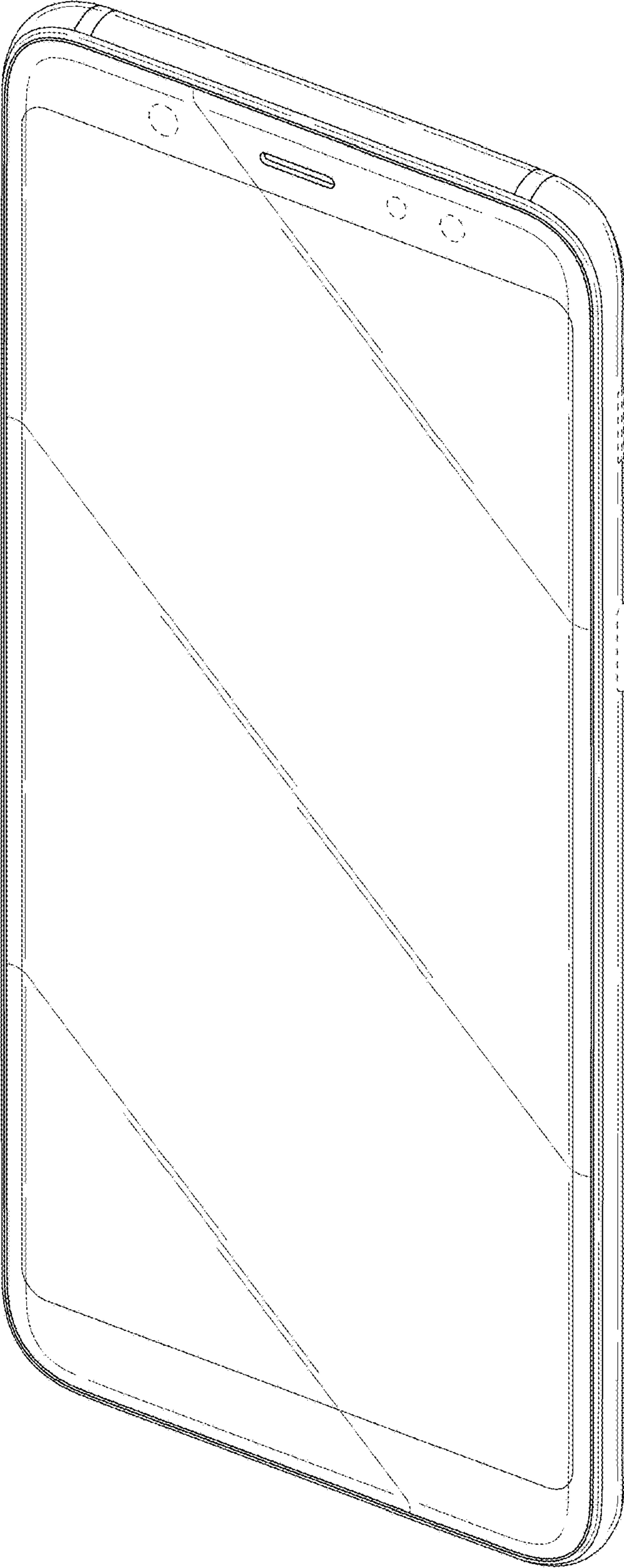

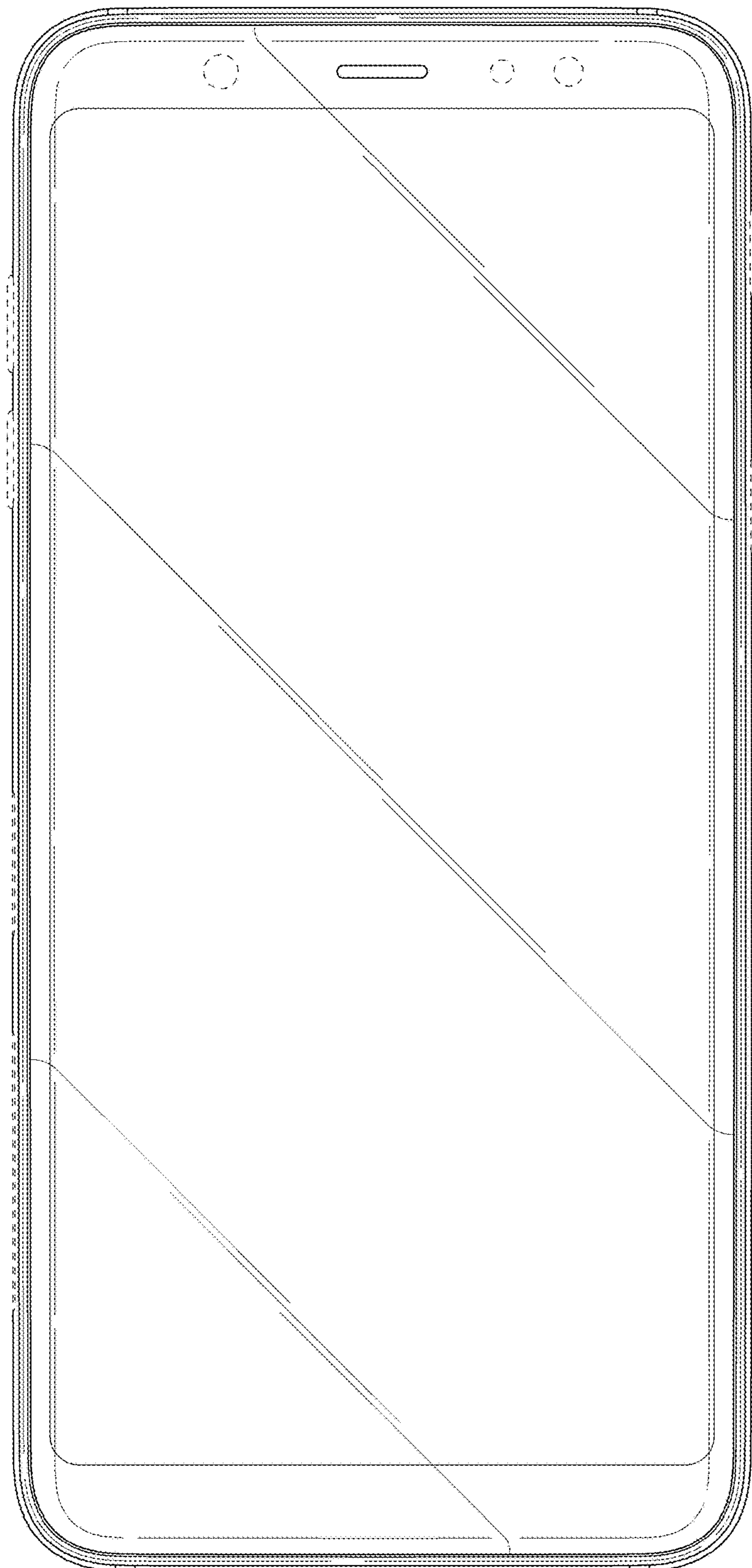

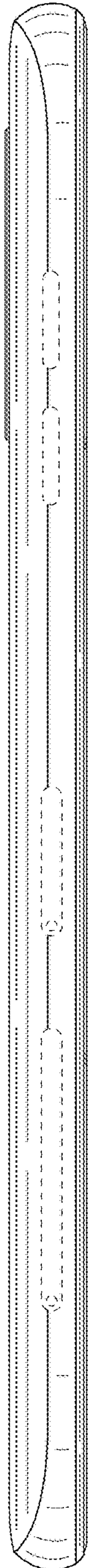

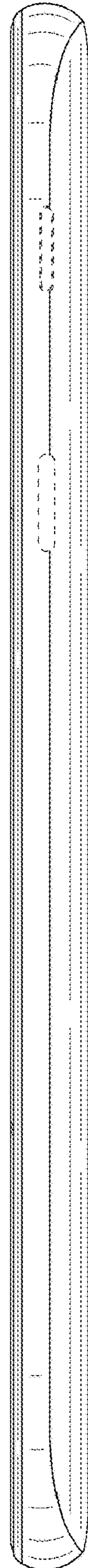

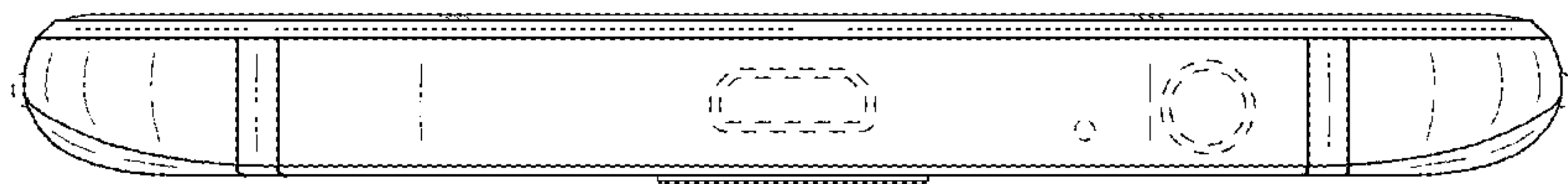

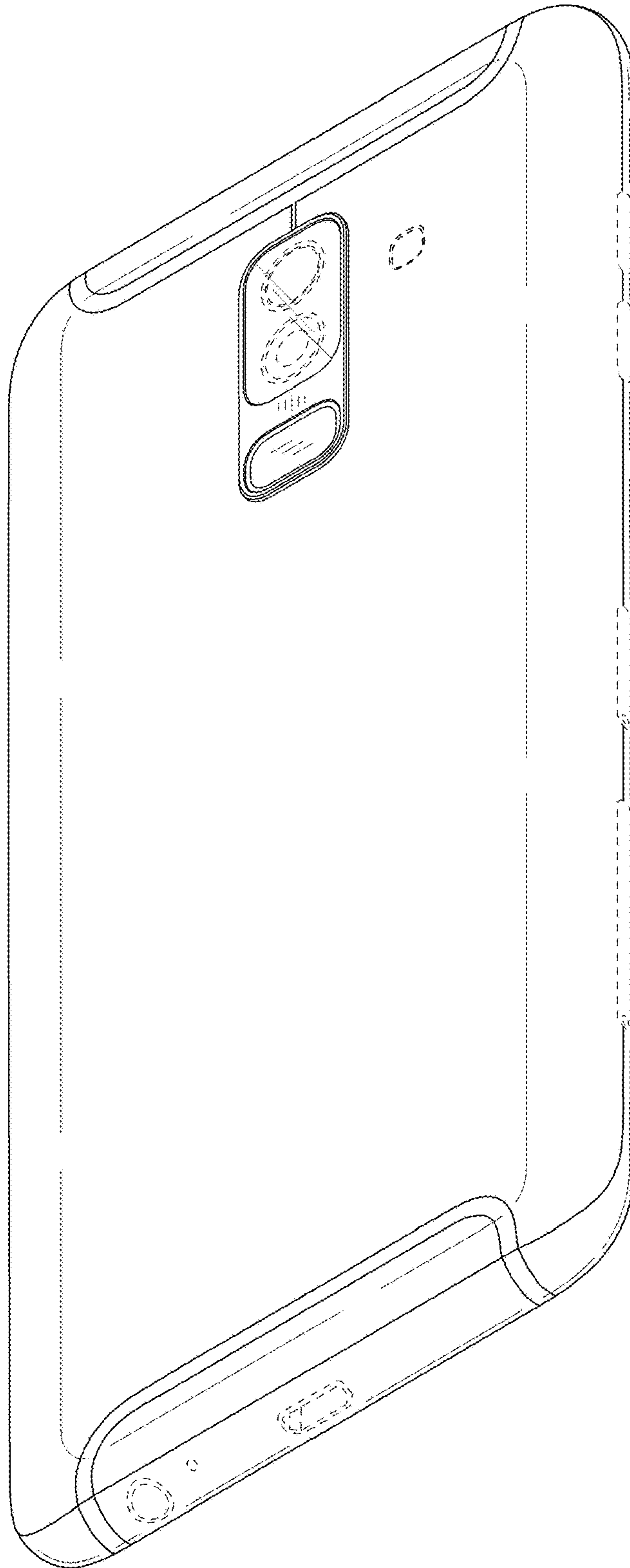

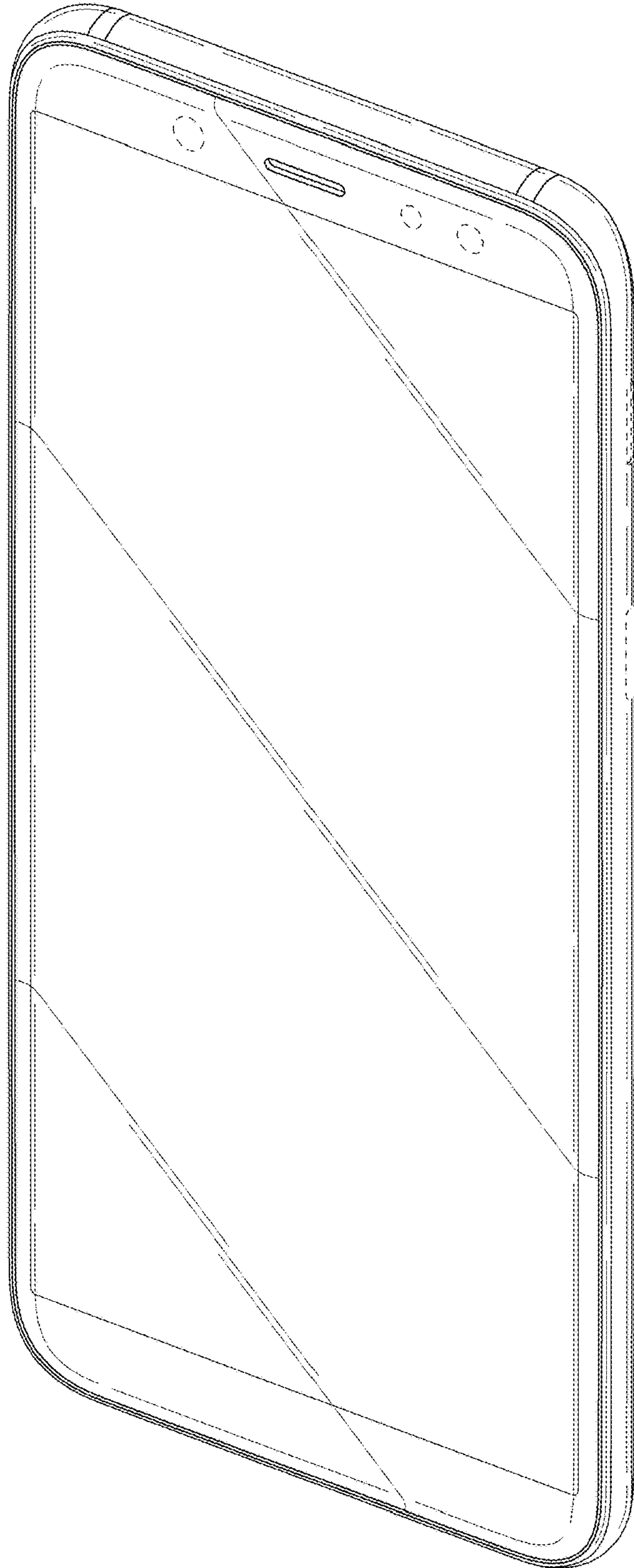

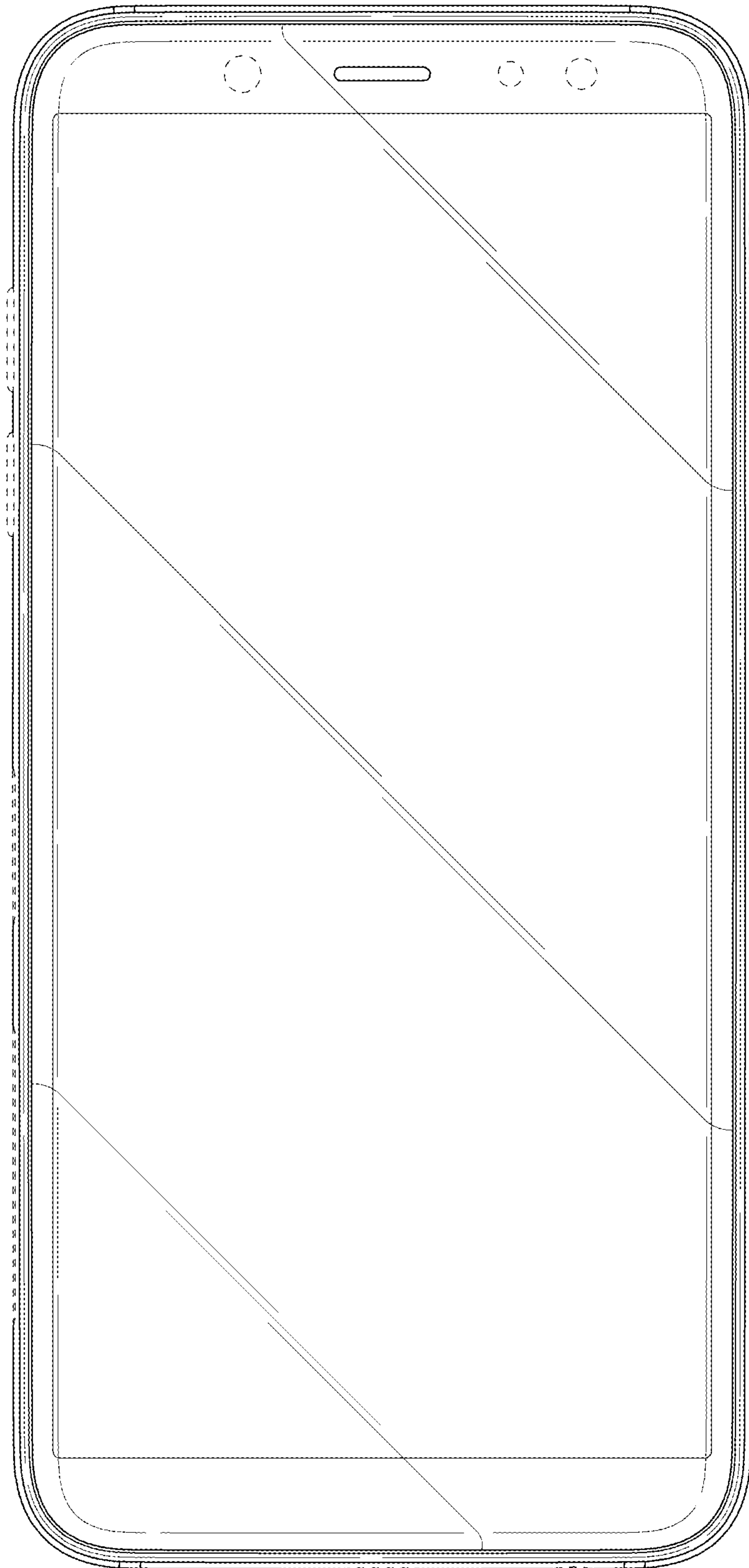

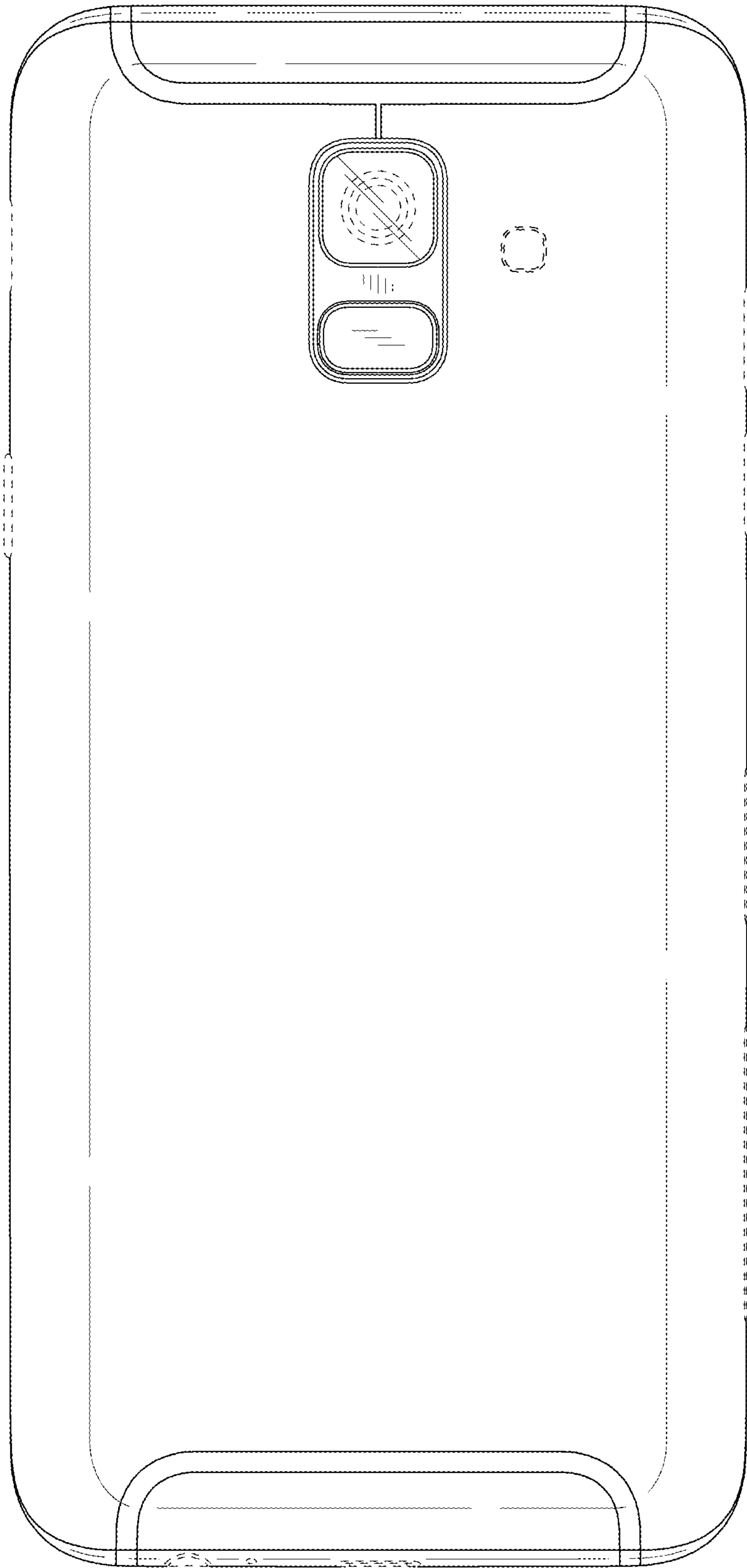

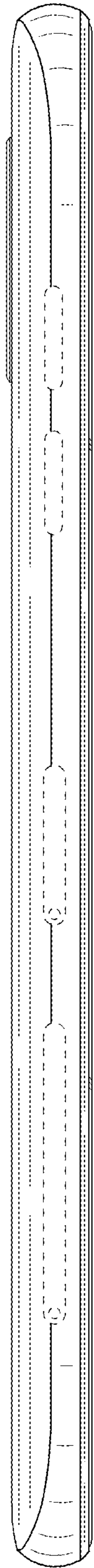

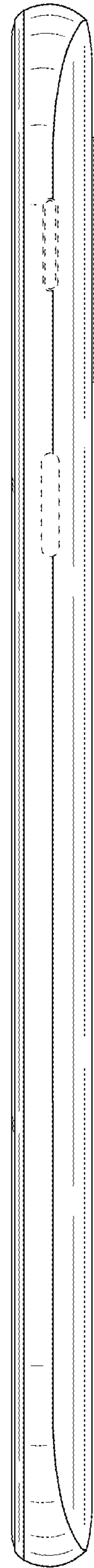

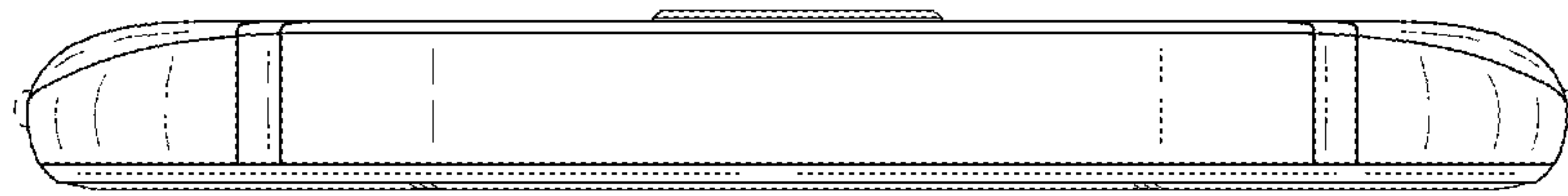

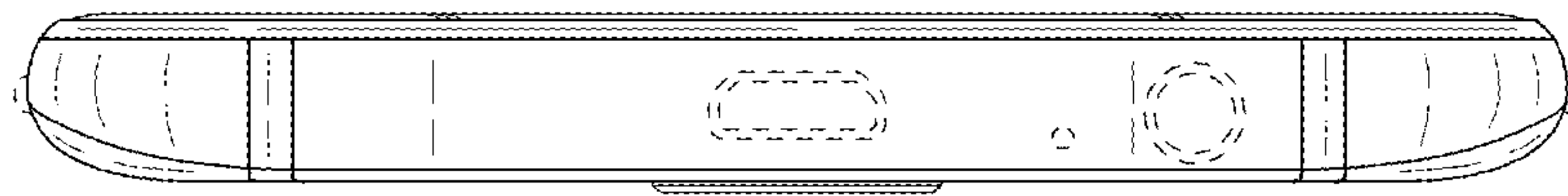
