FIG. 12 is a right side view thereof;

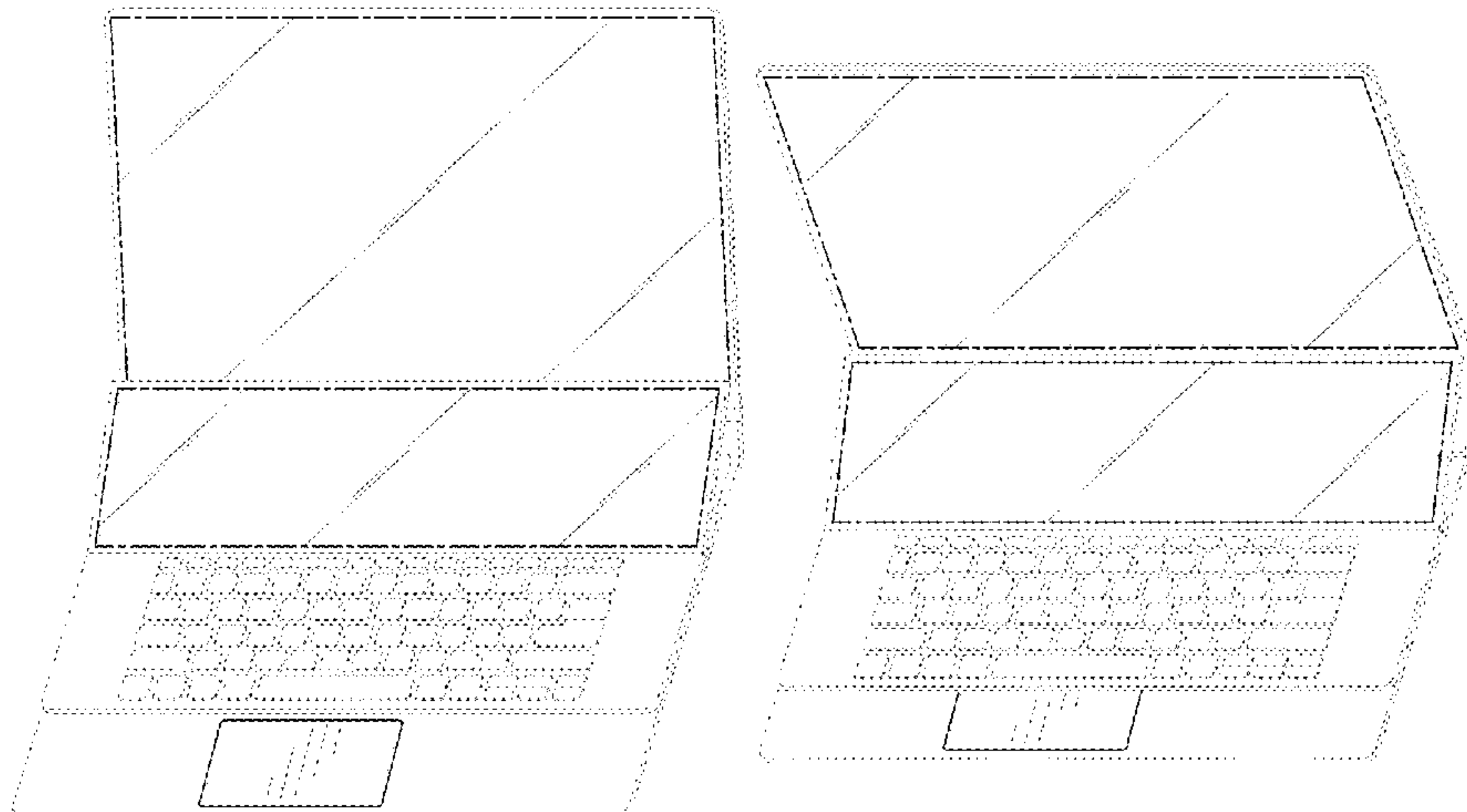
FIG. 13 is a top view thereof;

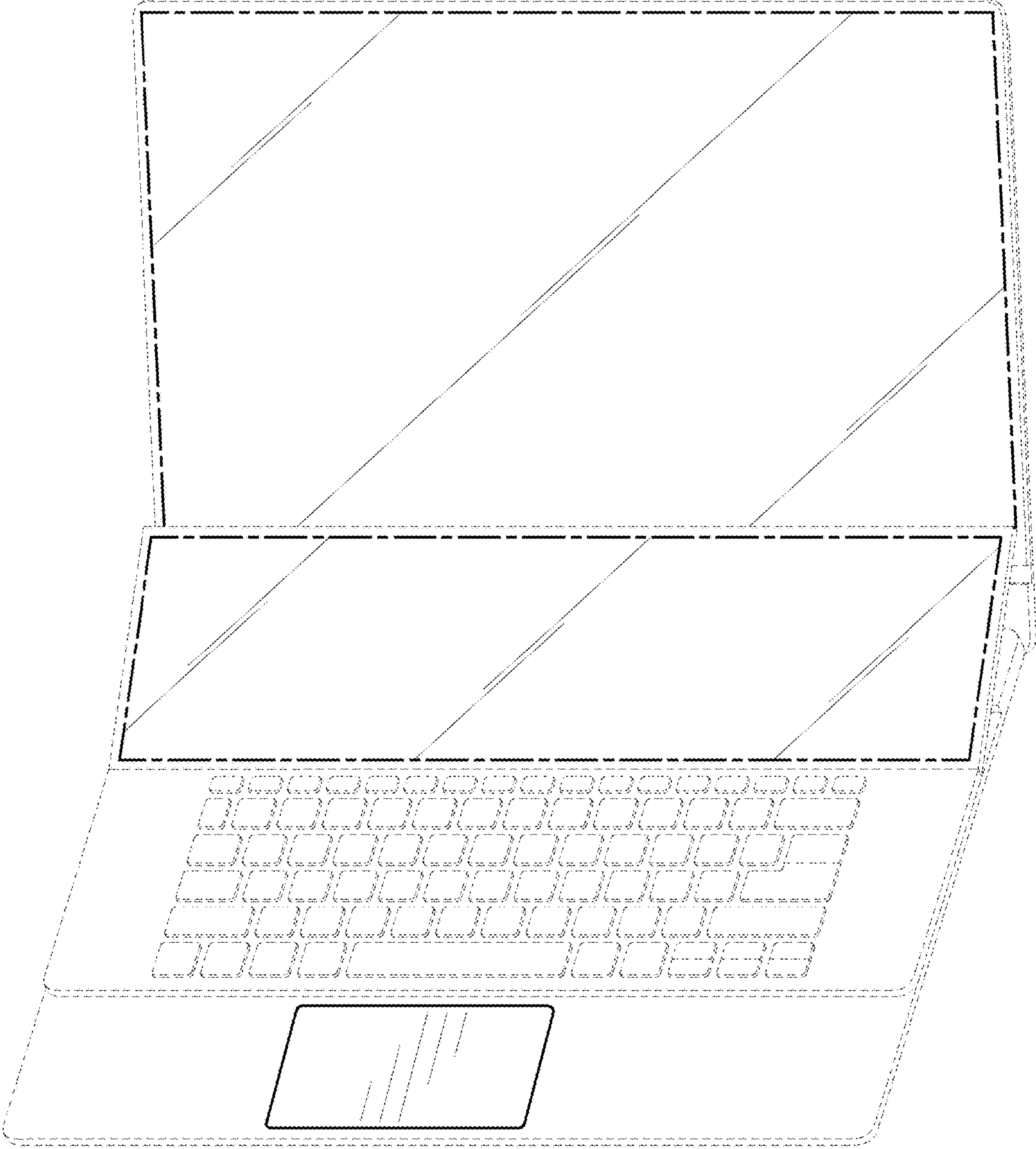

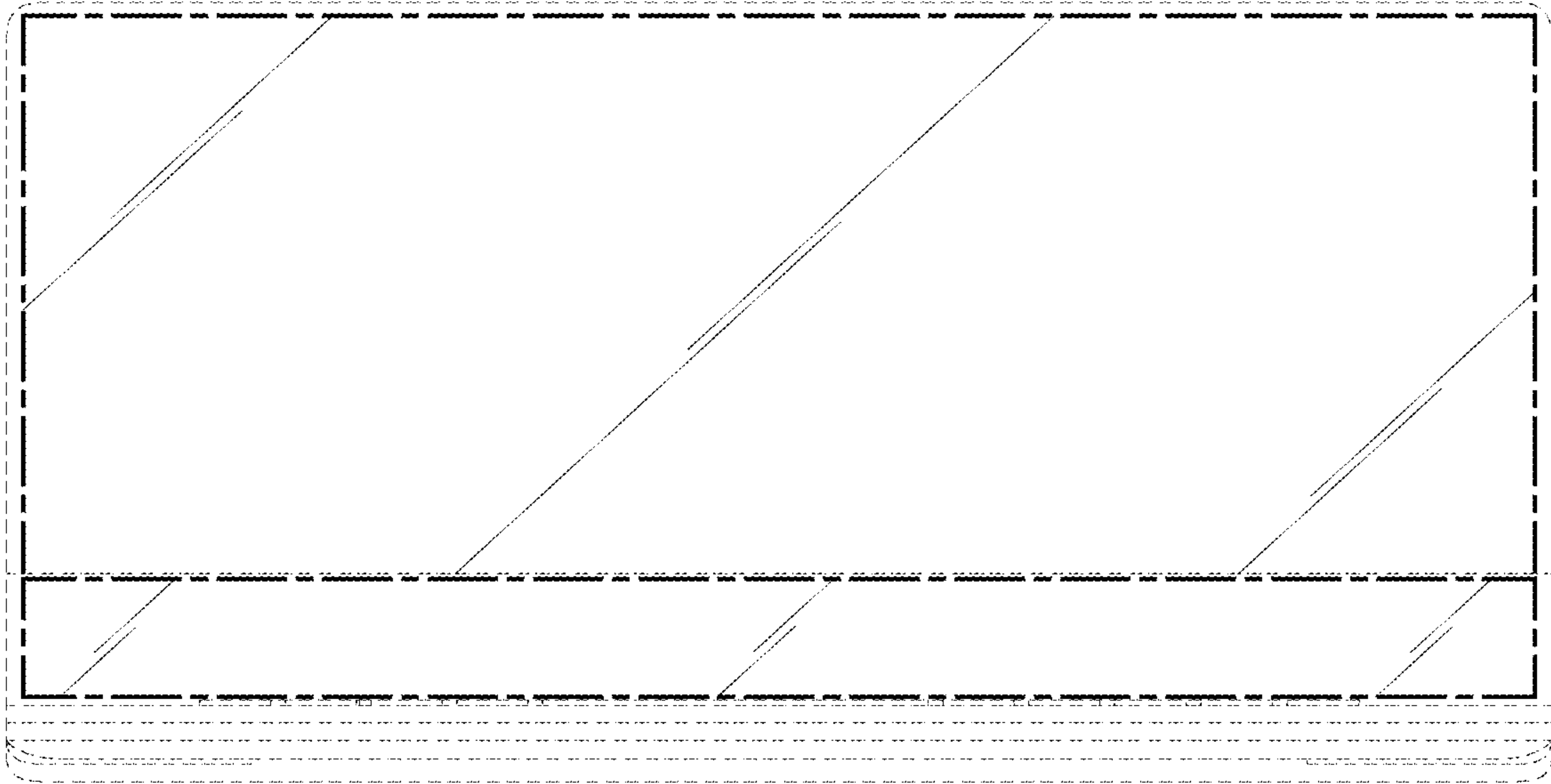

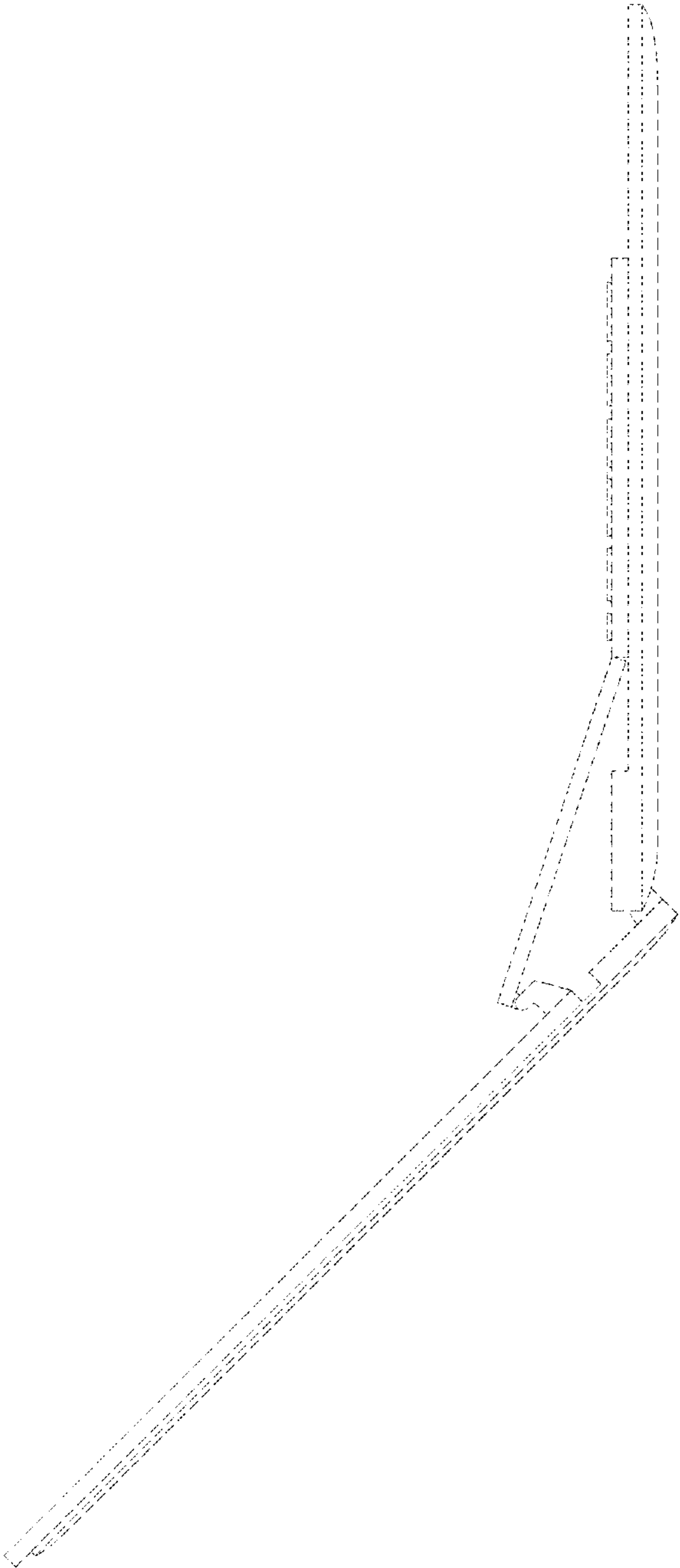

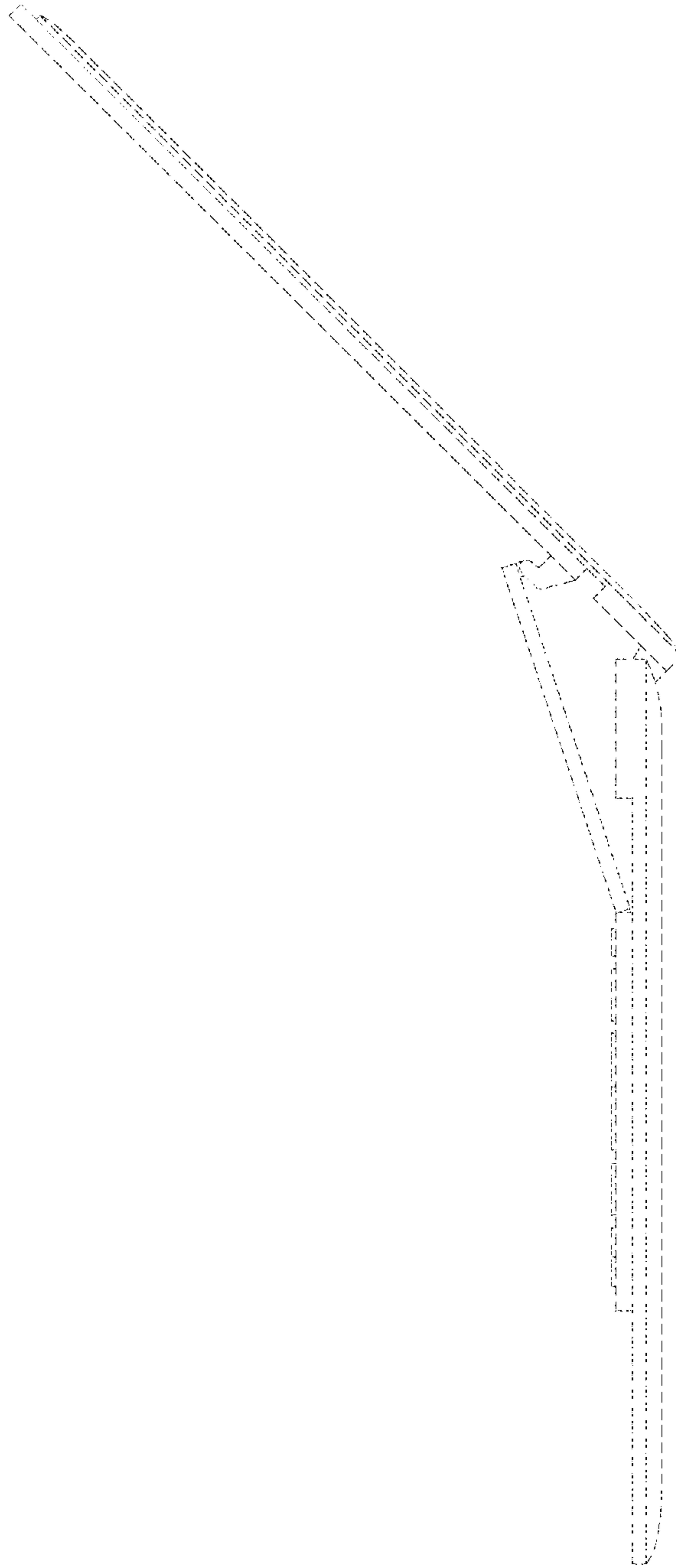

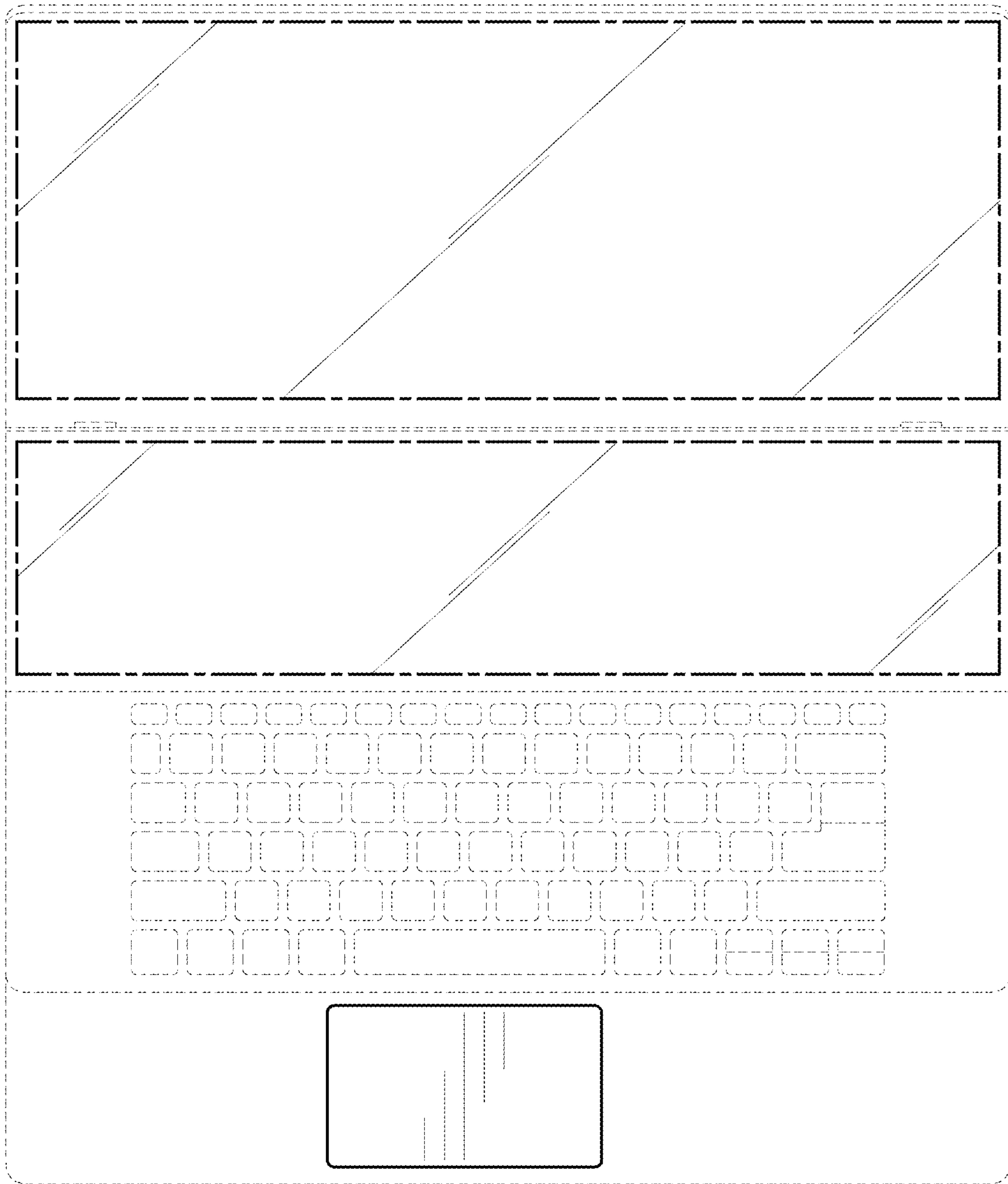

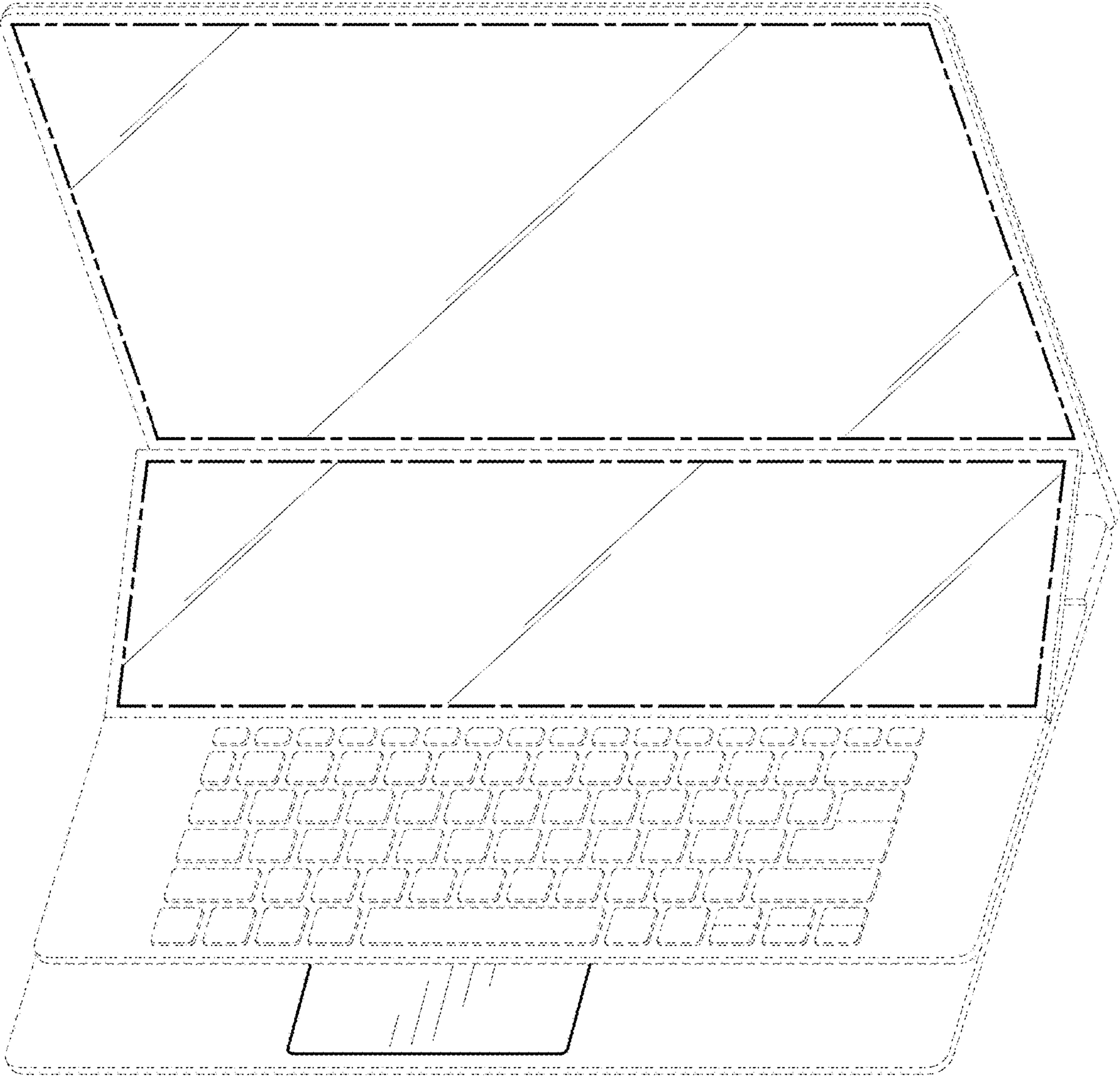

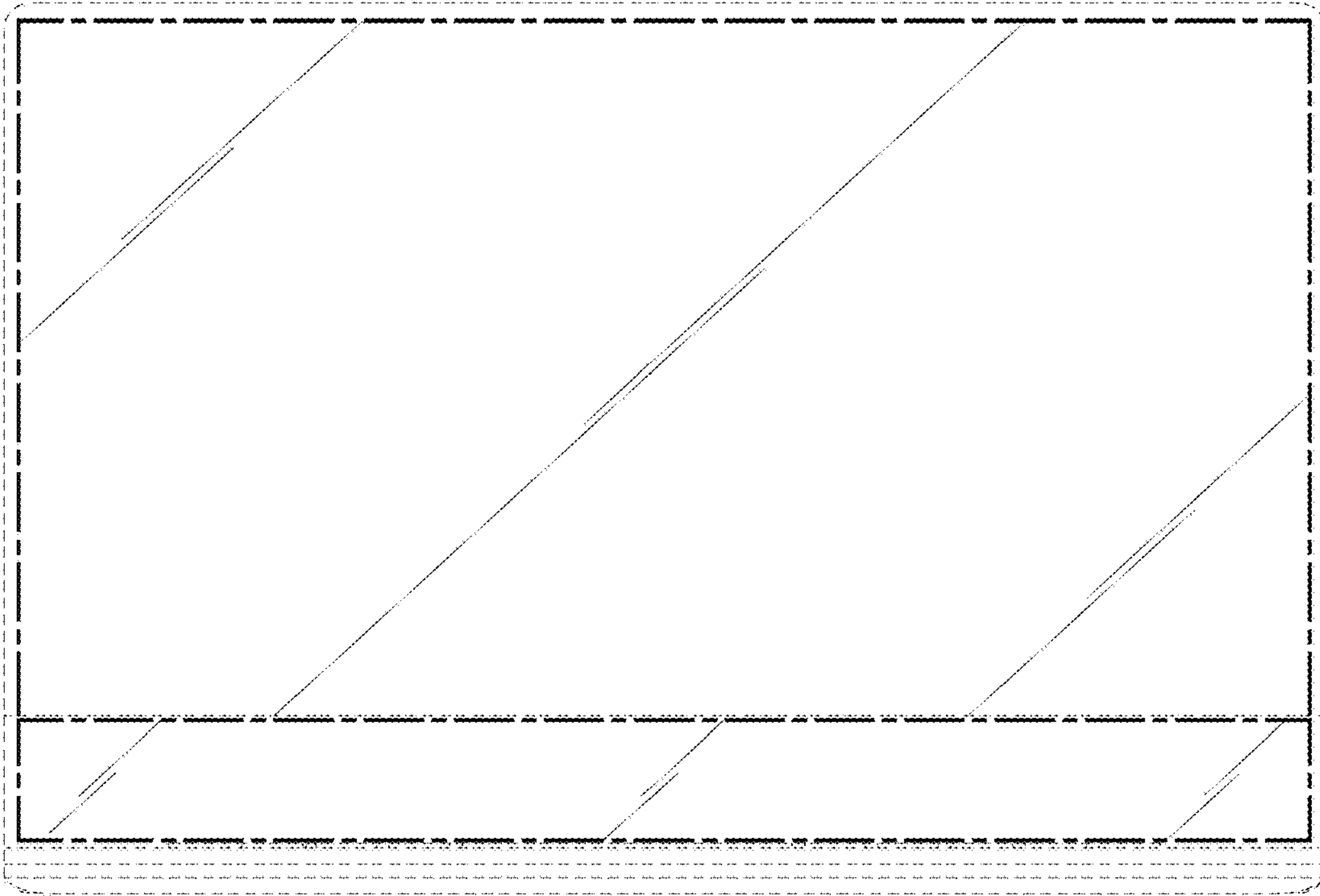

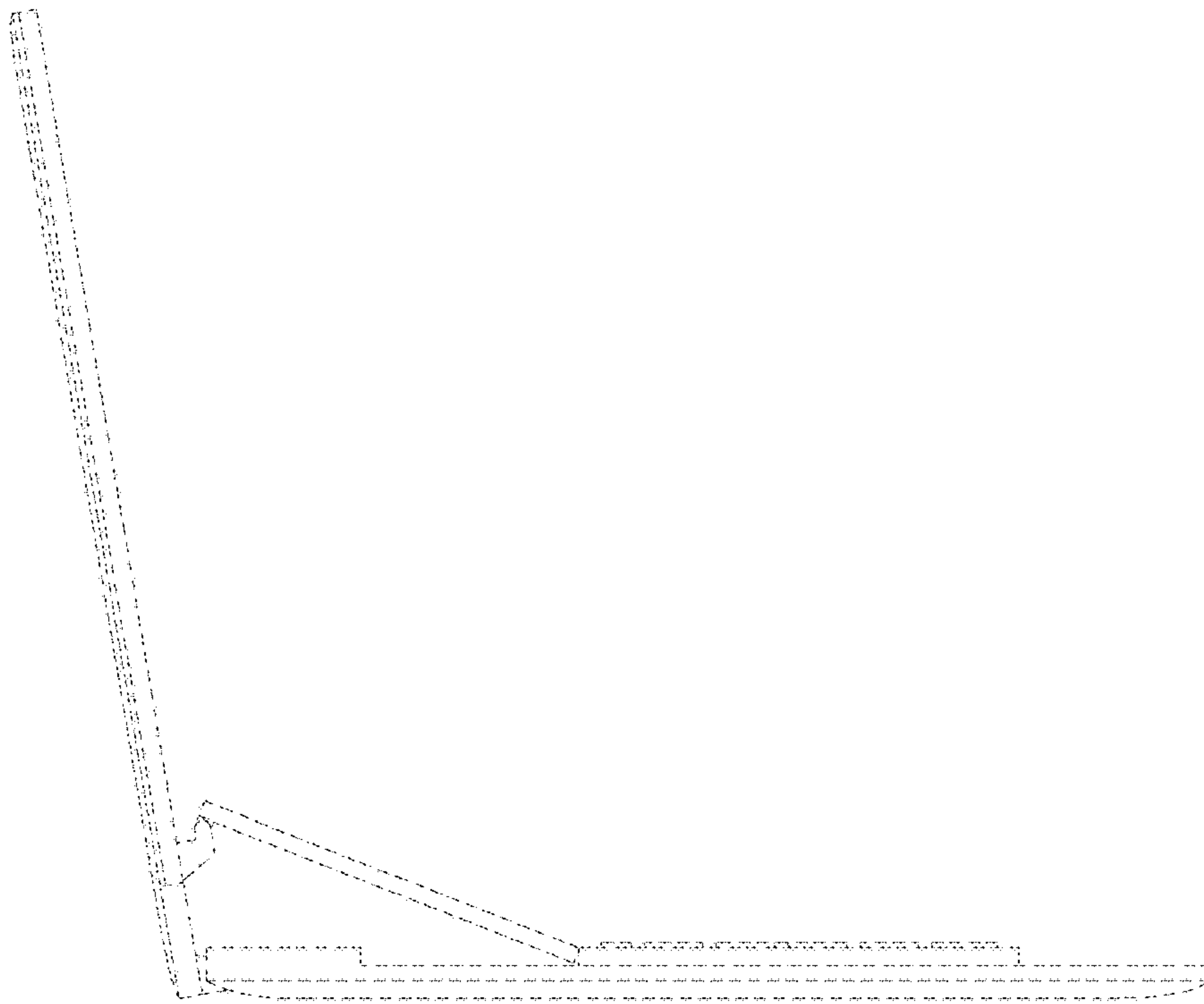

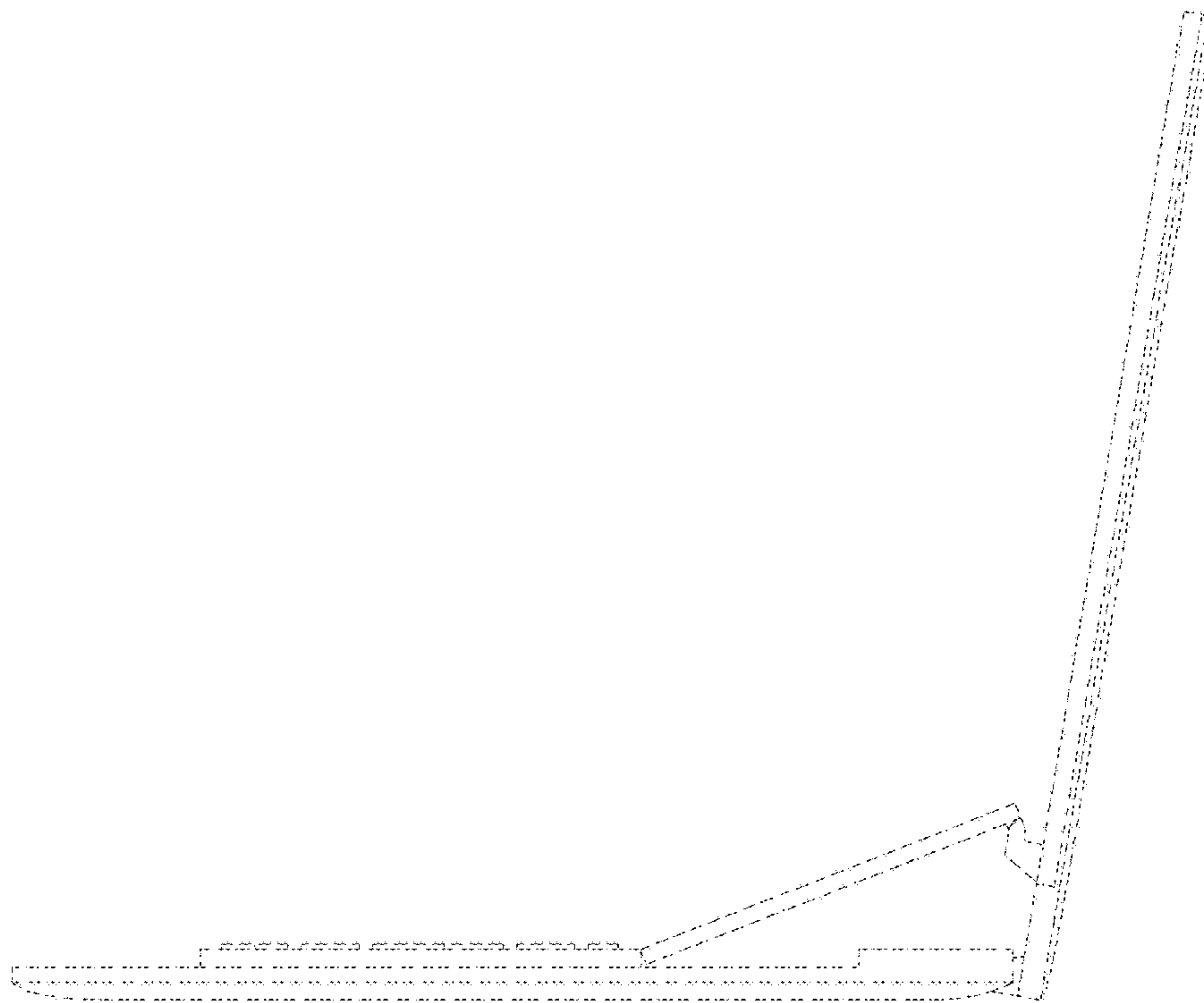

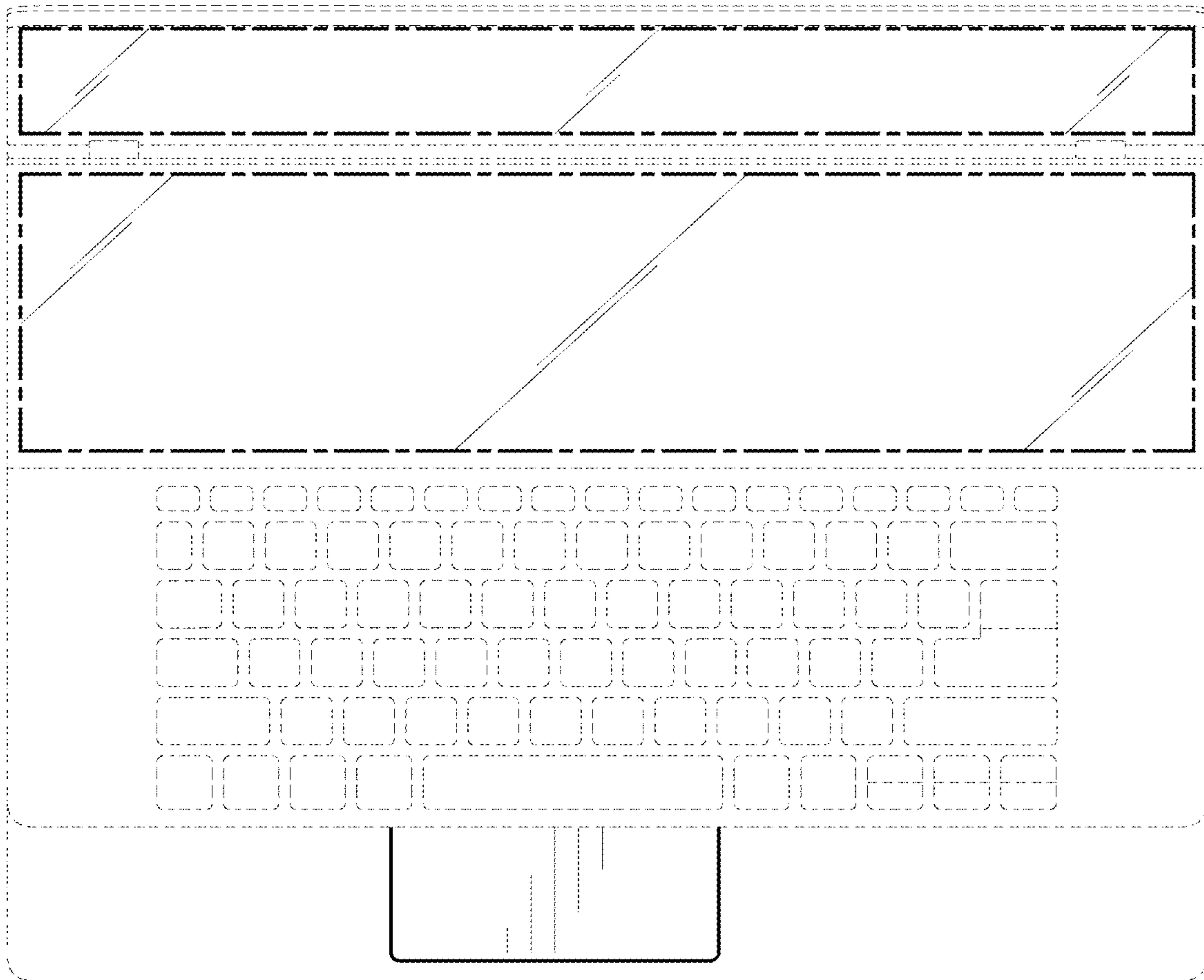
