FIG. 4 is a front view of another embodiment of a display or portion thereof with animated graphical user interface;

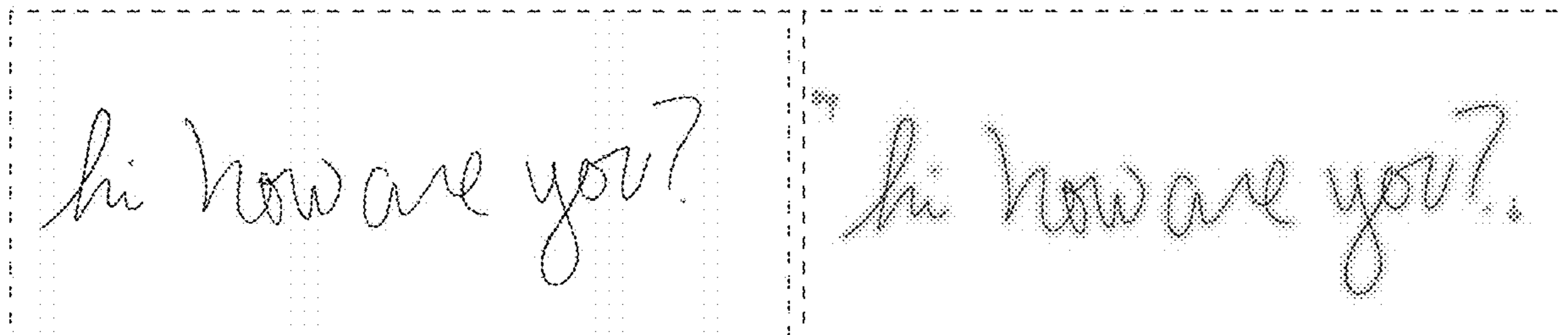
FIG. 5 is a front view of a second image thereof; and,

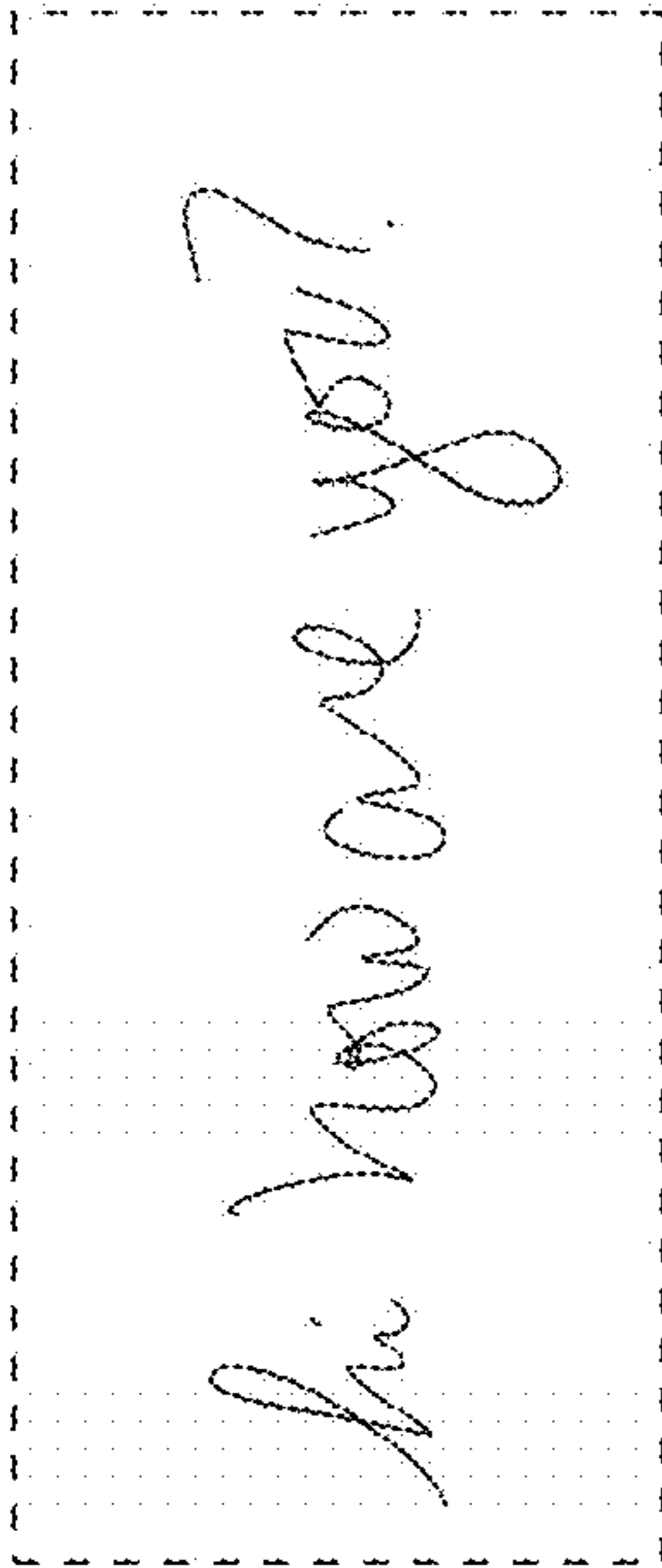

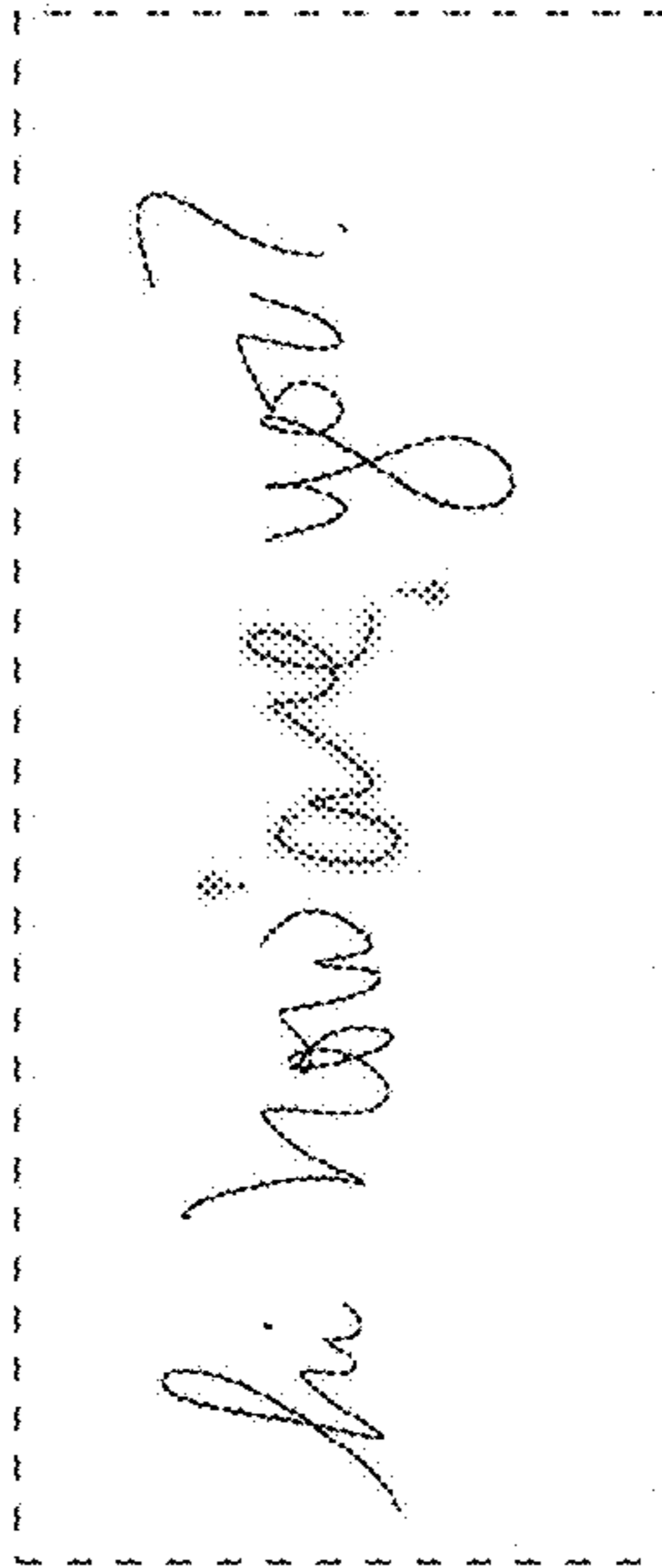

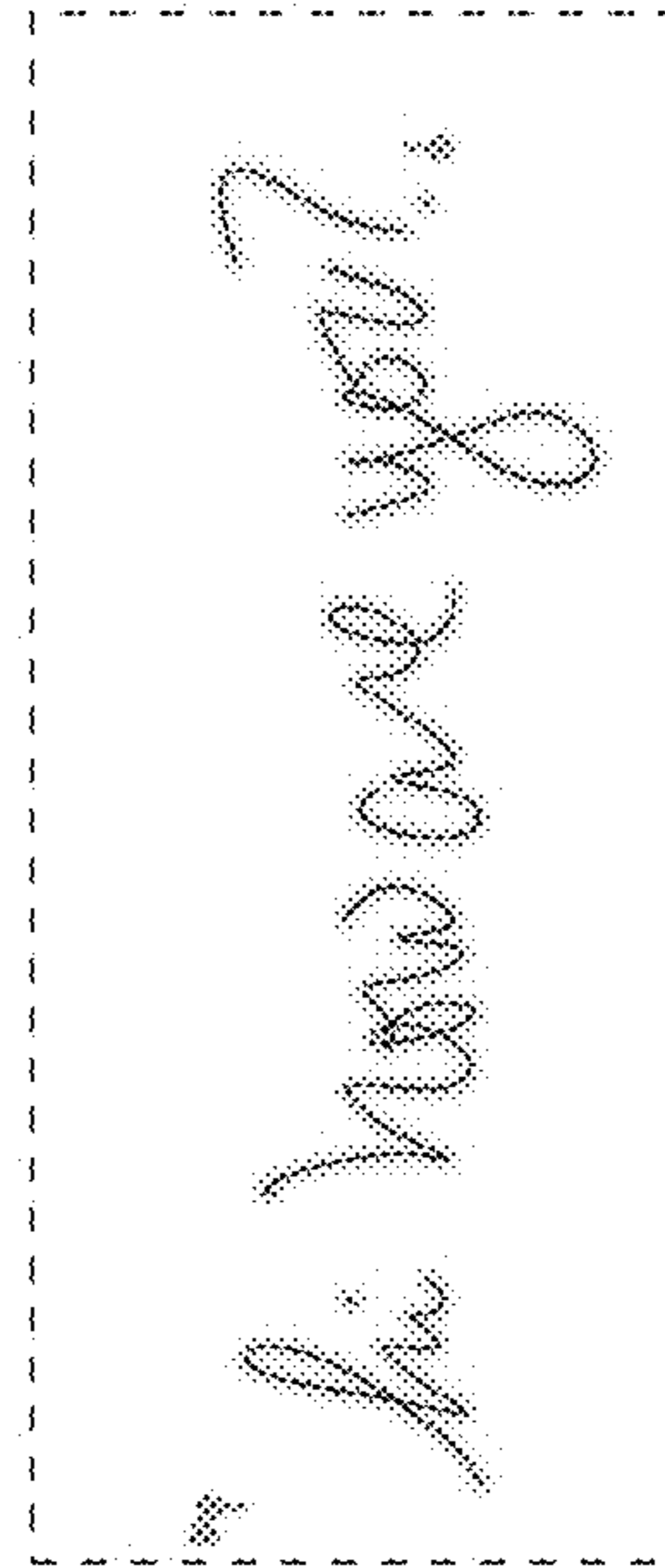

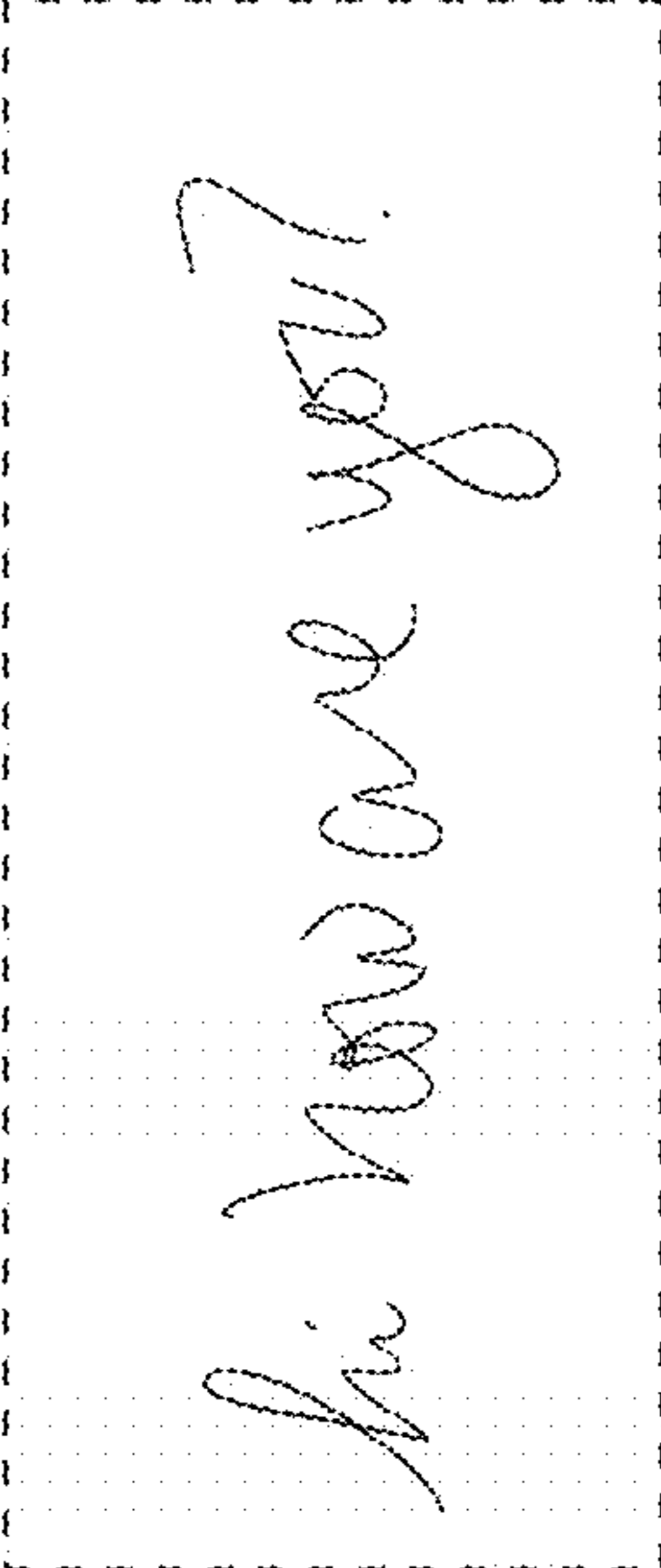

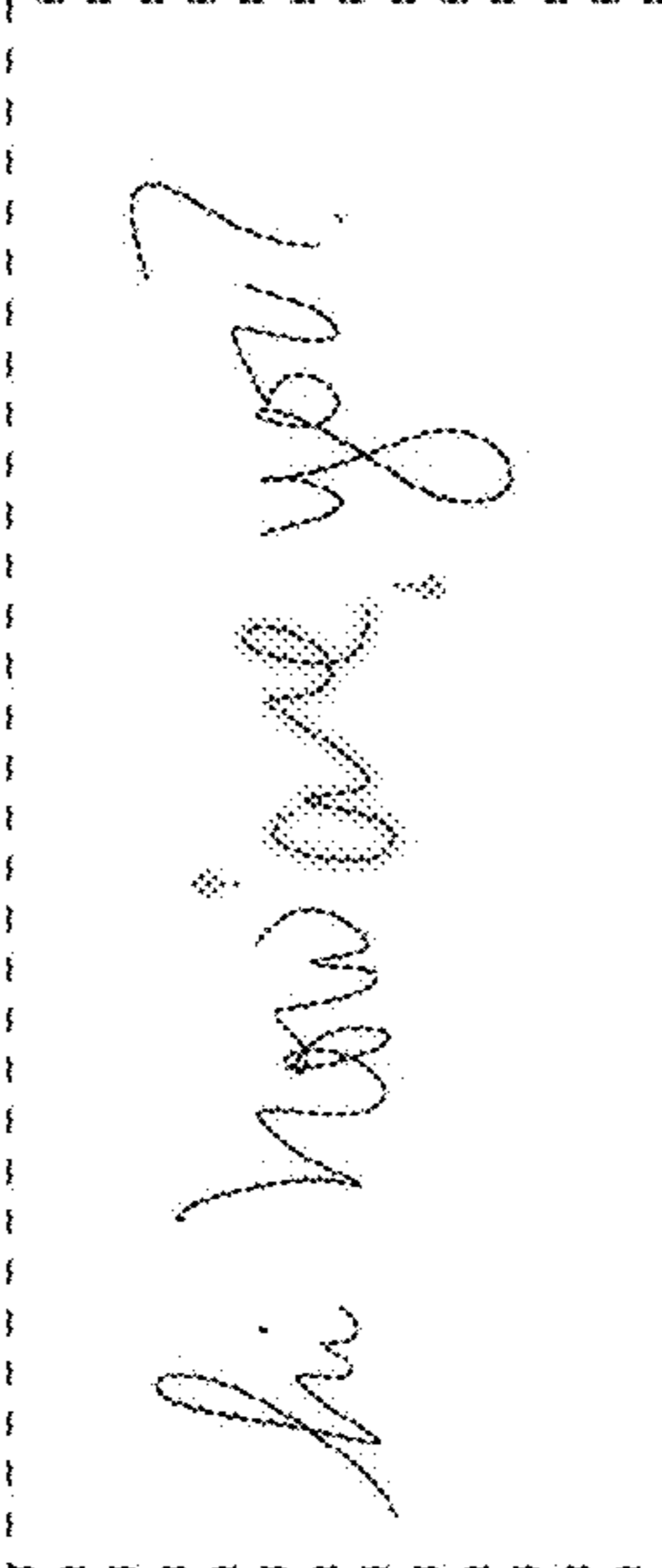

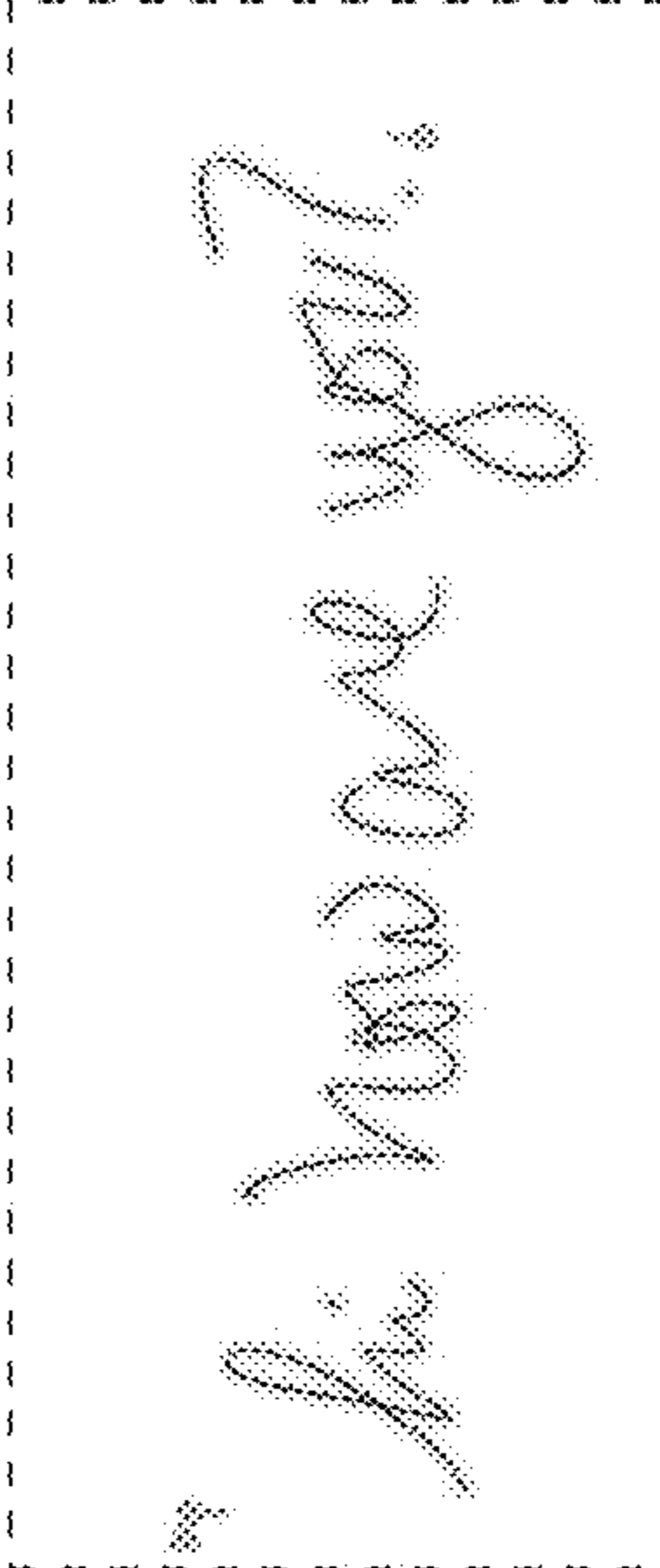
