FIG. 2 is a front view of a display screen or a portion thereof with construction costs-focused graphical user interface showing my new design according to a second embodiment.

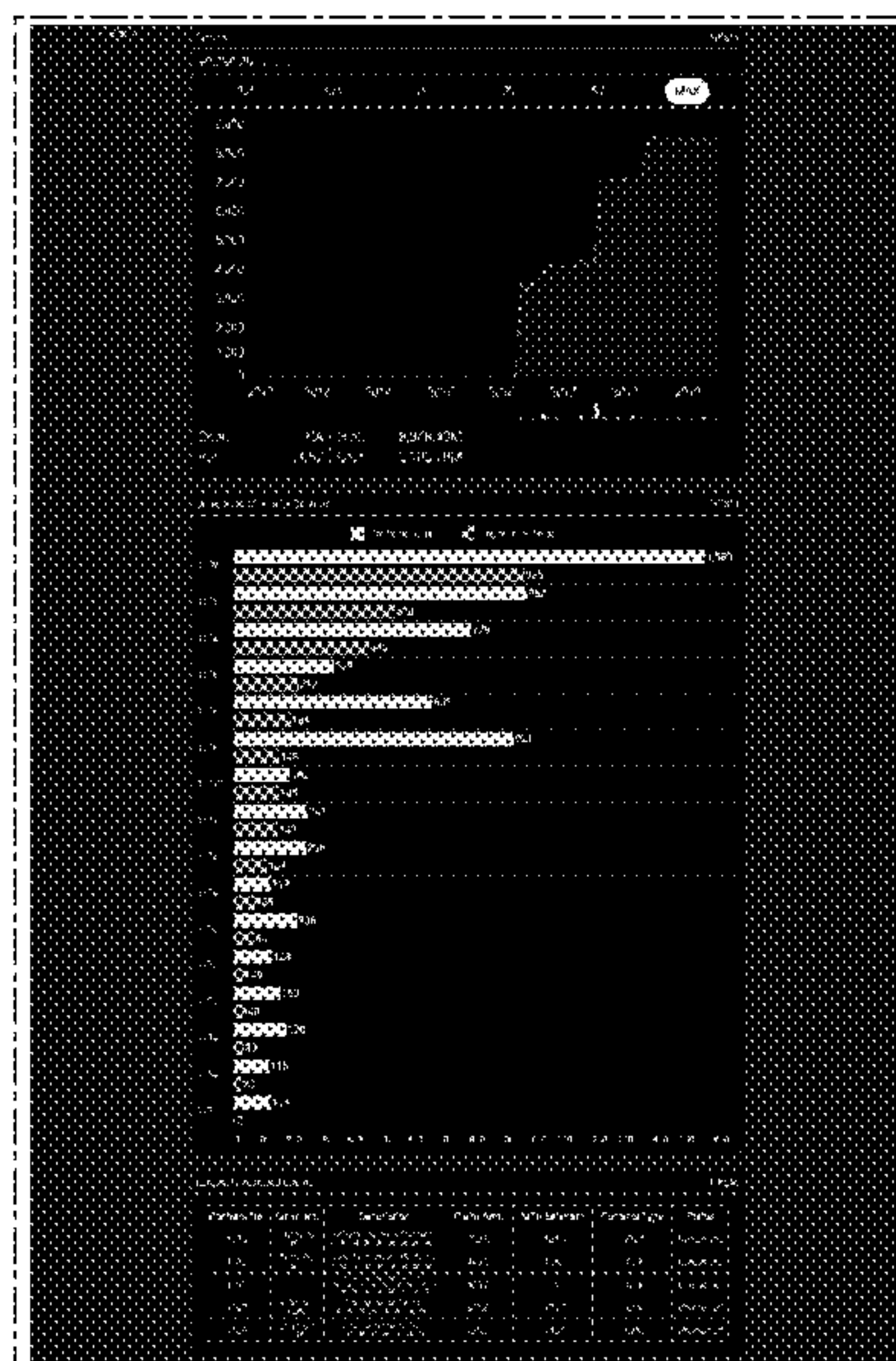
The outer broken lines in the figures show a display screen or a portion thereof, and form no part of the claimed design.

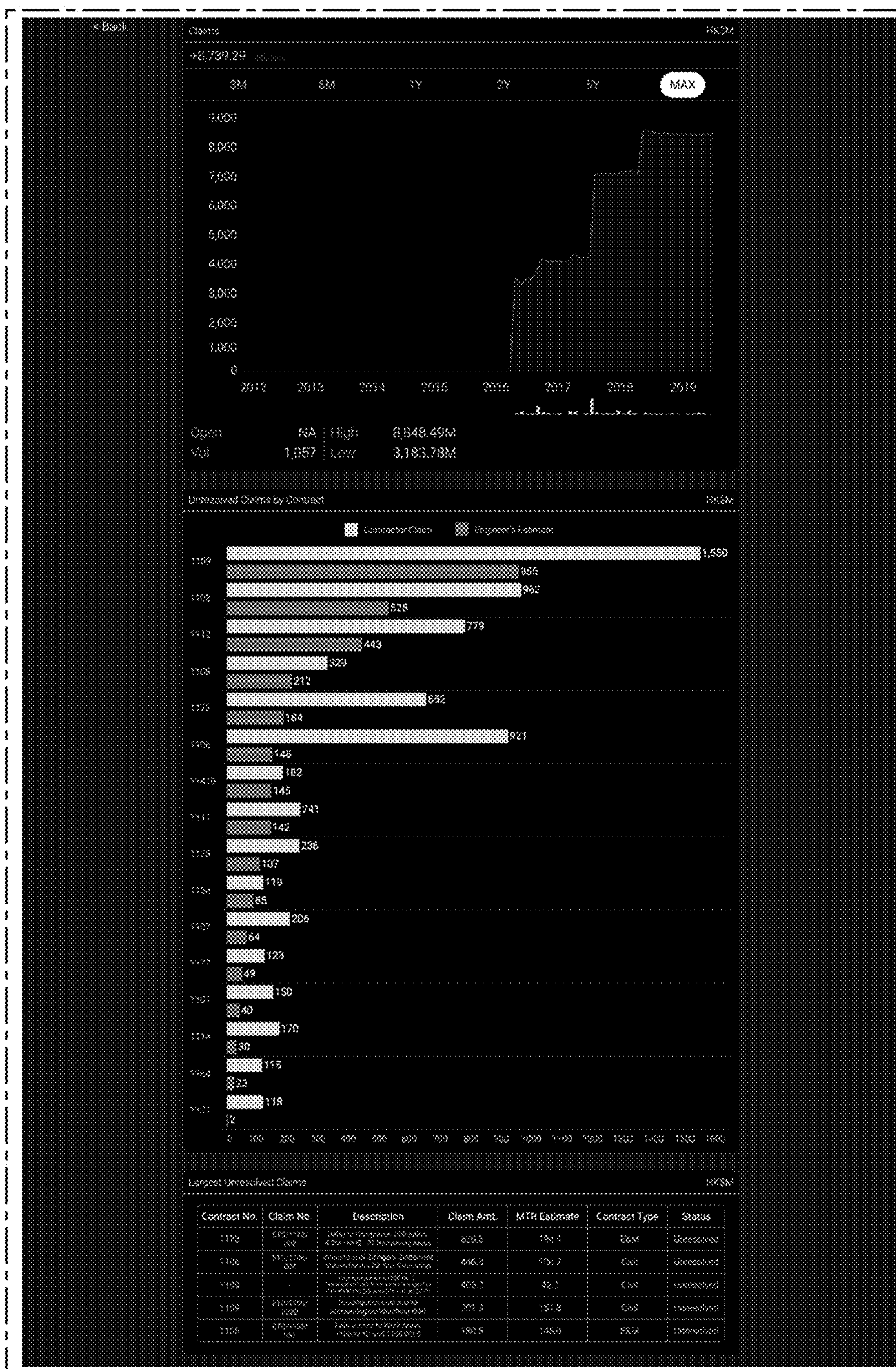

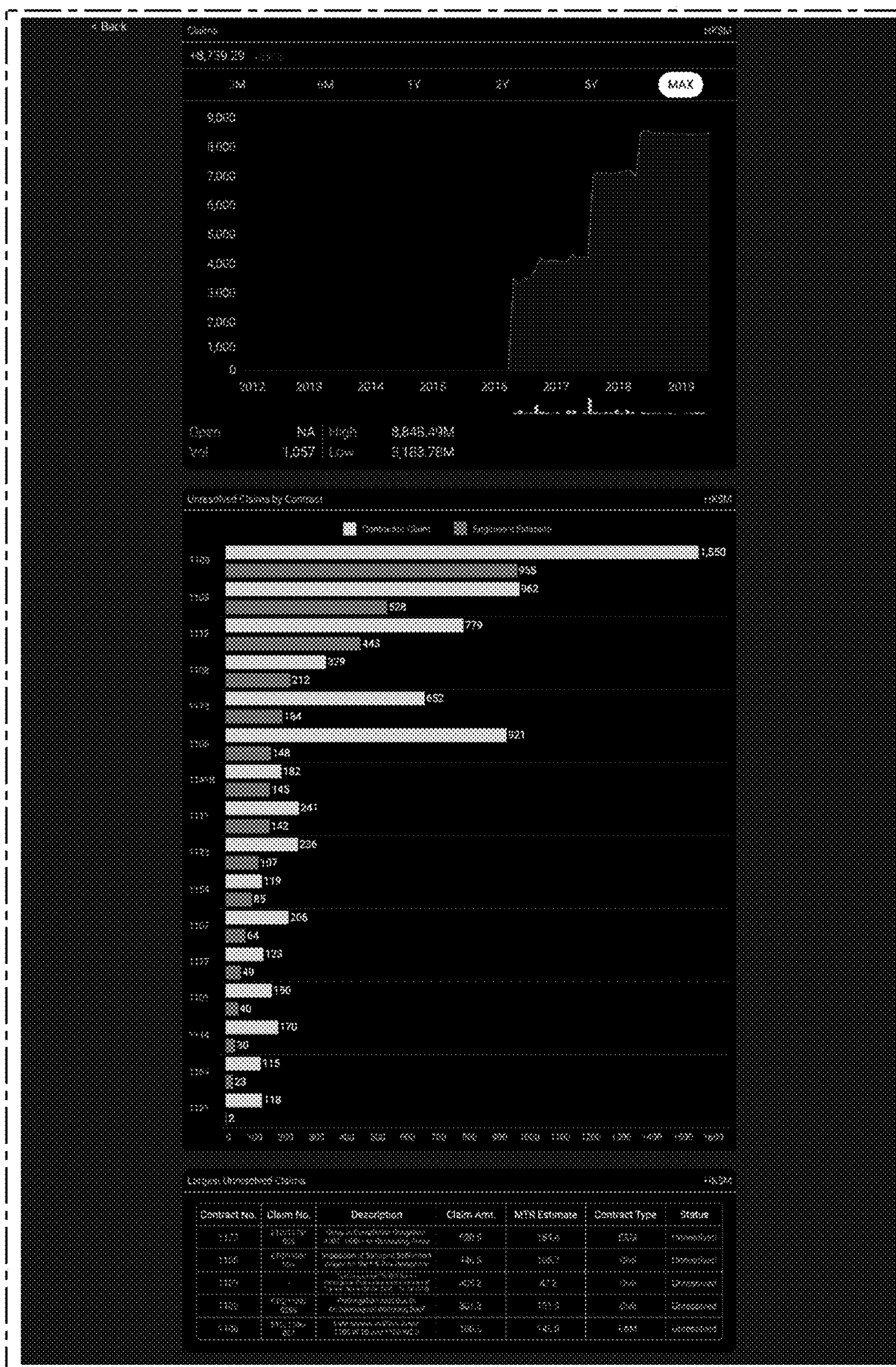
