DESCRIPTION

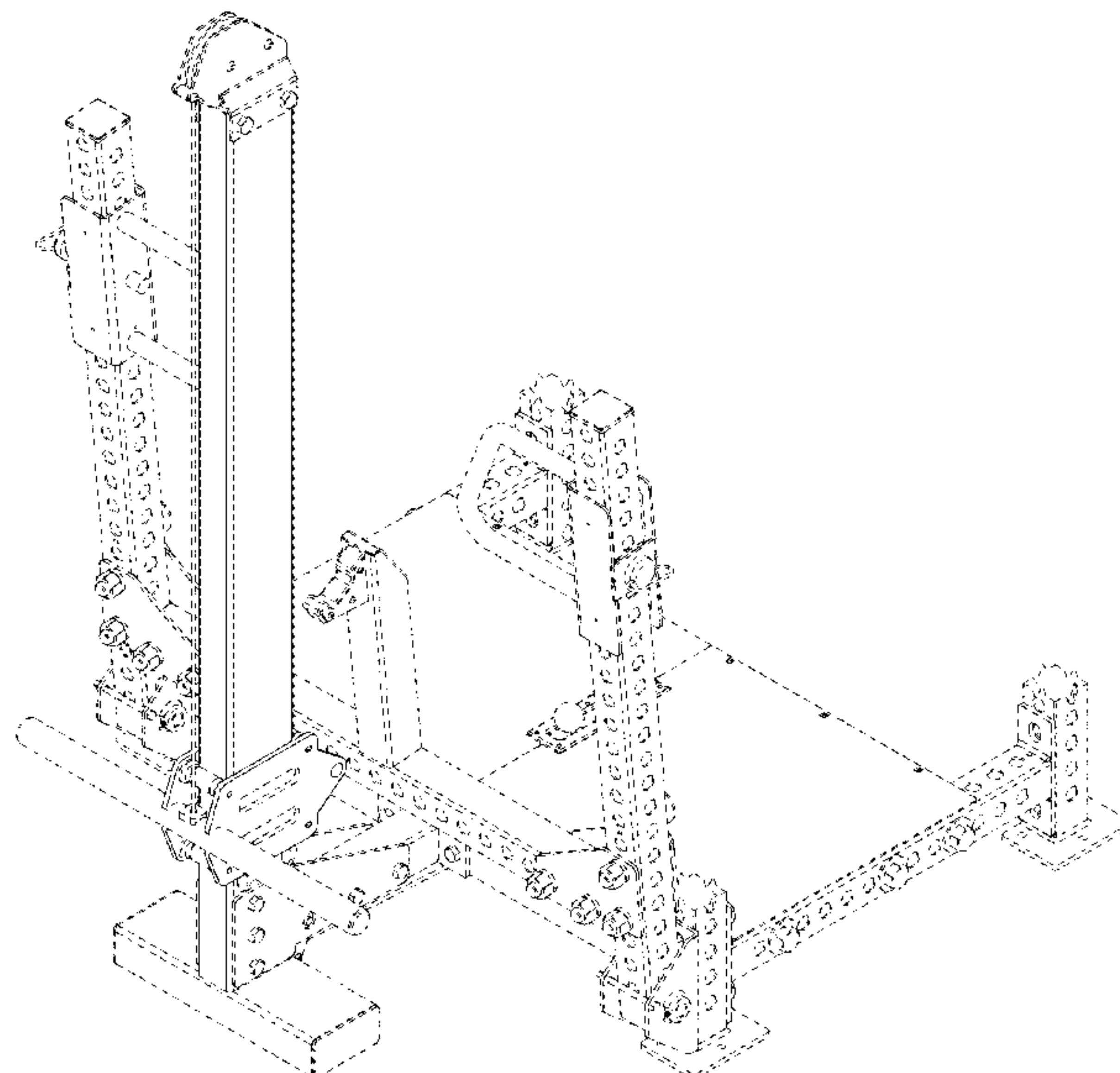
FIG. 1 is a top, front, right perspective view of an exercise stand showing my new design;

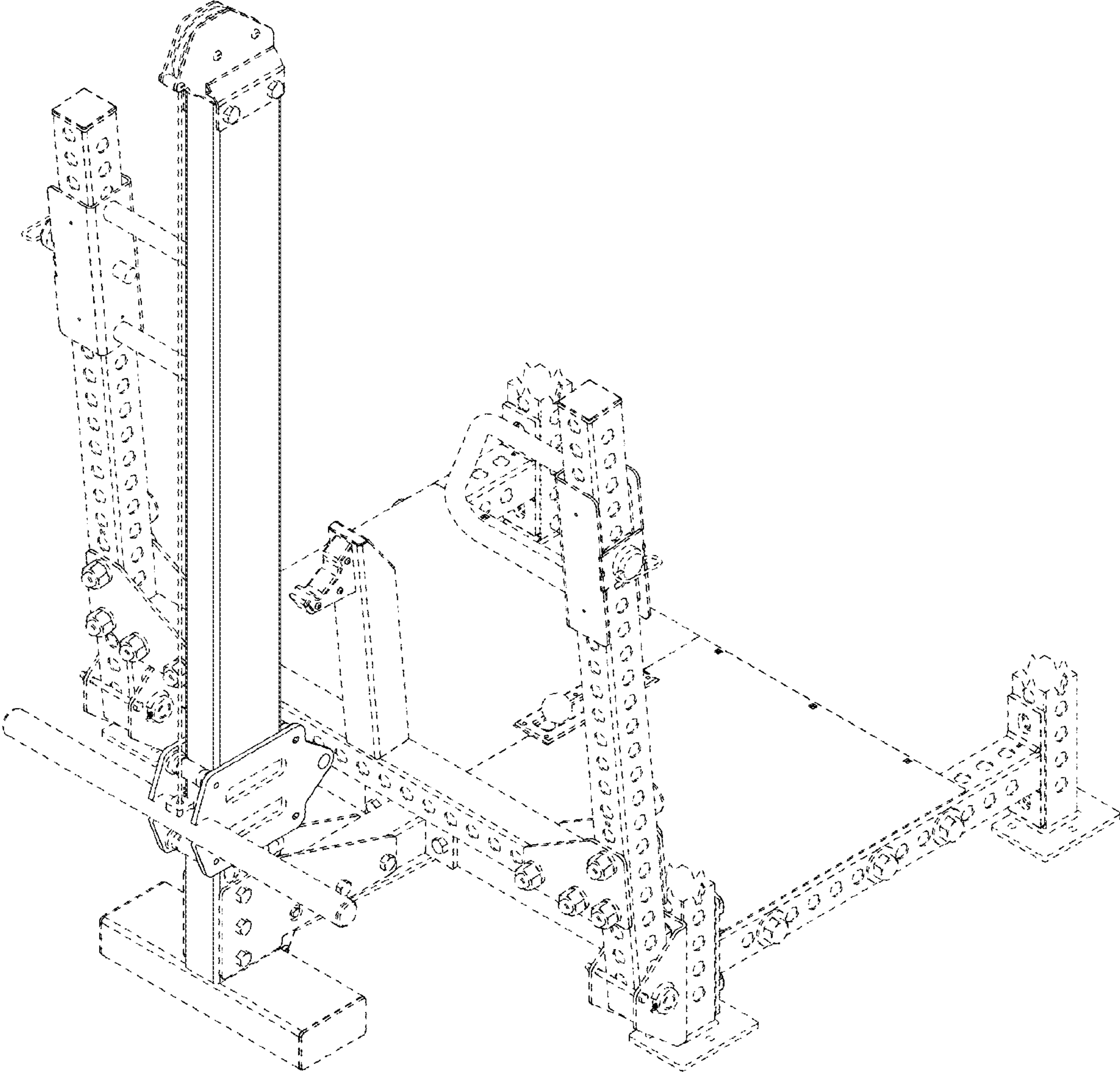

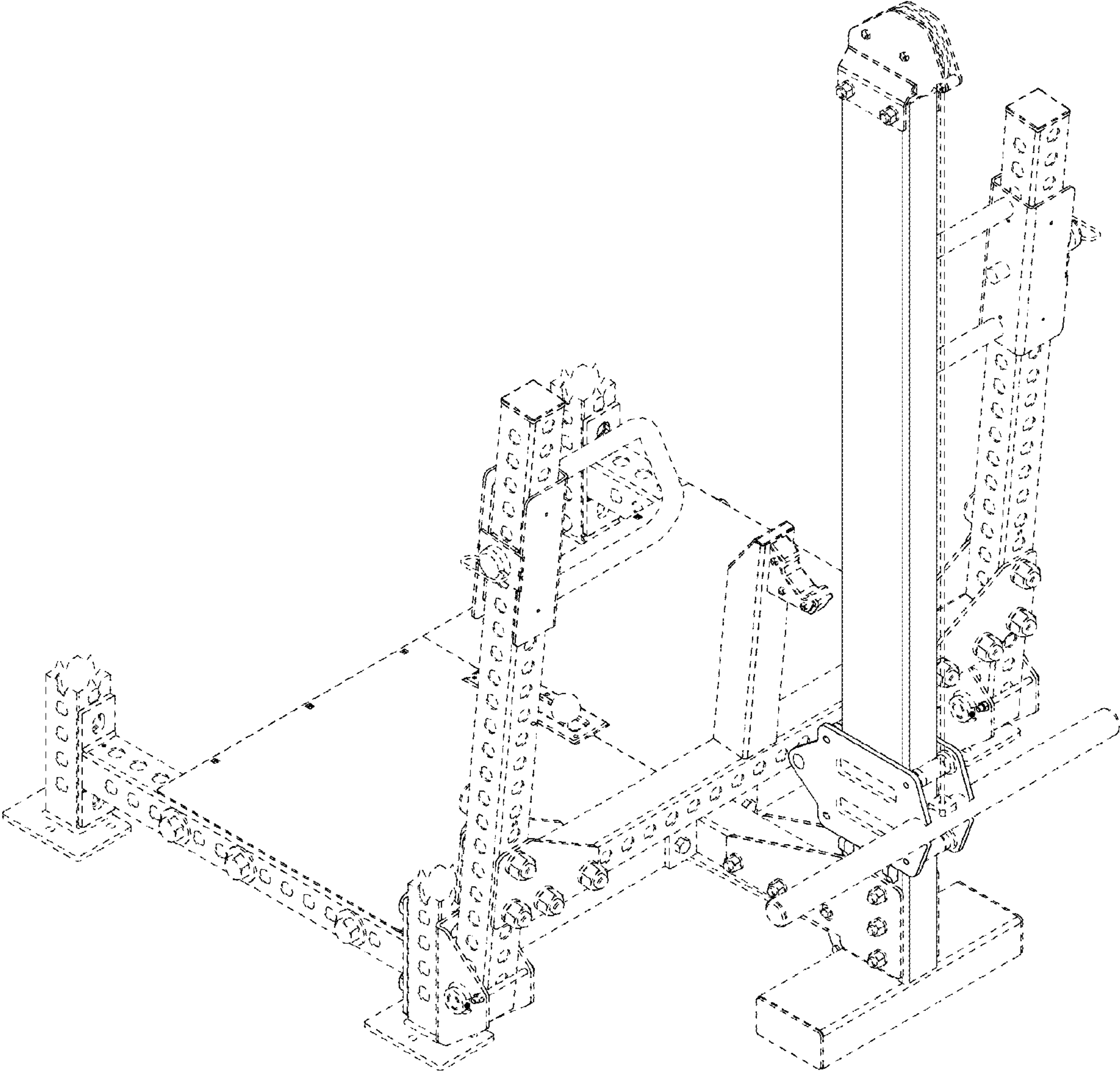

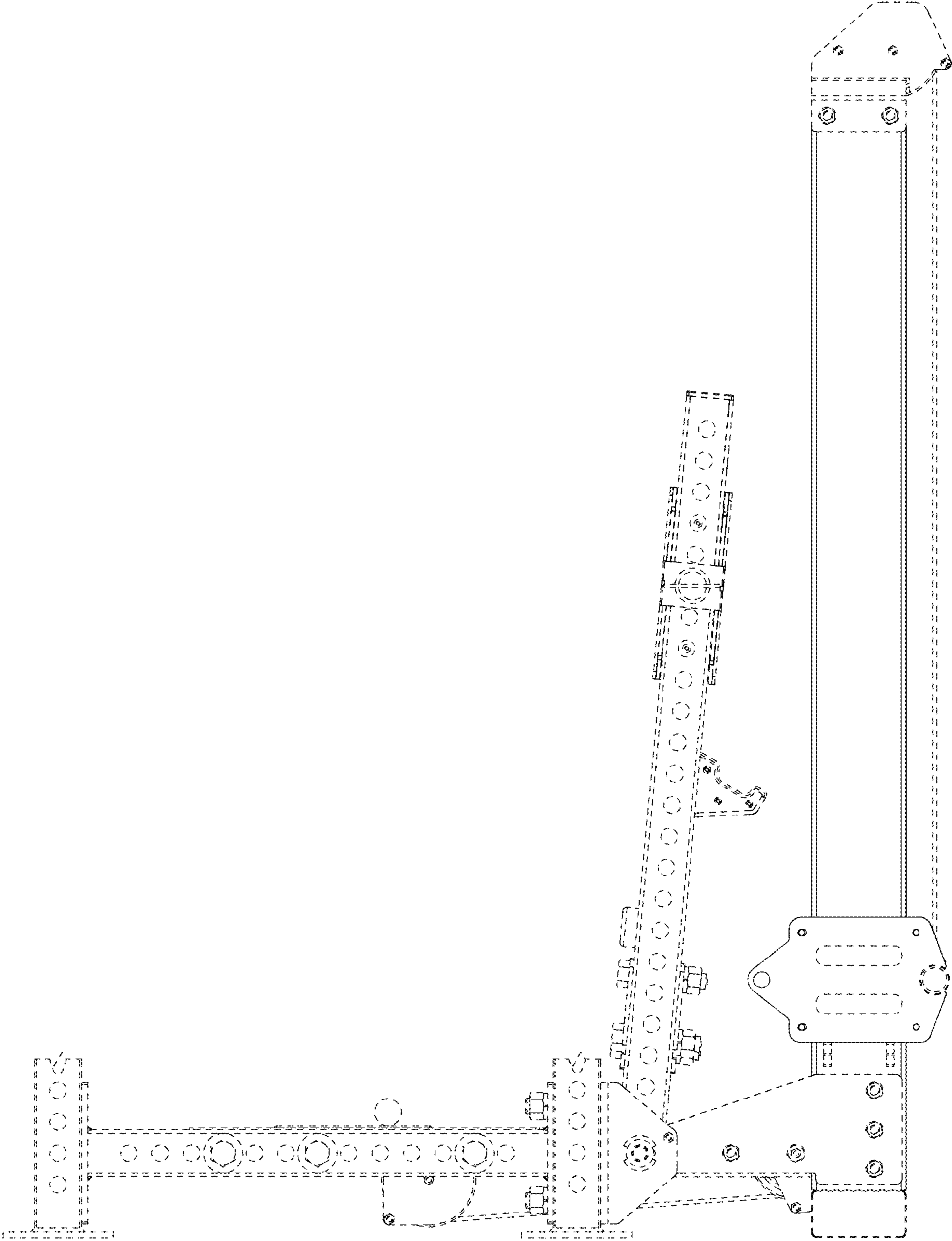

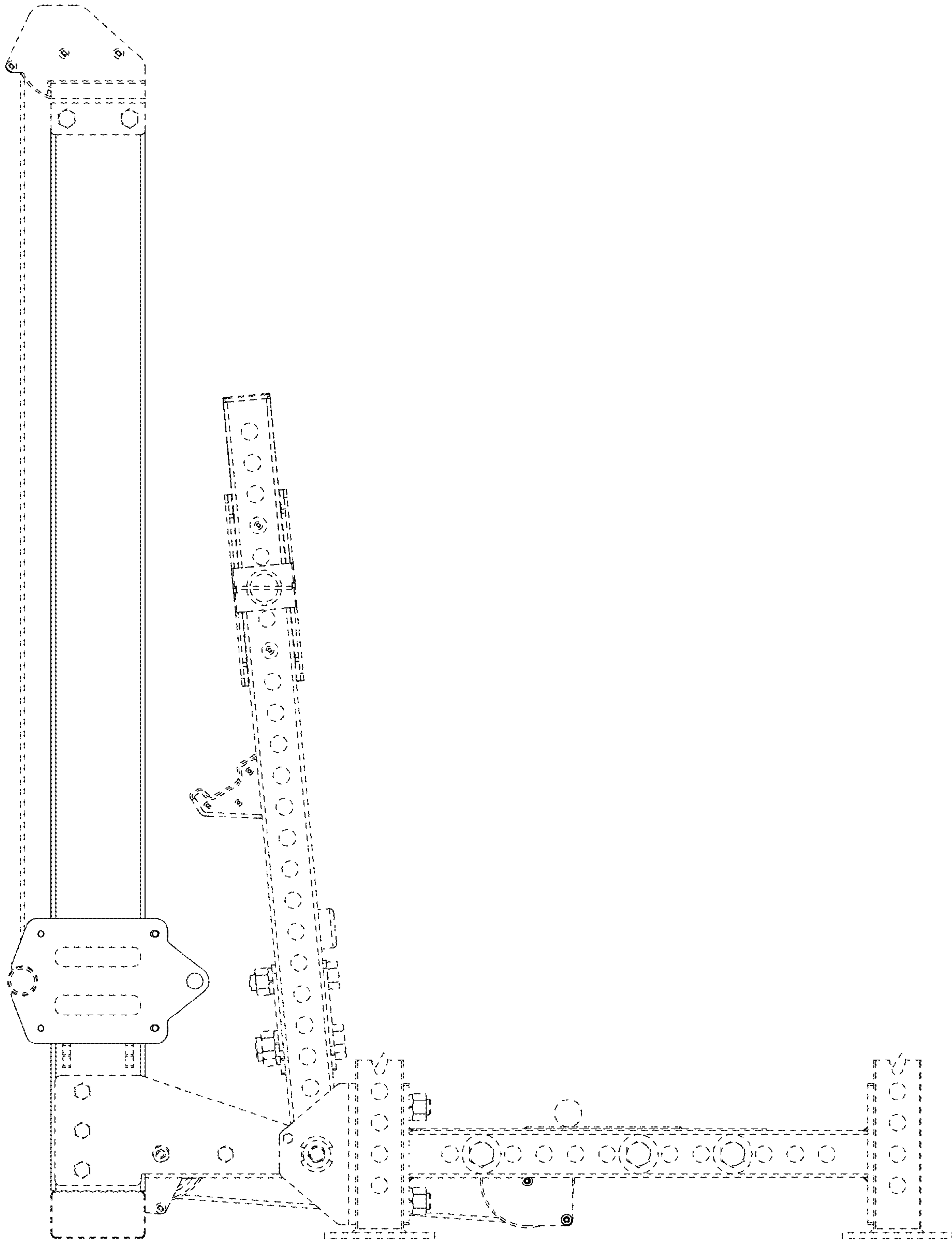

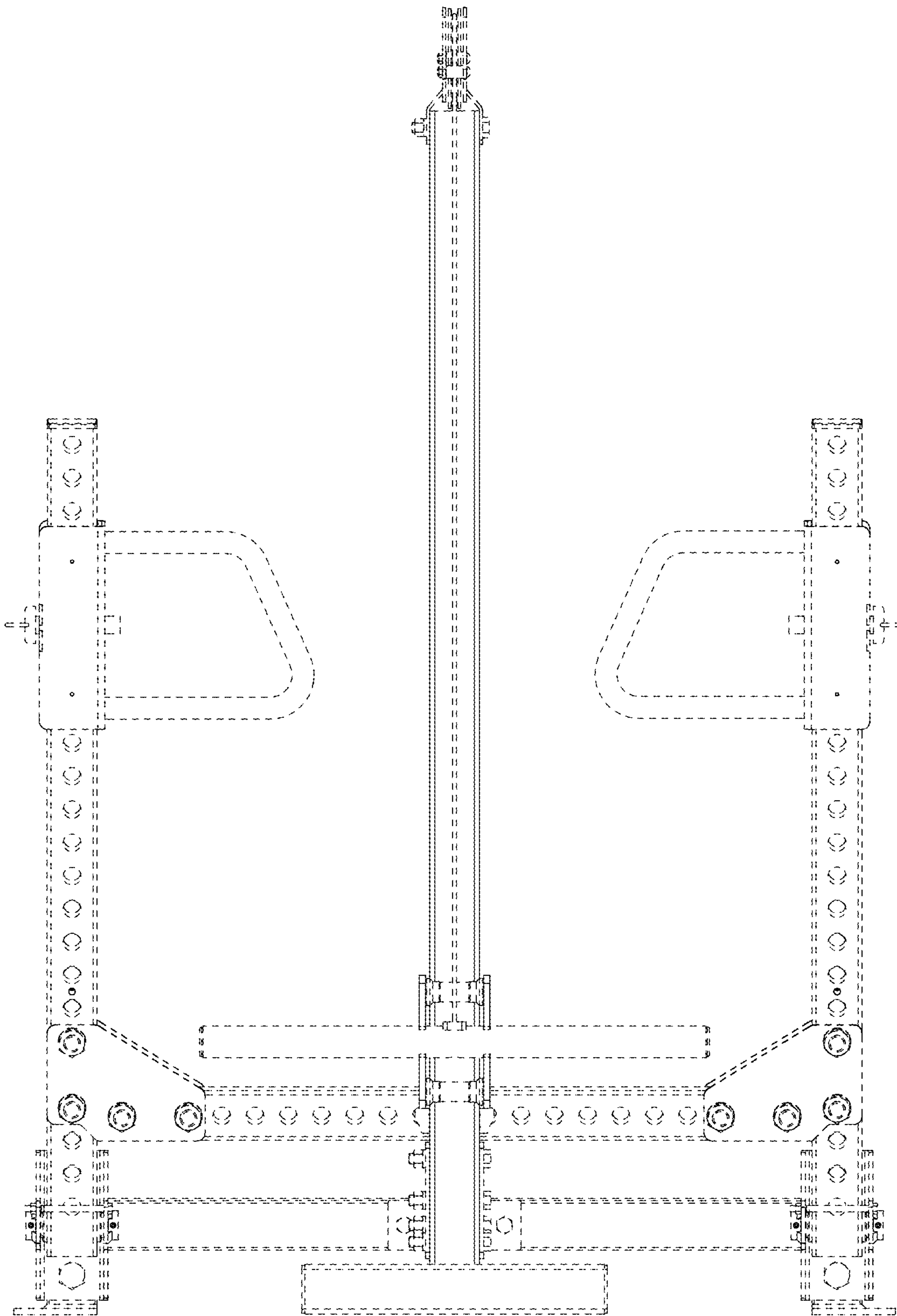

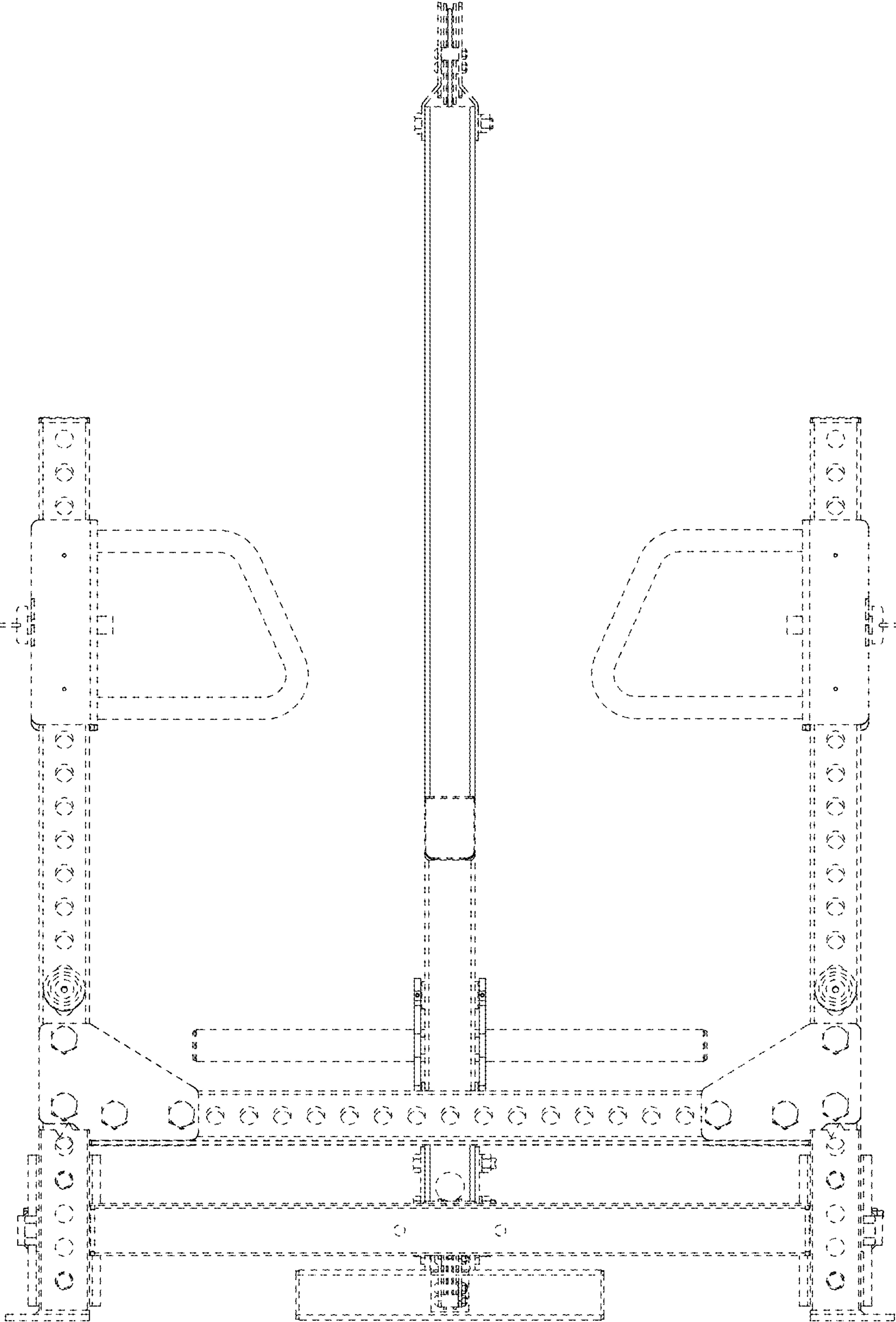

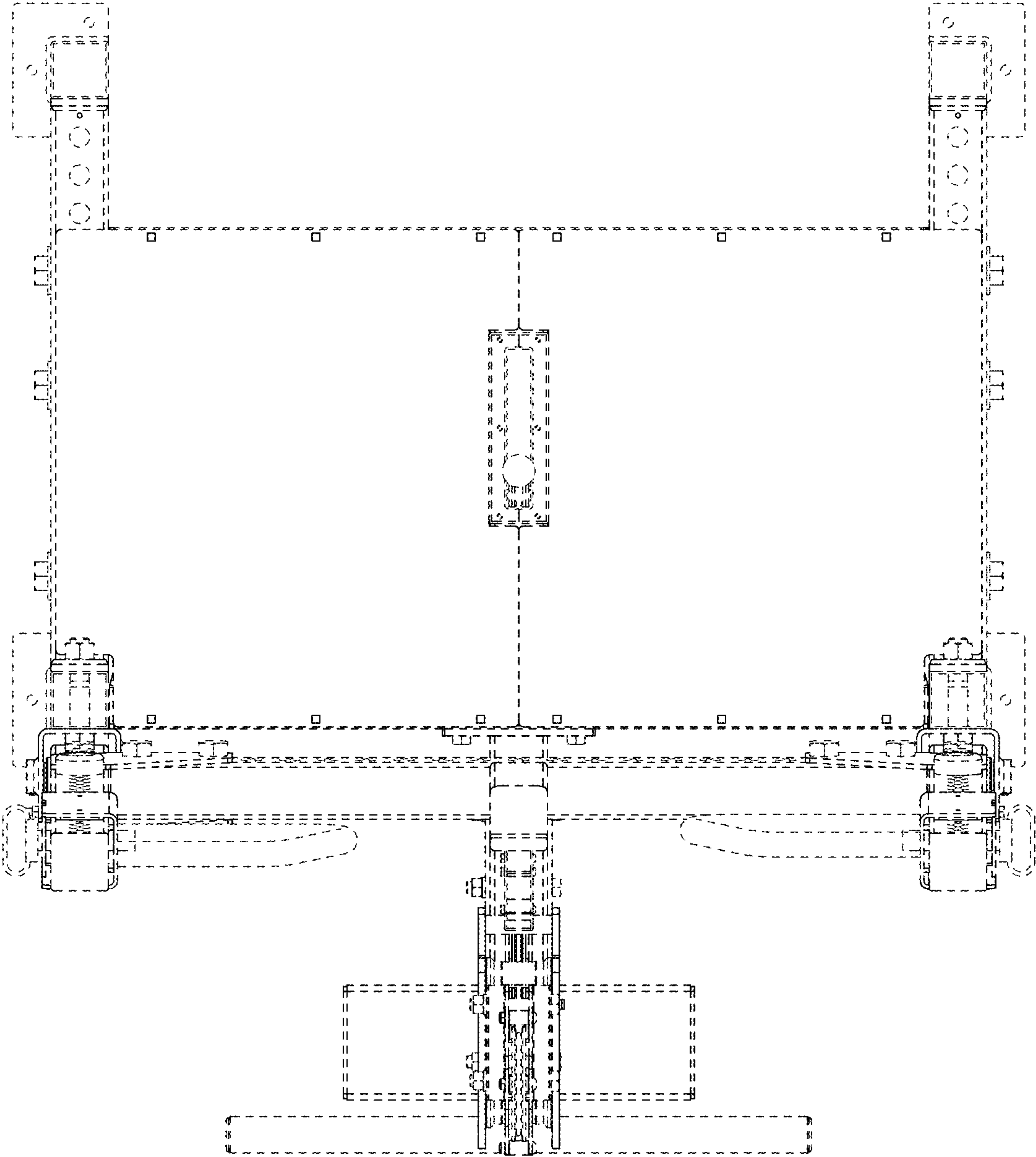

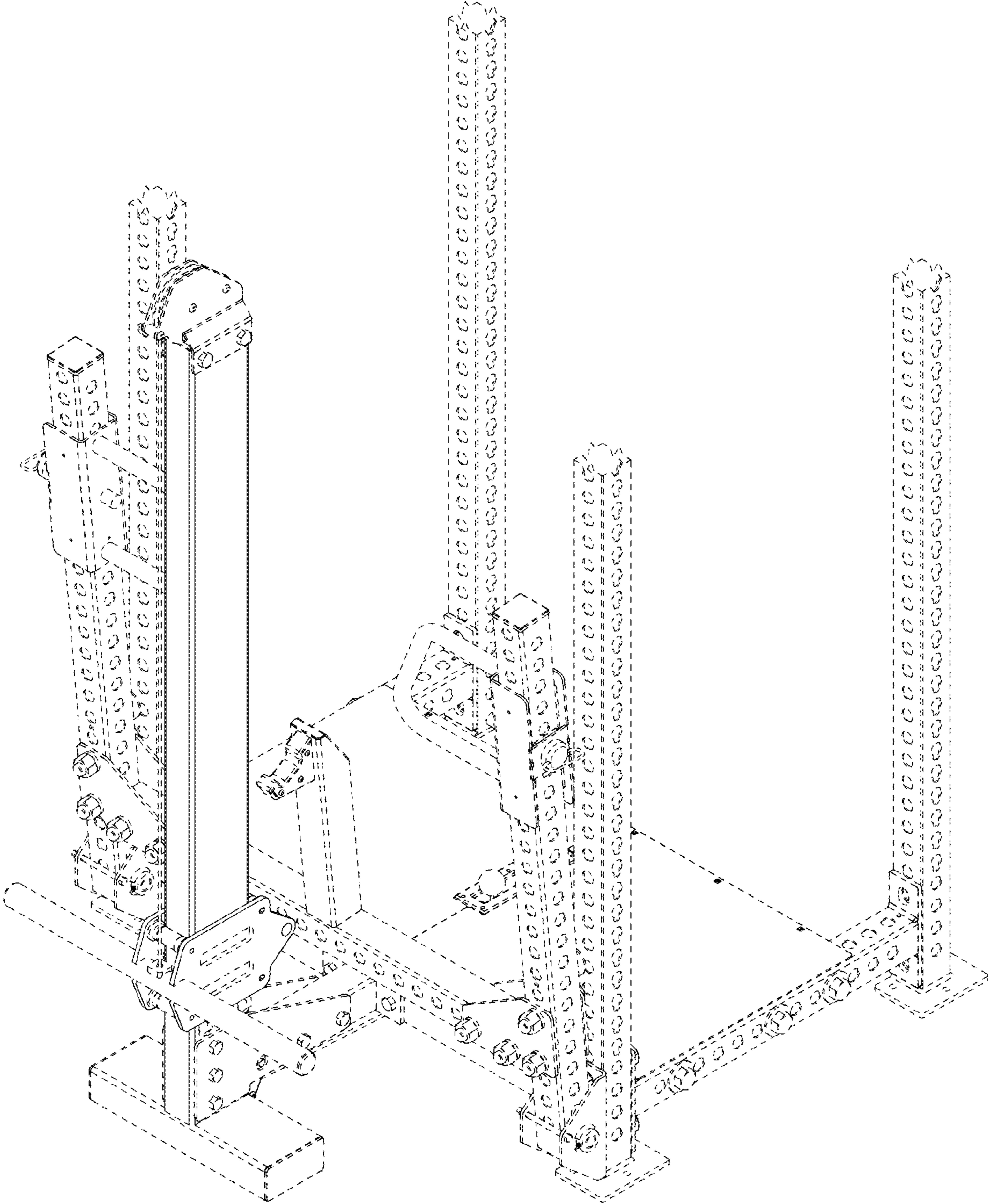
