FIG. 3 is a left side view.

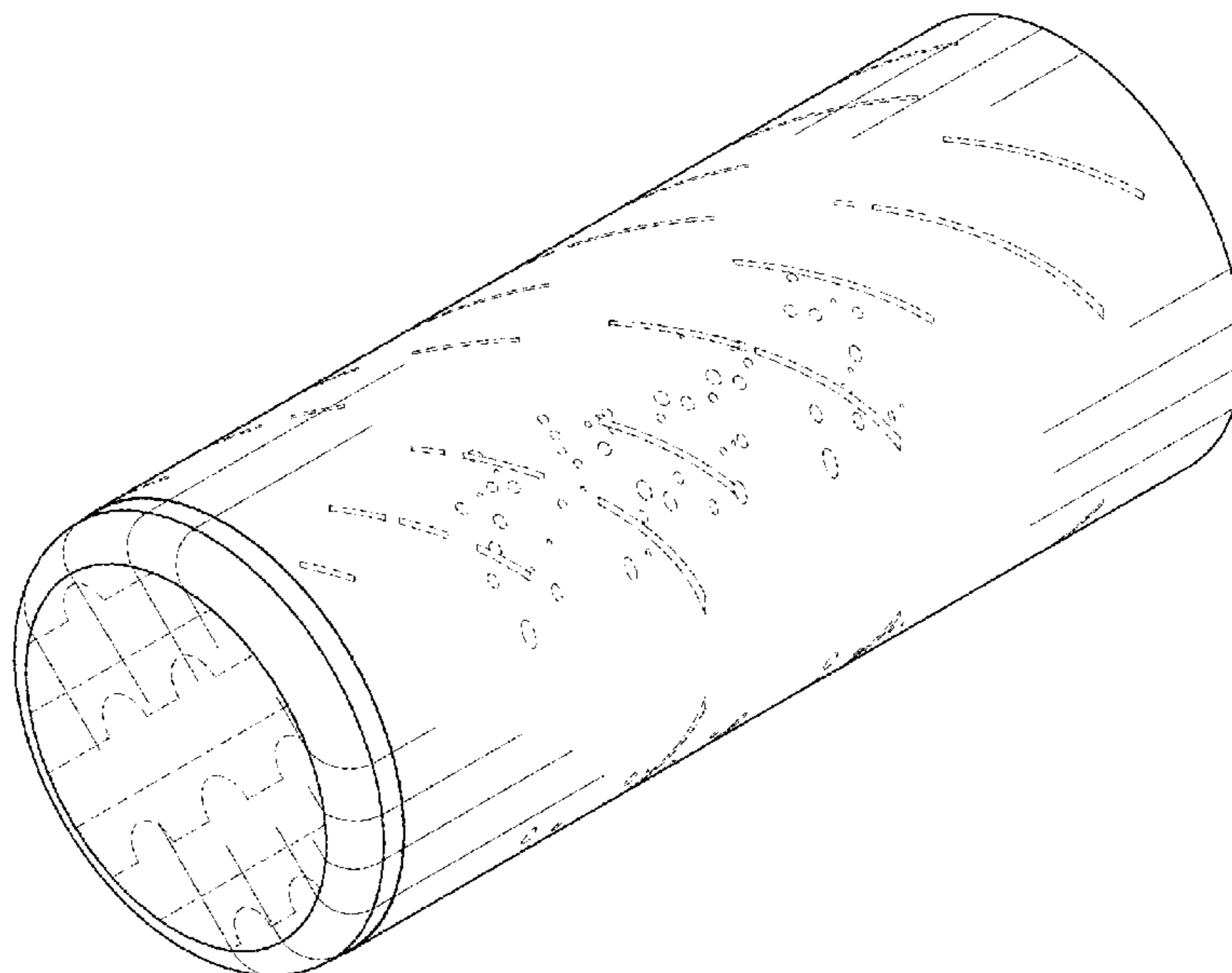
FIG. 4 is a right side view.

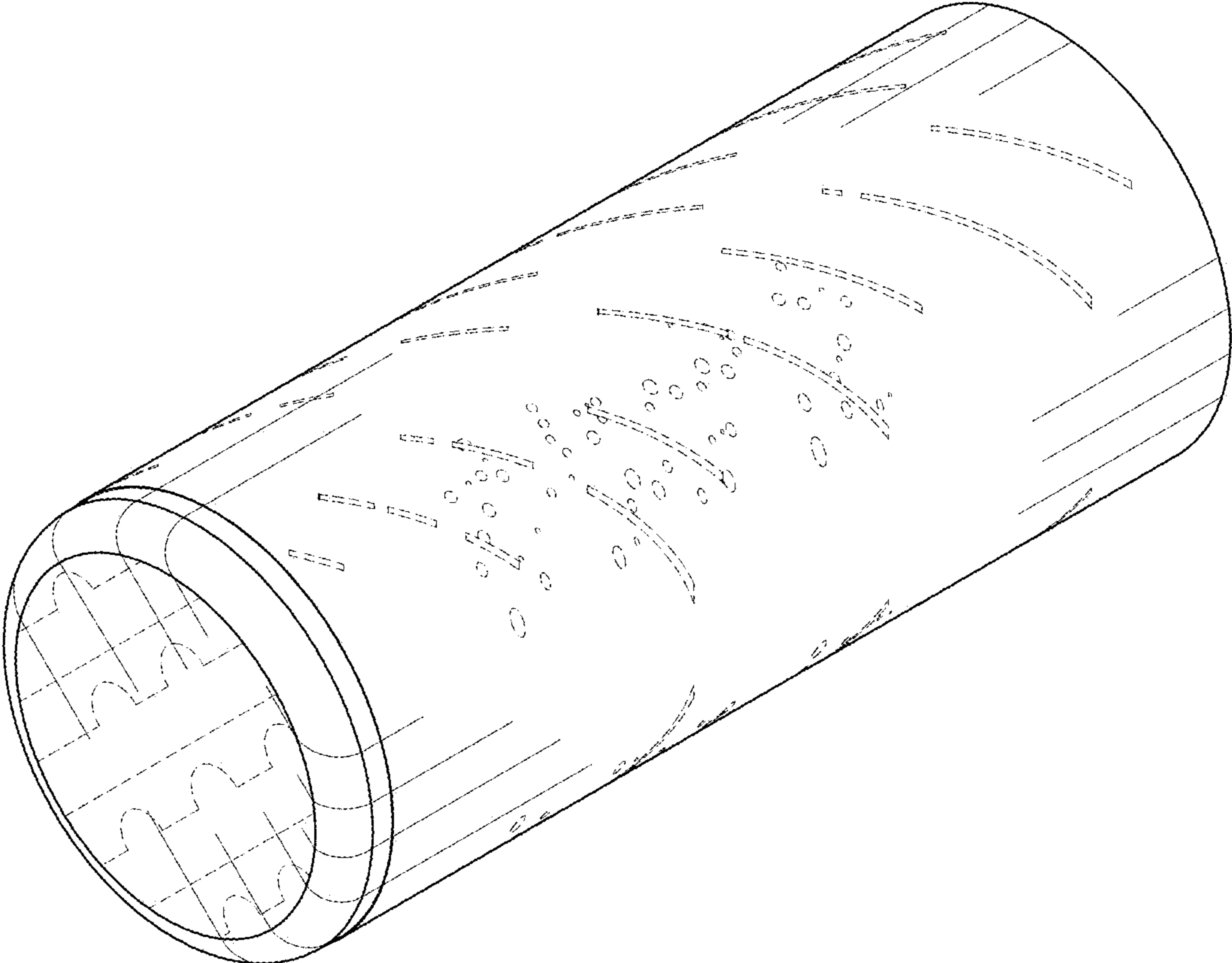

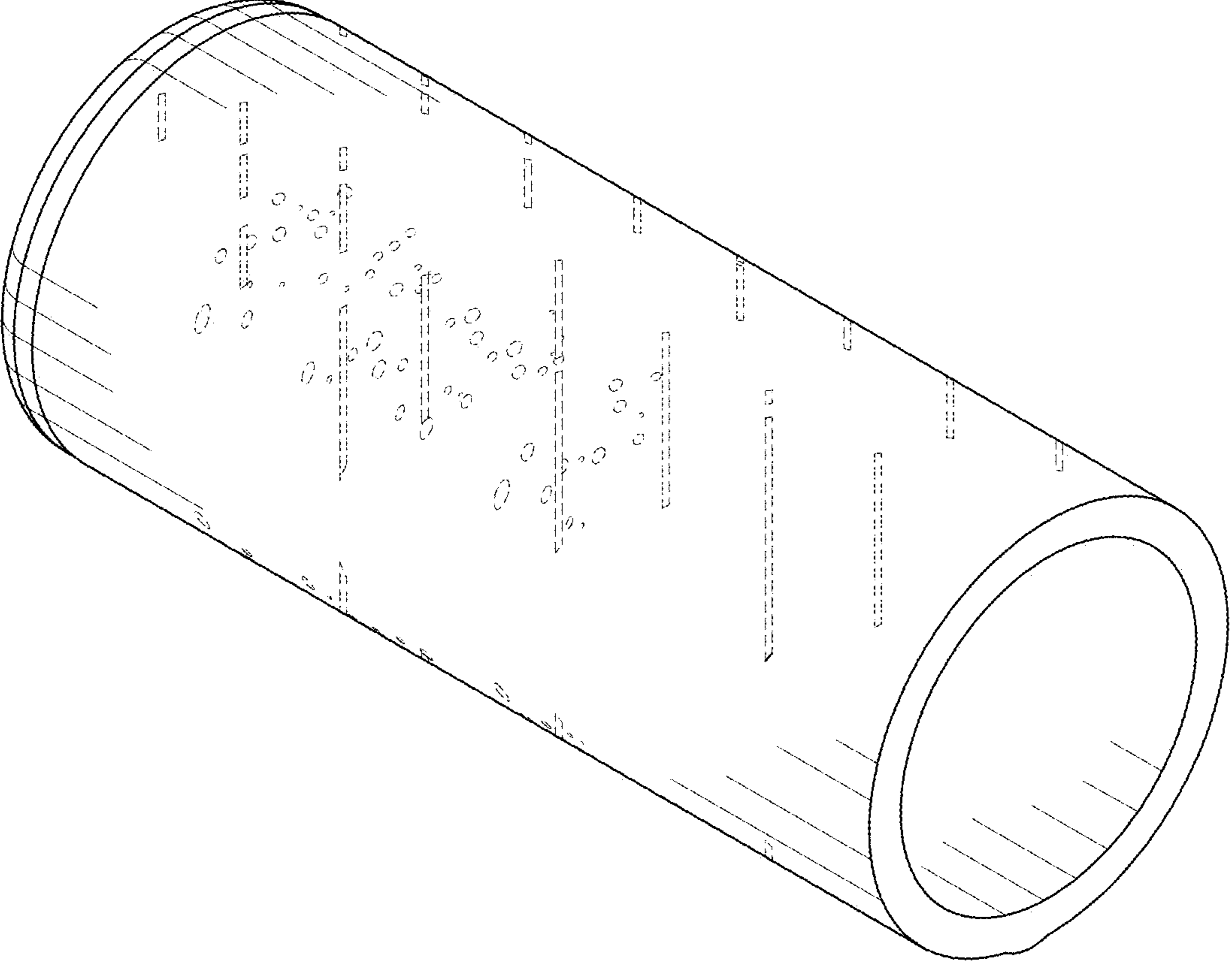

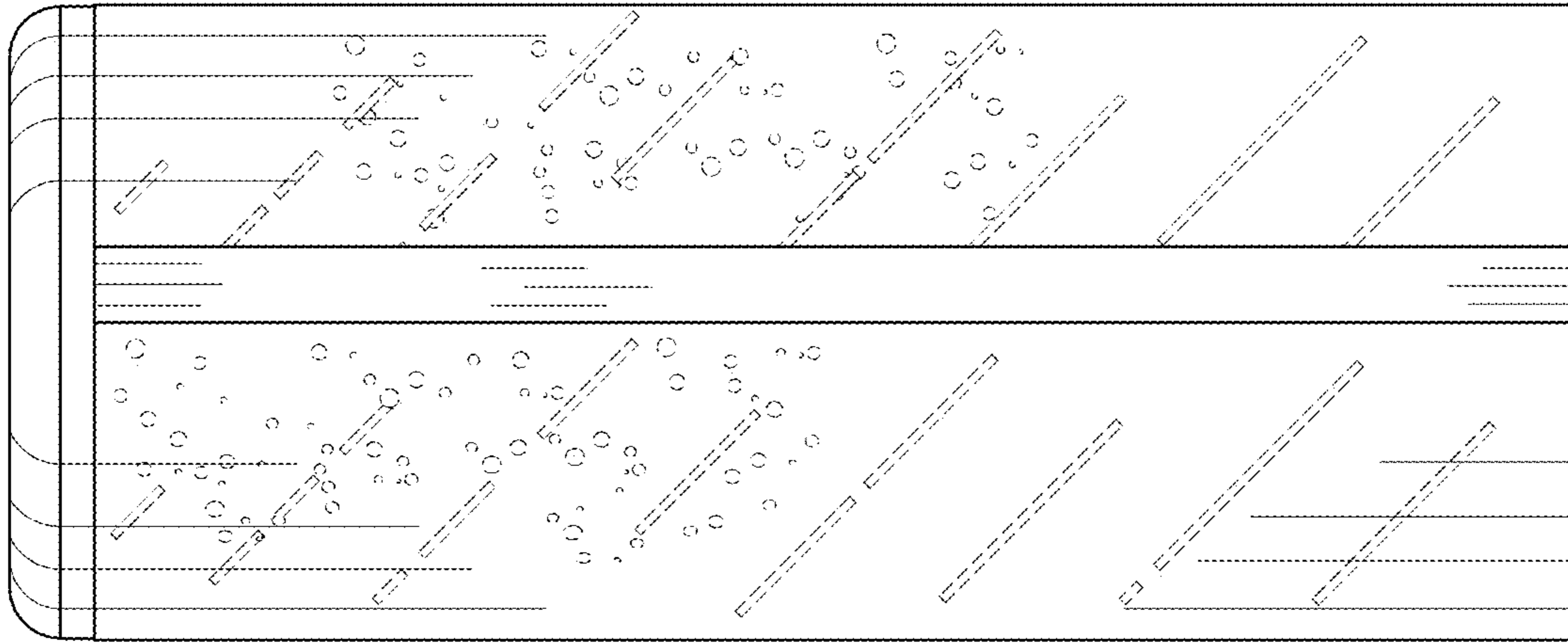

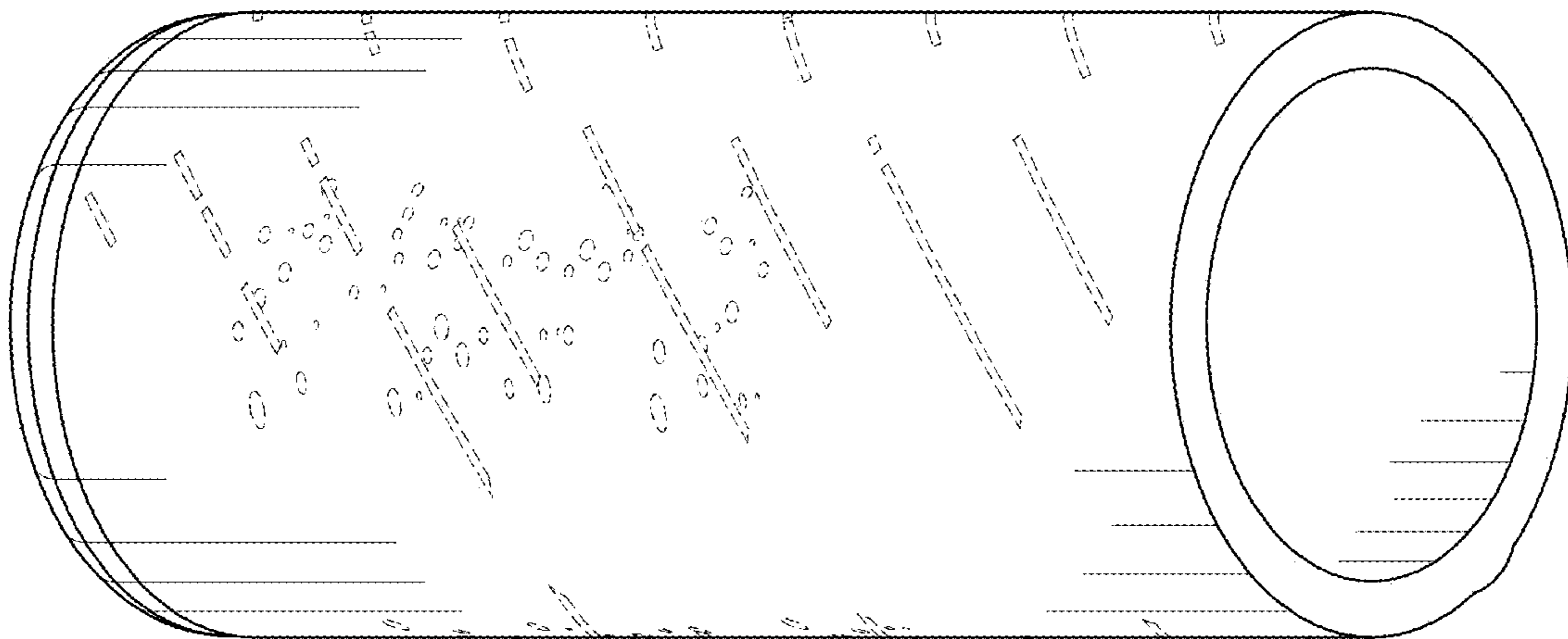

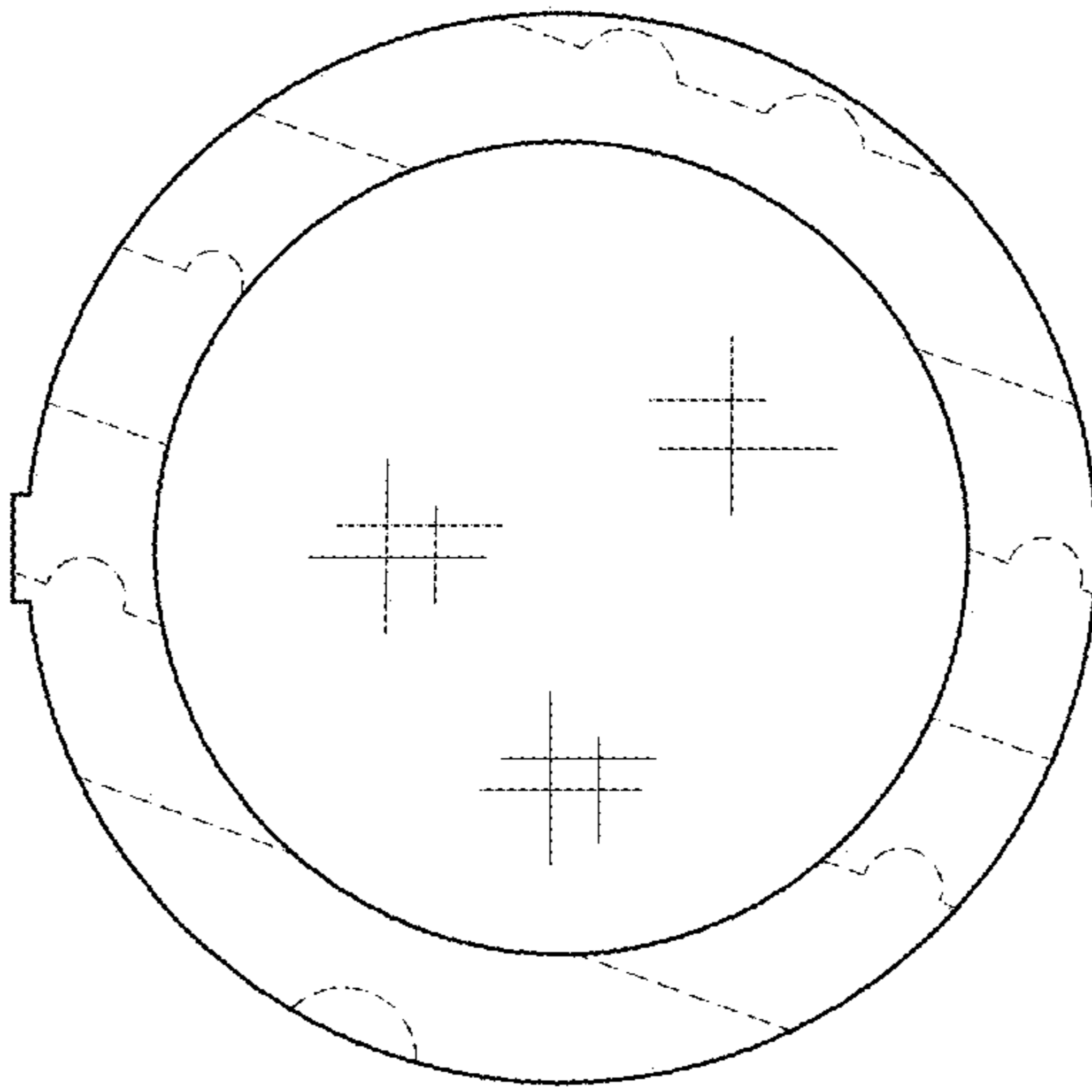

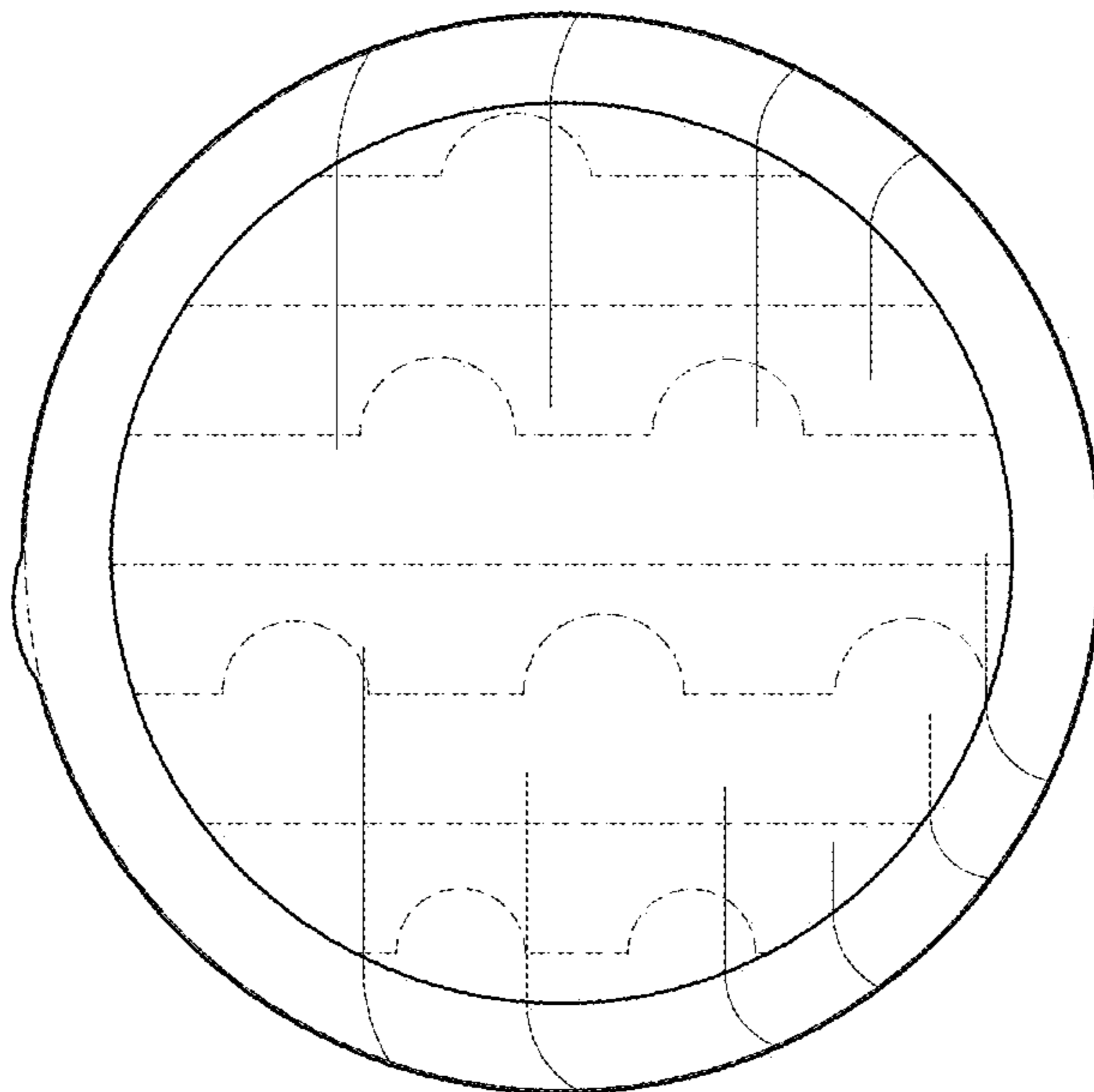
