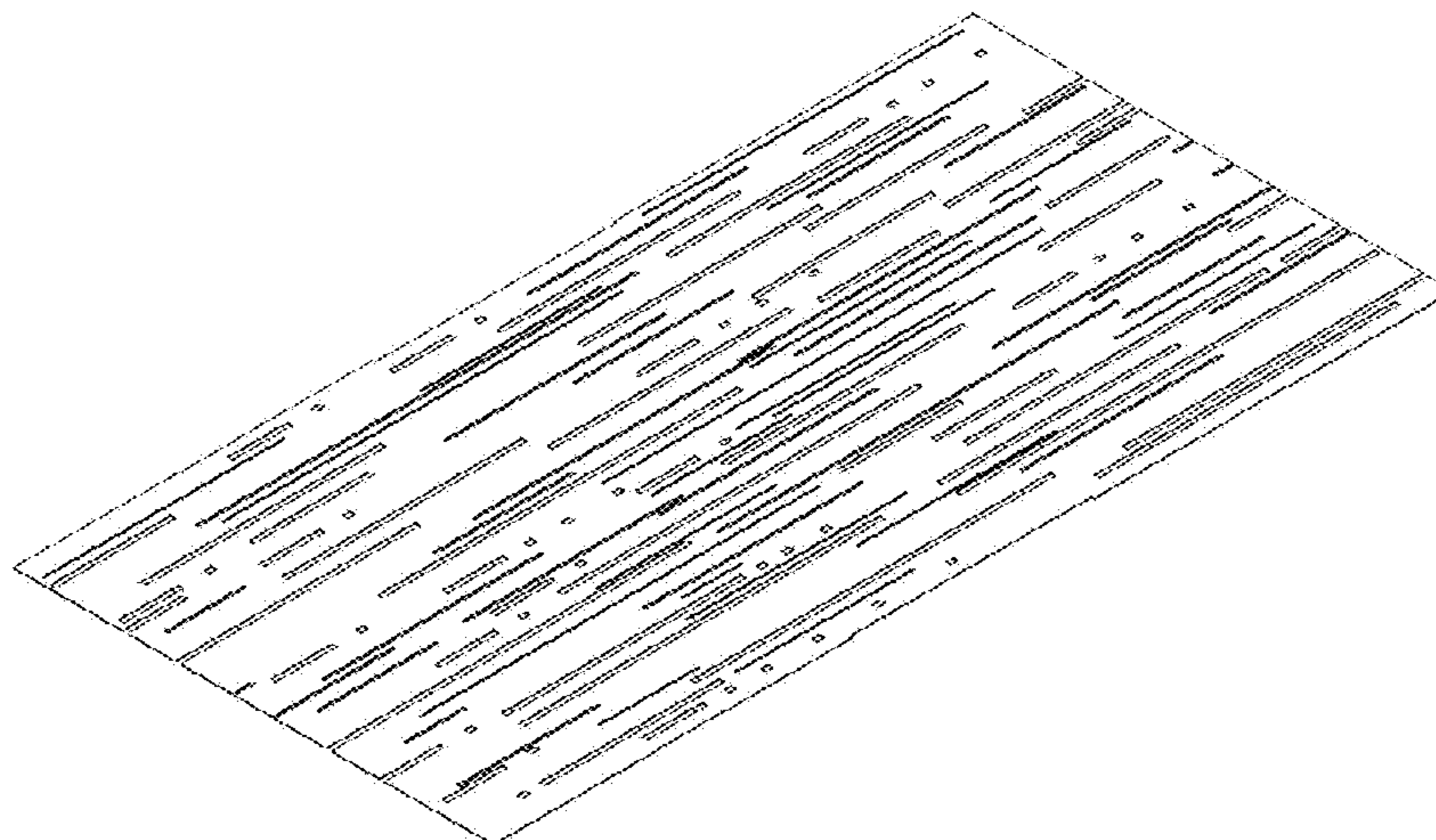


FIG. 42 is a left side elevation view thereof.

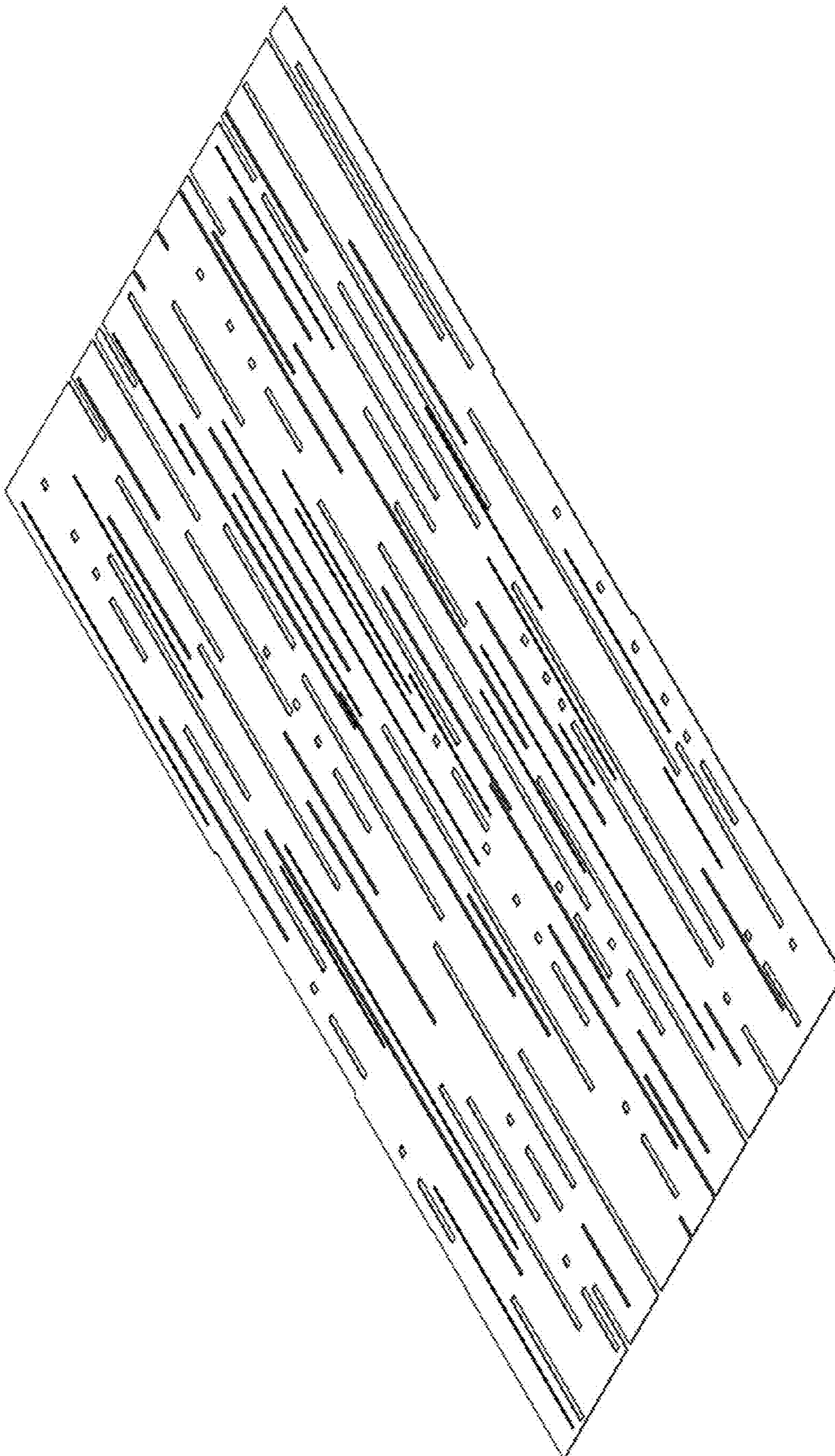

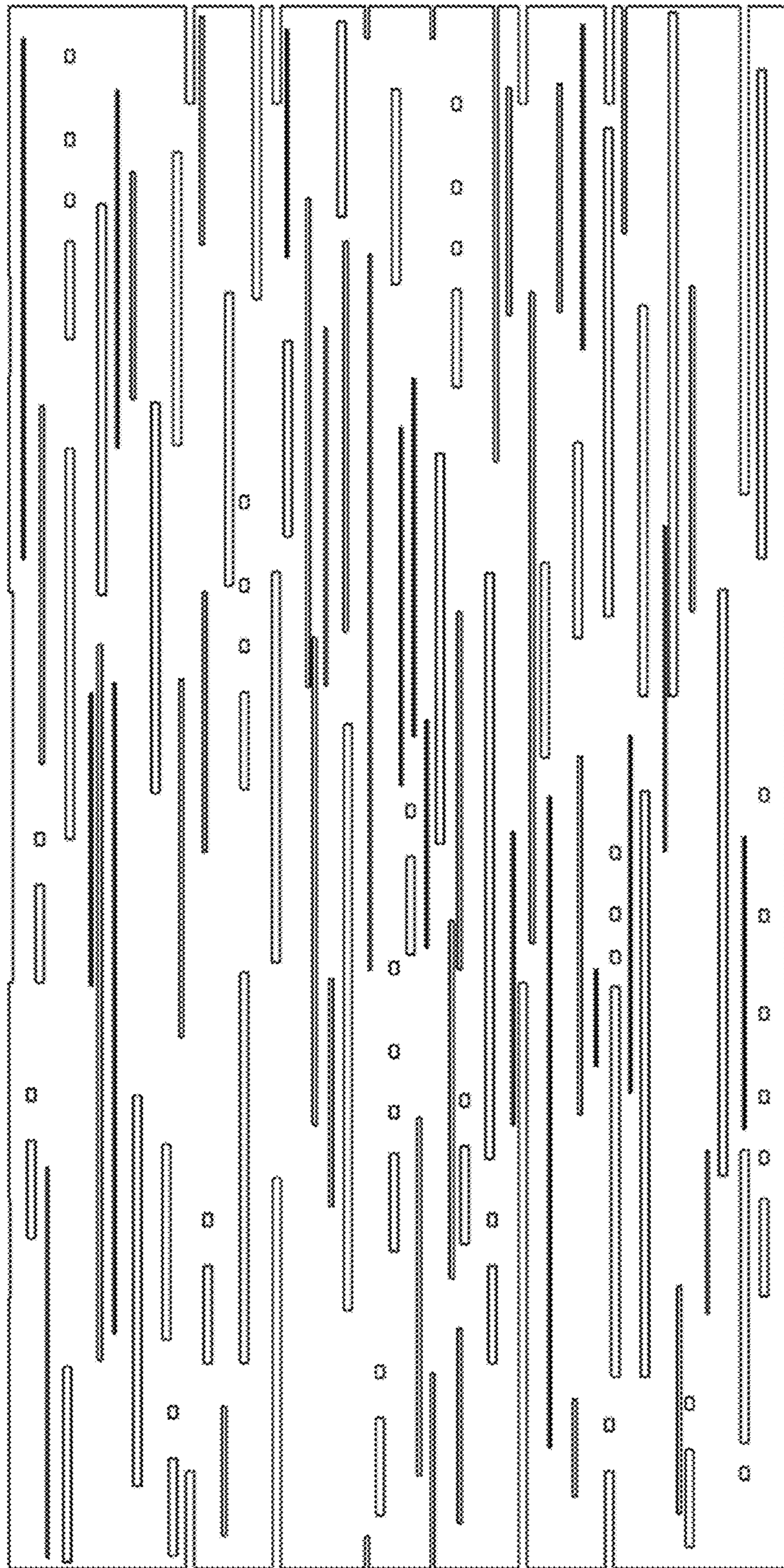

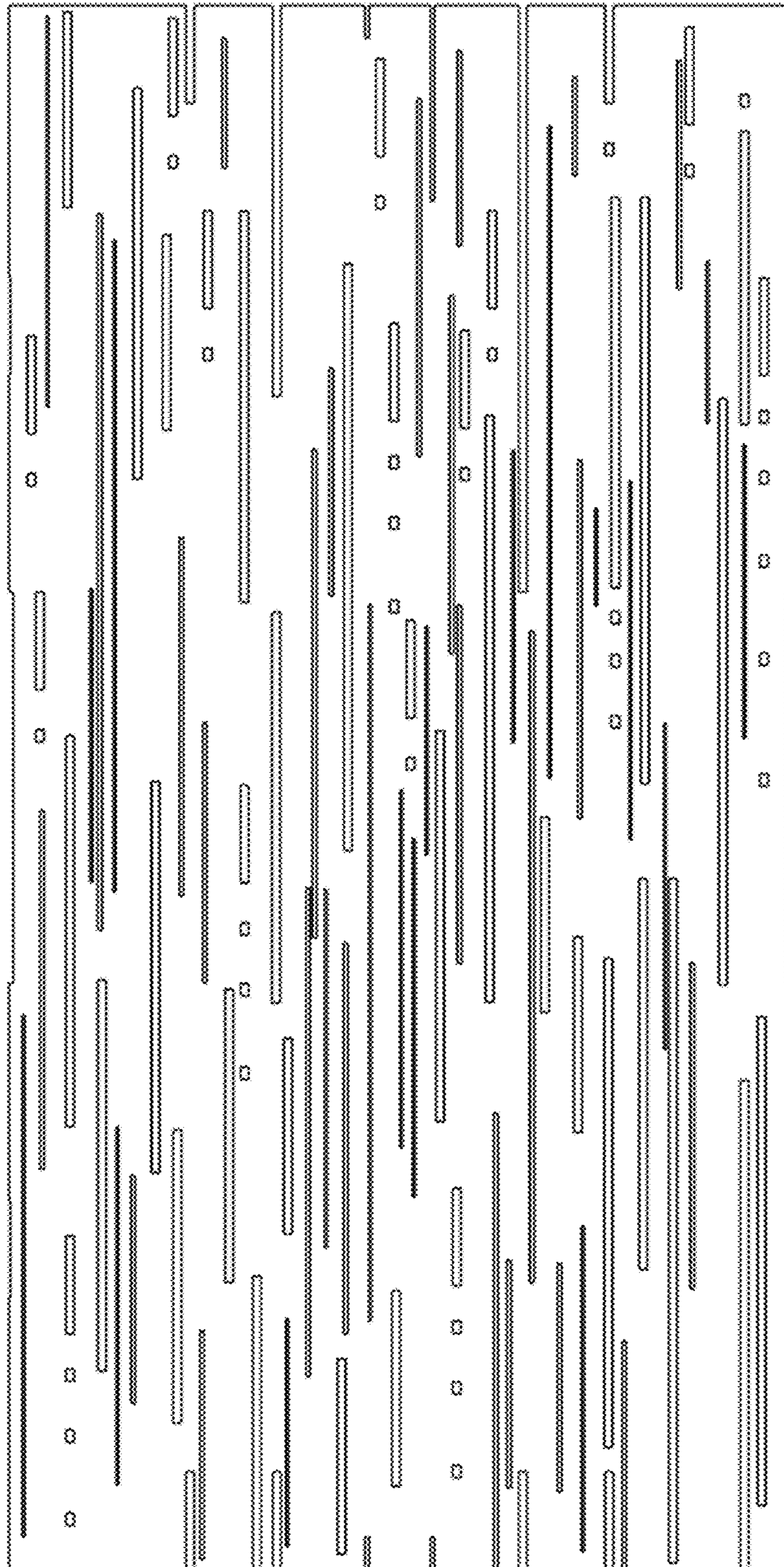

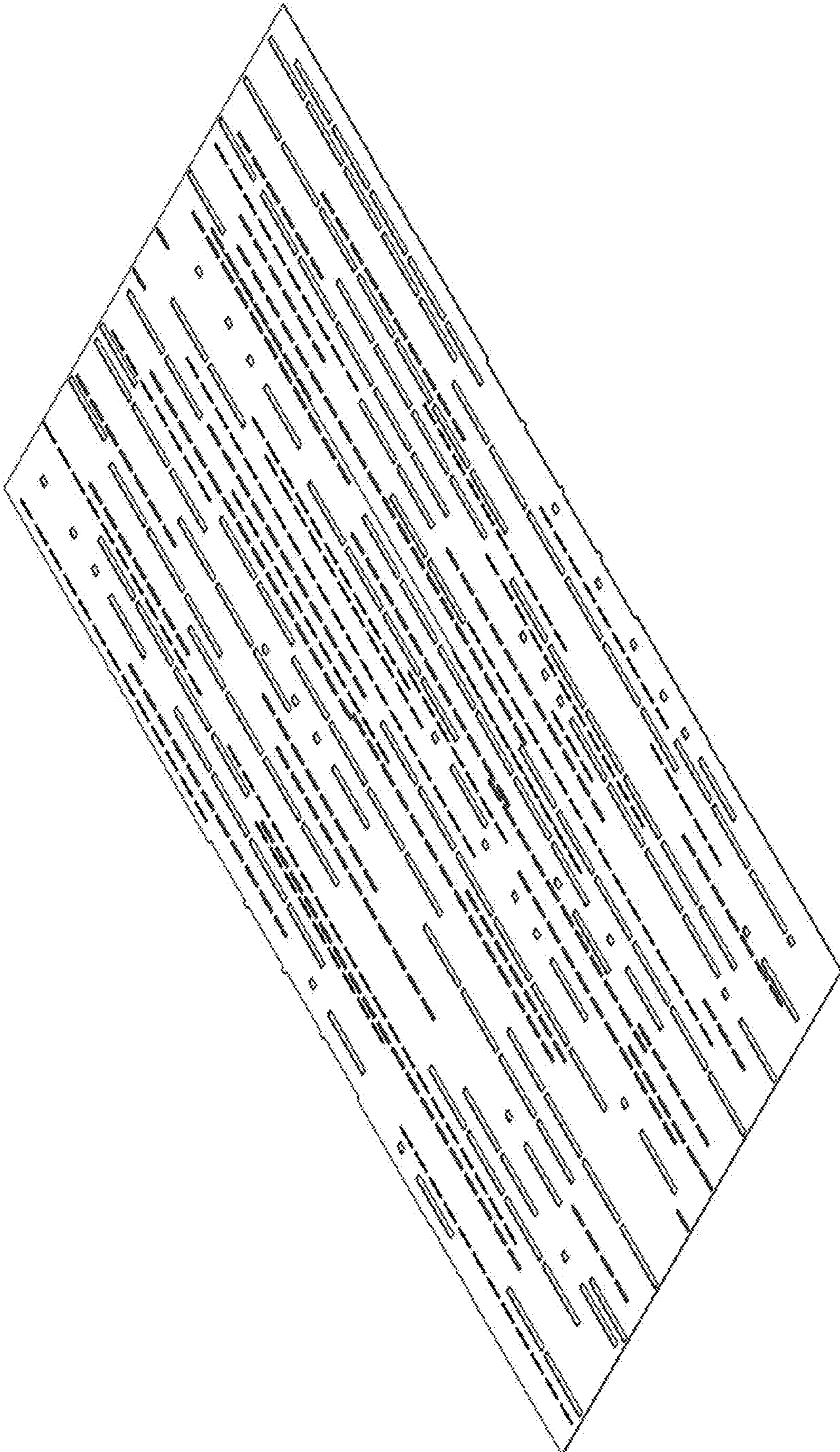

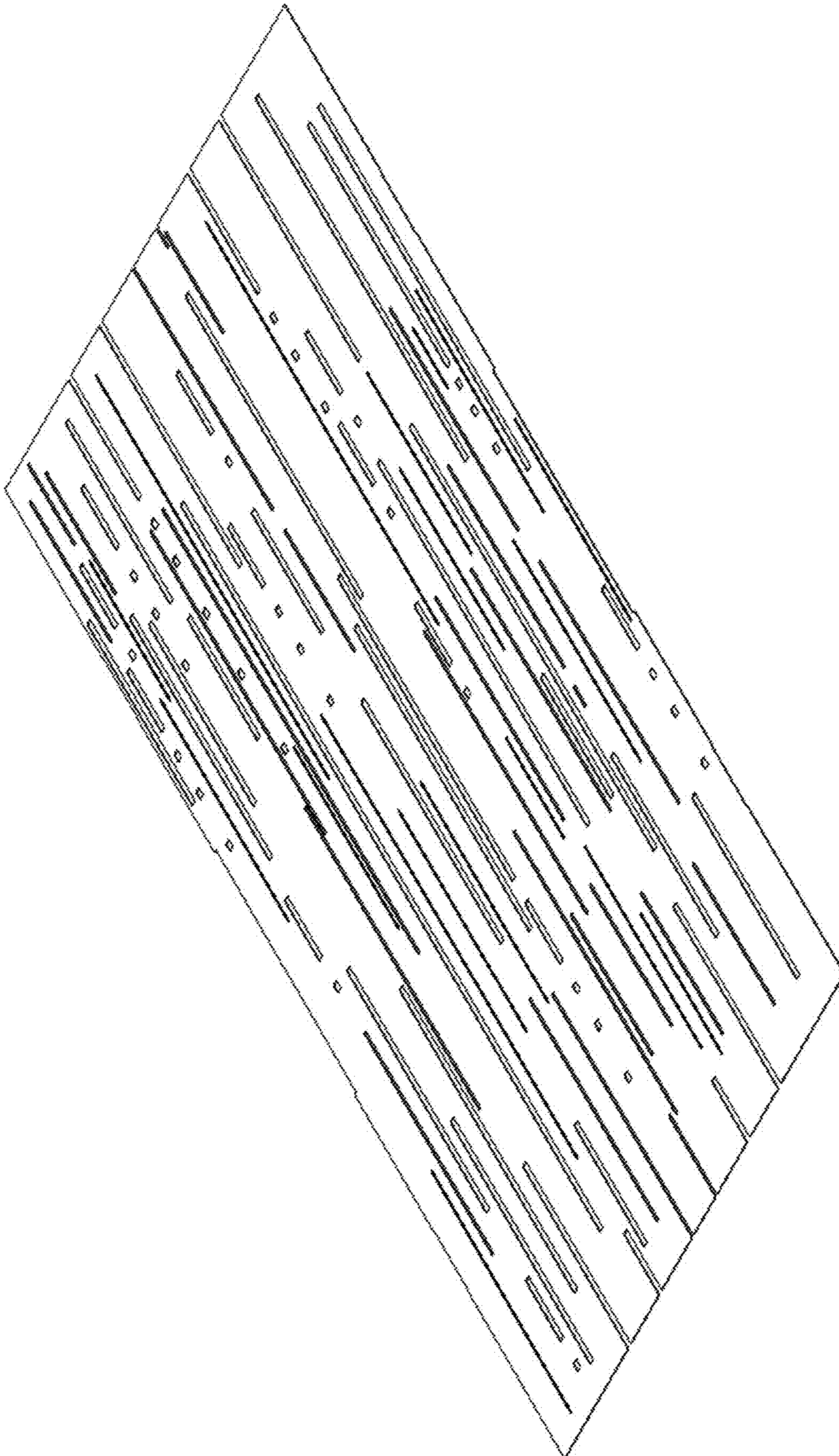

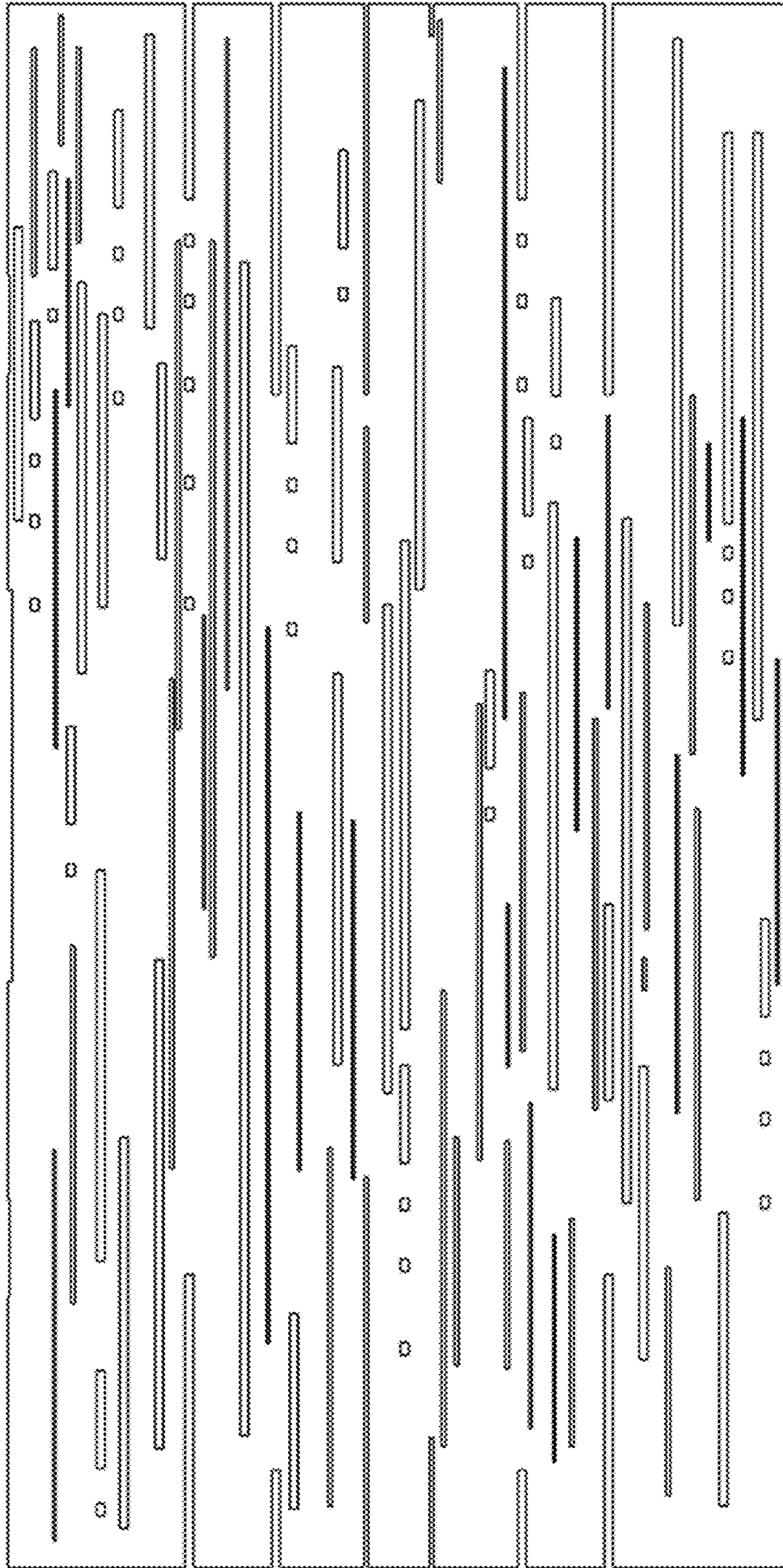

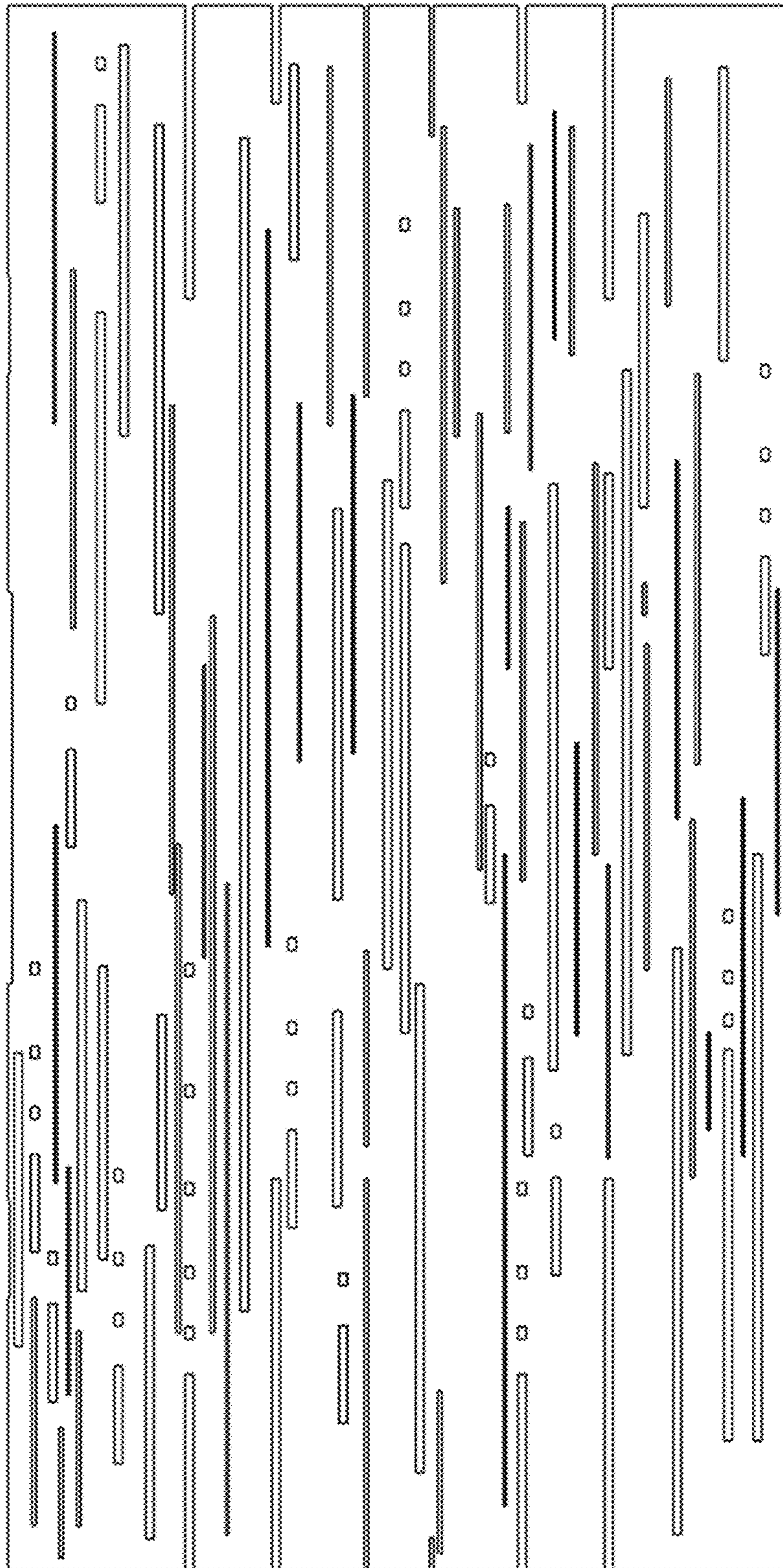

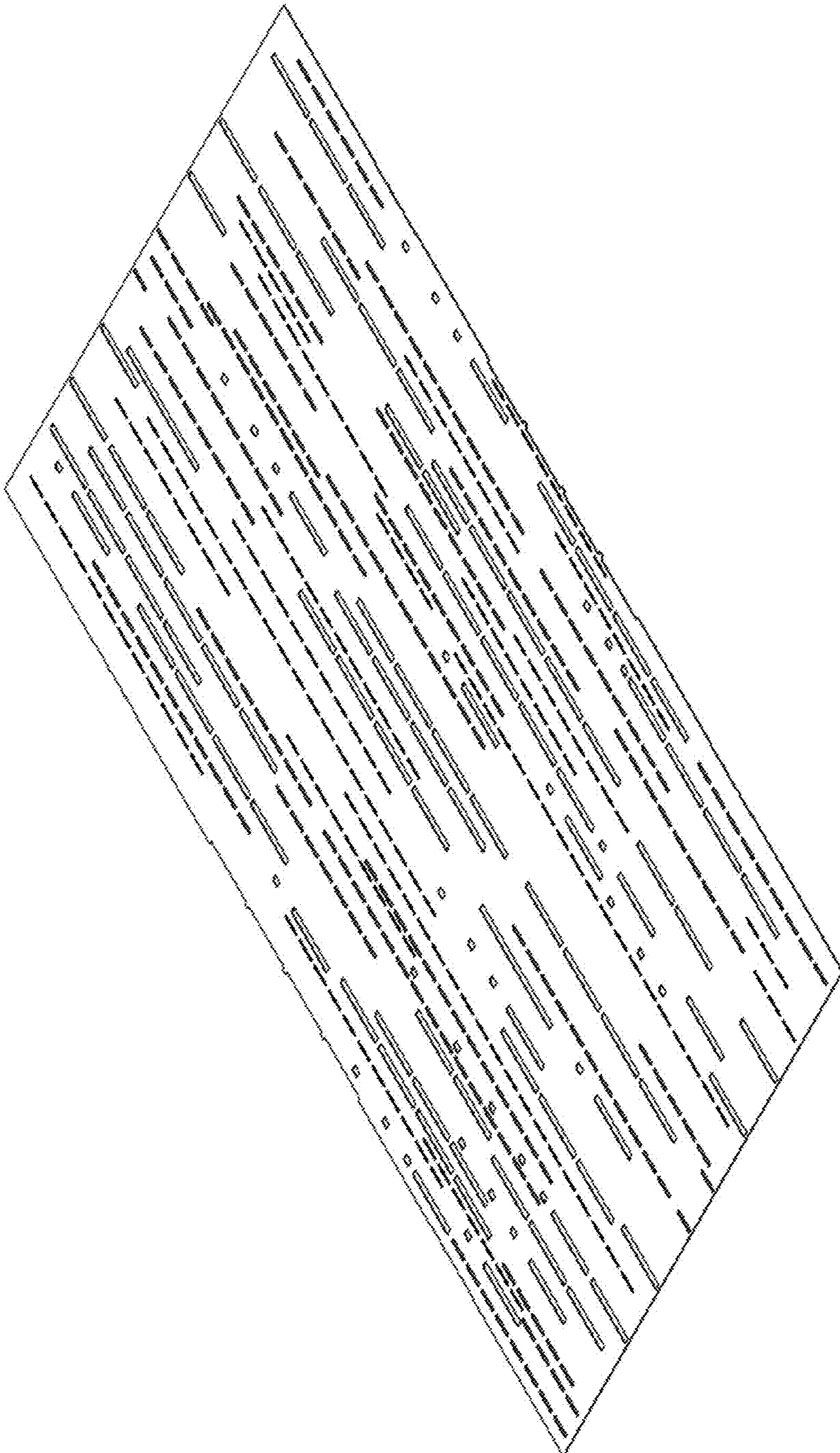

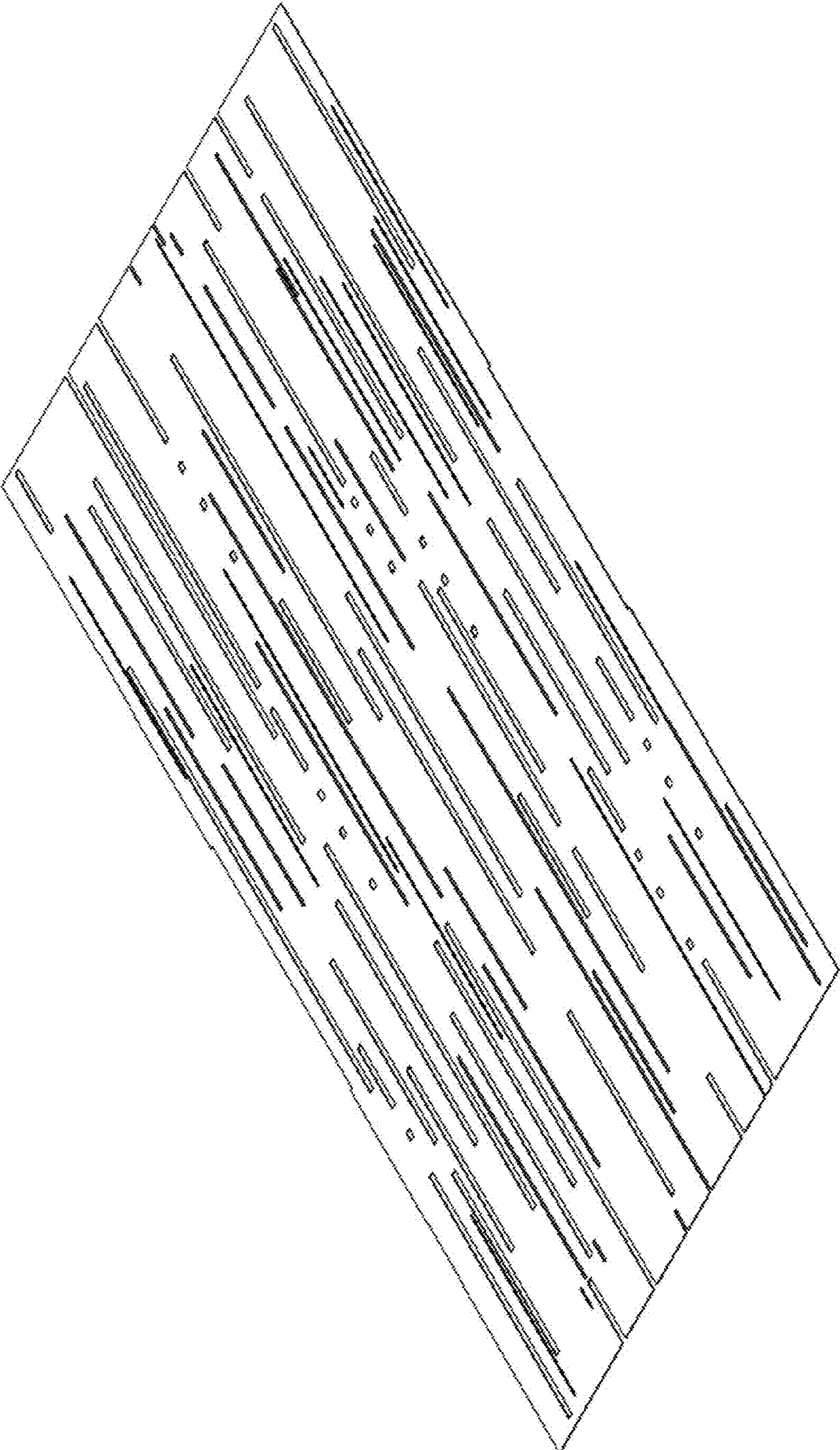

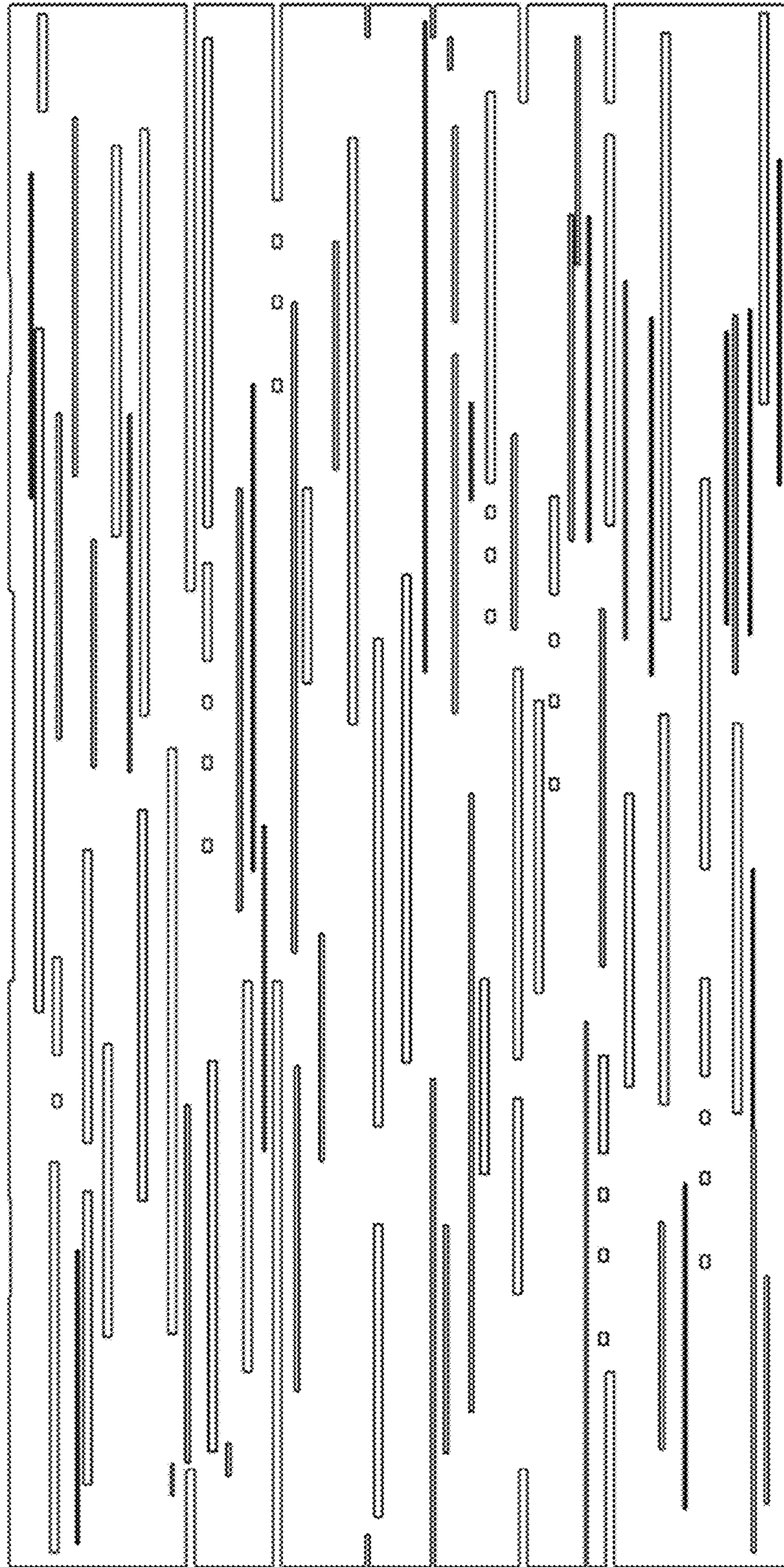

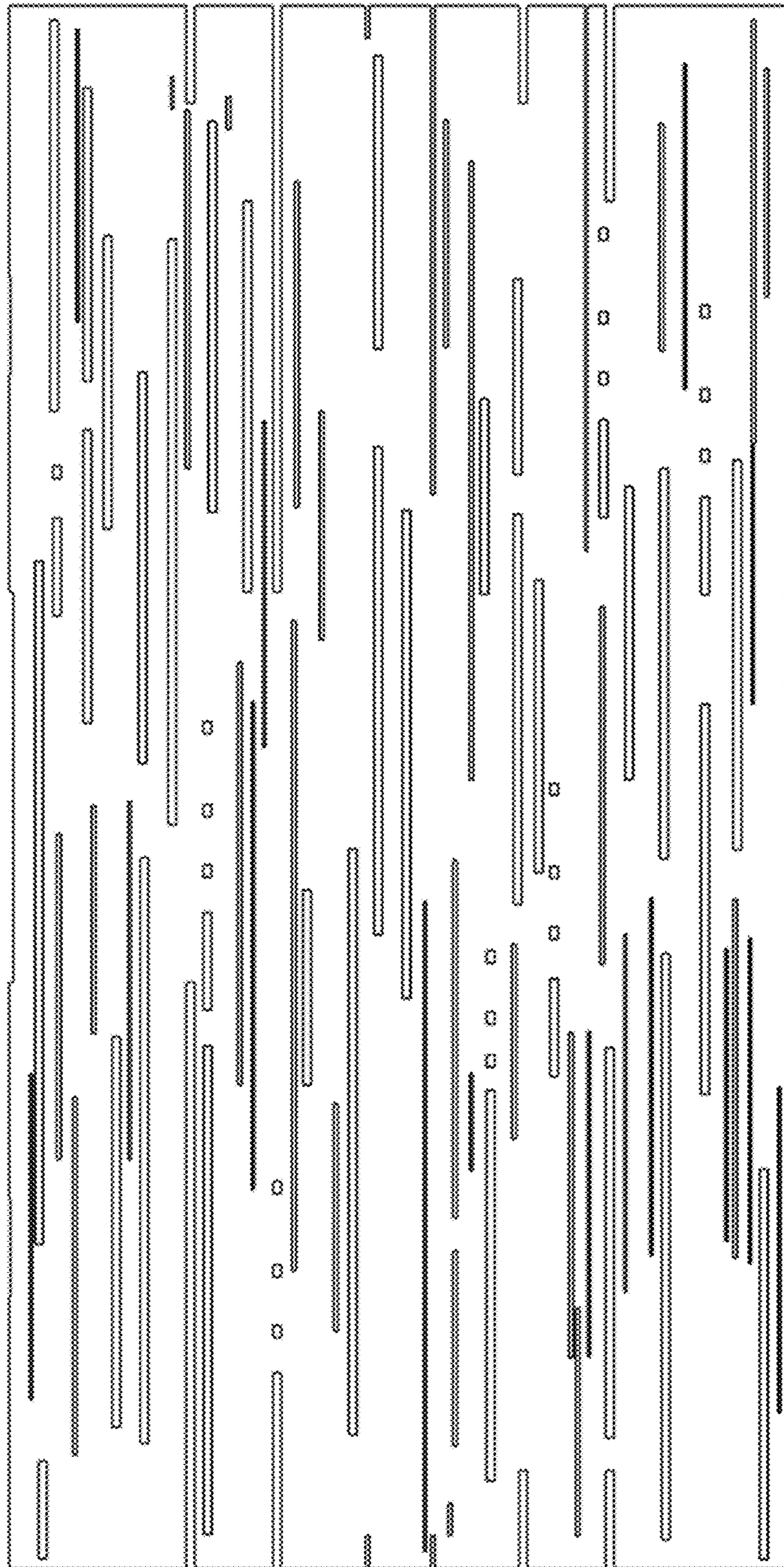

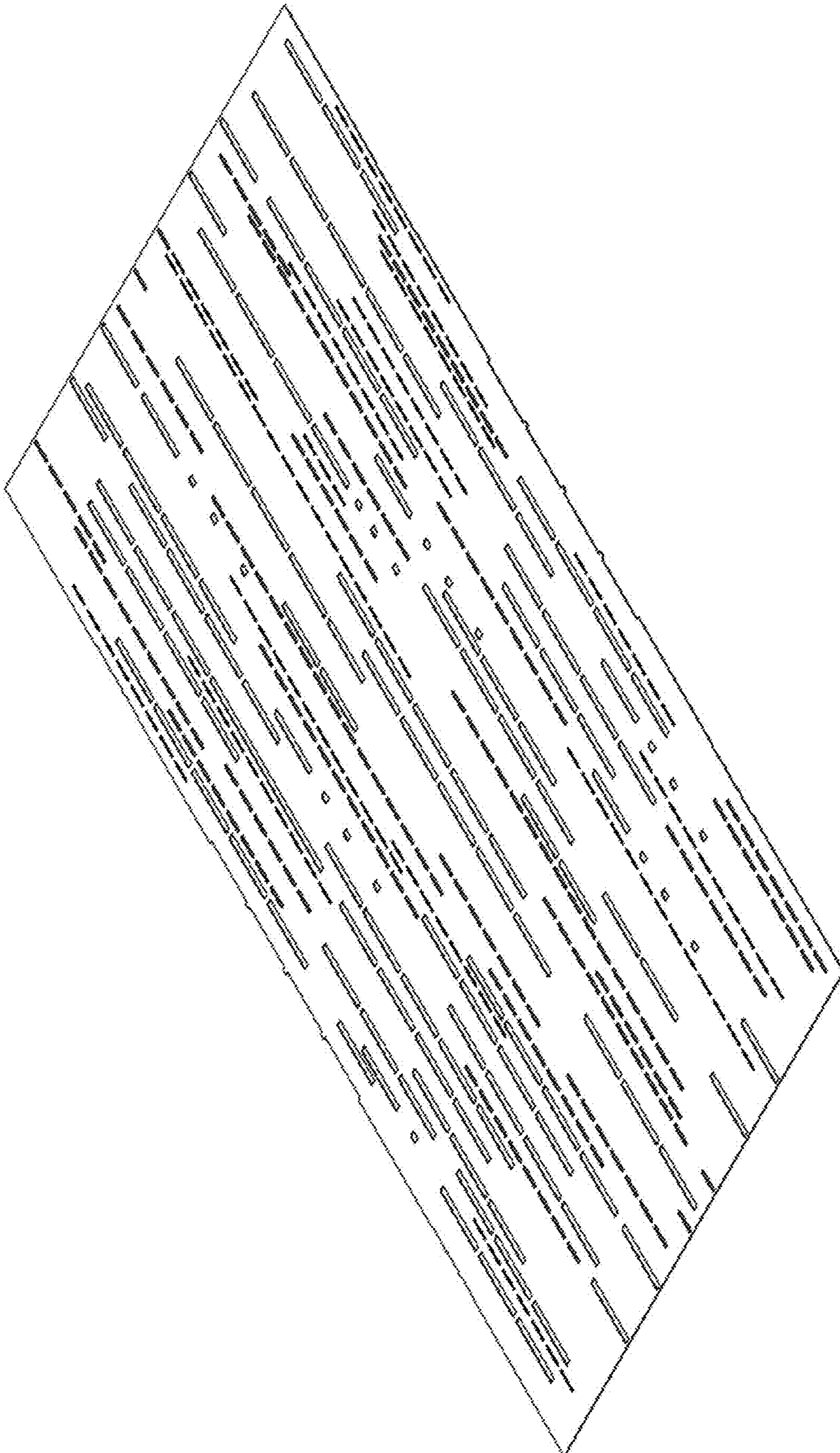

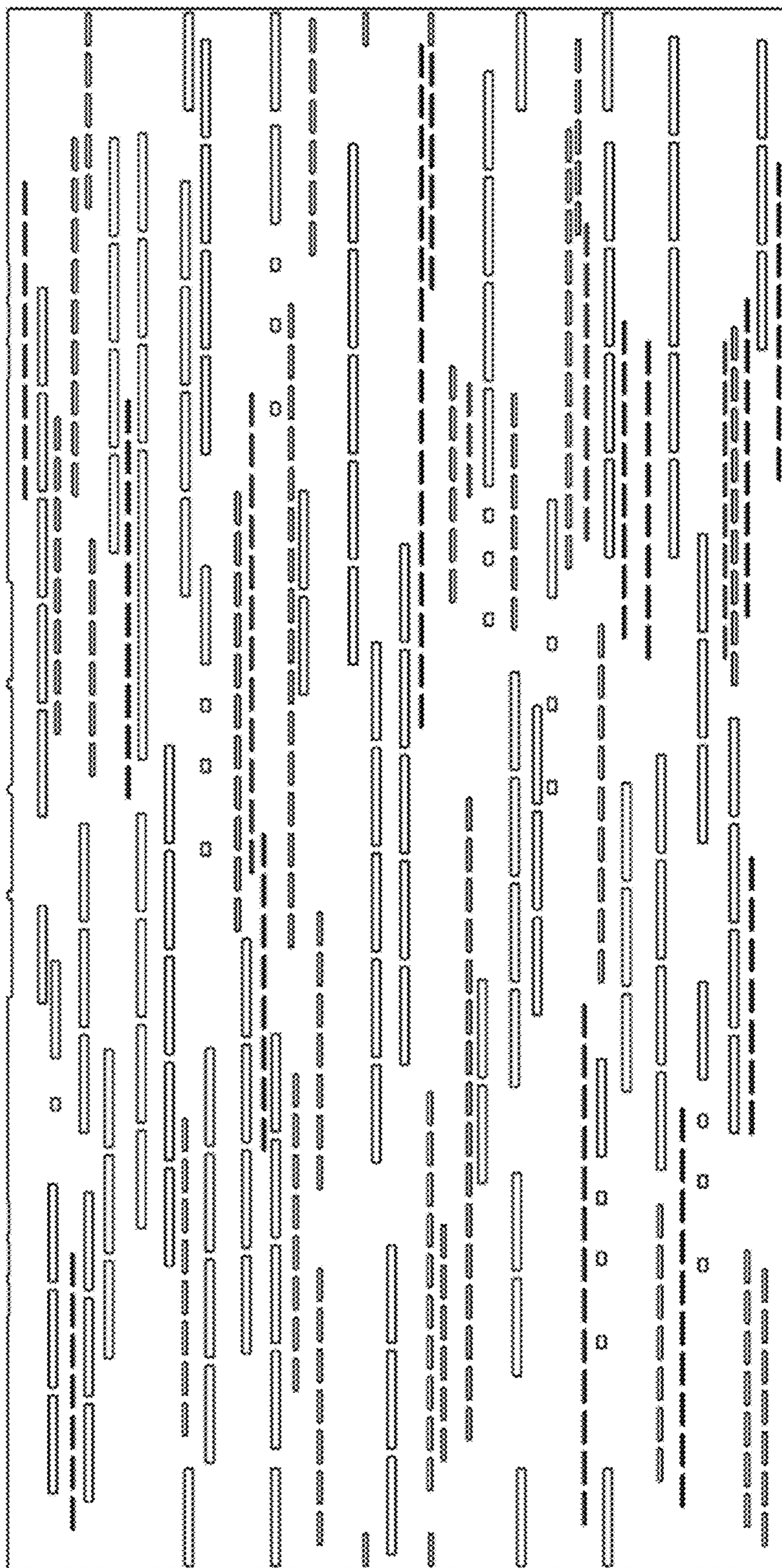

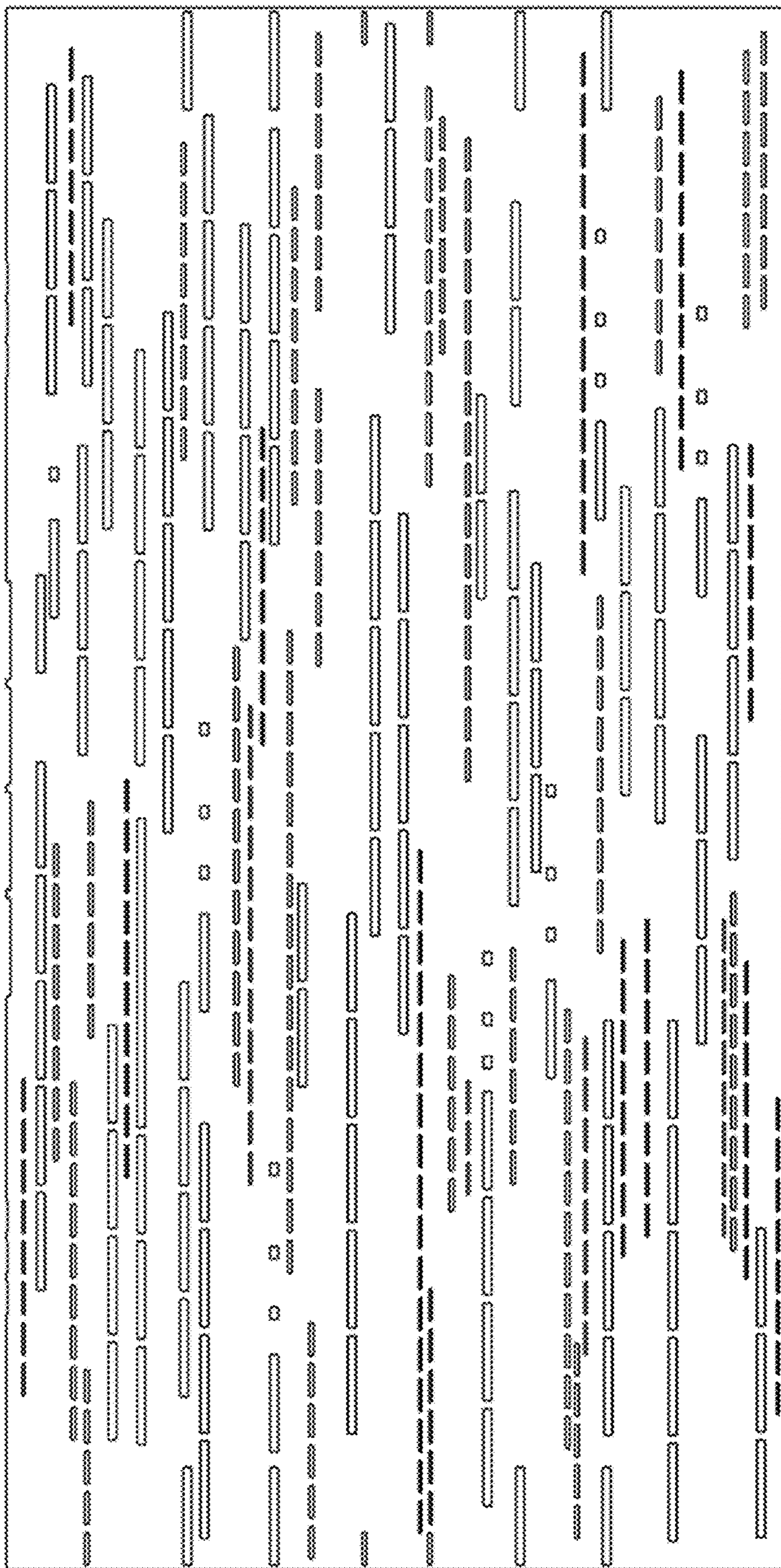

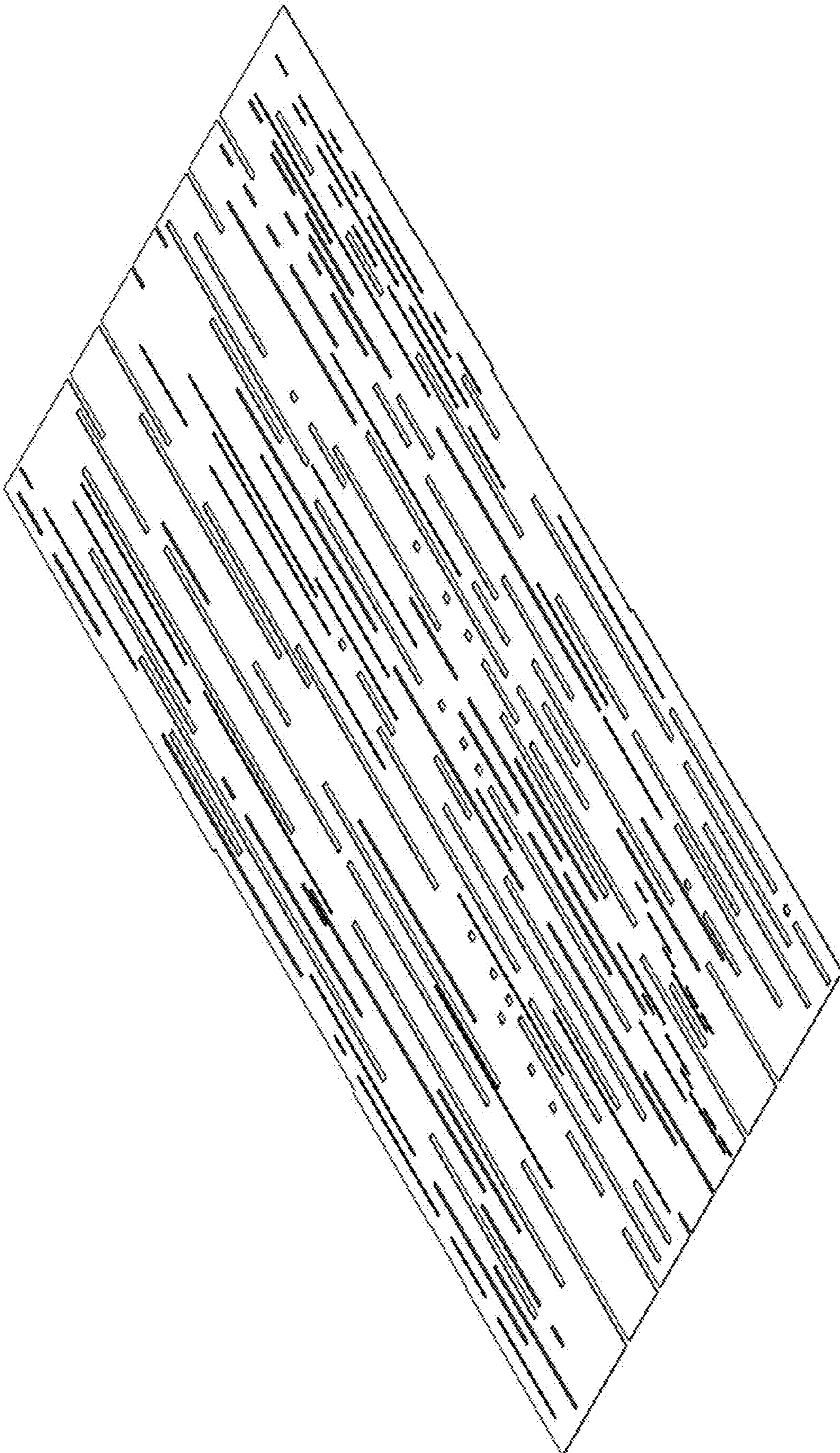

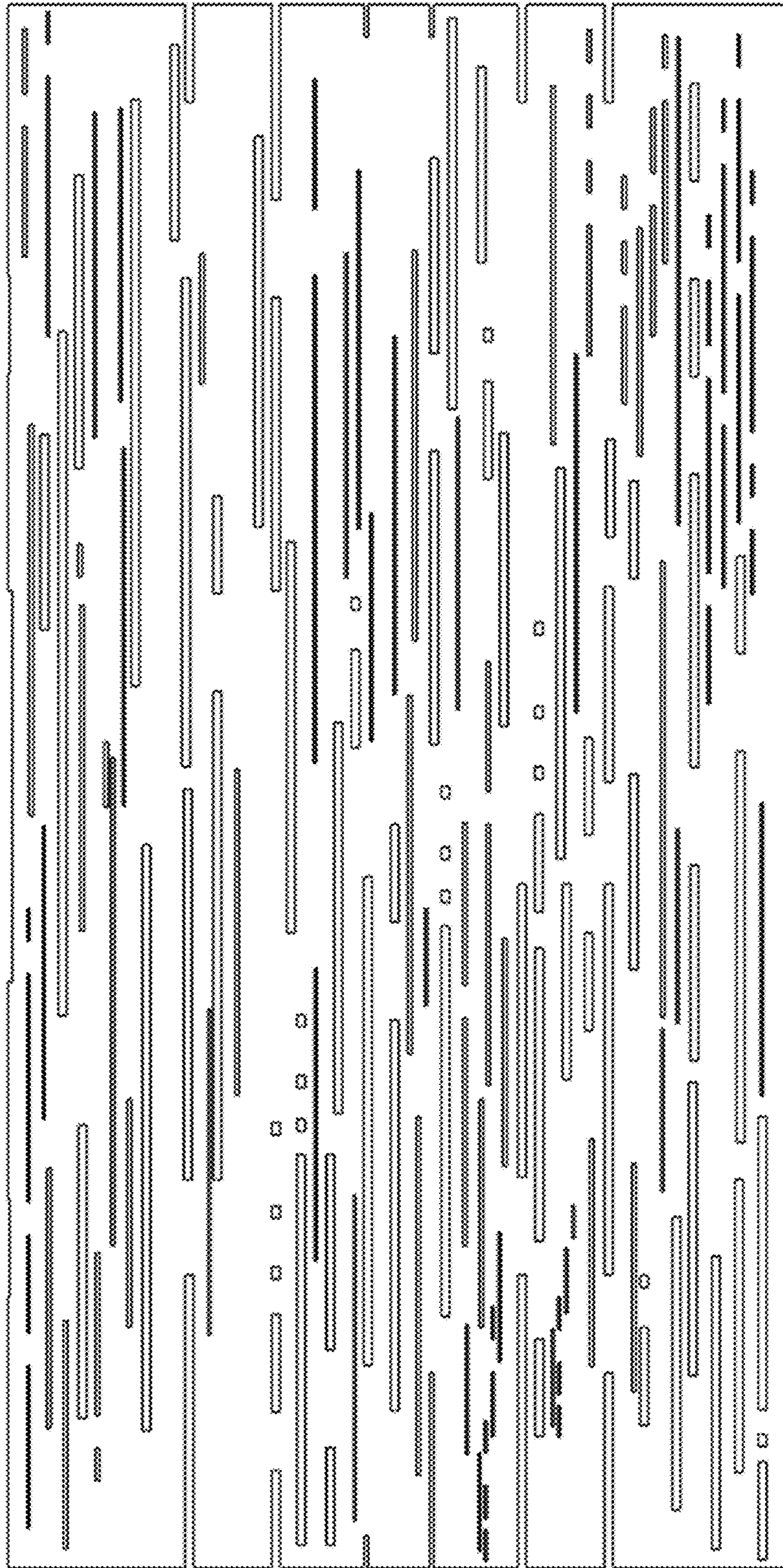

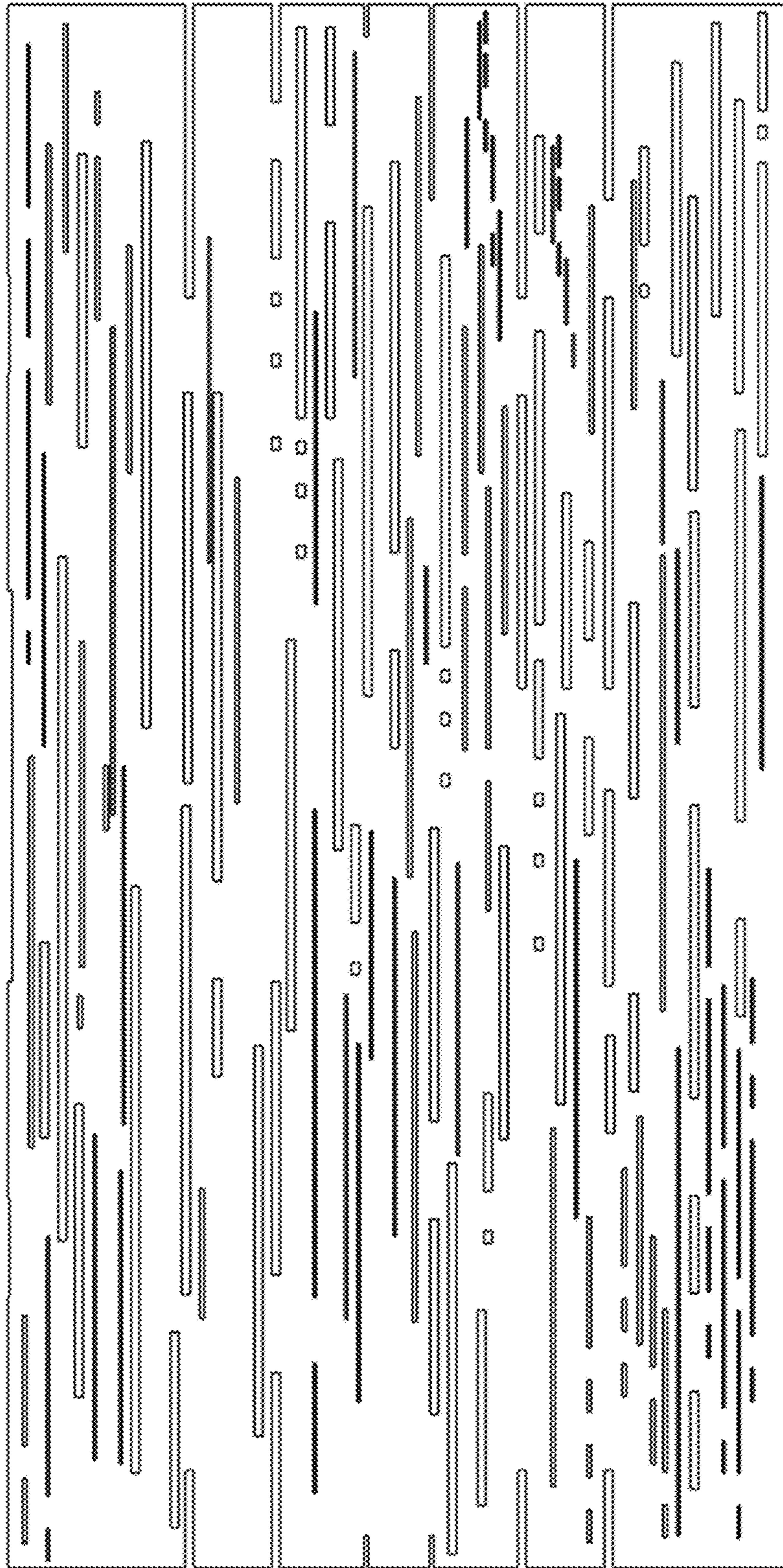

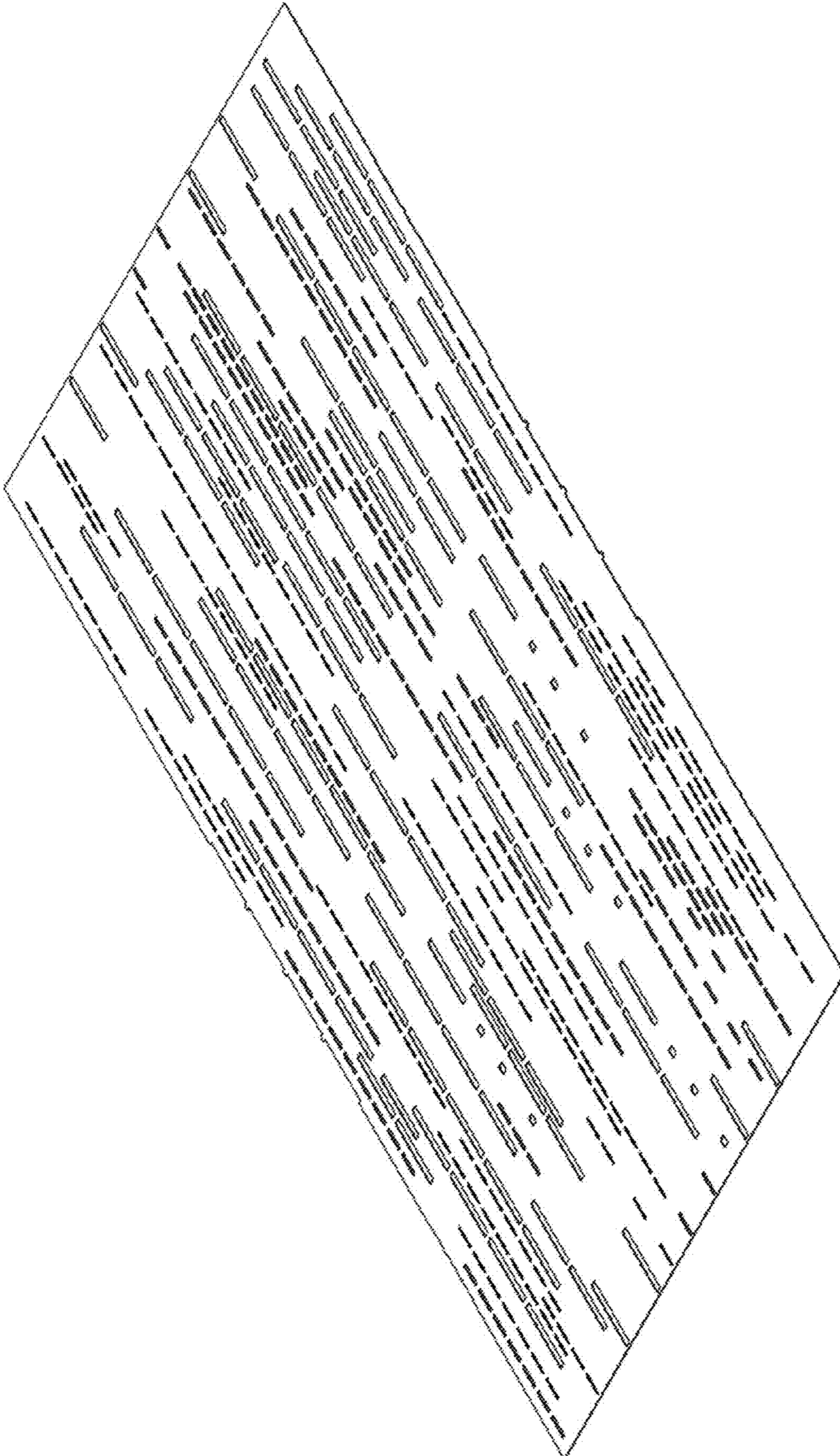

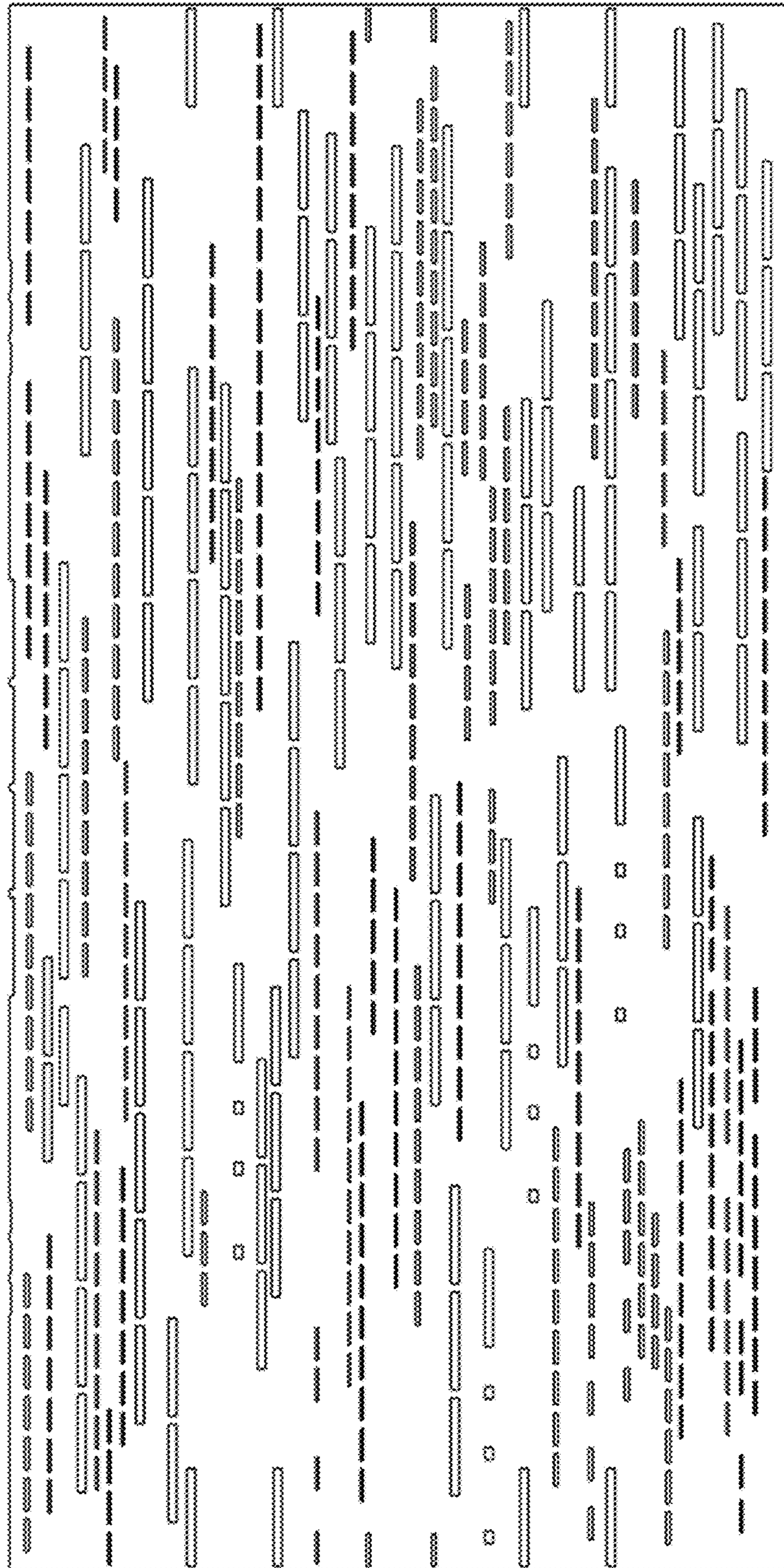

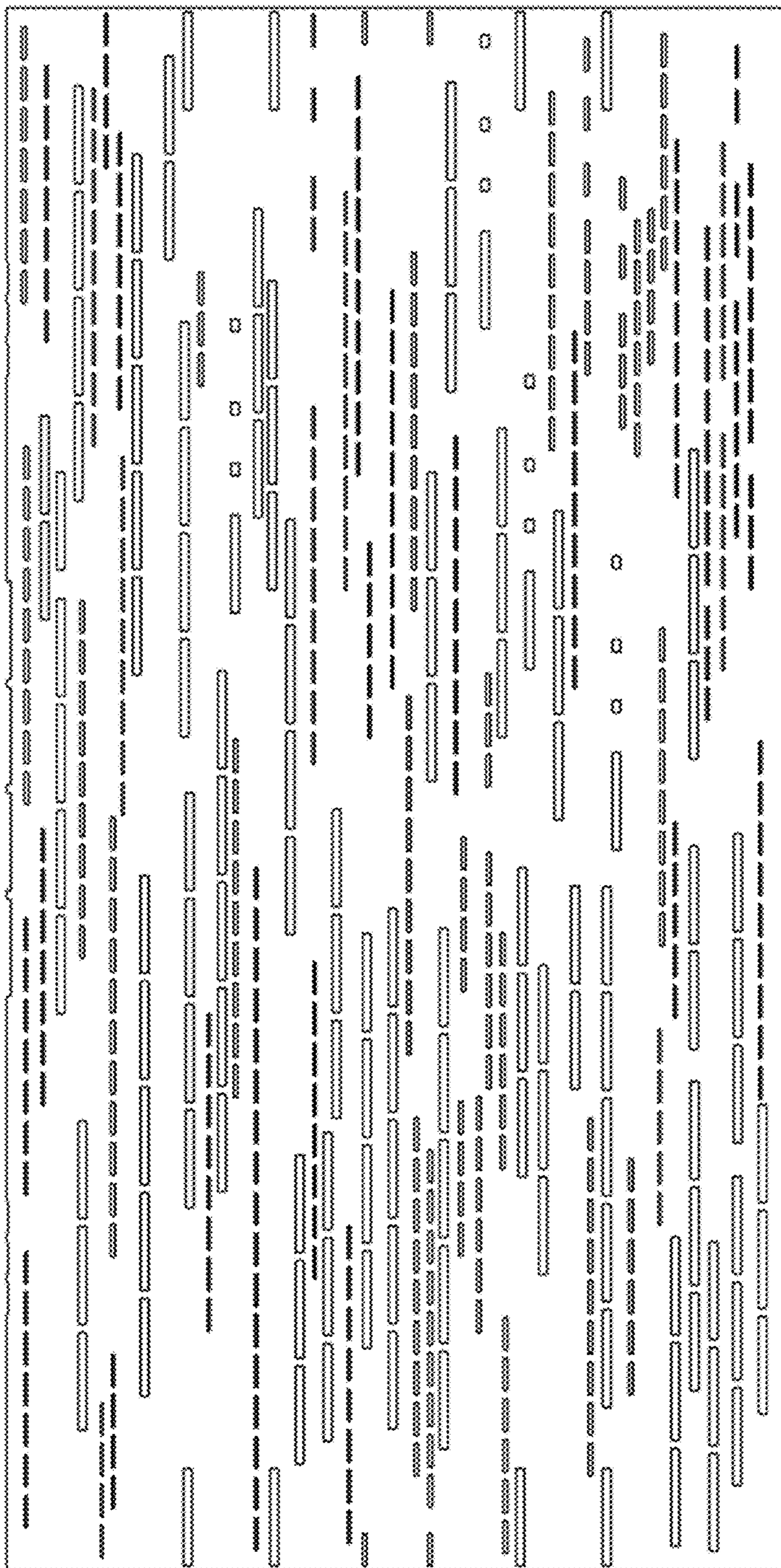

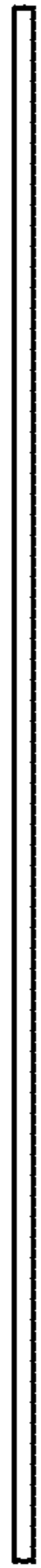
