(57) **CLAIM**

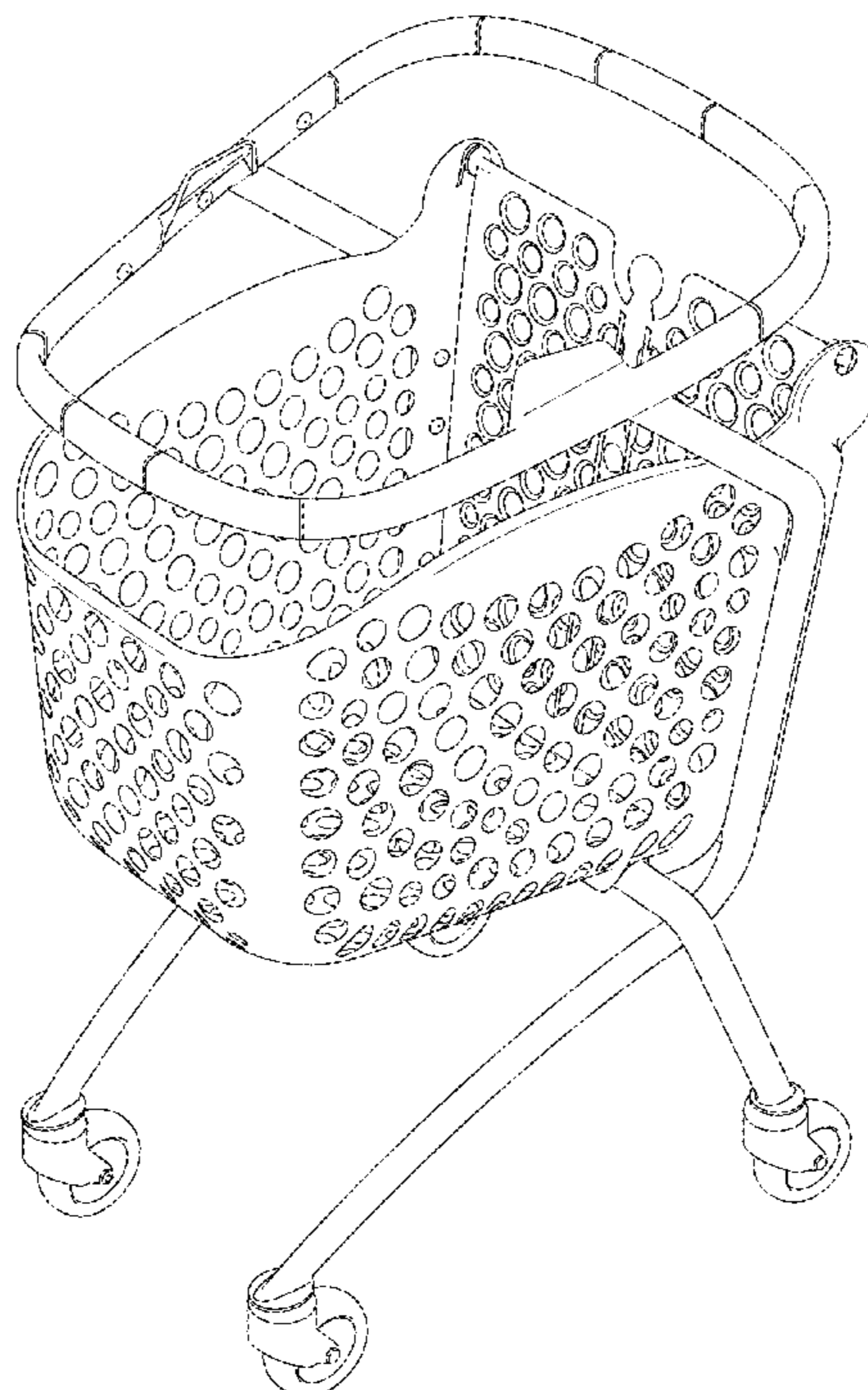
I claim the ornamental design for a shopping trolley with basket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shopping trolley with basket showing the new design;
FIG. 2 is a rear perspective view thereof;

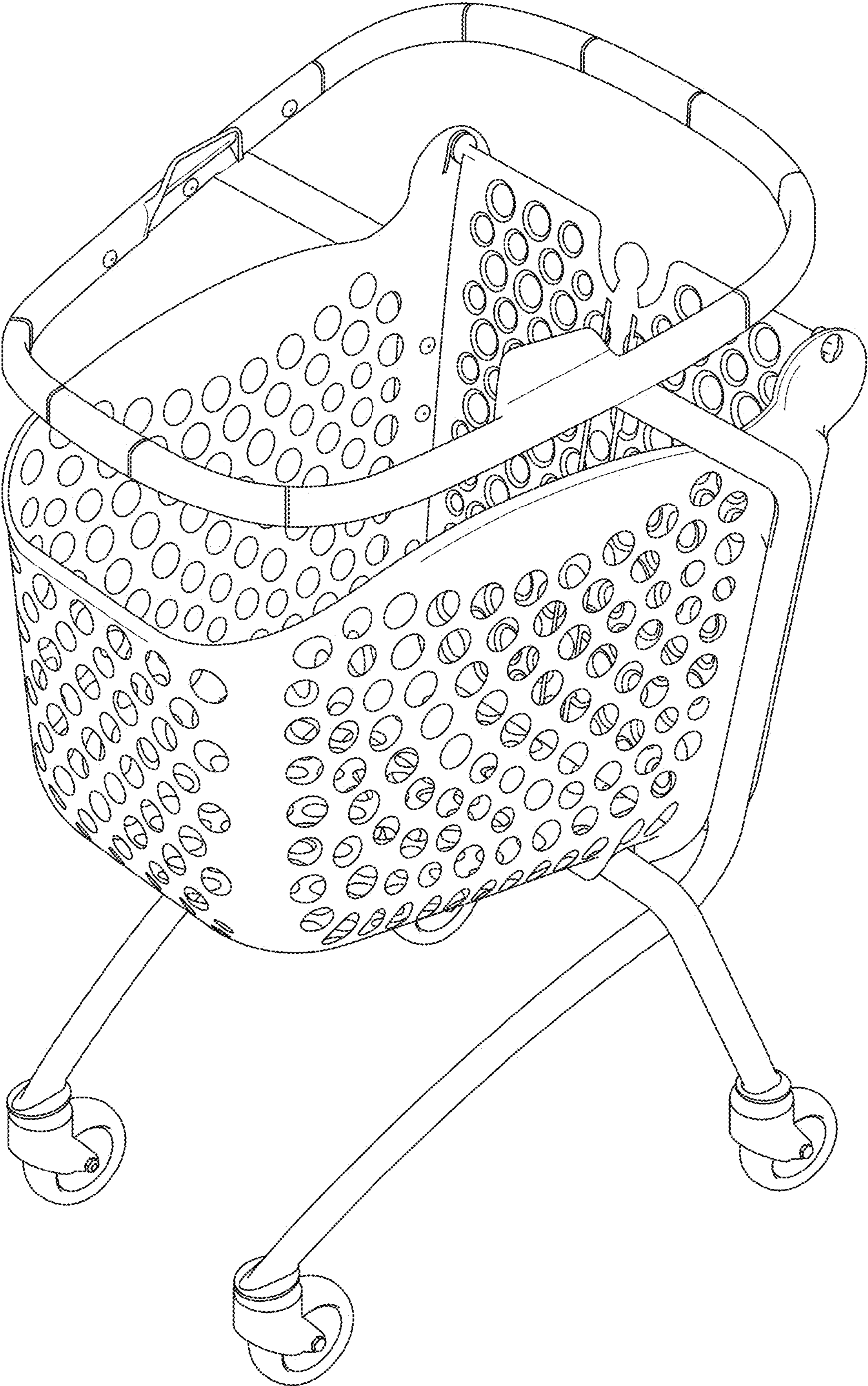

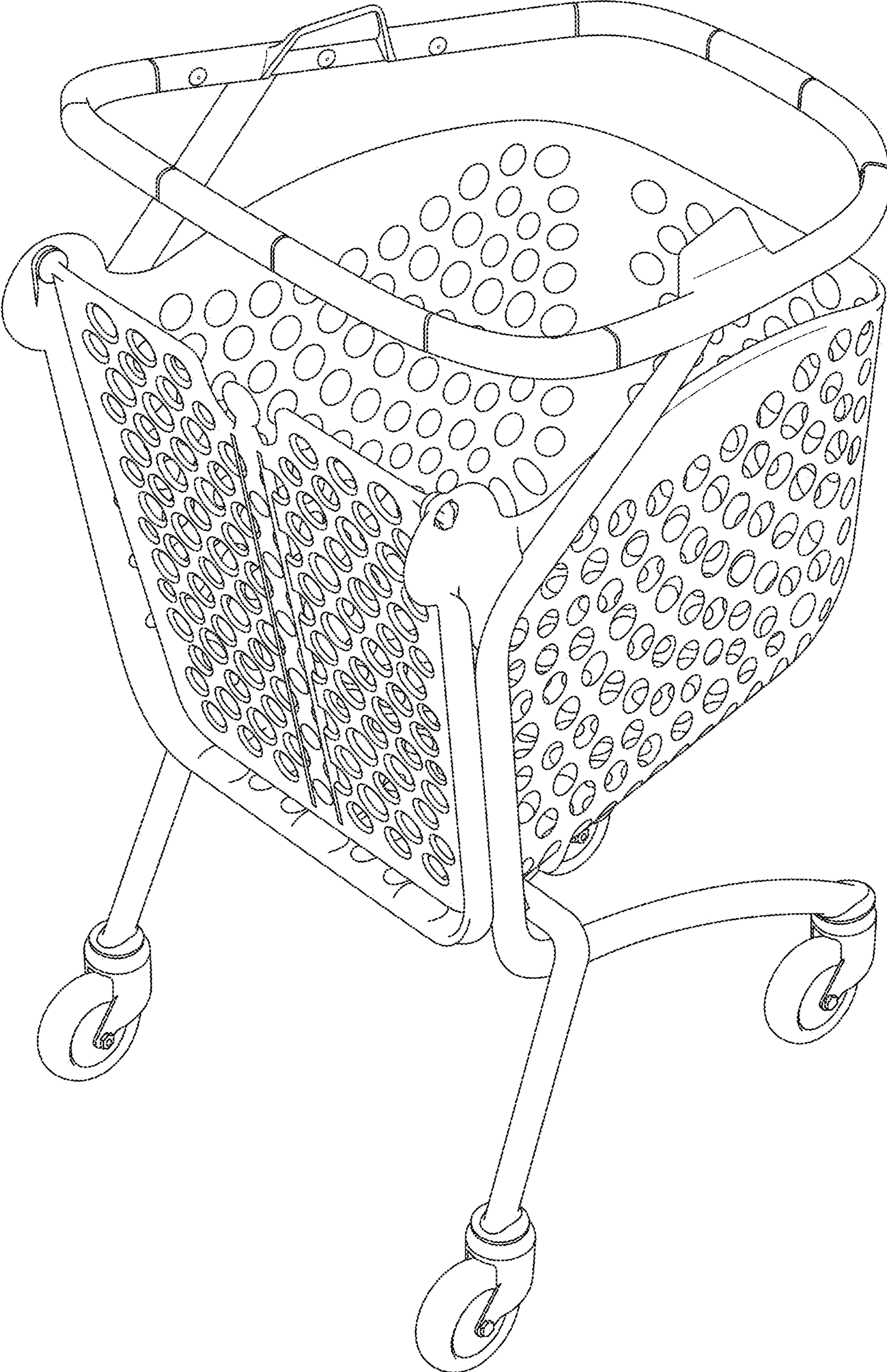

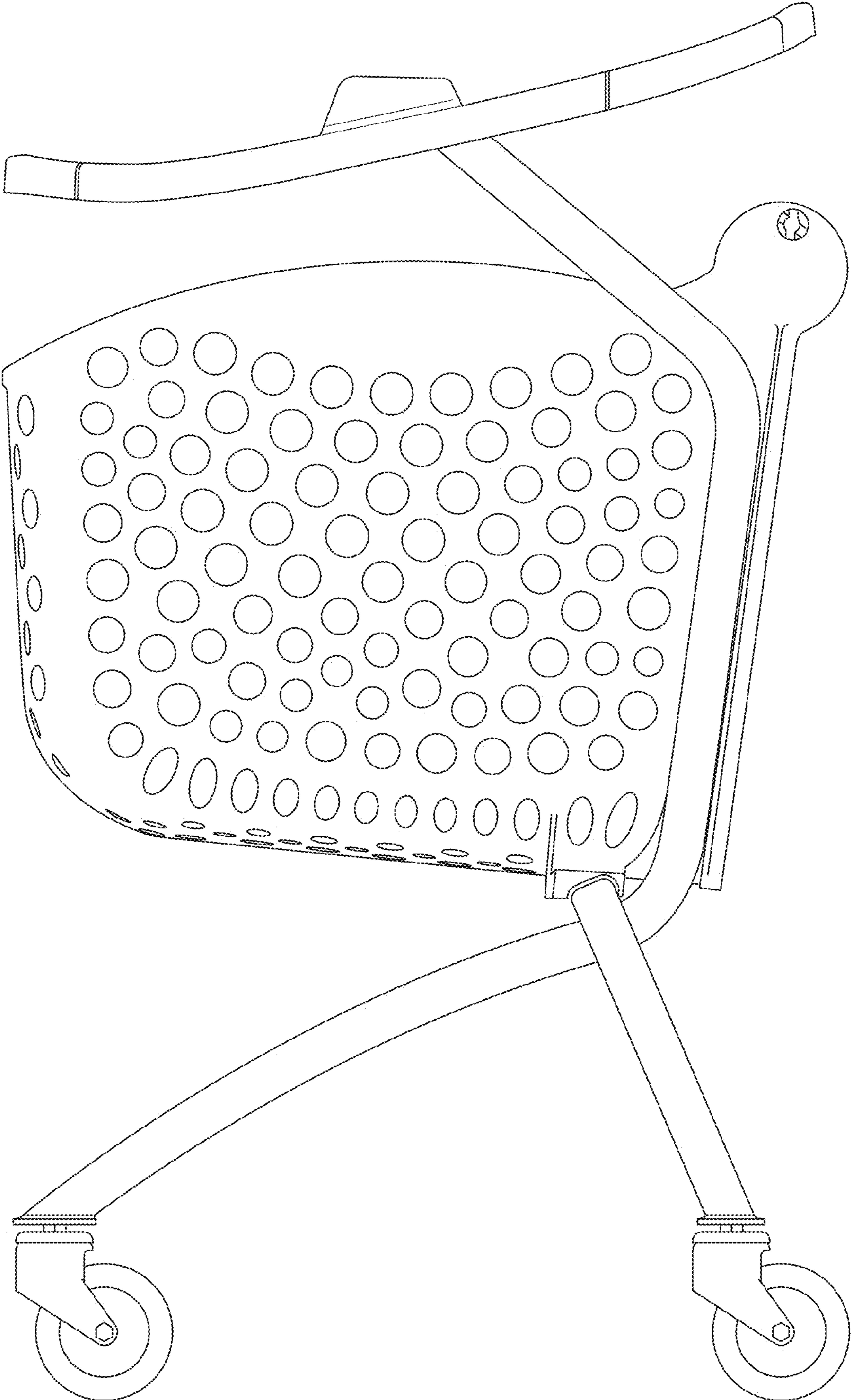

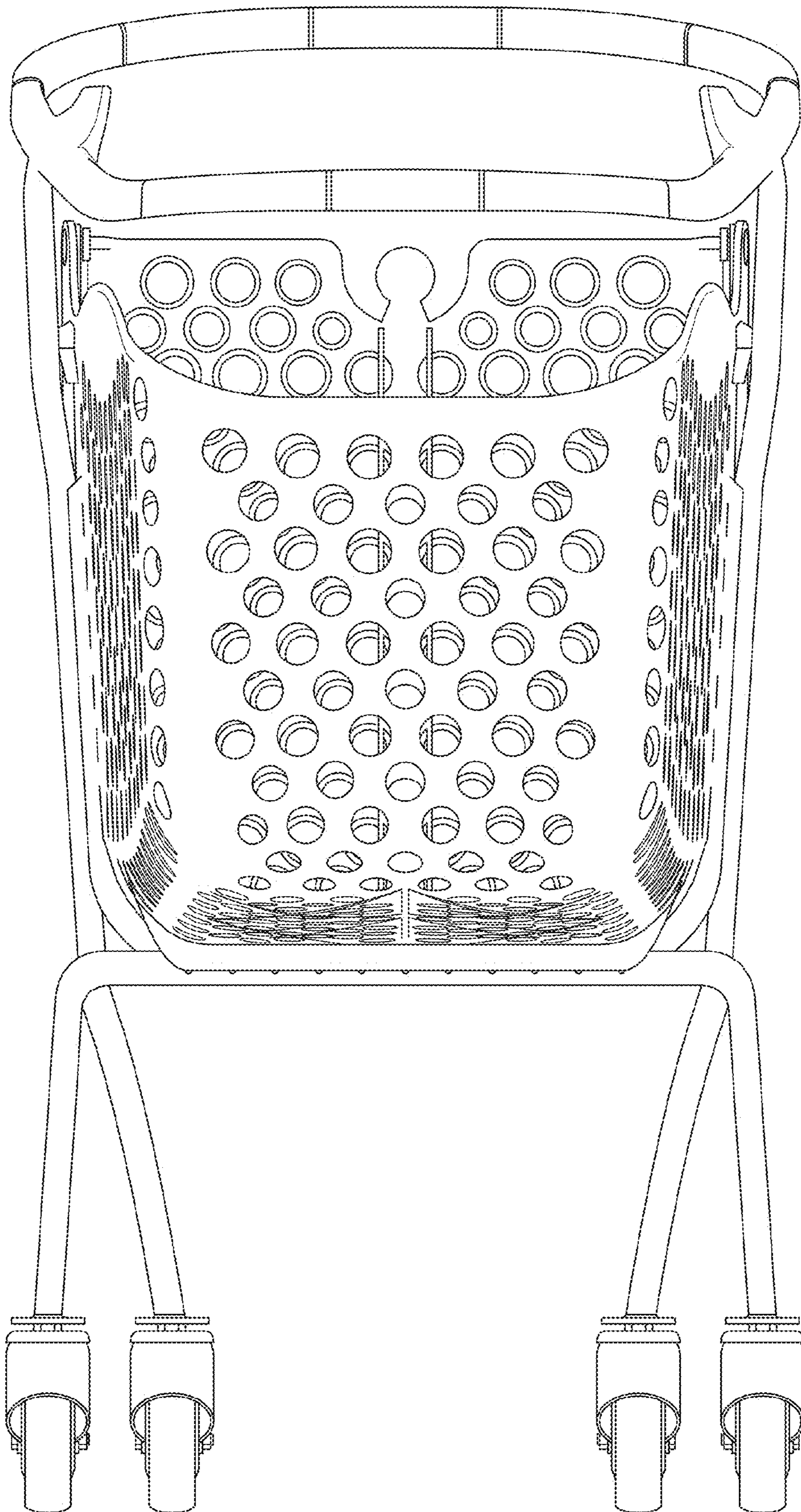

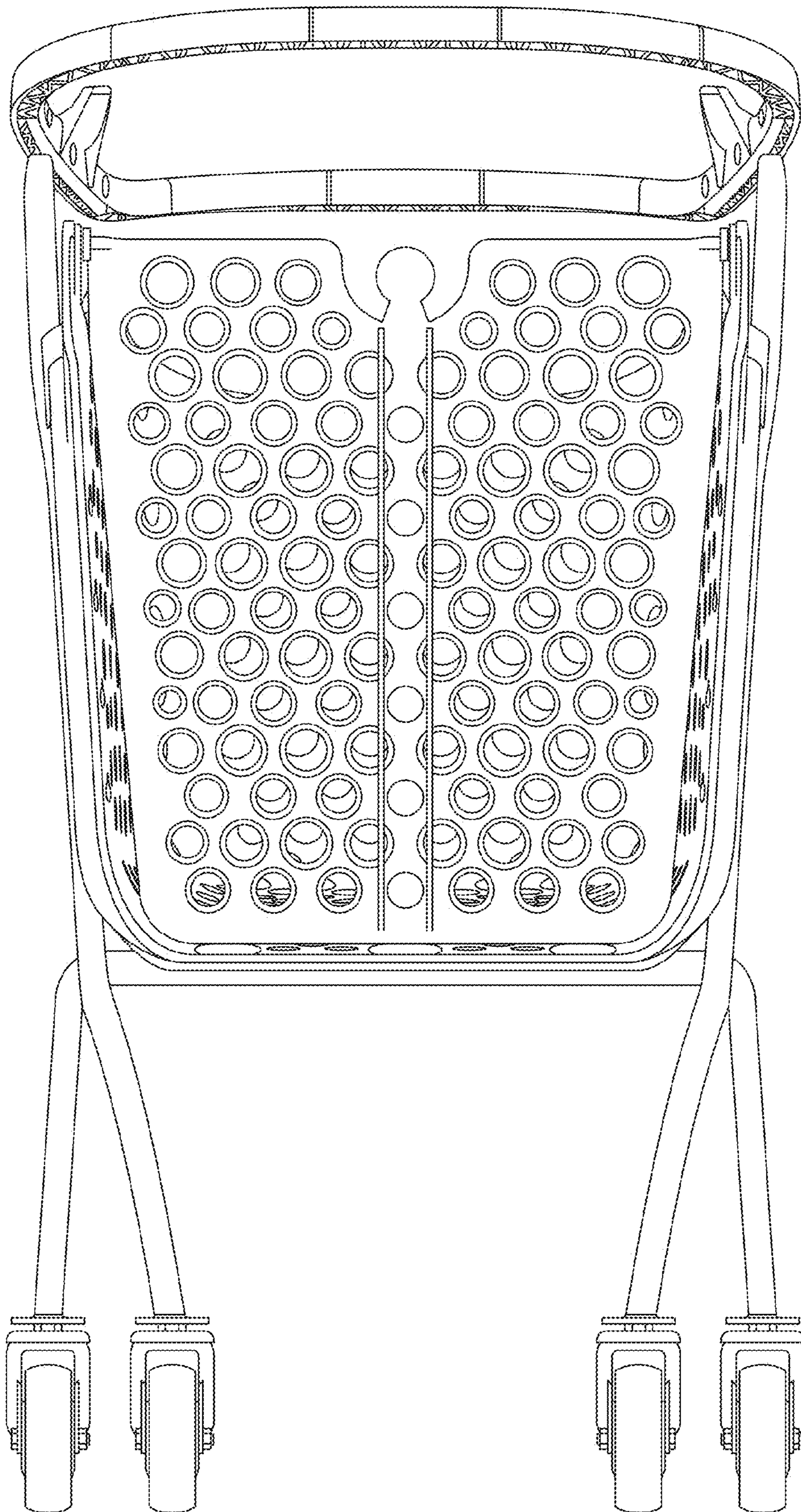

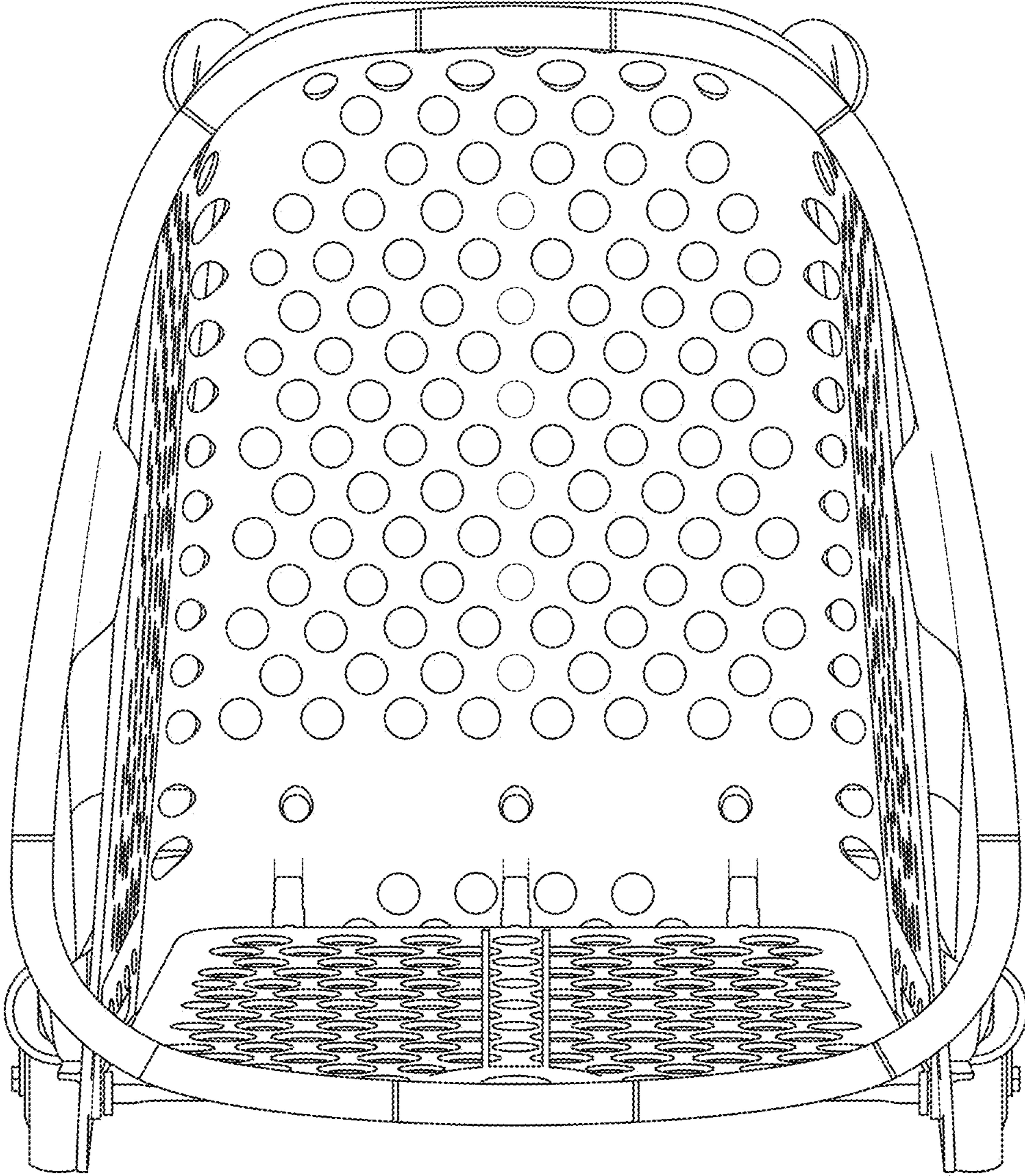

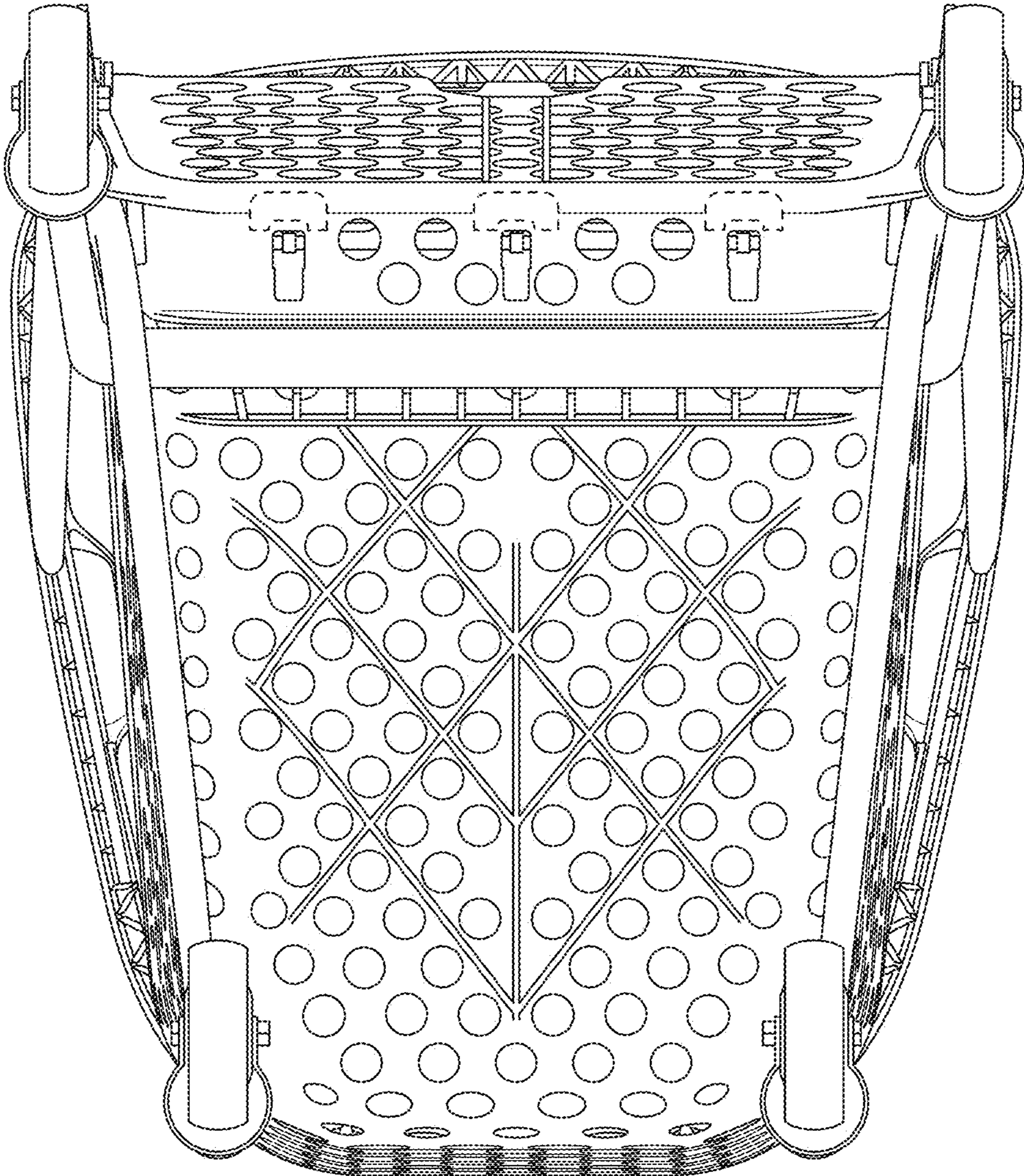
