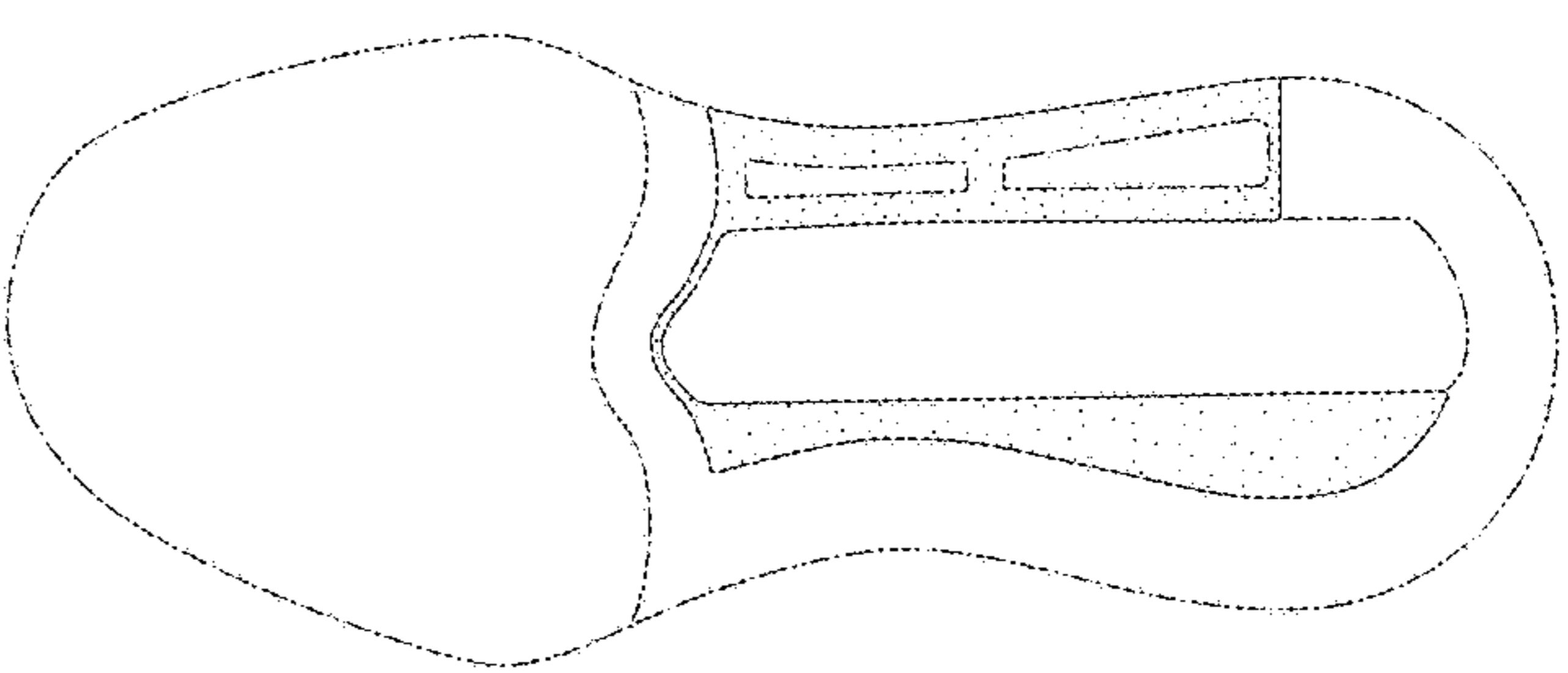
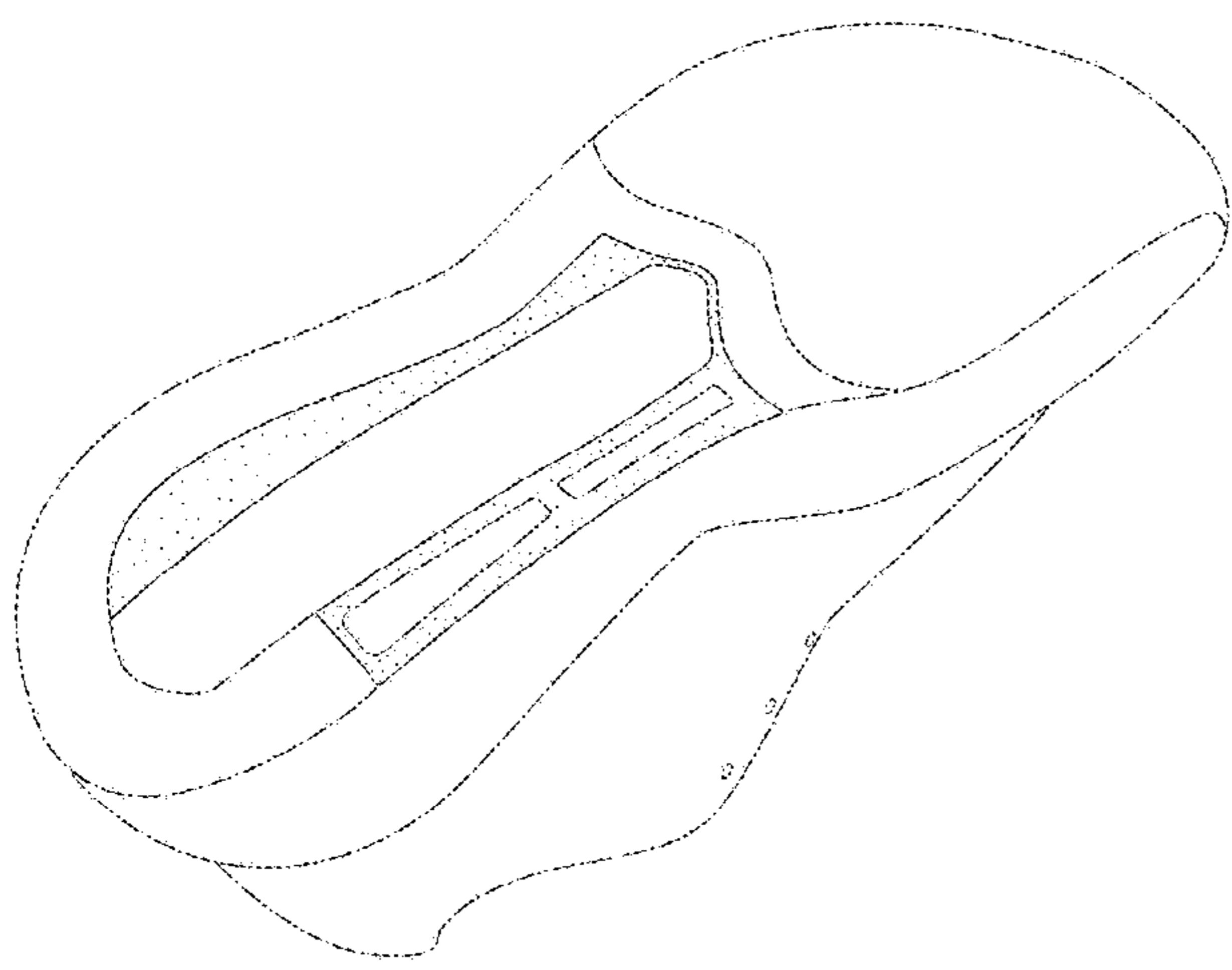

DESCRIPTION

FIG. 1 is a bottom rear perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a bottom front perspective view thereof.
The broken line showing of the two generally rectangular regions within the shaded area and the unshaded areas therewithin represent regions that form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

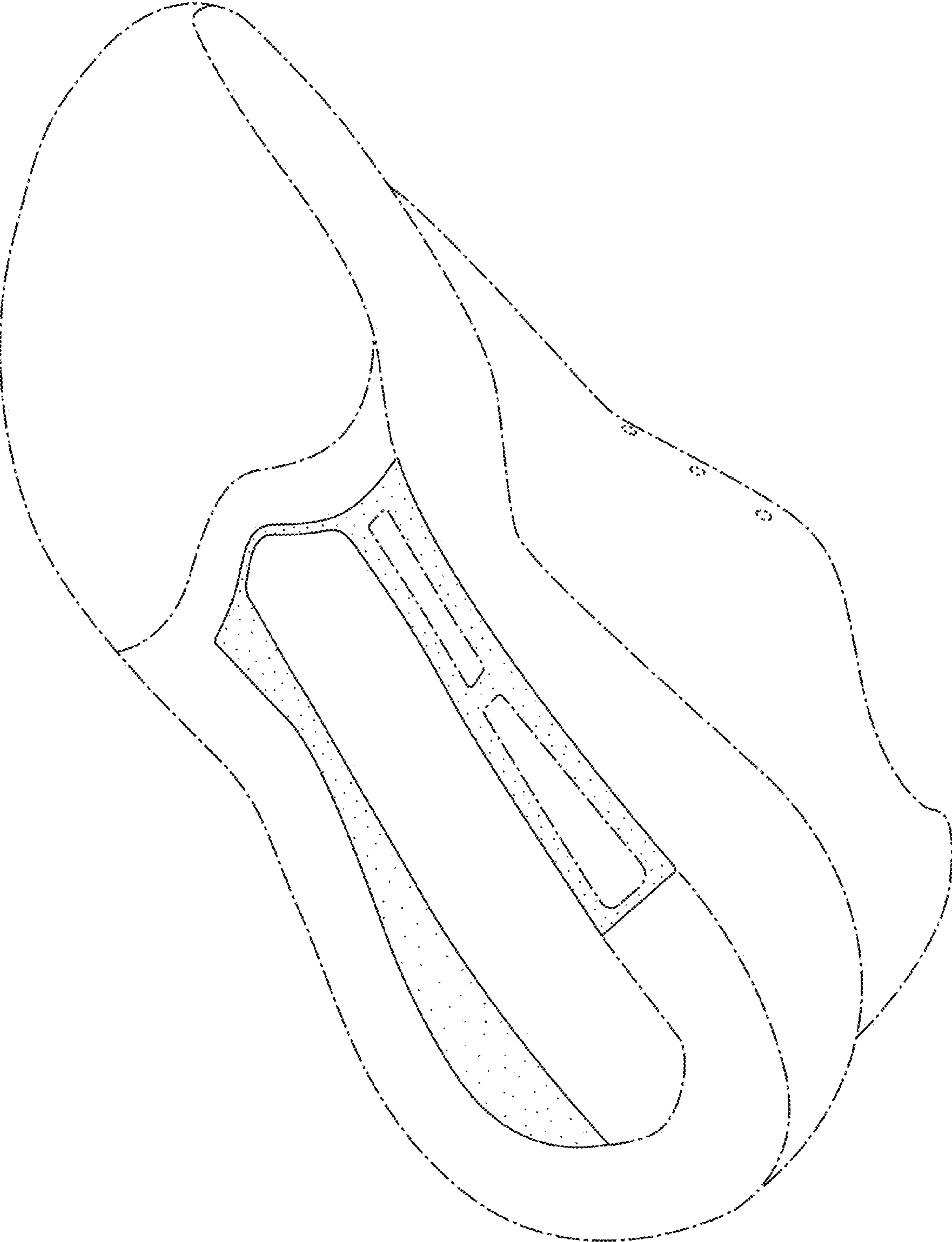

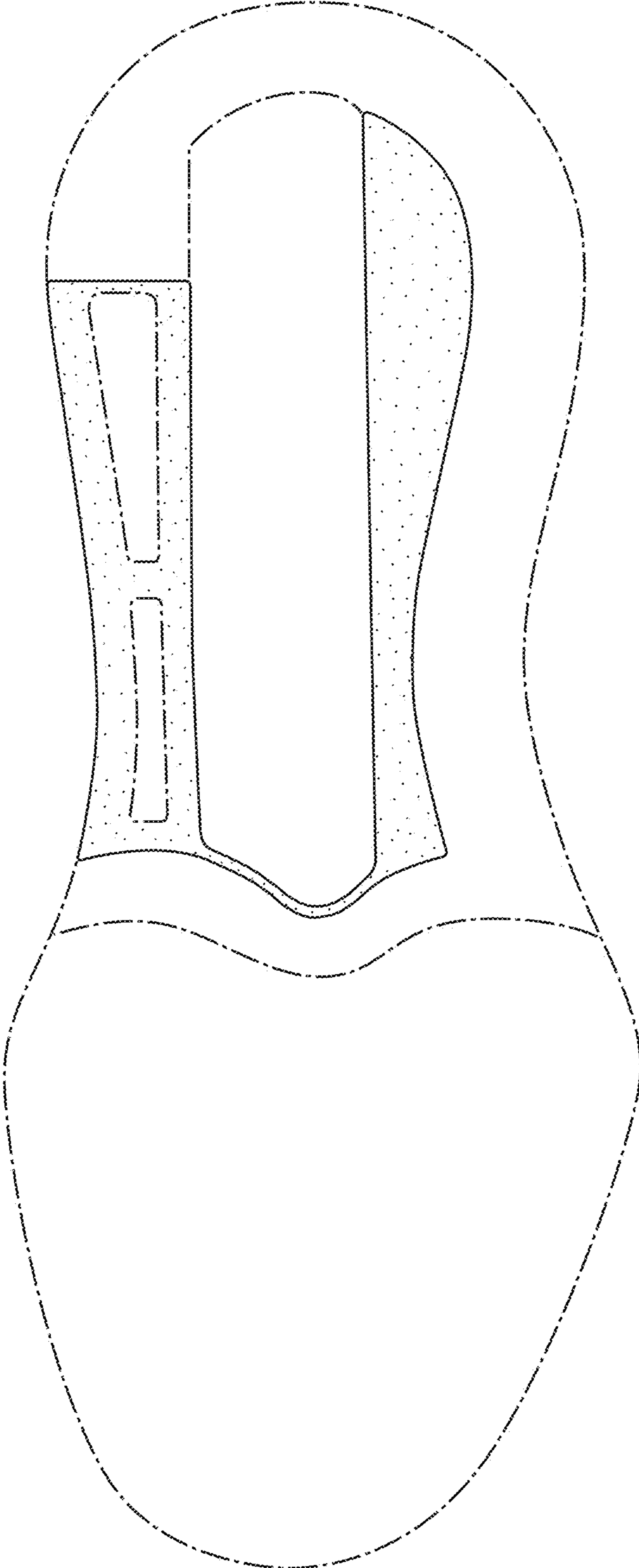

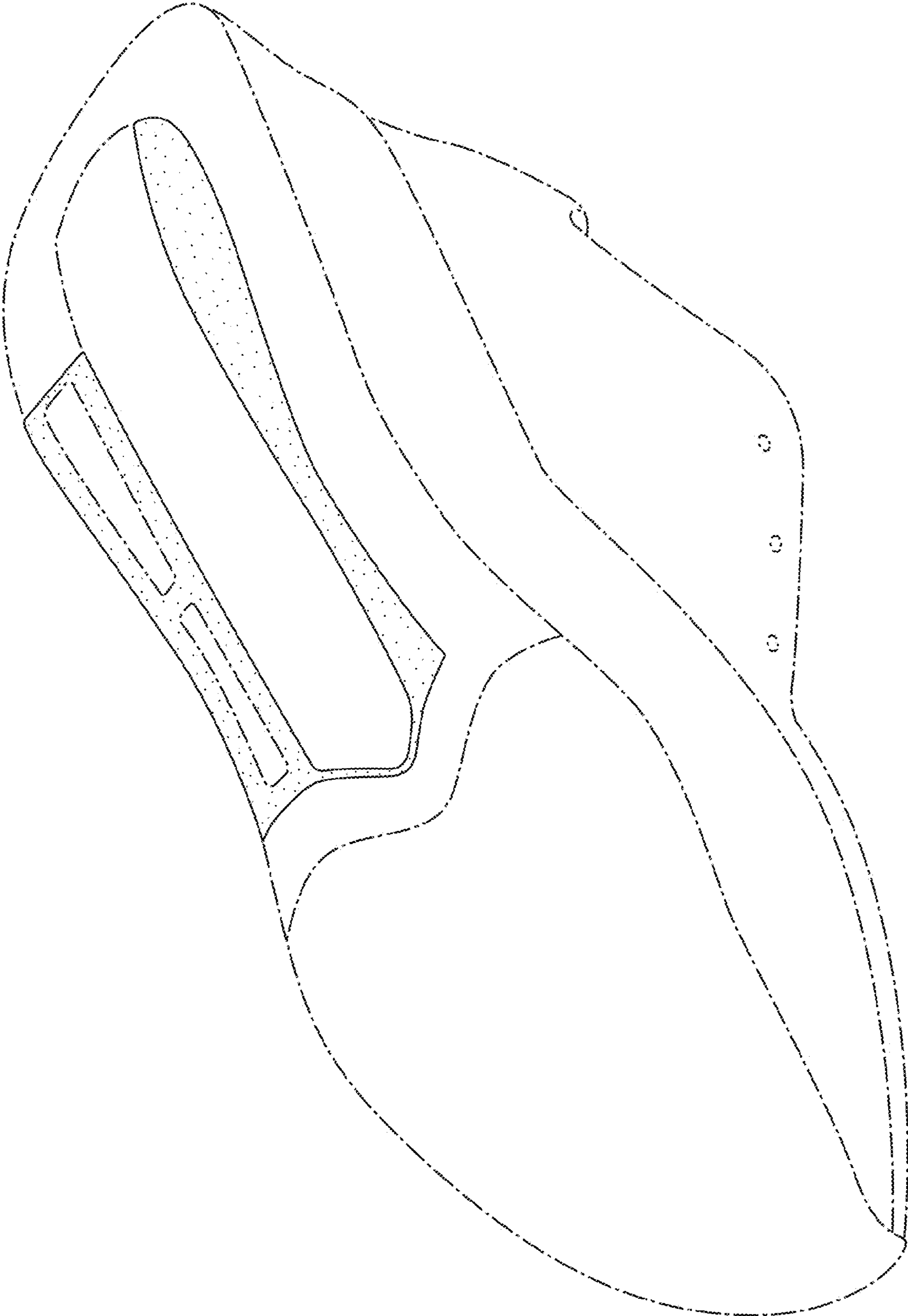
