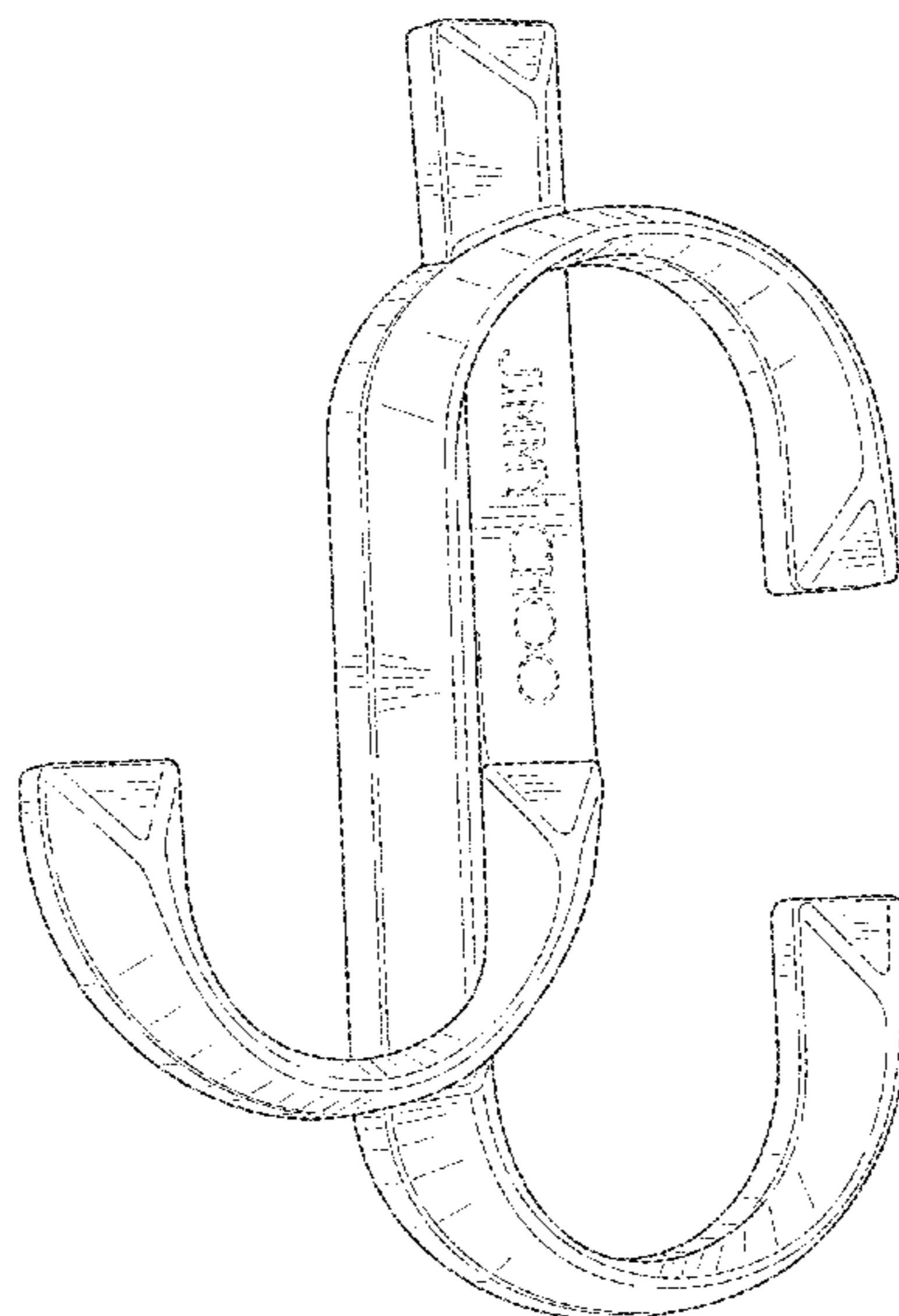

The ornamental design for a monogram, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a monogram showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a front perspective view of the monogram design shown in FIG. 1 in the environment of a handbag.
The broken lines shown on claimed surfaces depict portions of the article and form no part of the claim. The broken lines showing a handbag in FIG. 7 depict environment and forms no part of the claim.

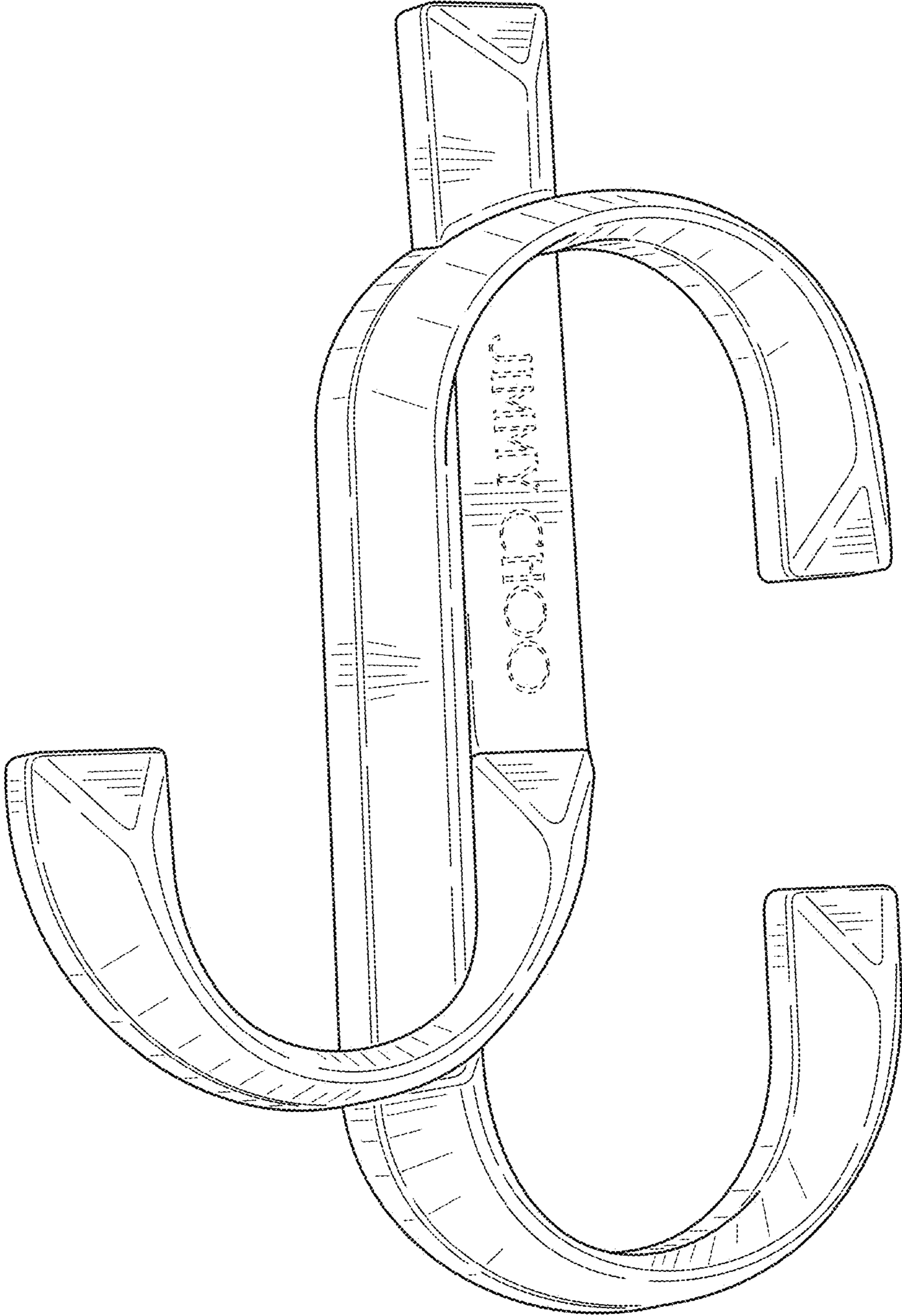

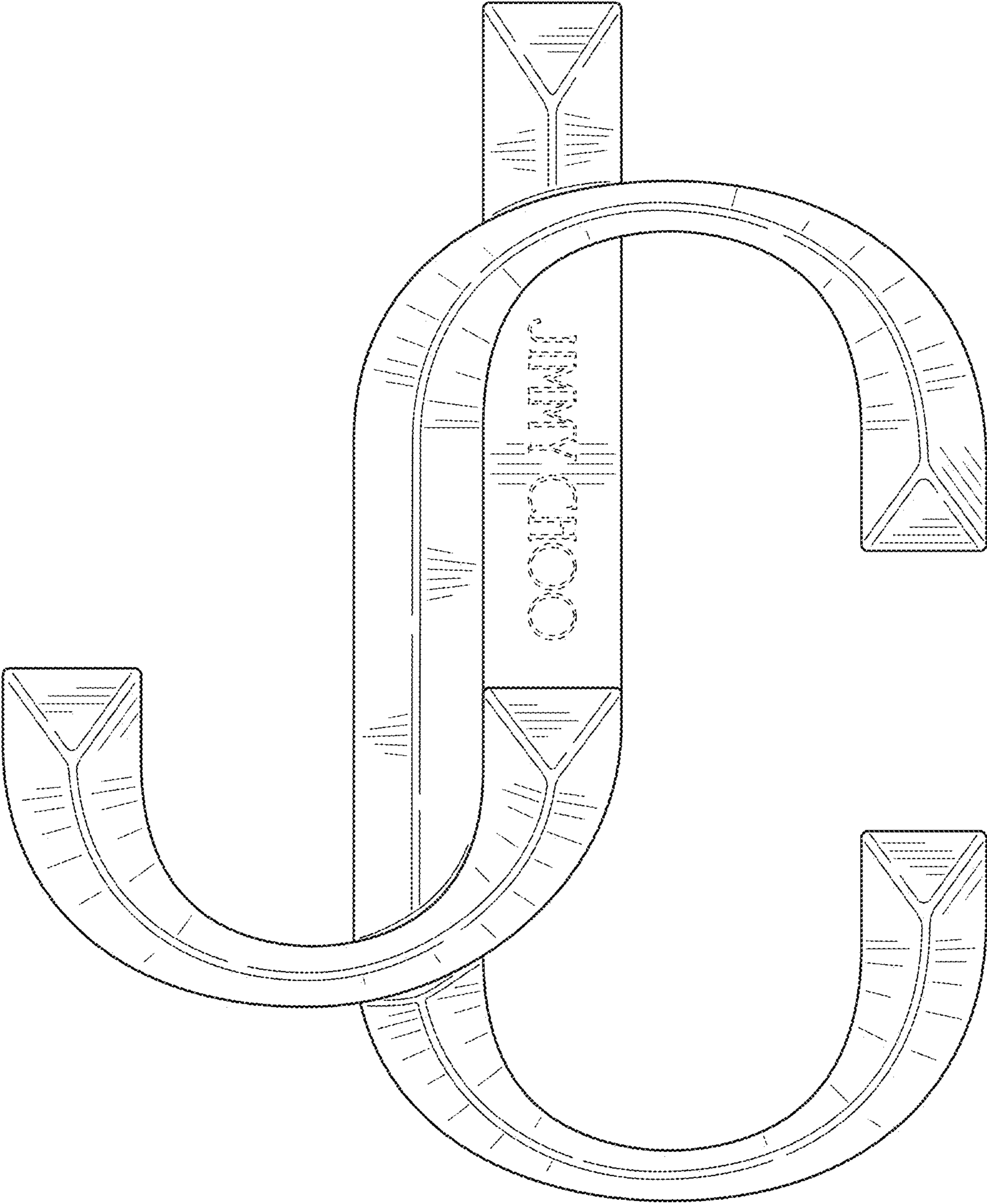

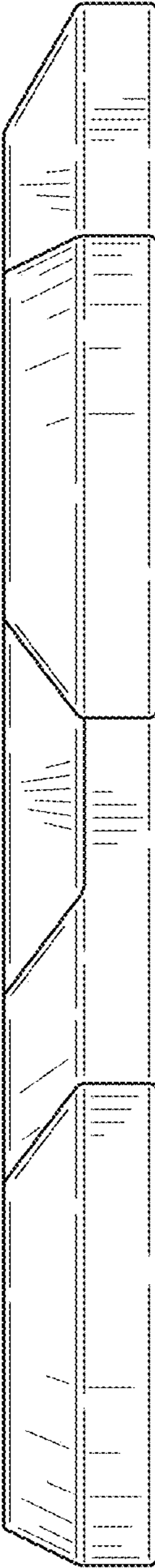

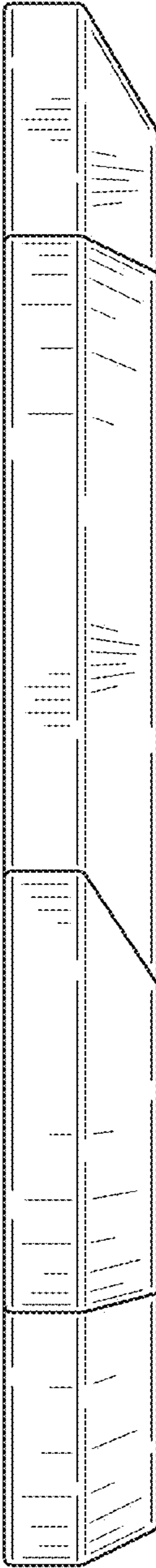

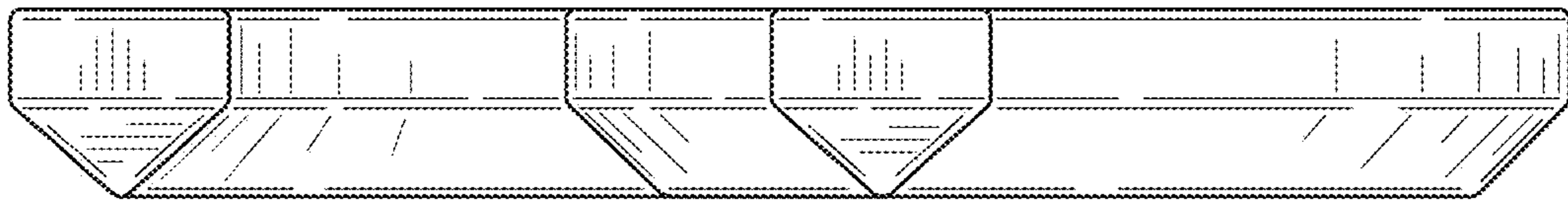

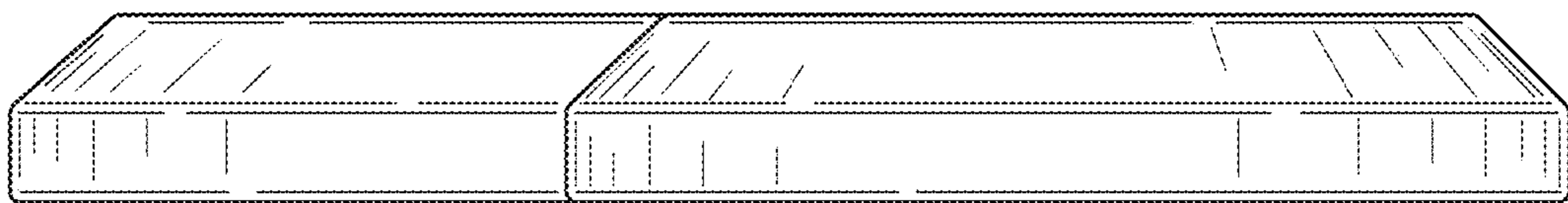
