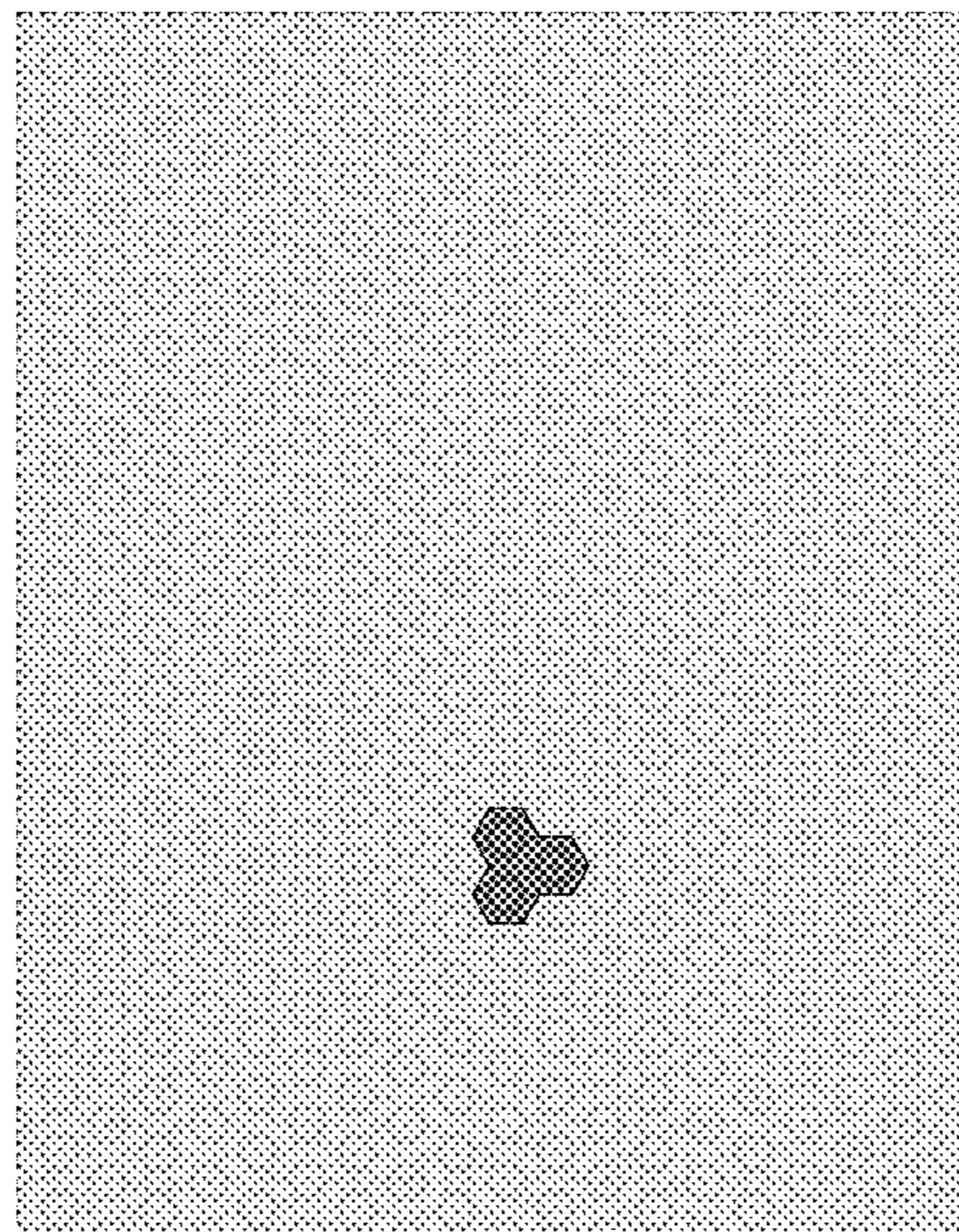
(57) **CLAIM**

The ornamental design for a textile including a surface pattern, as shown and described.

DESCRIPTION

The sole FIGURE is a top plan view of a textile including a surface pattern, showing our new design. The dot dash dot broken lines within the perimeter and adjacent to the solid lines denote the boundaries of the claim and form no part of thereof. The light grey pattern area outside of the boundary depicts portions of the textile including a surface pattern that form no part of the claimed design. The broken line forming a perimeter around the FIGURE depicts environmental subject matter that forms no part of the claimed design.
