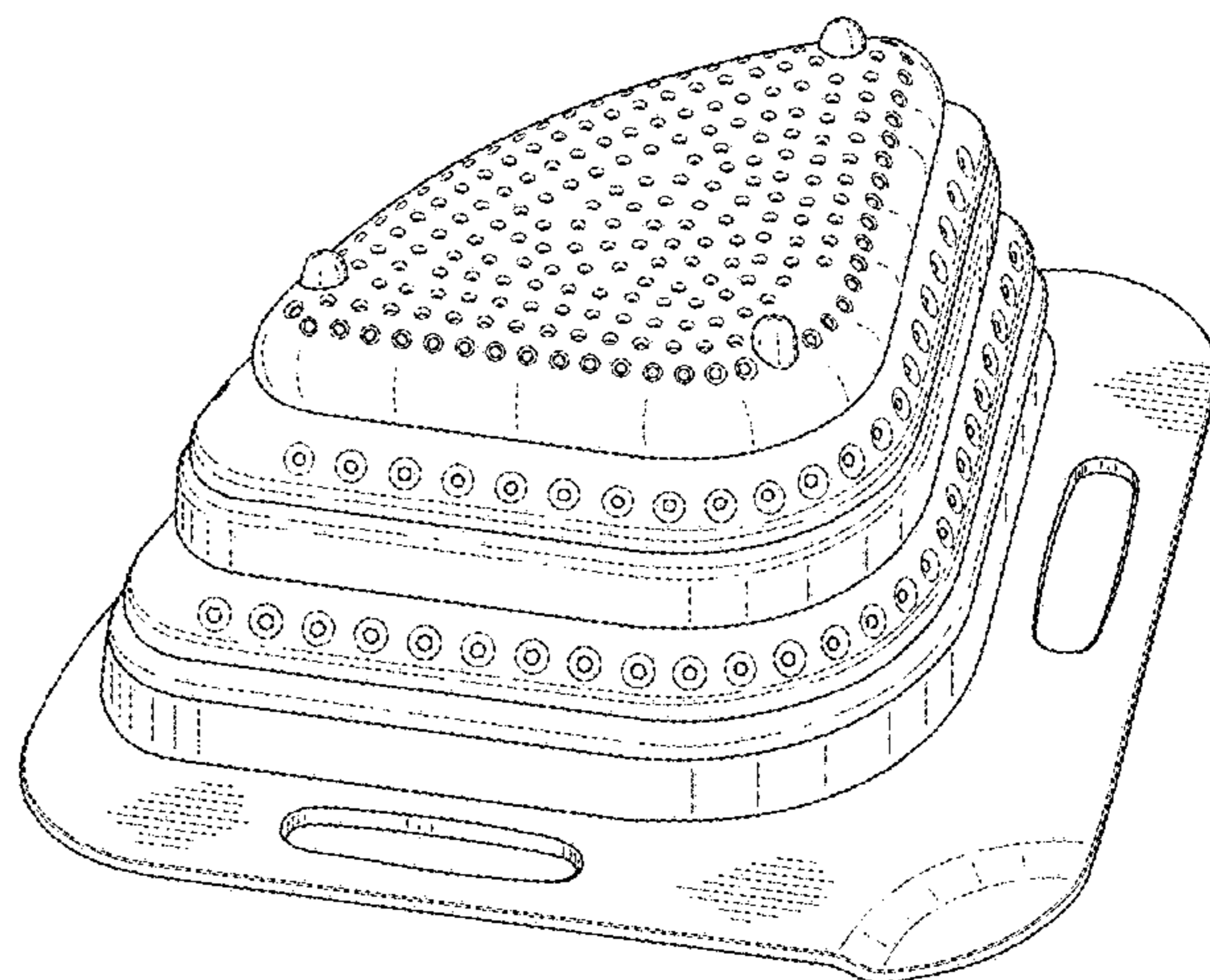
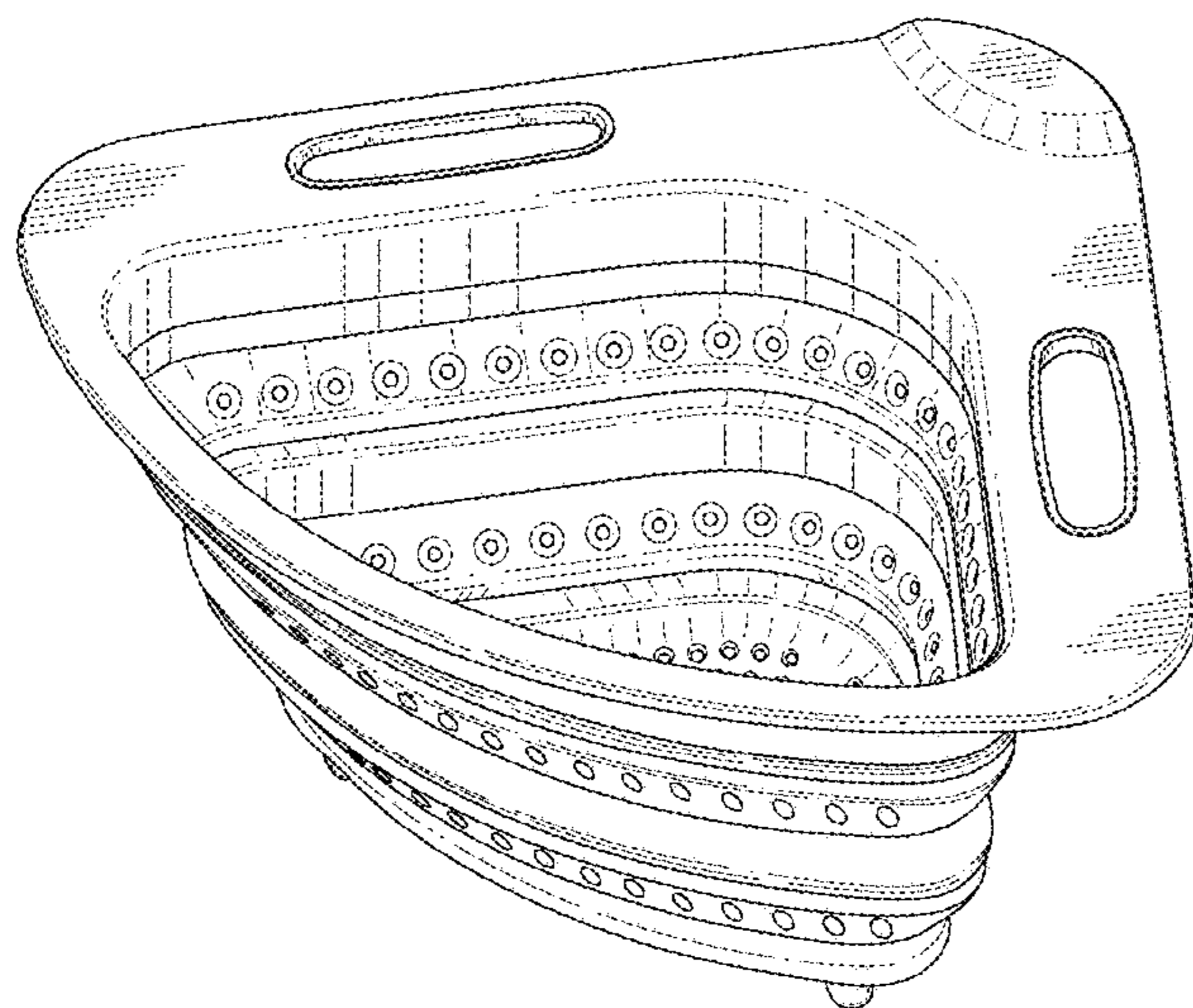
(57) **CLAIM**

I claim the ornamental design for a collapsible corner colander, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a collapsible corner colander in accordance with the design;

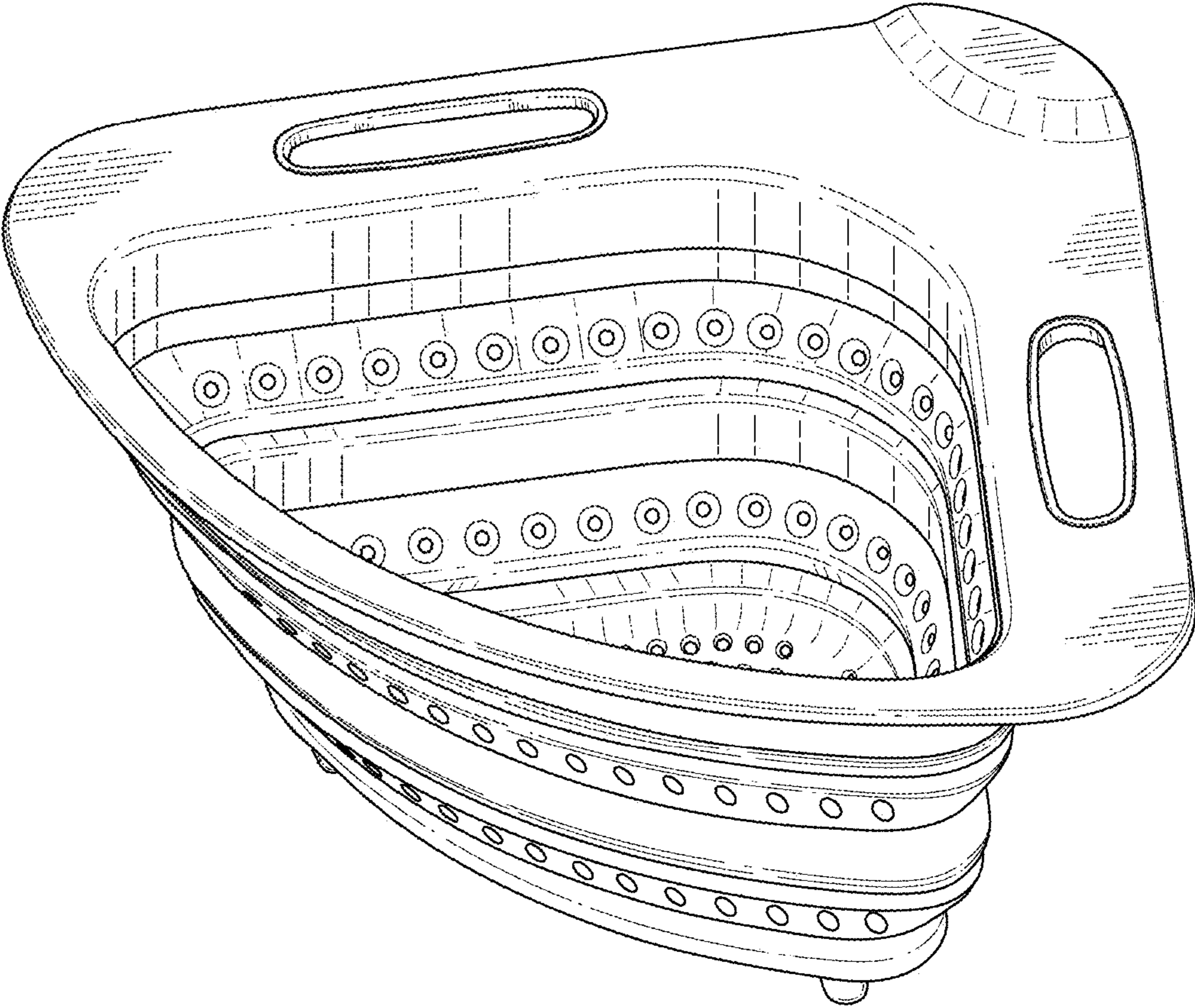

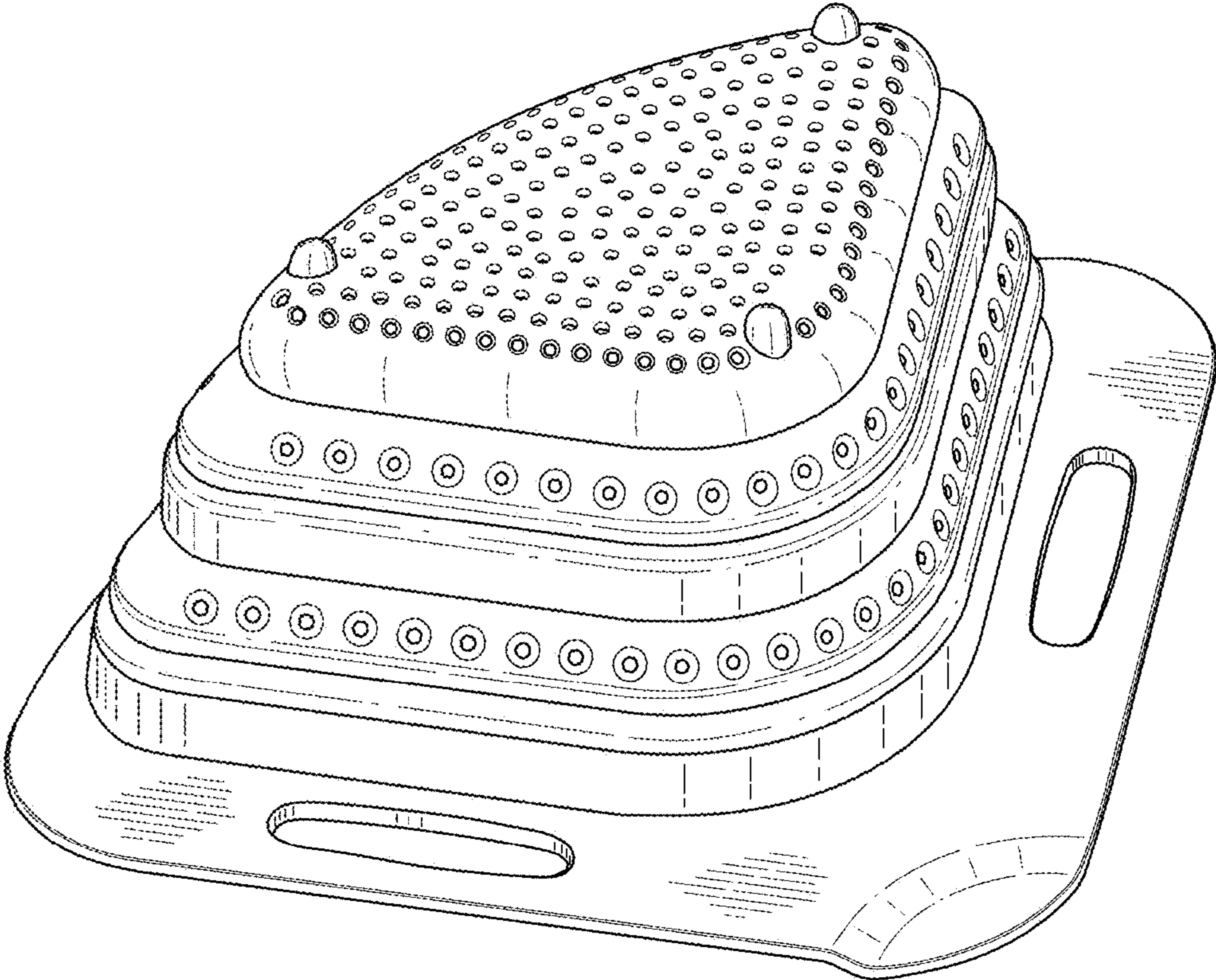

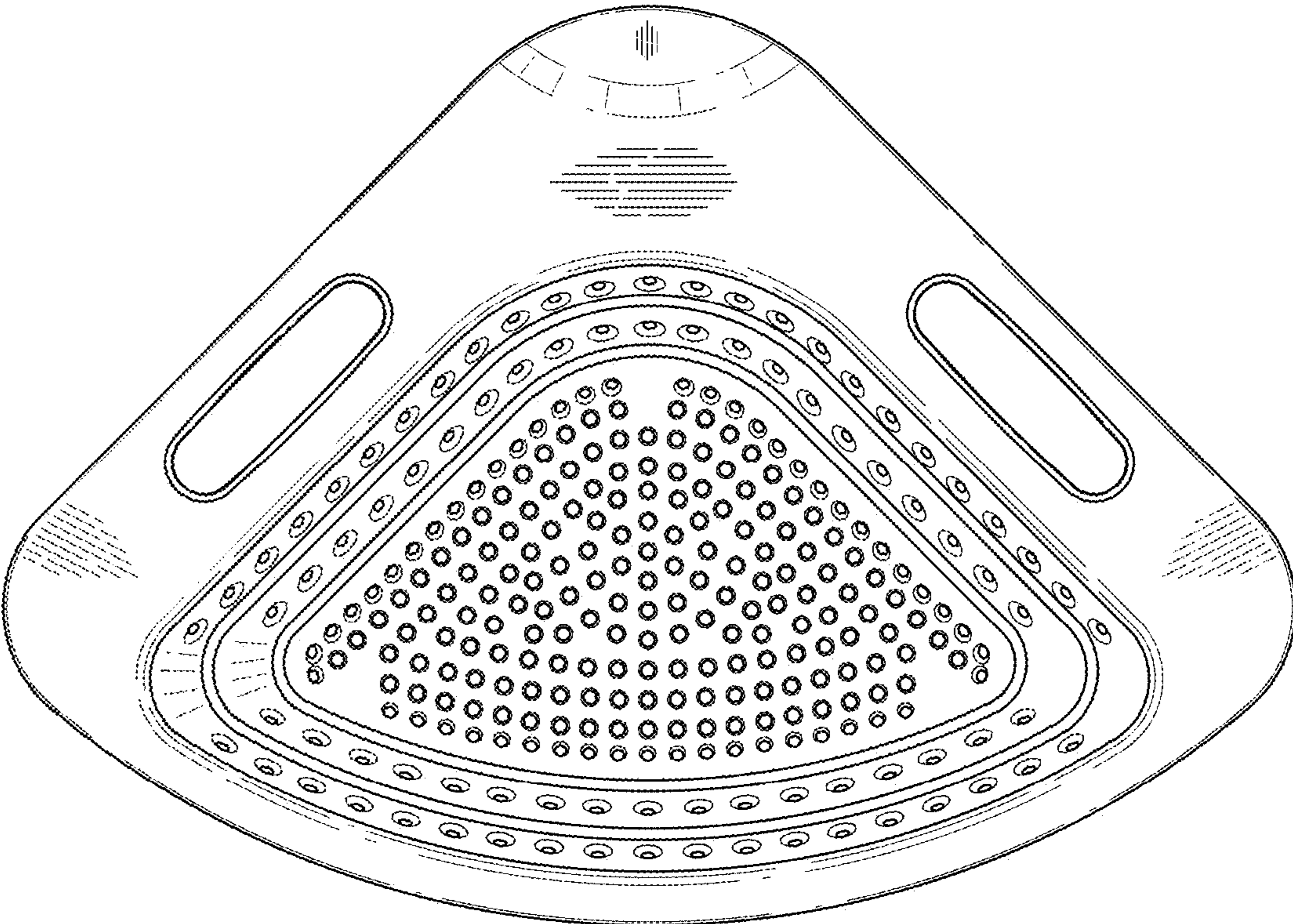

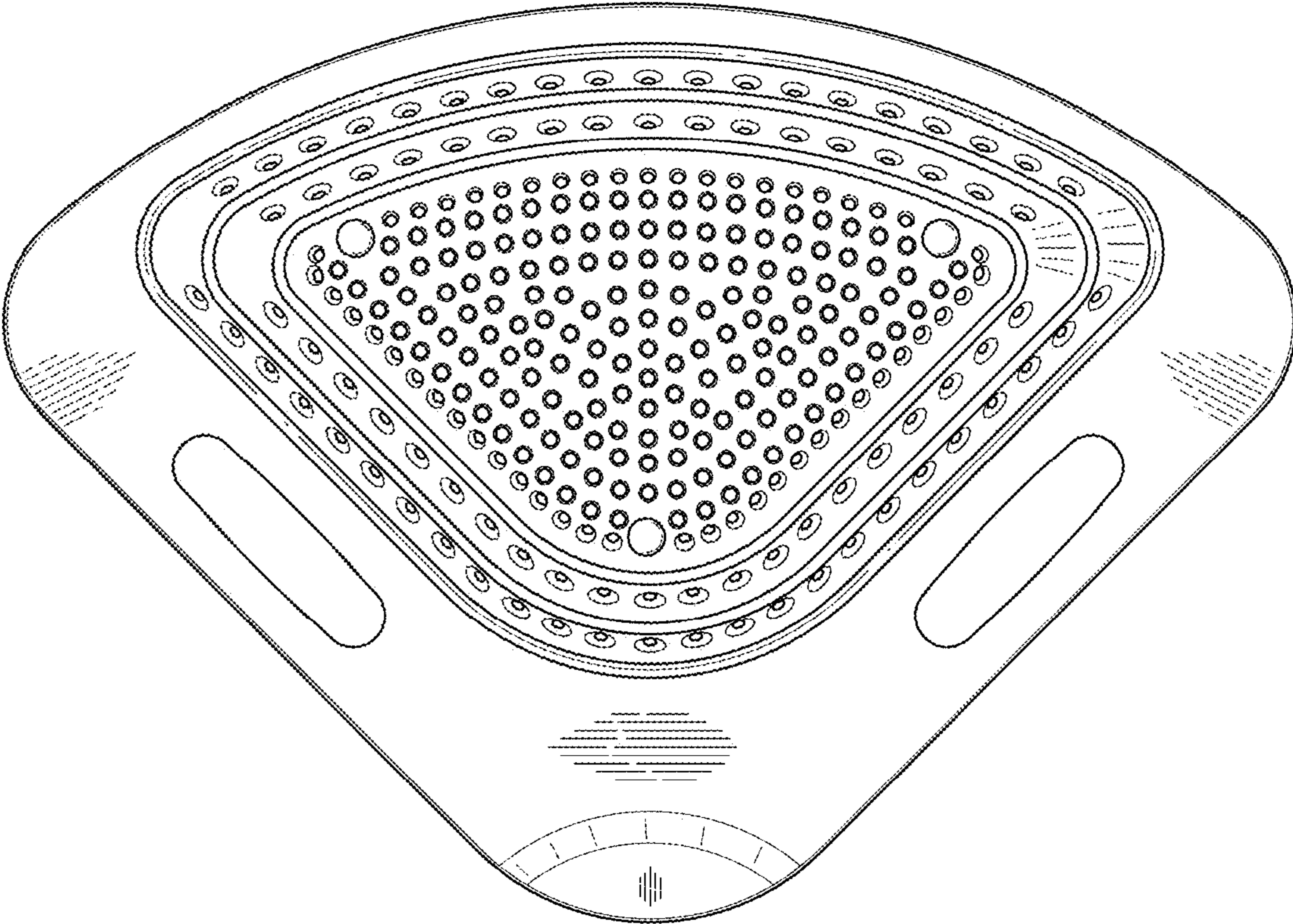

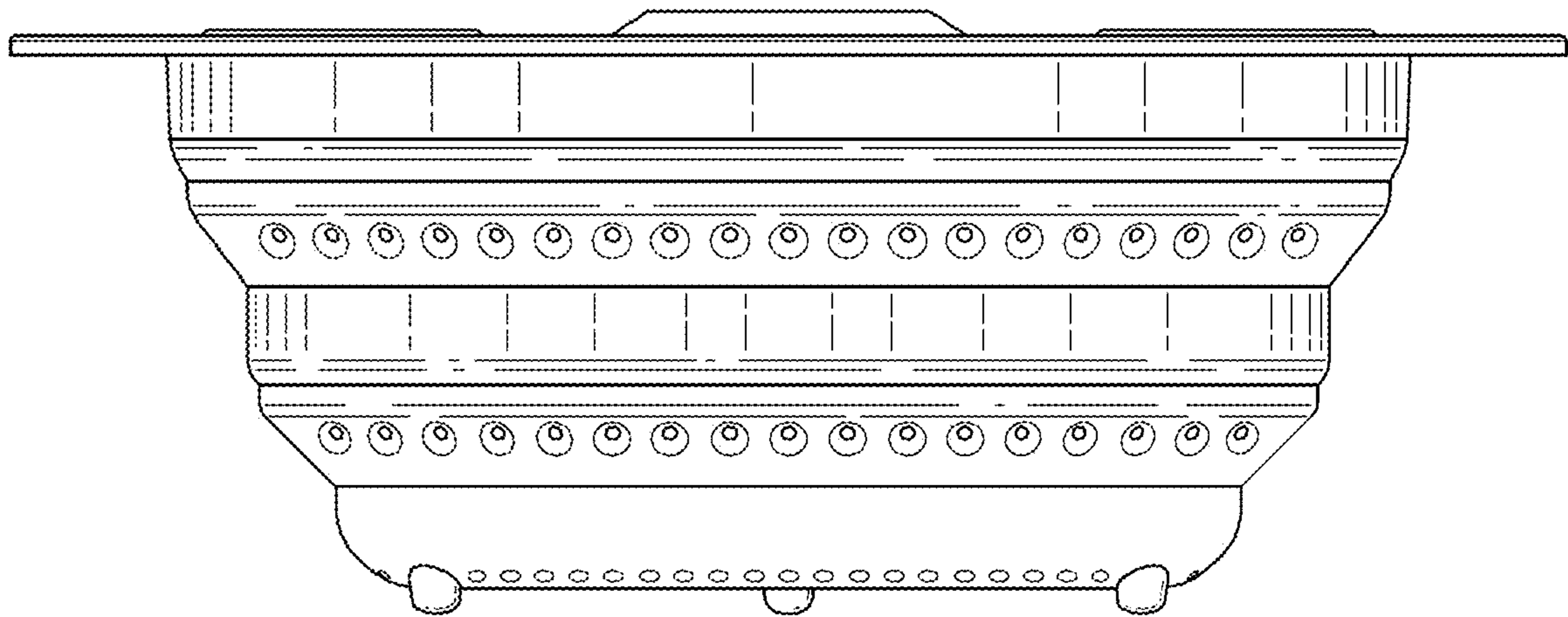

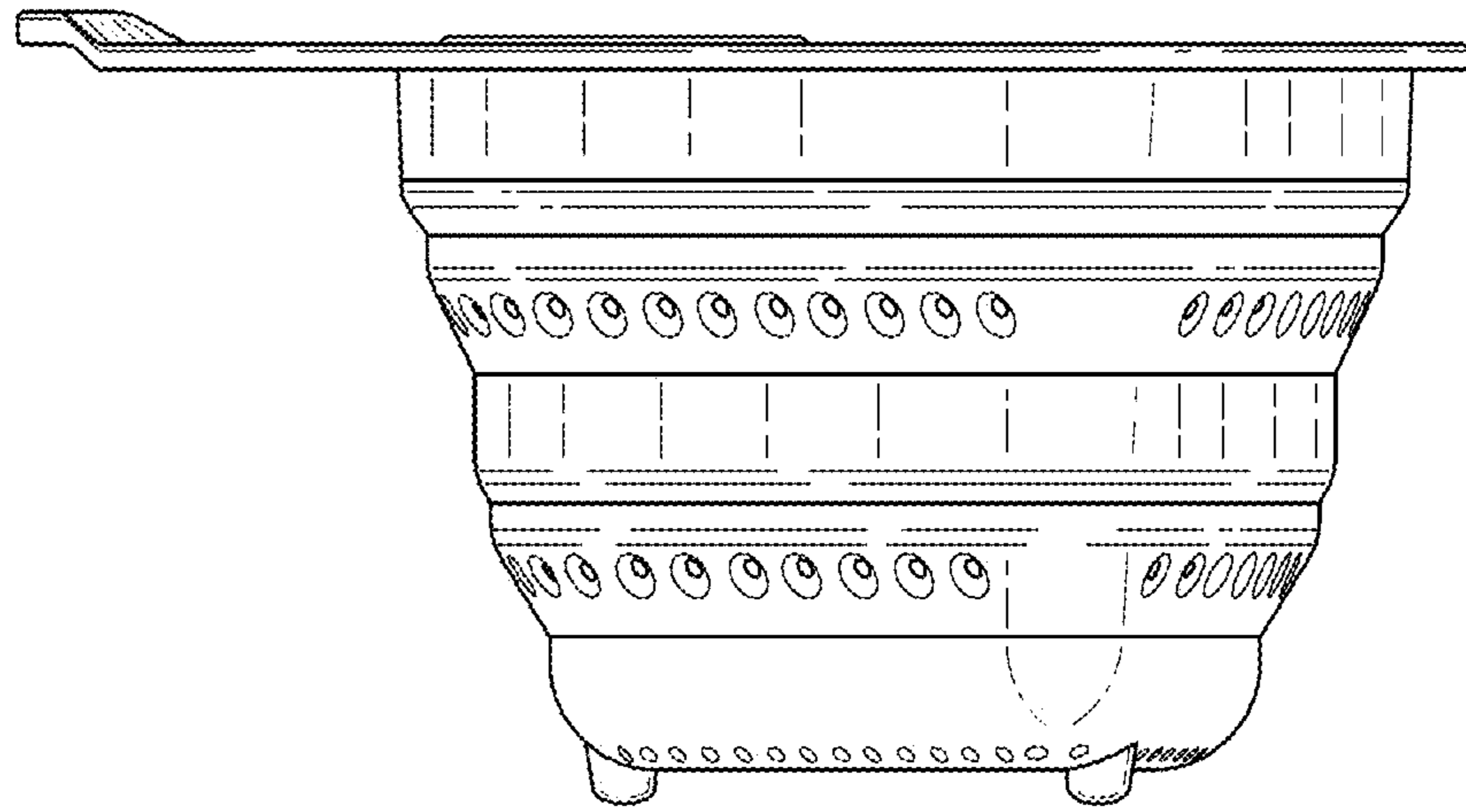
