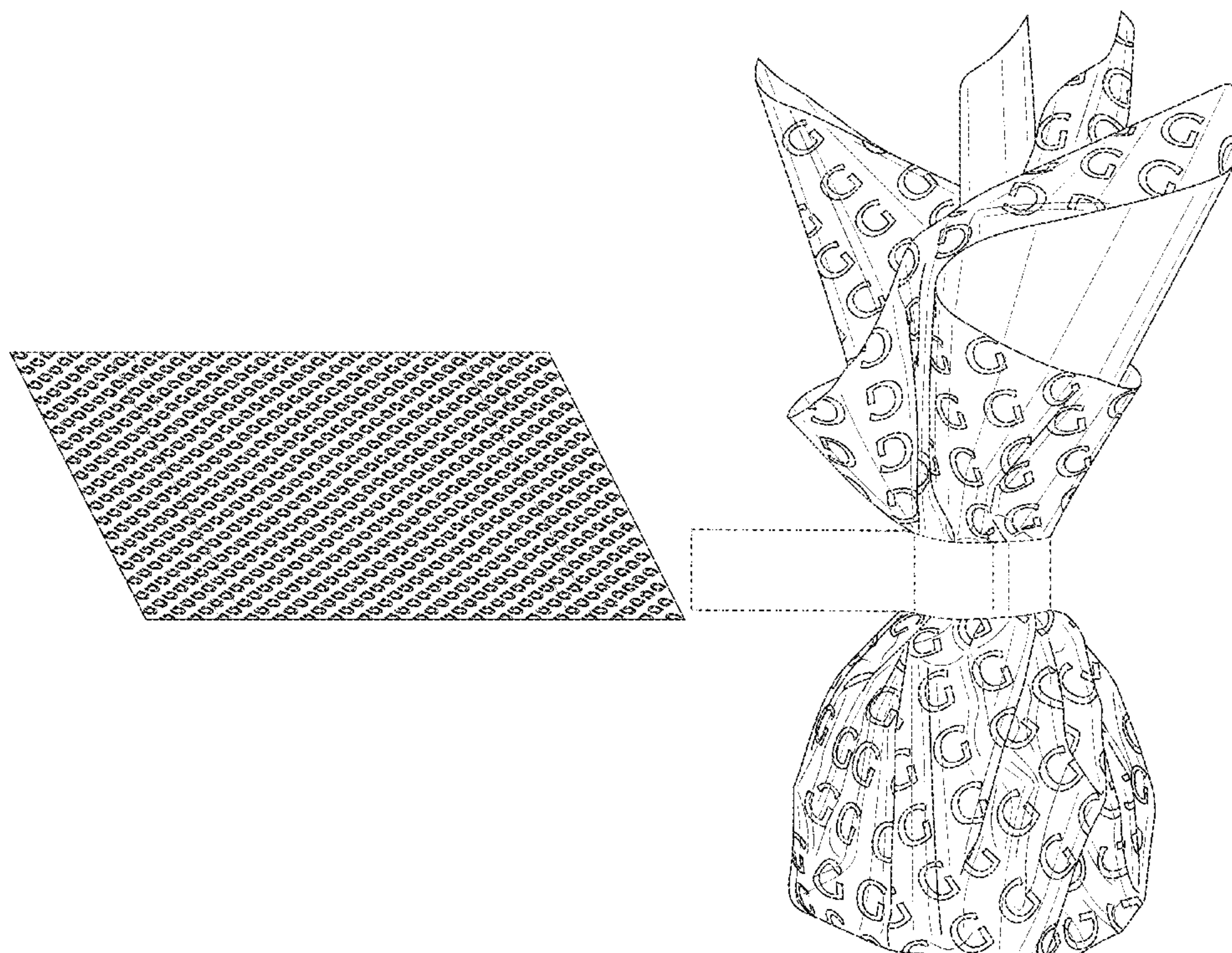
(57) **CLAIM**

The ornamental design for a wrapper with graphic, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wrapper with graphic showing my new design;

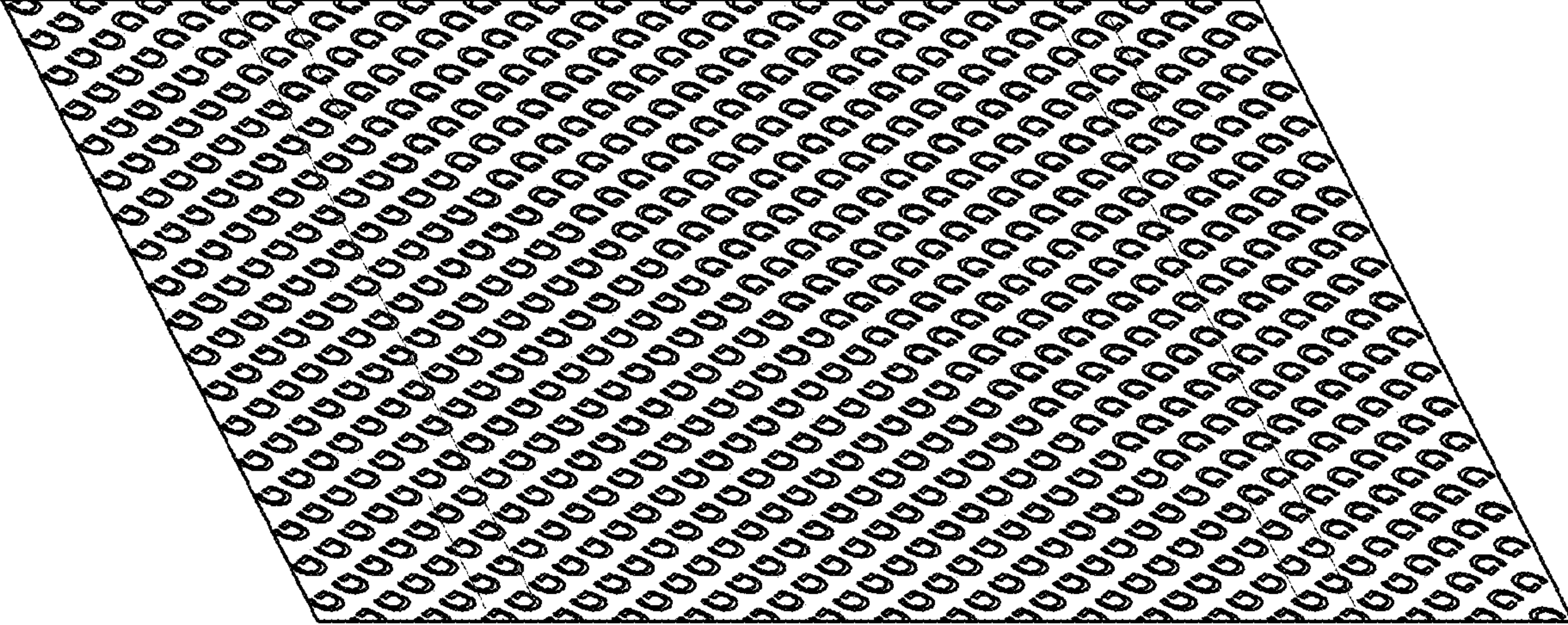

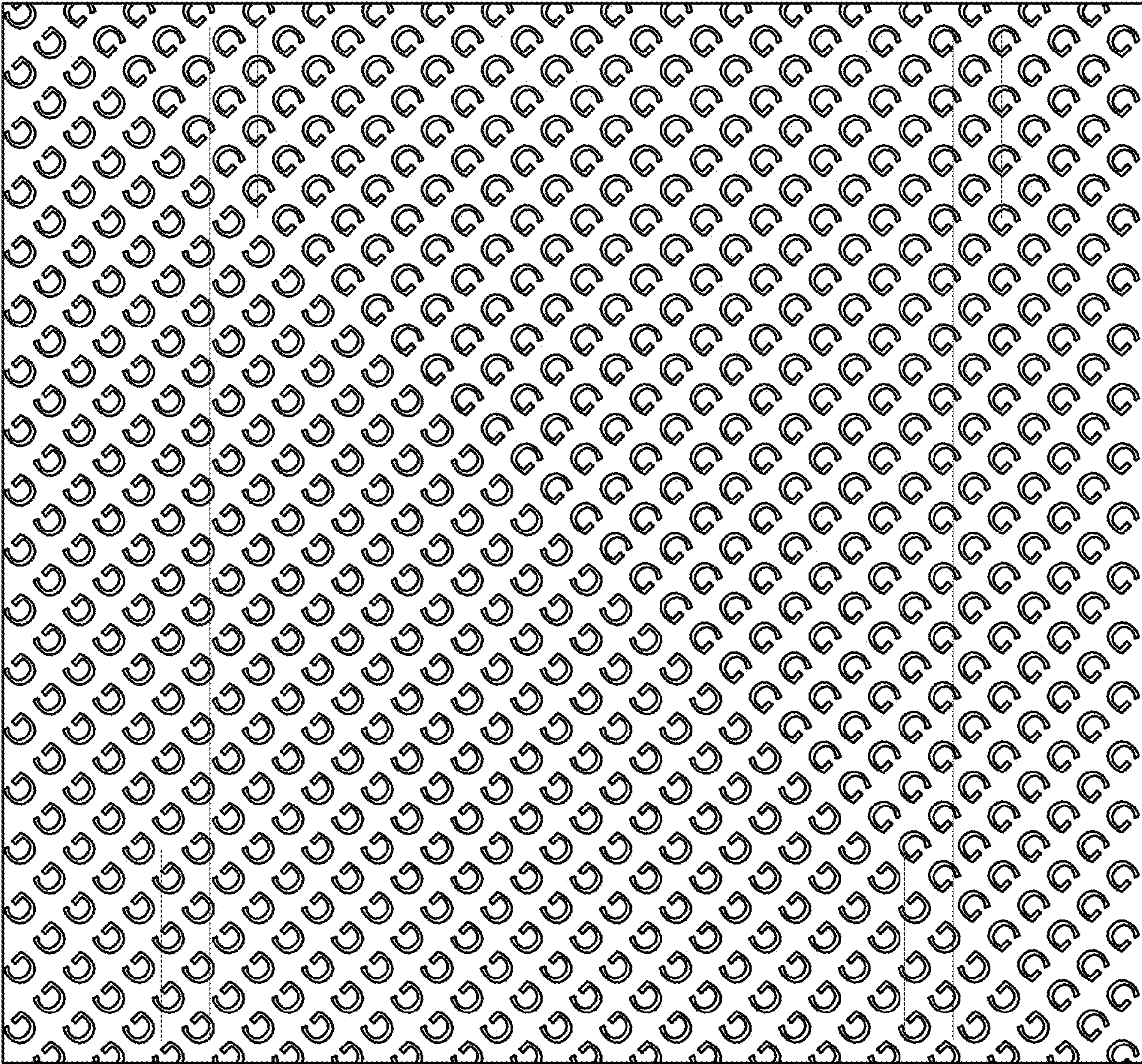

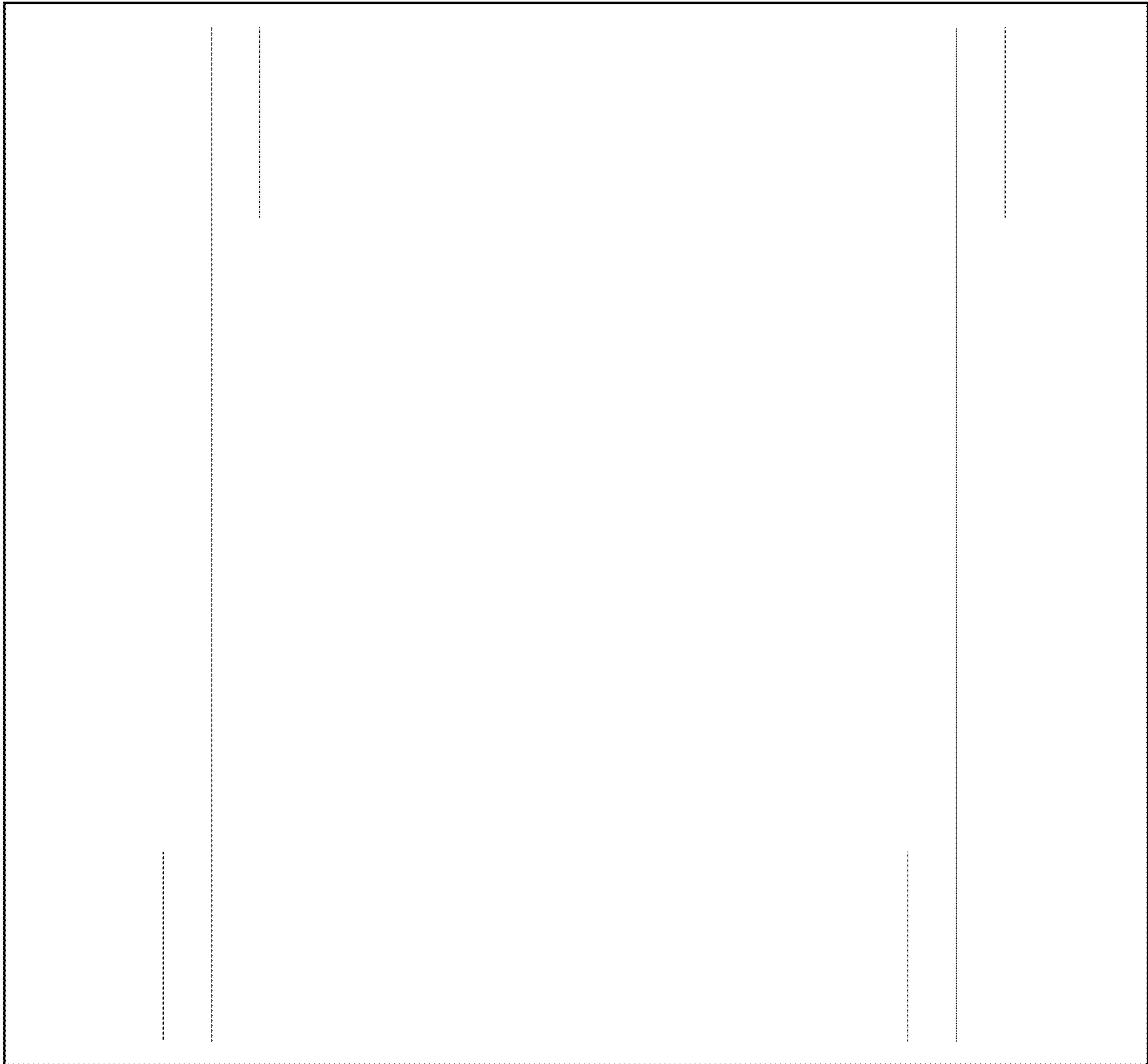

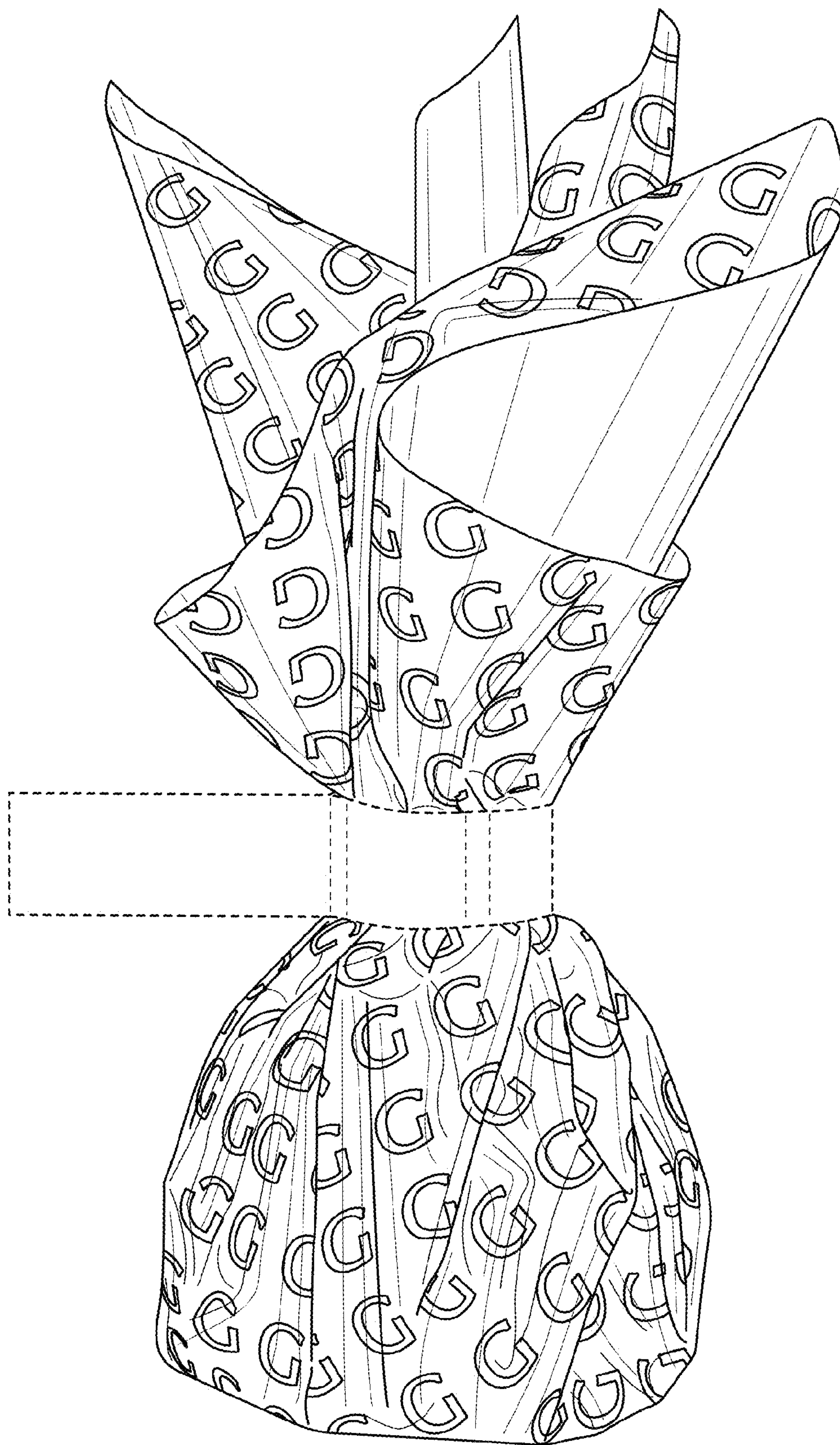
