An ornamental design for a trailer, as shown and described.

DESCRIPTION

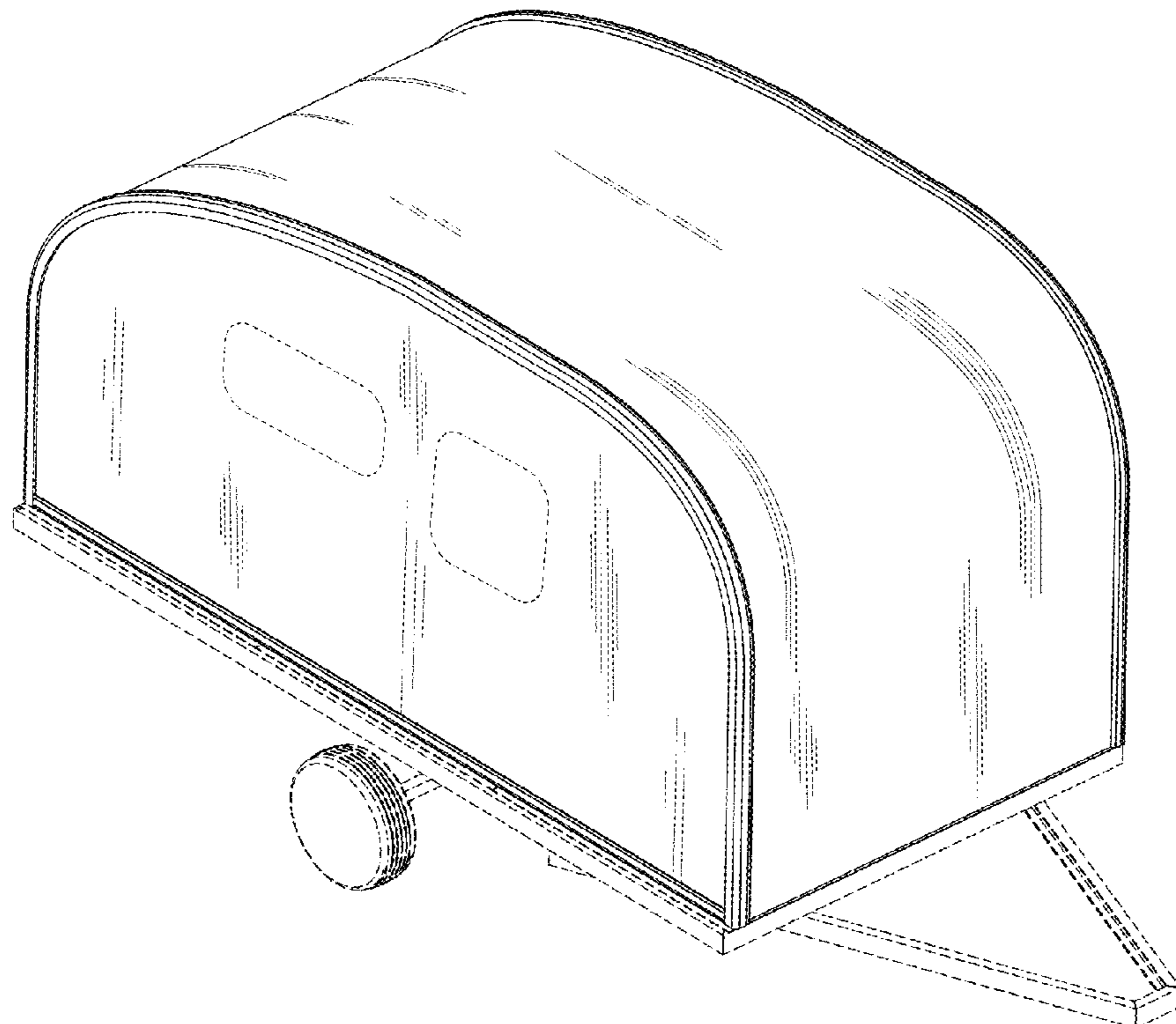
FIG. 1 is a perspective view of a new design for a trailer having a curved shape and a rear door; FIG. 2 is a left view thereof; FIG. 3 is a right thereof; FIG. 4 is a top view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a front thereof; and, FIG. 7 is a bottom view thereof.

The solid line showing illustrates the claimed features within the design for the claimed article of manufacture.

The broken lines shown in the drawings depict portions of the trailer that form no part of the claimed design.

The shading is provided to illustrate contour and material type only and is not an indication of texture, gloss, etc.

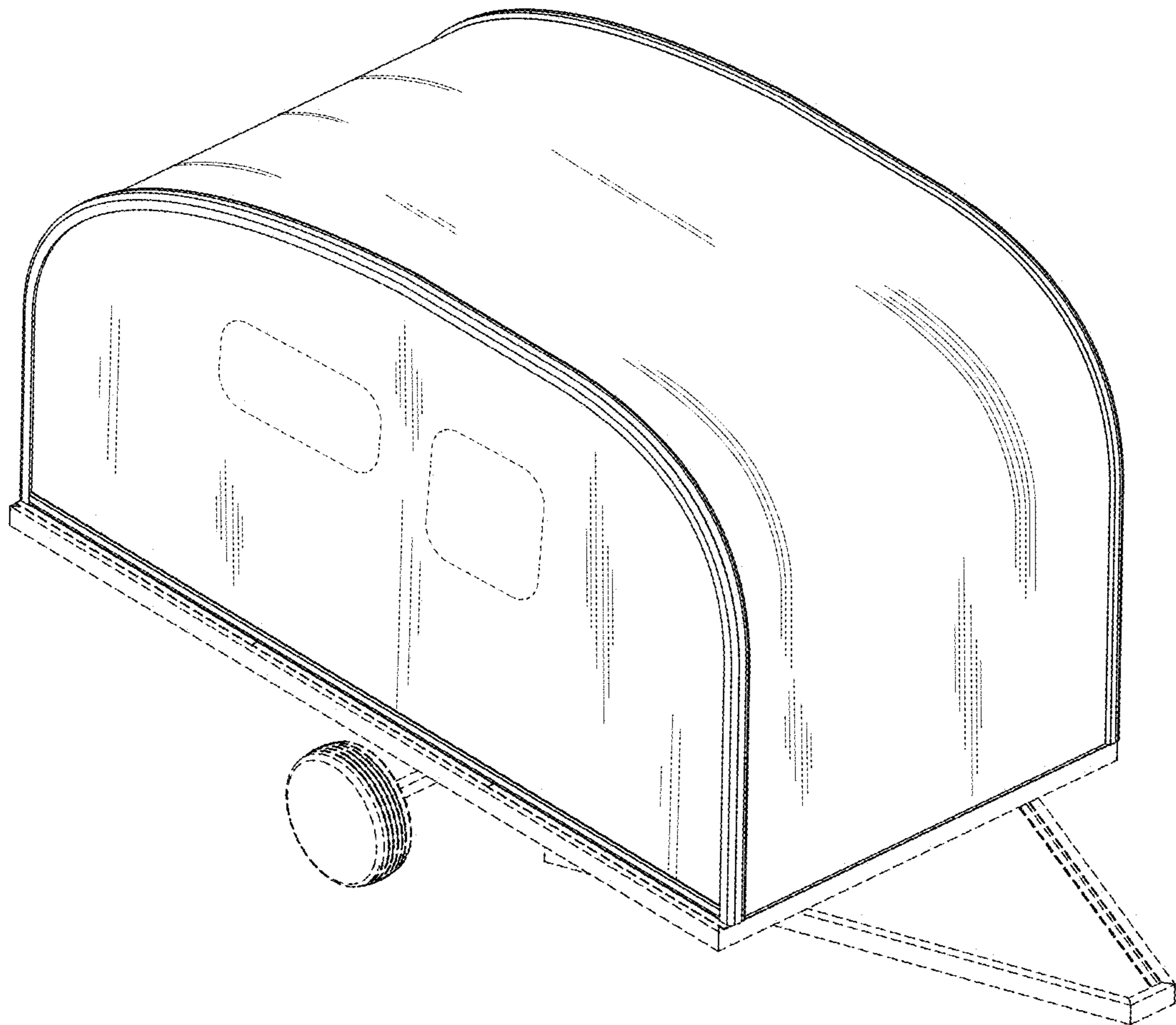

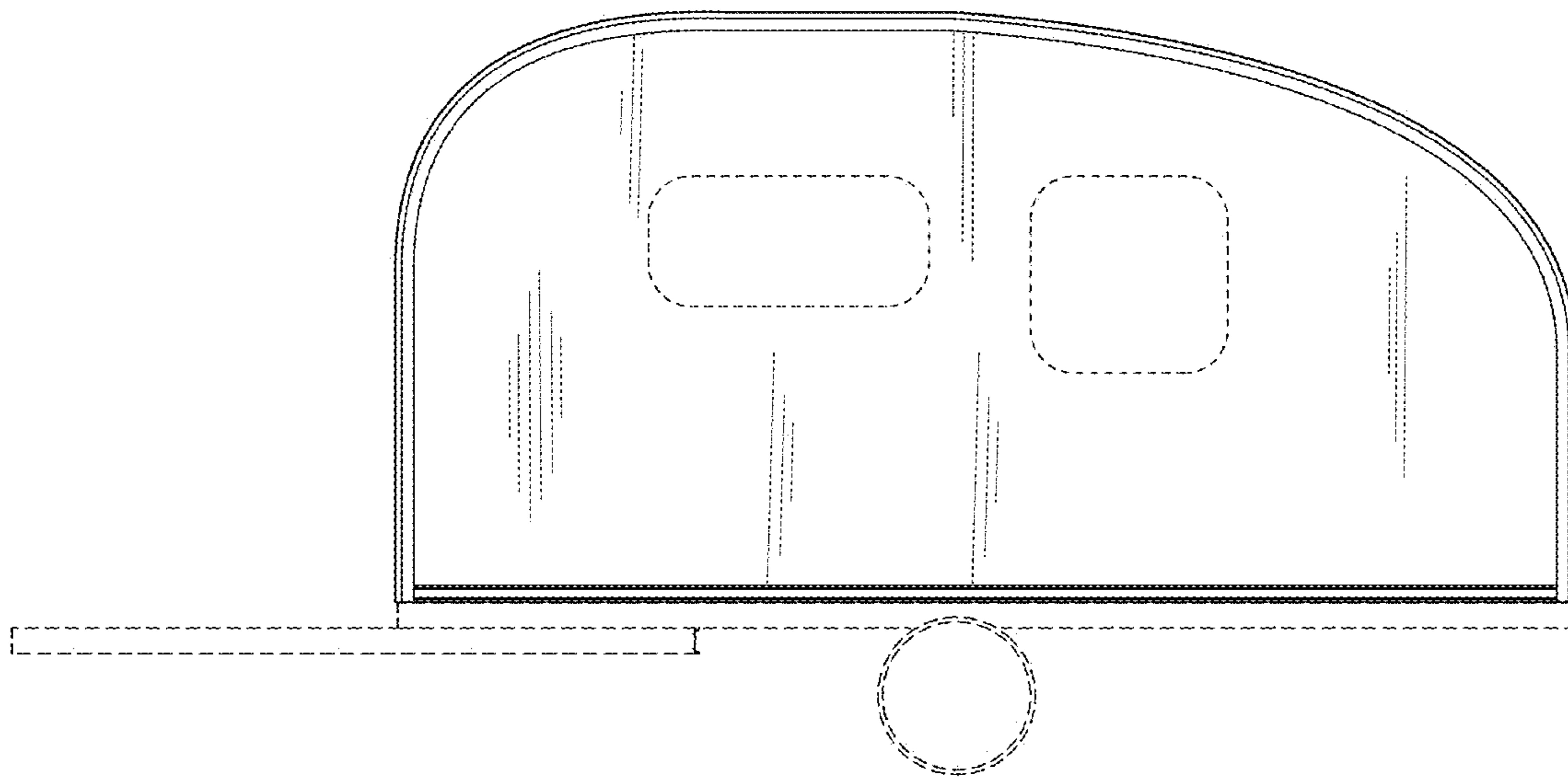

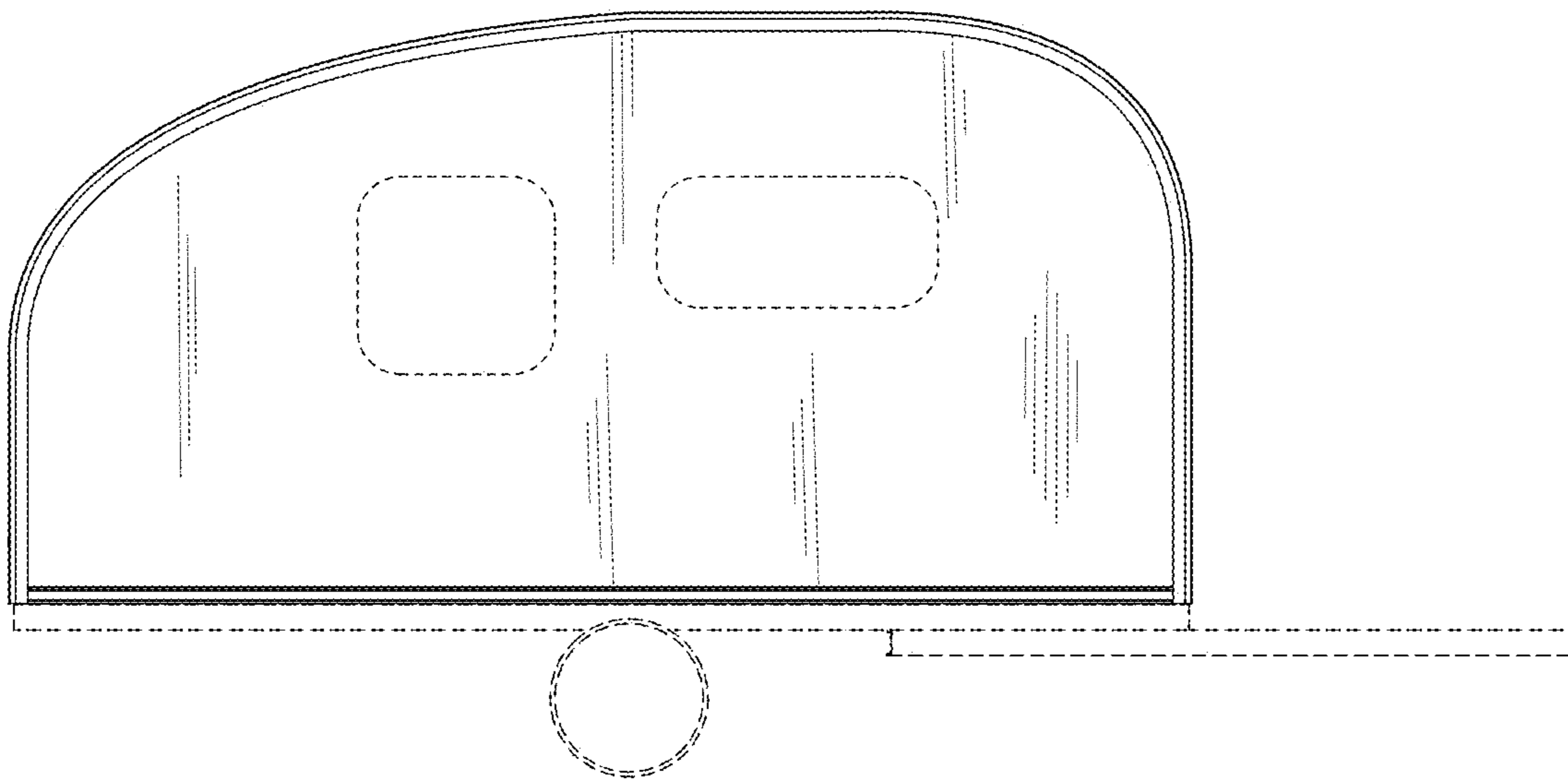

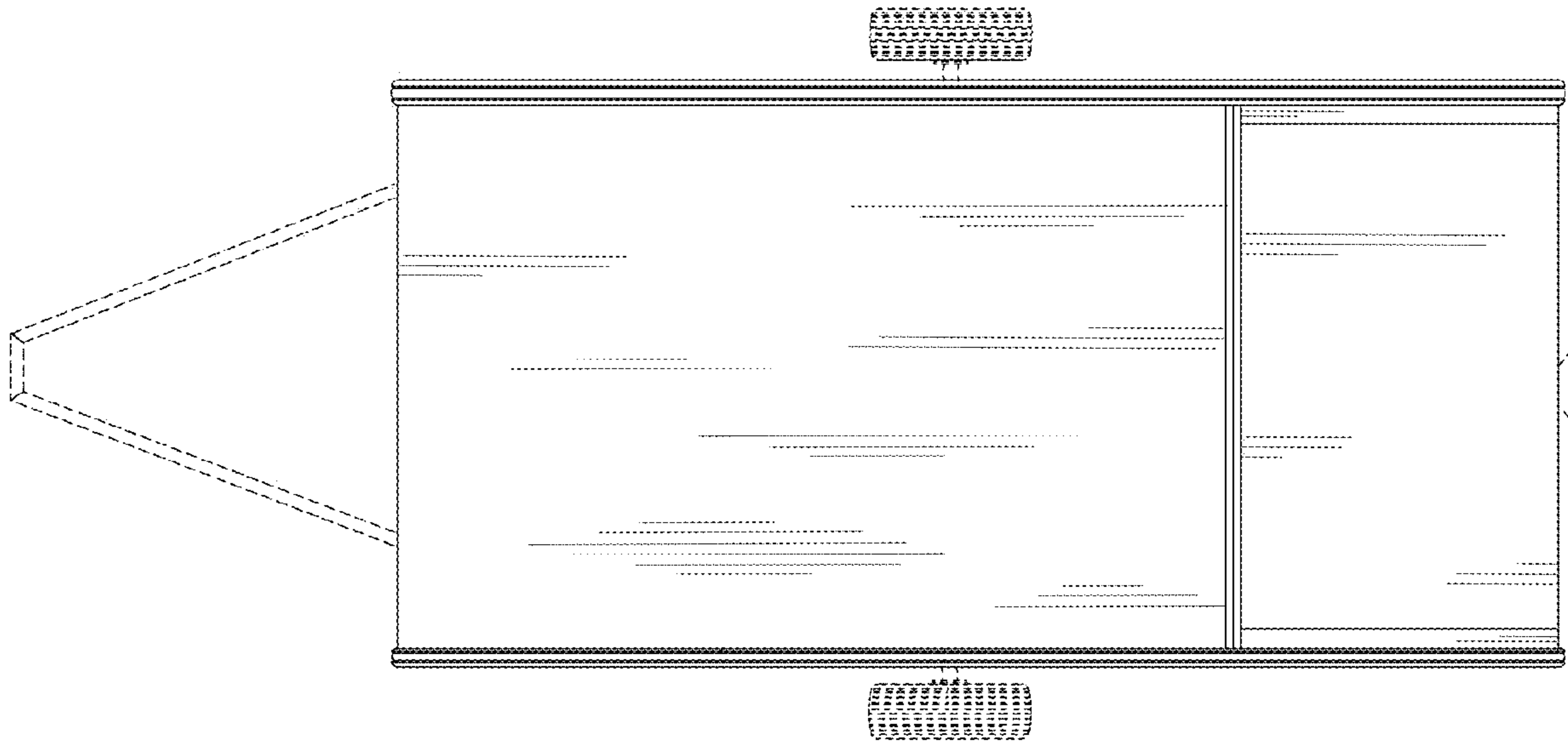

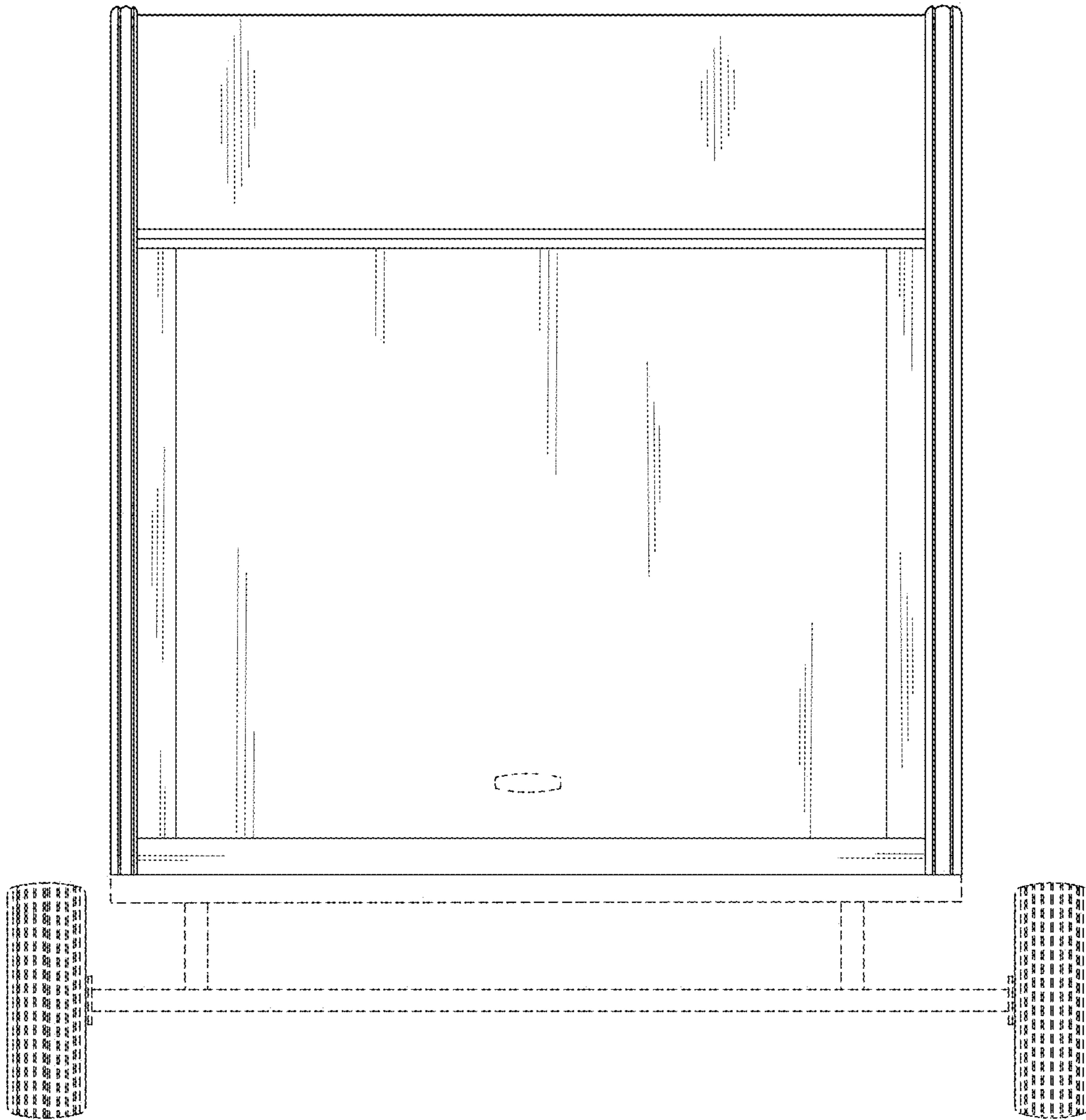

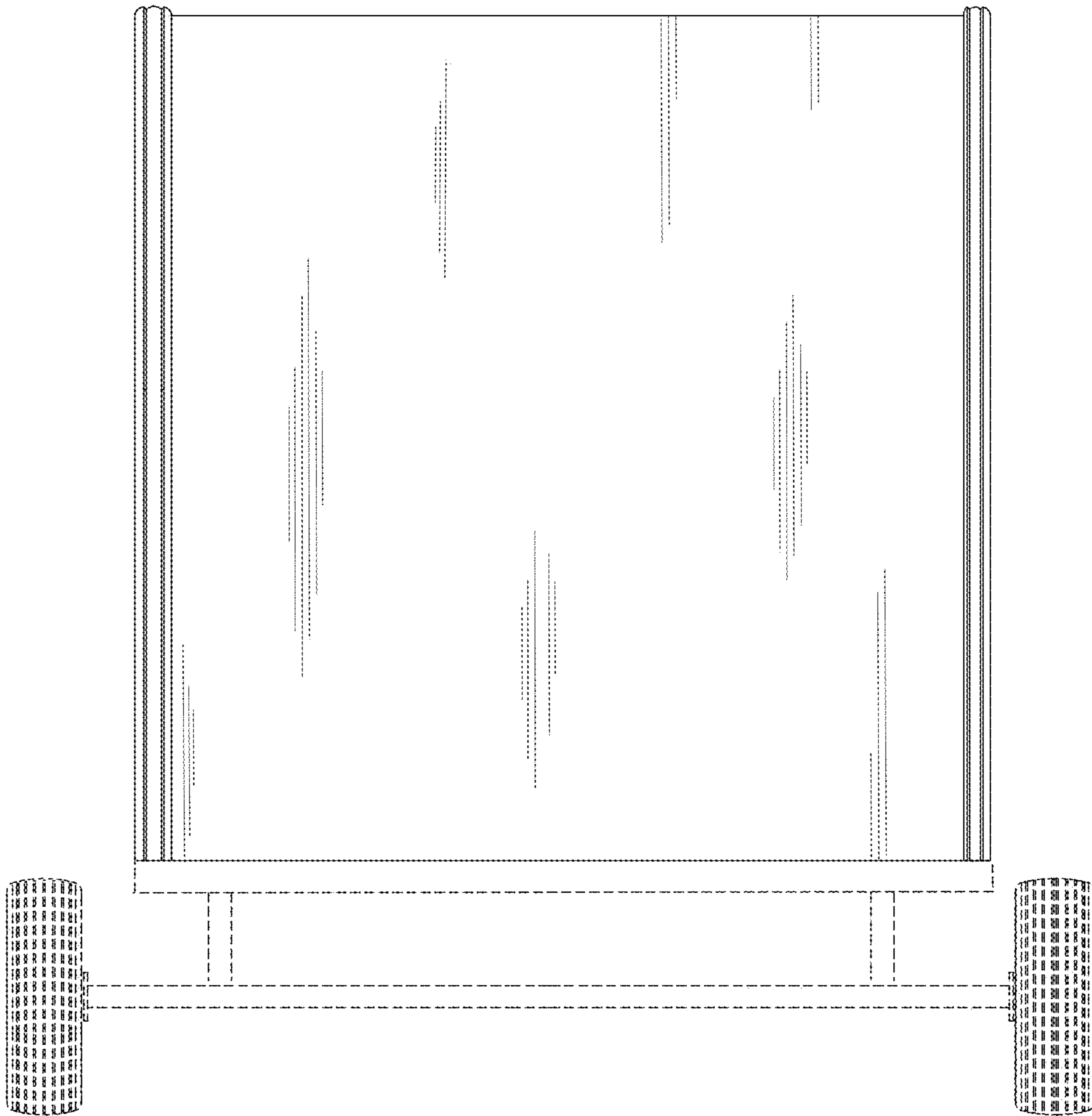

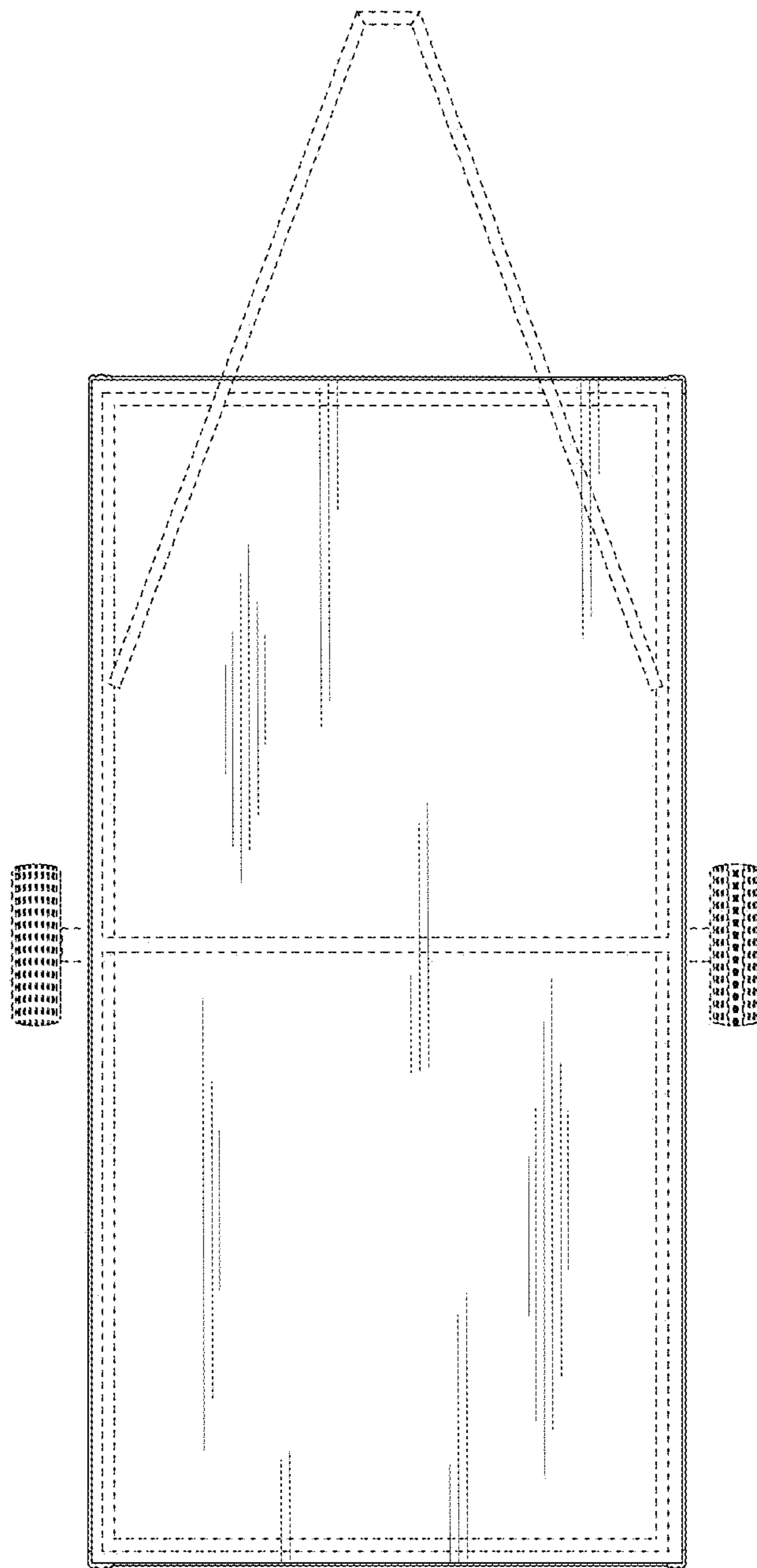
