(57) **CLAIM**

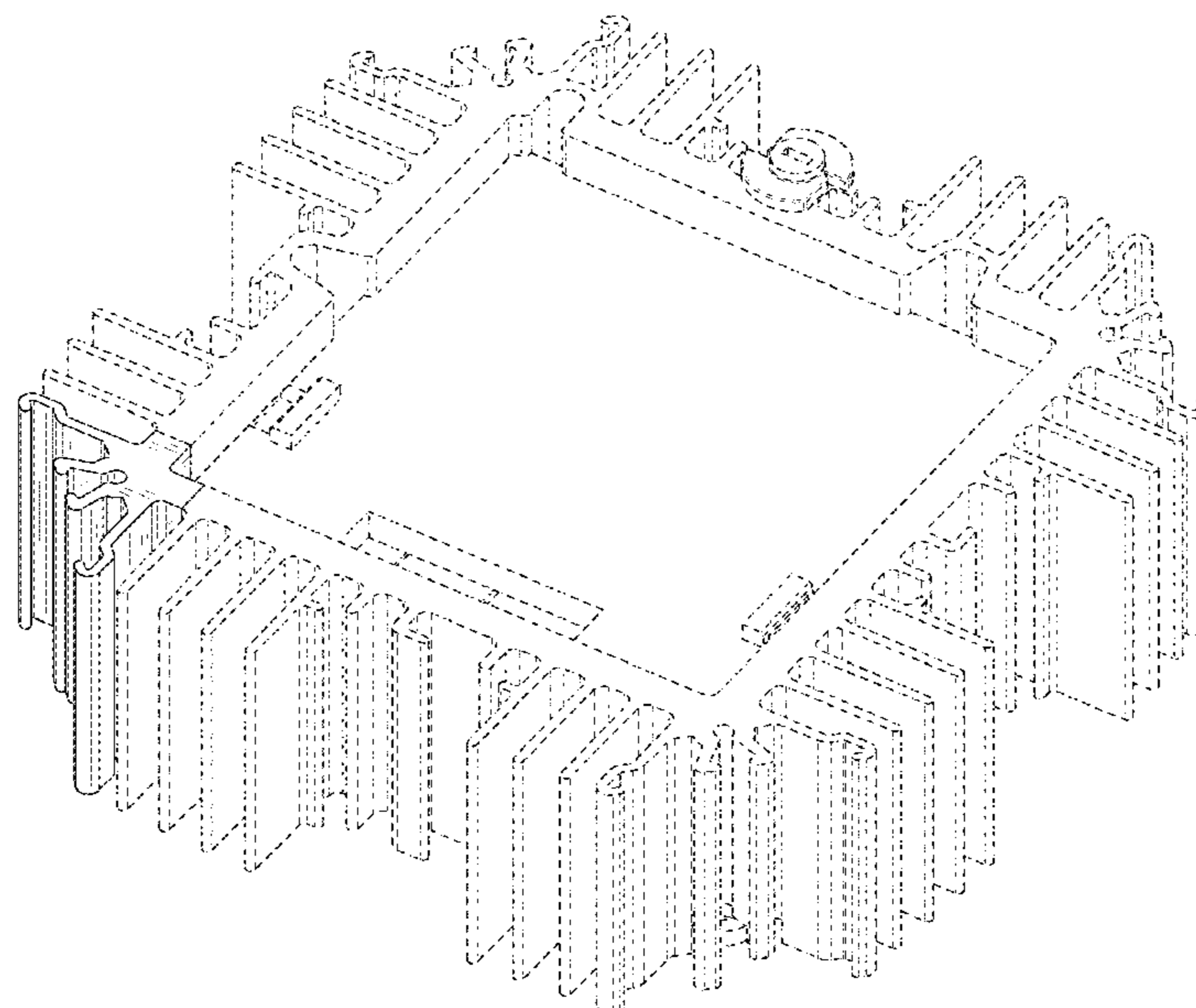
The ornamental design for a heat sink, as shown and described.

DESCRIPTION

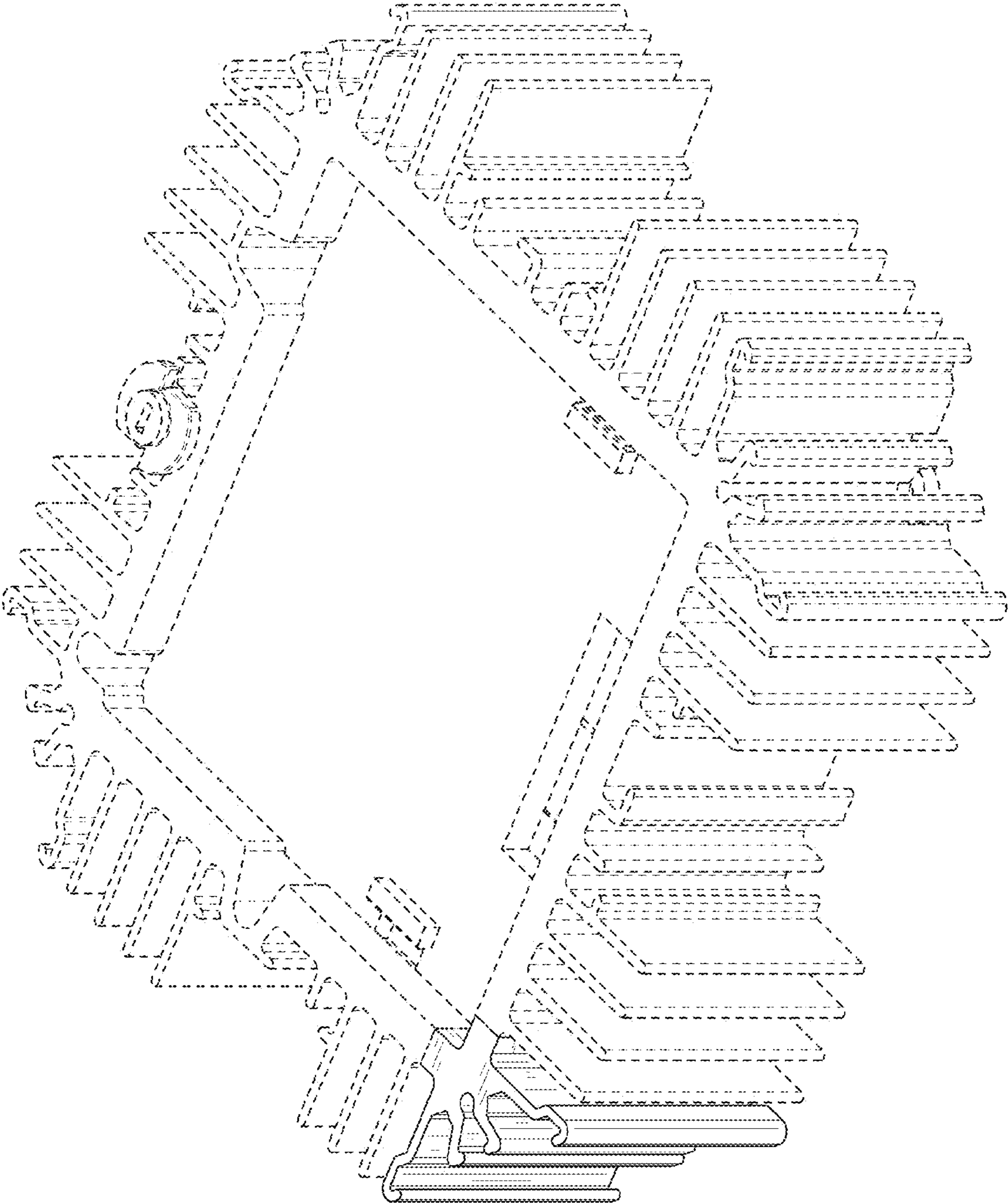

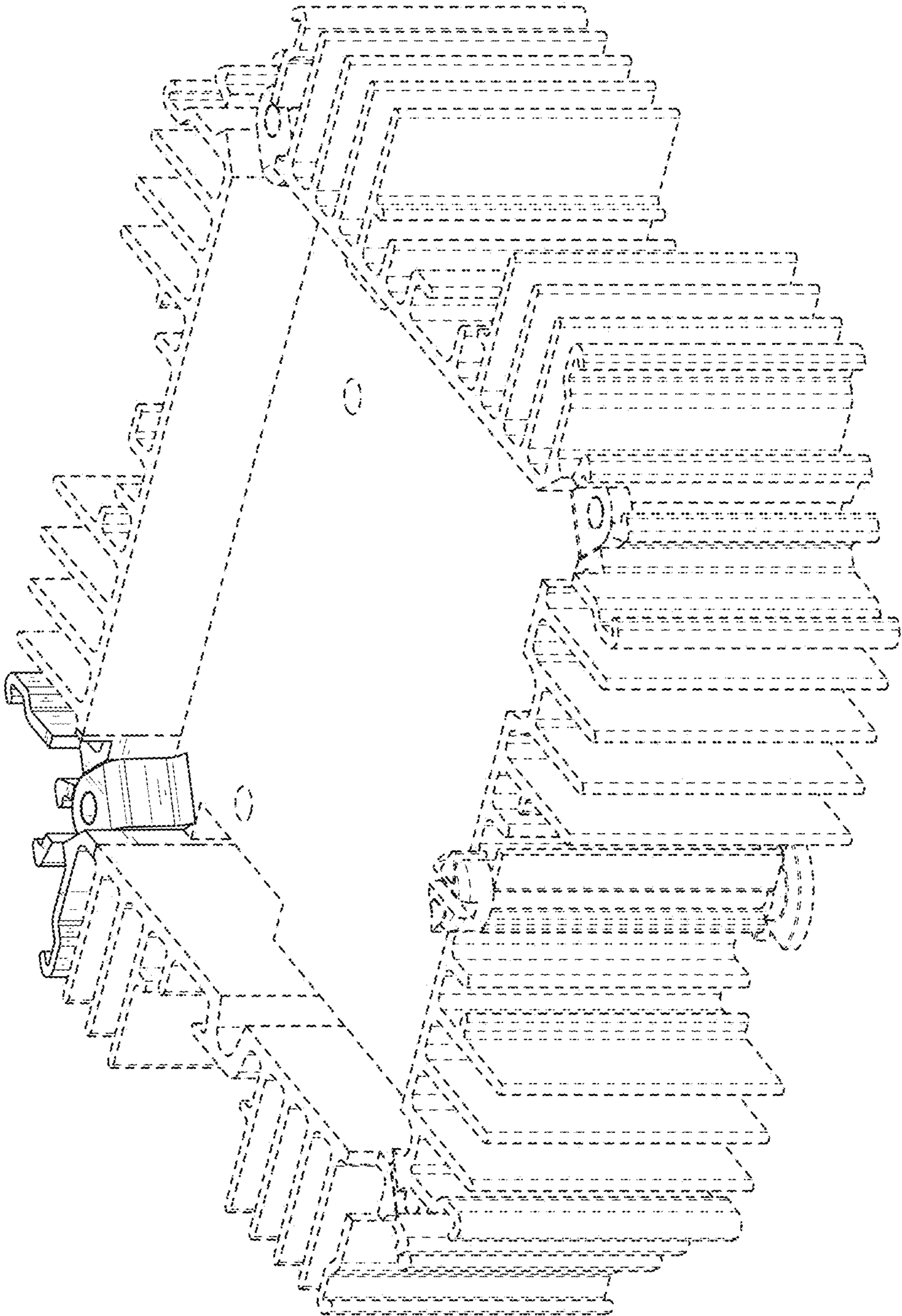

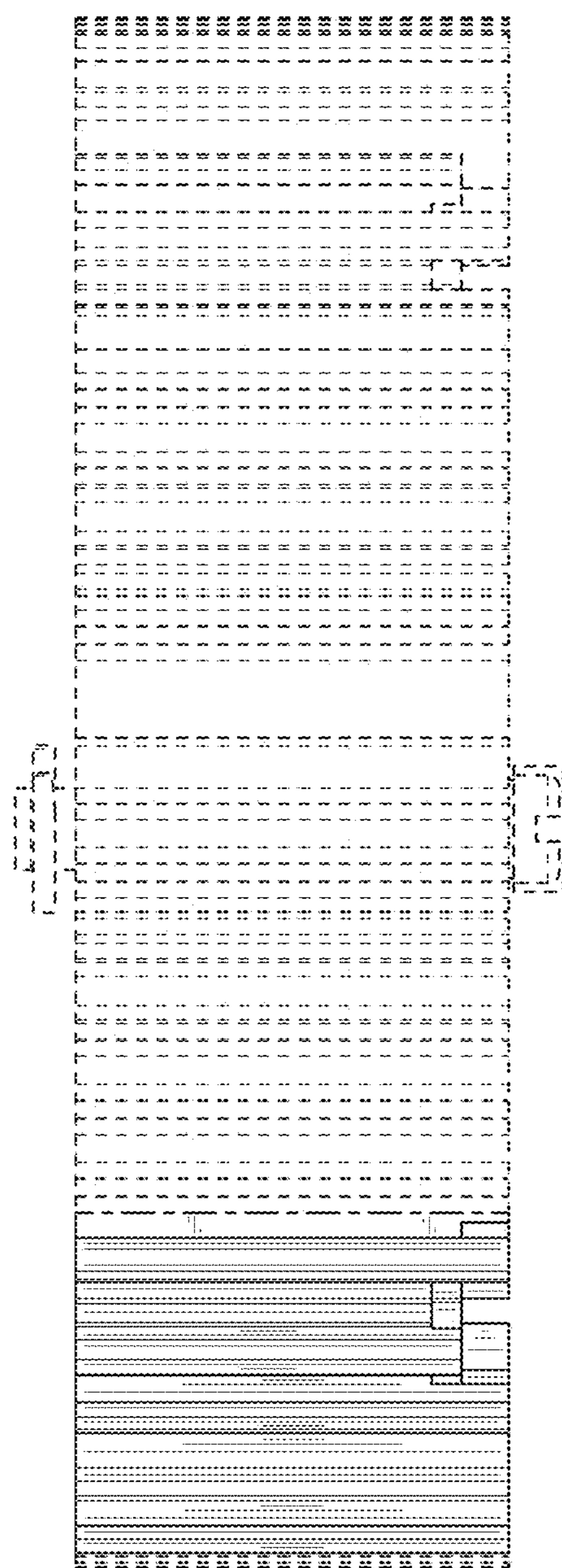

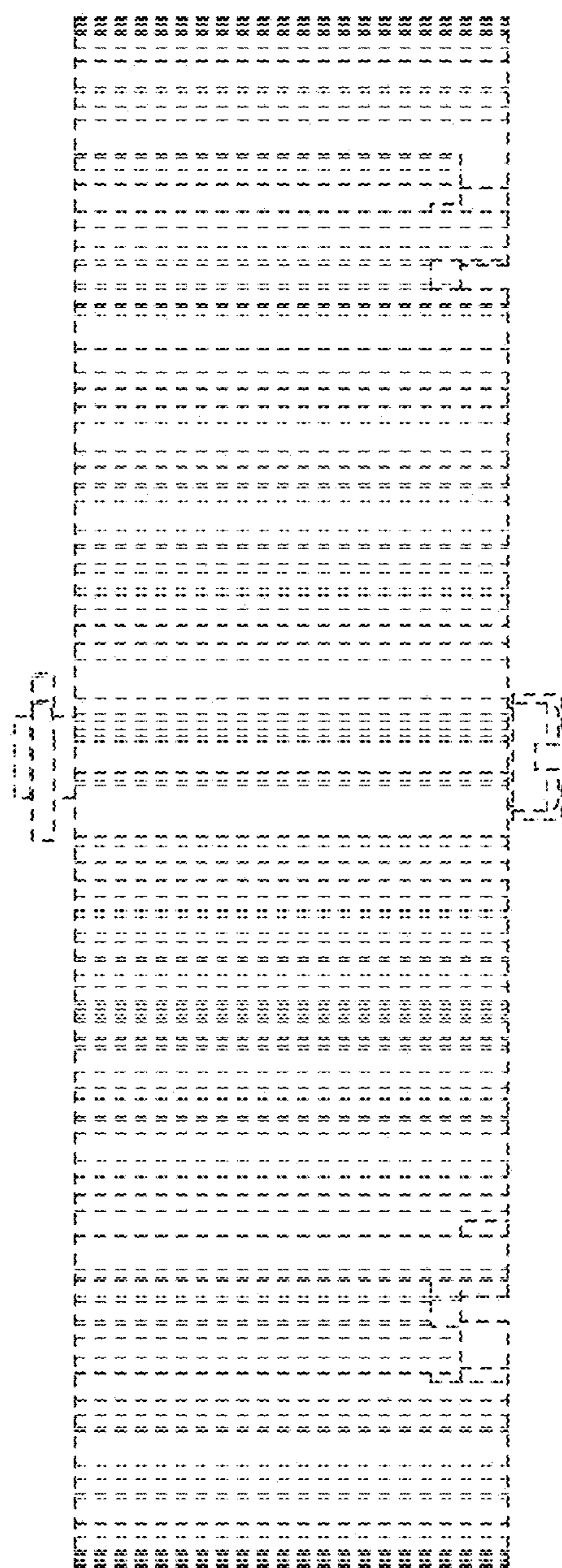

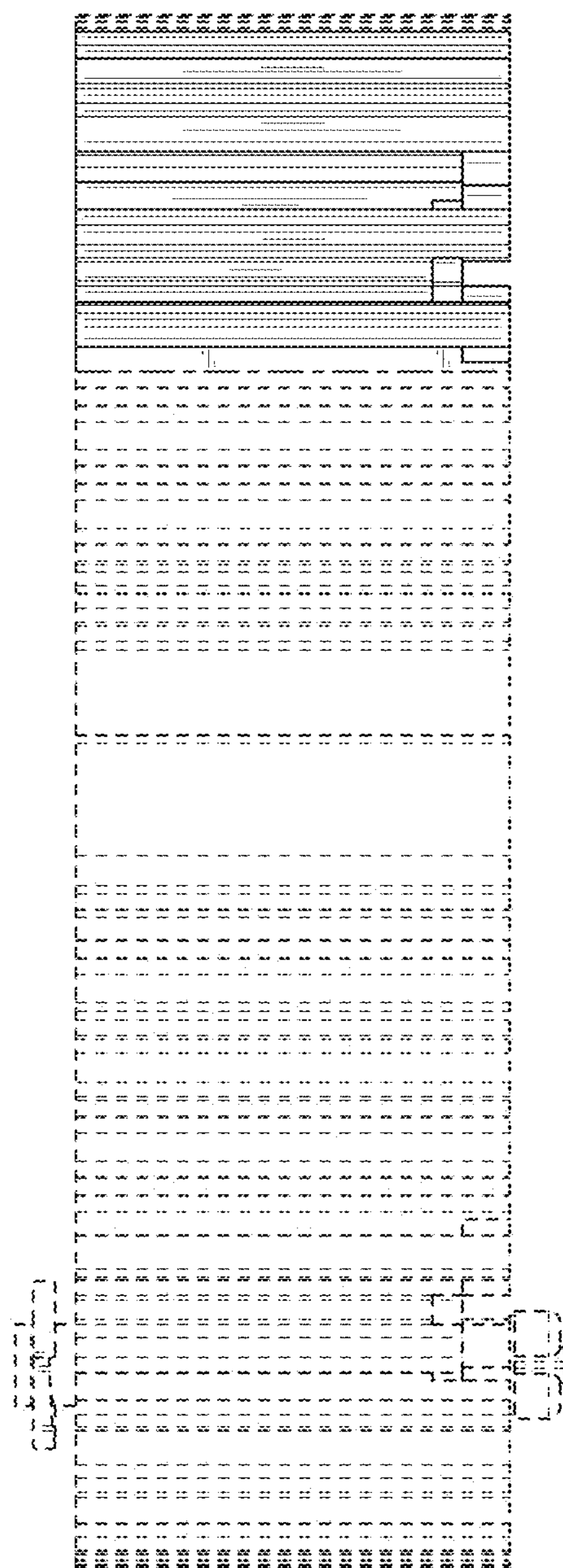

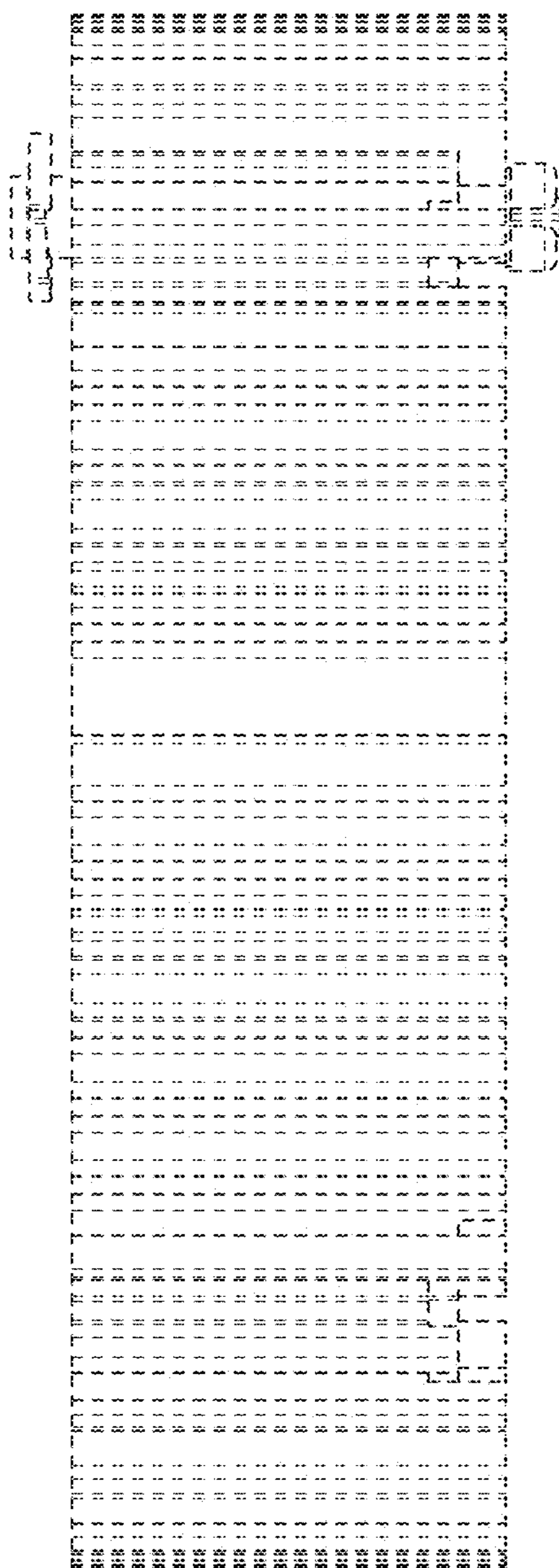

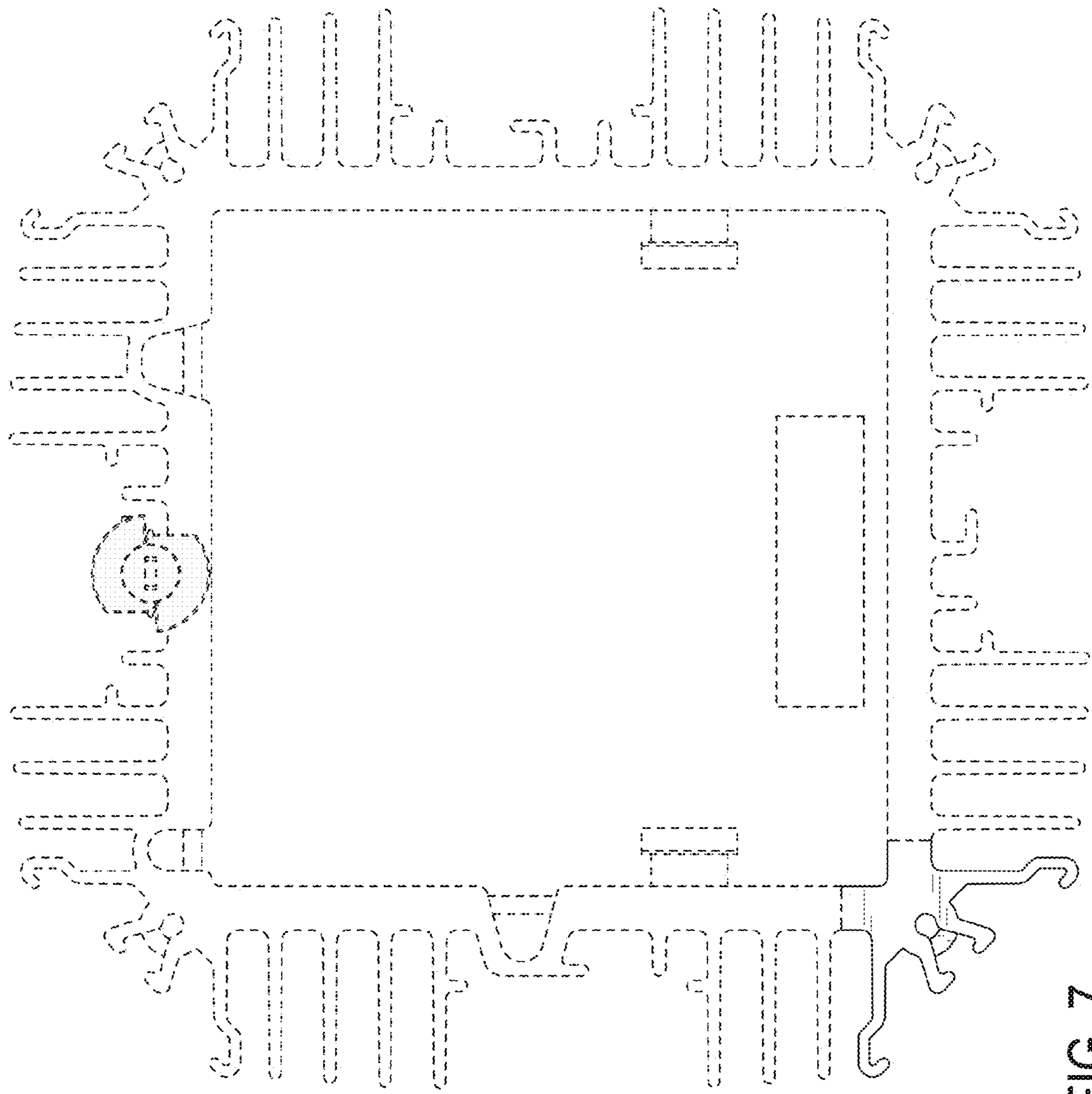

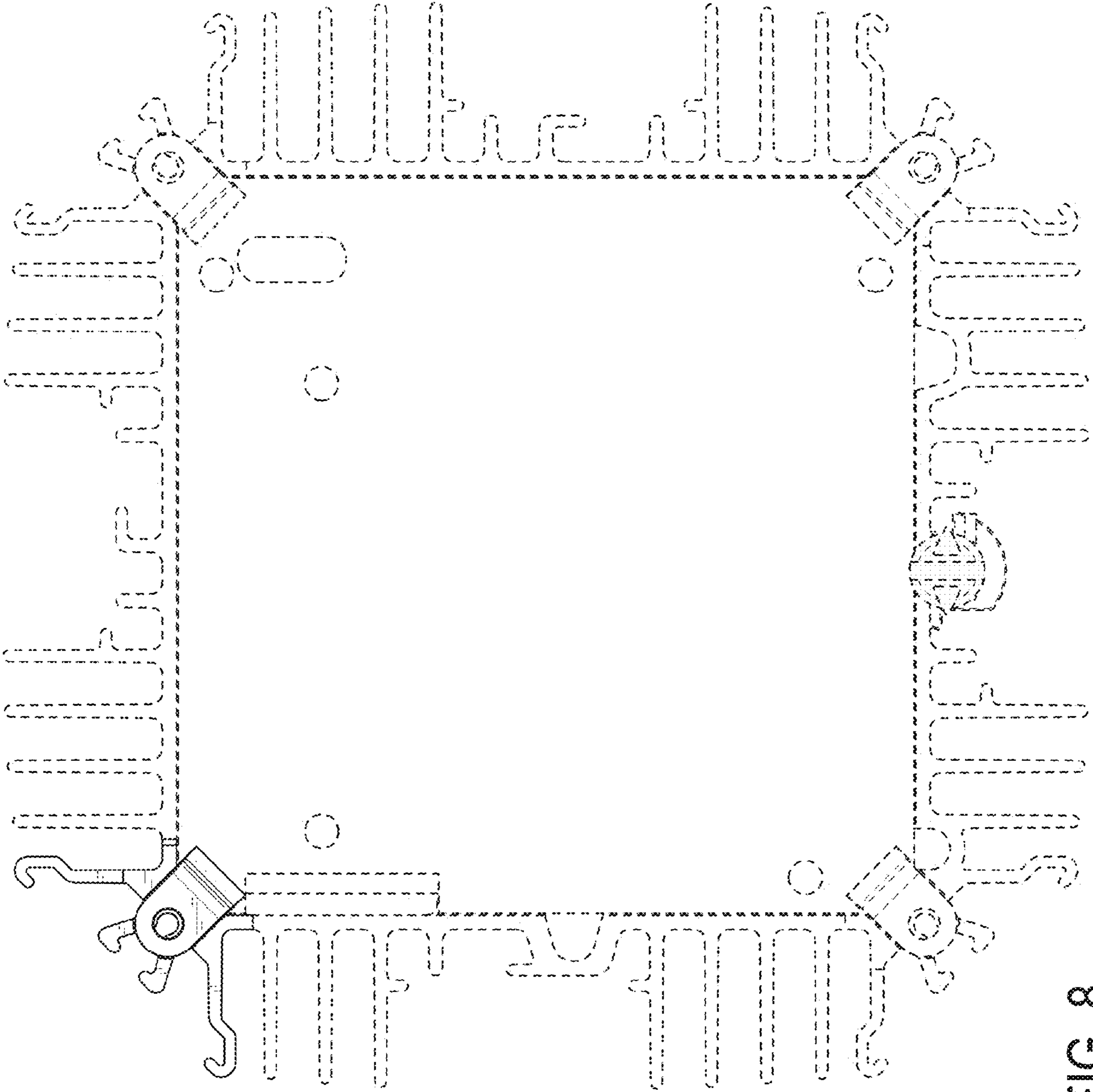
