FIG. 3 is a front view of the shaker arm of FIG. 1.

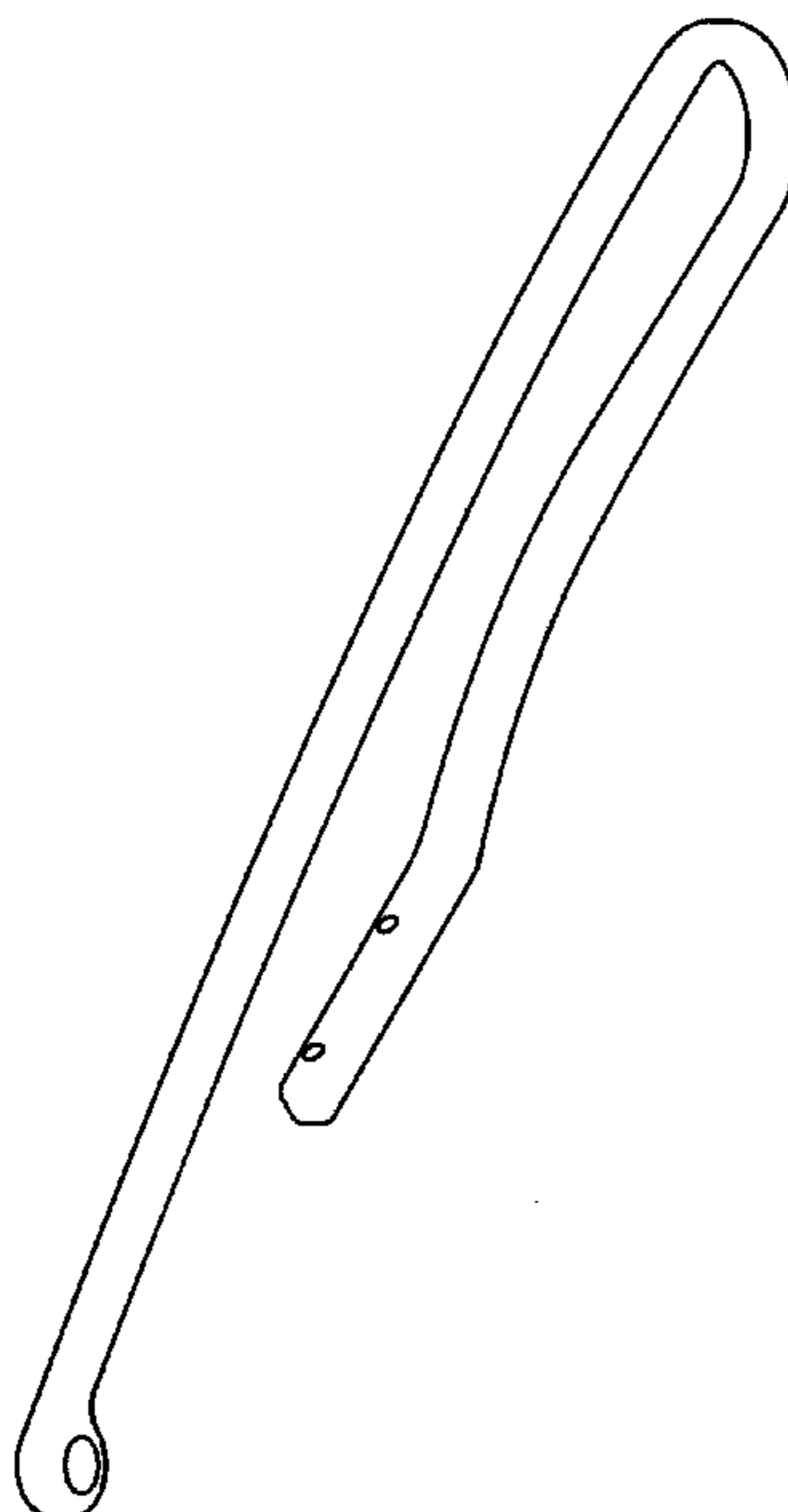
FIG. 4 is a left side view of the shaker arm of FIG. 1.

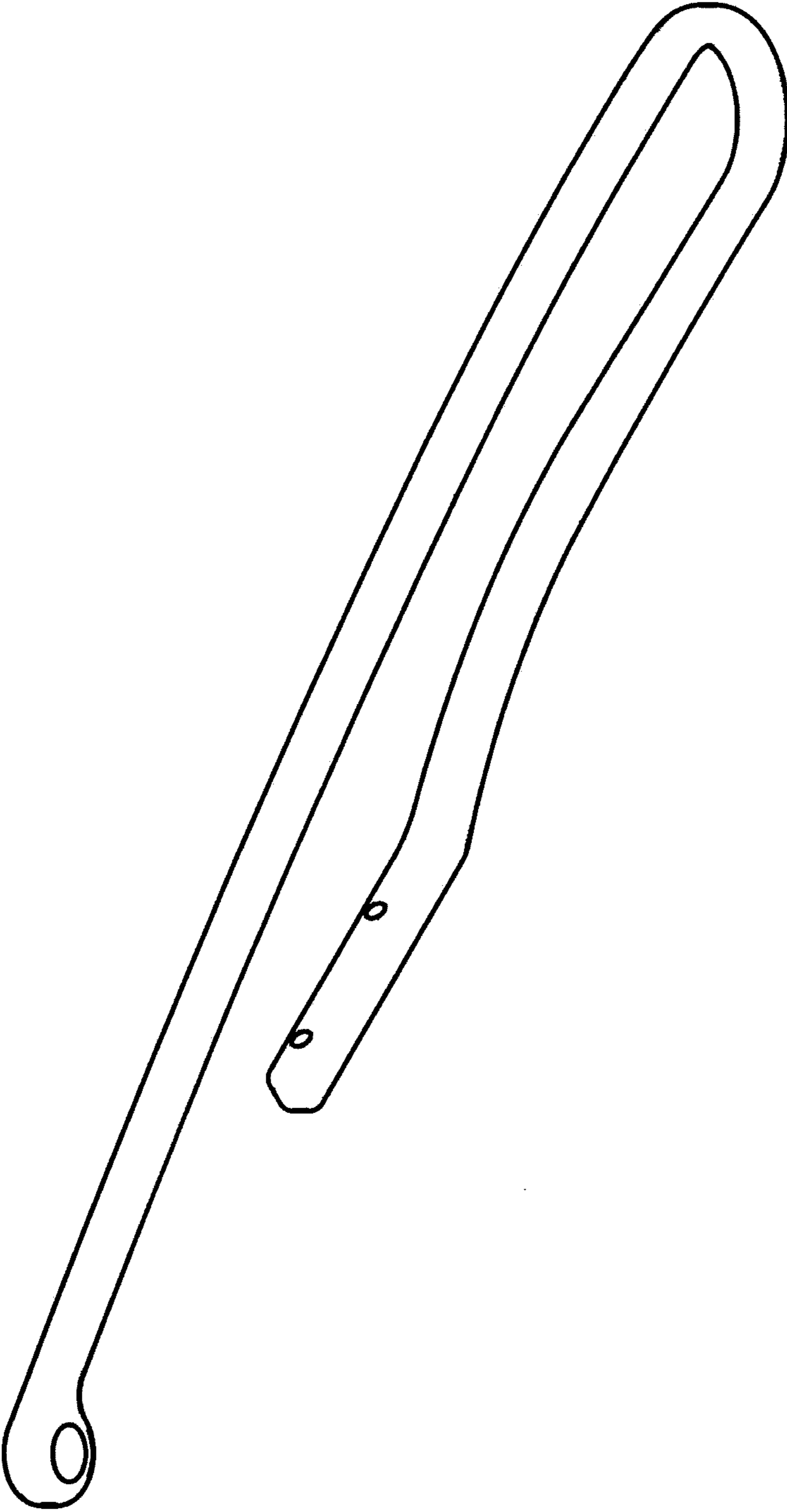

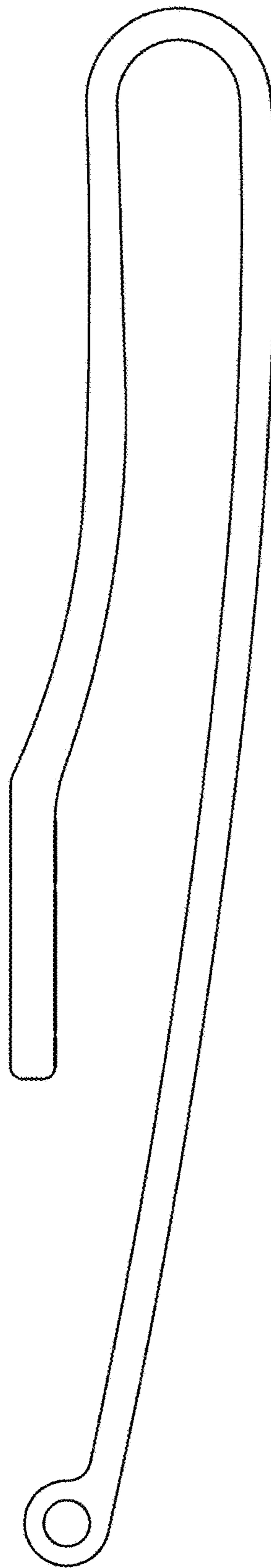

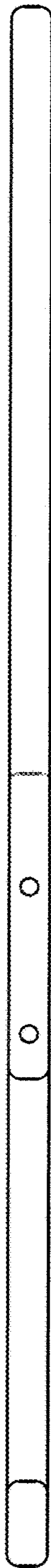

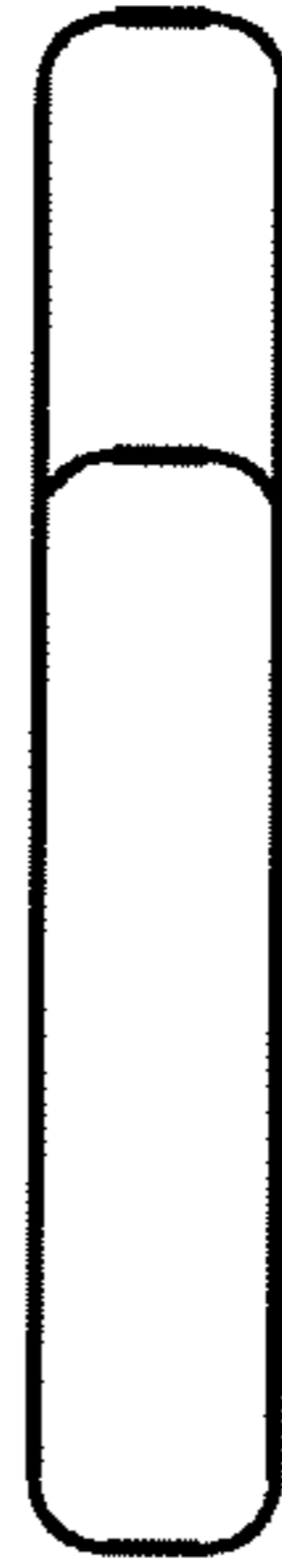

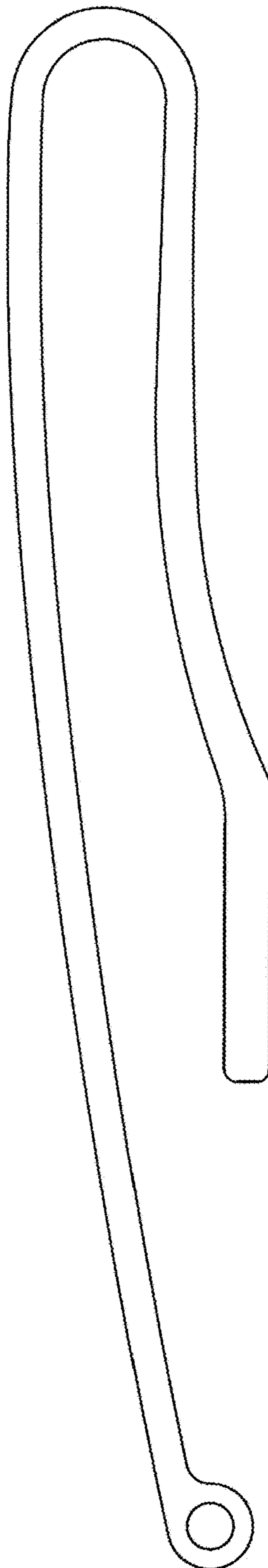
