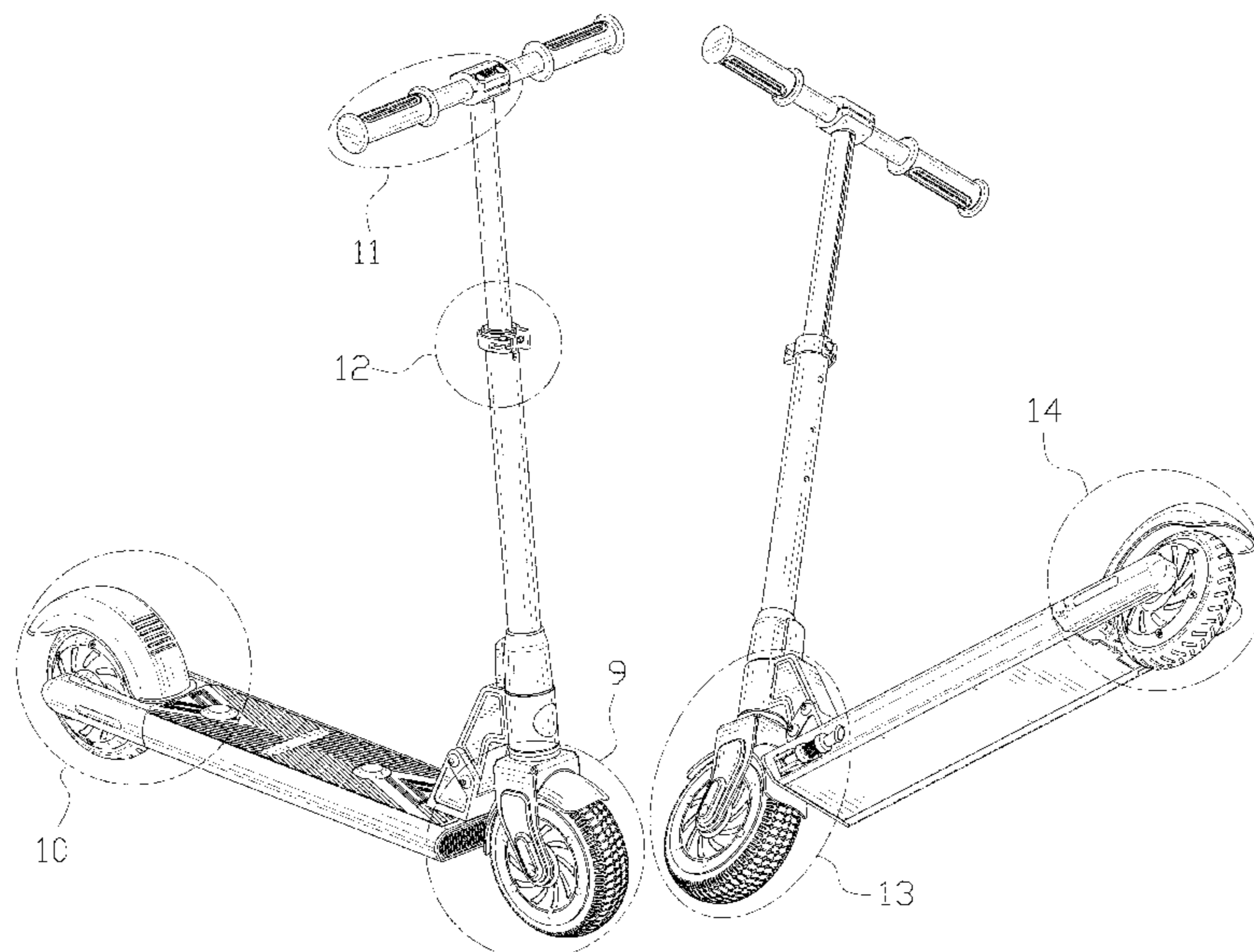
(57) **CLAIM**

The ornamental design for a motorized scooter, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a motorized scooter, showing our new design;
FIG. 2 is a rear and bottom perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof.
FIG. 9 is an enlarged view of a front wheel in FIG. 1;
FIG. 10 is an enlarged view of a rear wheel in FIG. 1;
FIG. 11 is an enlarged view of a handle in FIG. 1;
FIG. 12 is an enlarged view of a connector in FIG. 1;
FIG. 13 is an enlarged view of a front wheel in FIGS. 2; and
FIG. 14 is an enlarged view of a rear wheel in FIG. 2.

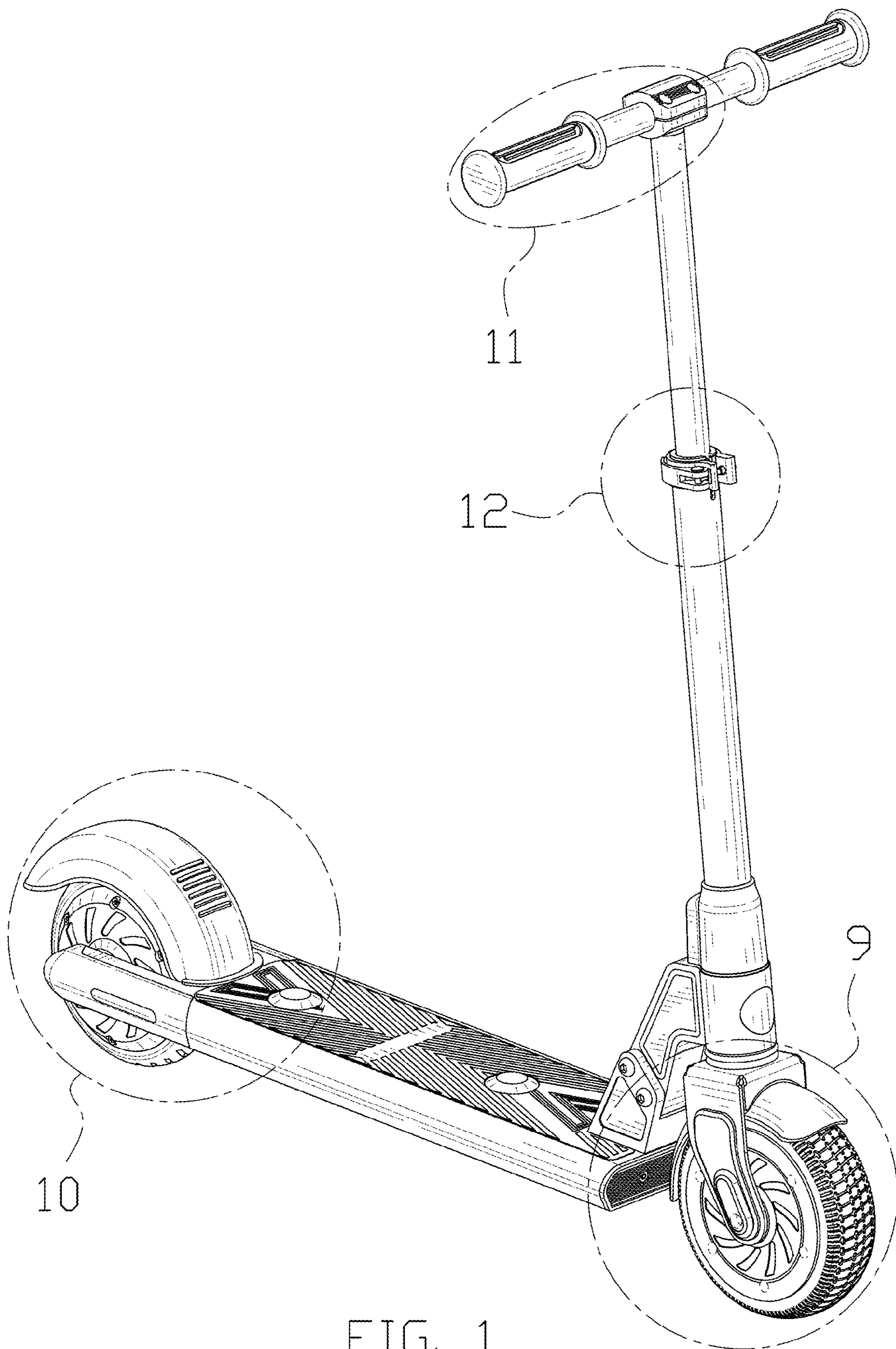

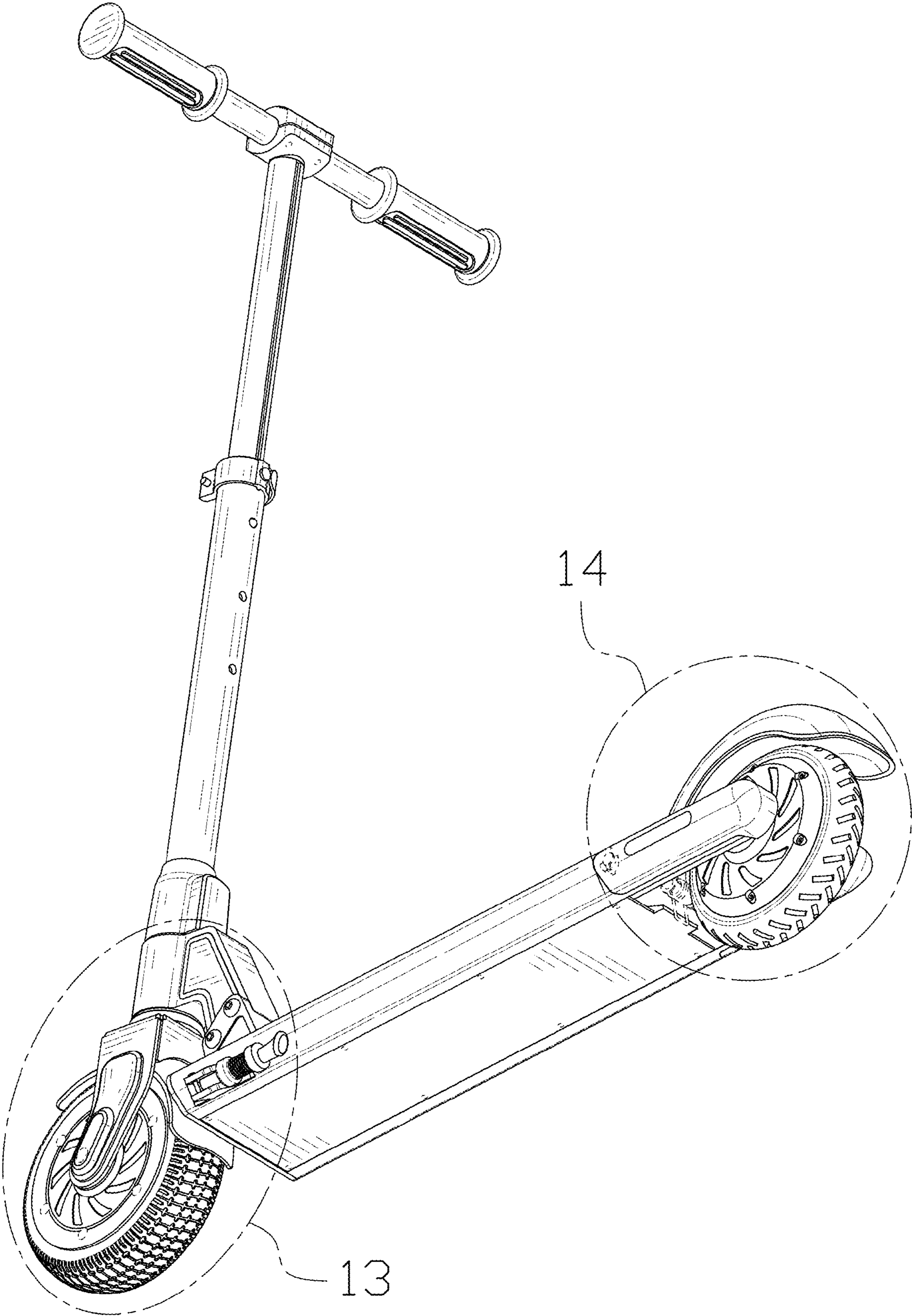

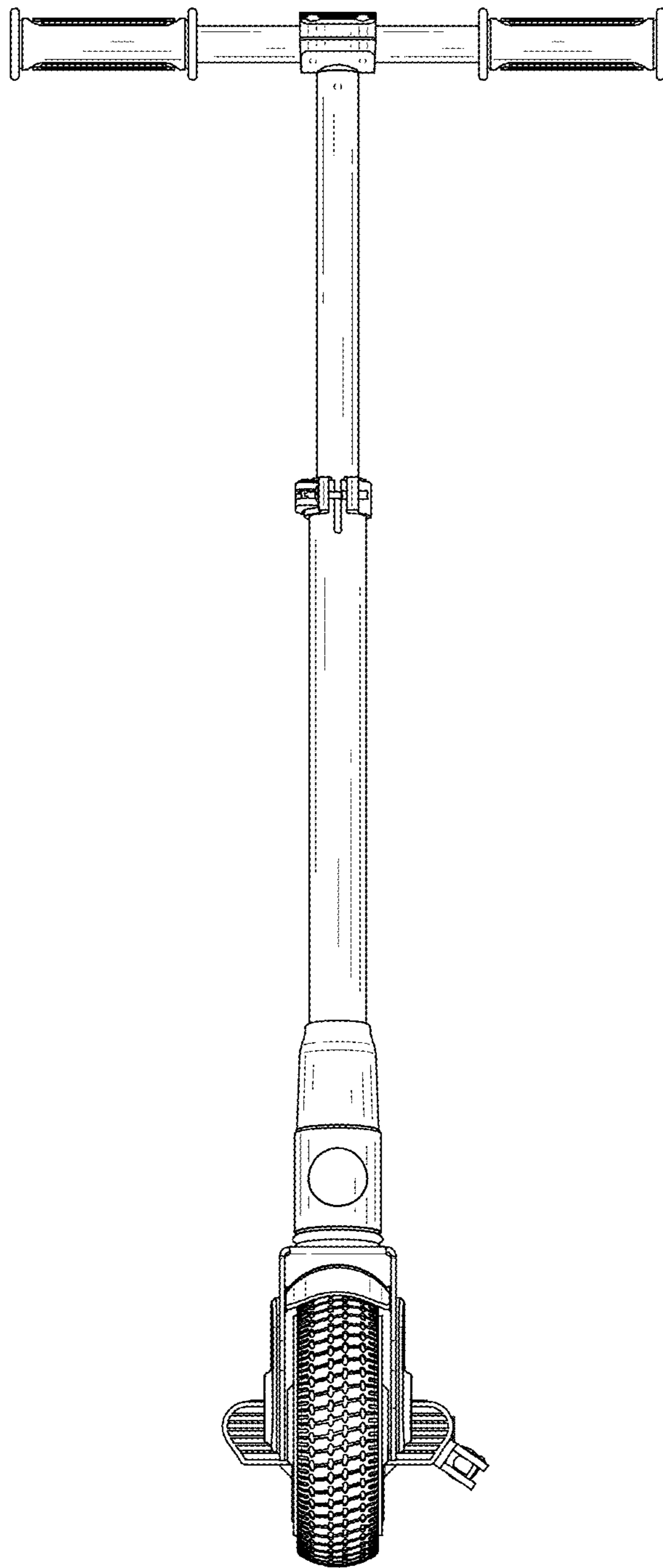

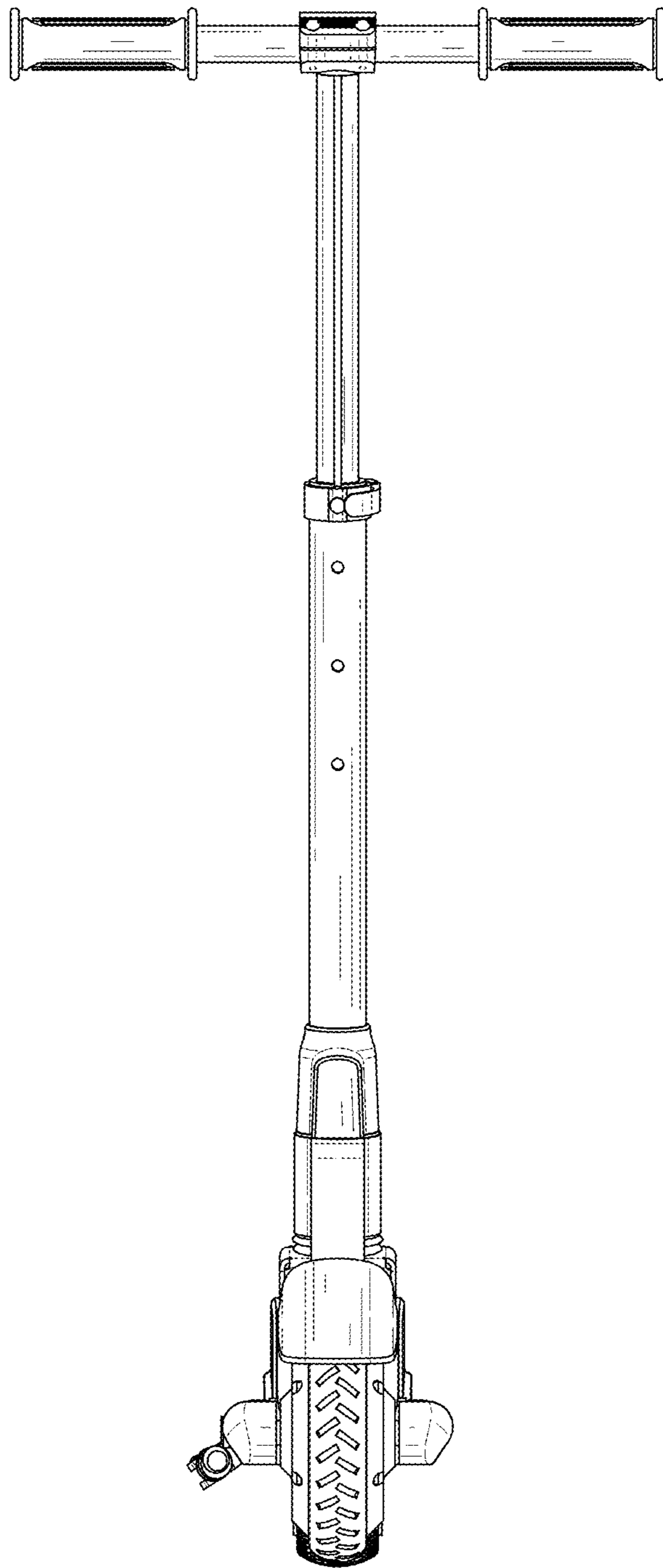

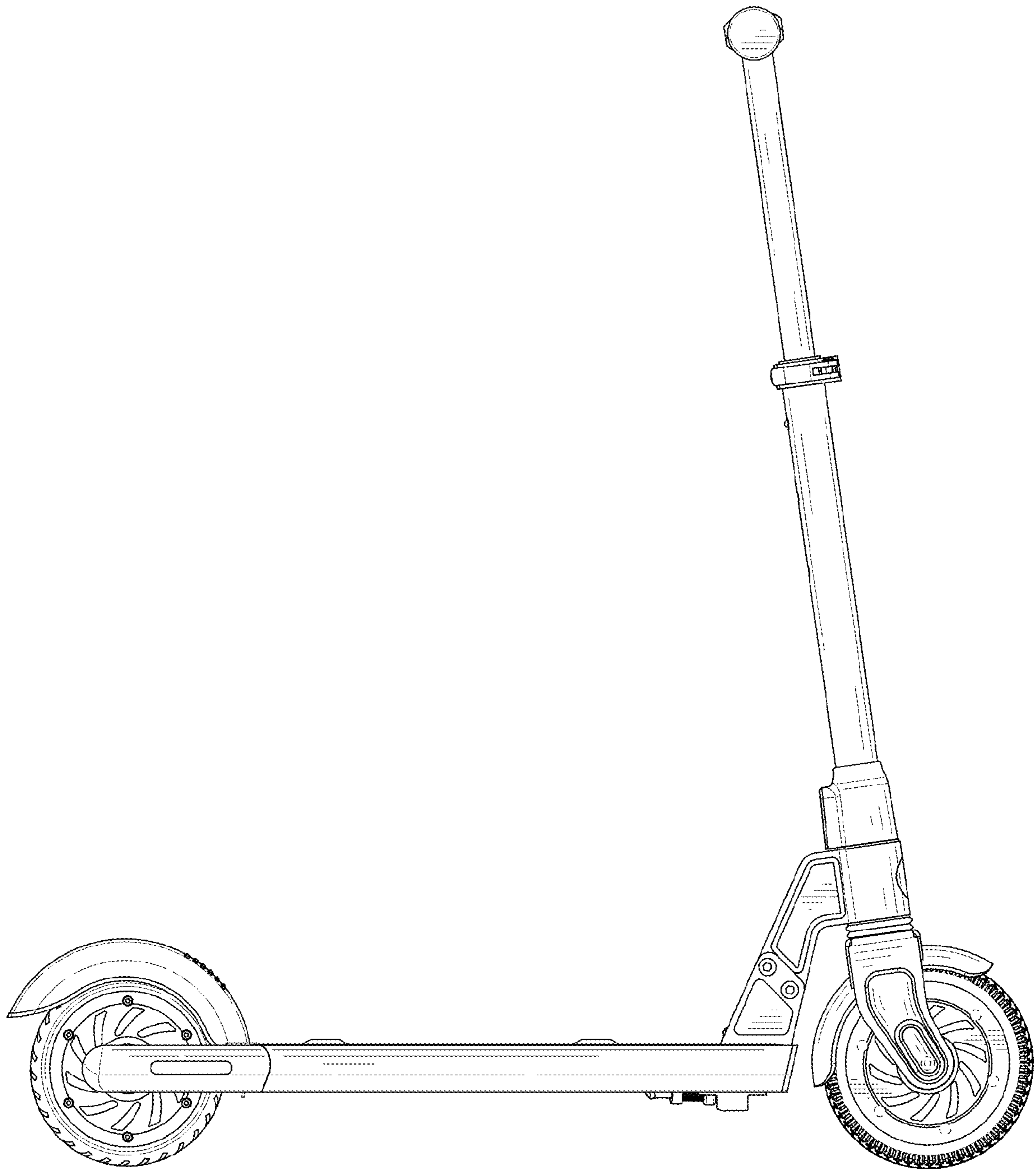

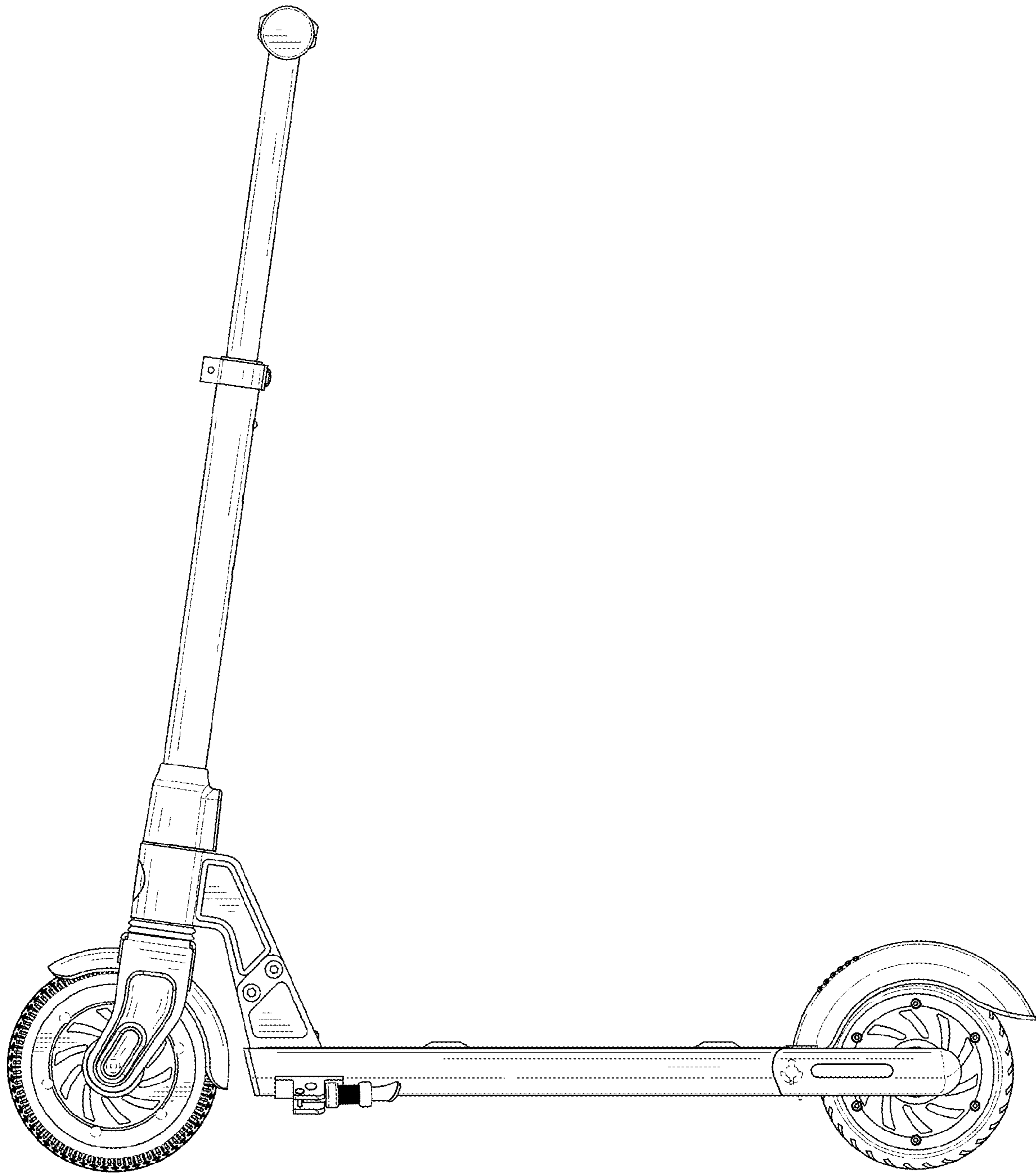

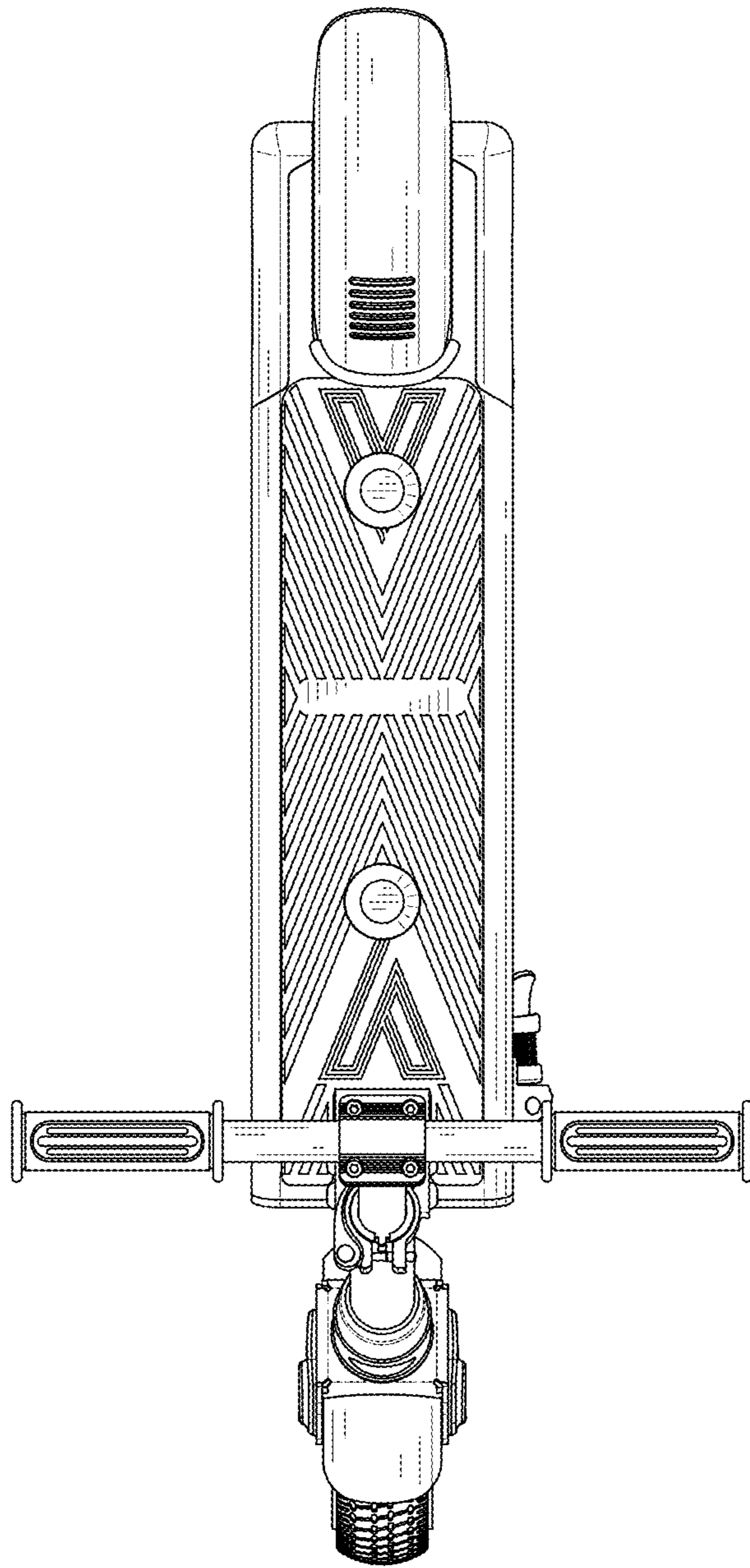

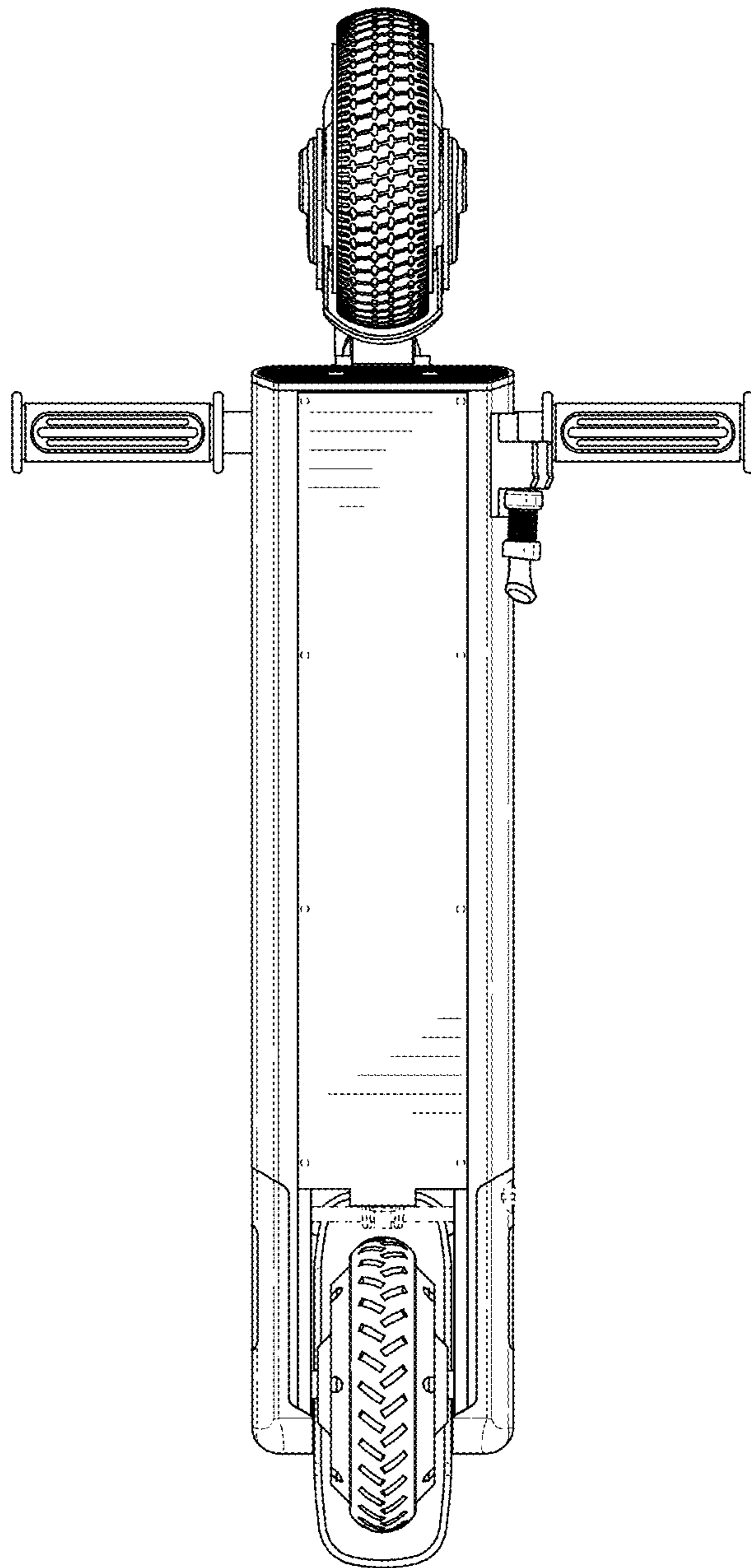

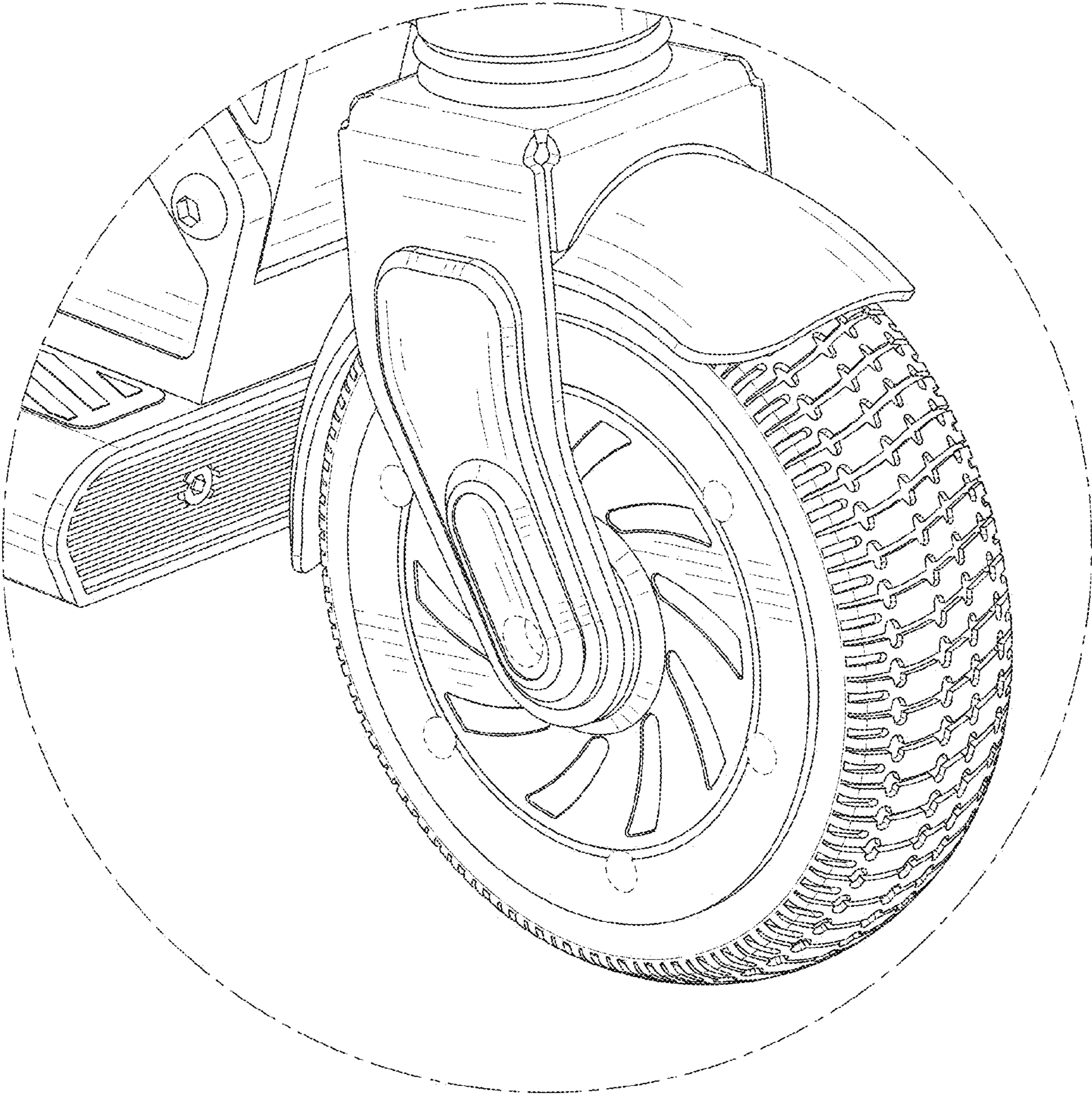

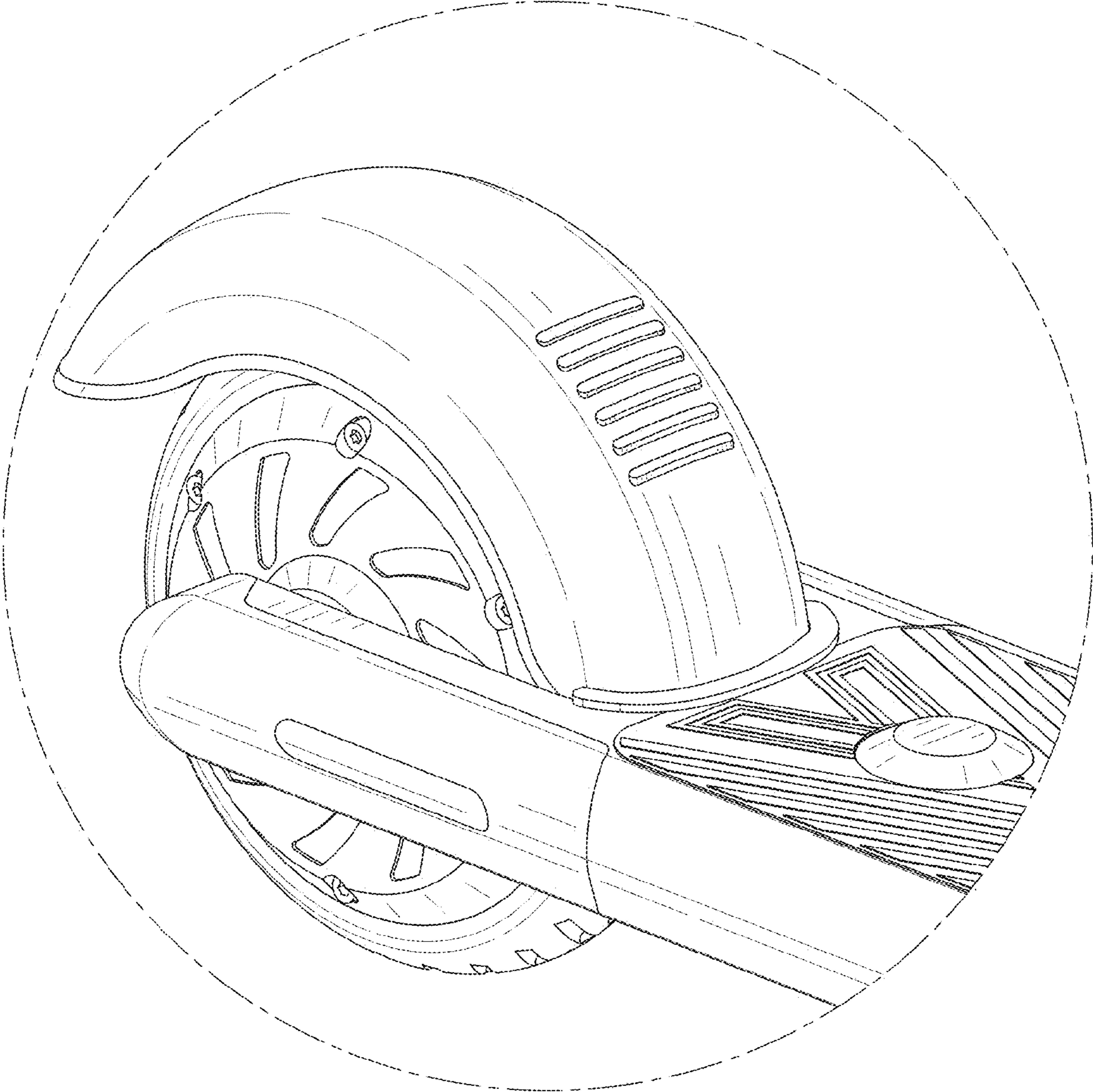

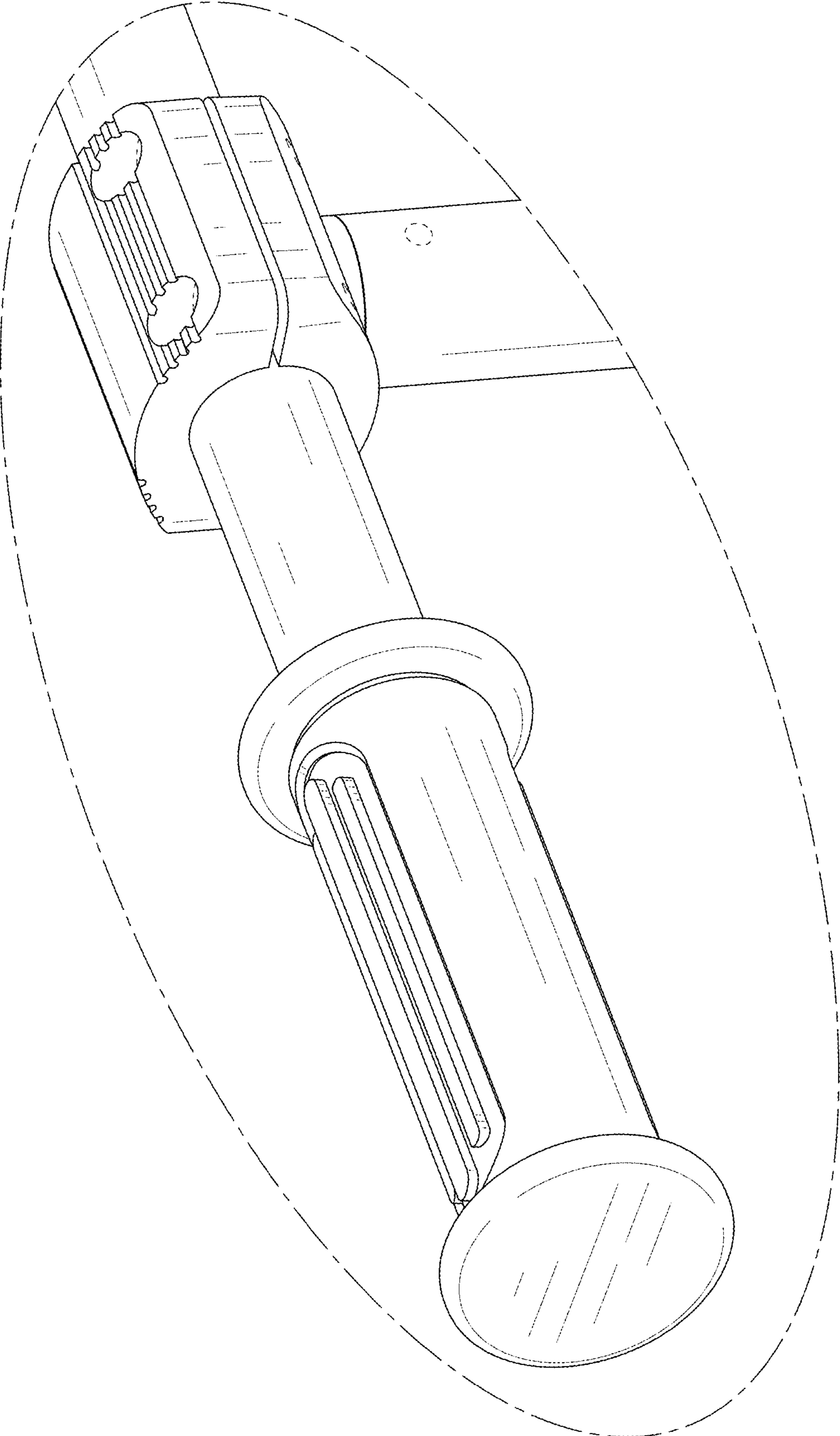

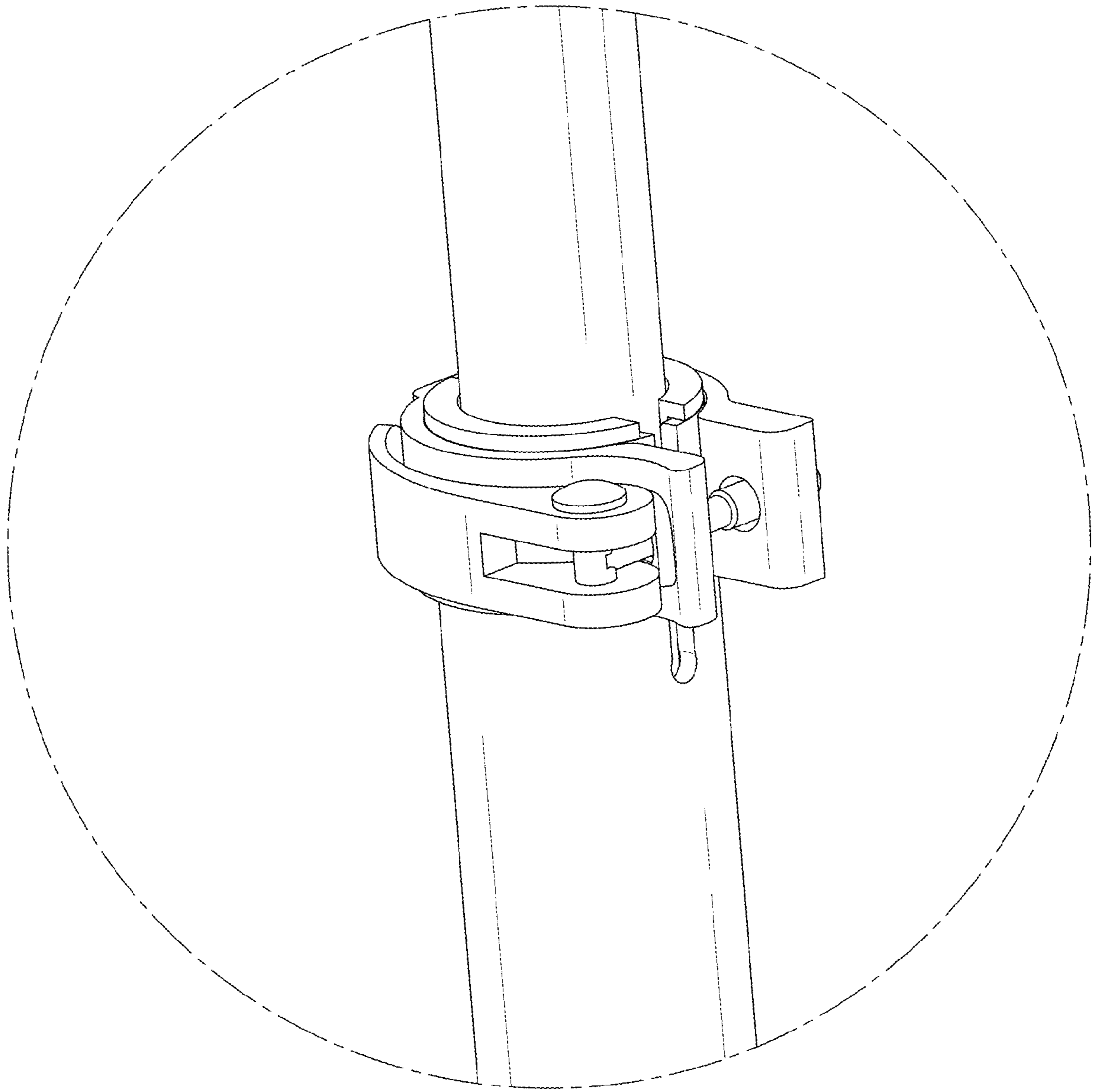

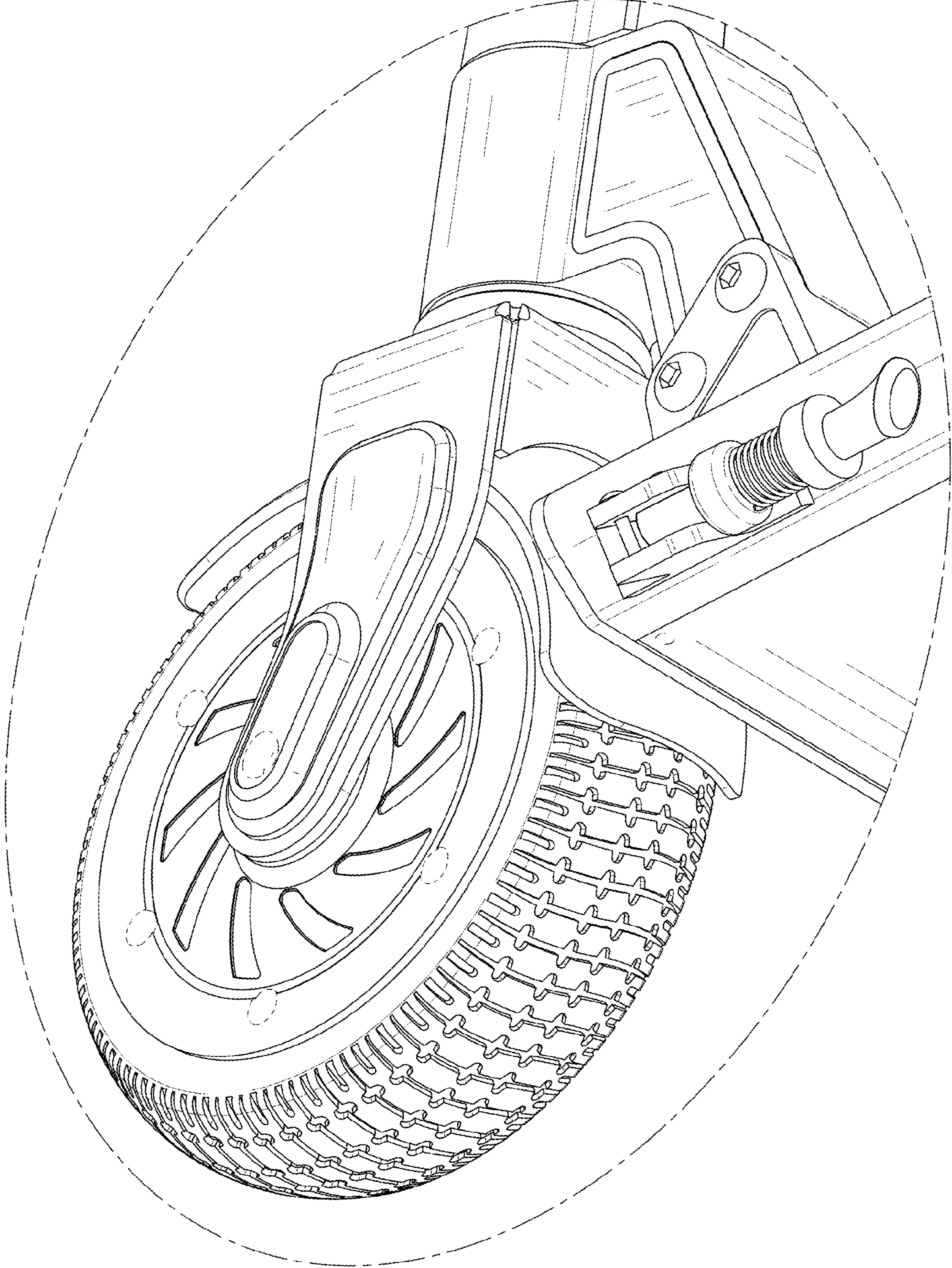

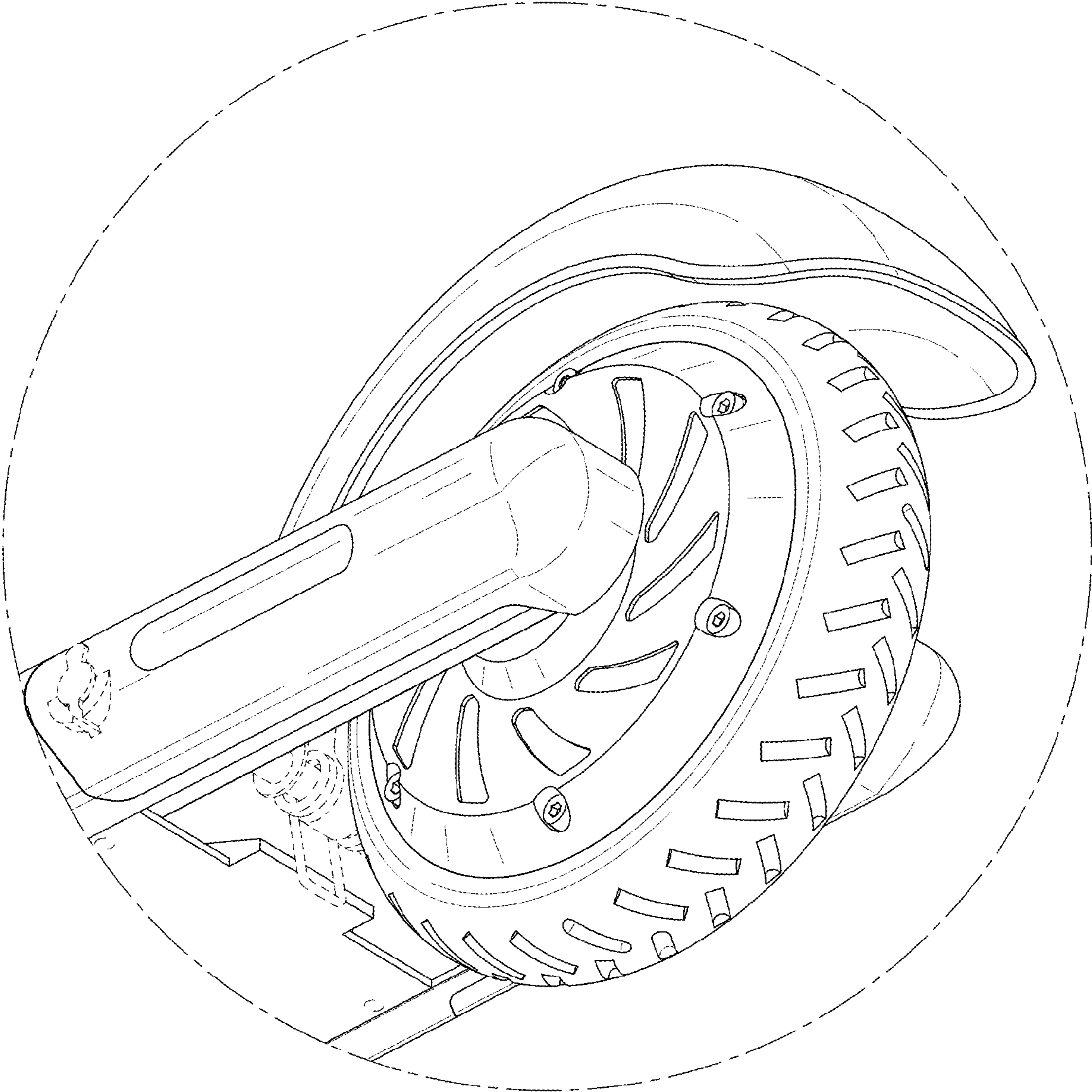
