(57) **CLAIM**

What is claimed is the ornamental design for a tattoo needle holder, as shown and described.

DESCRIPTION

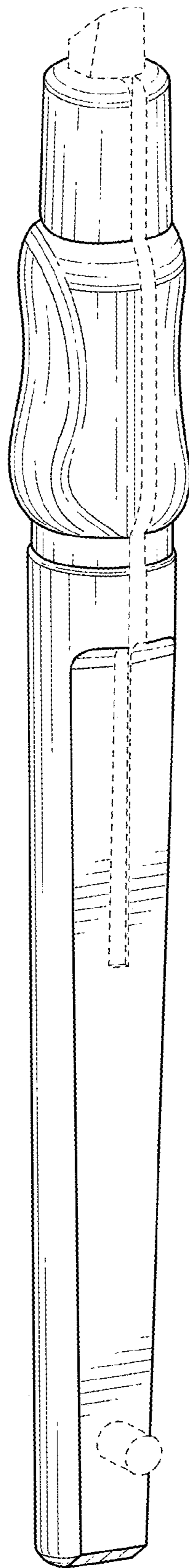

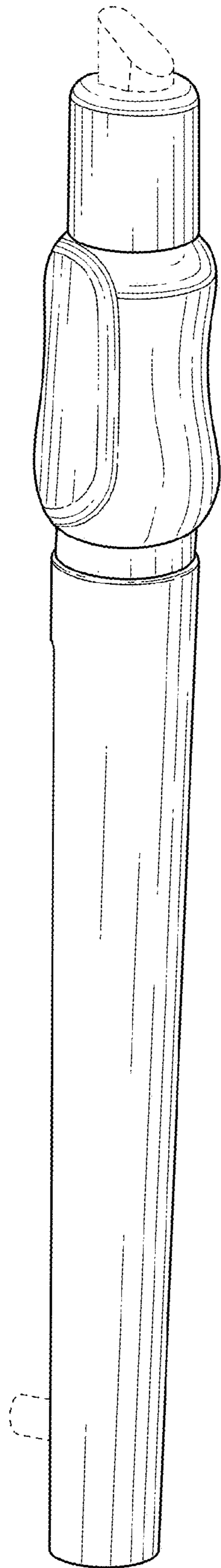

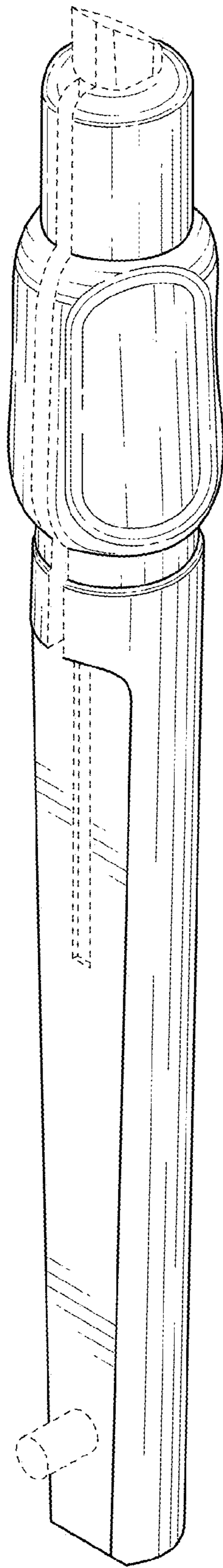

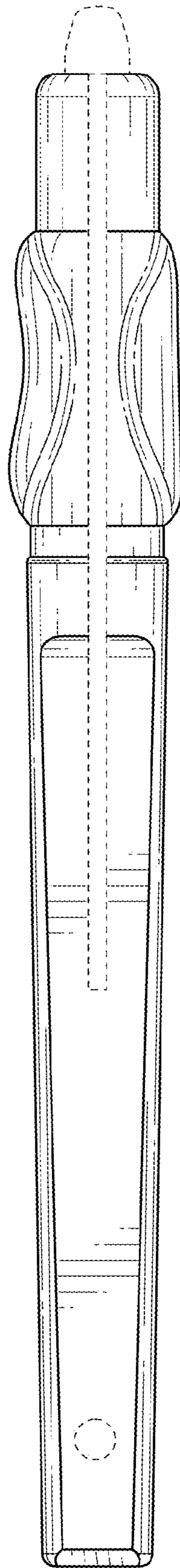

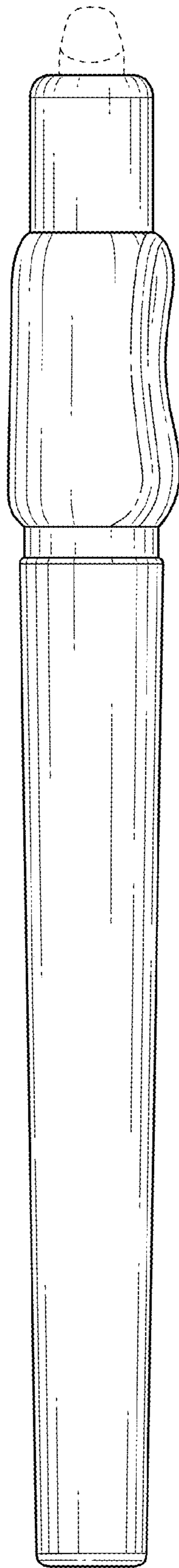

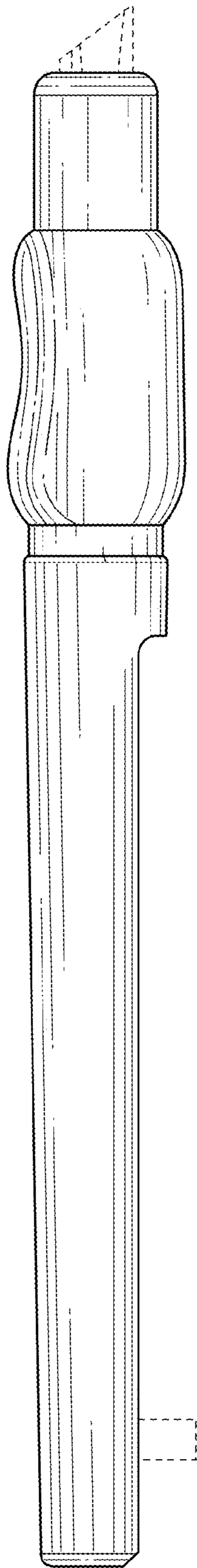

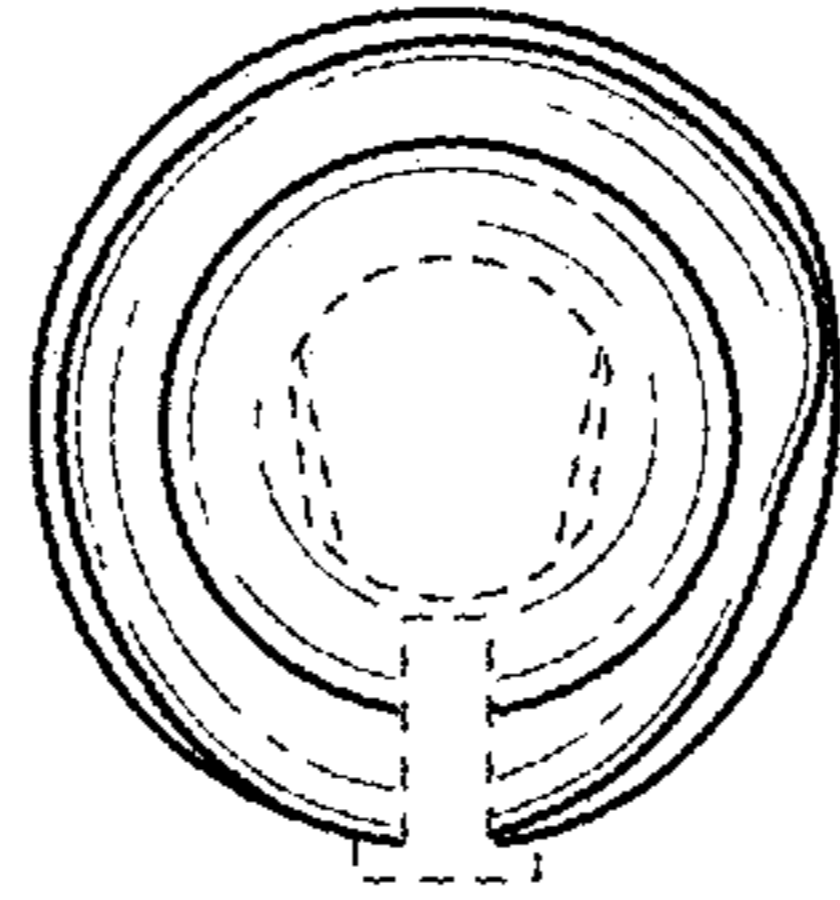

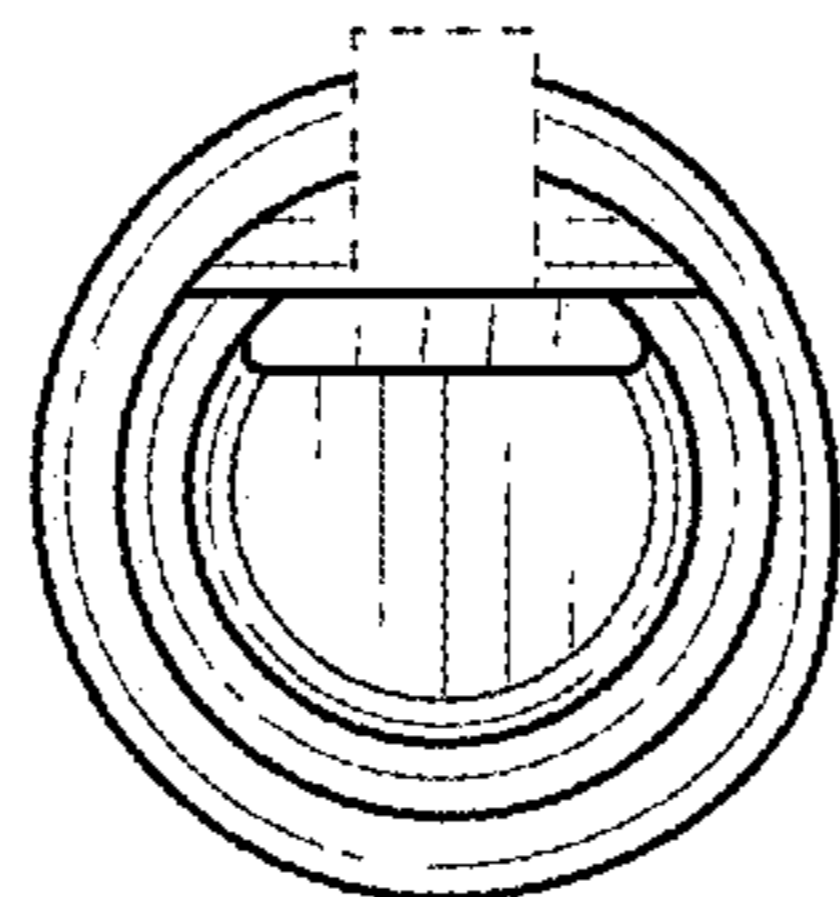
