DESCRIPTION

FIG. 1 is a perspective view of a vaporizer;
FIG. 2 is a front elevational view of the vaporizer;
FIG. 3 is a right side elevational view of the vaporizer;

FIG. 5 is a rear elevational view of the vaporizer;

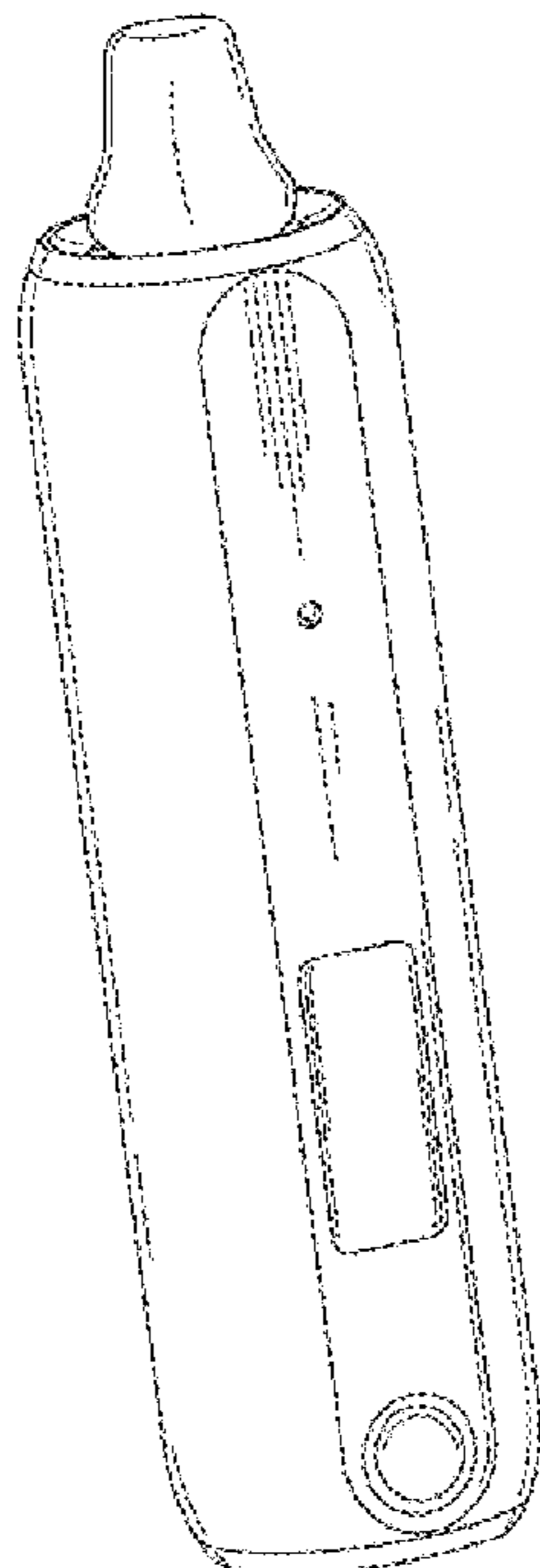

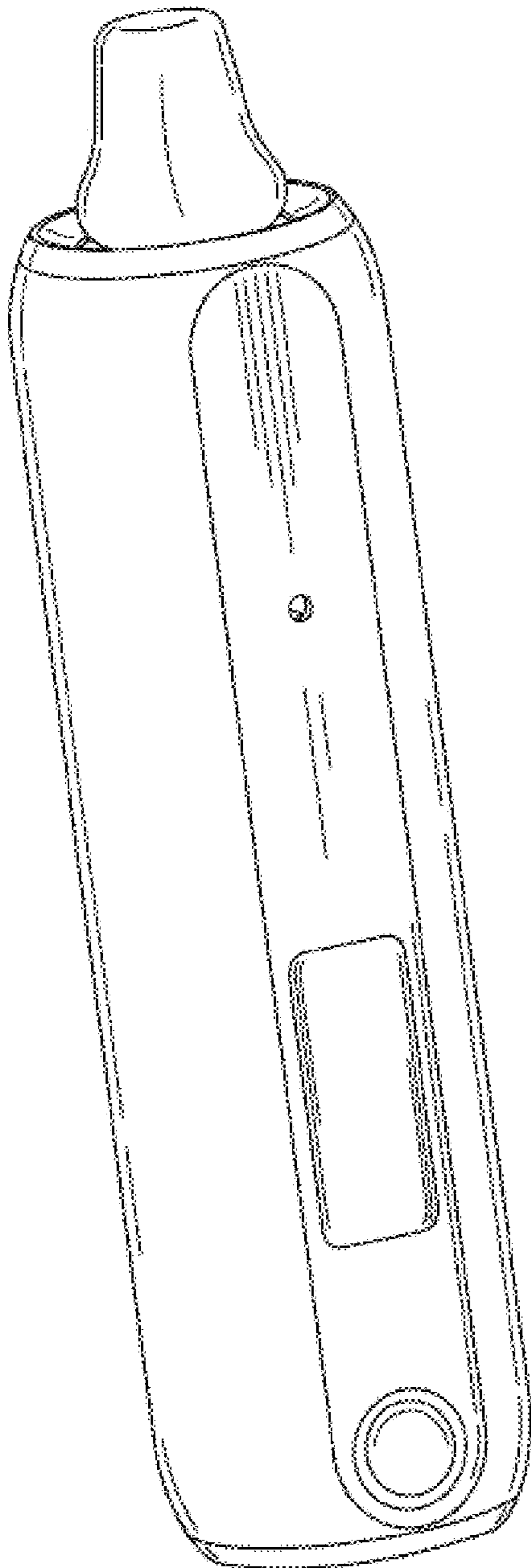

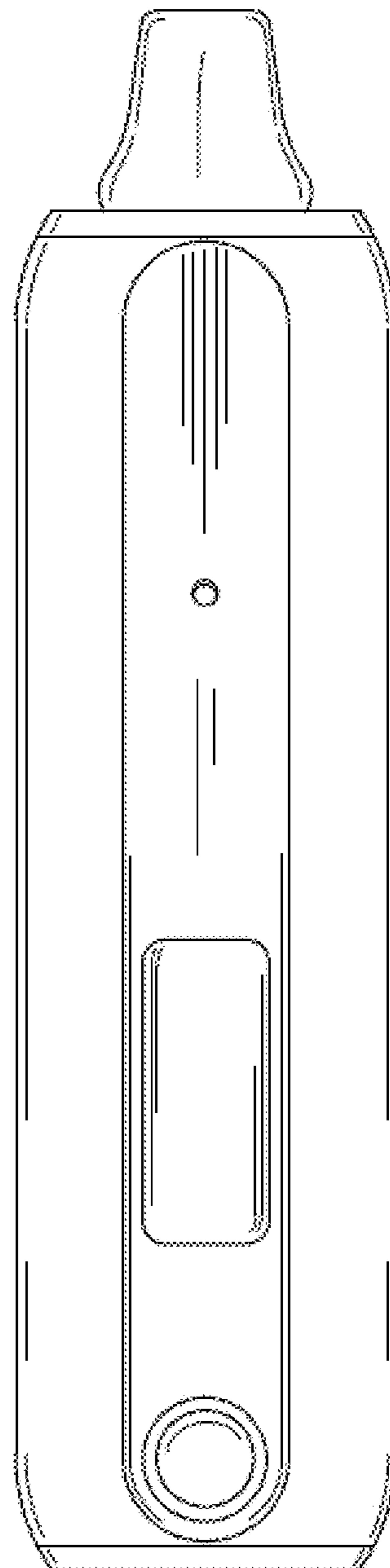

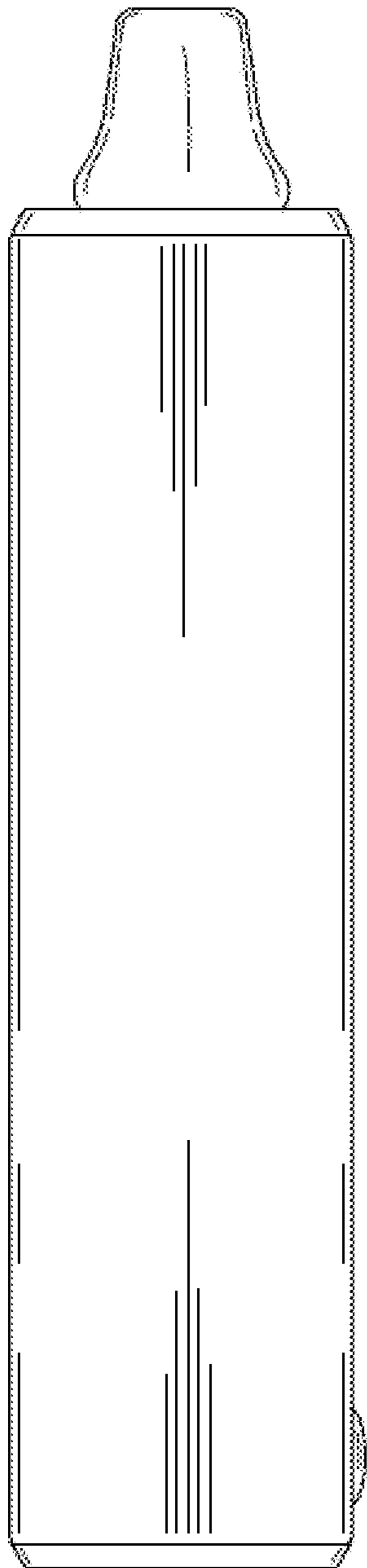

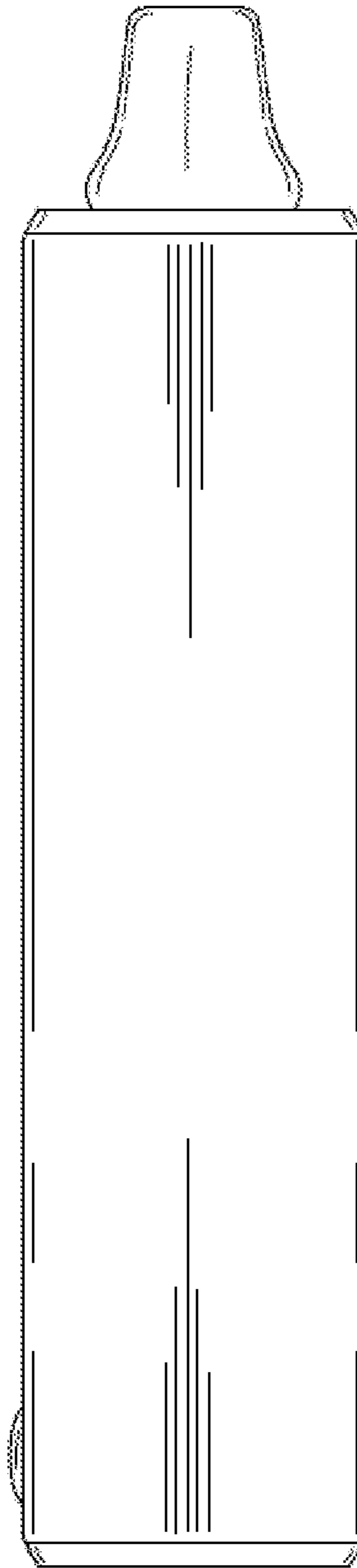

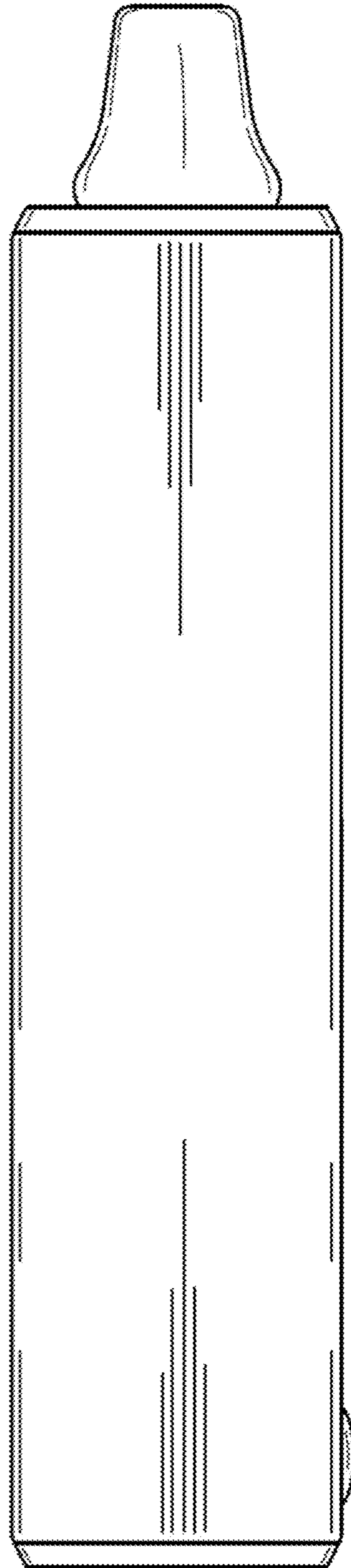

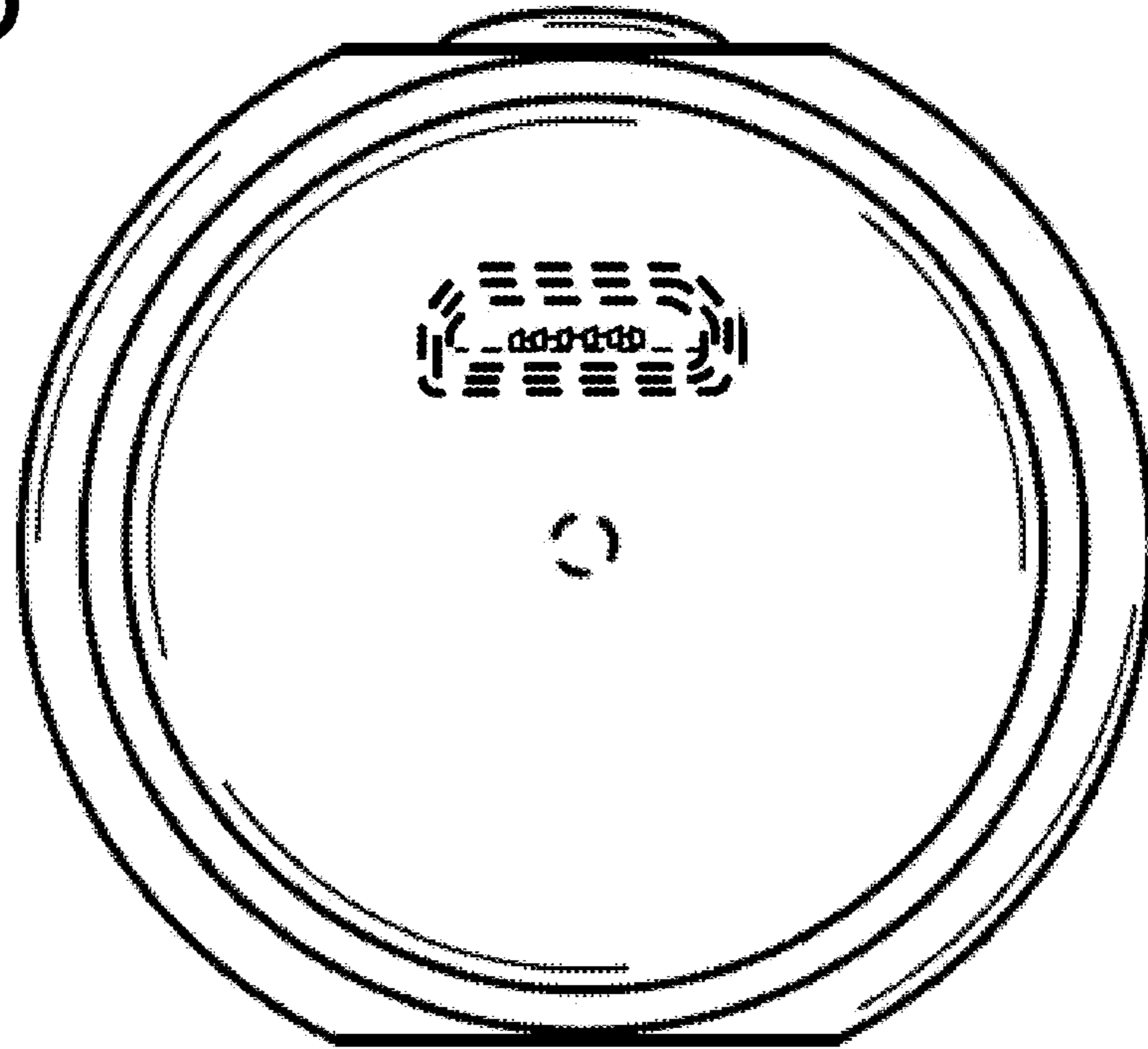
