(57) **CLAIM**

The ornamental design for cigar punch for creating multiple perforations into a cigar, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged isometric view of a cigar punch for creating multiple perforations into a cigar showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

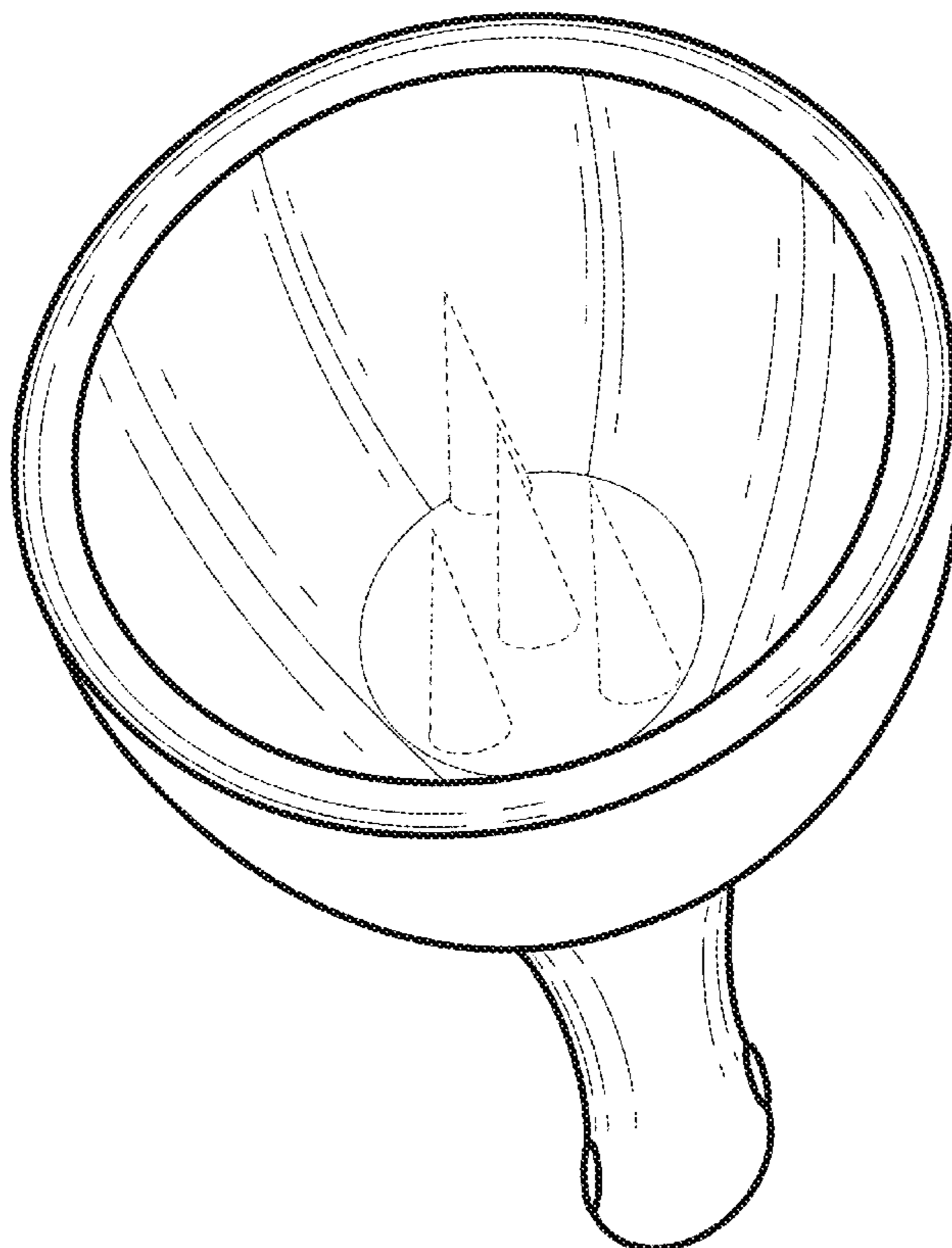
FIG. 5 is a right side elevational view thereof;

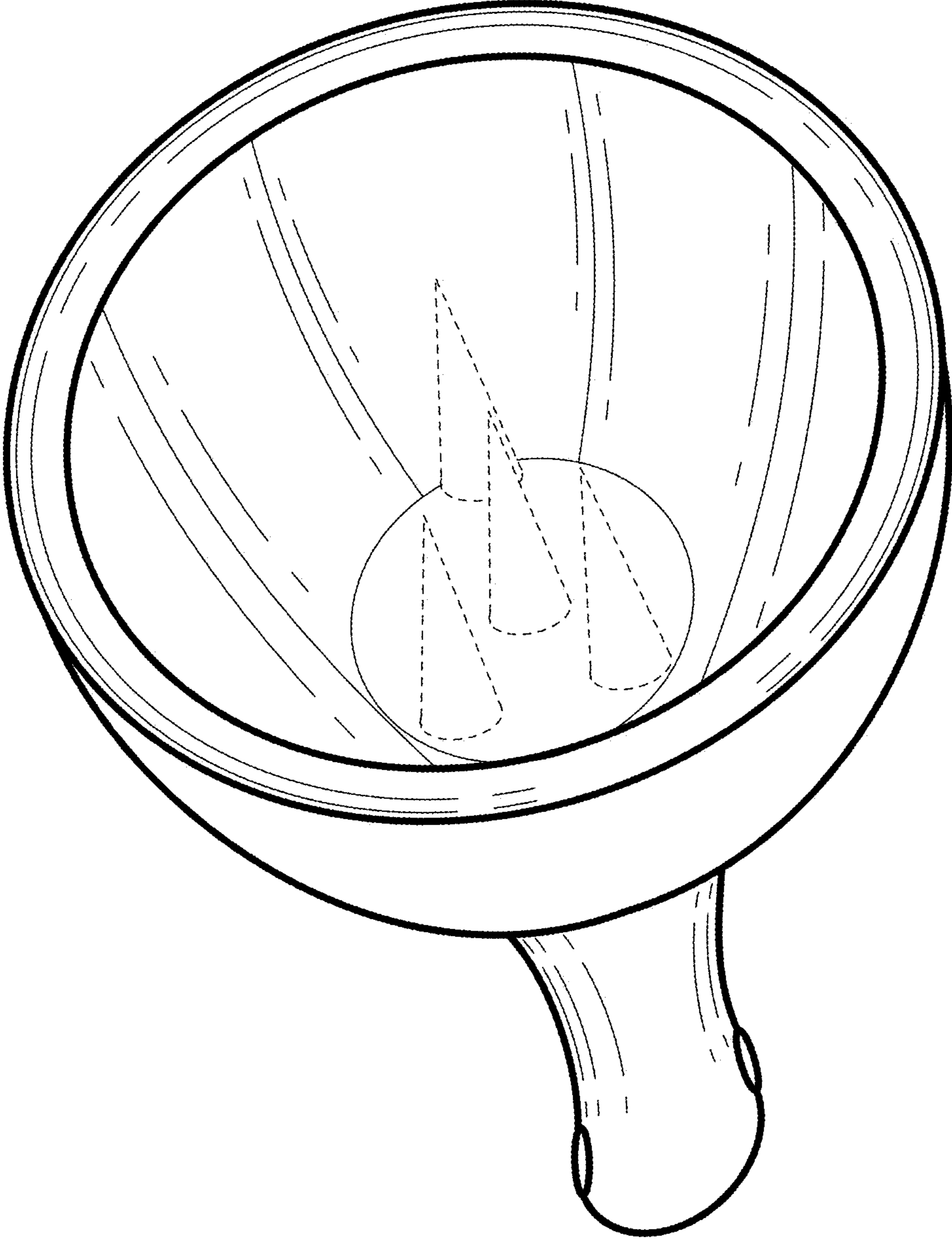

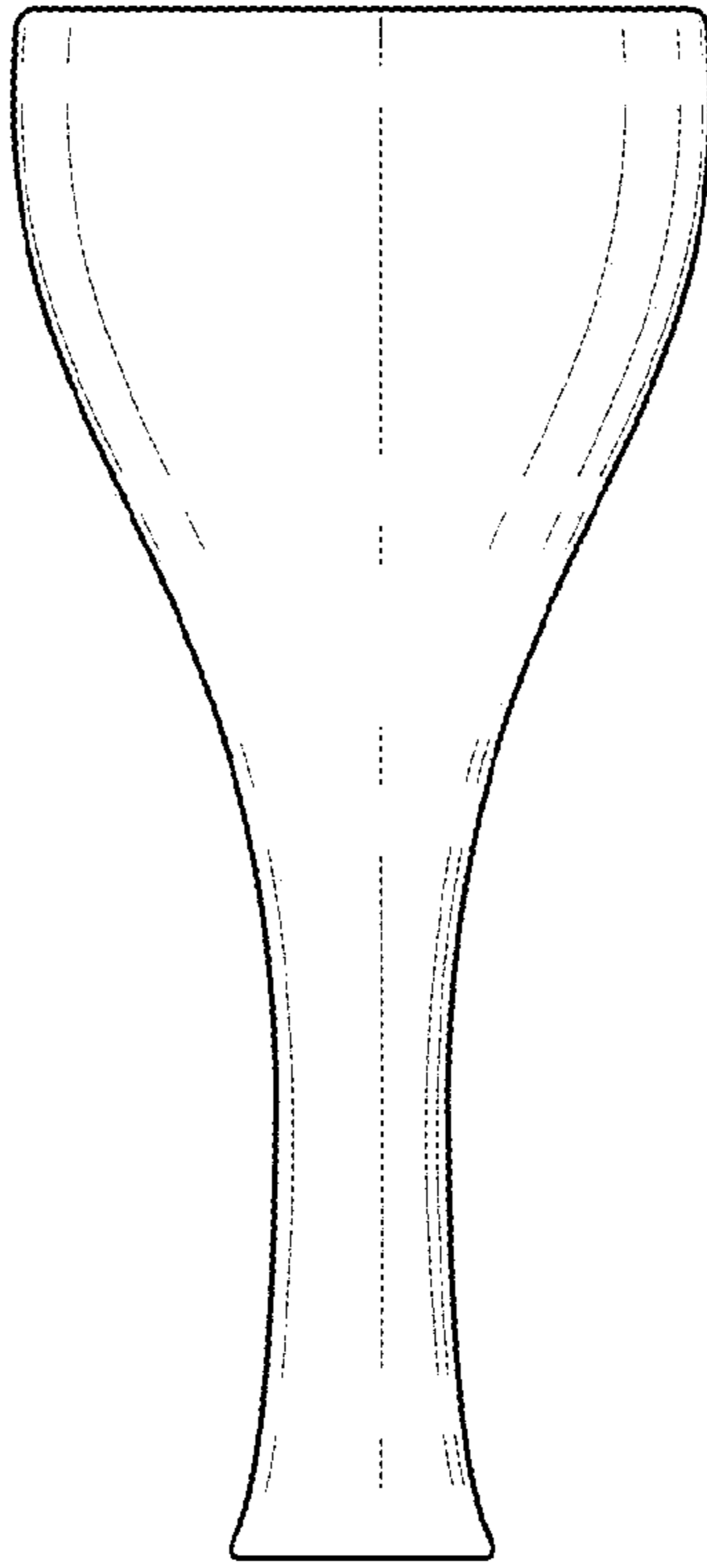

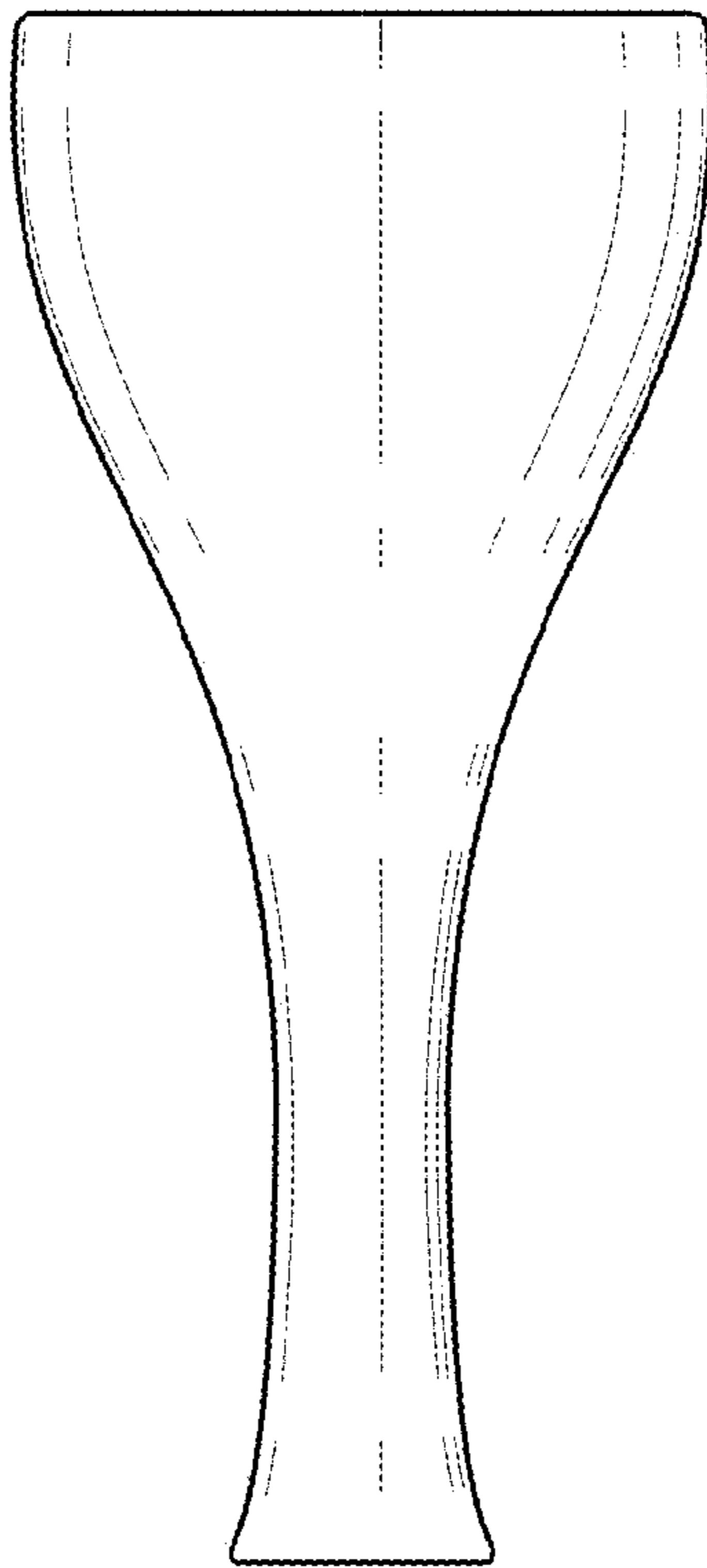

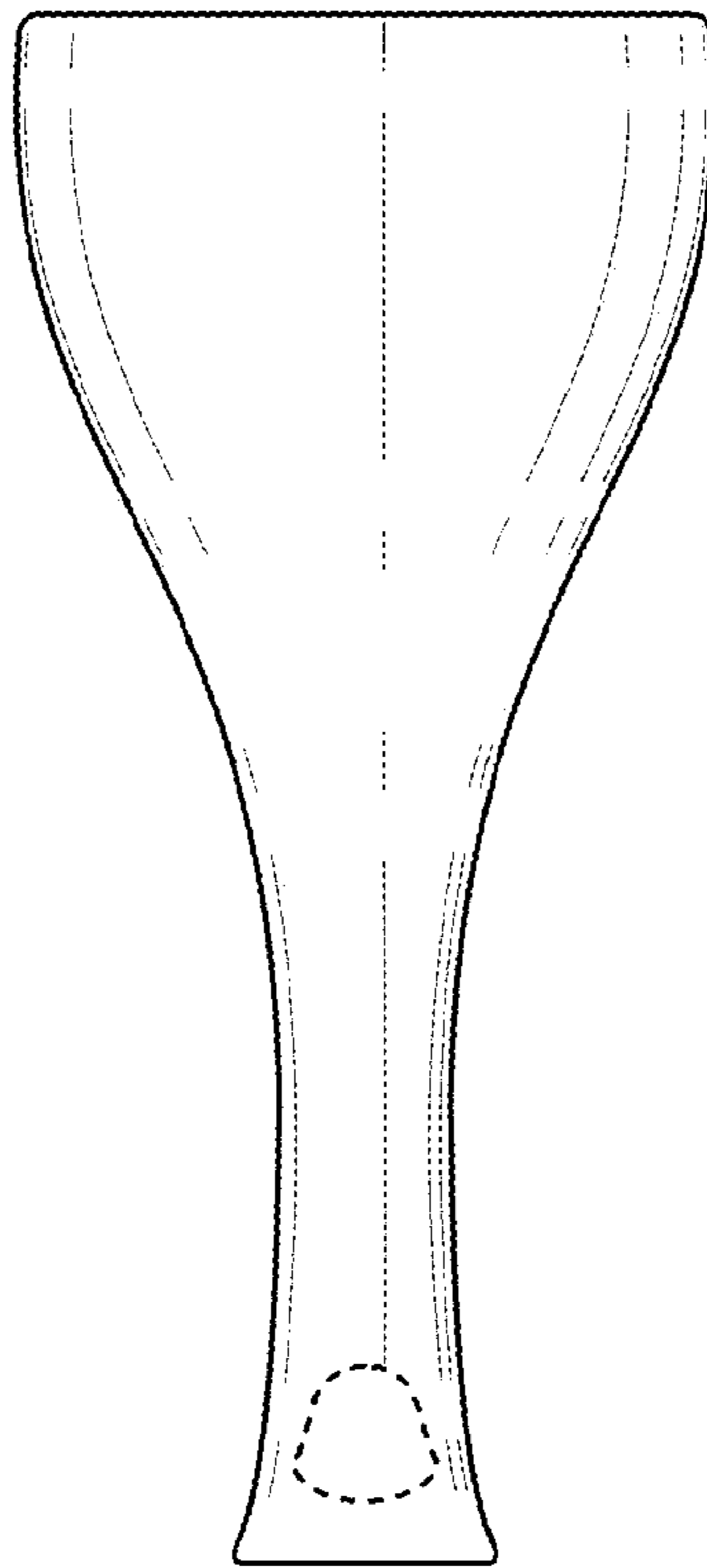

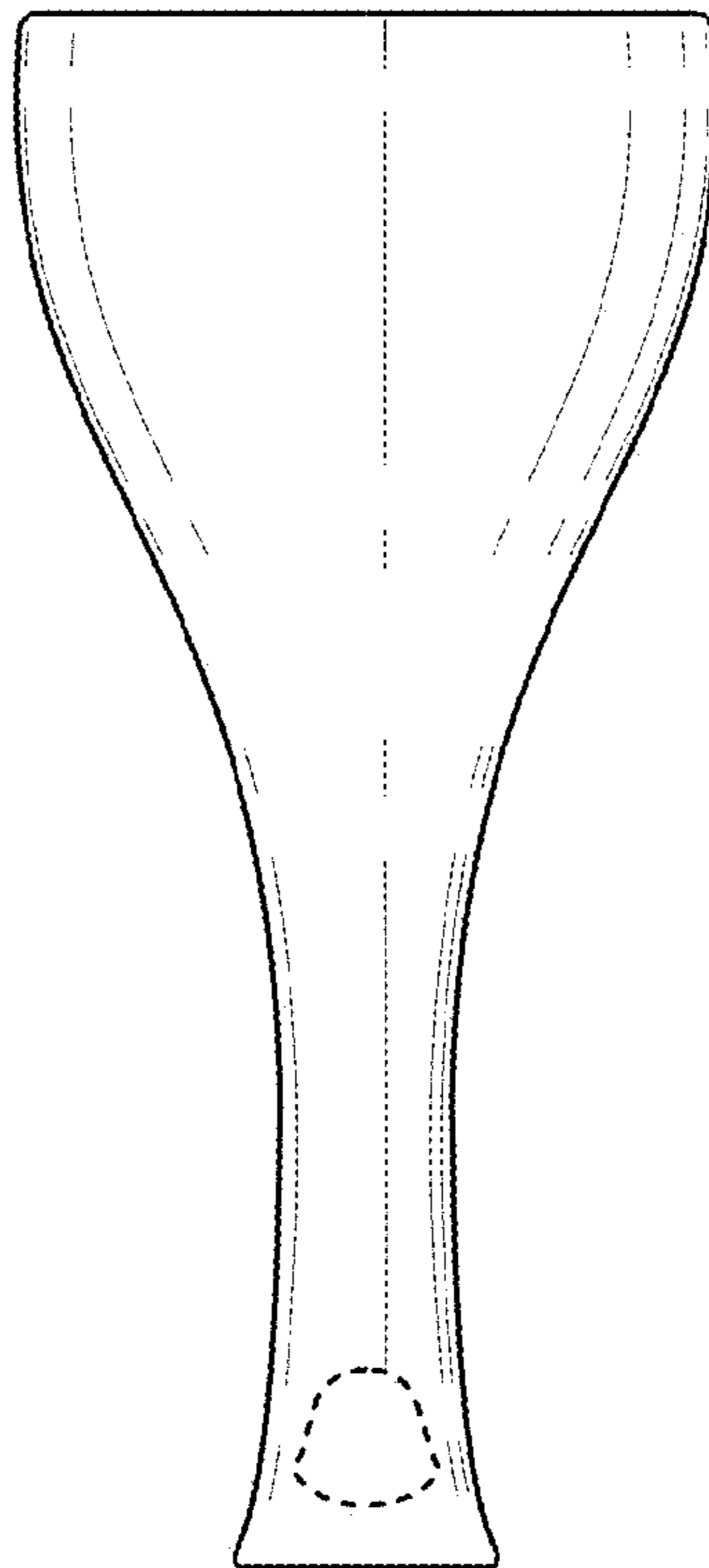

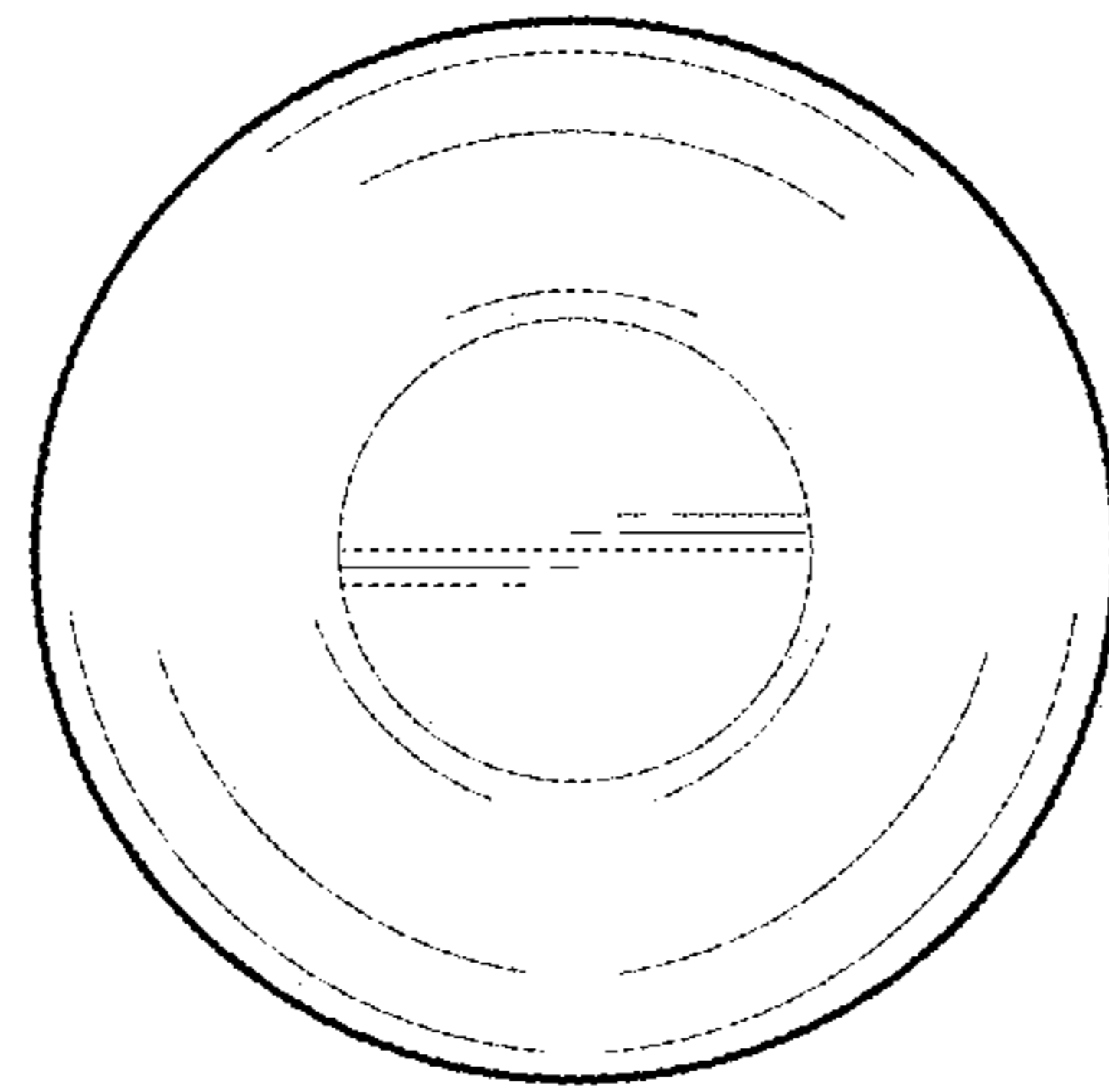

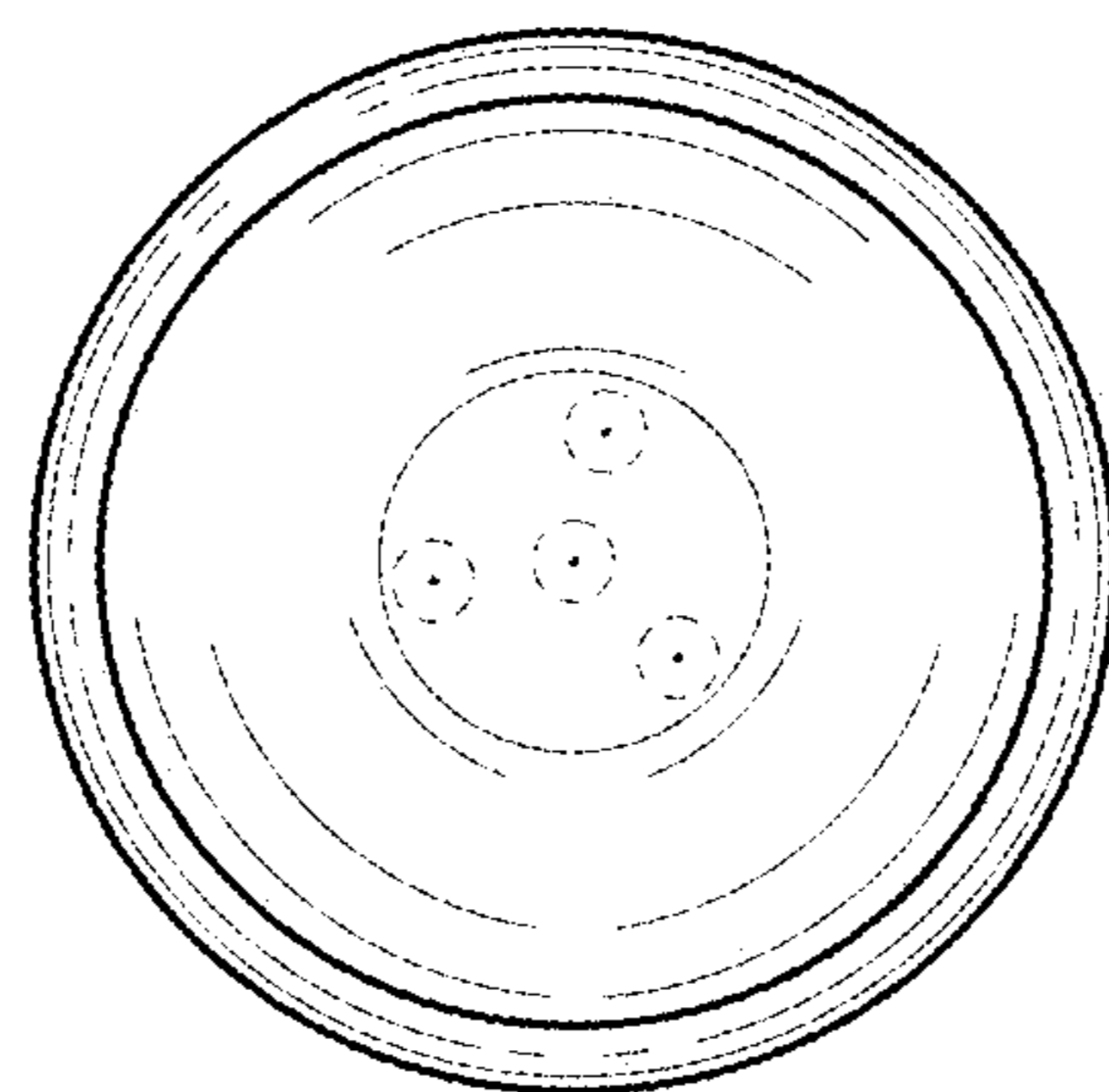
