I claim the ornamental design for a hair clipper, as shown and described.

FIG. 30 is a right side view of the hair clipper of FIG. 25;

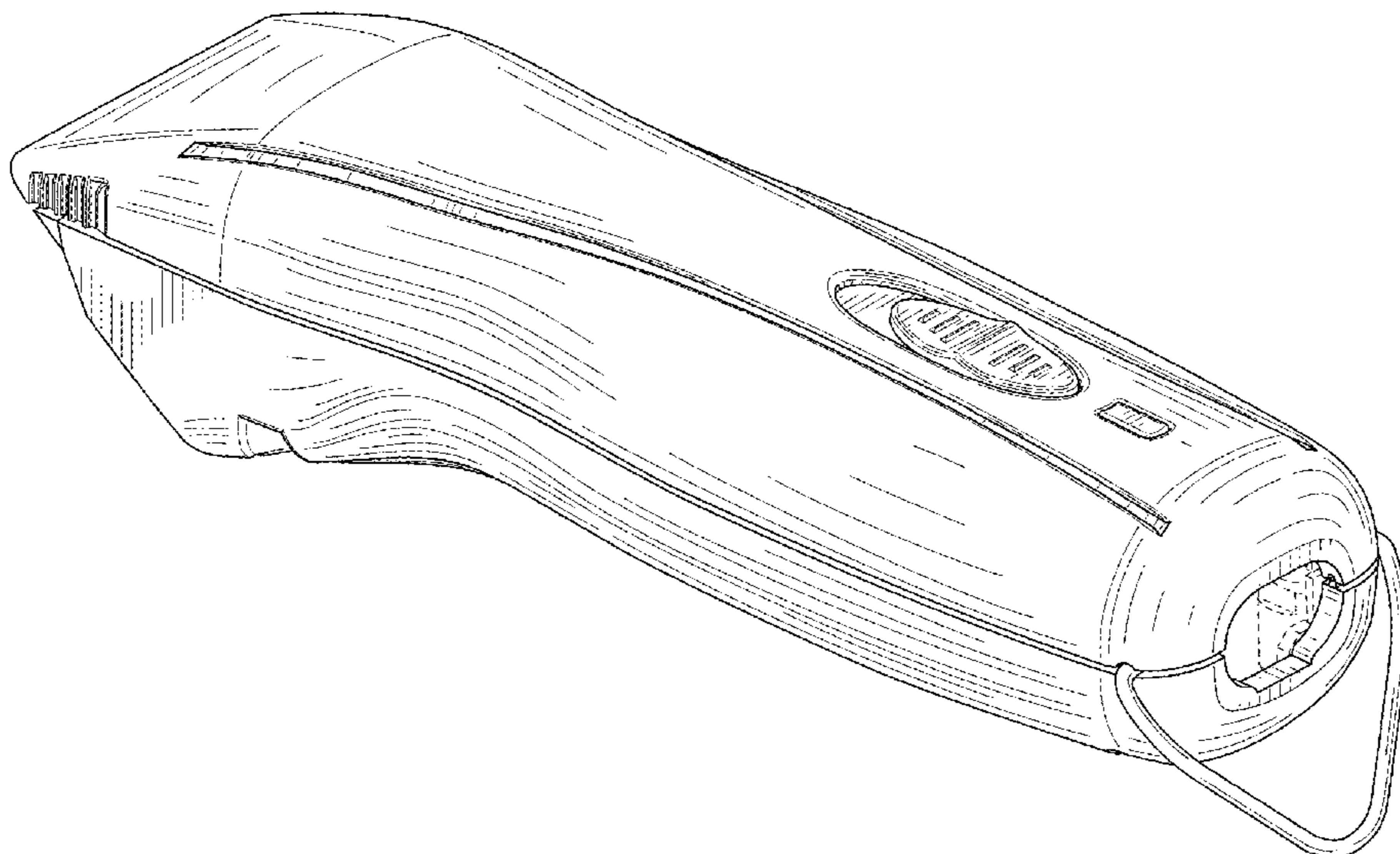
FIG. 31 is a front side view of the hair clipper of FIG. 25;

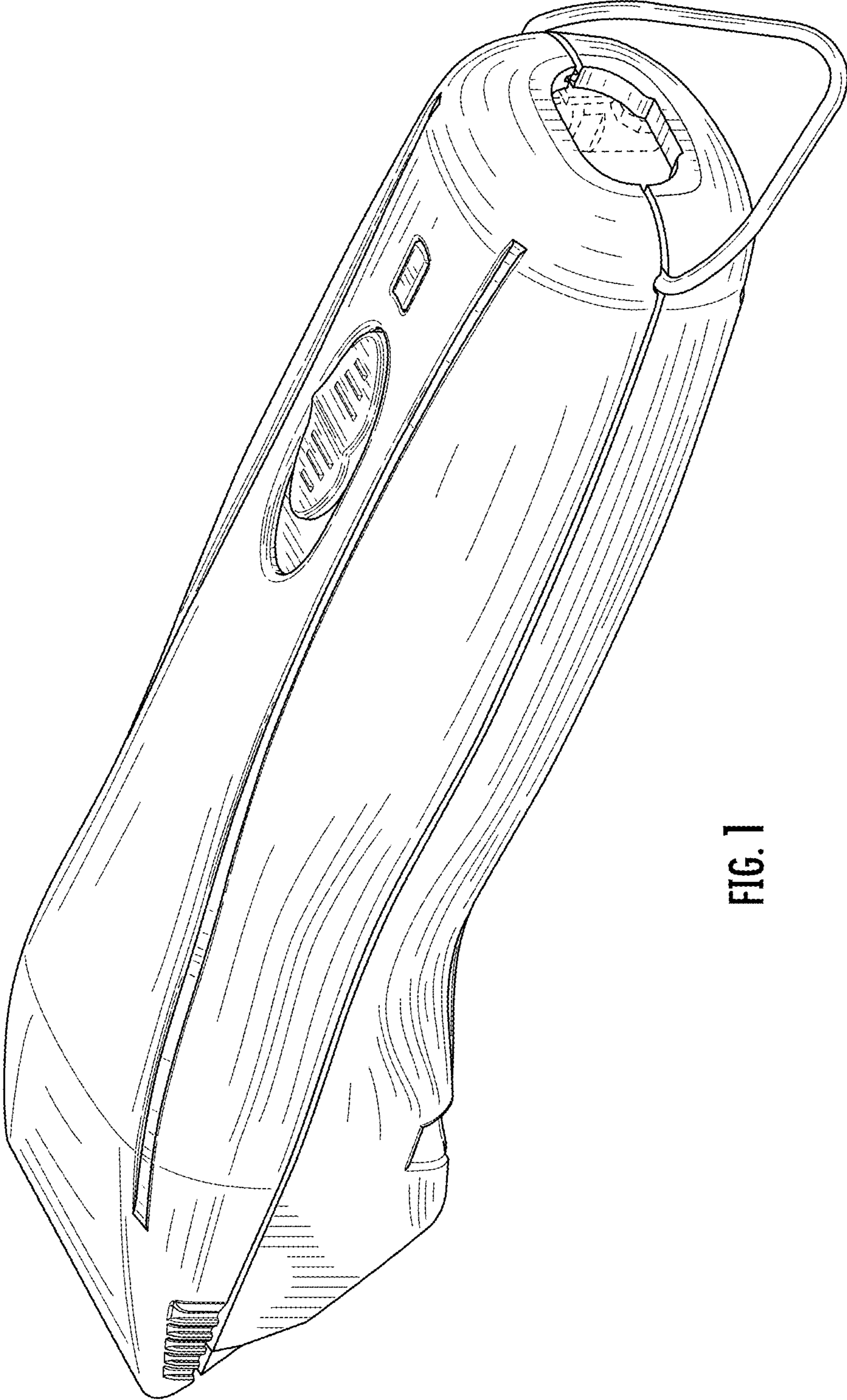

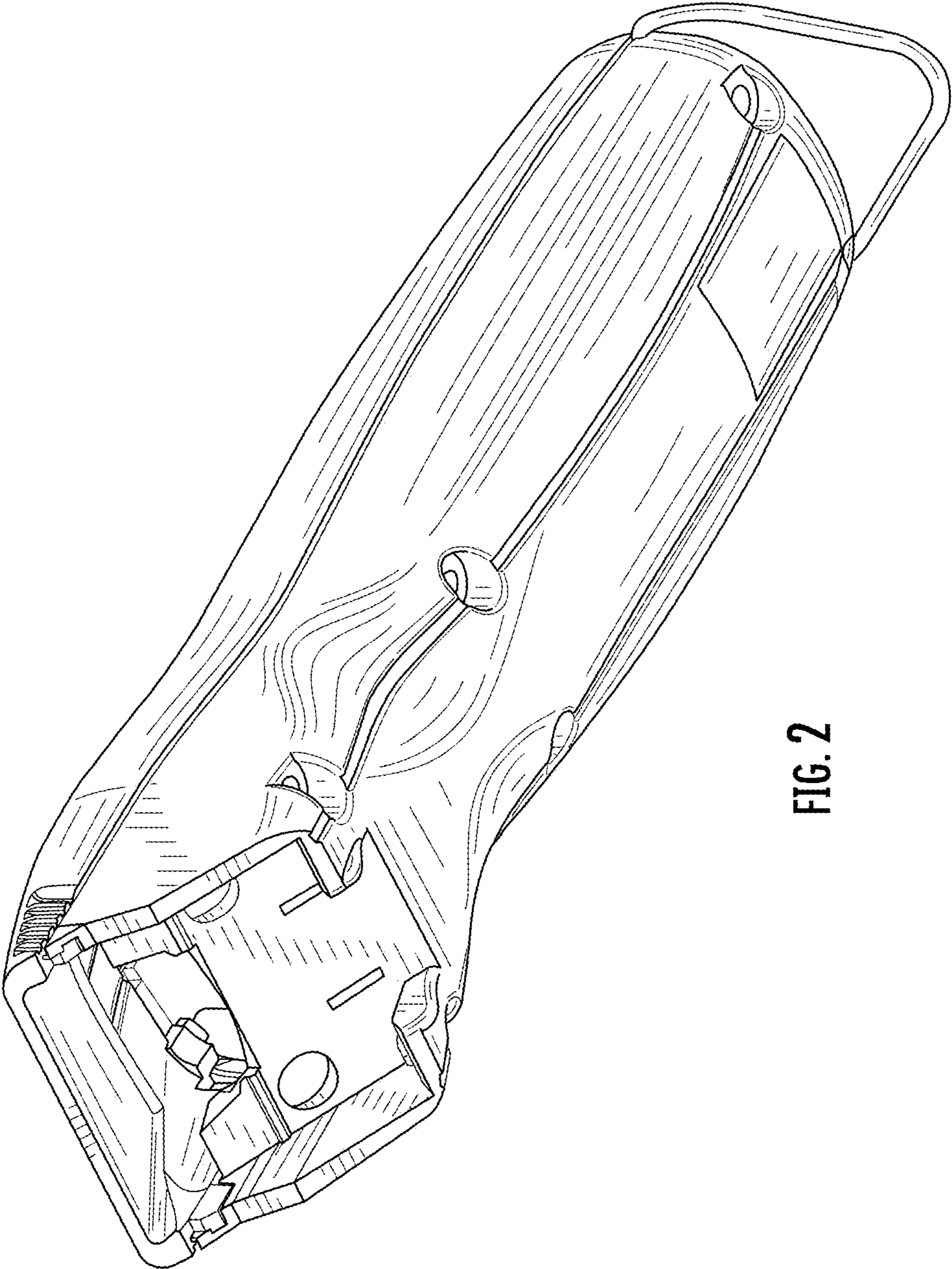

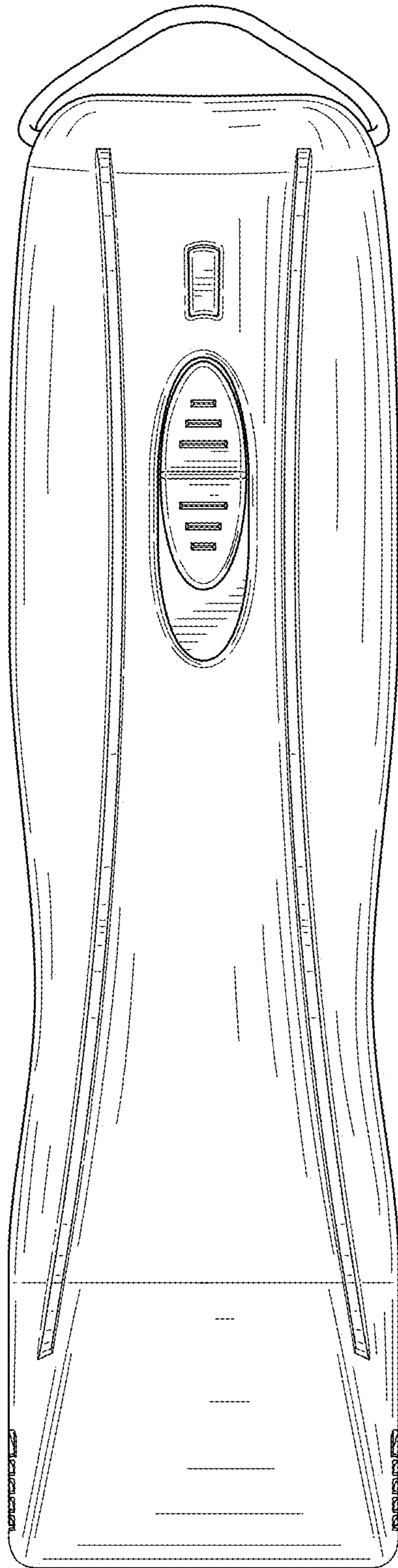

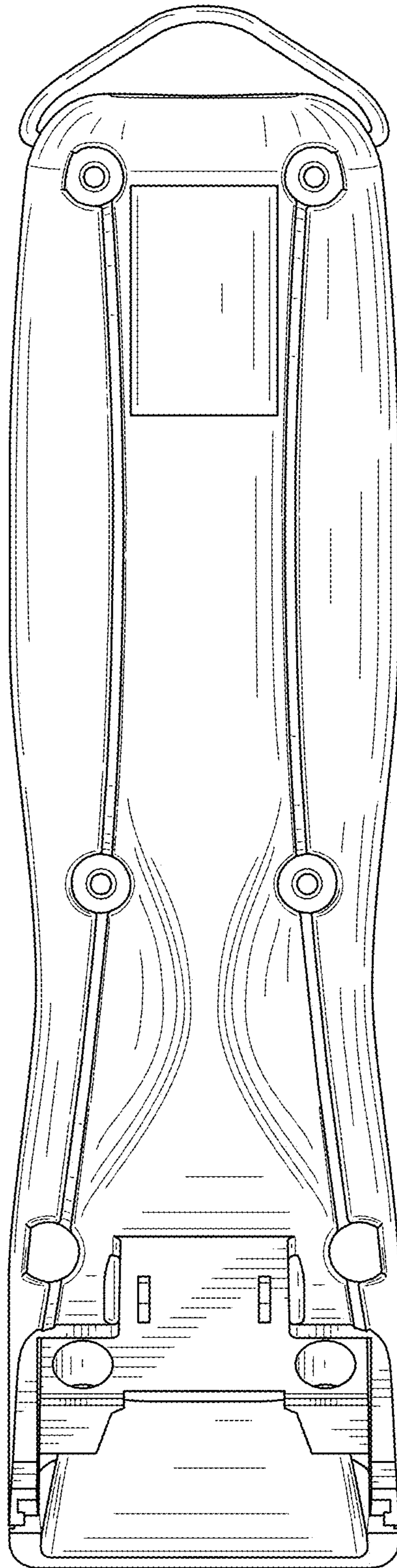

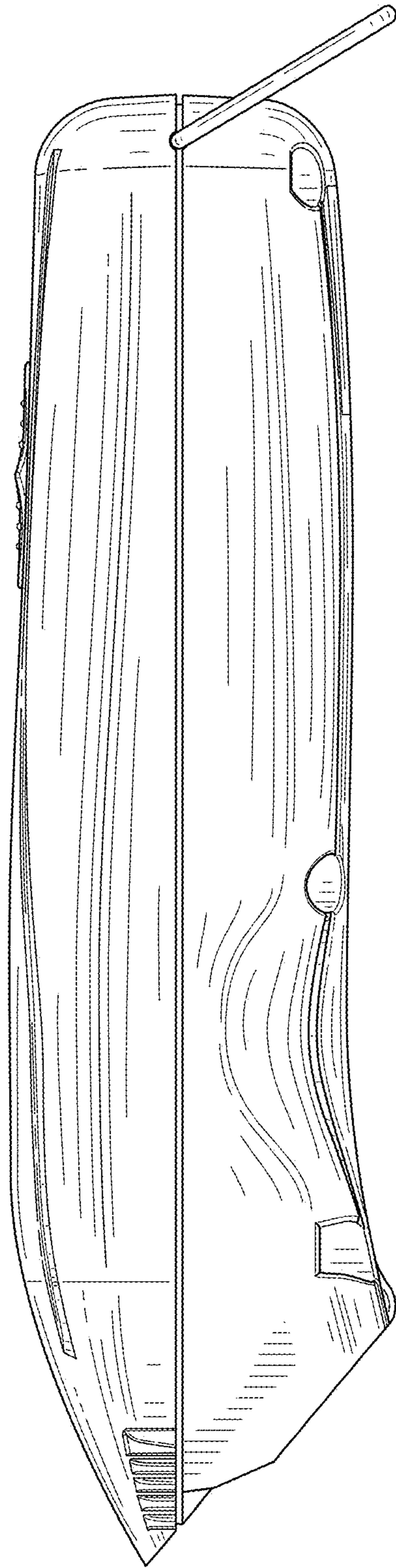

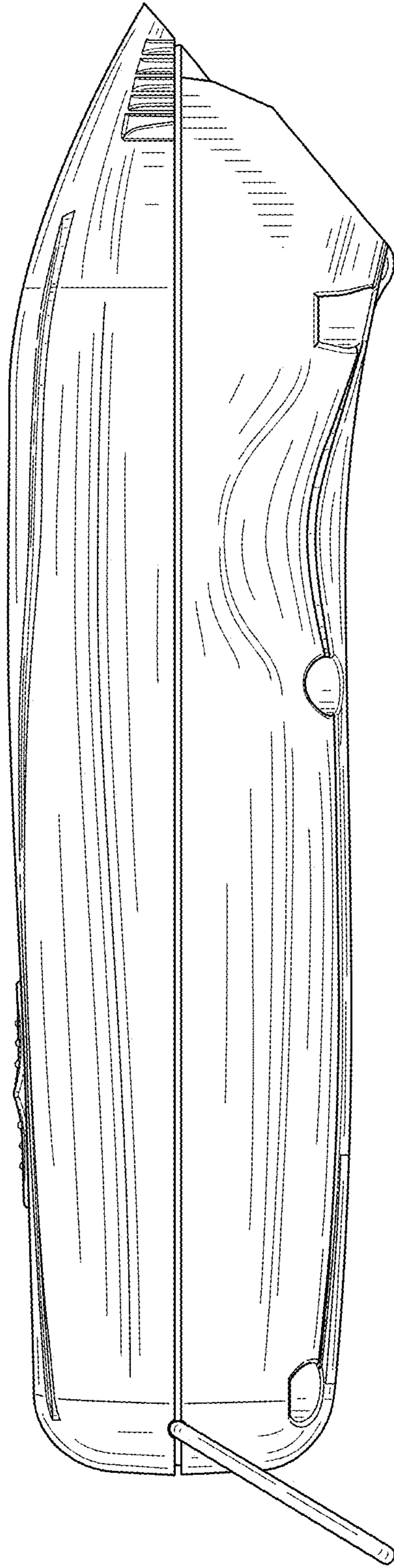

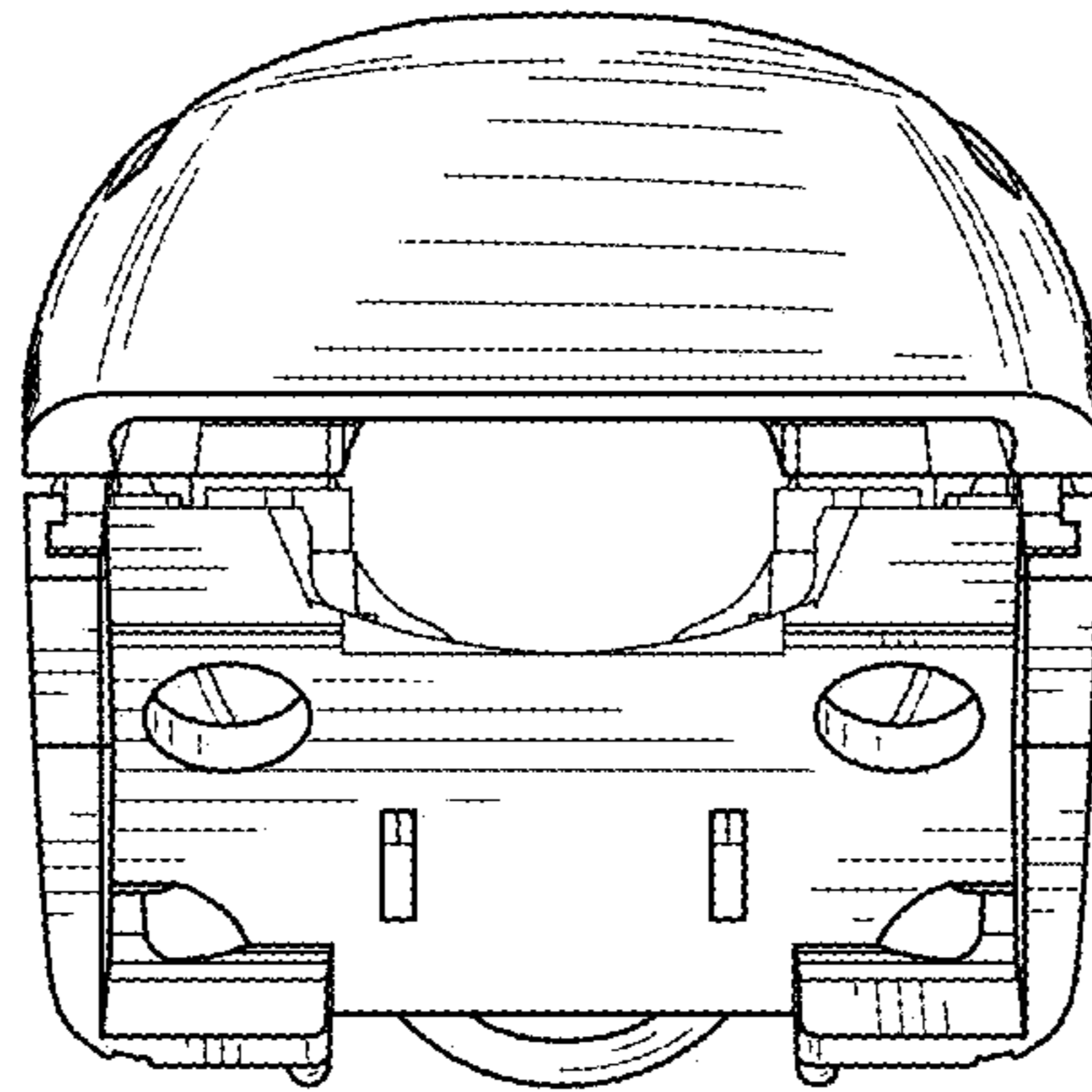

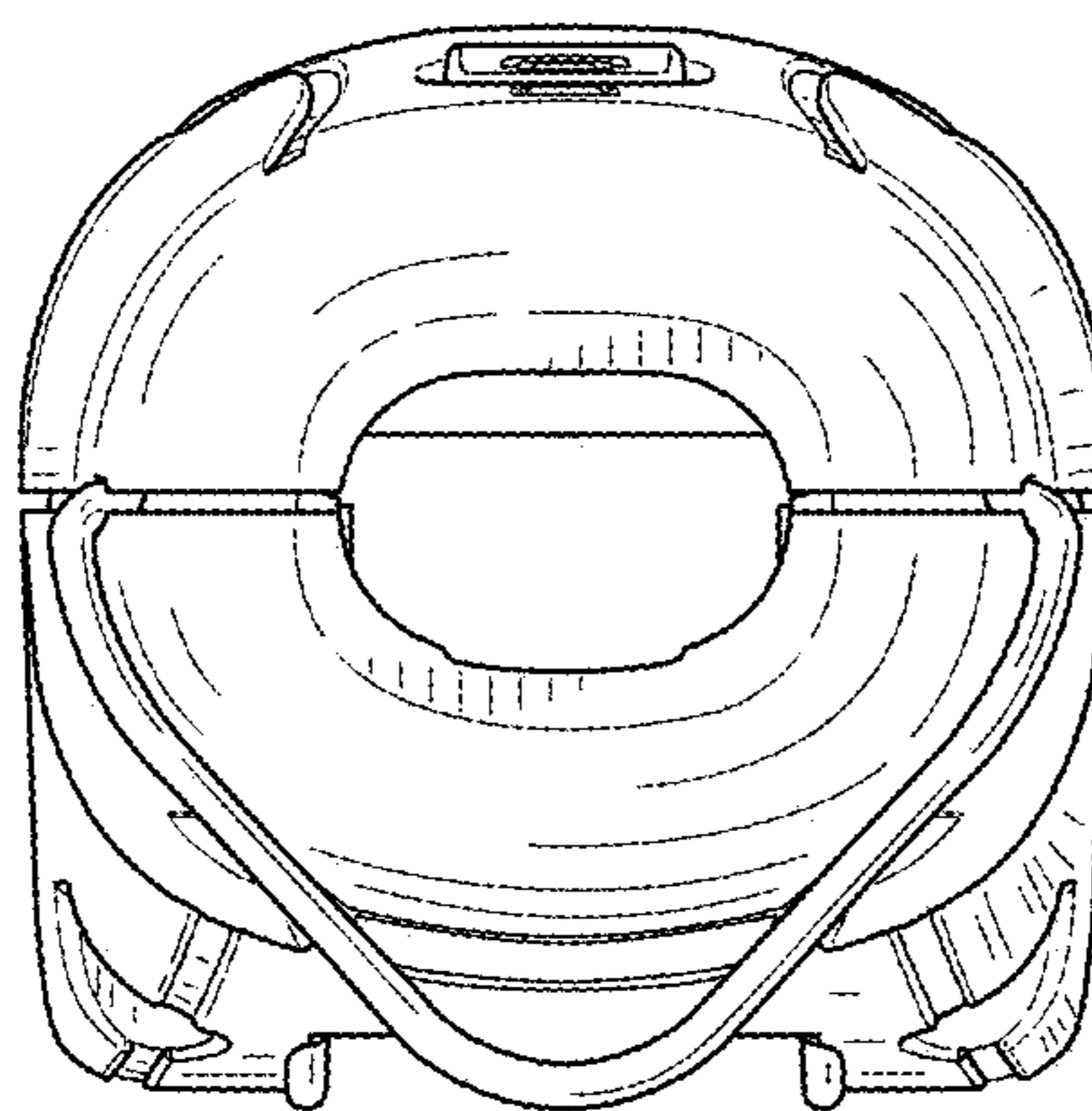

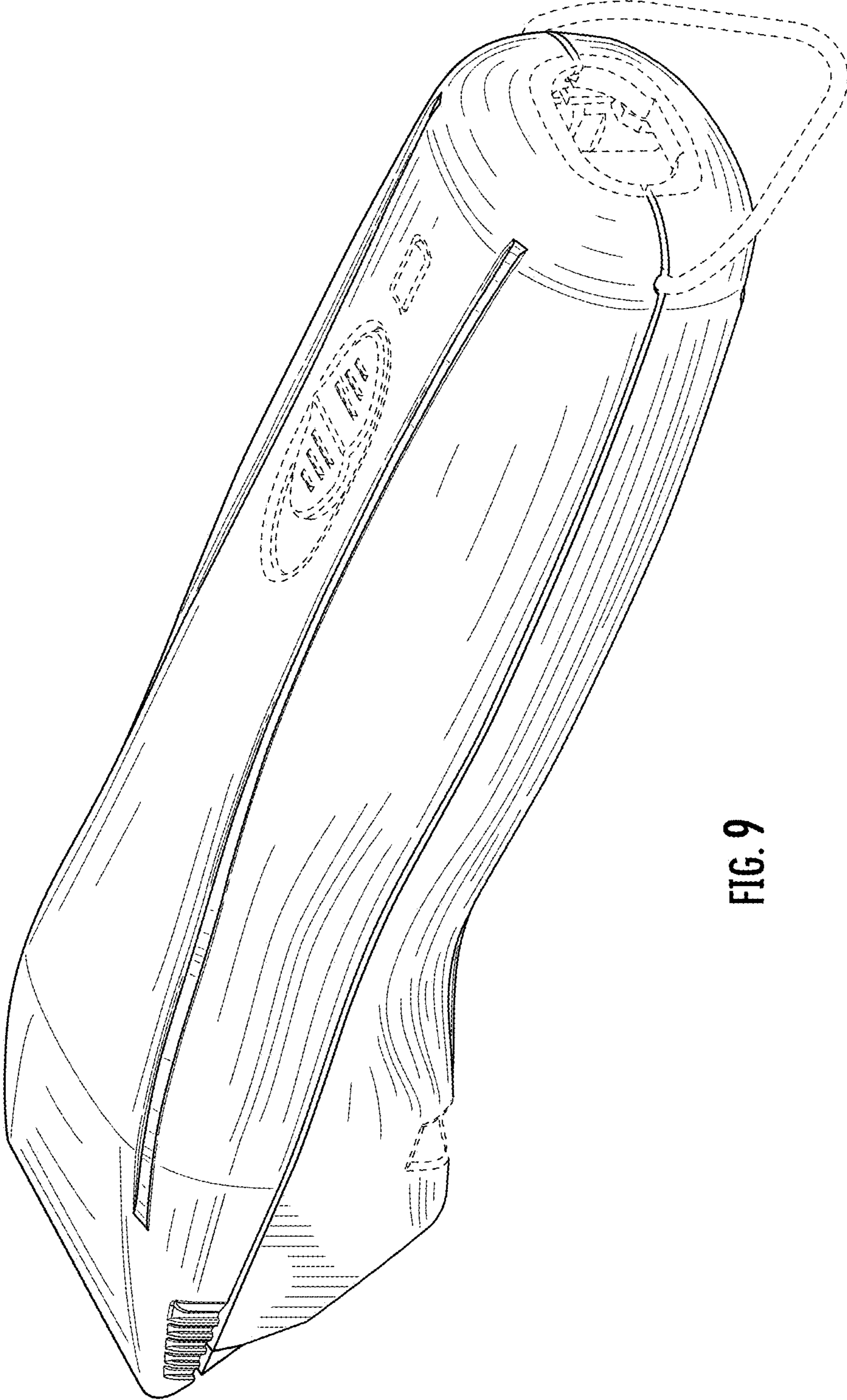

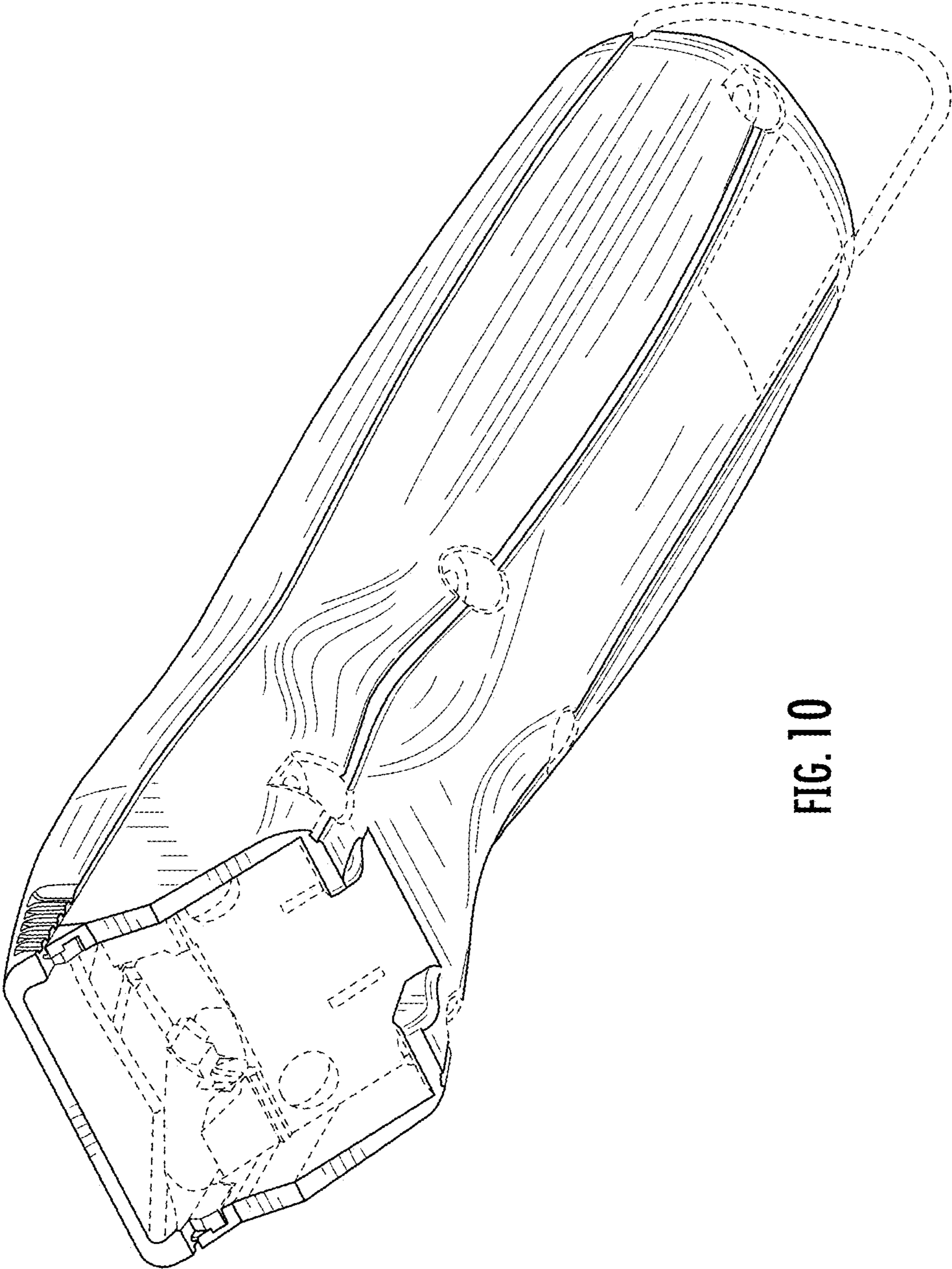

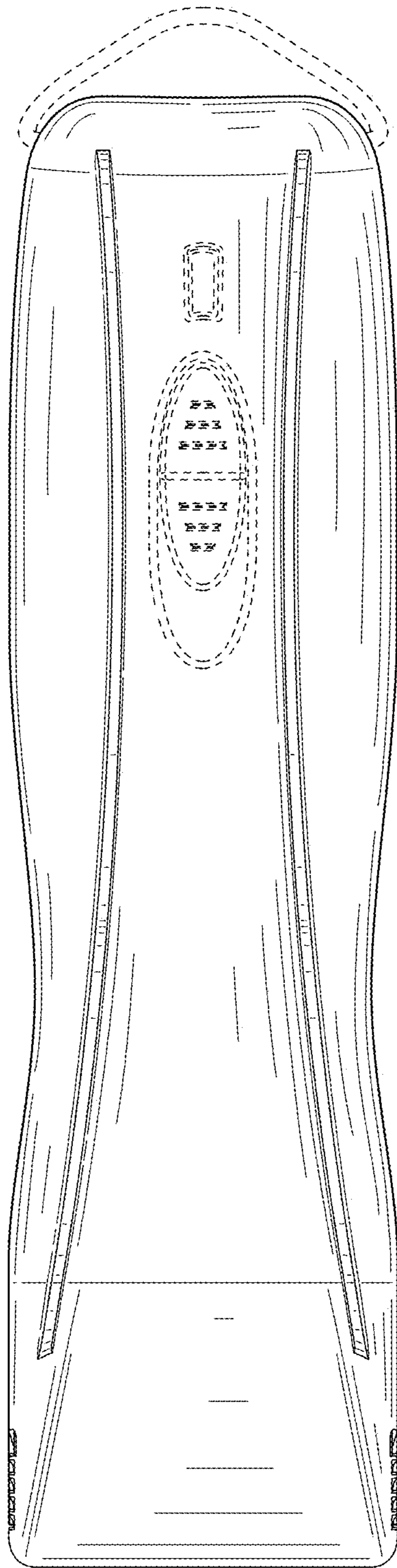

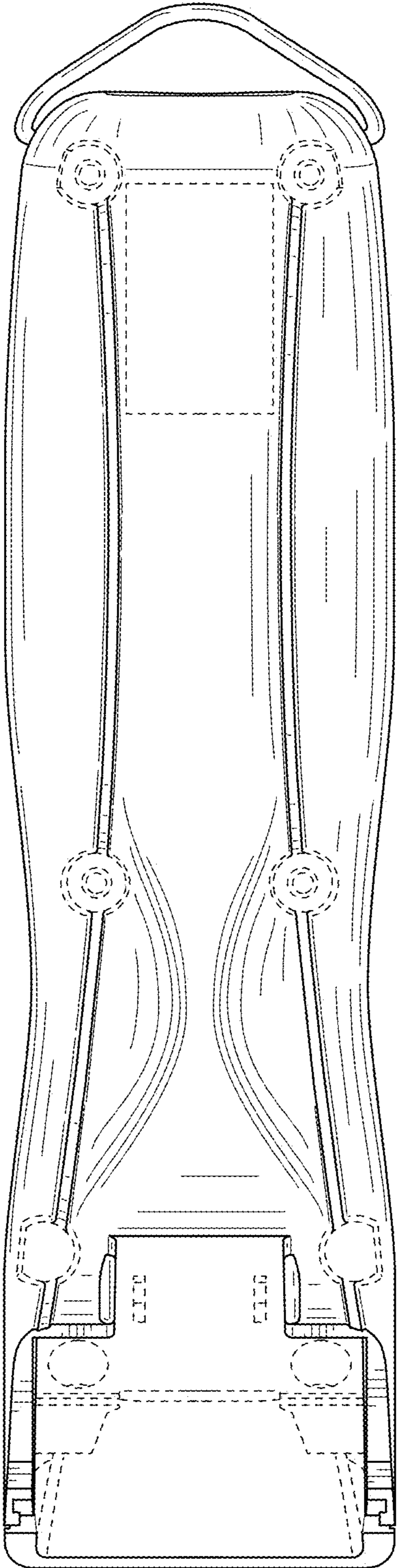

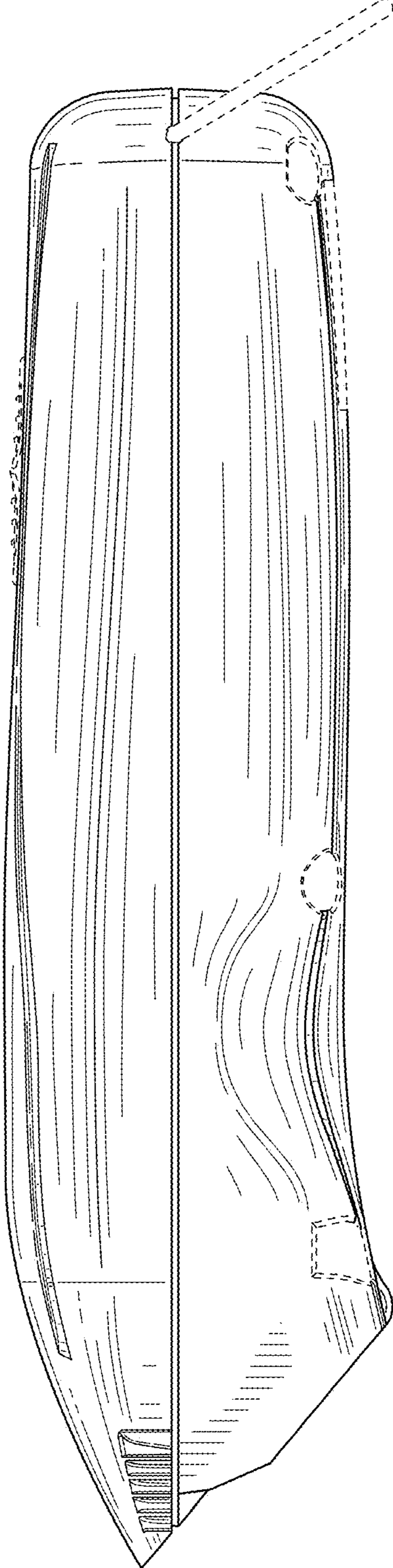

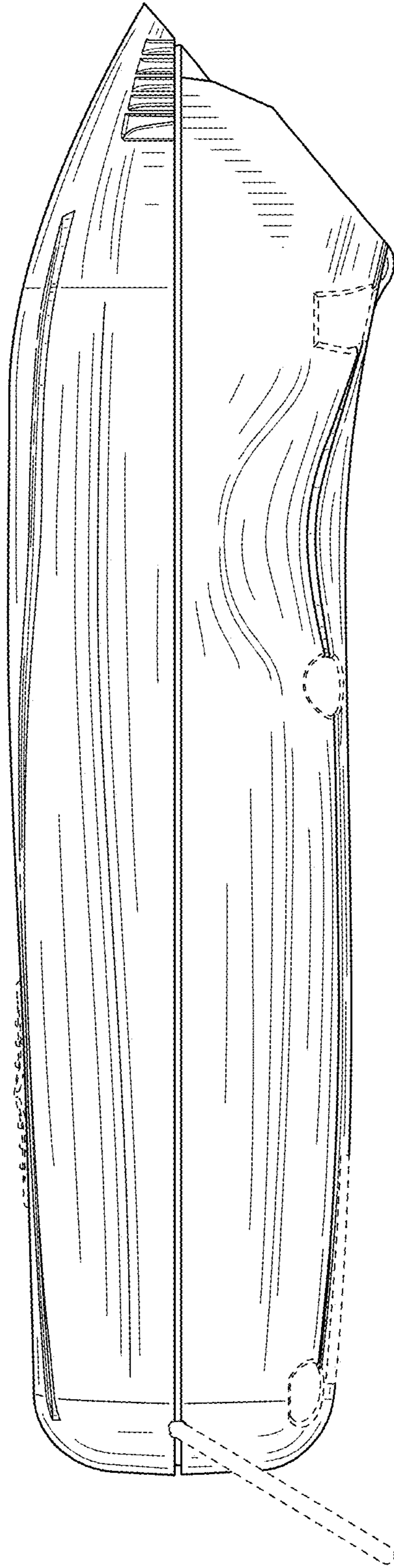

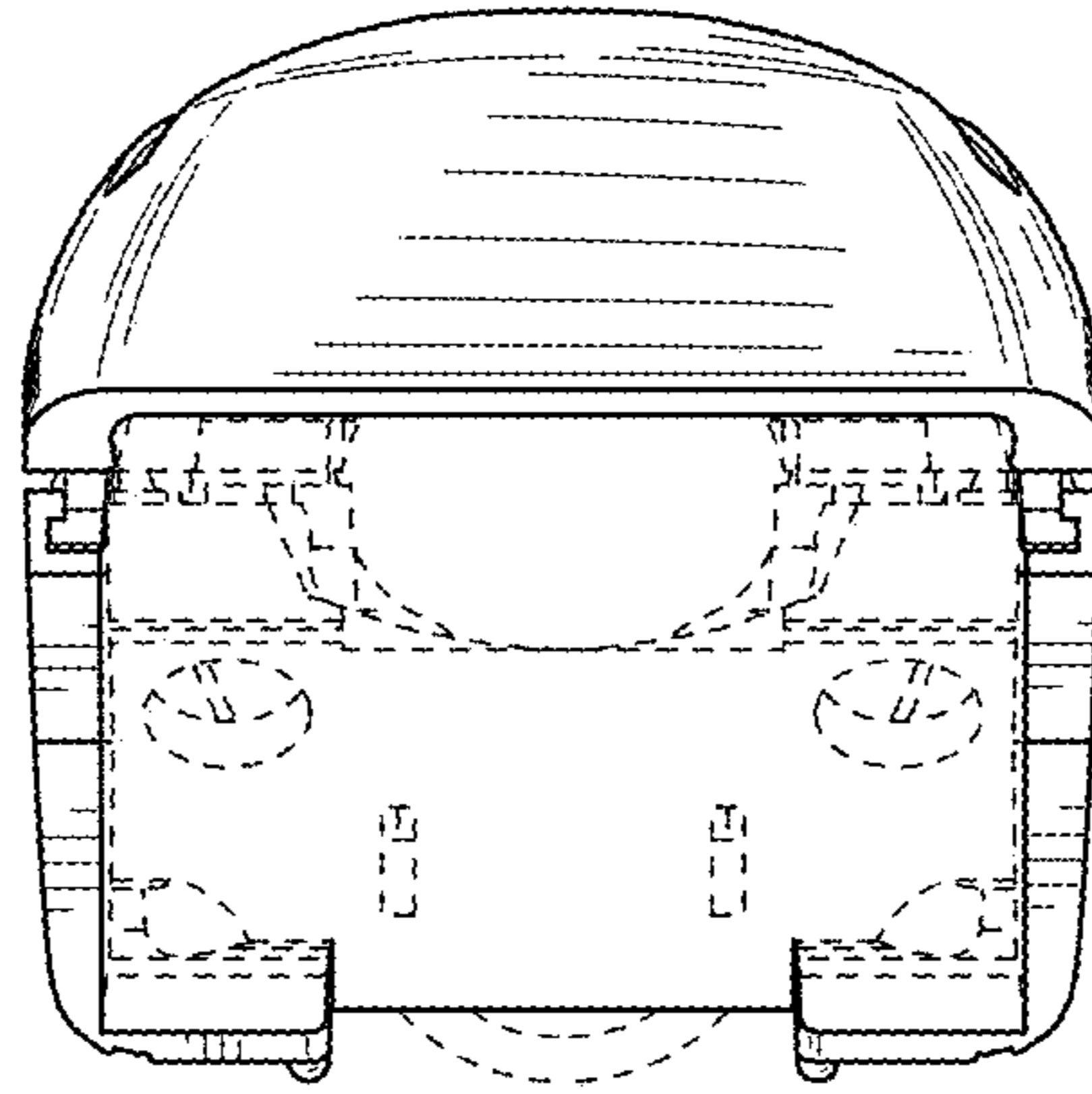

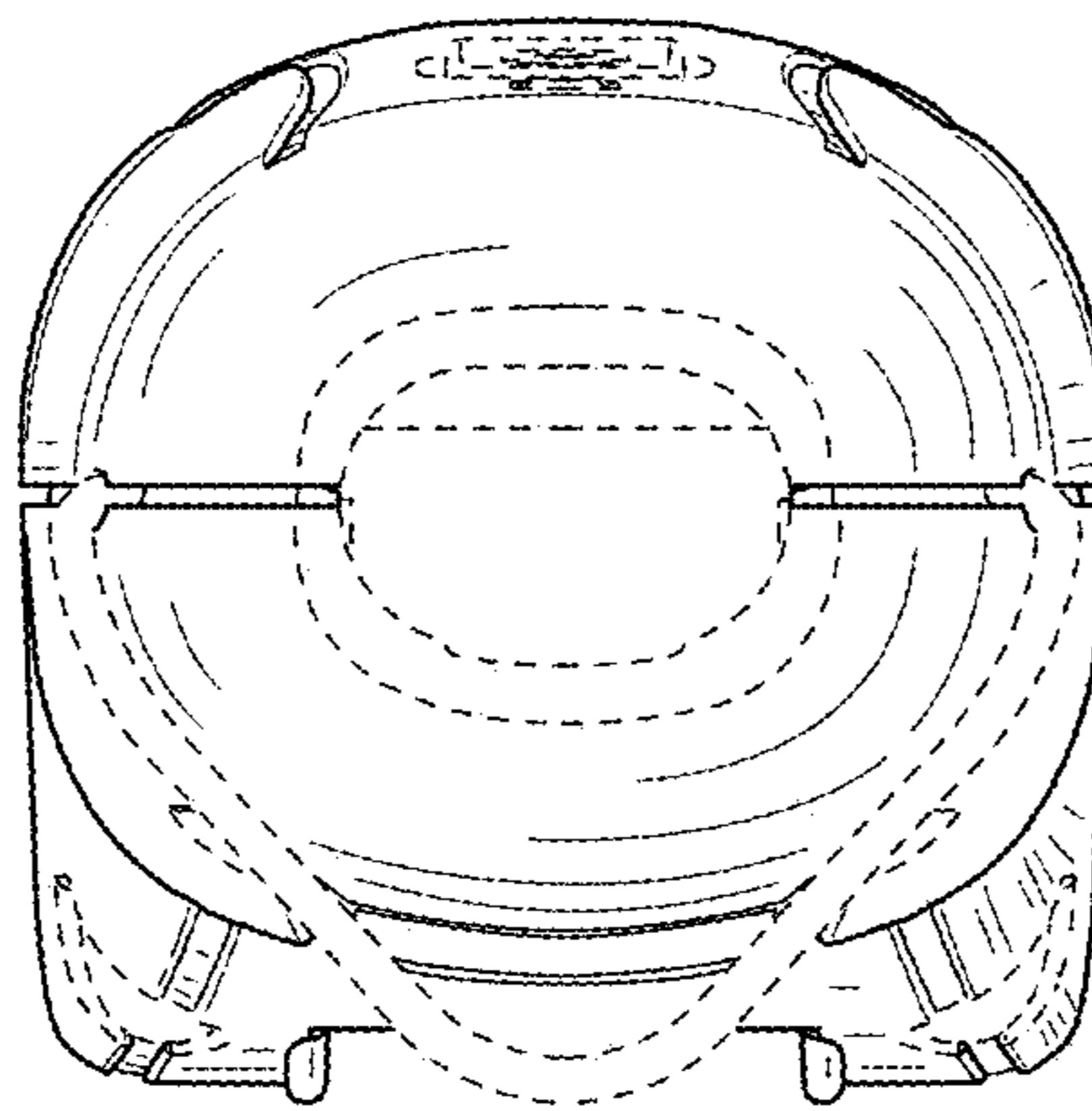

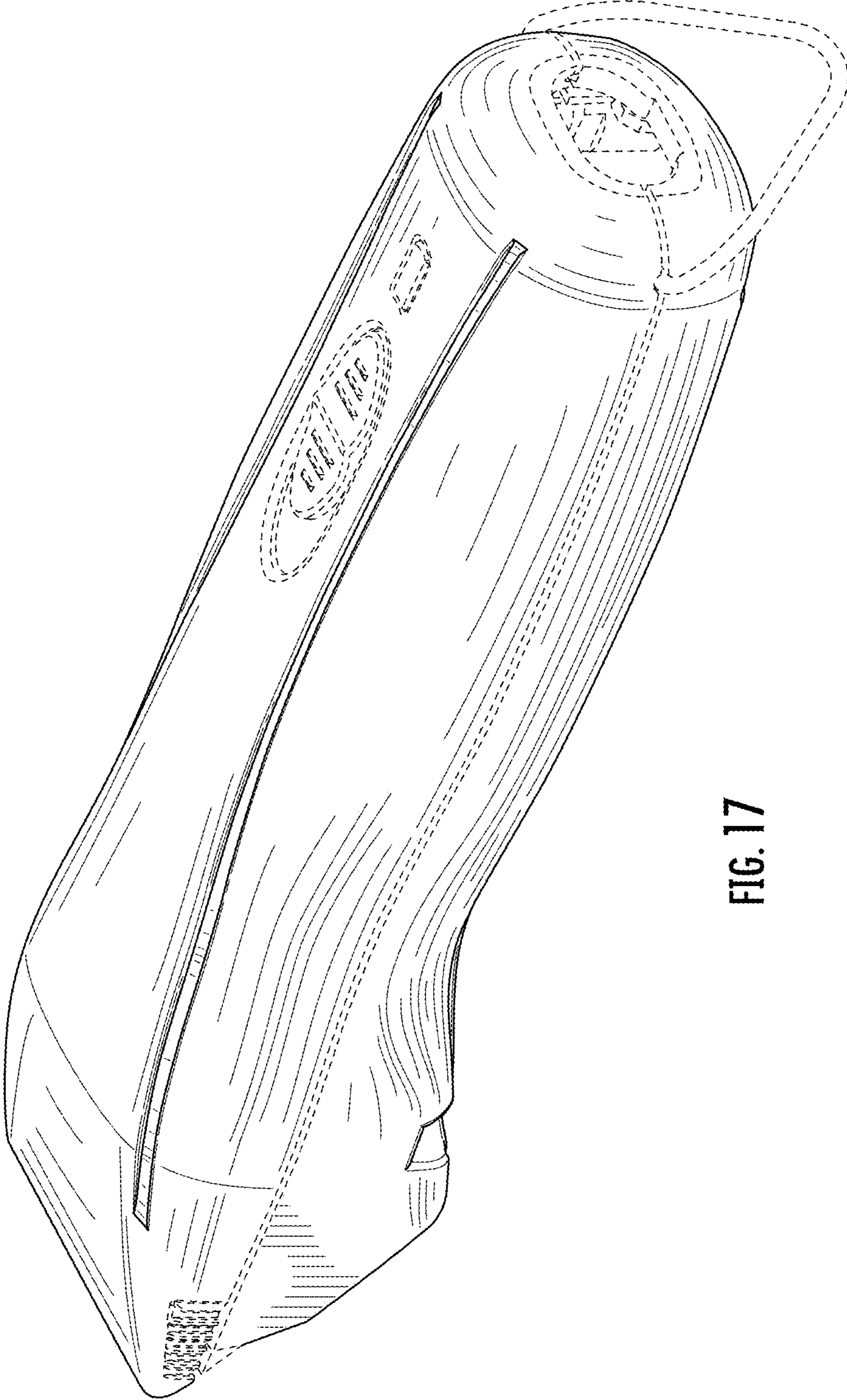

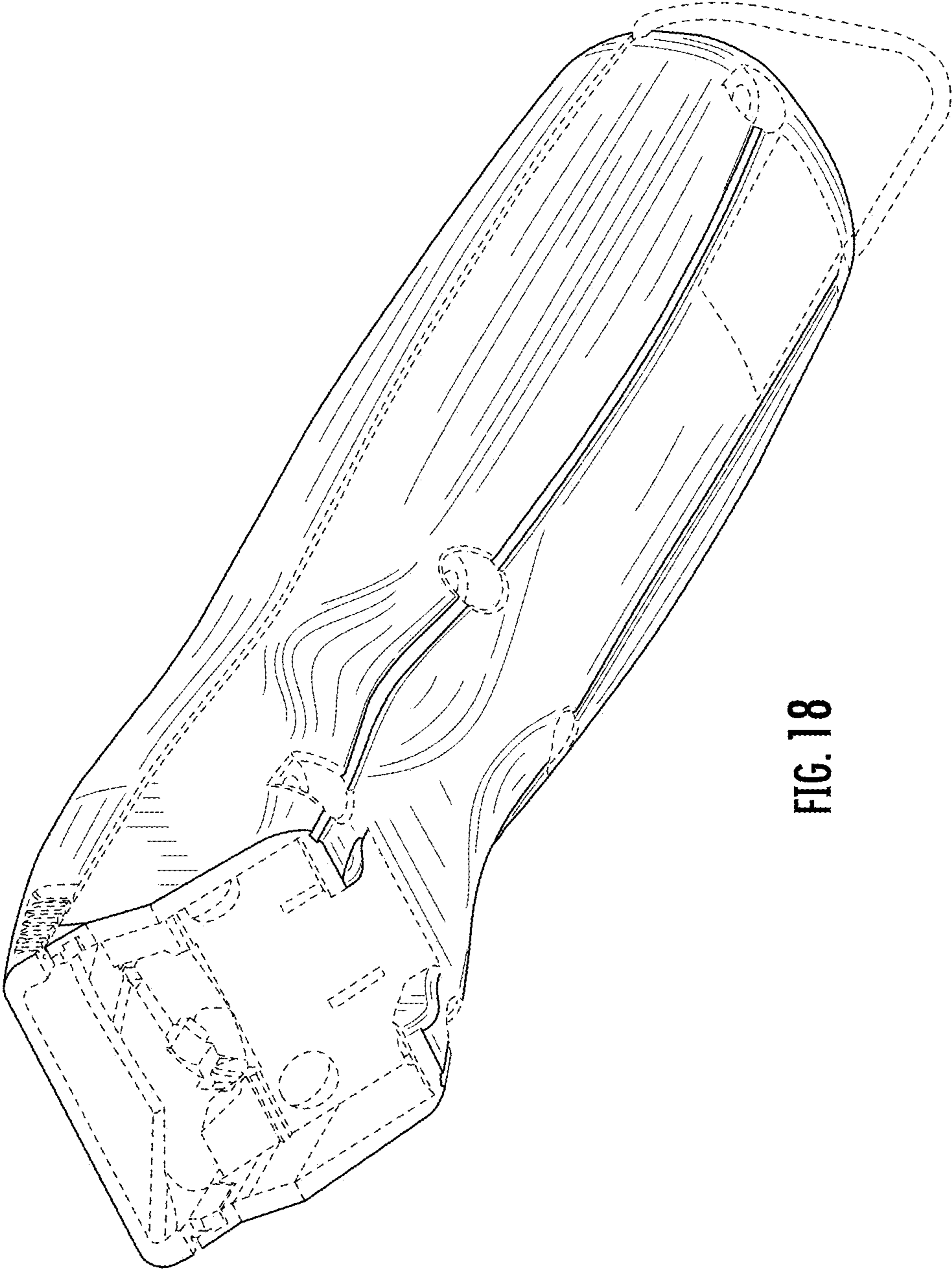

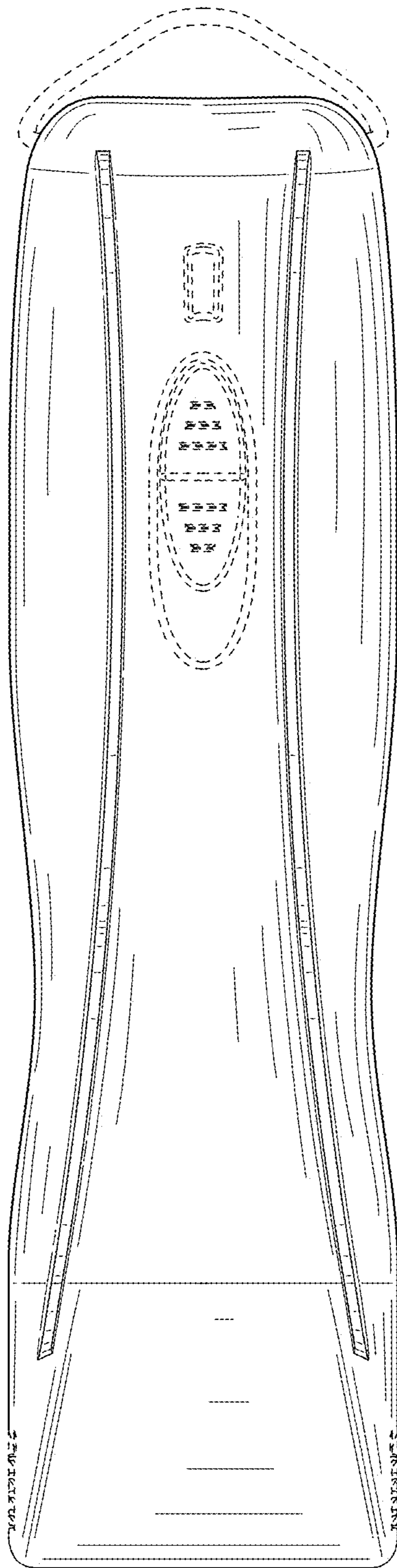

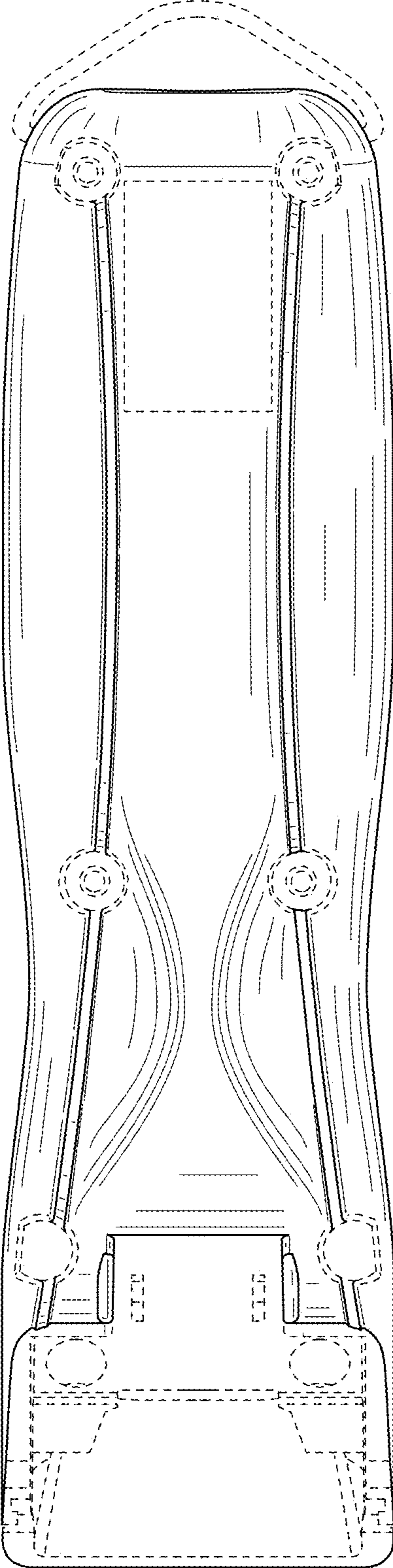

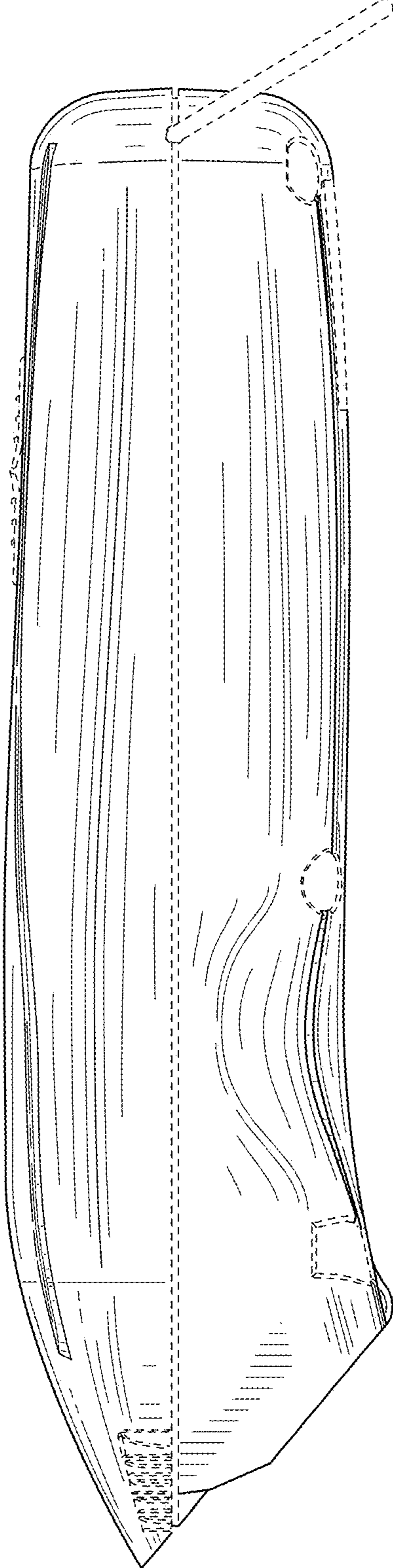

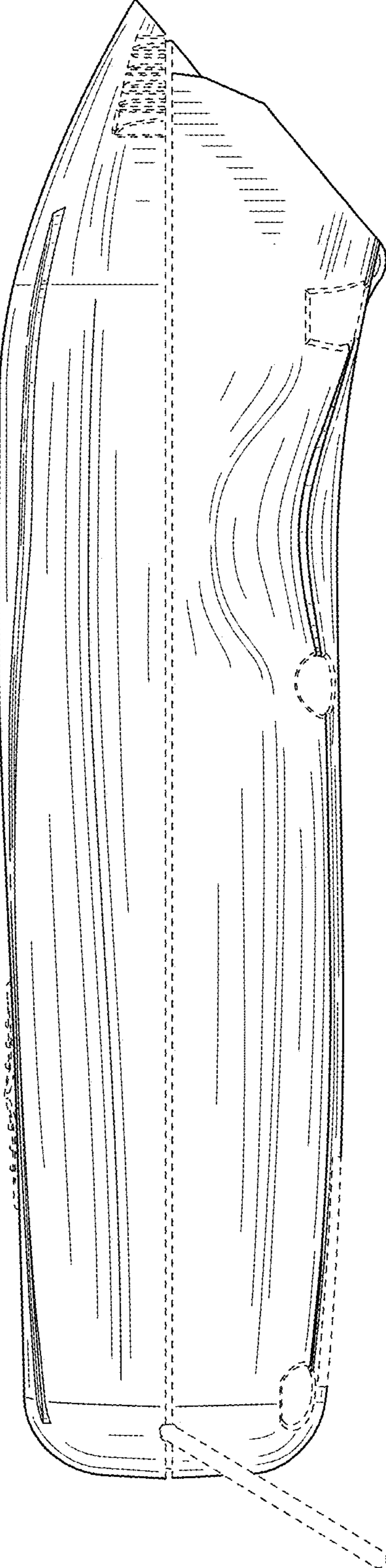

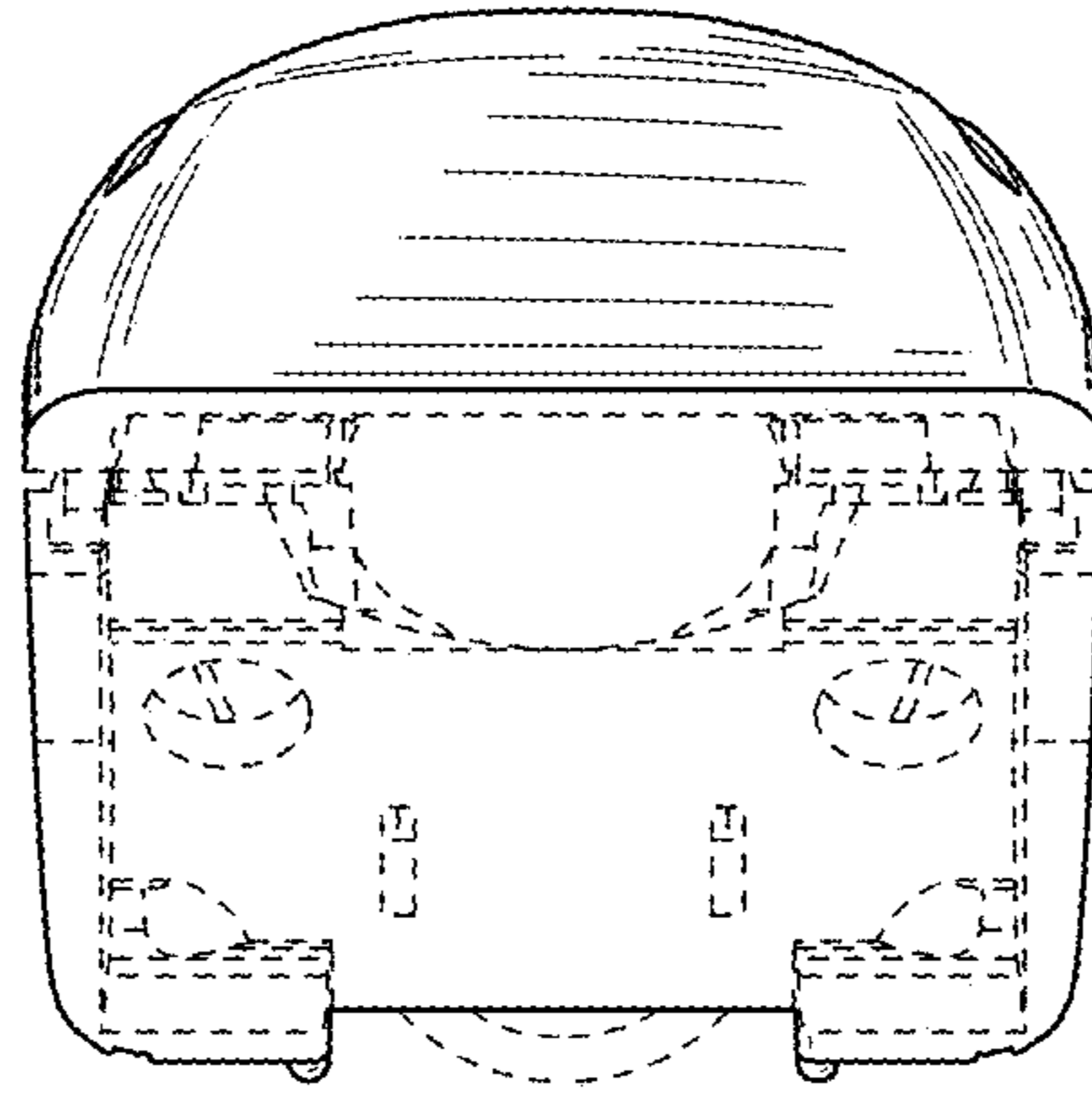

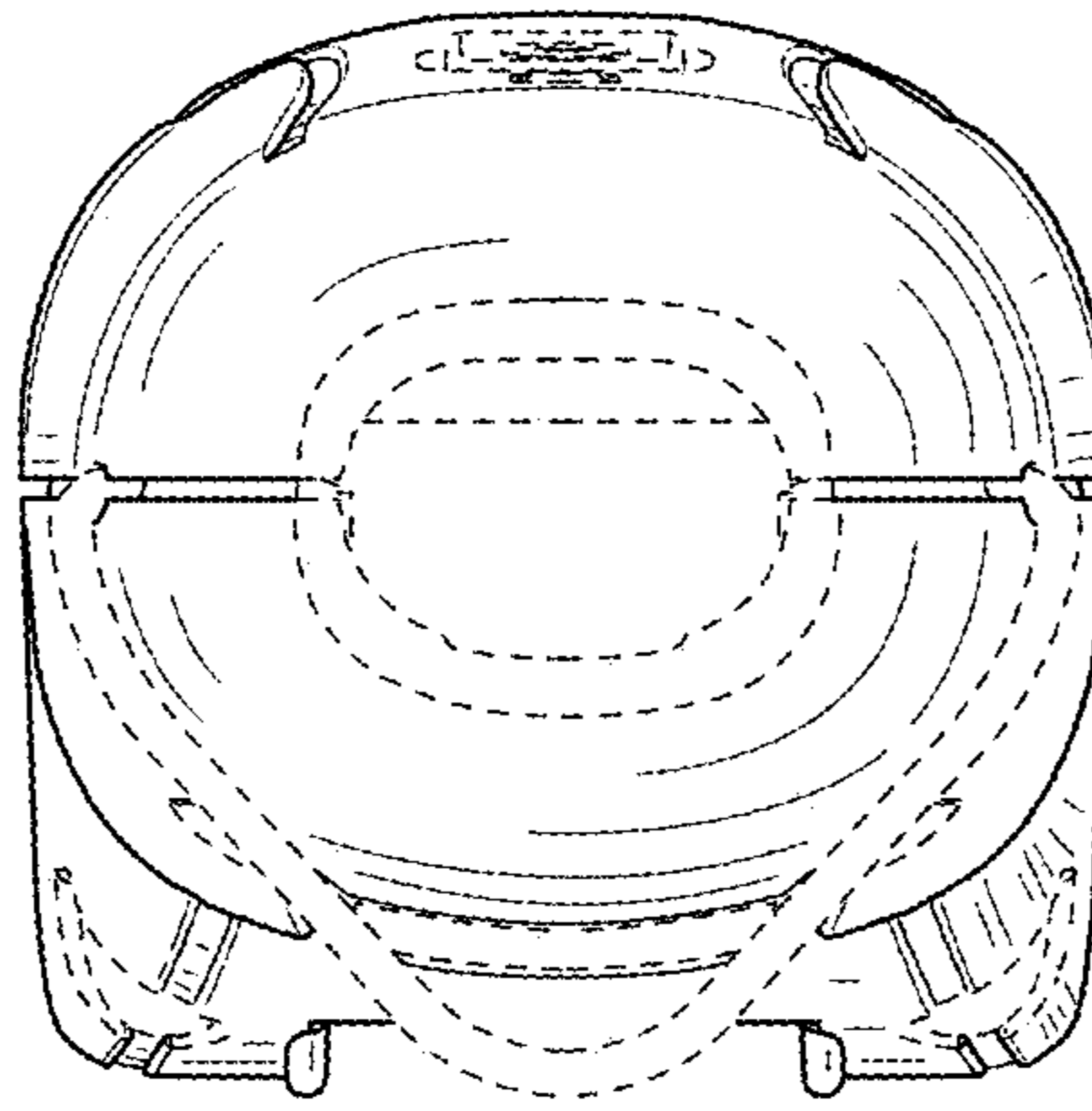

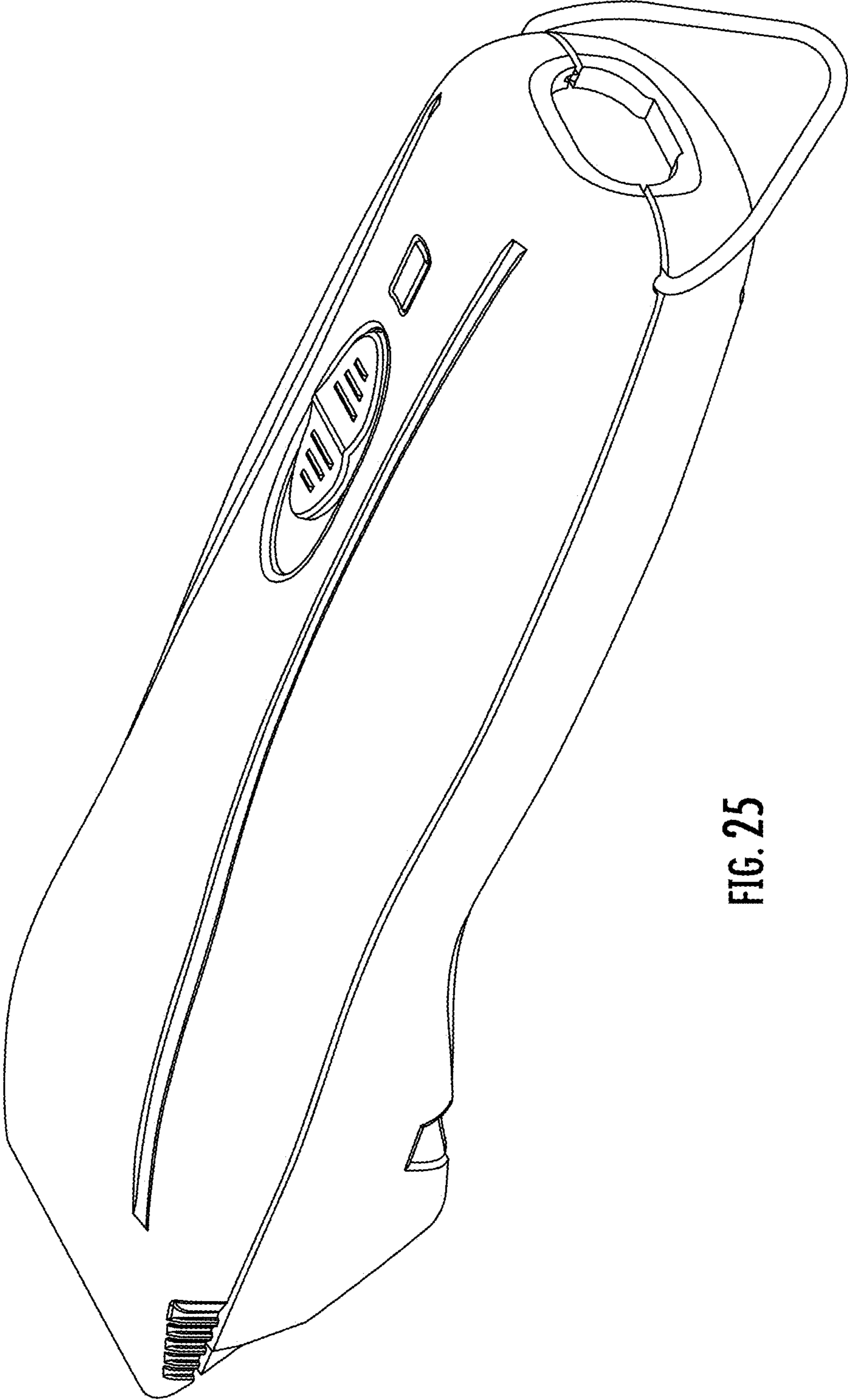

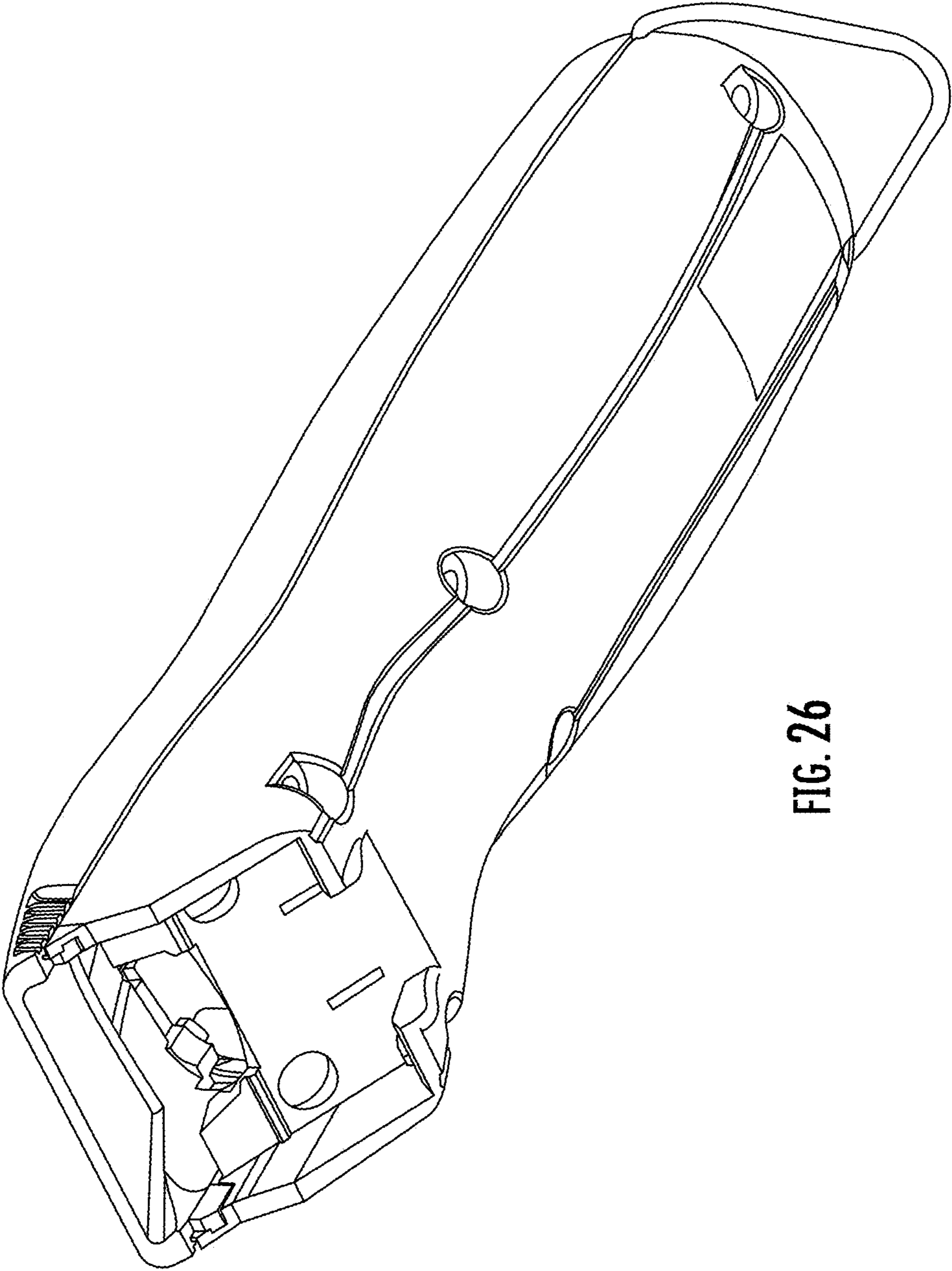

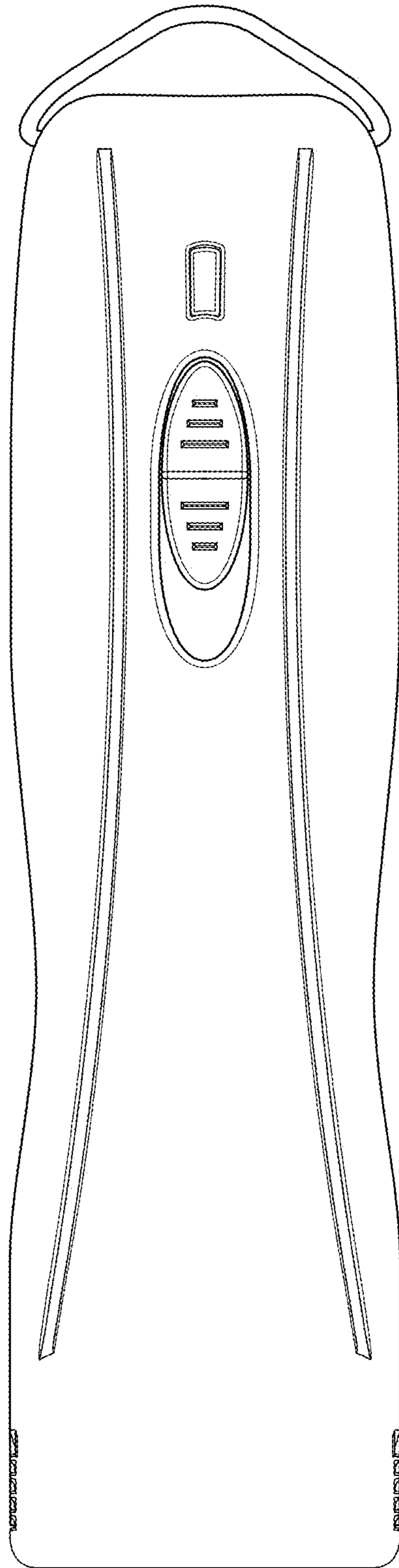

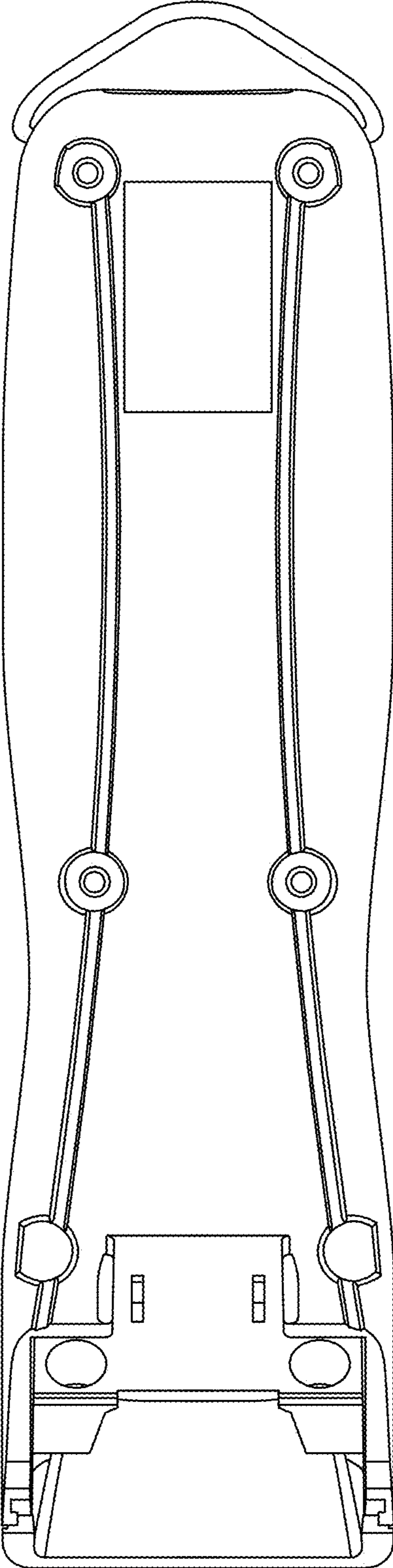

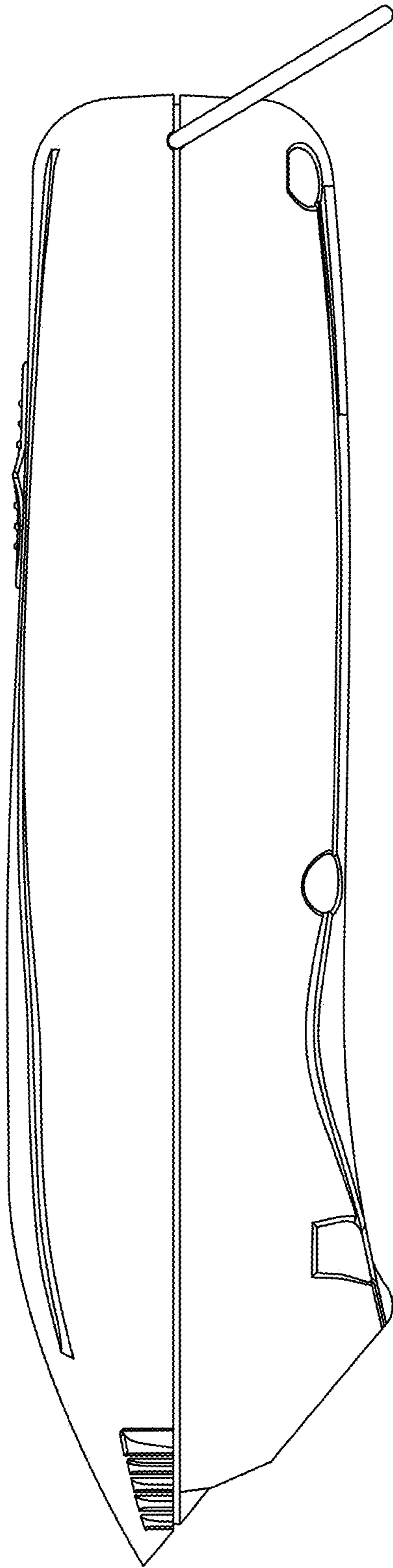

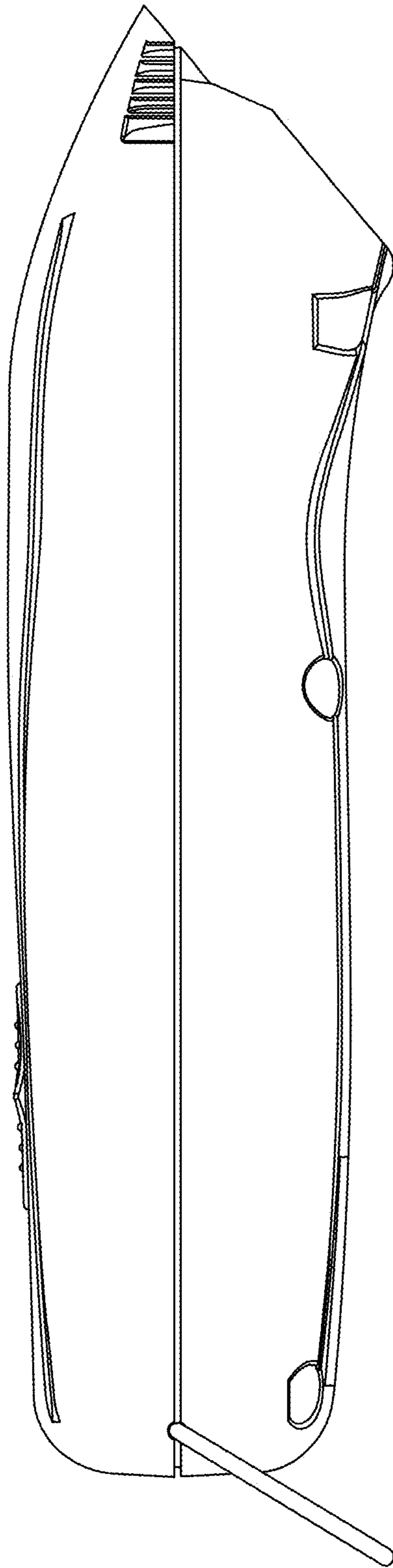

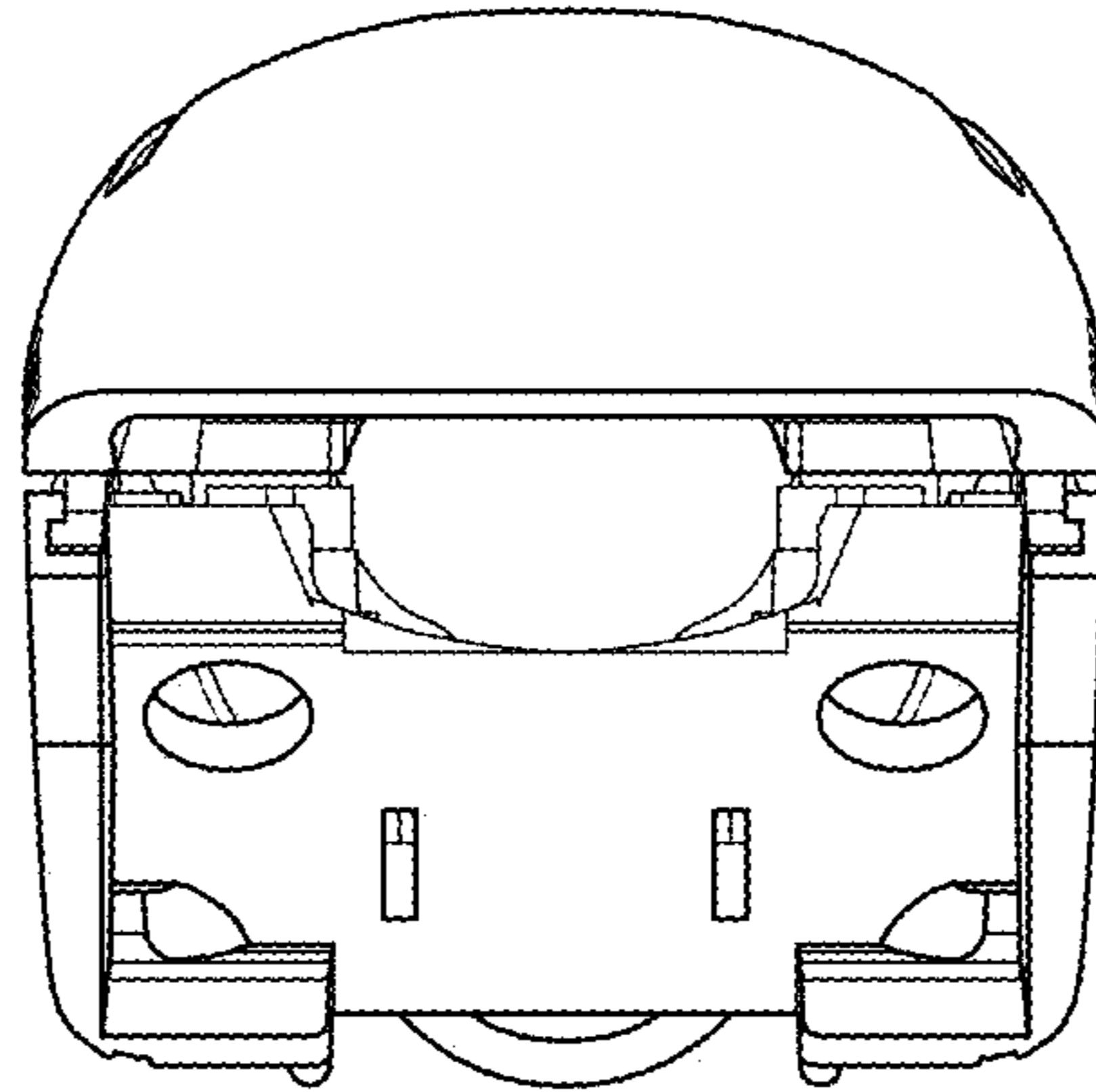

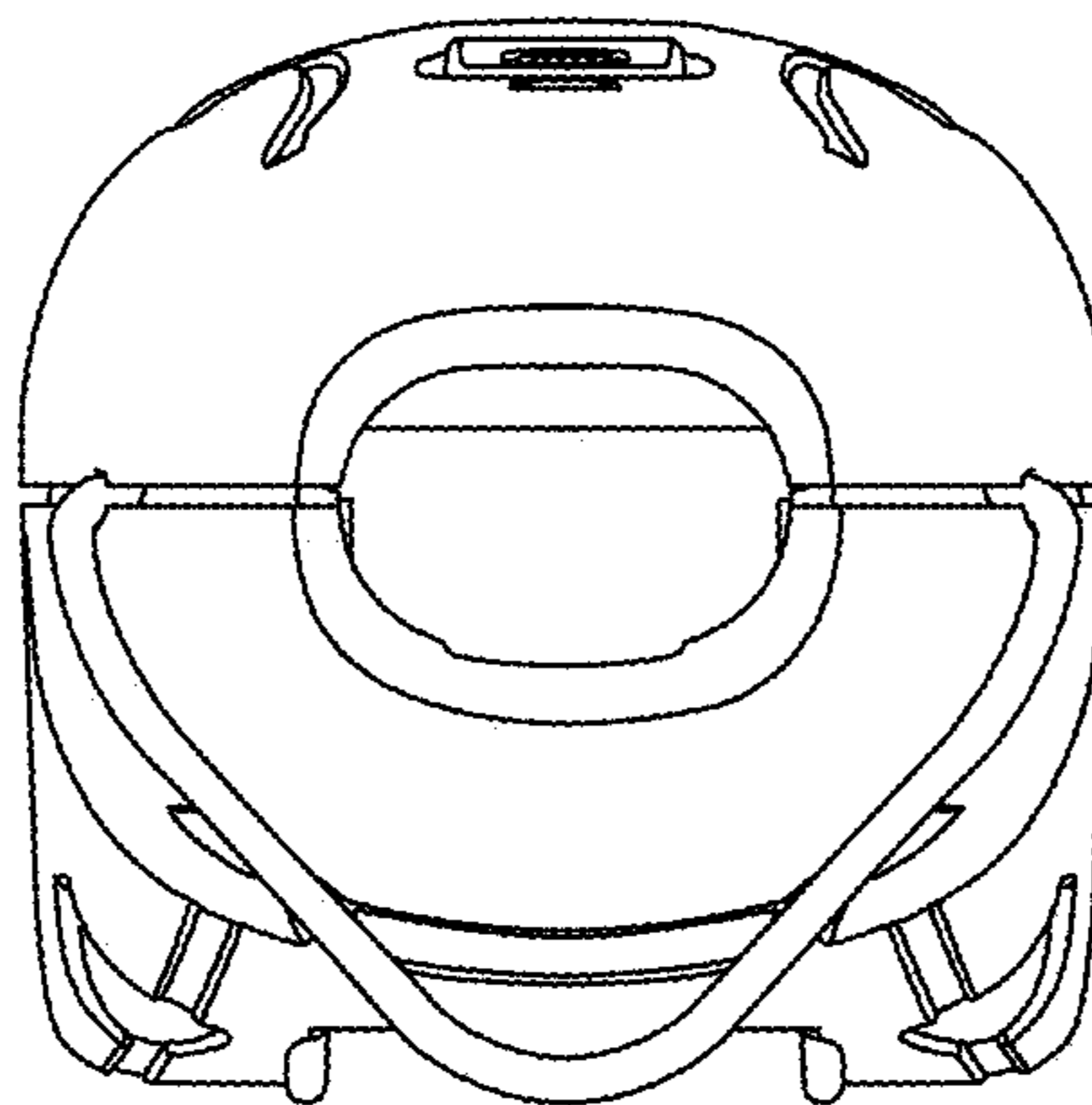
