(57) **CLAIM**

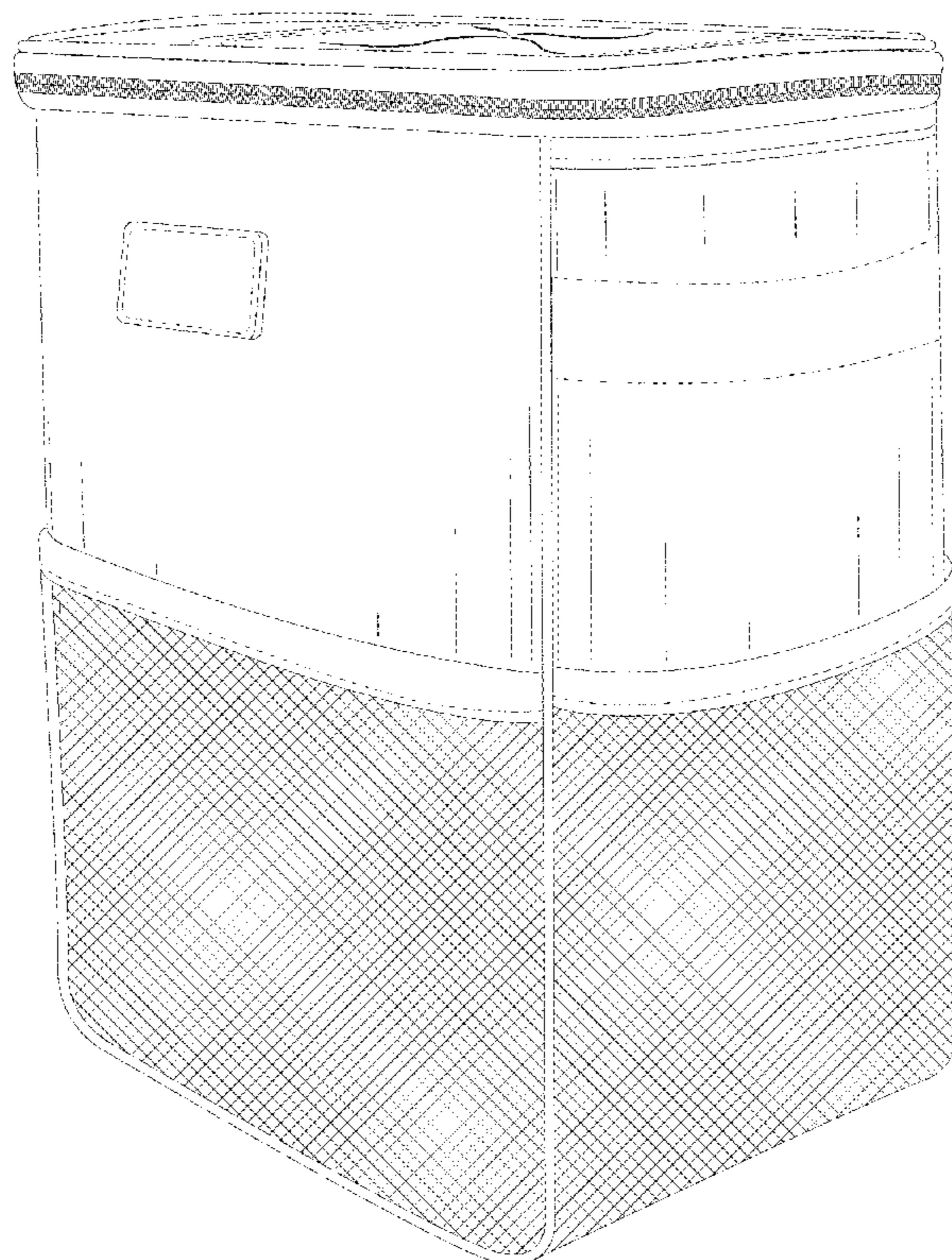
I claim the ornamental design for a car trash can, as shown and described.

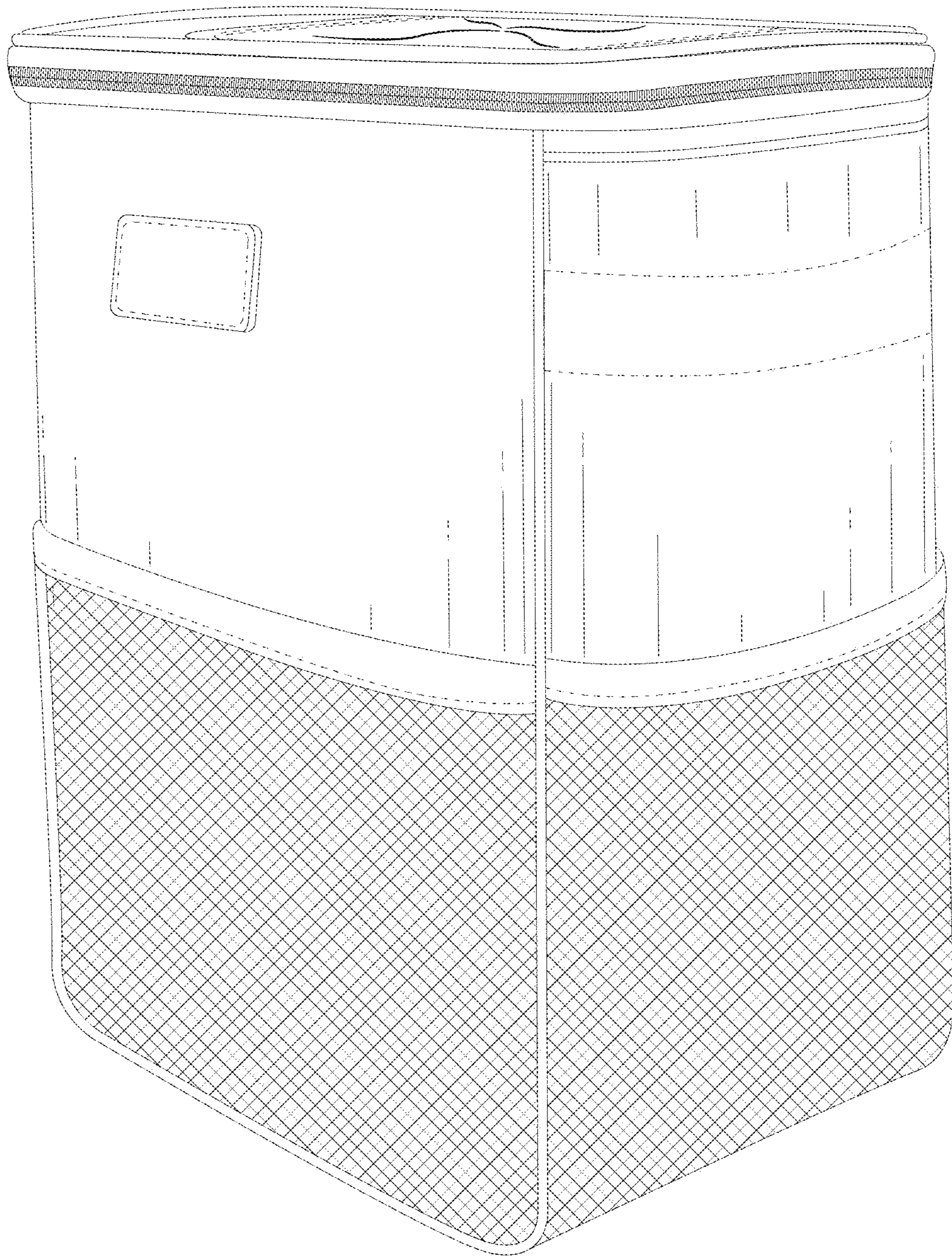

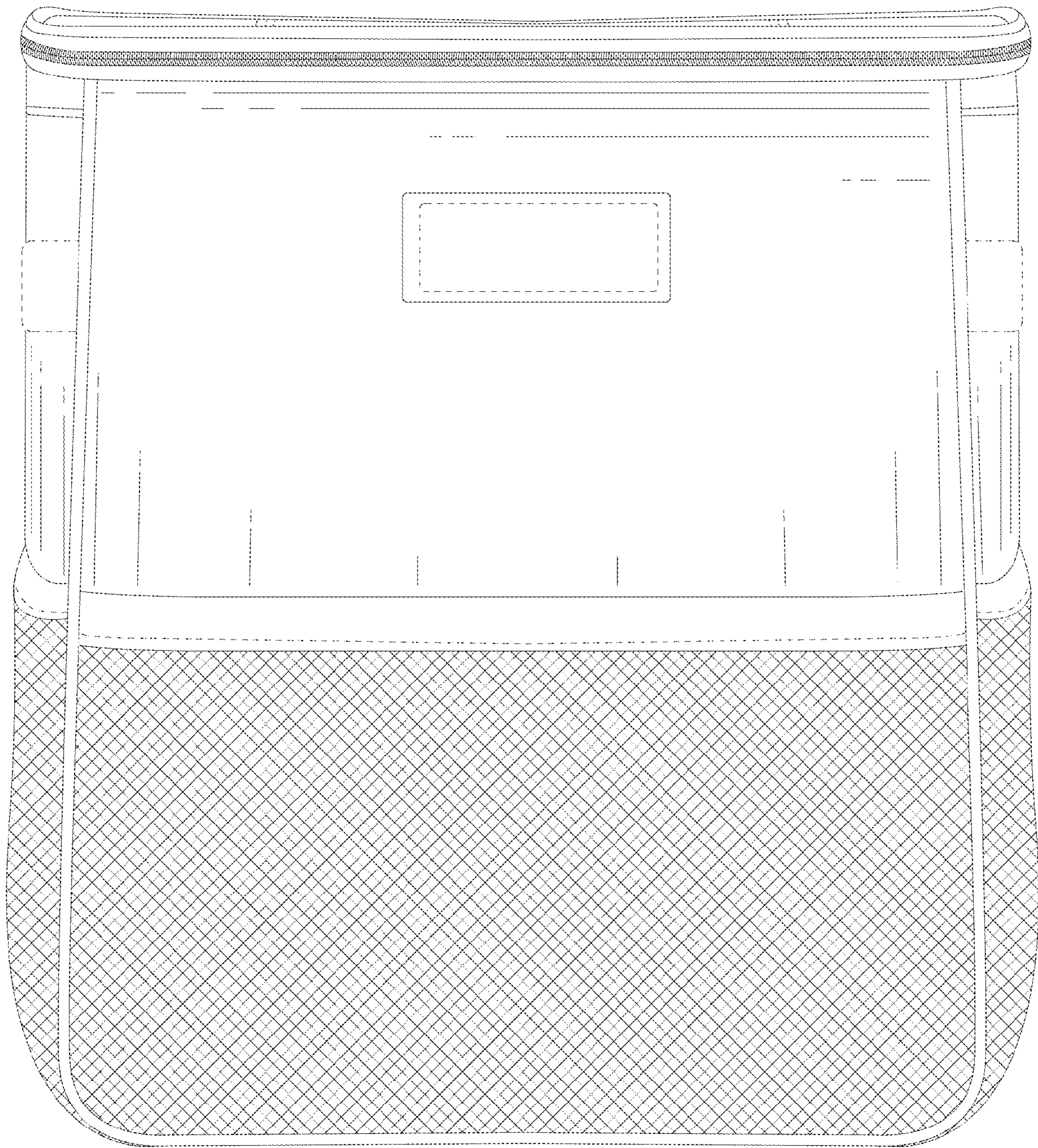

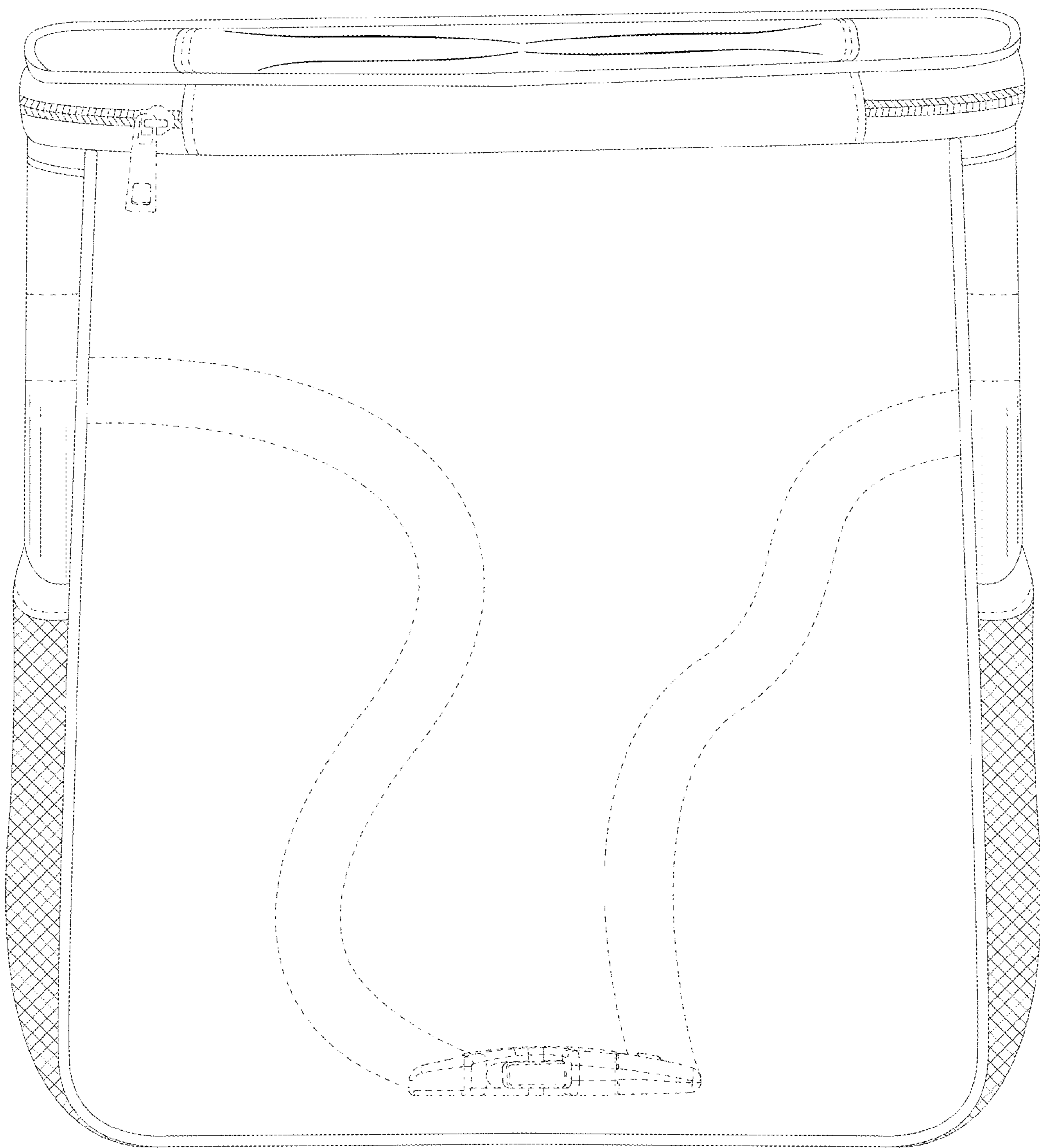

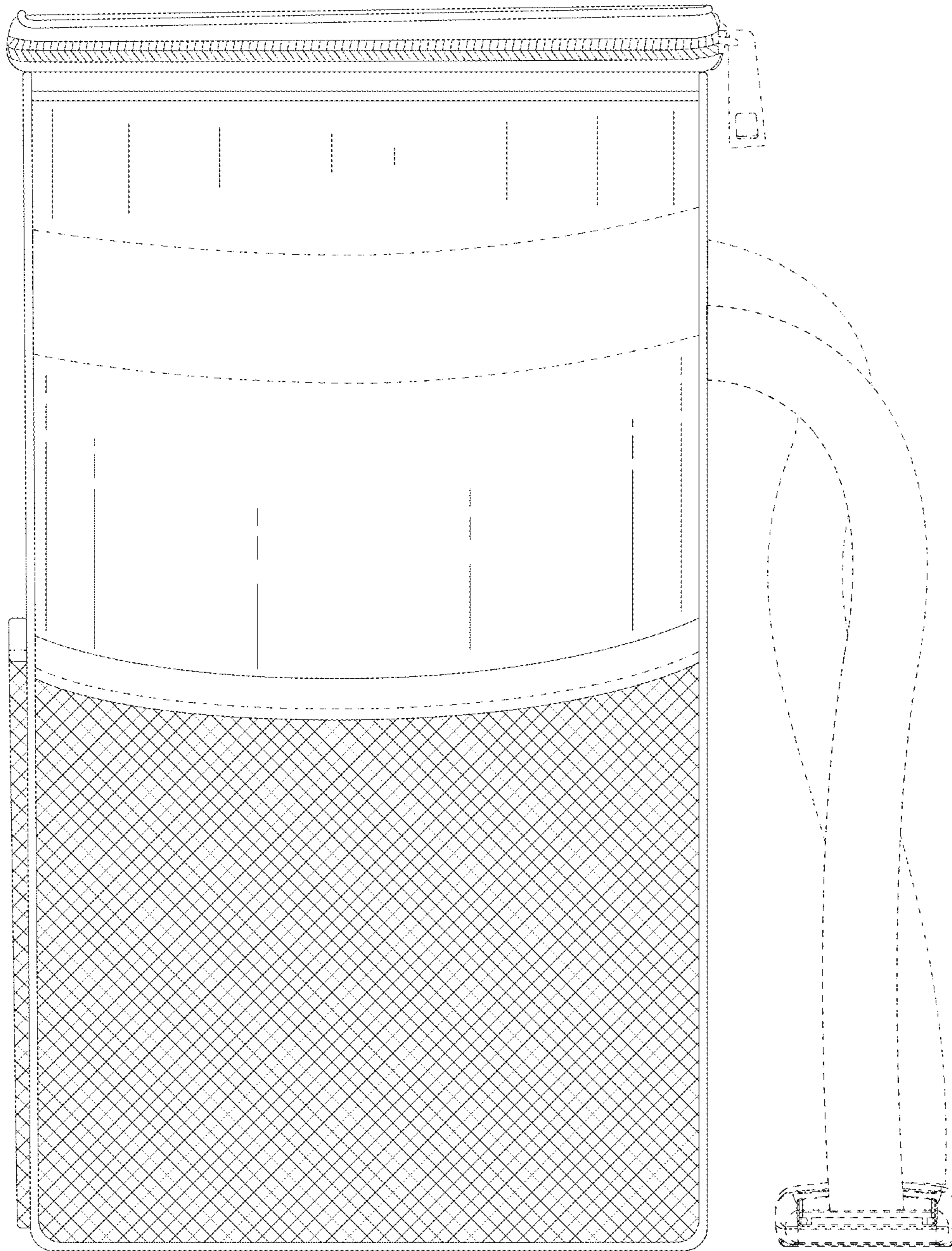

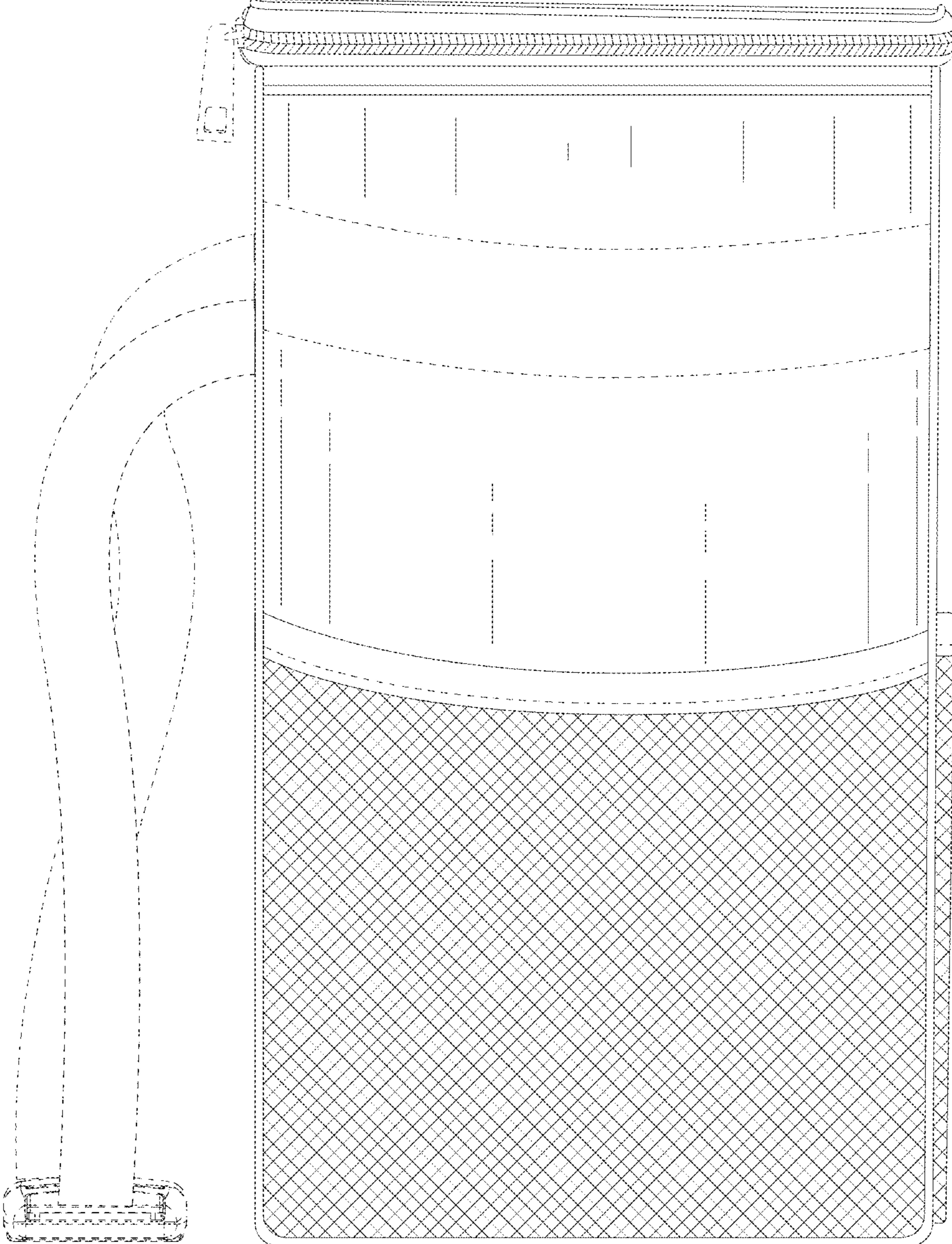

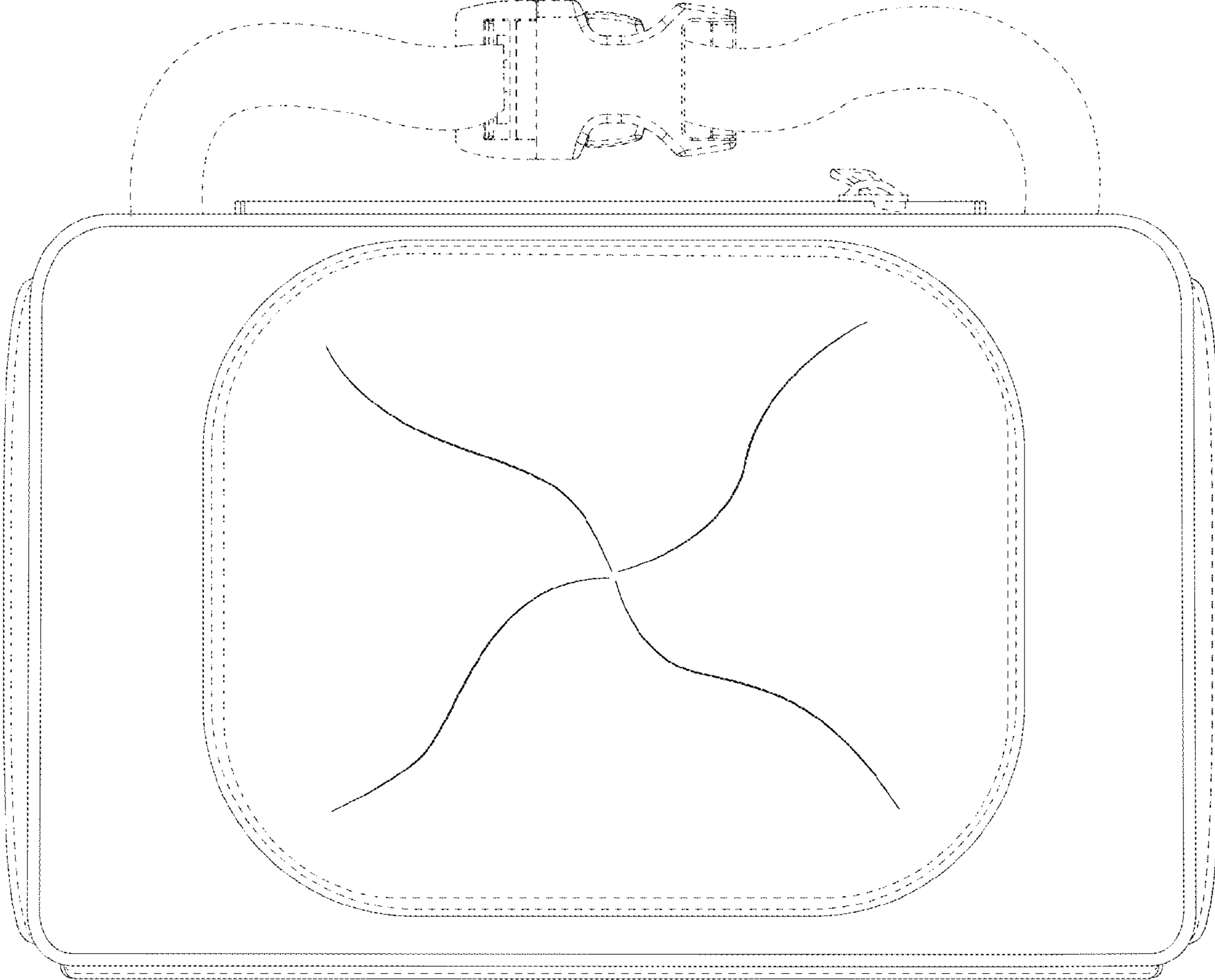

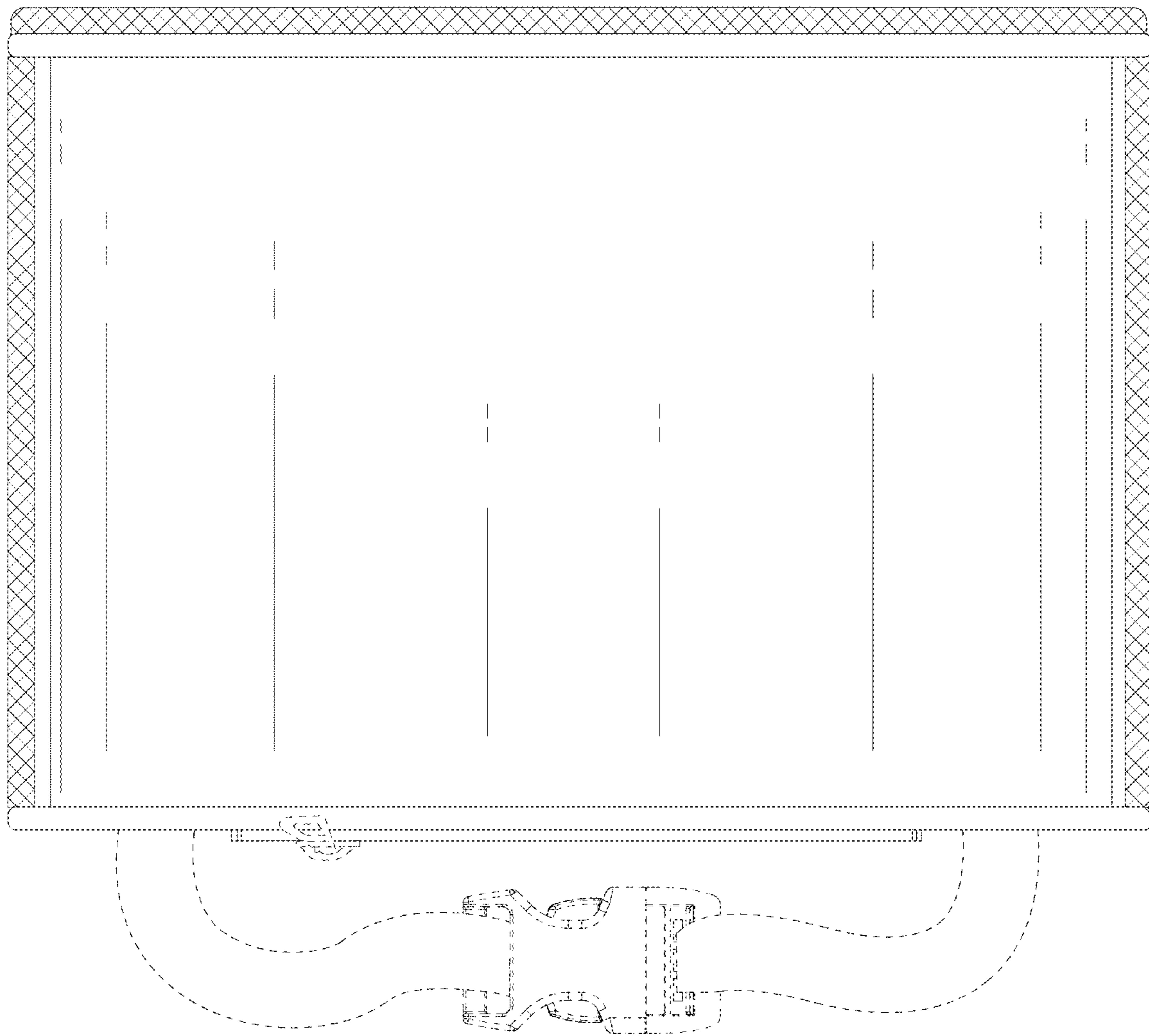
