(57) **CLAIM**

The ornamental design for a fumigation facilitating and bug-resistant covering, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a fumigation facilitating and bug-resistant covering, showing my design;

FIG. 19 is a right side view thereof;


FIG. 20 is a top view thereof; and,








































