(57) **CLAIM**

The ornamental design for a hoodie with a head covering, as shown and as described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a hoodie with a head covering showing my new design; FIG. 2 is a right side view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a back view thereof; and, FIG. 6 is a top view thereof. The broken lines included in the Figures above represent environmental structure and form no part of the claimed design. The design is shown with a symbolic break in its length, which indicates an indeterminate length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

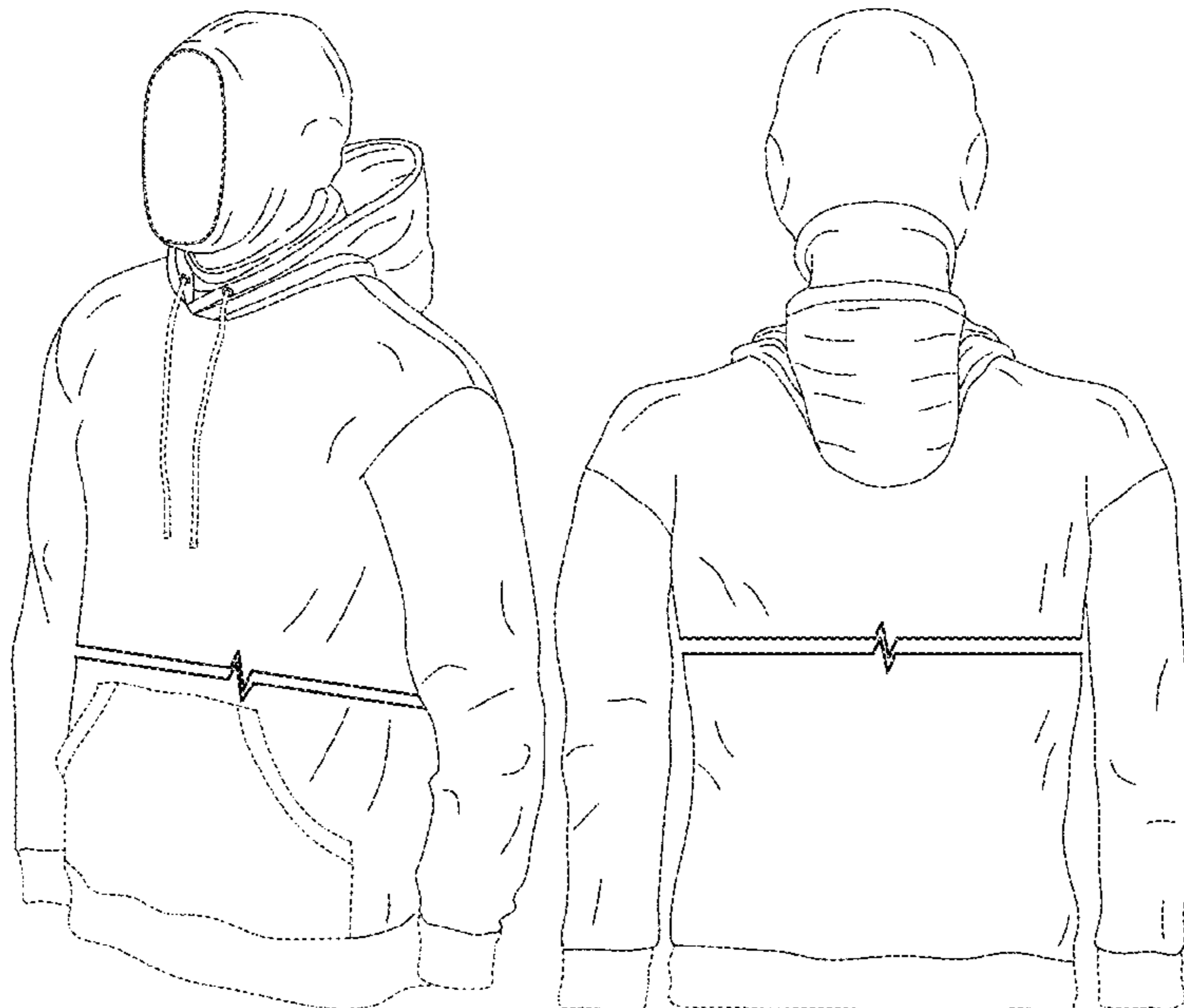

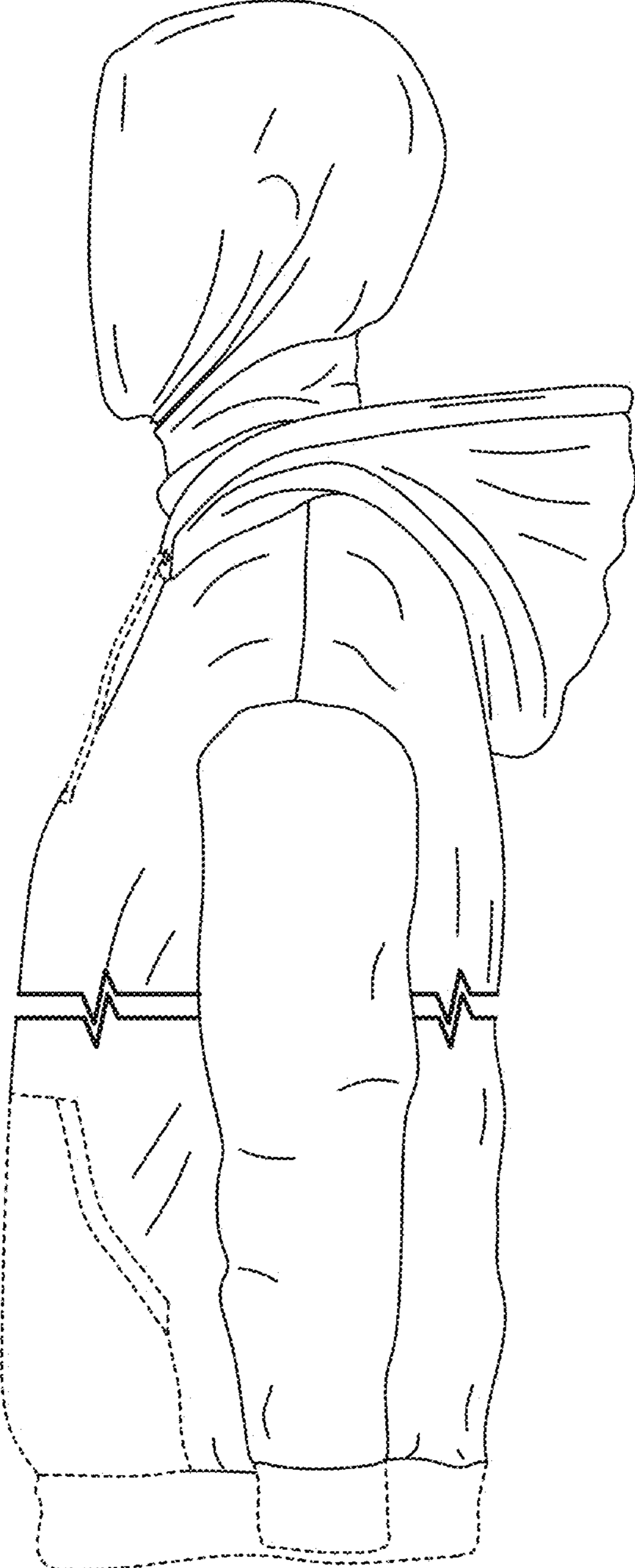

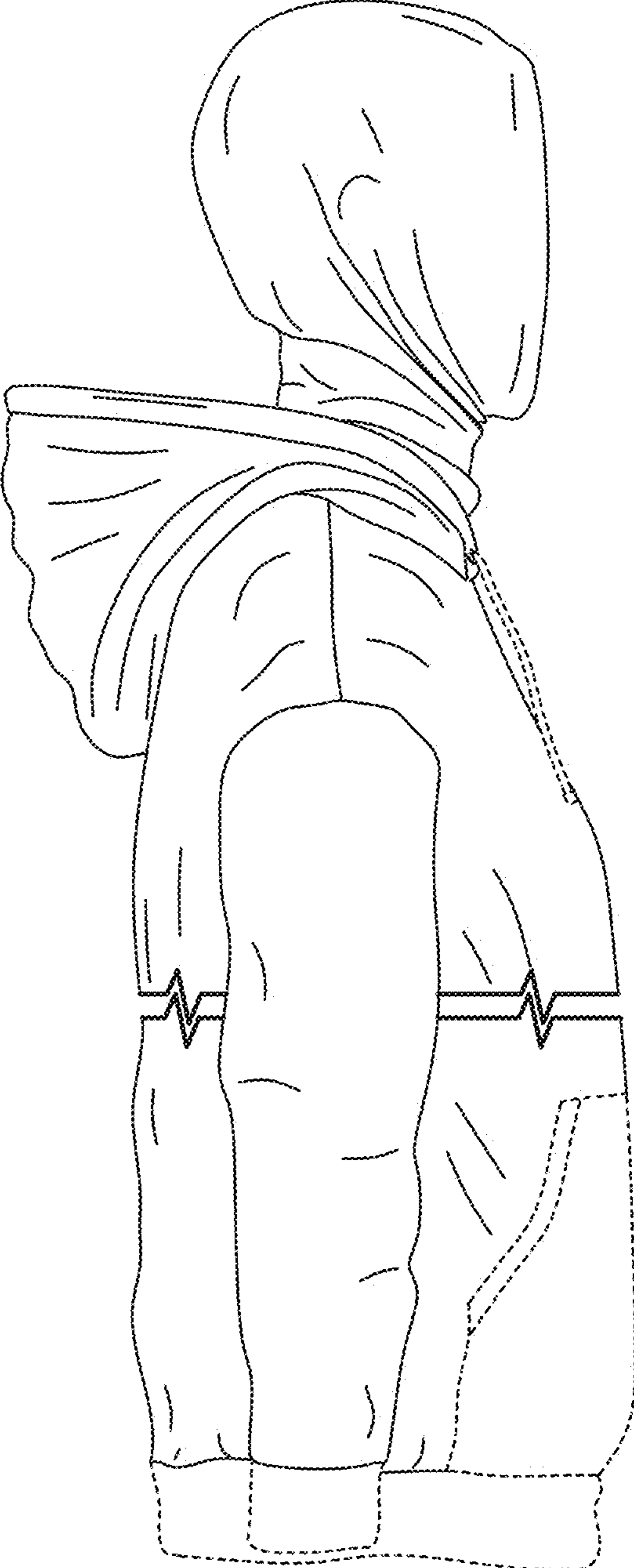

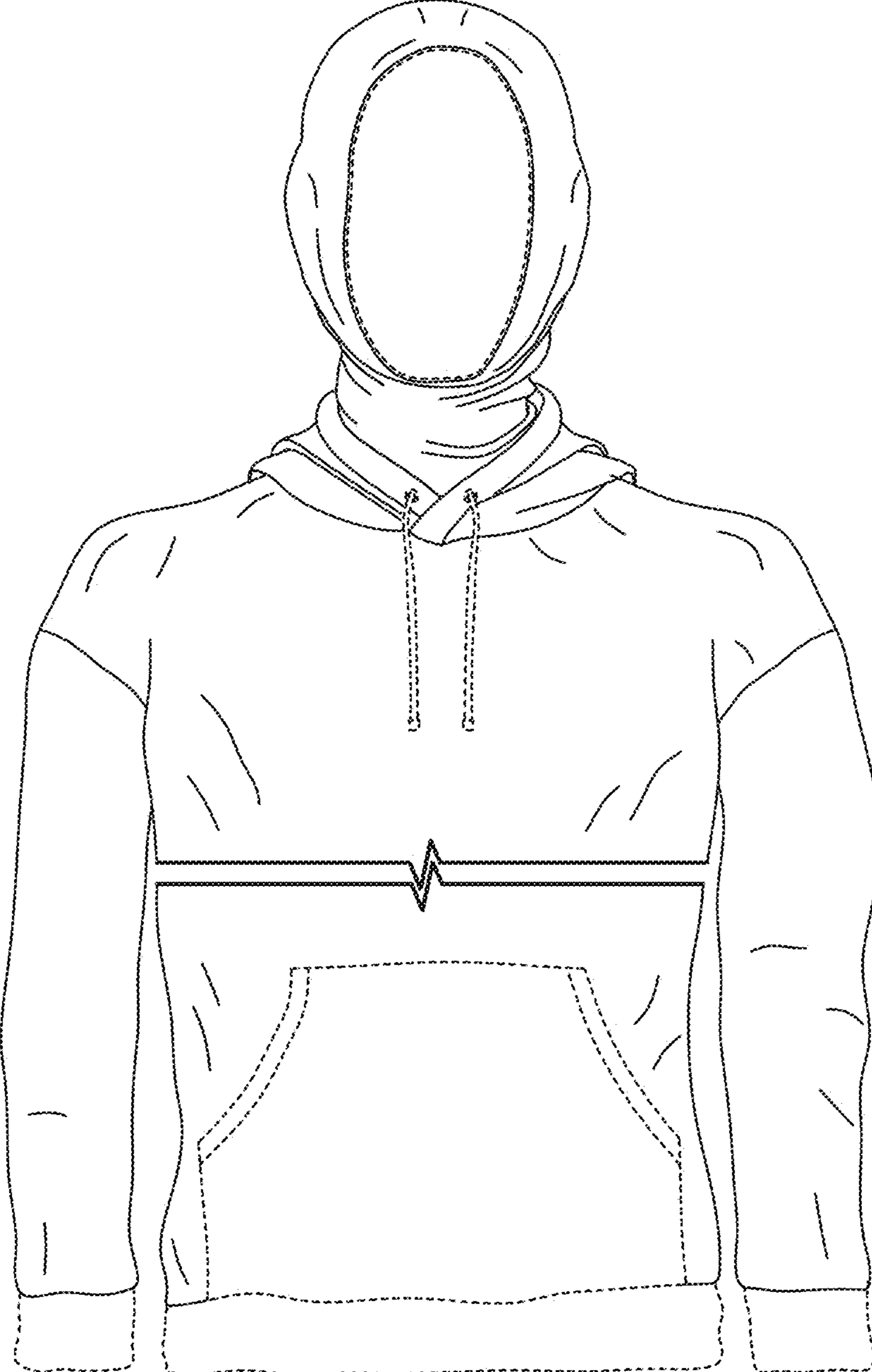

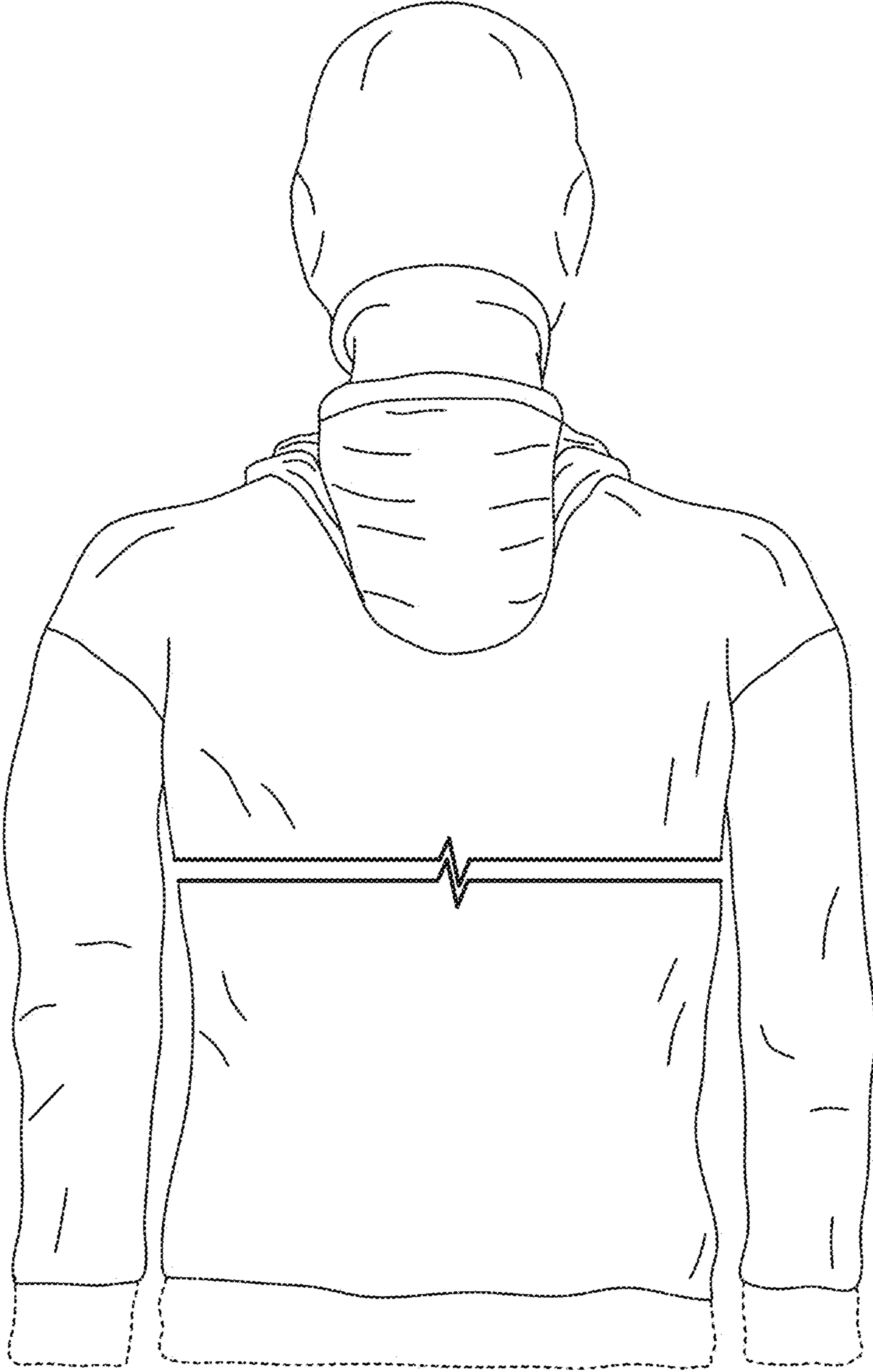

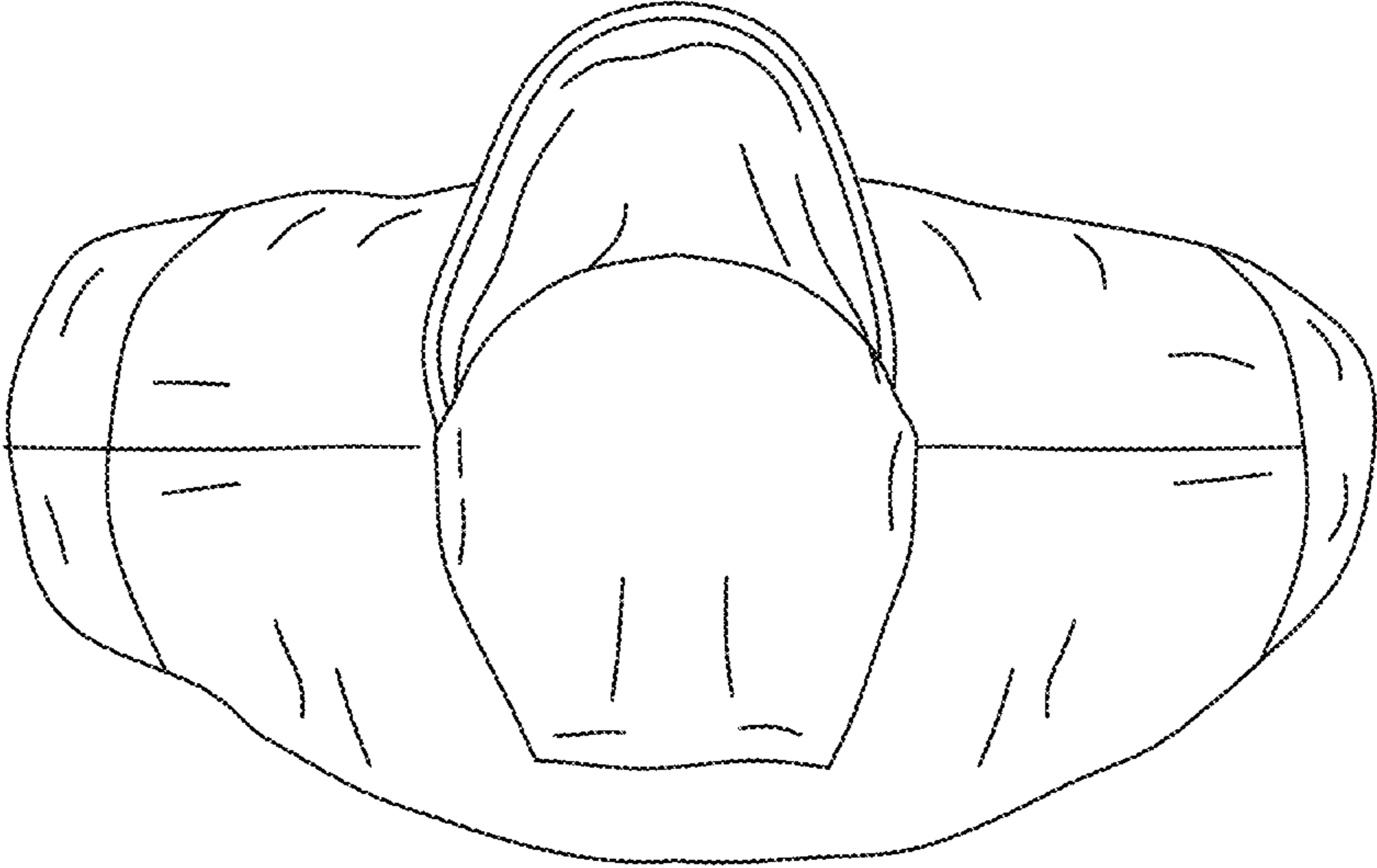
