The ornamental design for an interlocking gift card sleeve, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the interlocking gift card sleeve of the present invention, in a closed position.

FIG. 2 is a front view of FIG. 1.

FIG. 3 is a rear view of FIG. 1.

FIG. 4 is a top down view of FIG. 1.

FIG. 5 is a bottom up view of FIG. 1.

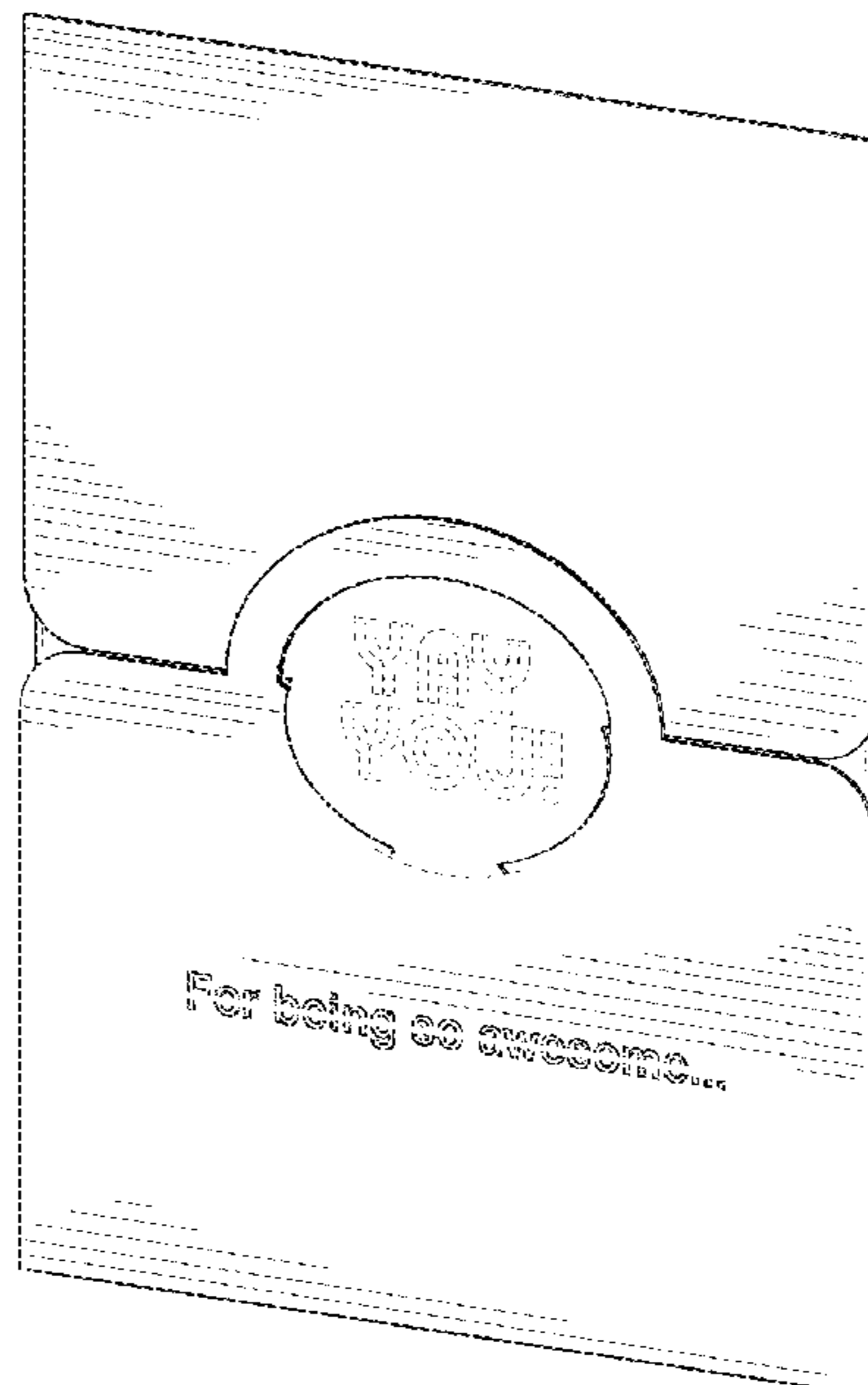
FIG. 6 is a right side view of FIG. 1, the left side view being a mirror image thereof.

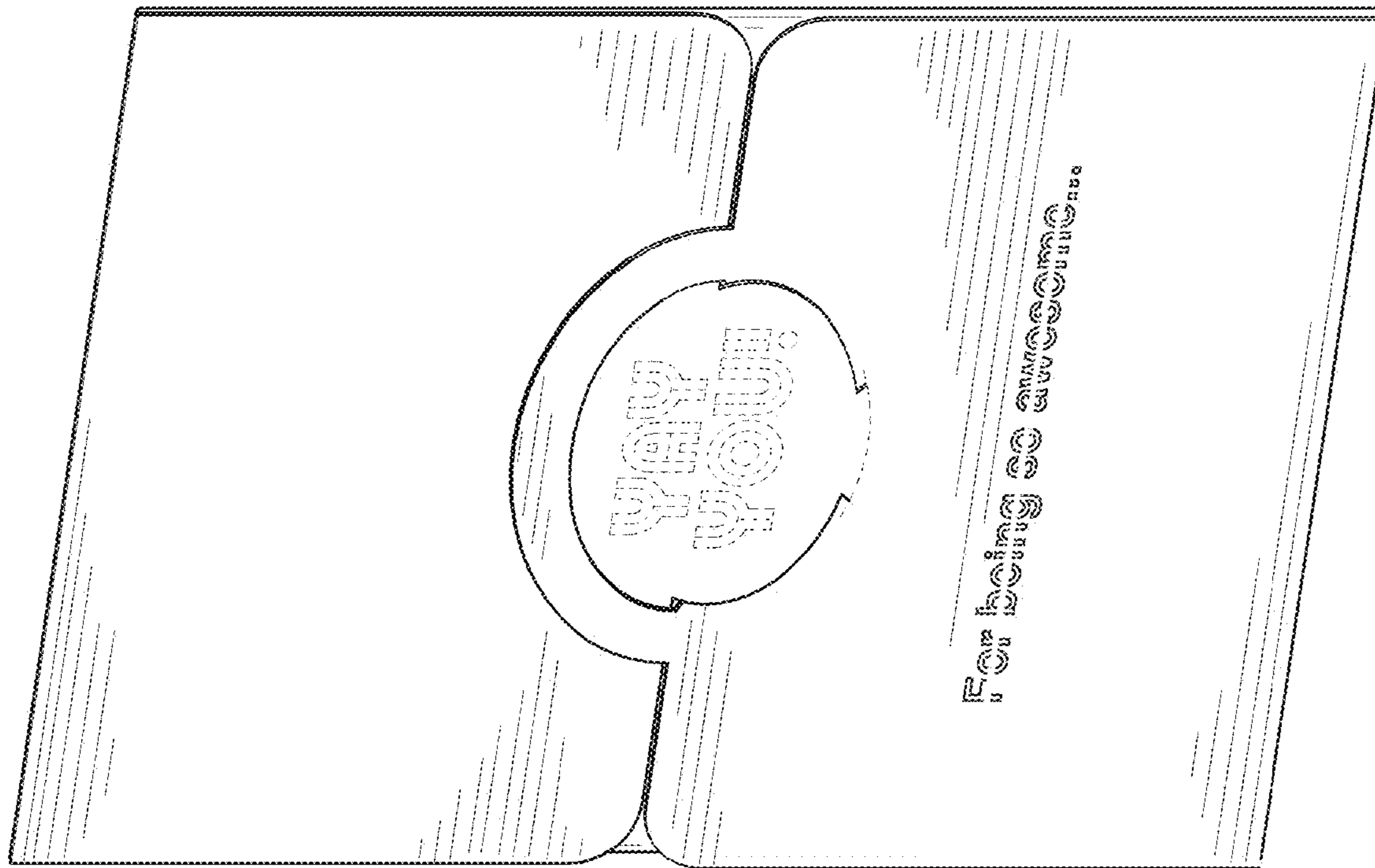

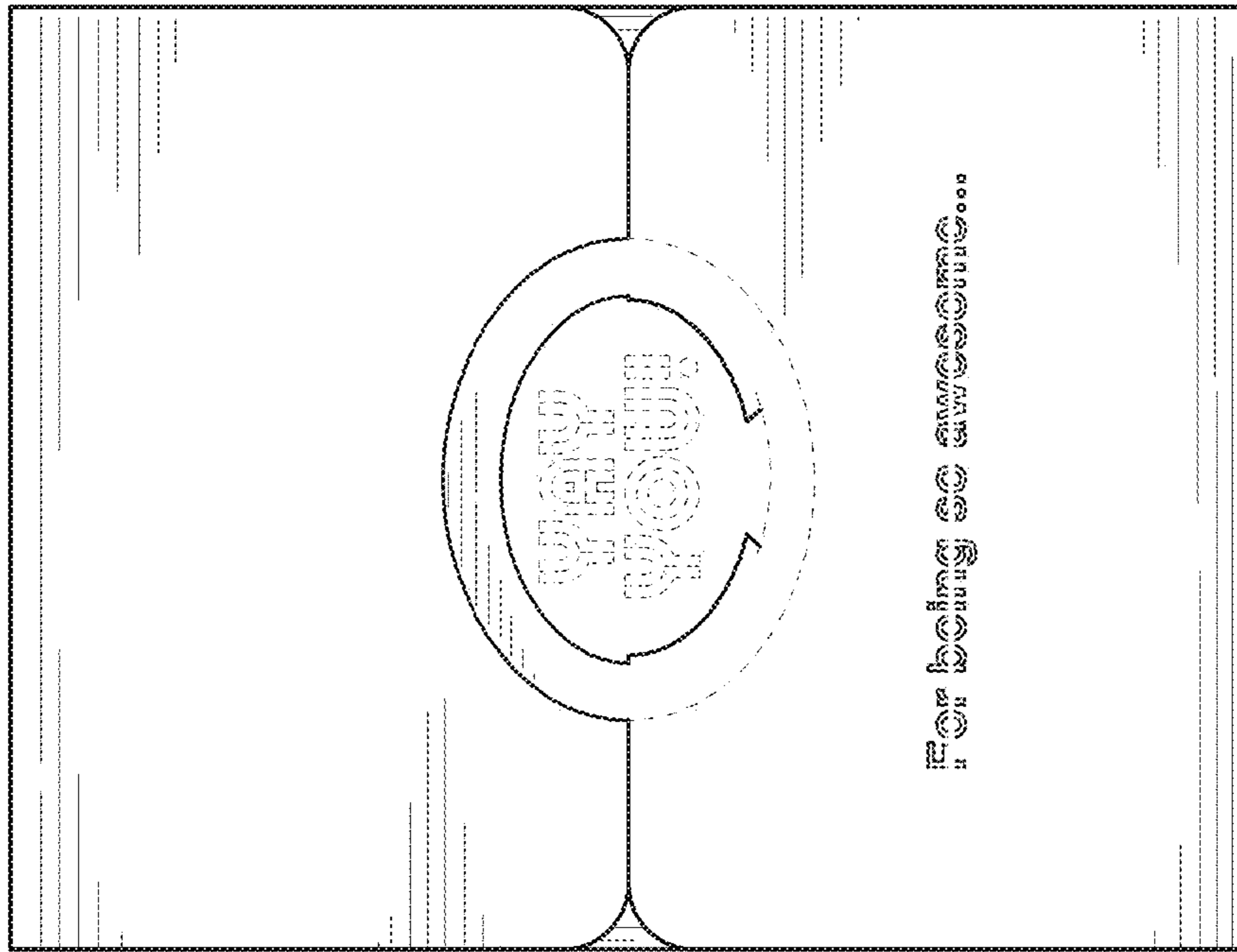

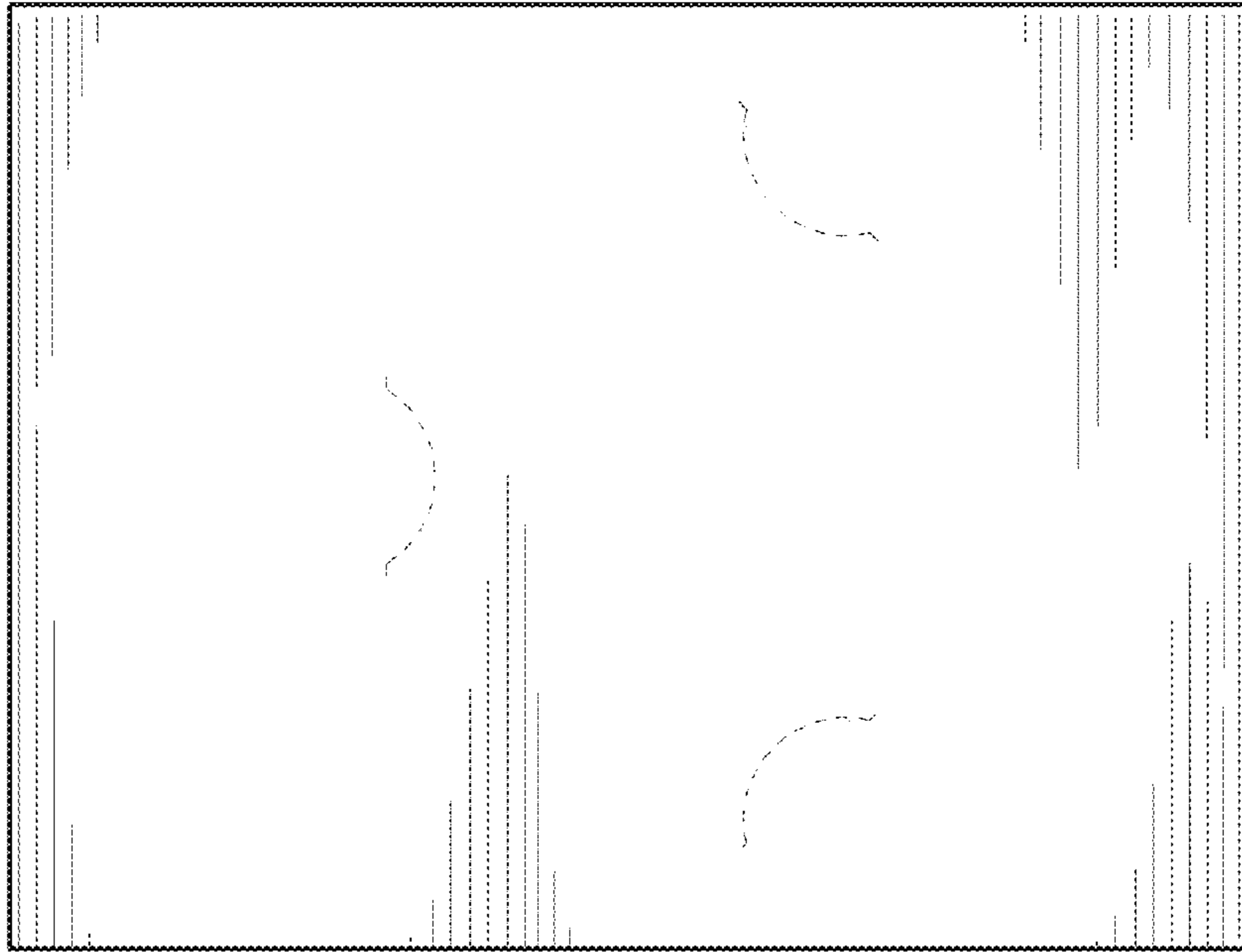

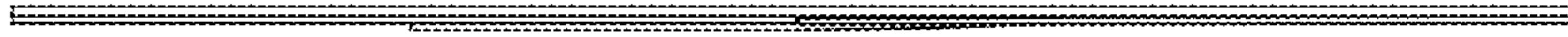

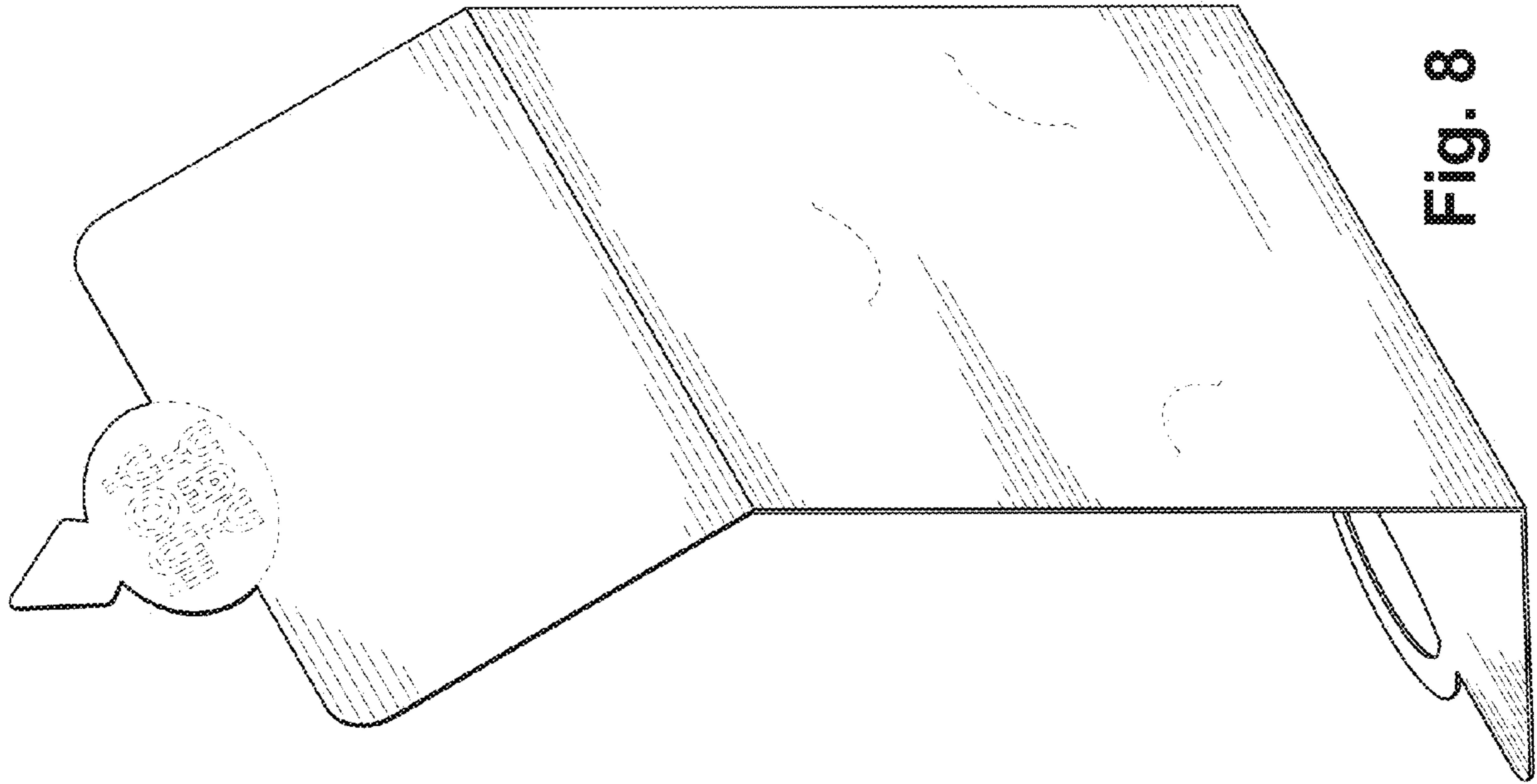

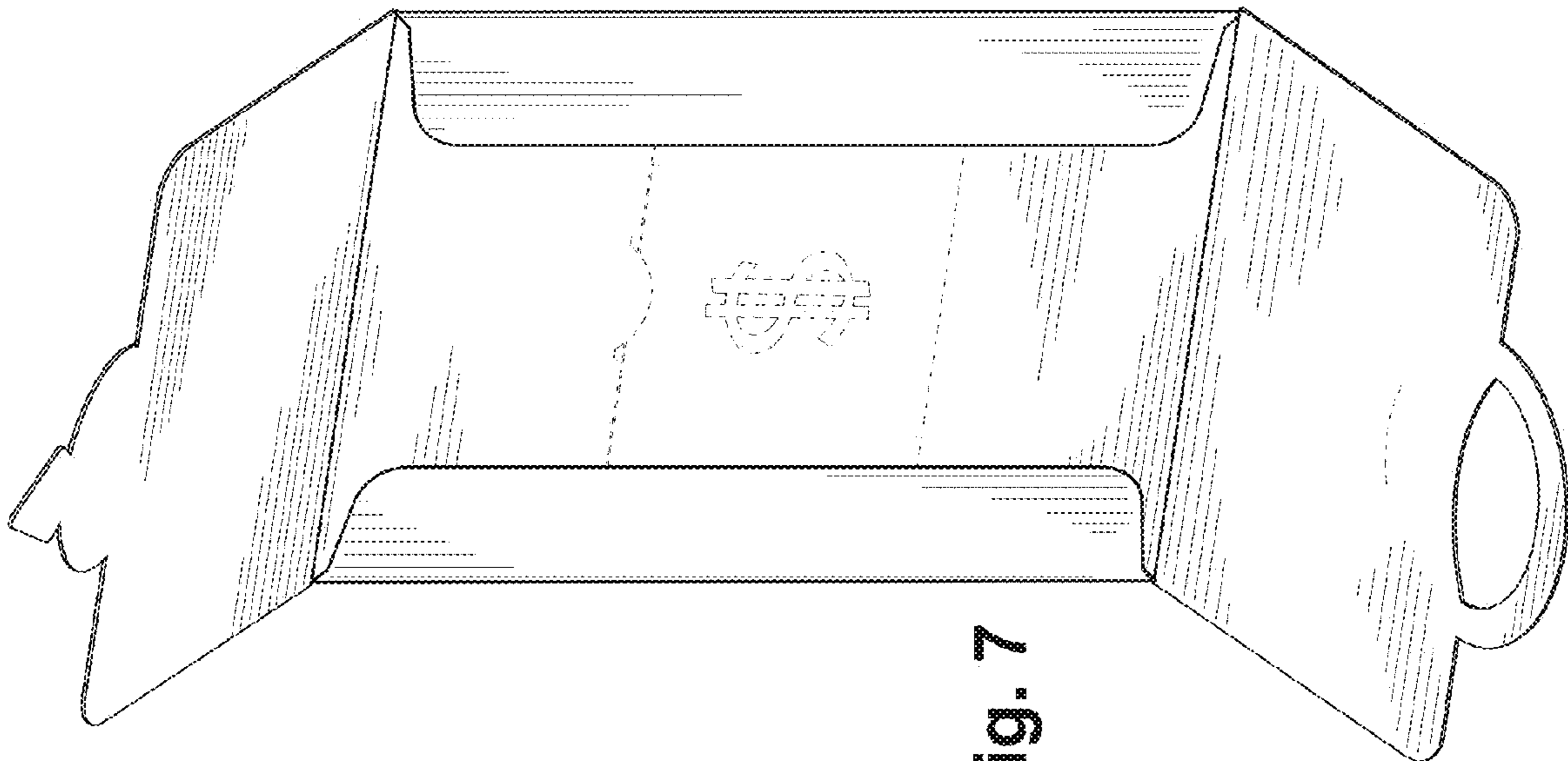
