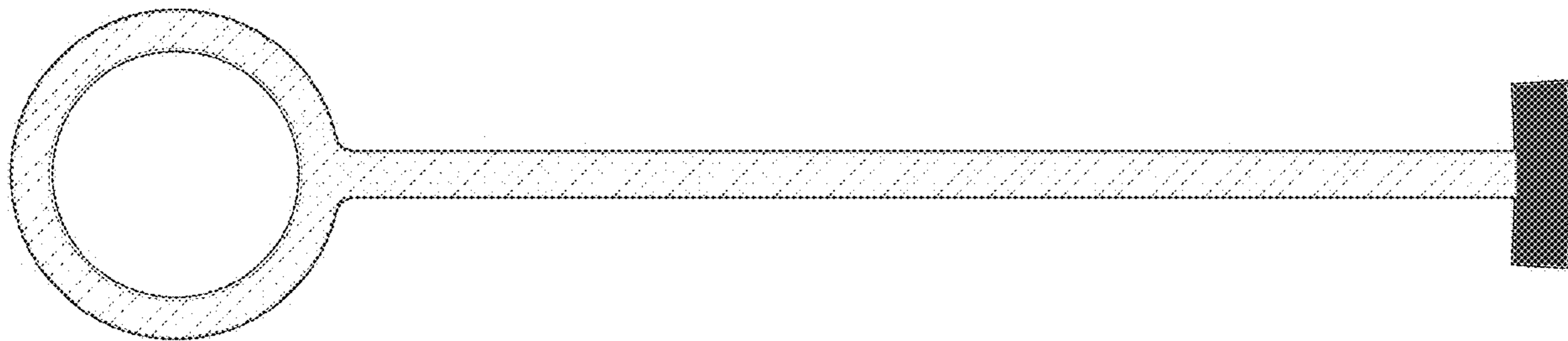

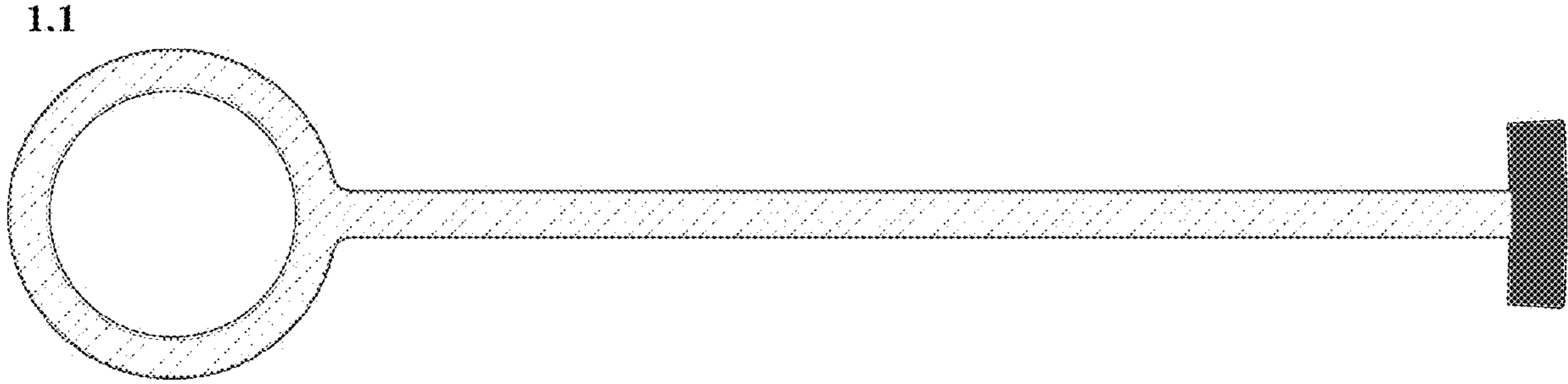
The ornamental design for a timepiece hand, as shown and described.

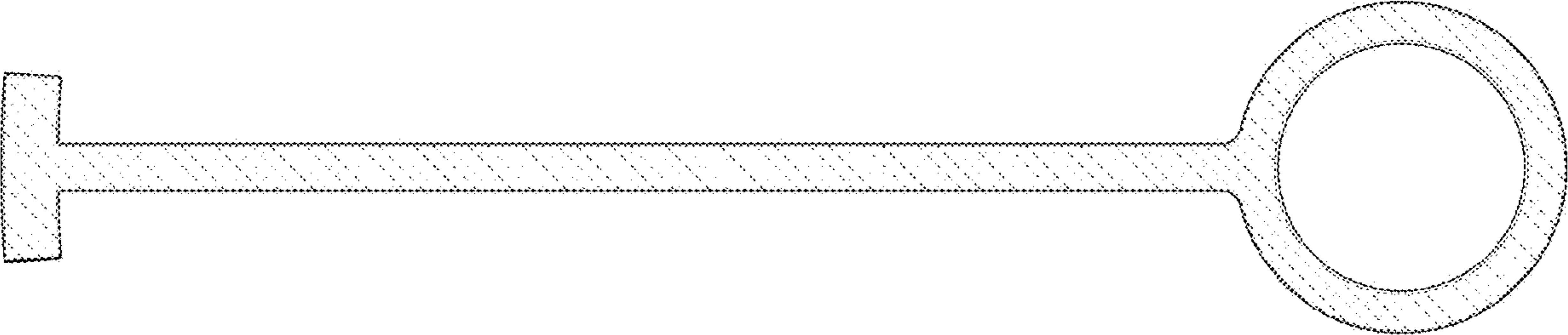

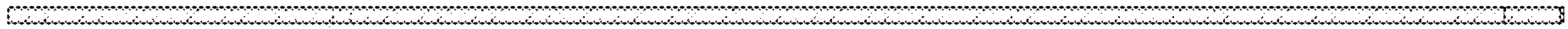




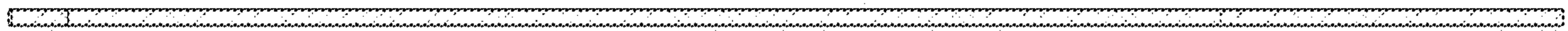

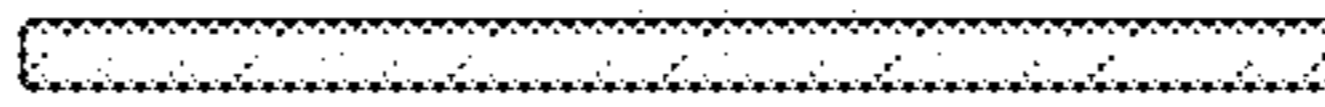

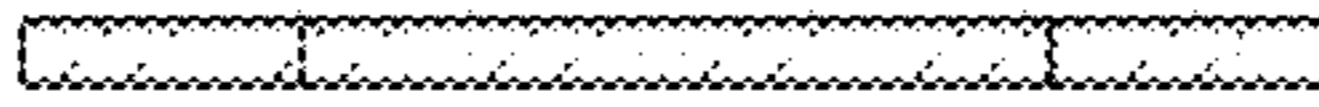

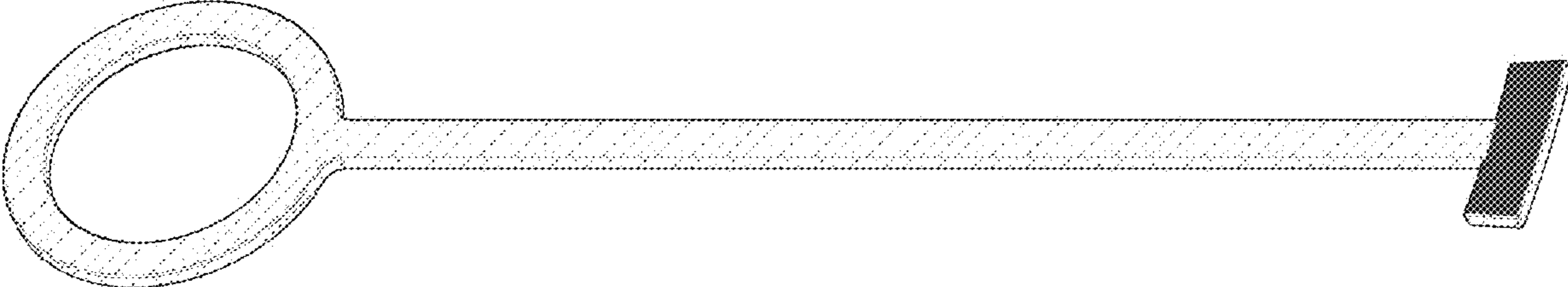

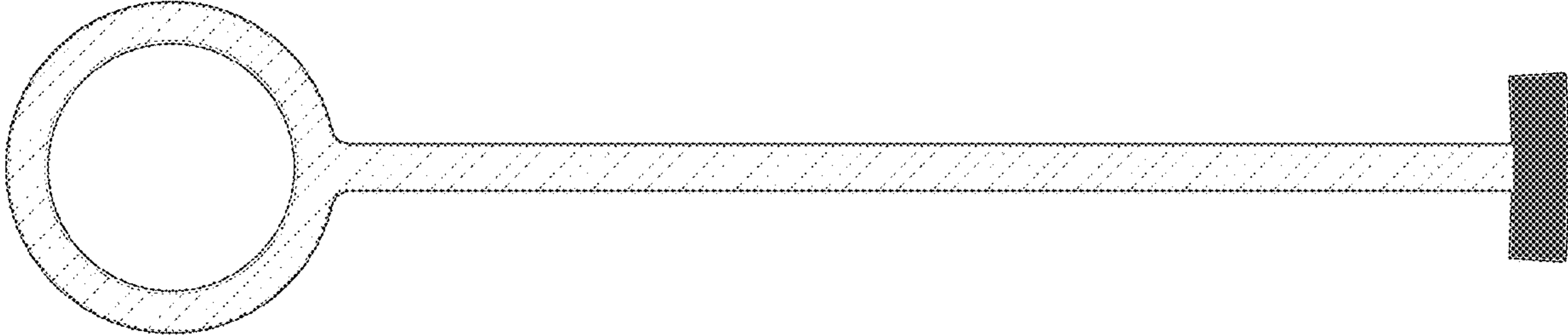

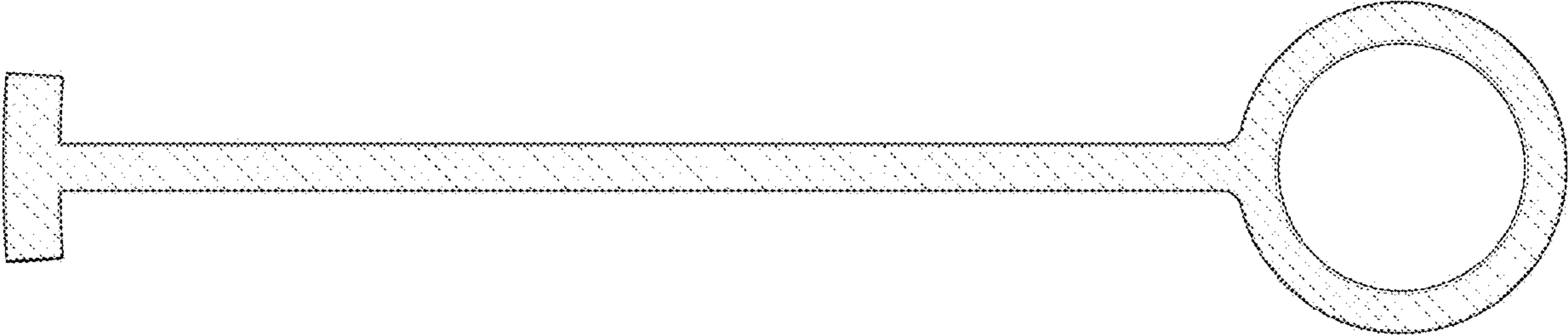

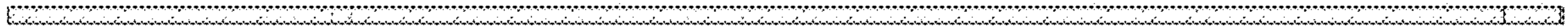

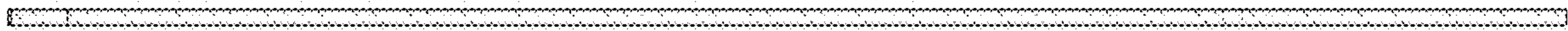

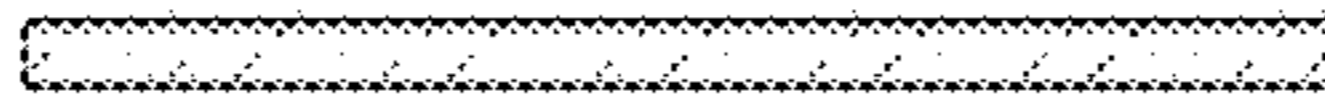

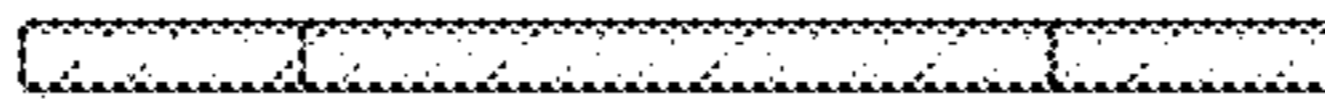

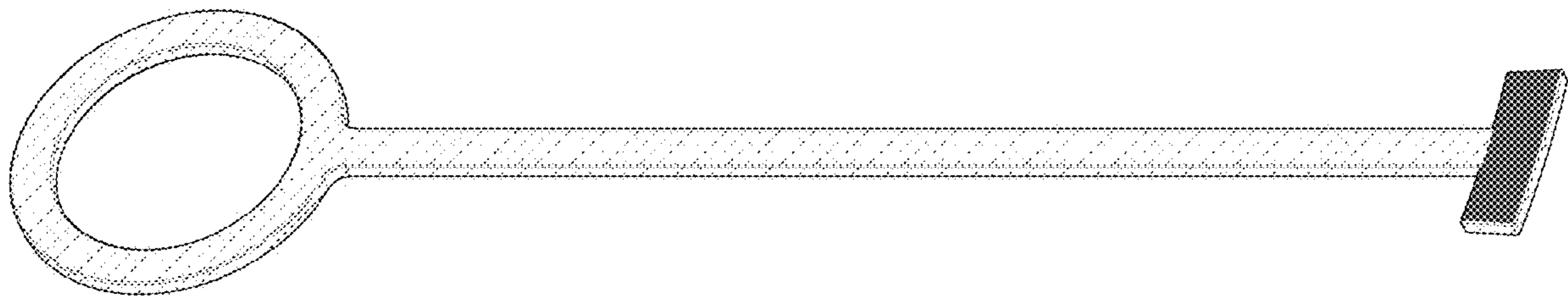

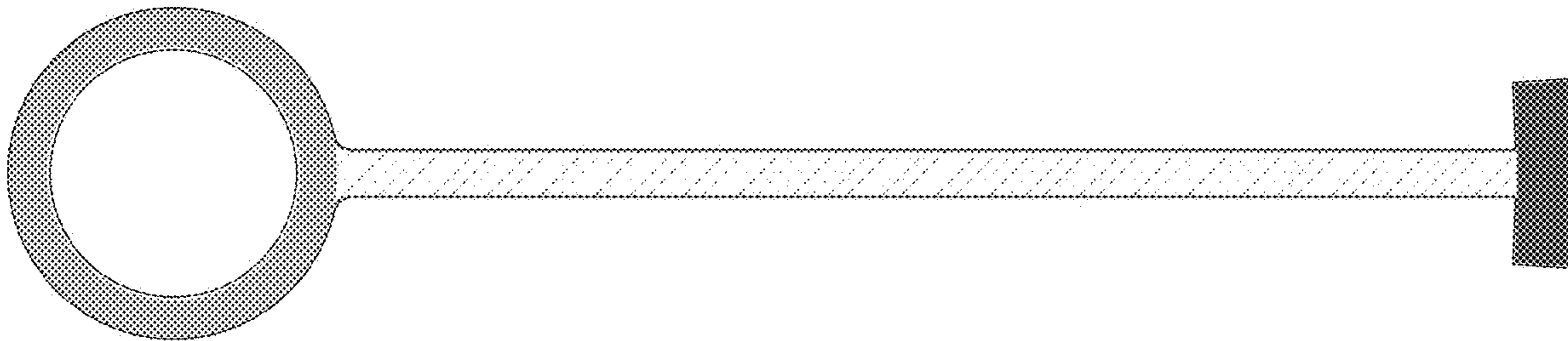

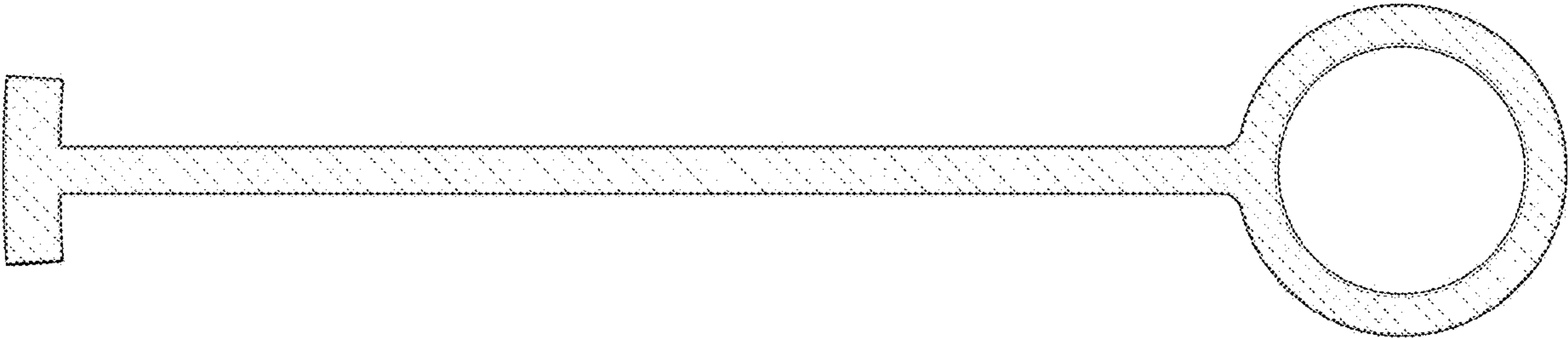

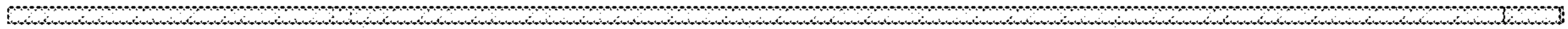

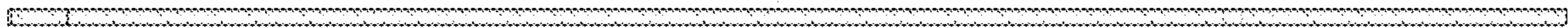

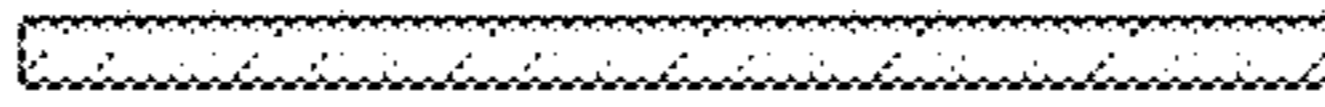

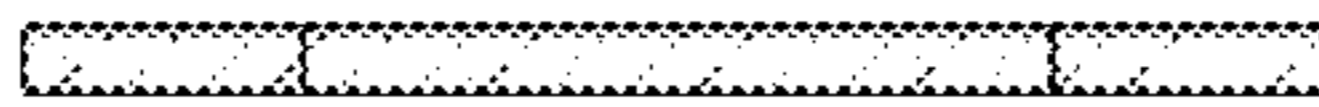
