FIG. 1 is a top, front perspective view of a first embodiment of a chain with charms, showing our new design; FIG. 2 is a top, back perspective view of FIG. 1; FIG. 3 is a front view of FIG. 1; FIG. 4 is a back view of FIG. 1; FIG. 5 is a left side view of FIG. 1; FIG. 6 is a right side view of FIG. 1; FIG. 7 is a top view of FIG. 1; FIG. 8 is a bottom view of FIG. 1; FIG. 9 is a top, front perspective view of a second embodiment of the chain with charms of FIG. 1; FIG. 10 is a top, back perspective view of FIG. 9; FIG. 11 is a left side view of FIG. 9; FIG. 12 is a right side view of FIG. 9; FIG. 13 is a top view of FIG. 9; and, FIG. 14 is a bottom view of FIG. 9.

The broken lines in the drawings represent portions of the chain with charms that form no part of the claimed design. FIGS. 1 and 3 depict a cursive “L” on the charms. A cursive “L” comprises a portion of the mark depicted in the drawing in US trademark application number 88160099, owned by the same entity as the assignee of the present design patent application as recorded in the USPTO at reel 48472 and frame 967.

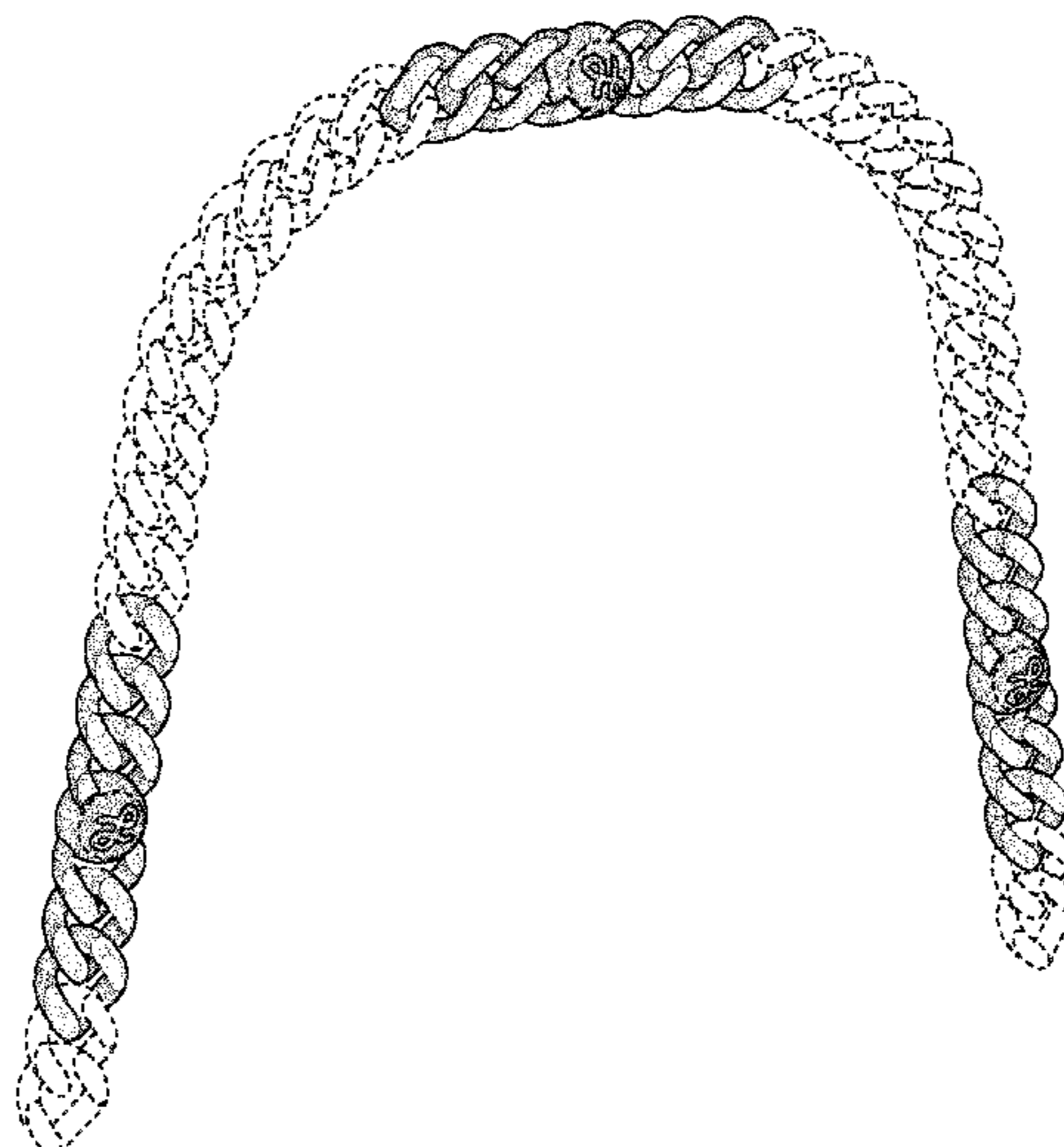

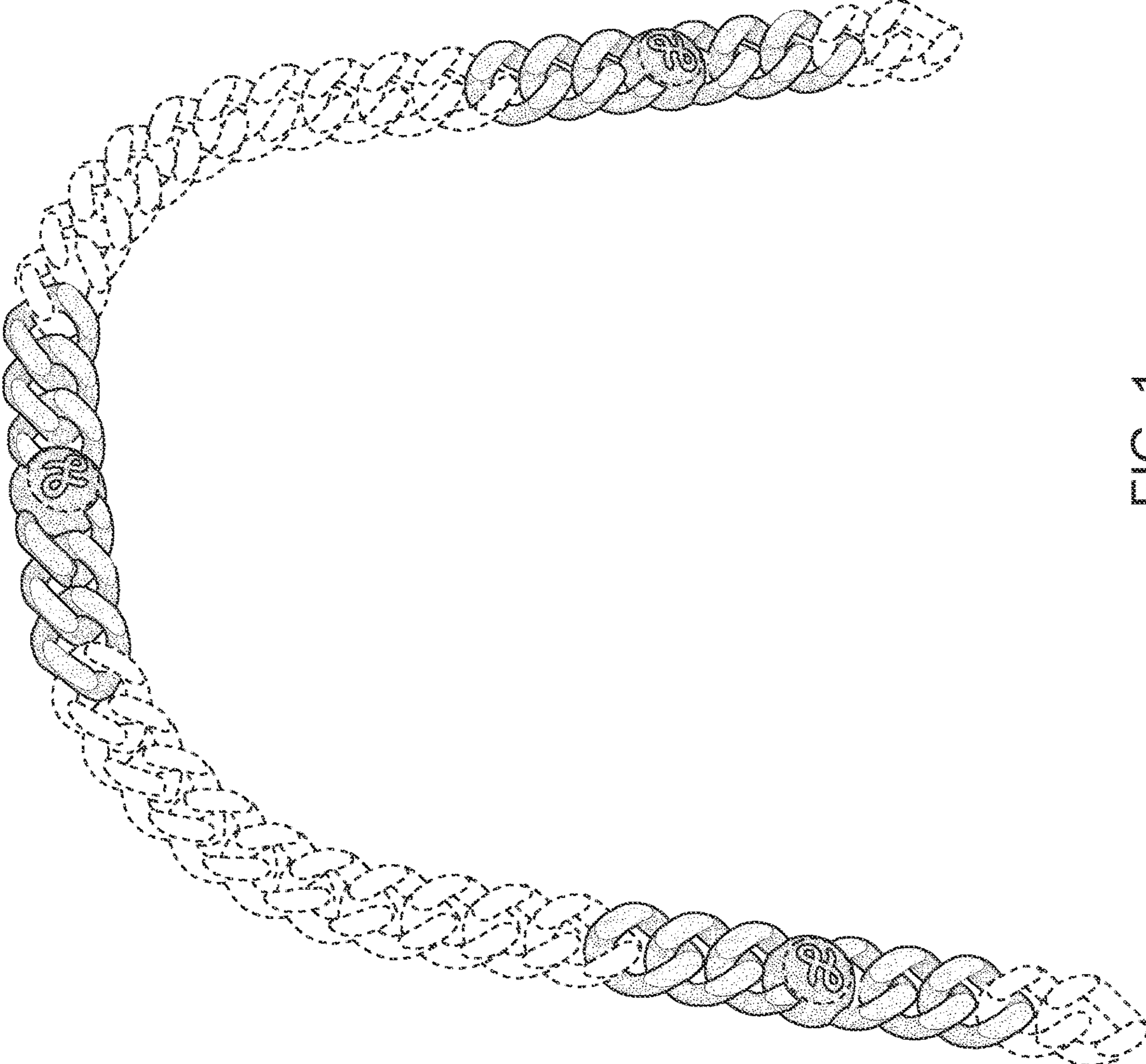

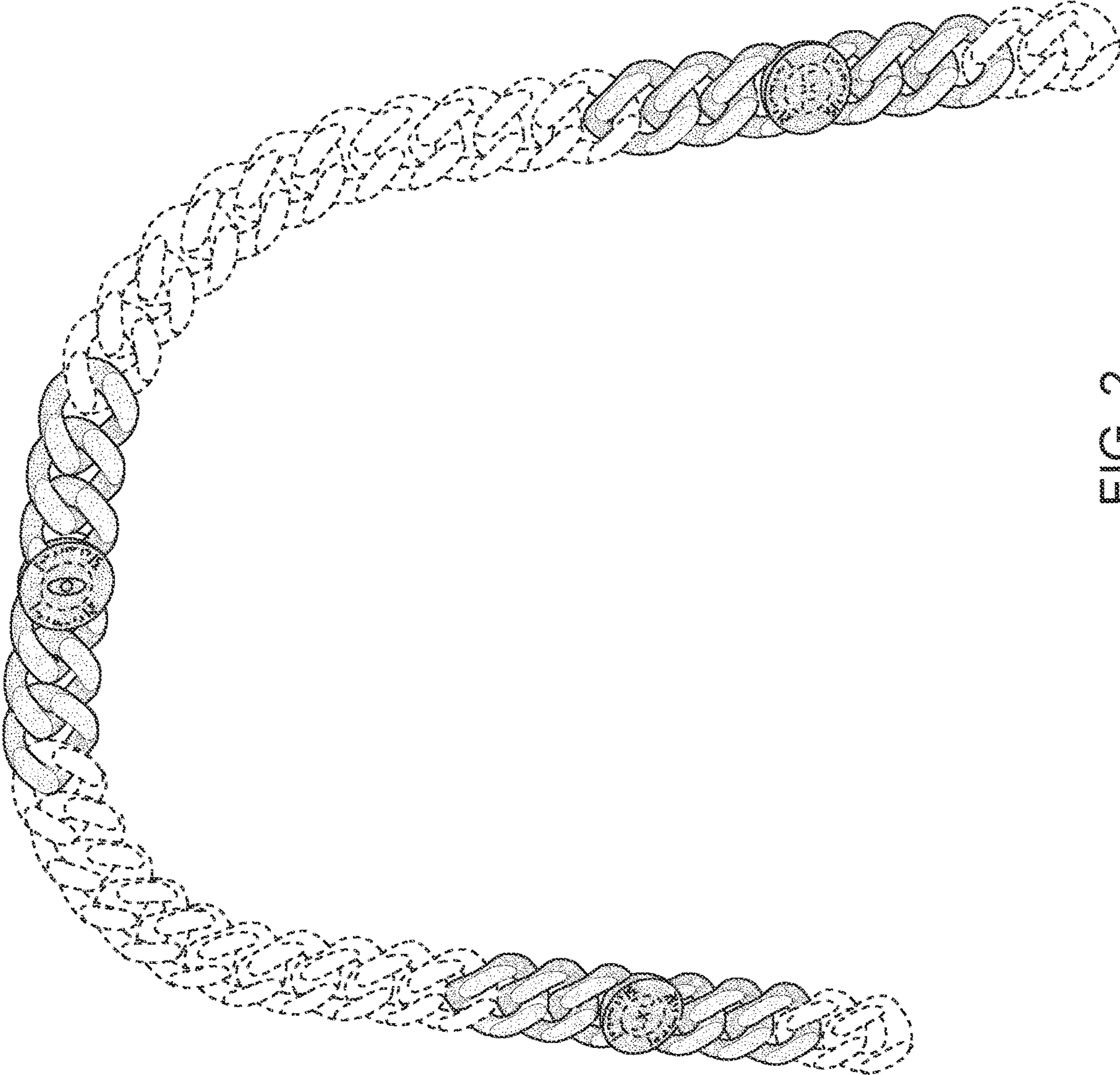

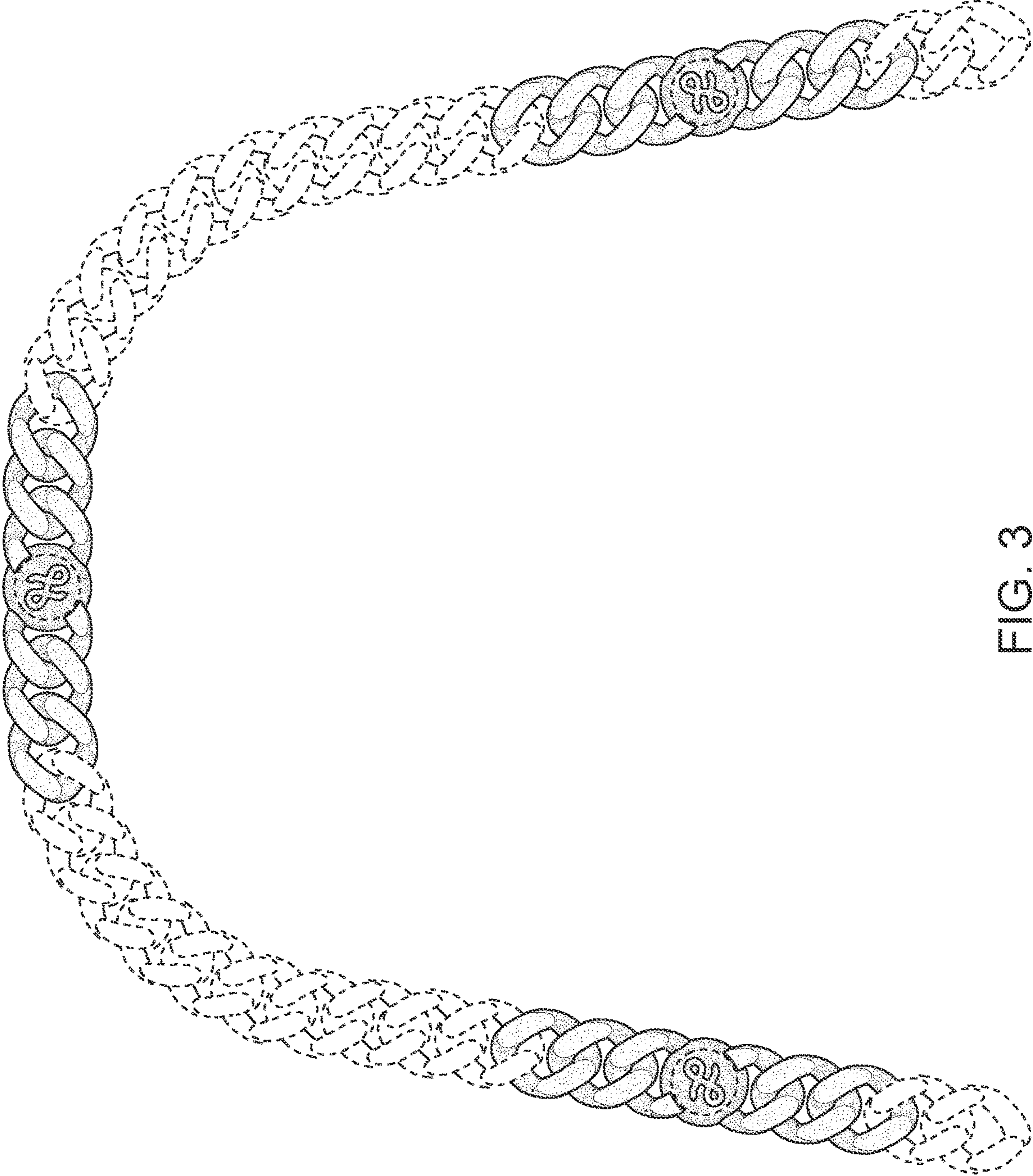

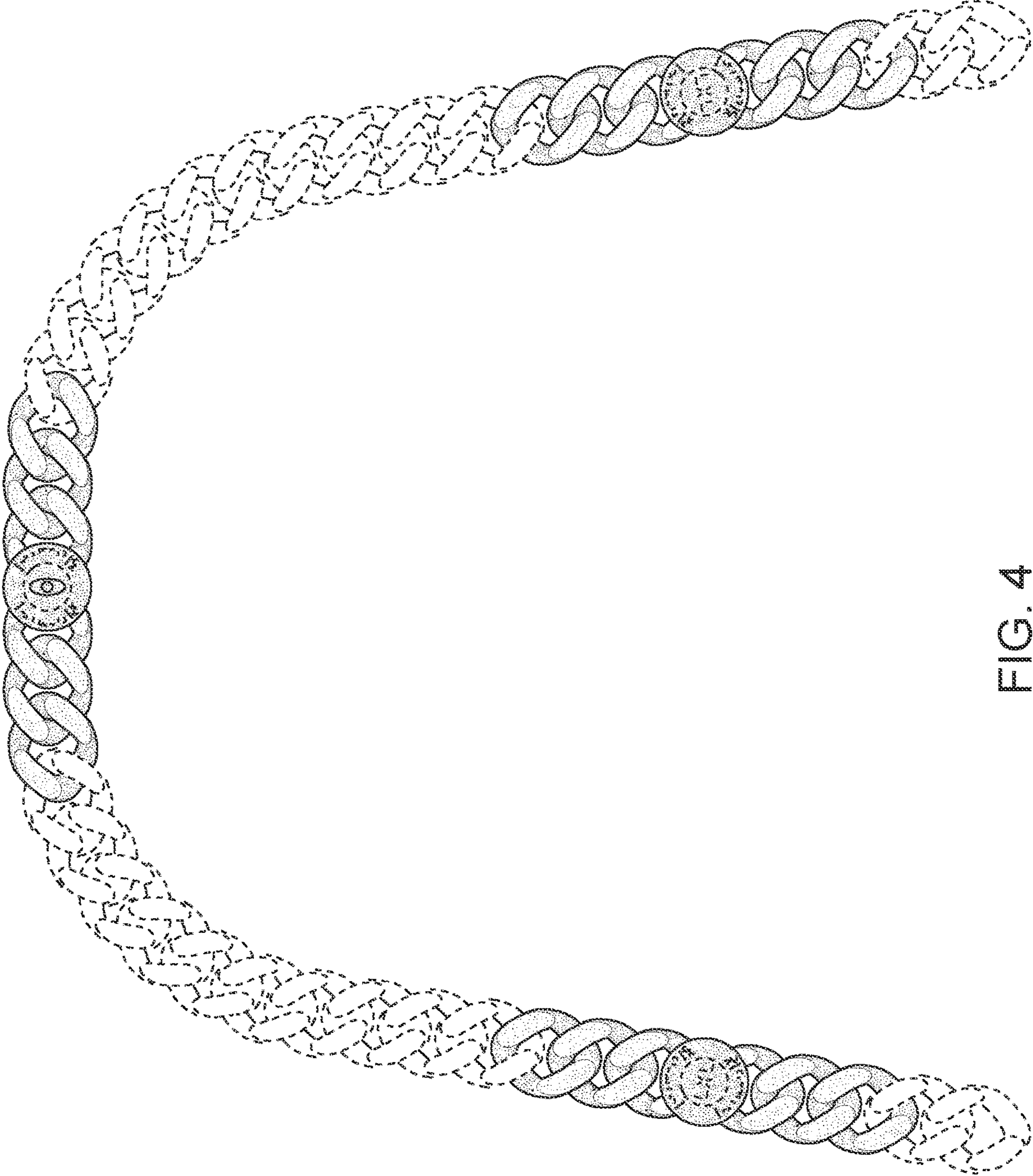

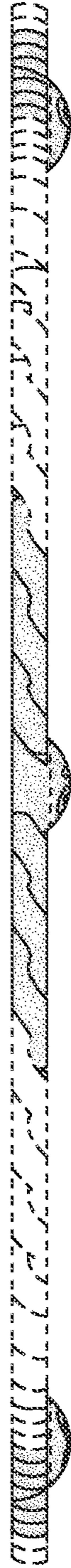

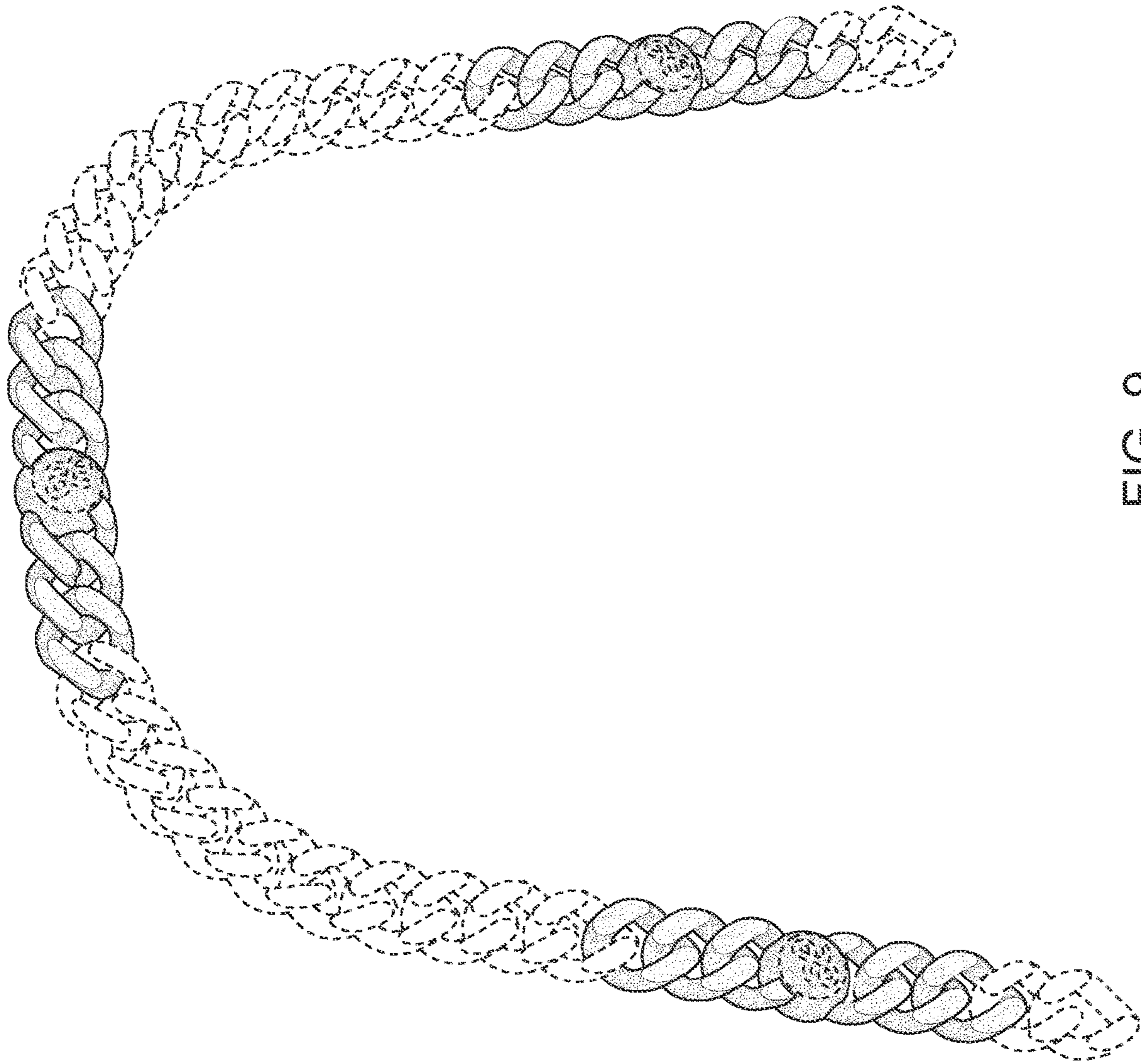

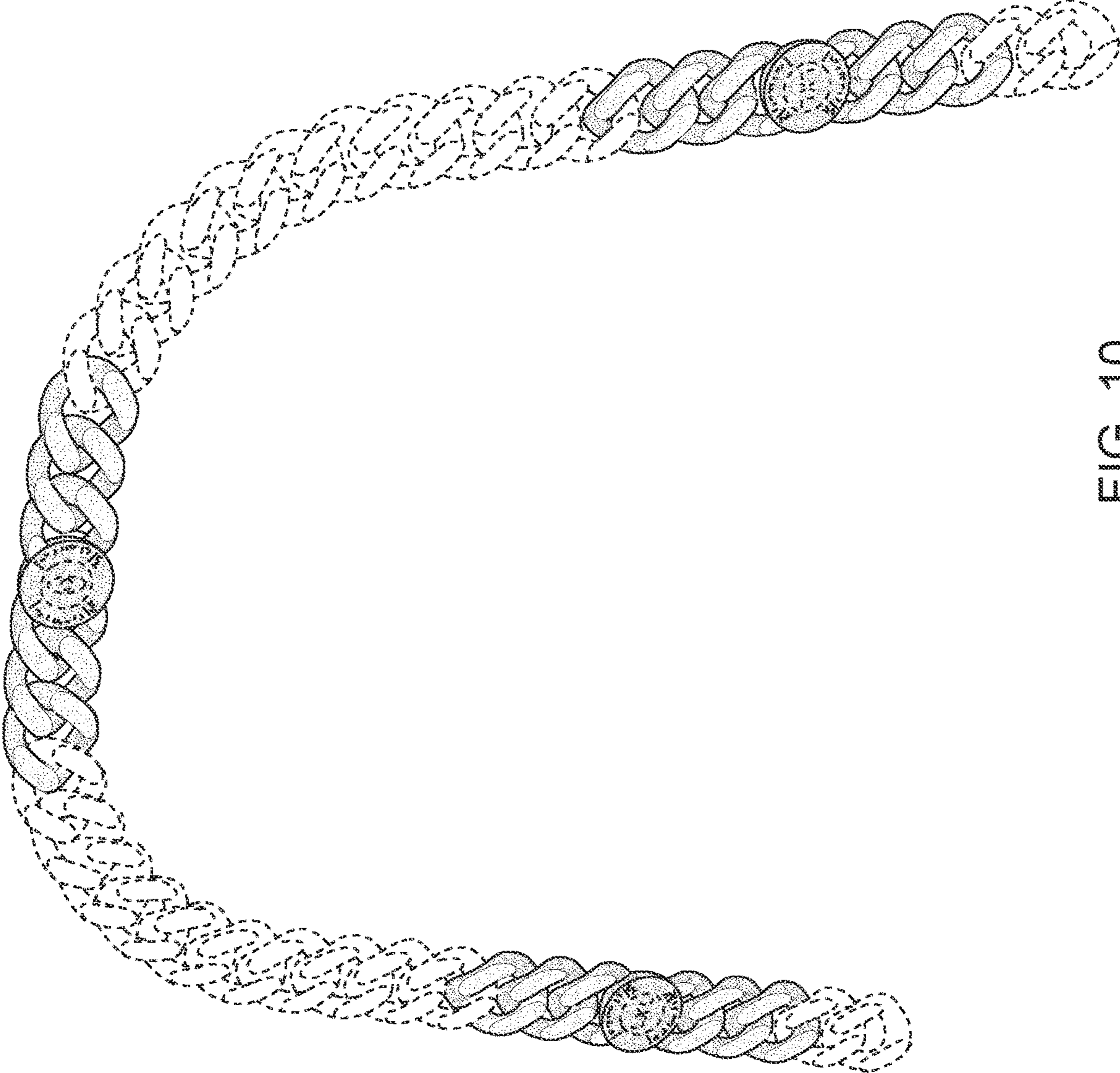

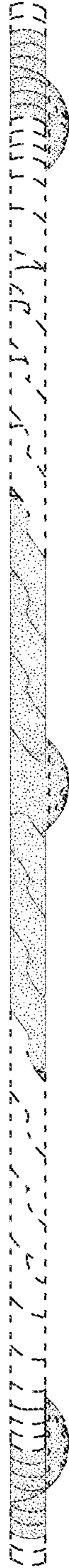

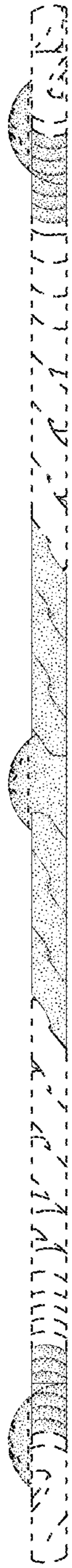
