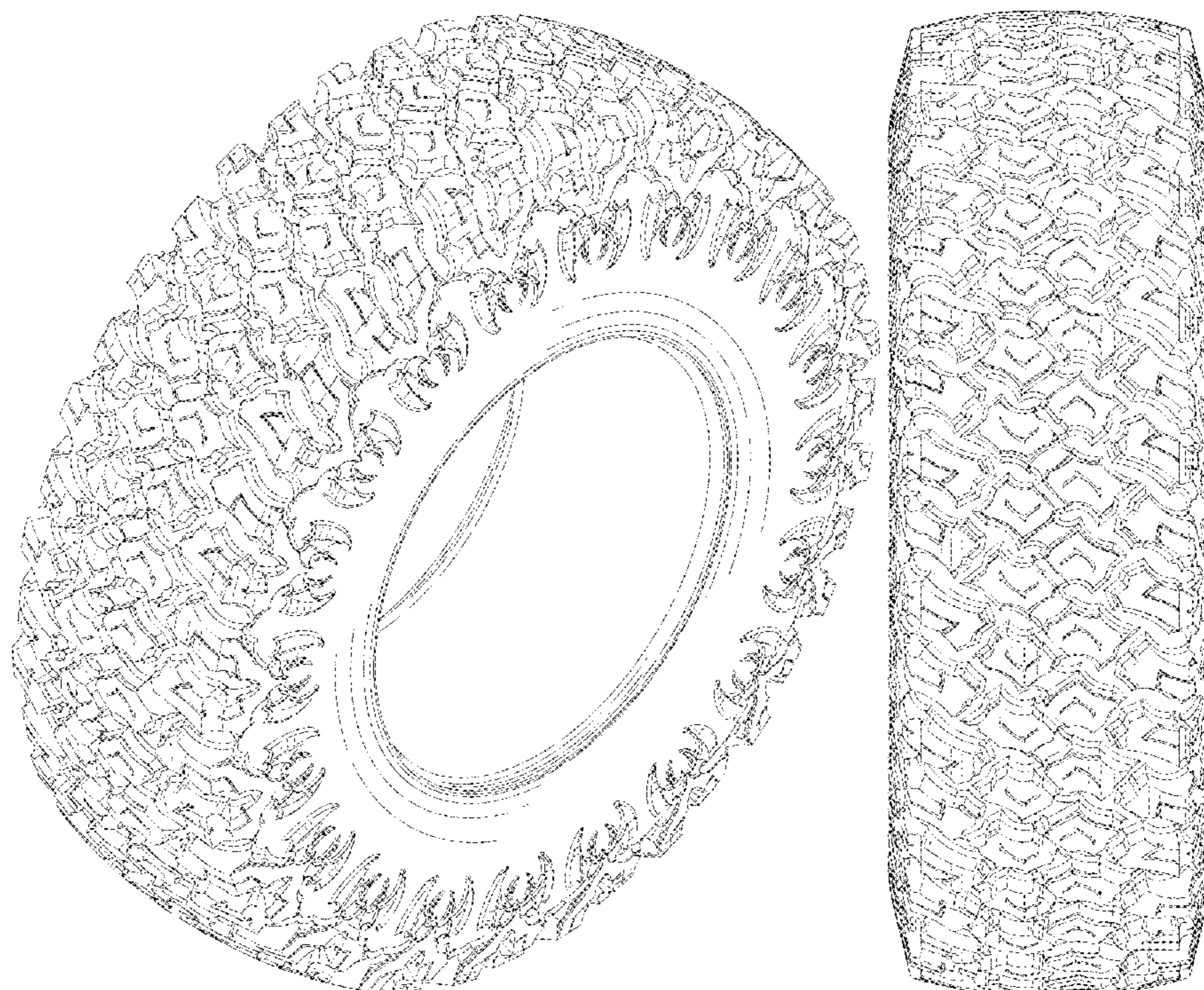
The ornamental design for an all-terrain vehicle tire pattern,

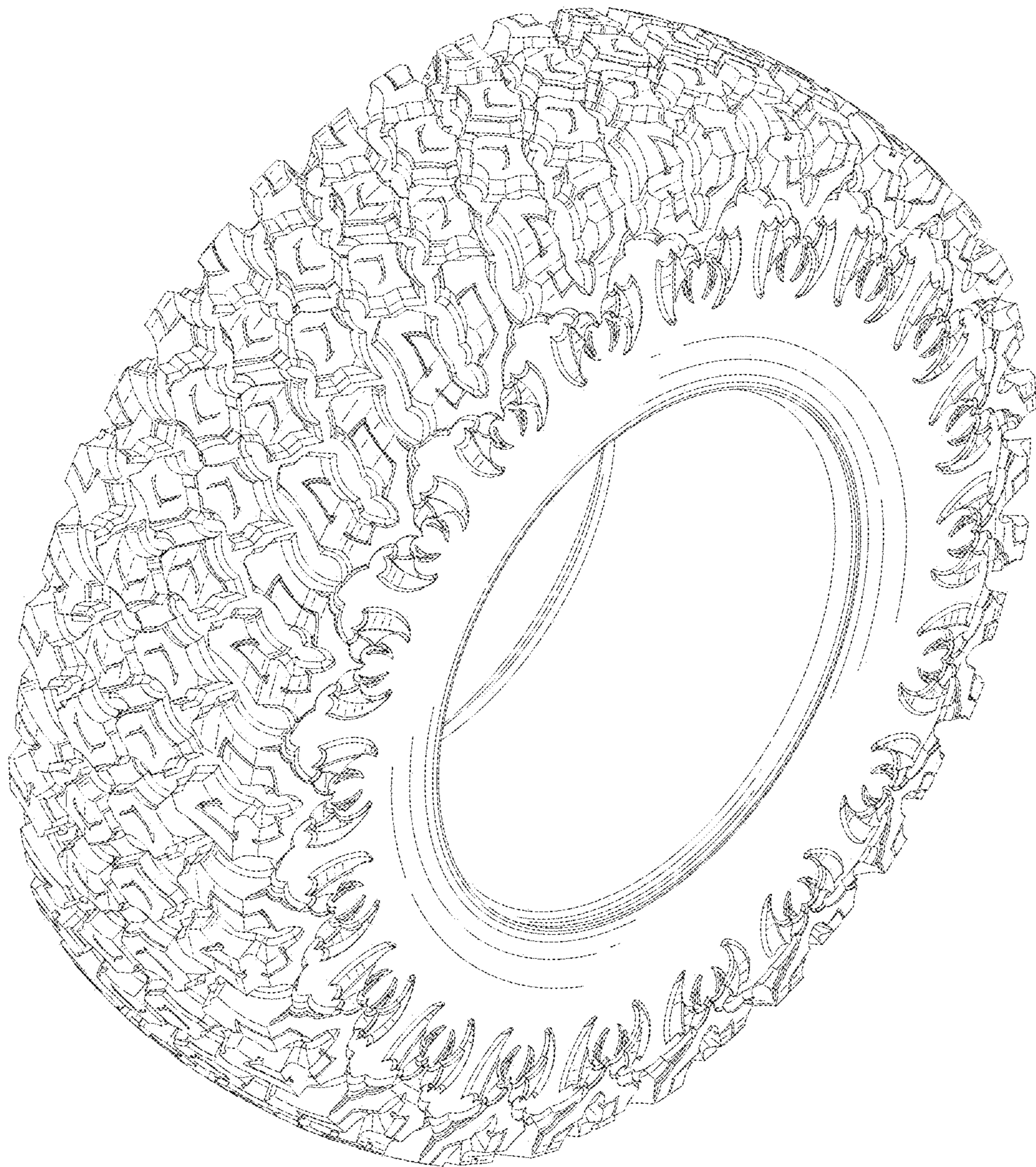

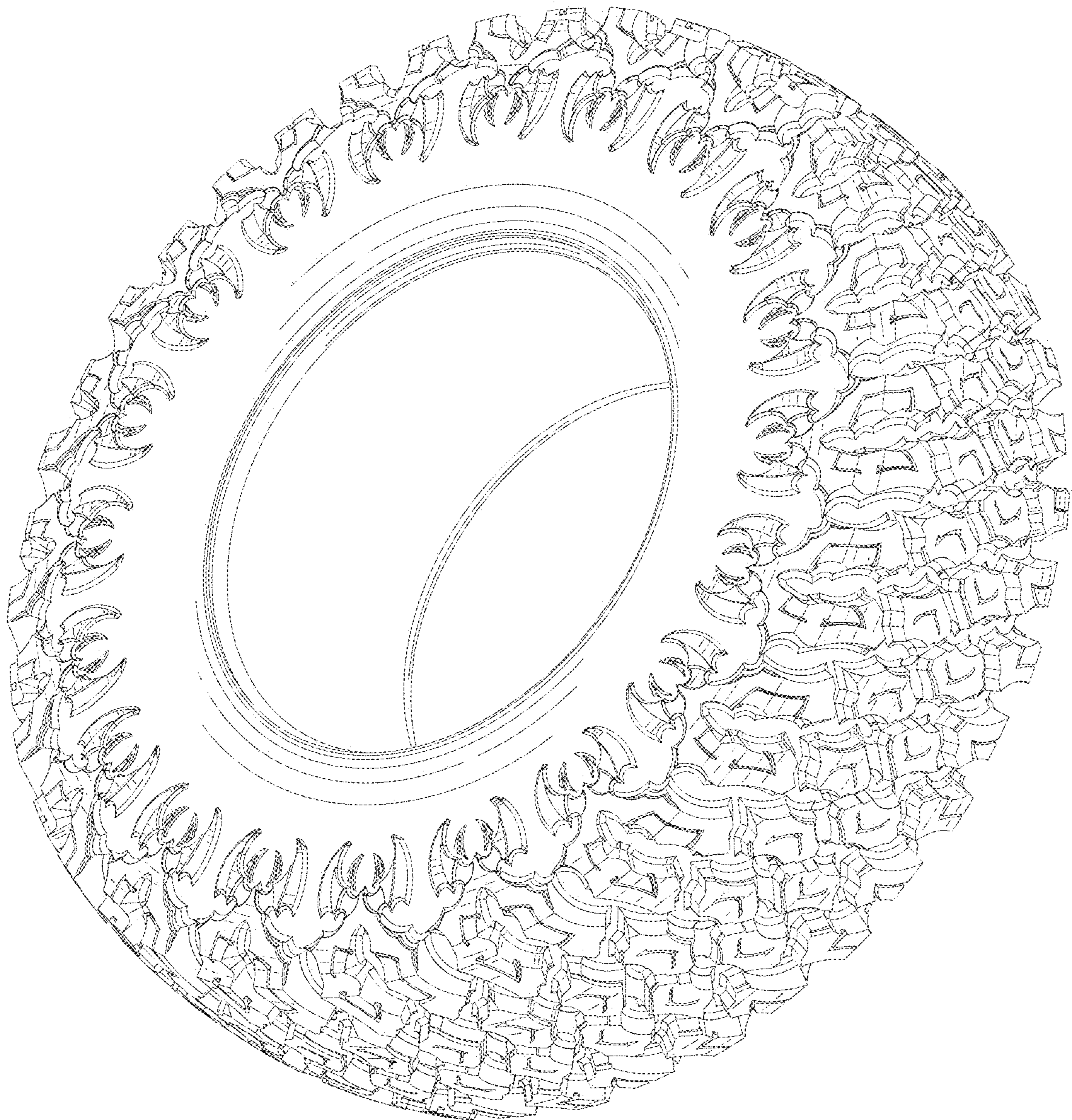

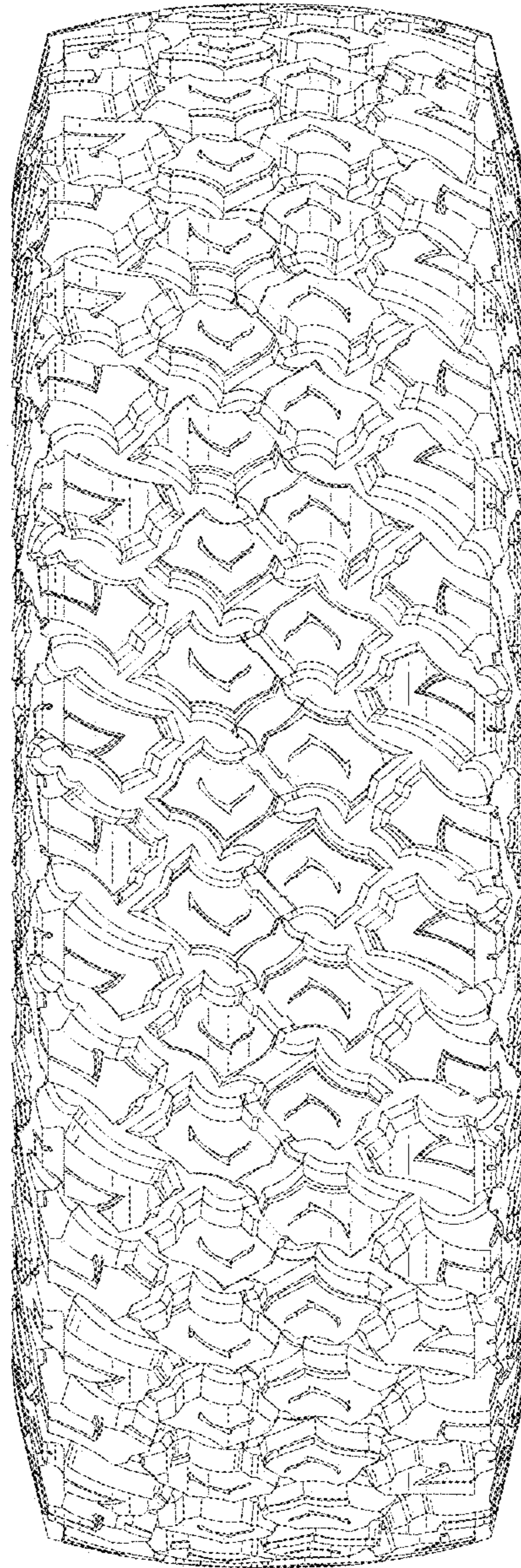

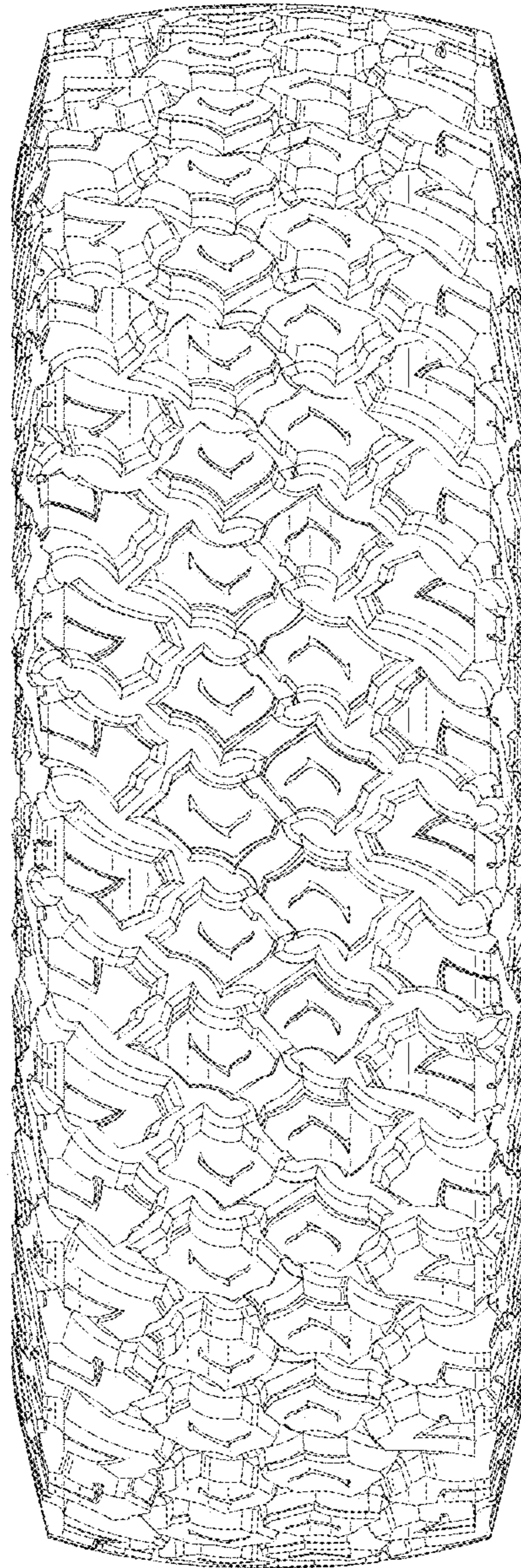

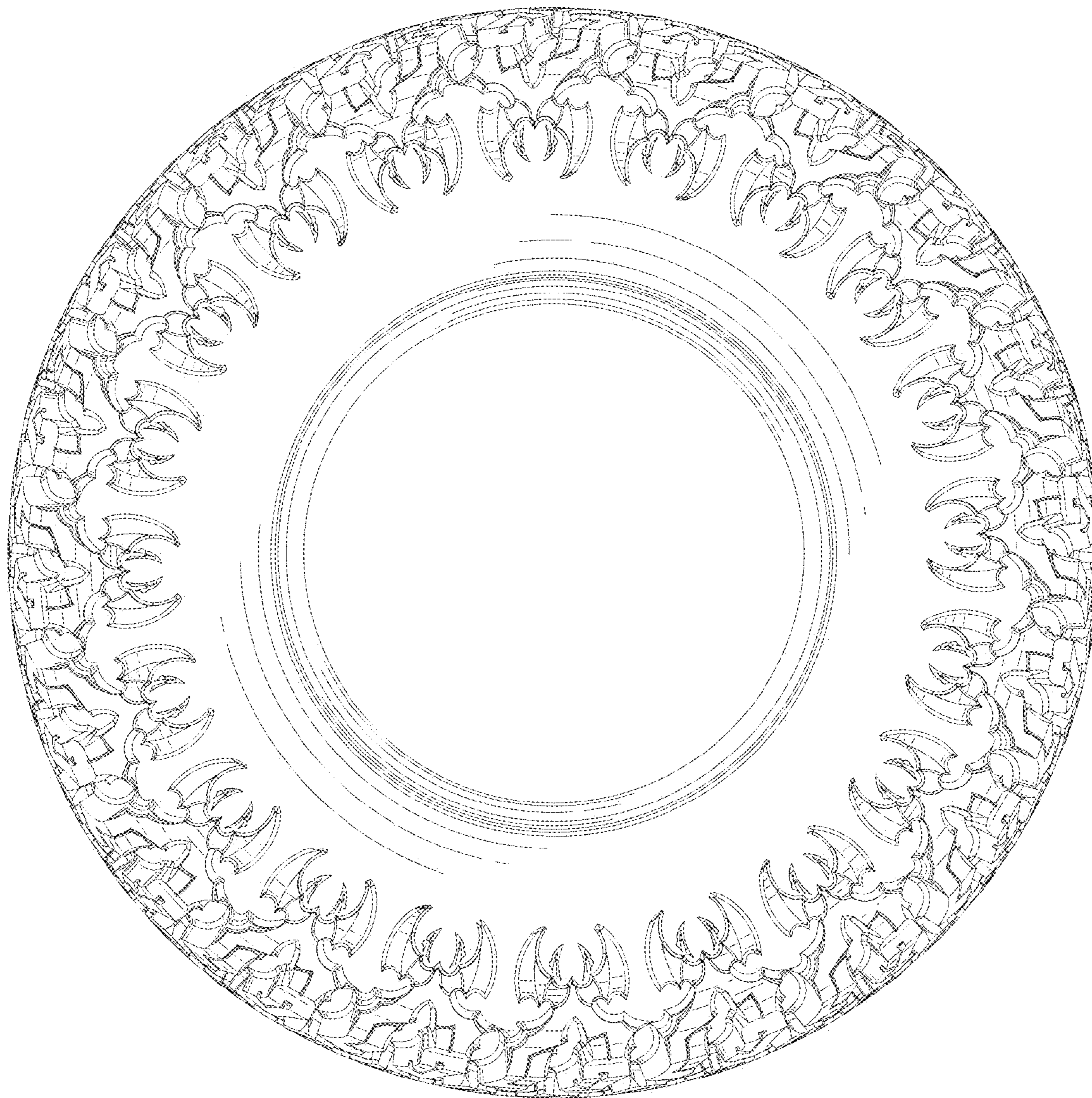

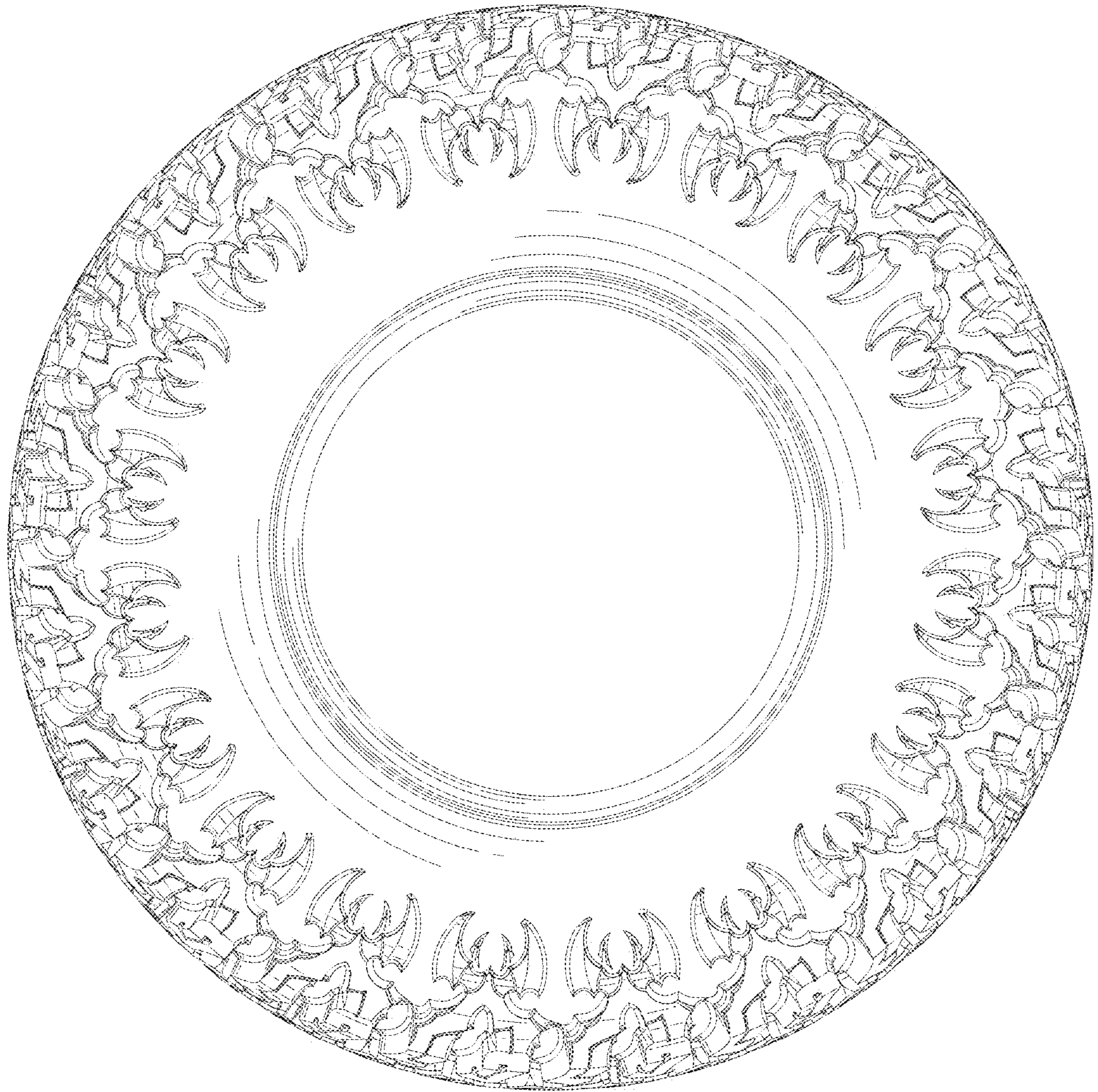

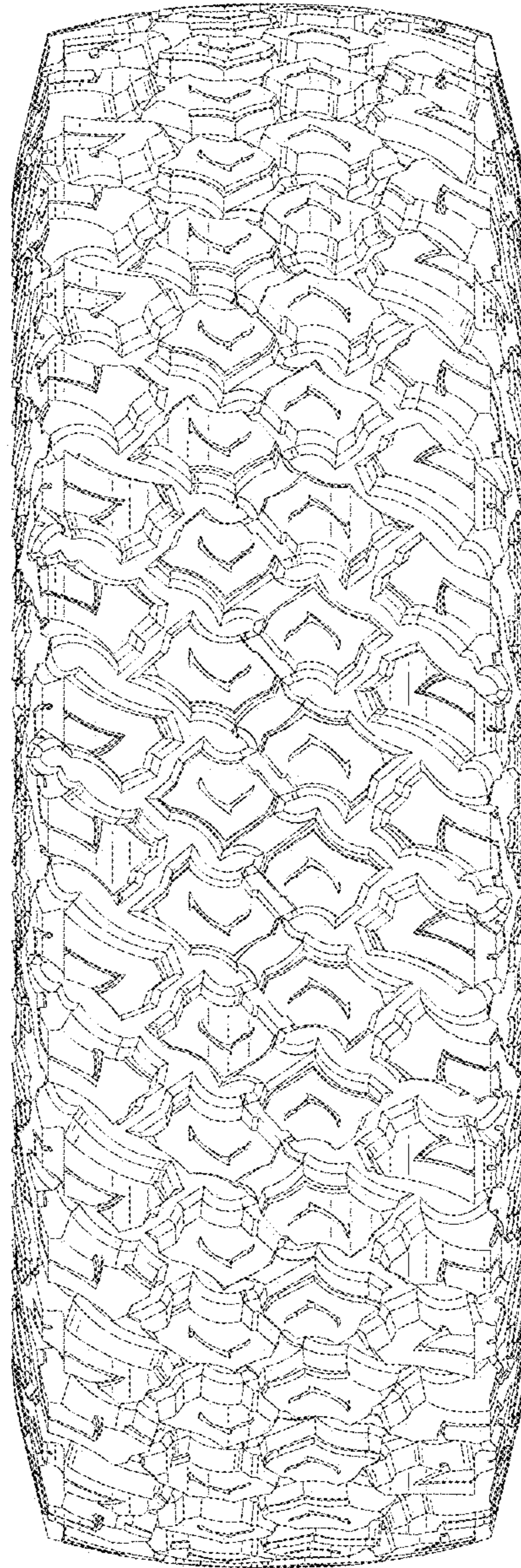

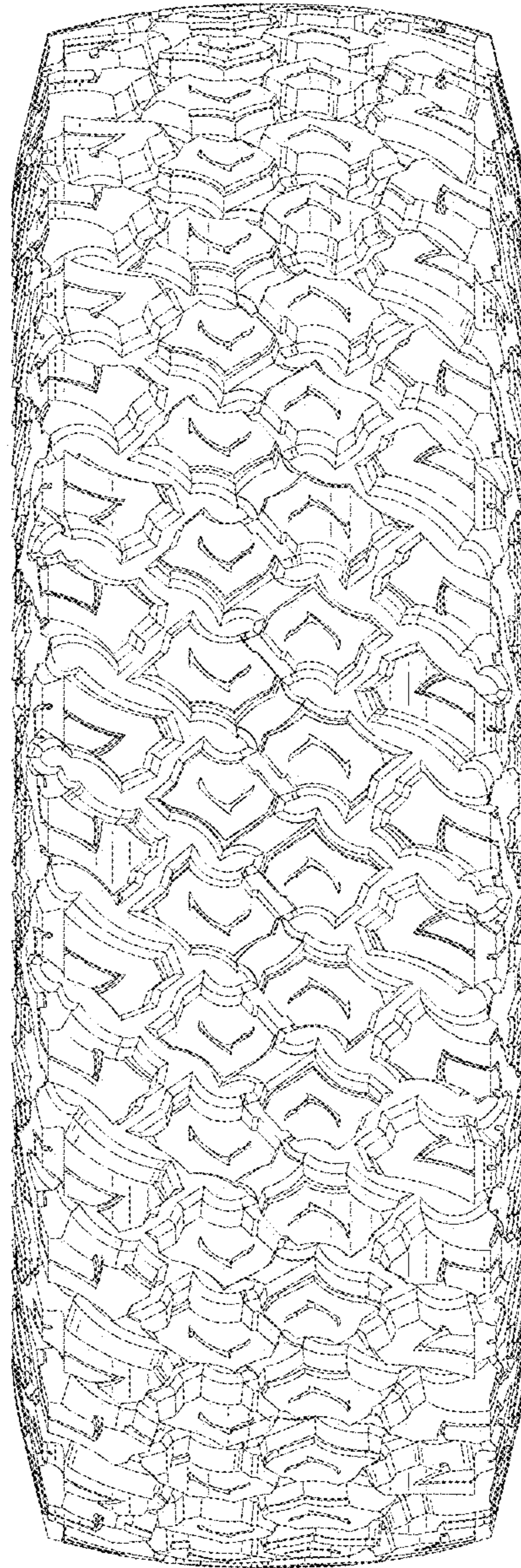
