The ornamental design for gaming machine display screen or a portion thereof with a graphical user interface, as shown and described.

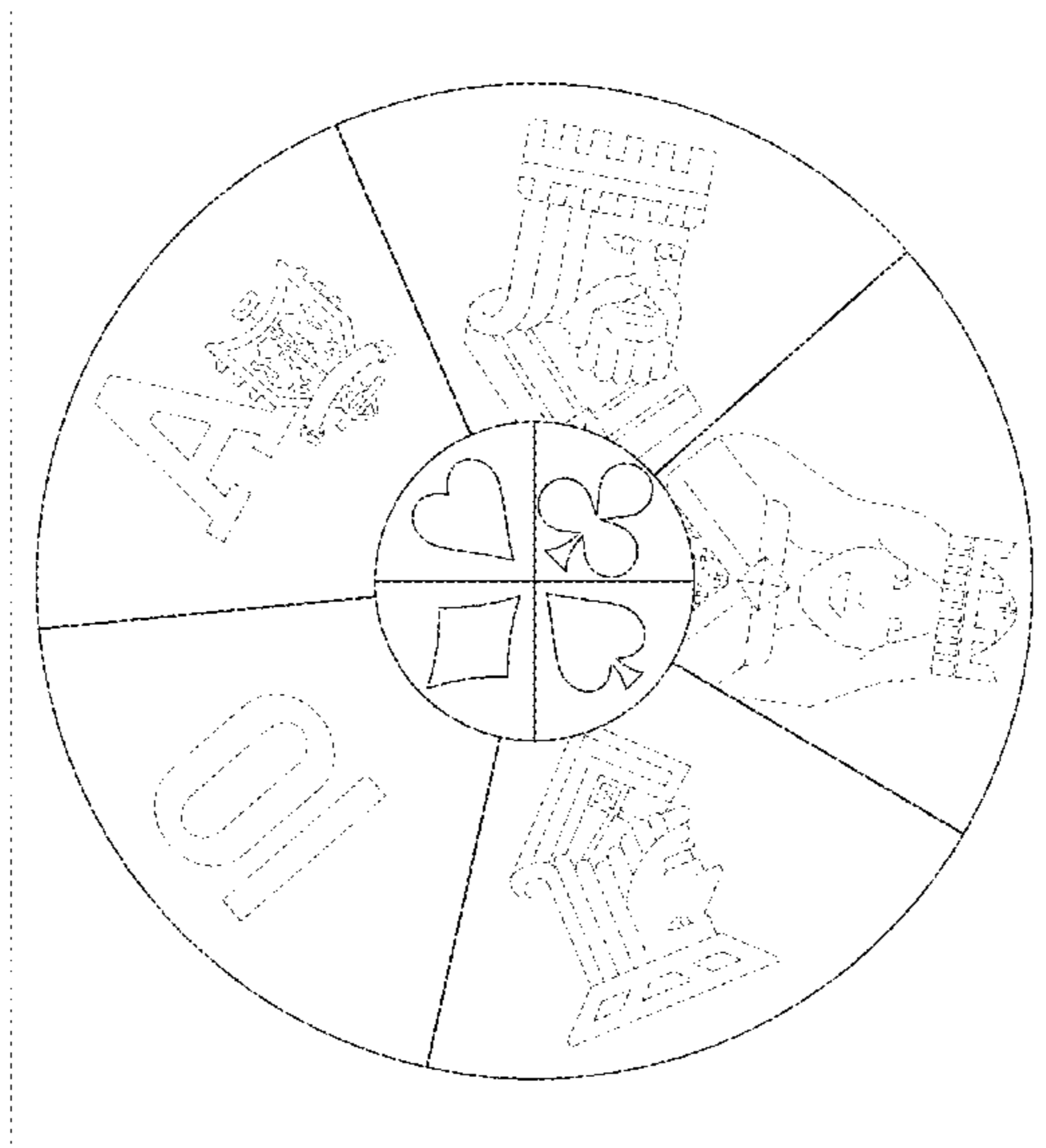
DESCRIPTION
