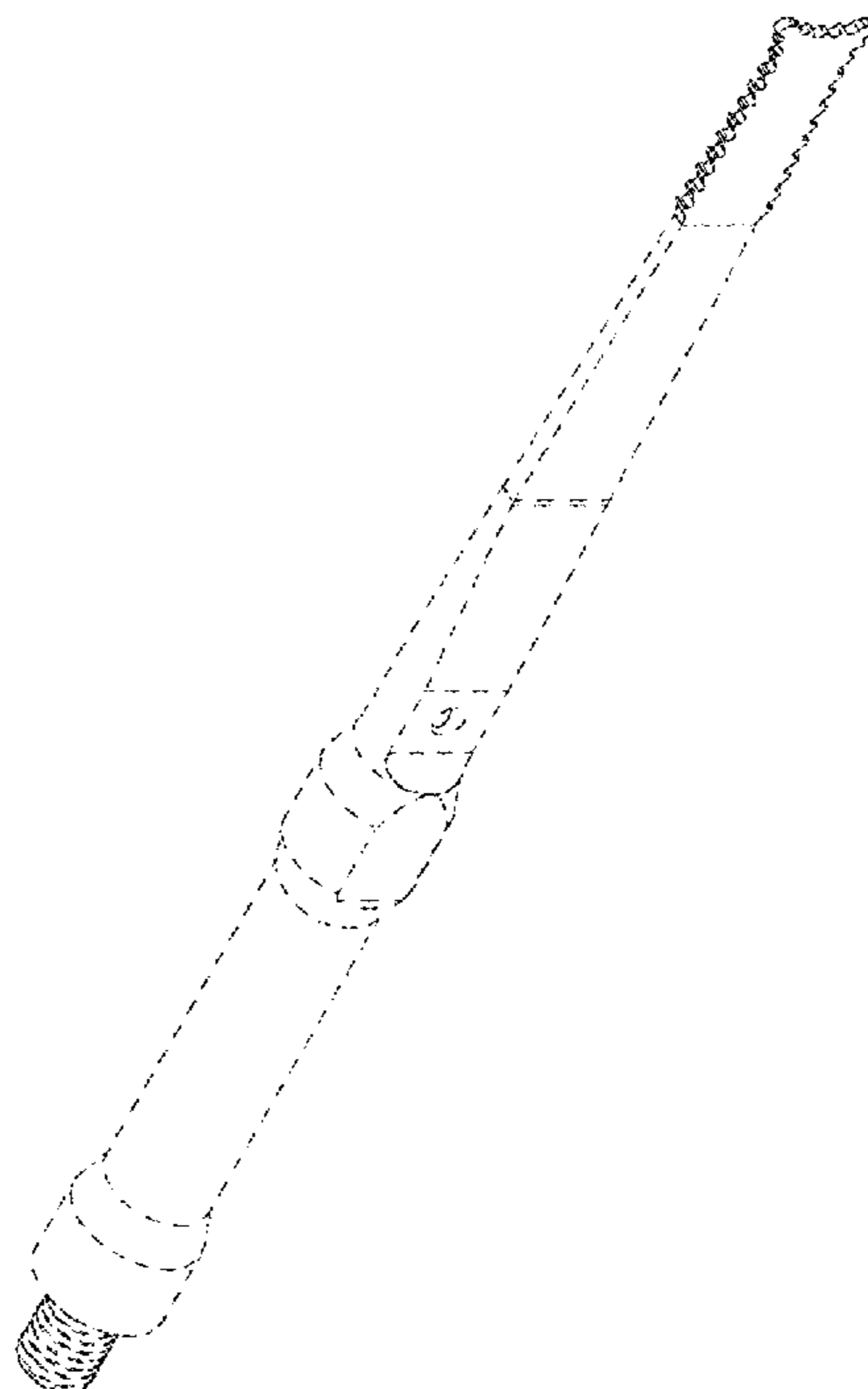
(57) **CLAIM**

The ornamental design for an ultrasonic cutter head, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the ultrasonic cutter head; FIG. 2 is a rear view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is an enlarged top view thereof; FIG. 6 is an enlarged bottom view thereof; and, FIG. 7 is a perspective view thereof. The broken lines shown in the drawings depict portions of the ultrasonic cutter head that form no part of the claimed design. The dash-dot broken lines define the bounds of the claimed design and form no part thereof.

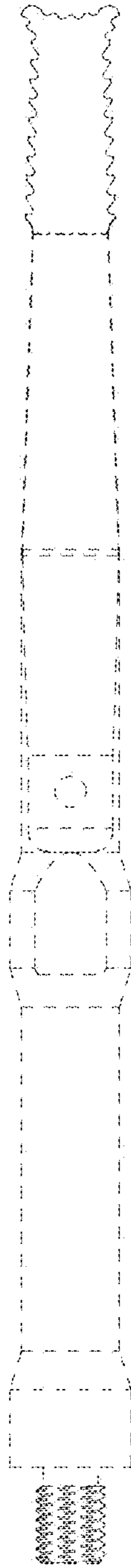

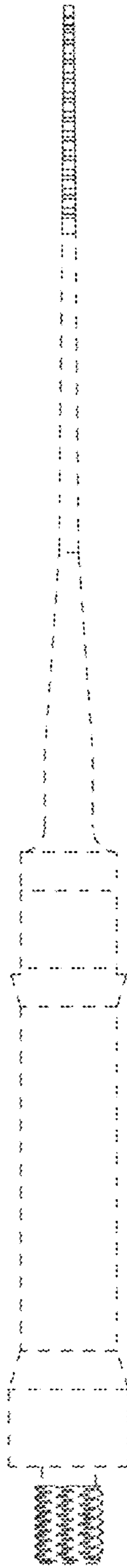

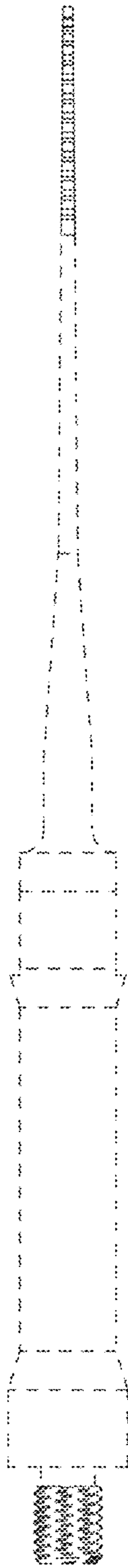

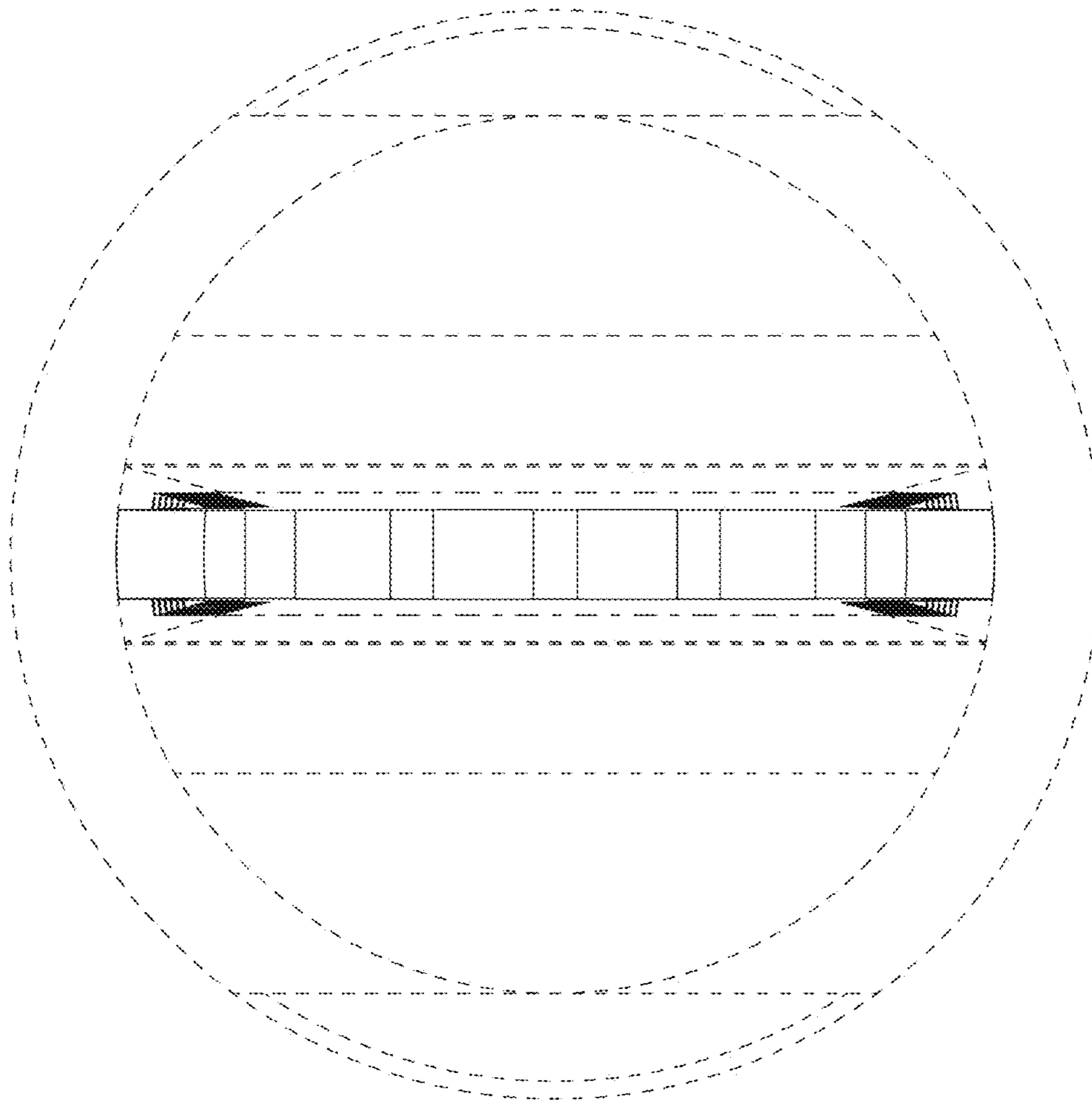

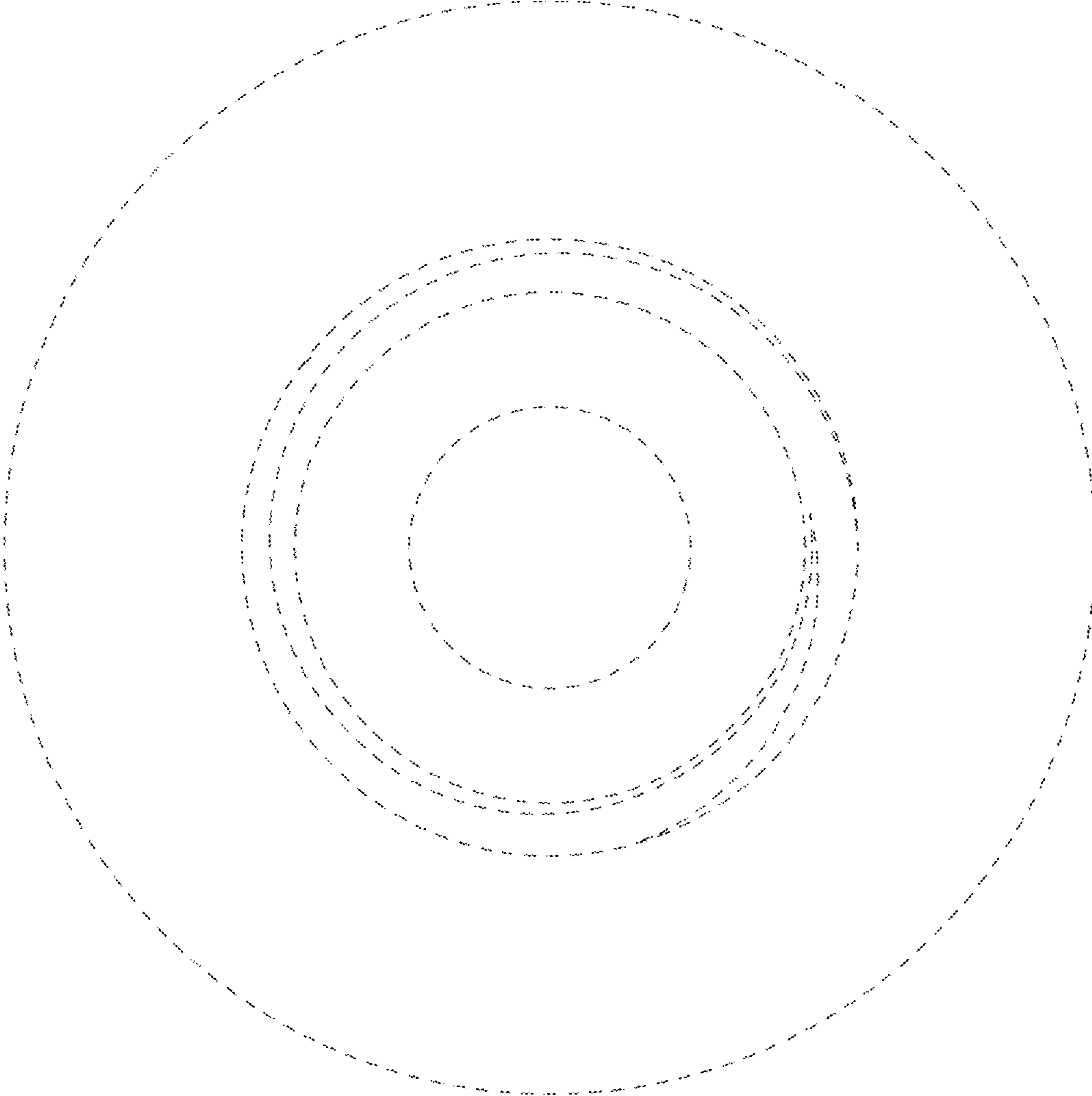

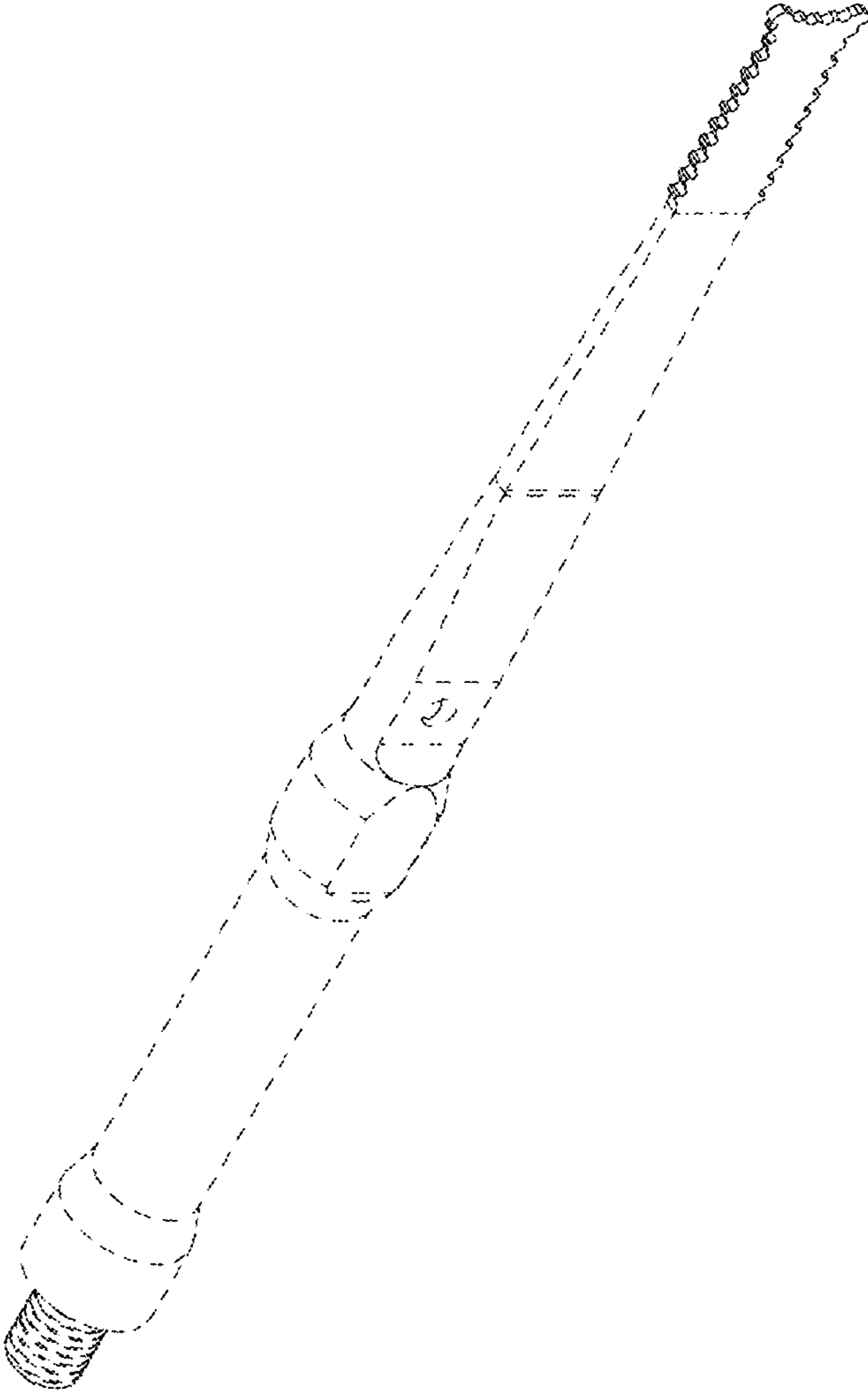
