The broken lines in the figures are for contextual purposes or show the environment and form no part of the claimed design.

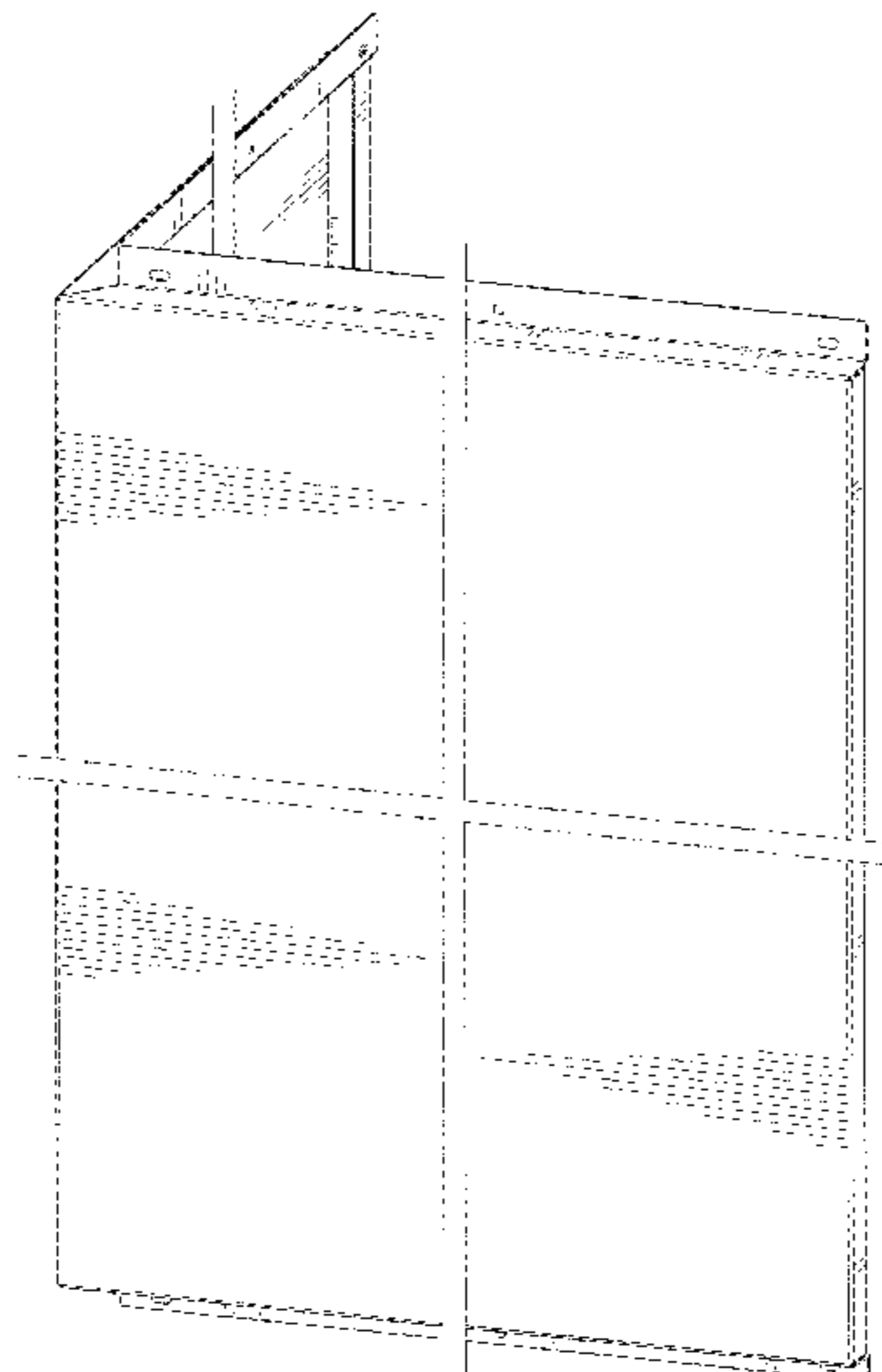

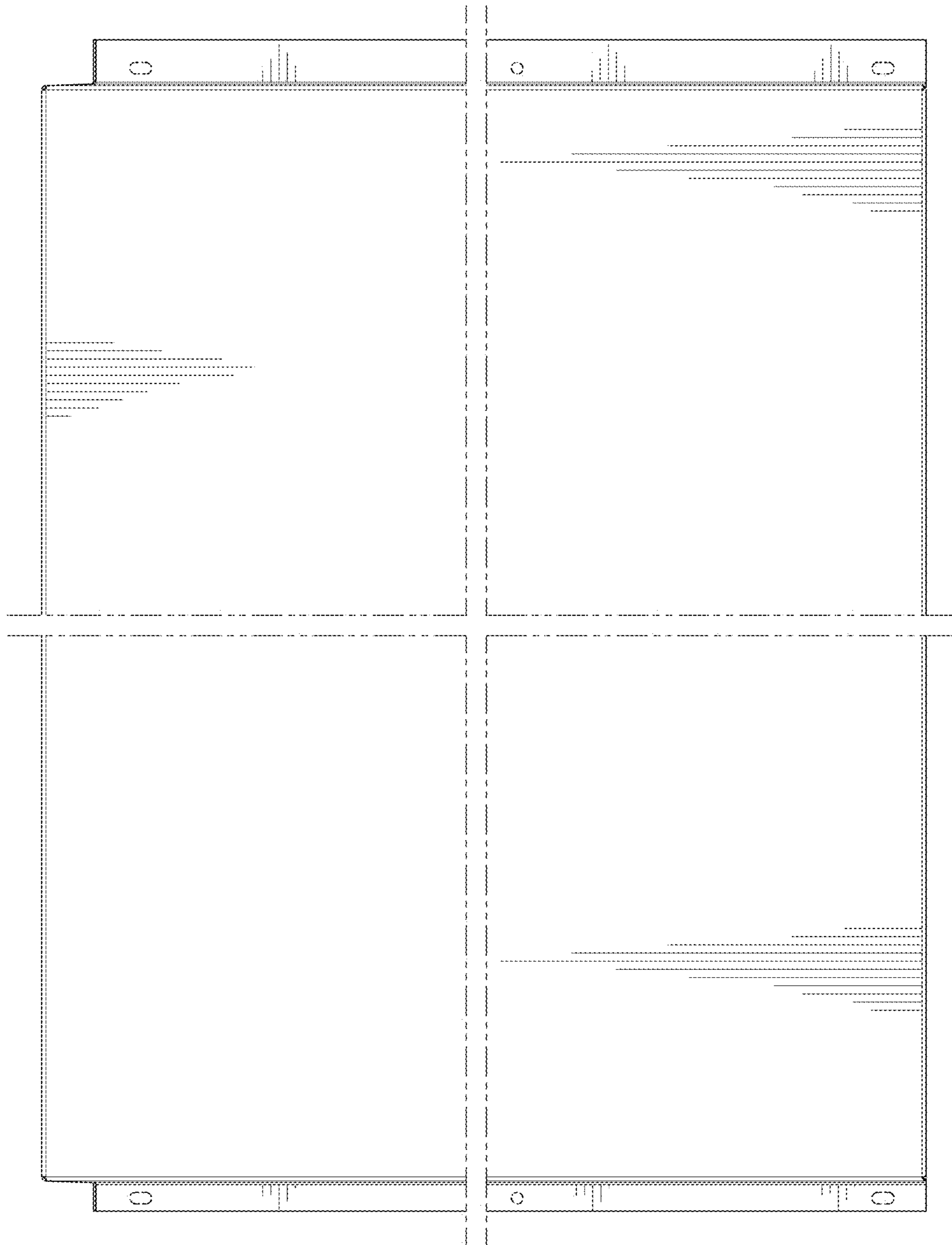

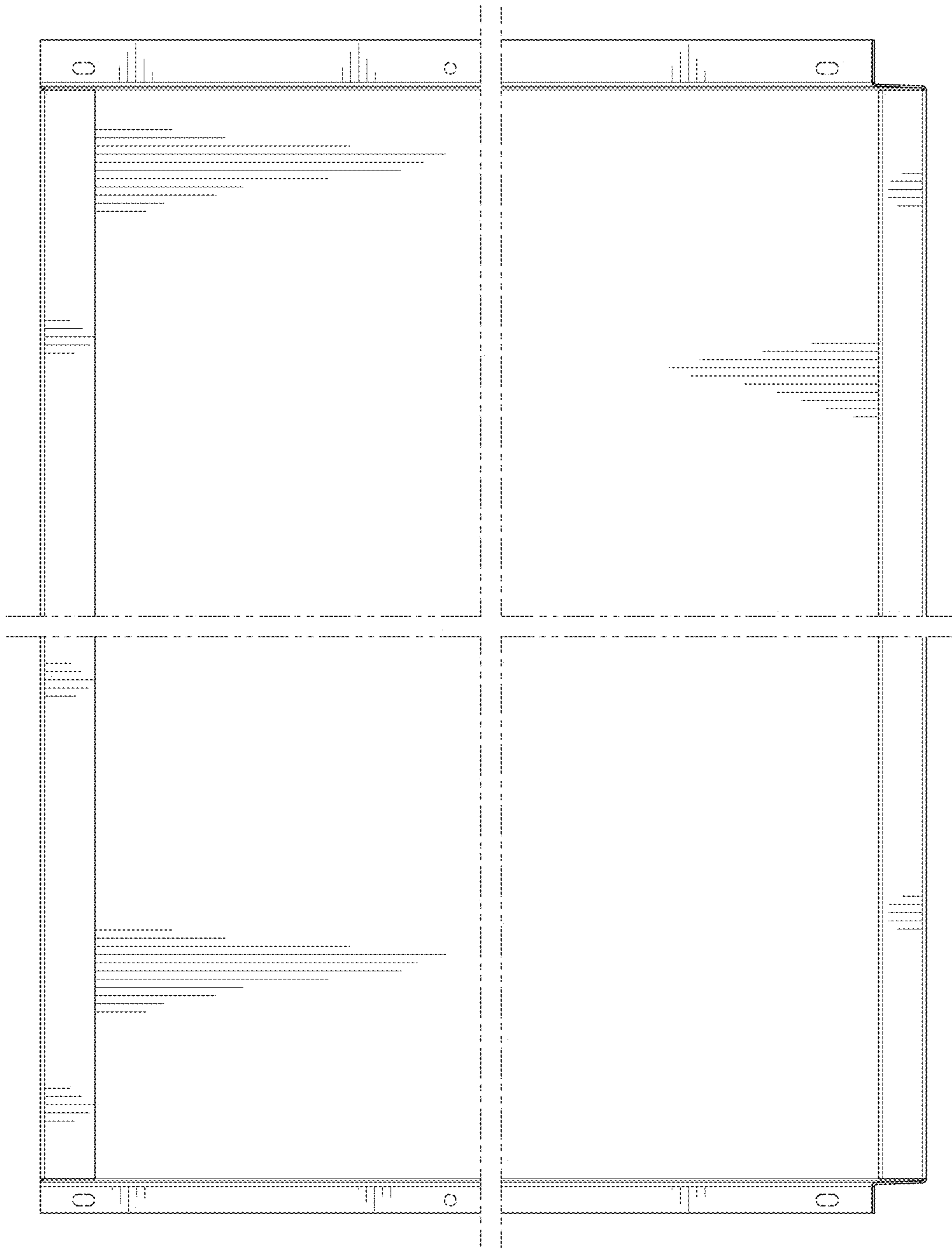

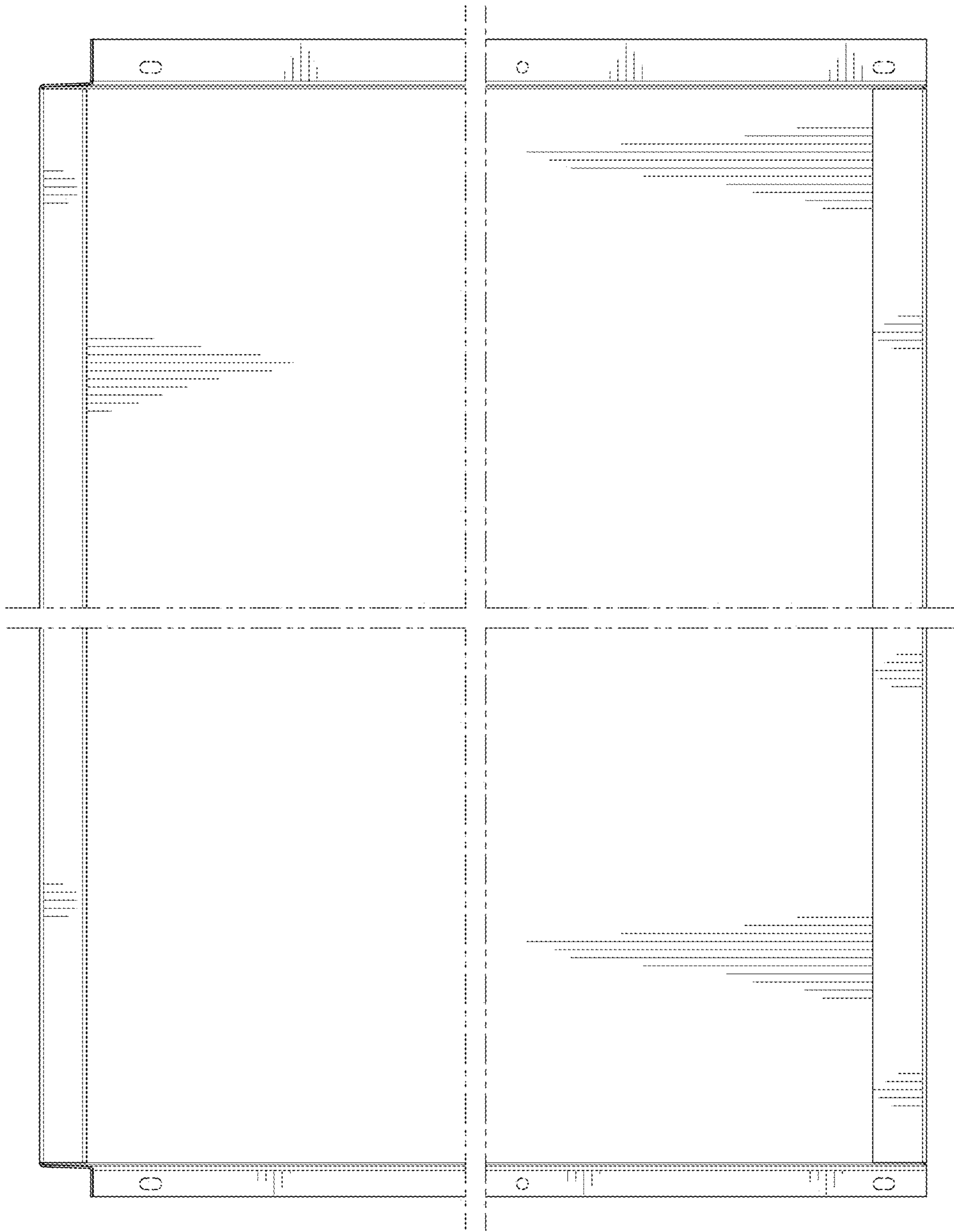

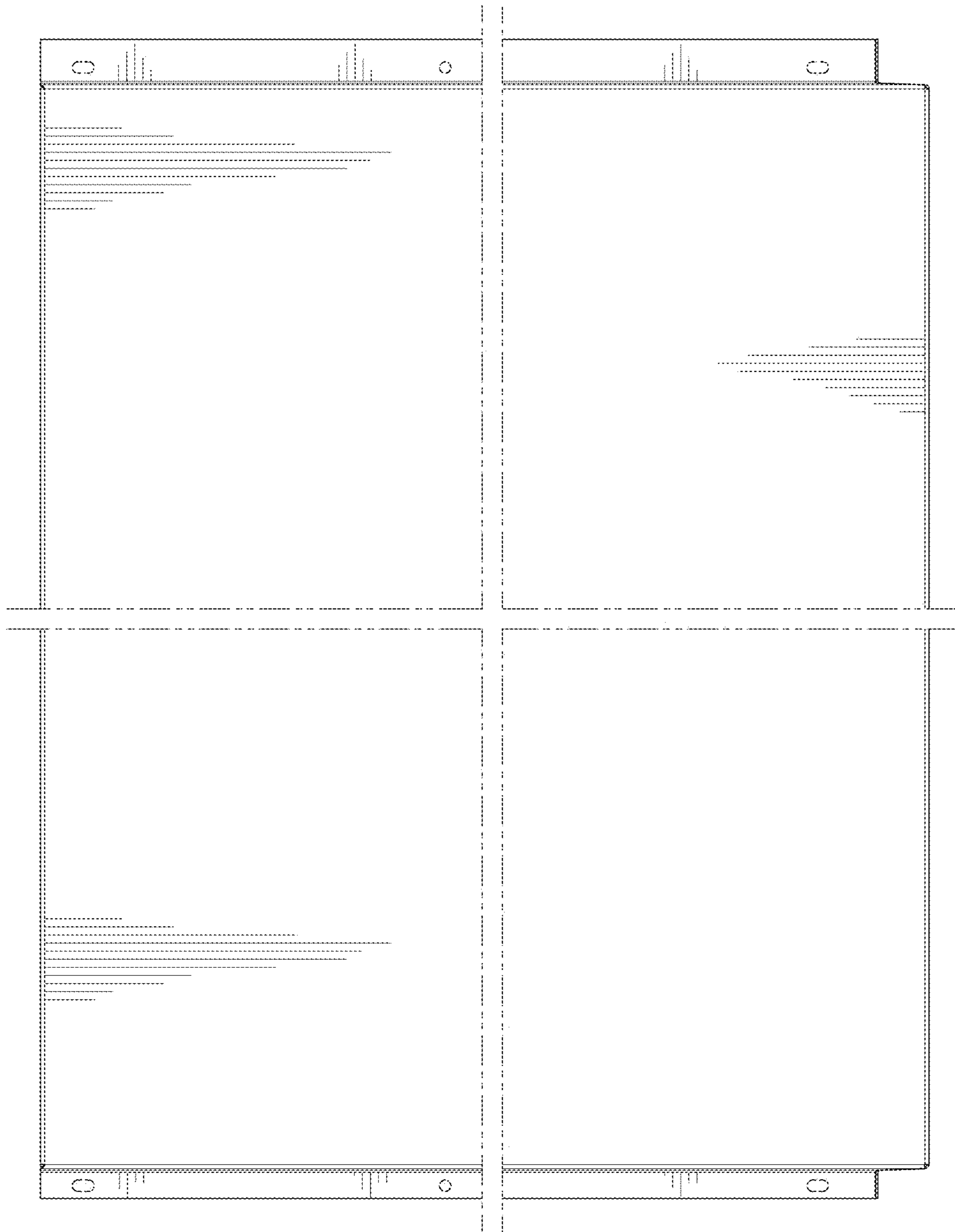

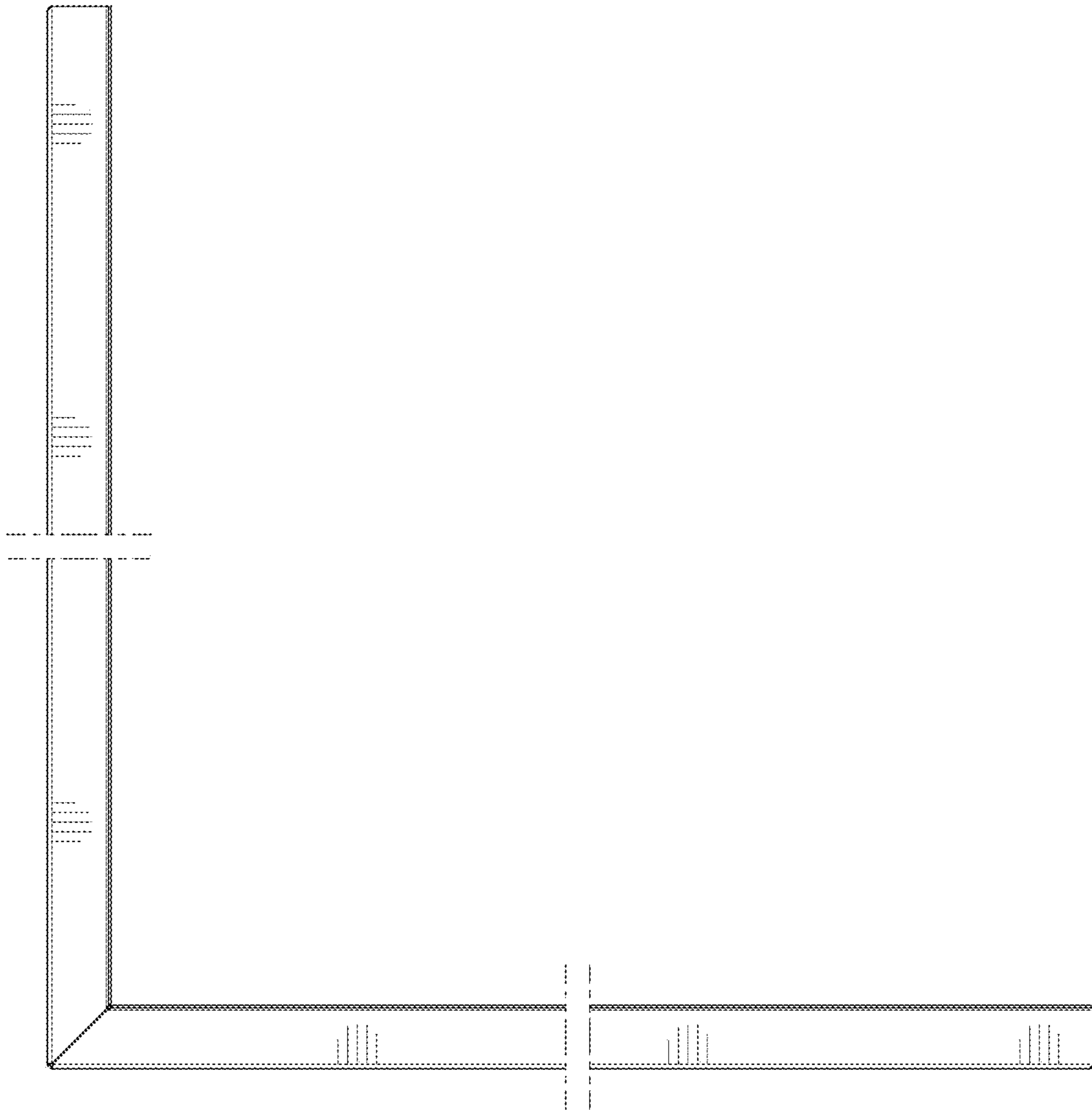

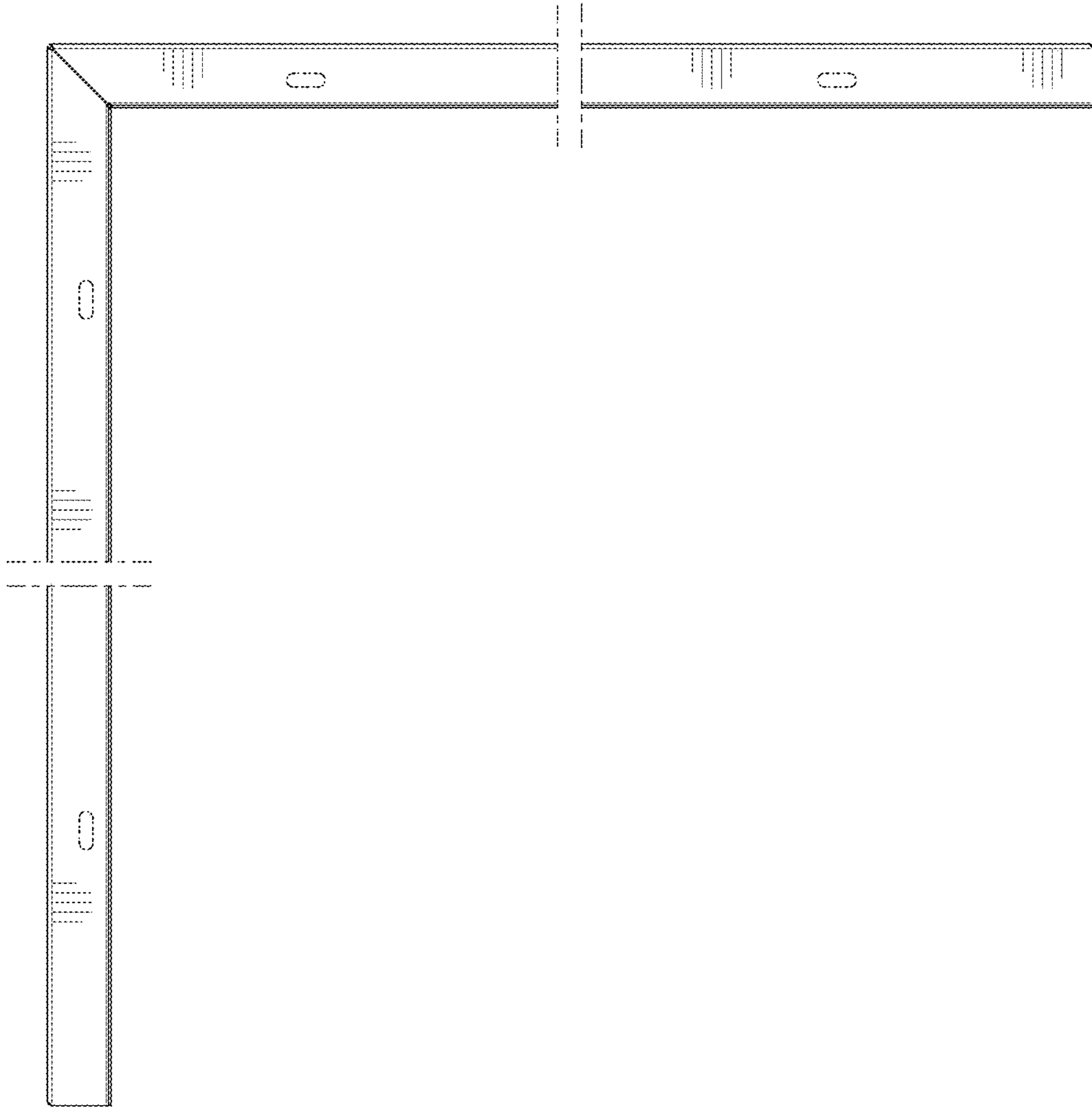

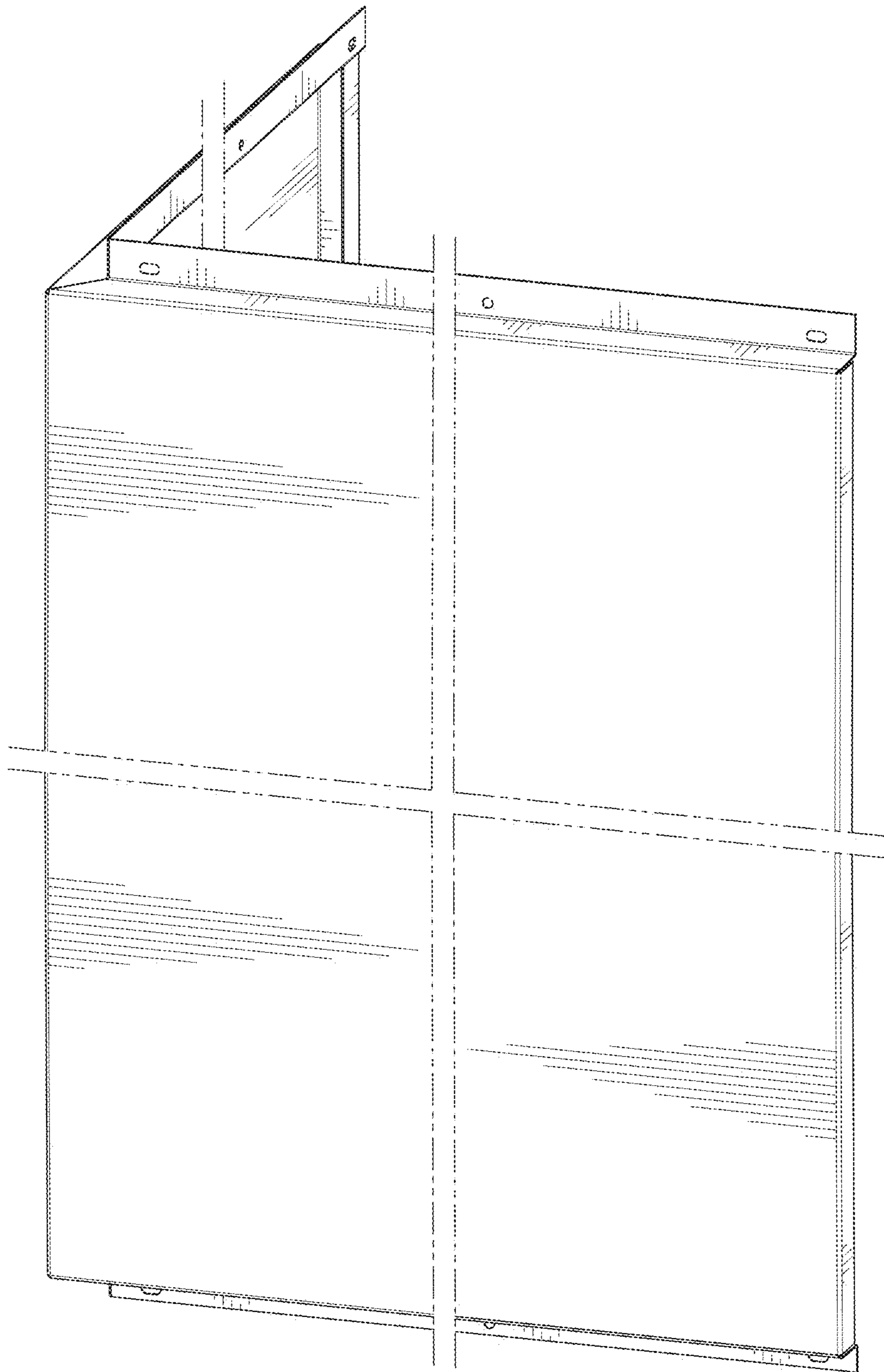
